(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of a first embodiment of a container showing our new design, with the lid closed;

FIG. 2 is a top and side perspective view thereof, with the lid partially removed;

FIG. 3 is a top plan view thereof, with the lid closed;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a side elevational view thereof from the left of FIG. 5, the view from the right of FIG. 5 being the mirror image thereof;

FIG. 7 is a rear elevational view thereof;

FIG. 8 is a top and side perspective view thereof, with the lid removed to show aspects of the design not apparent from FIGS. 1-7;

FIG. 9 is a top plan view thereof;

FIG. 10 is a bottom plan view thereof;

FIG. 11 is a front elevational view thereof;

FIG. 12 is a side elevational view thereof from the left of FIG. 11;

FIG. 13 is a rear elevational view thereof;

FIG. 14 is a side elevational view thereof from the right of FIG. 11;

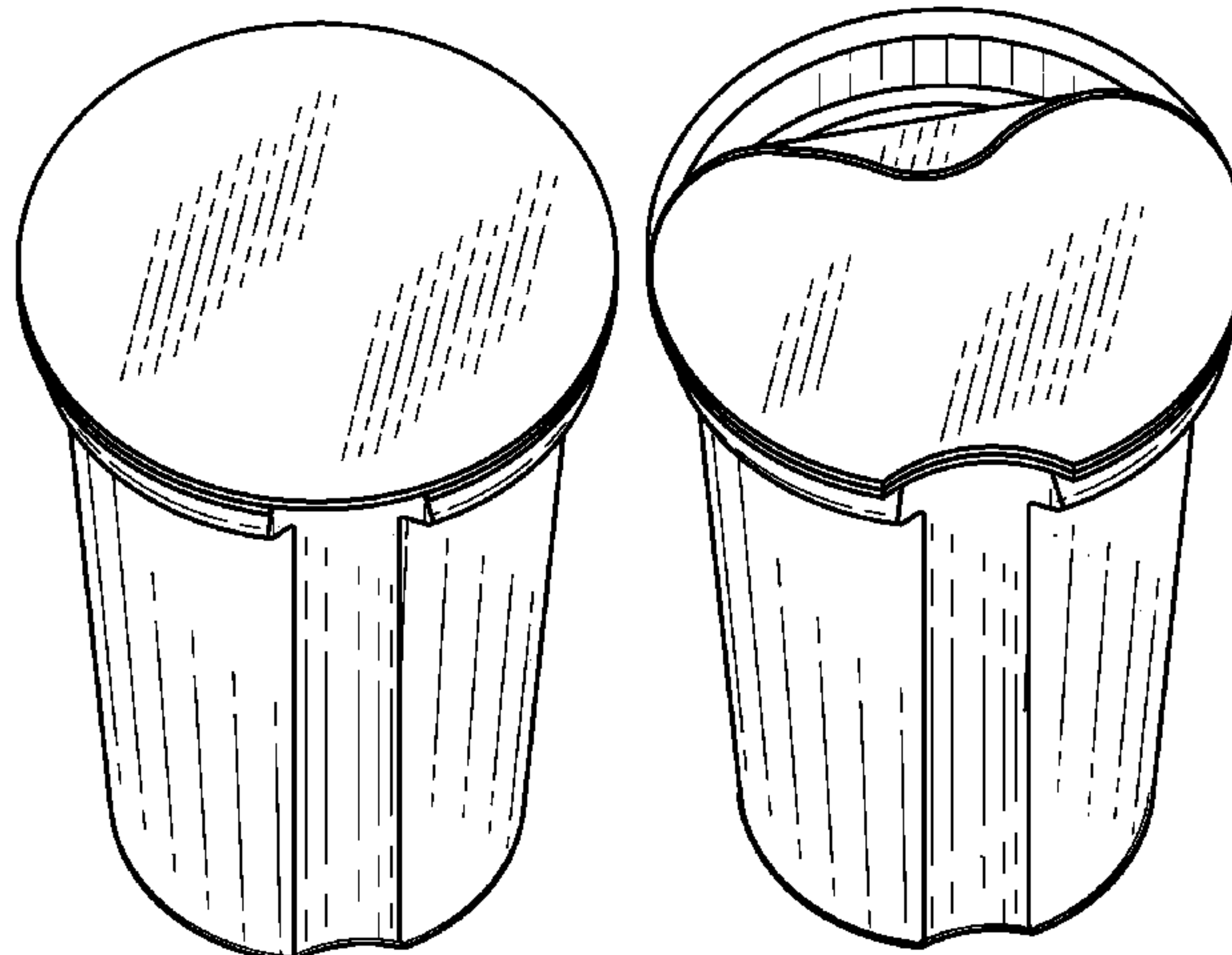


FIG. **15** is a top and side perspective view of a second embodiment of a container showing our new design, with the lid closed;

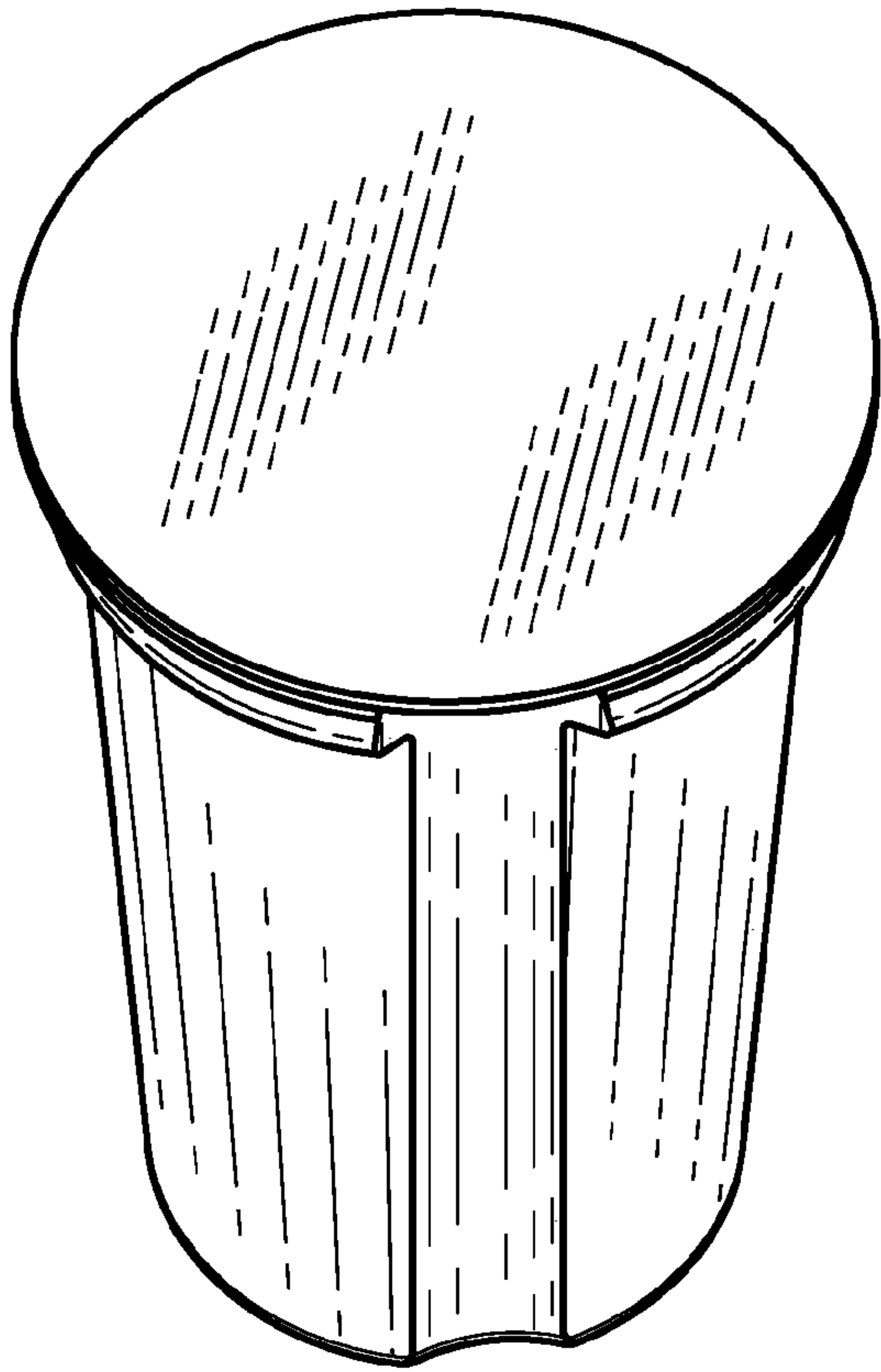

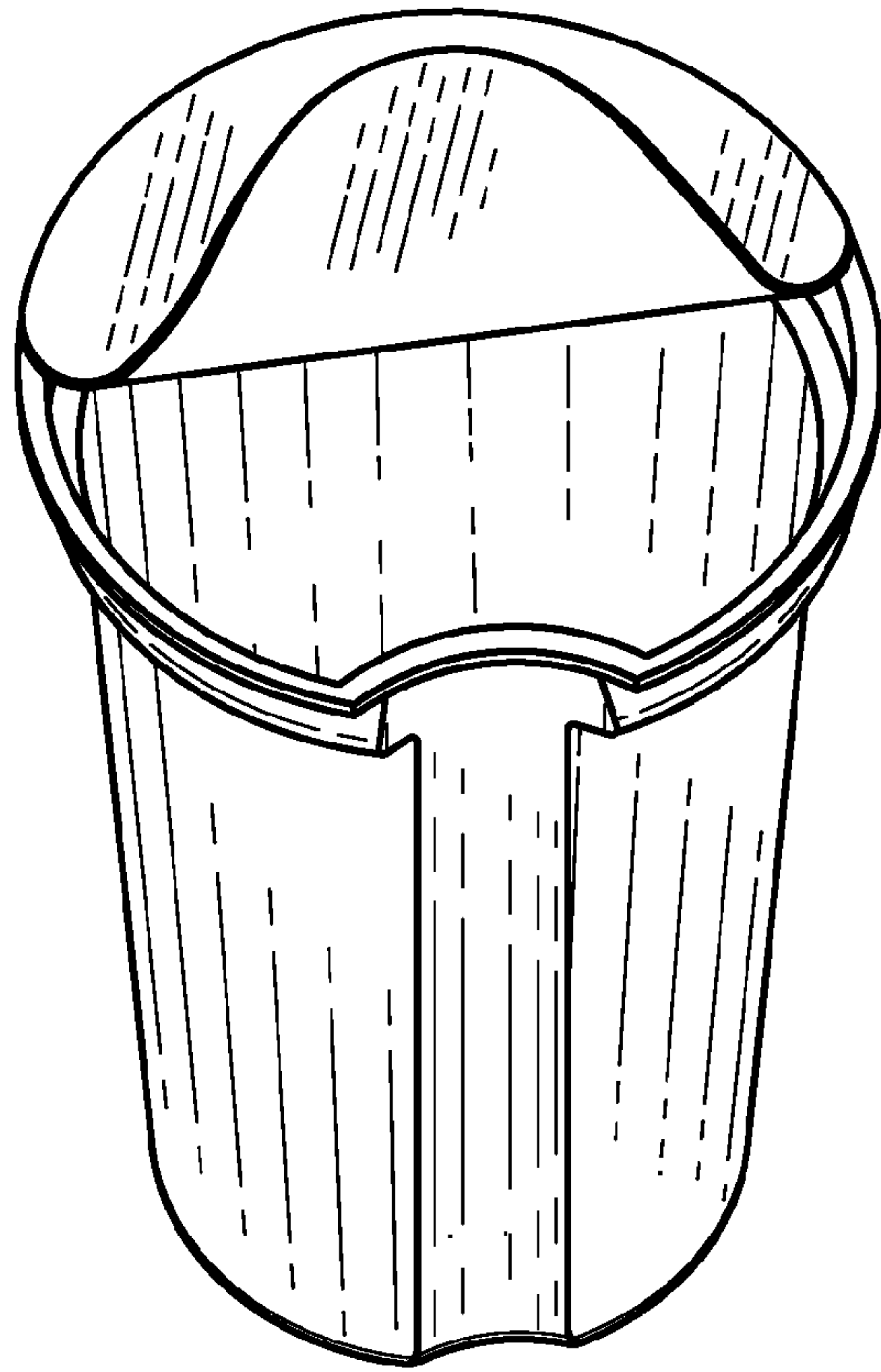

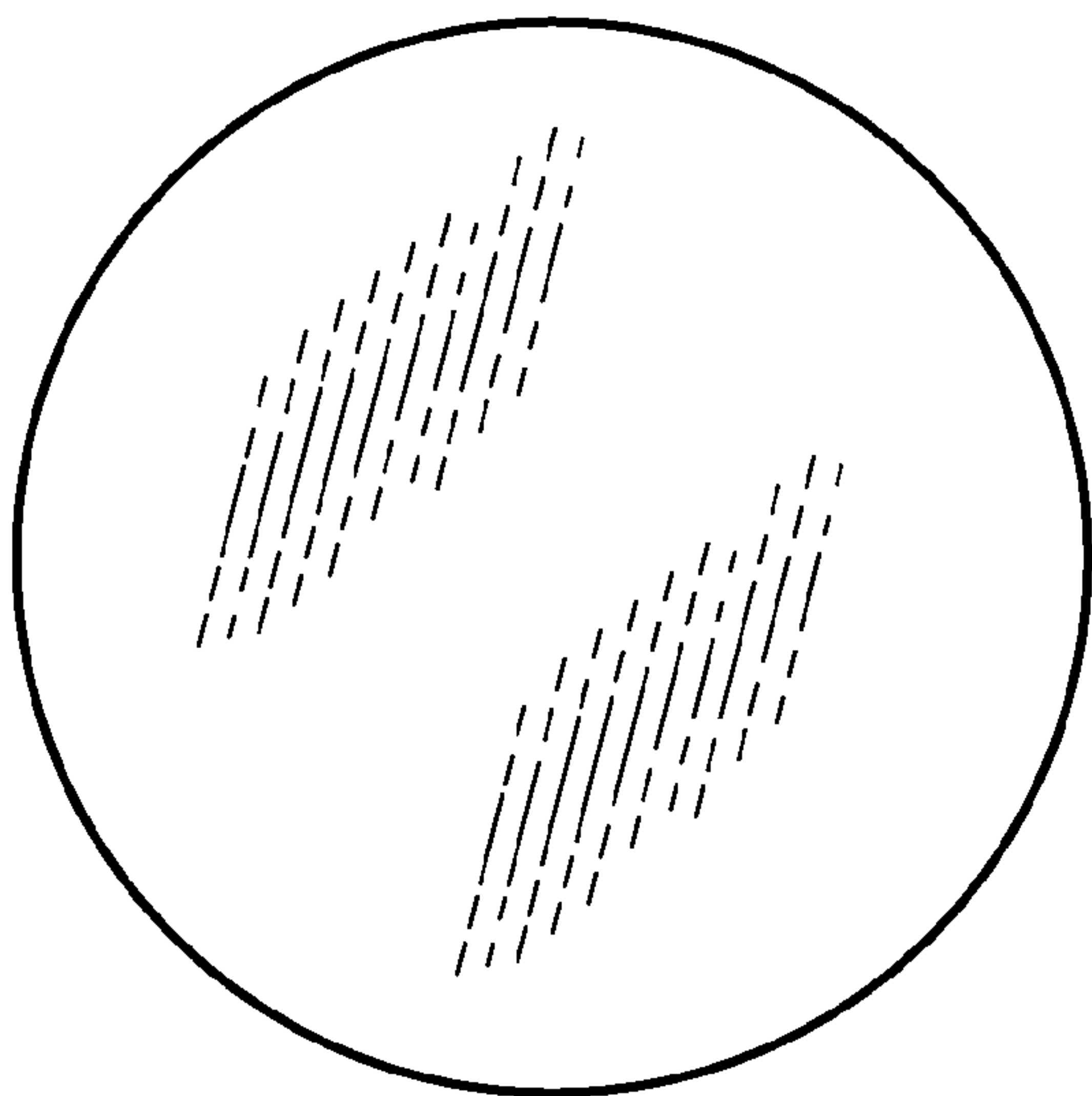

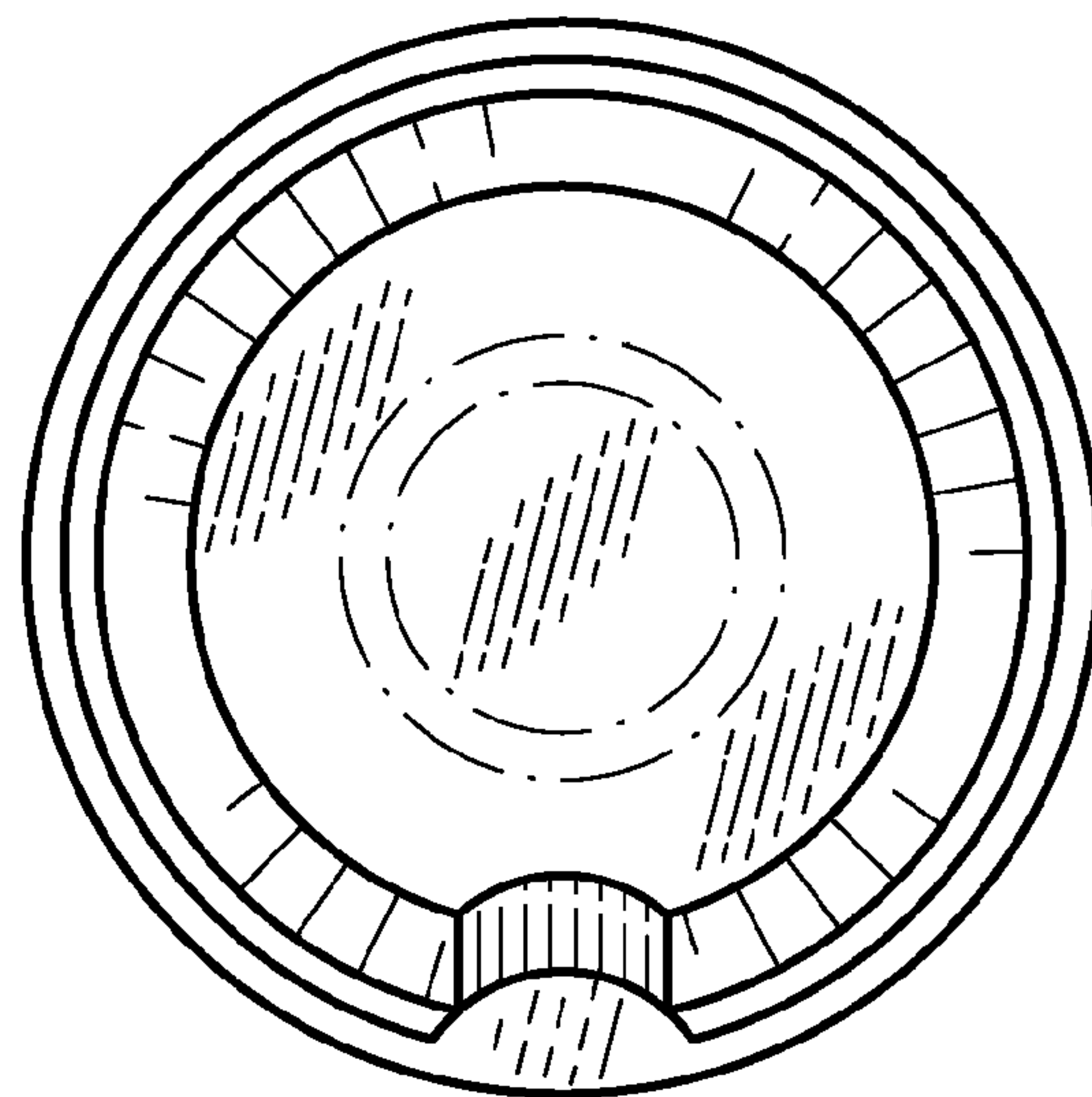

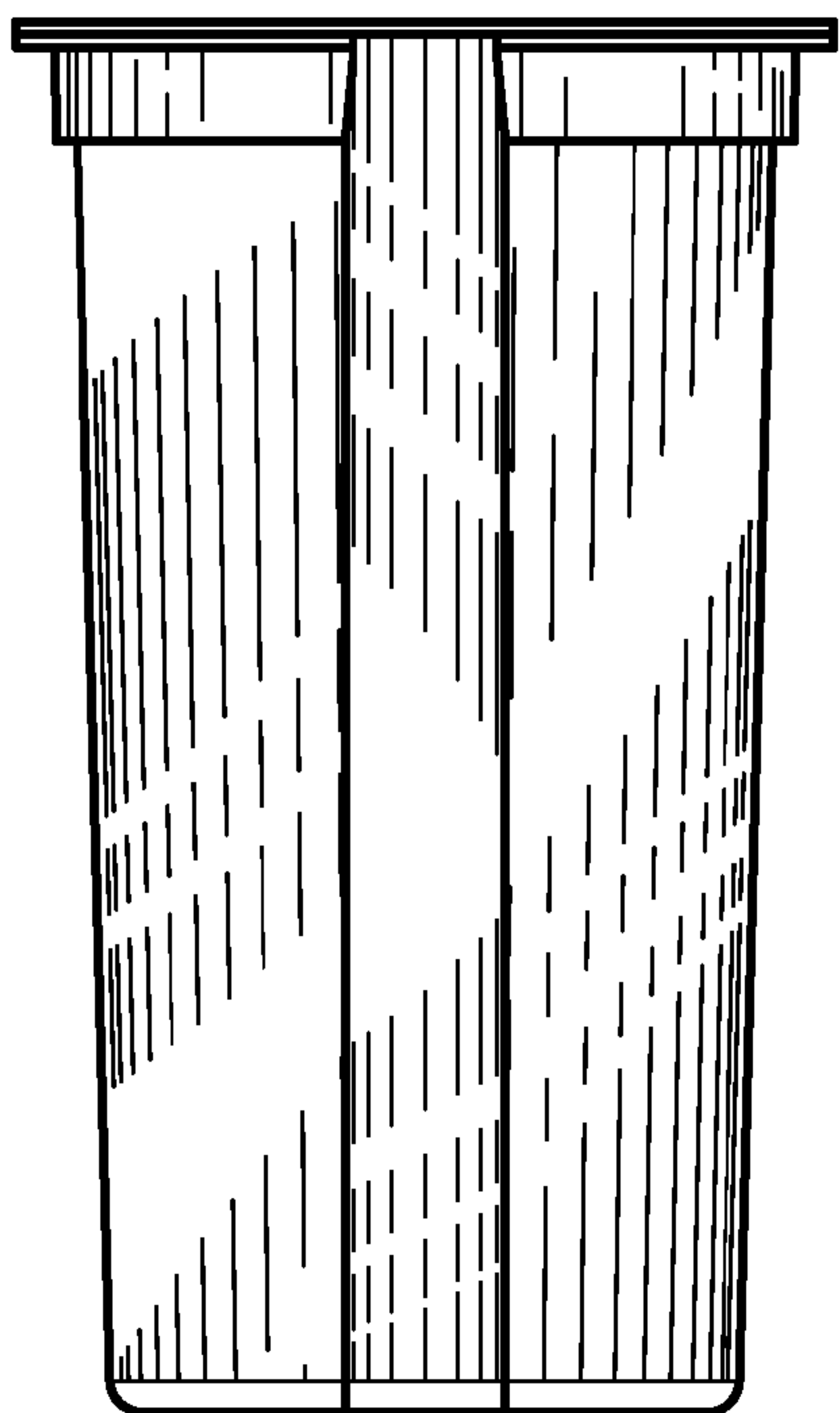

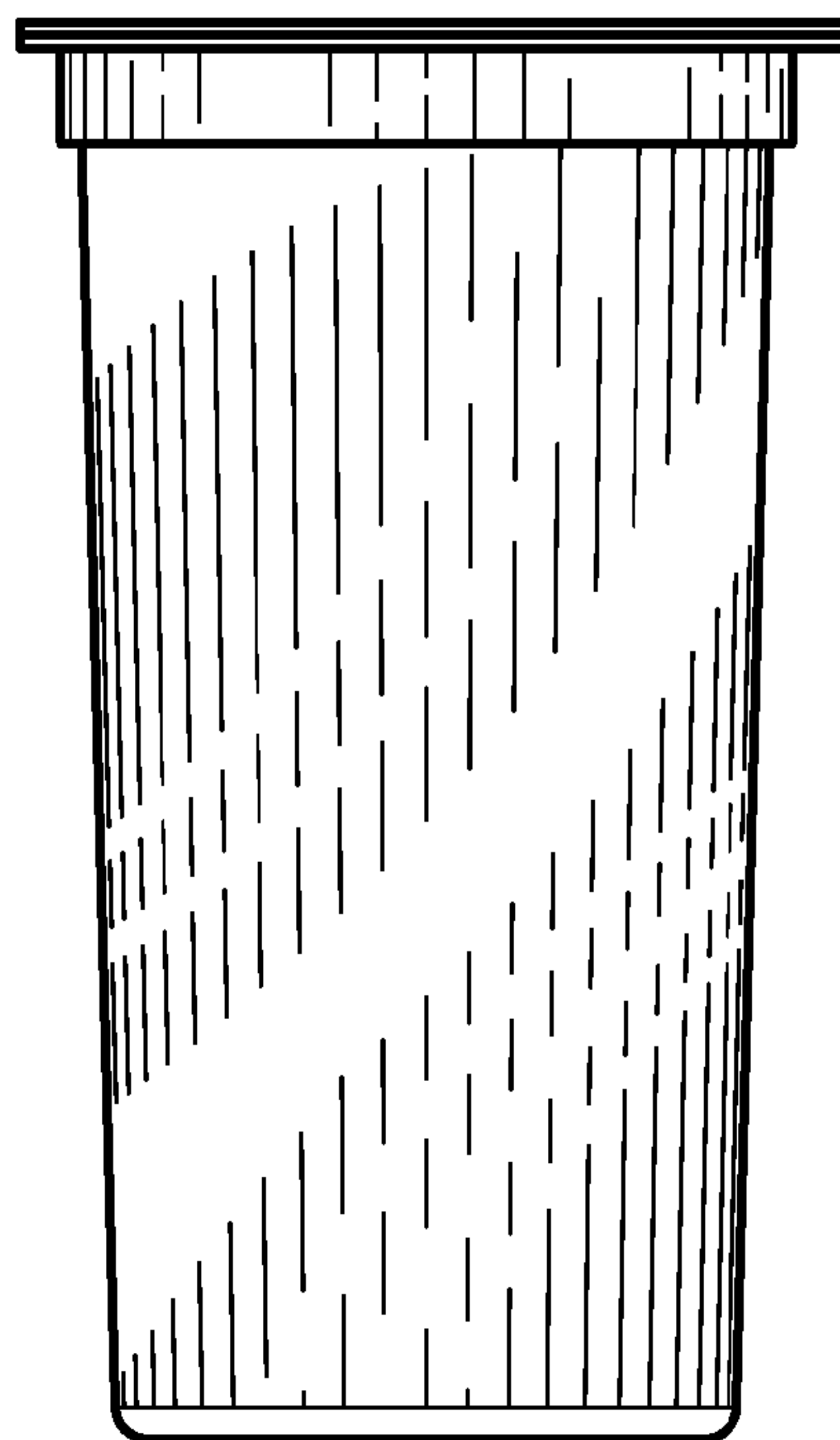

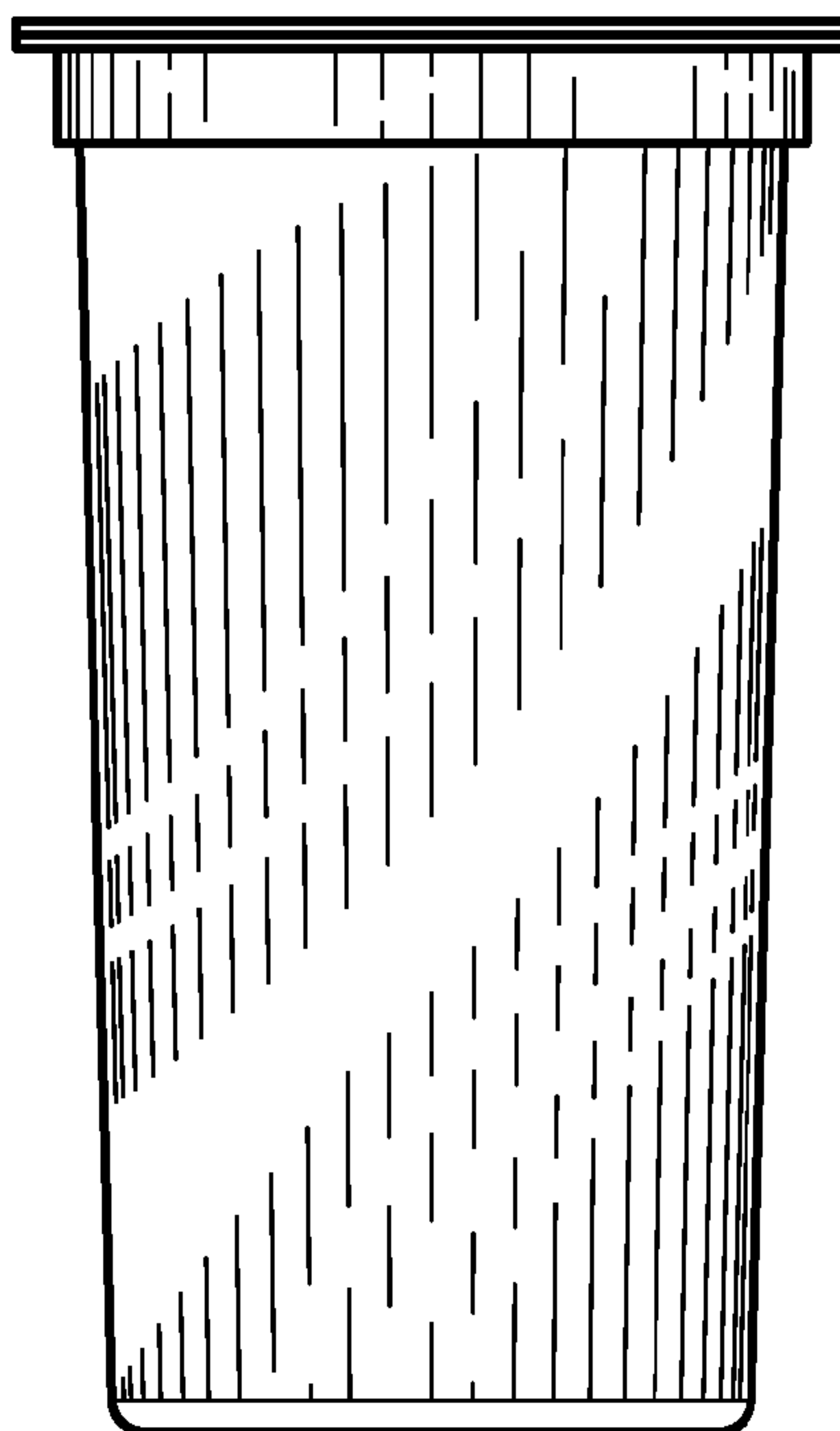

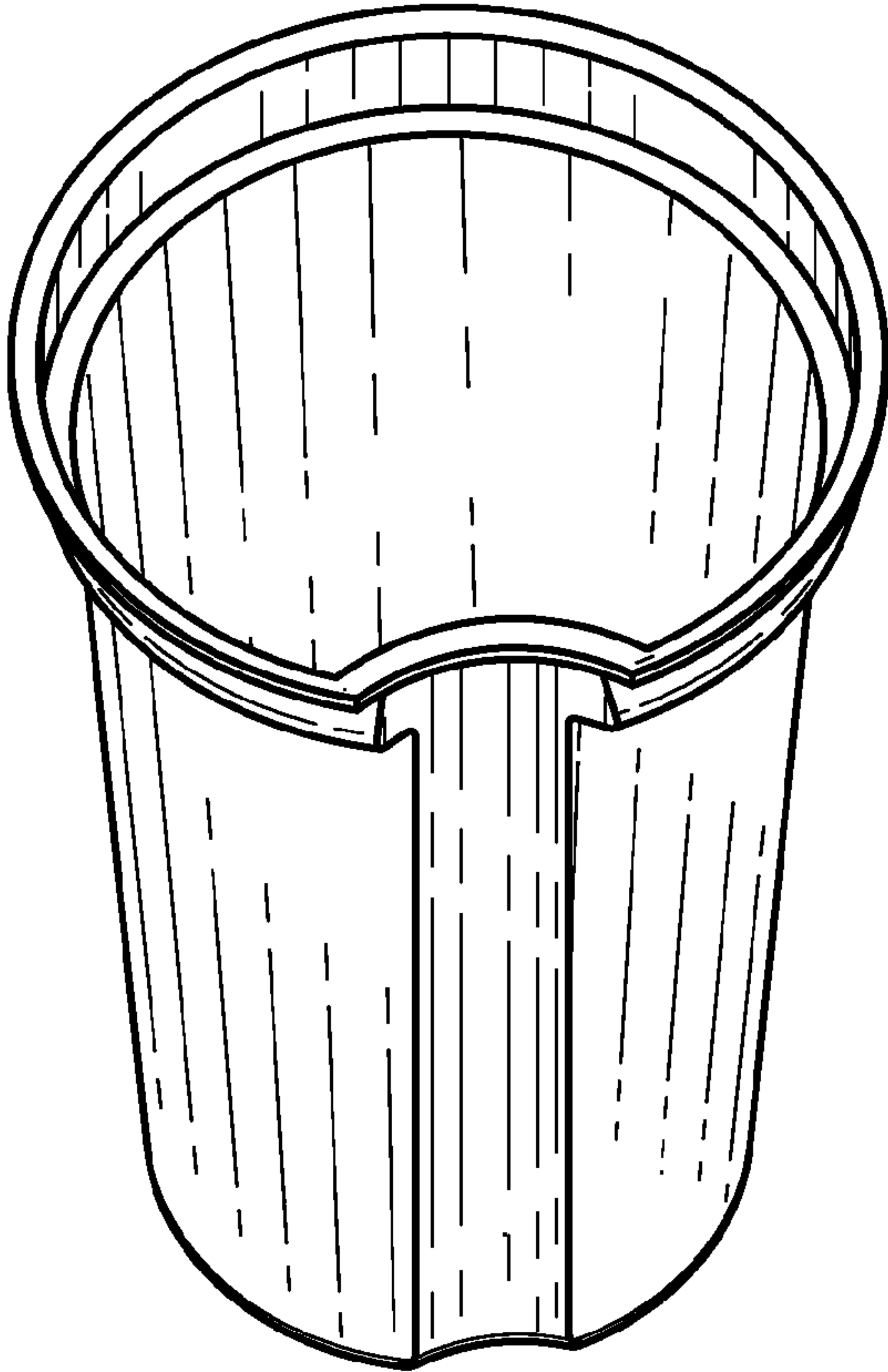

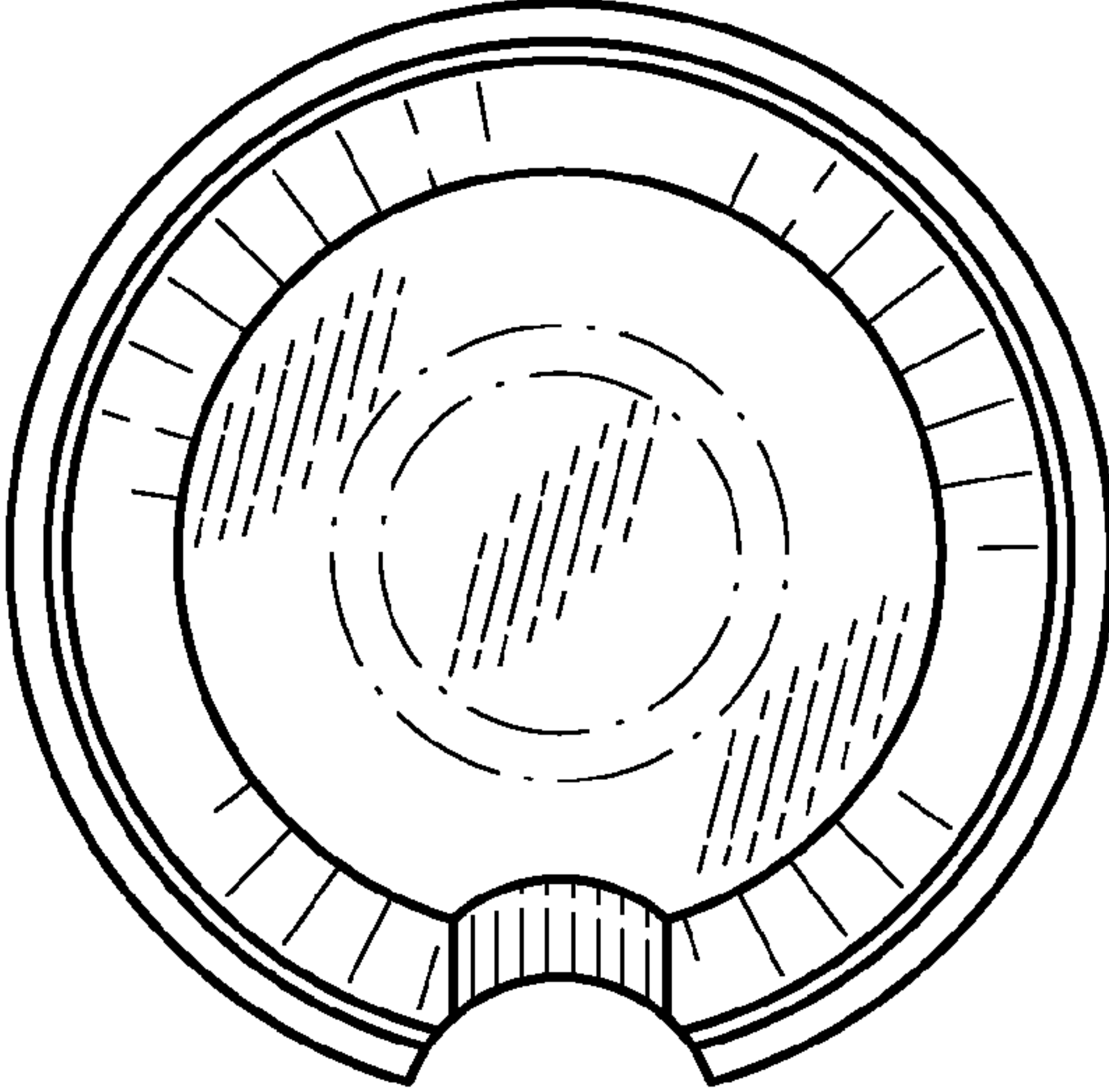

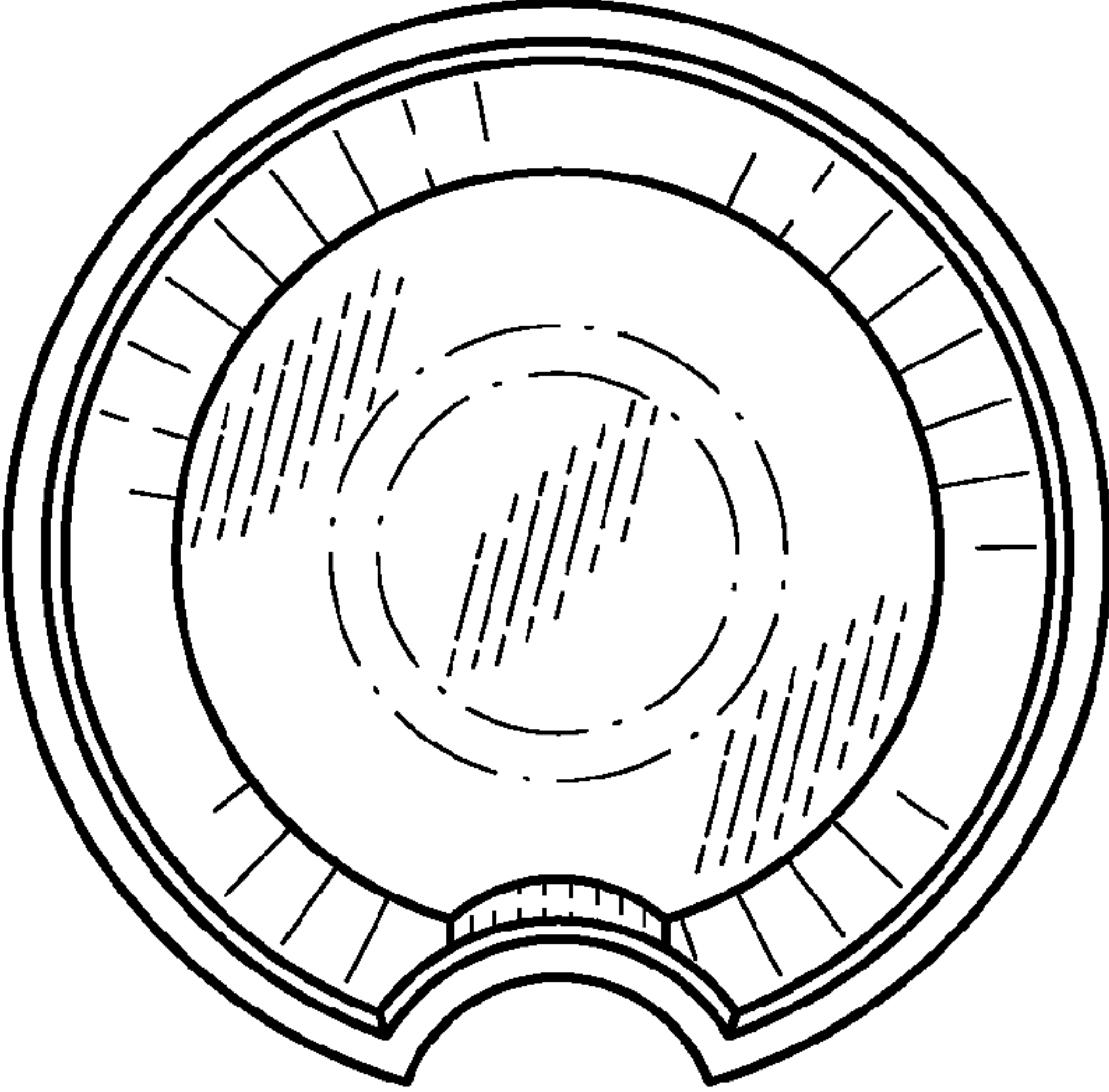

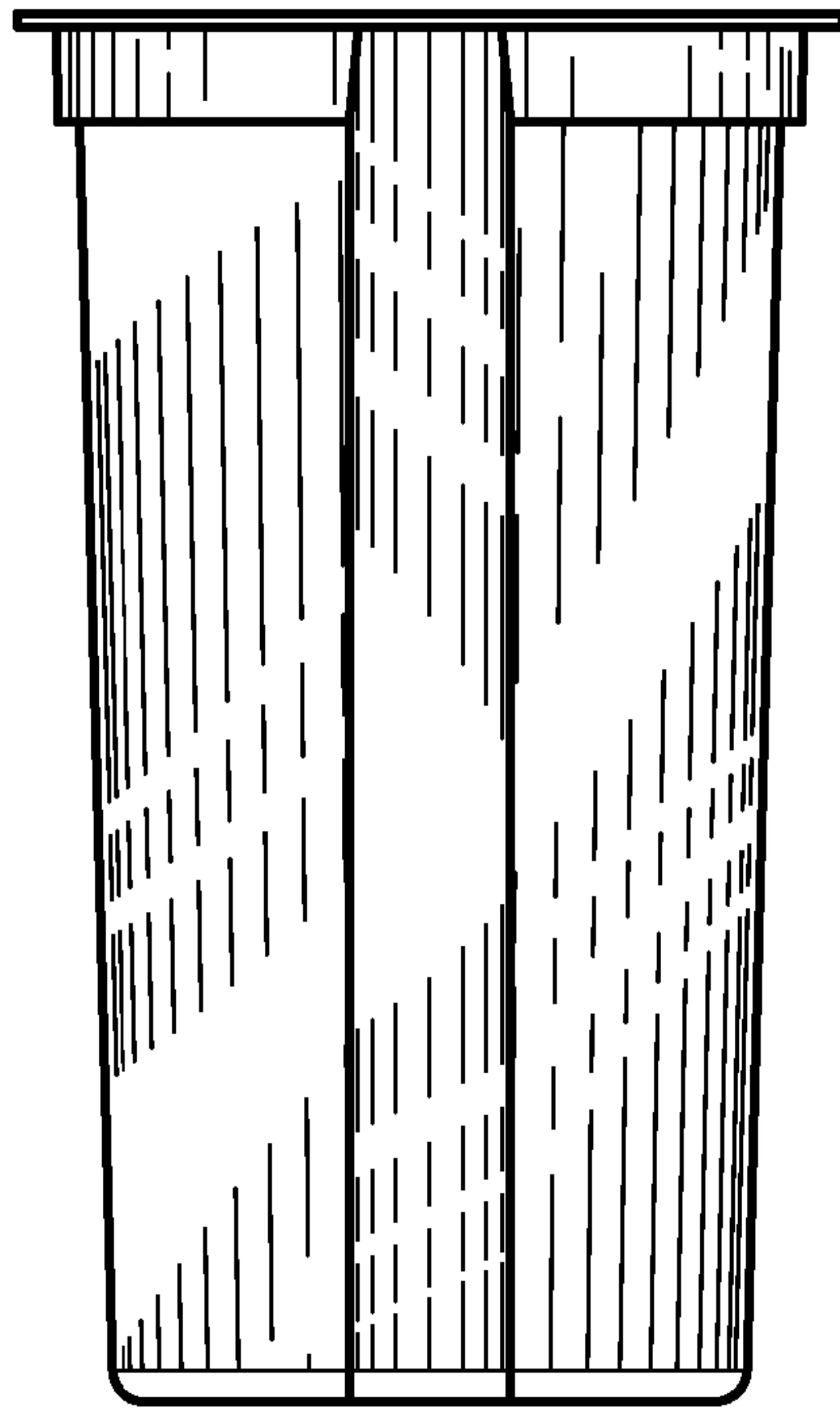

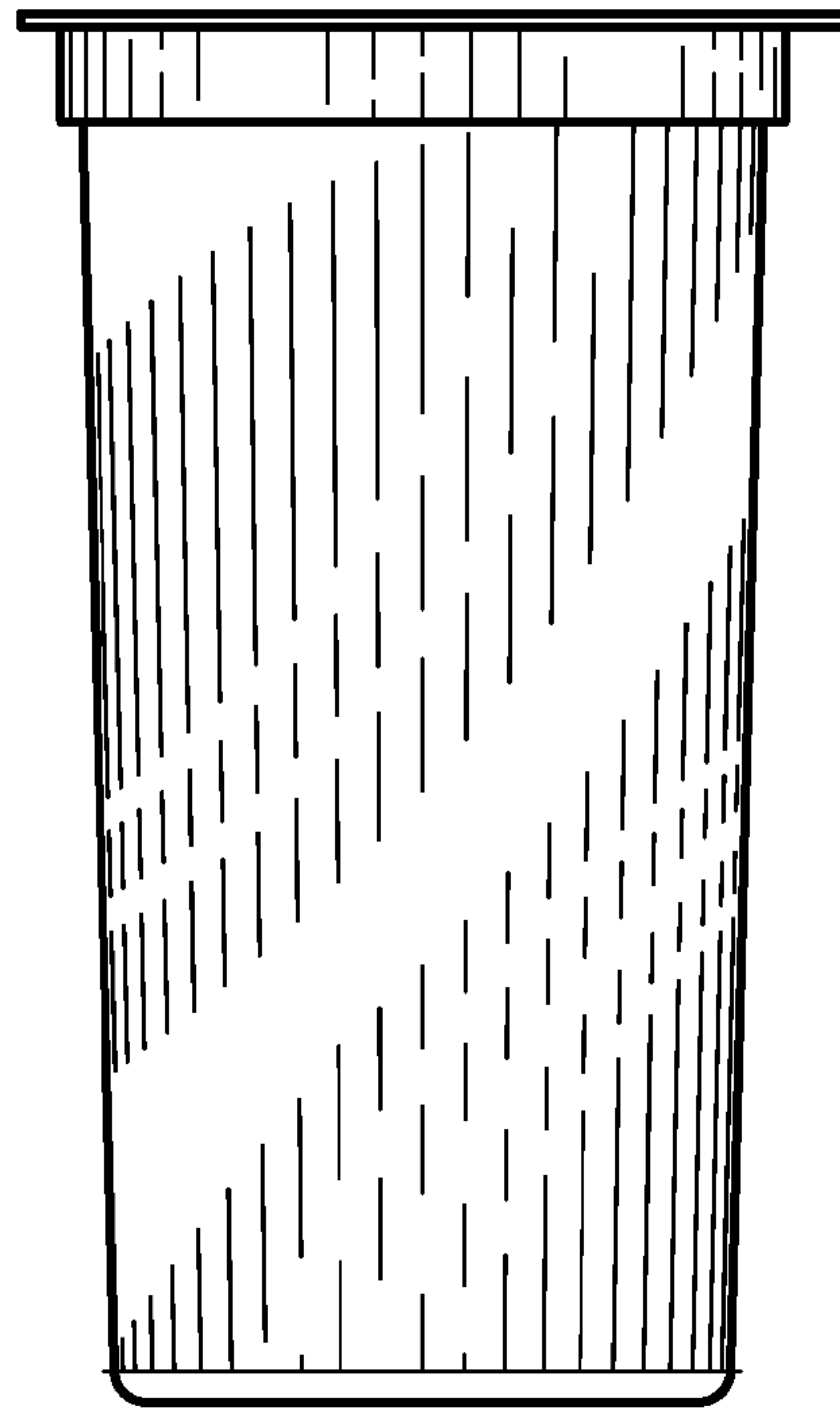

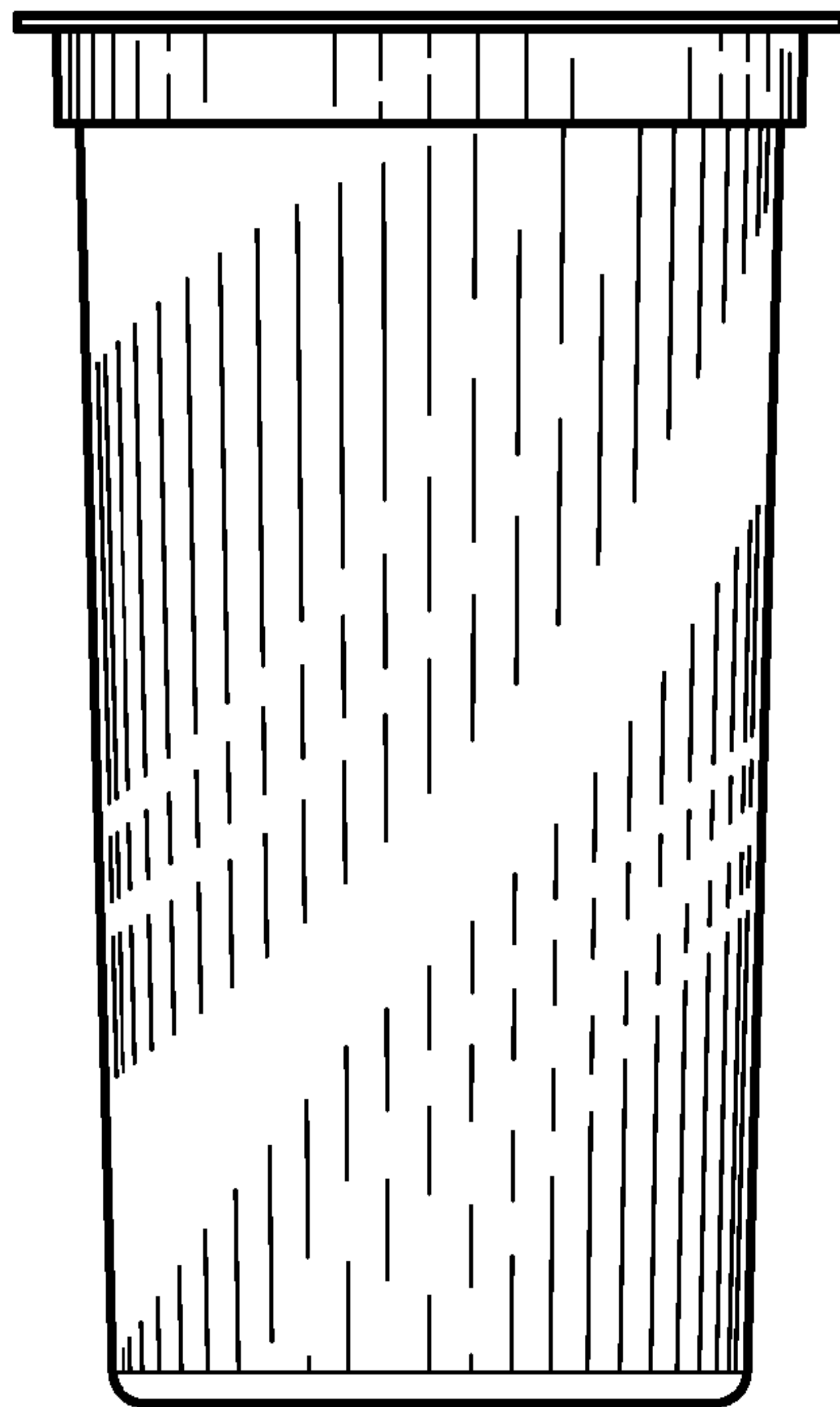

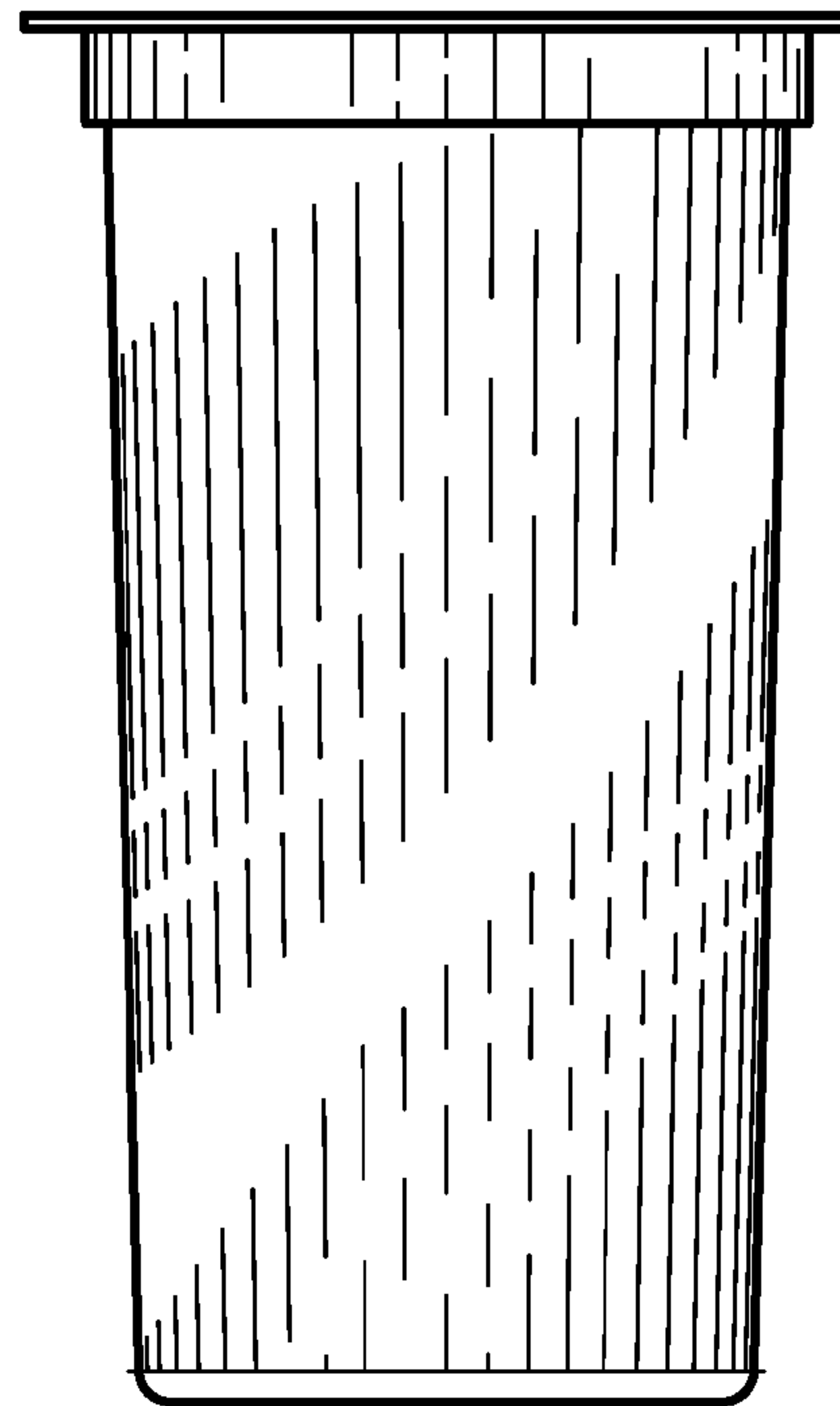

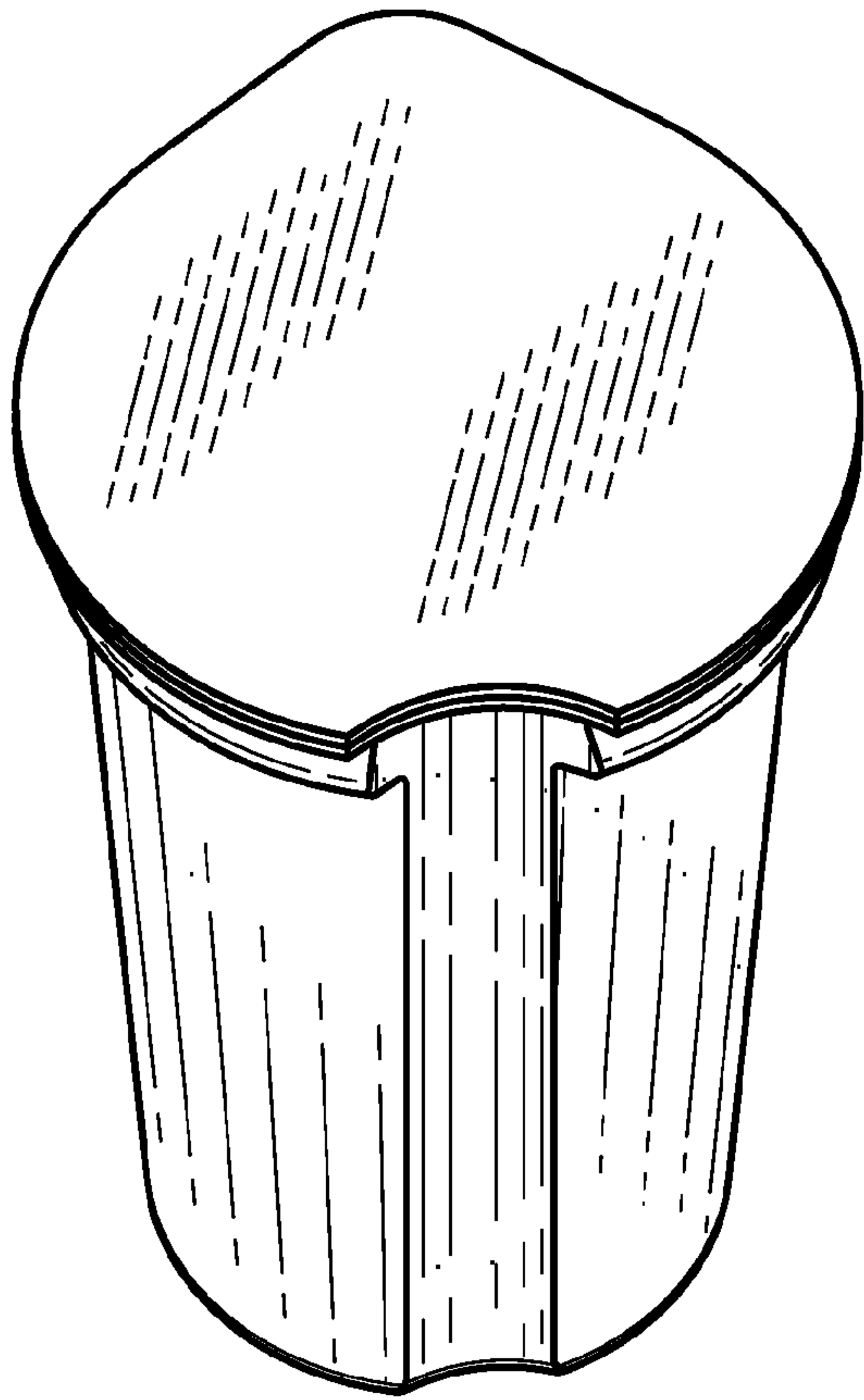

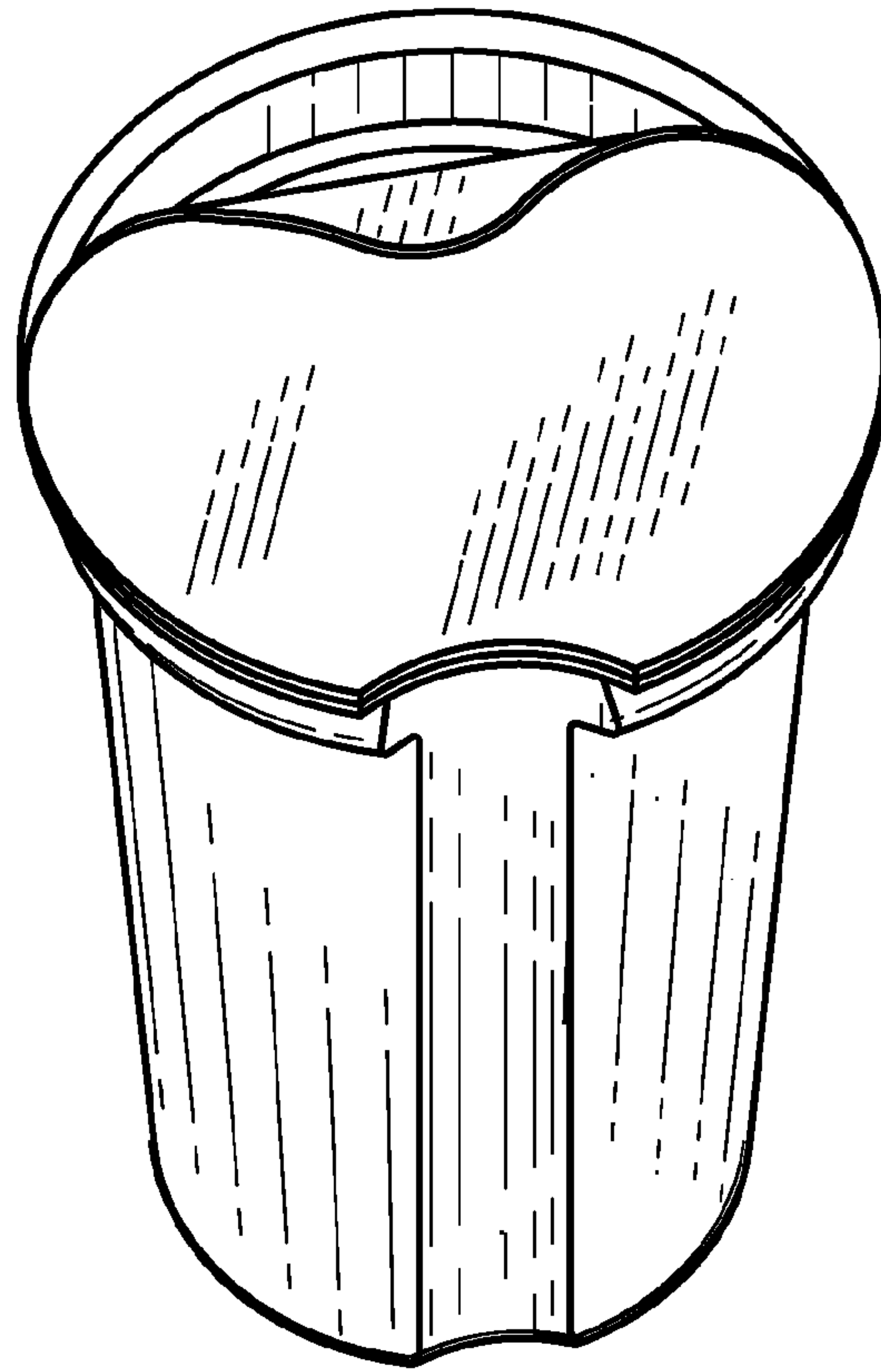

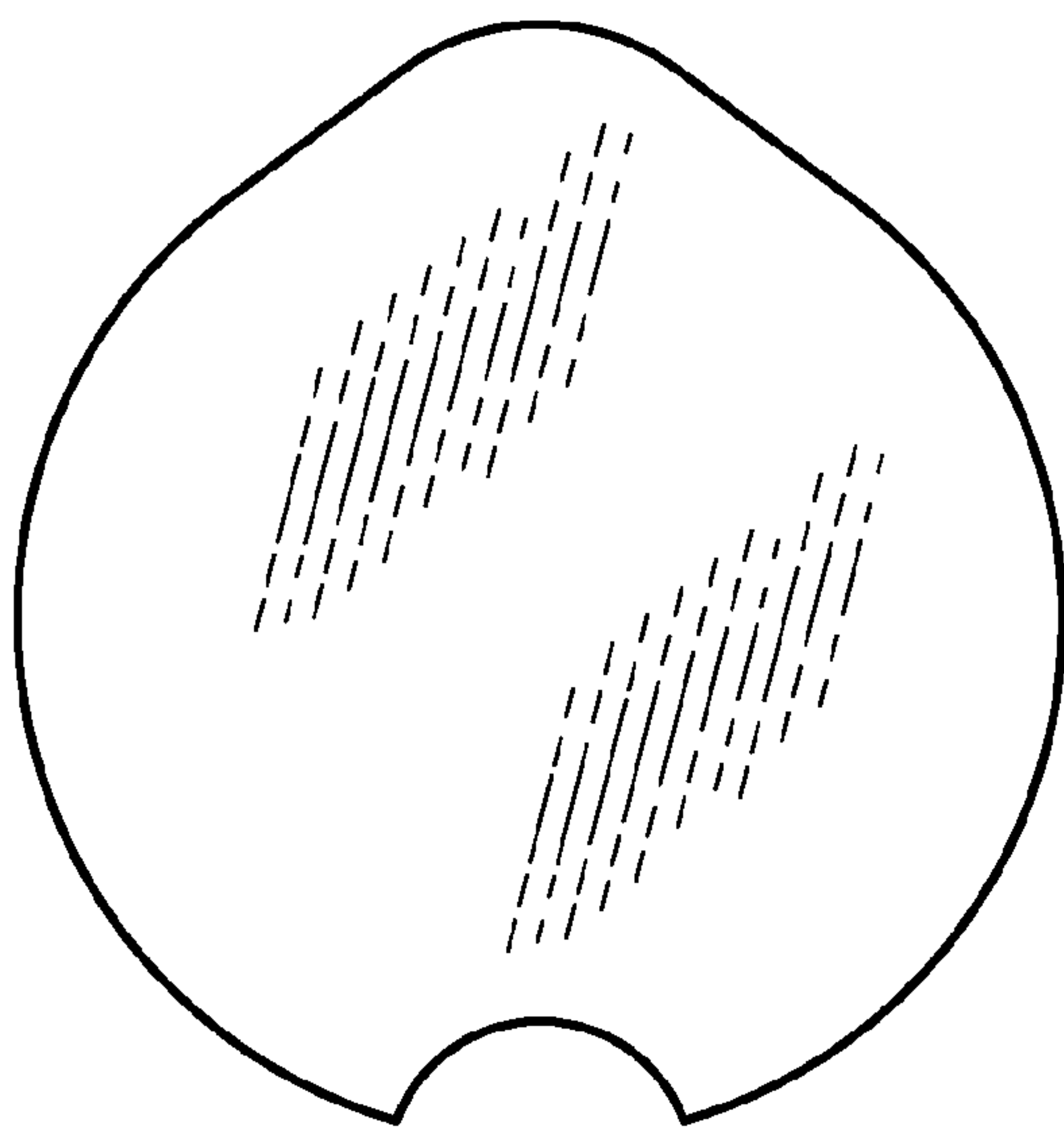

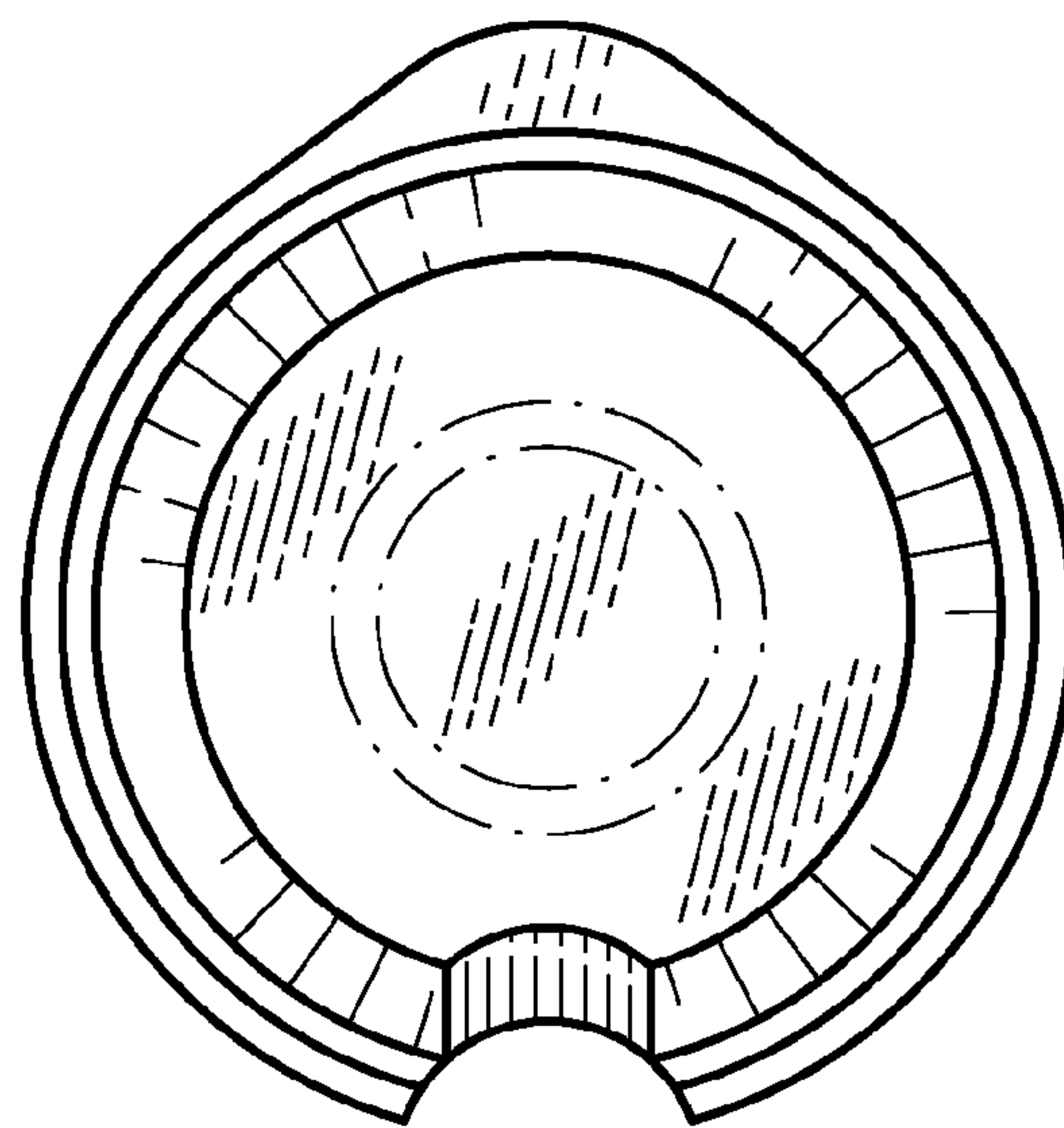

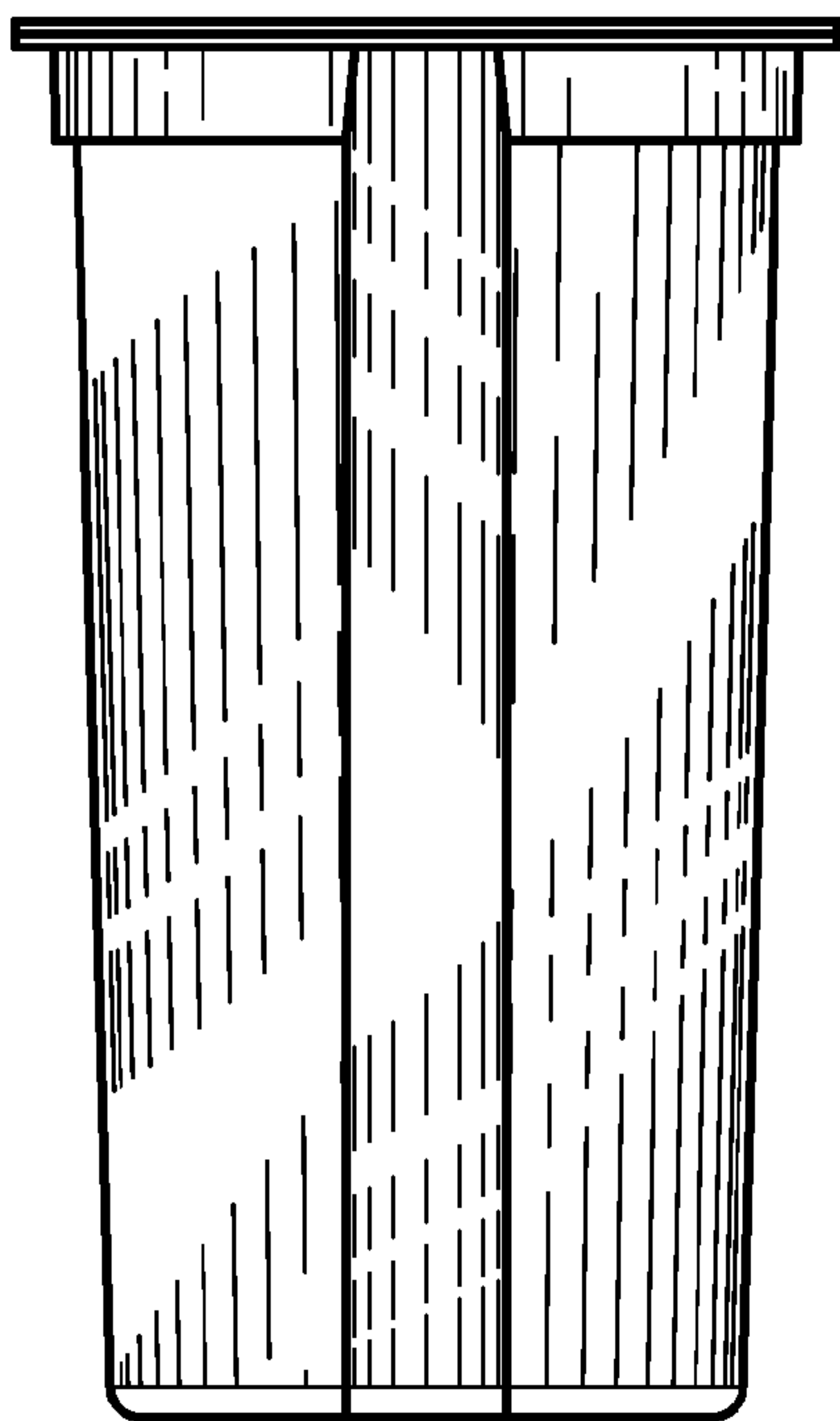

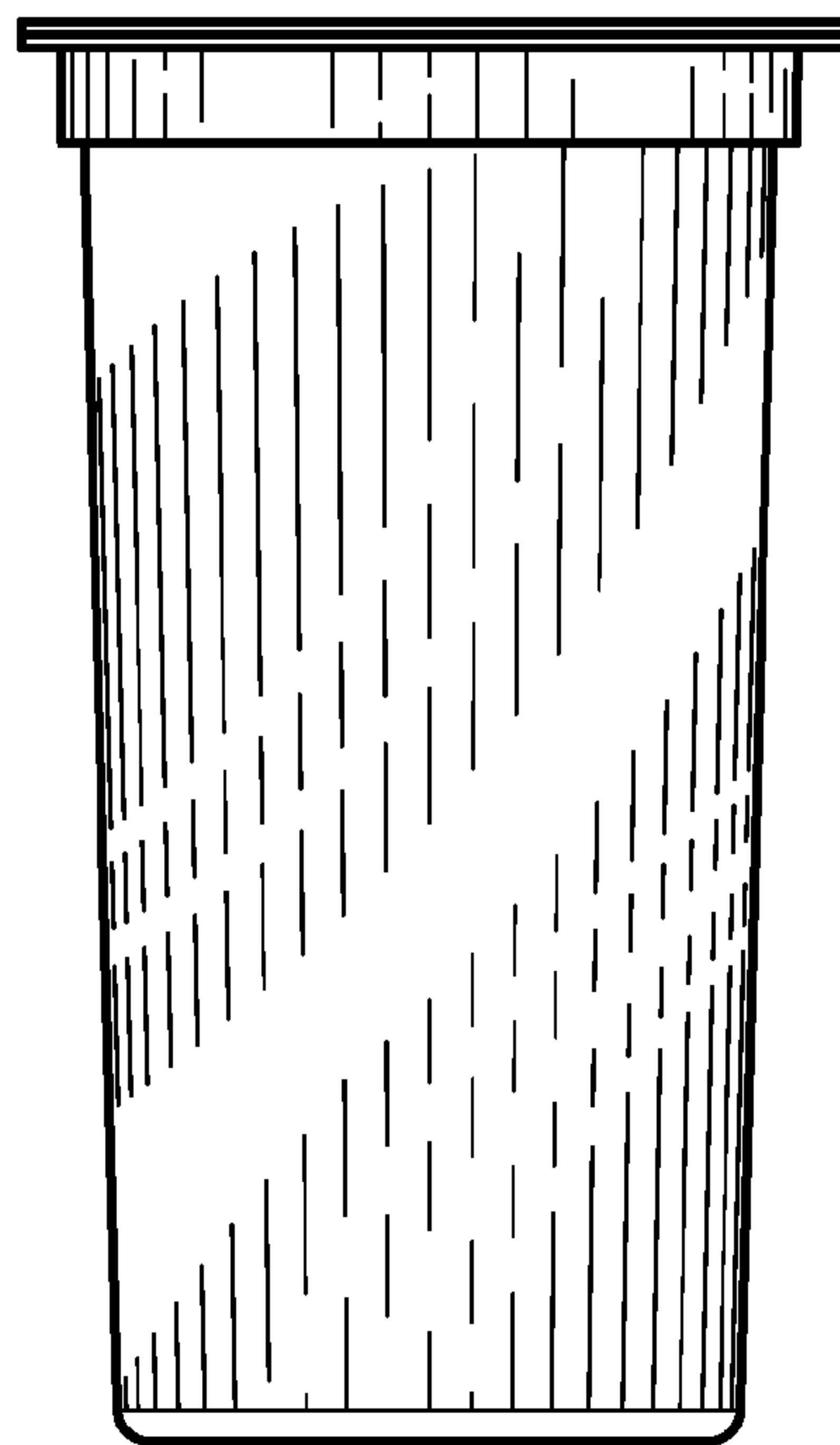

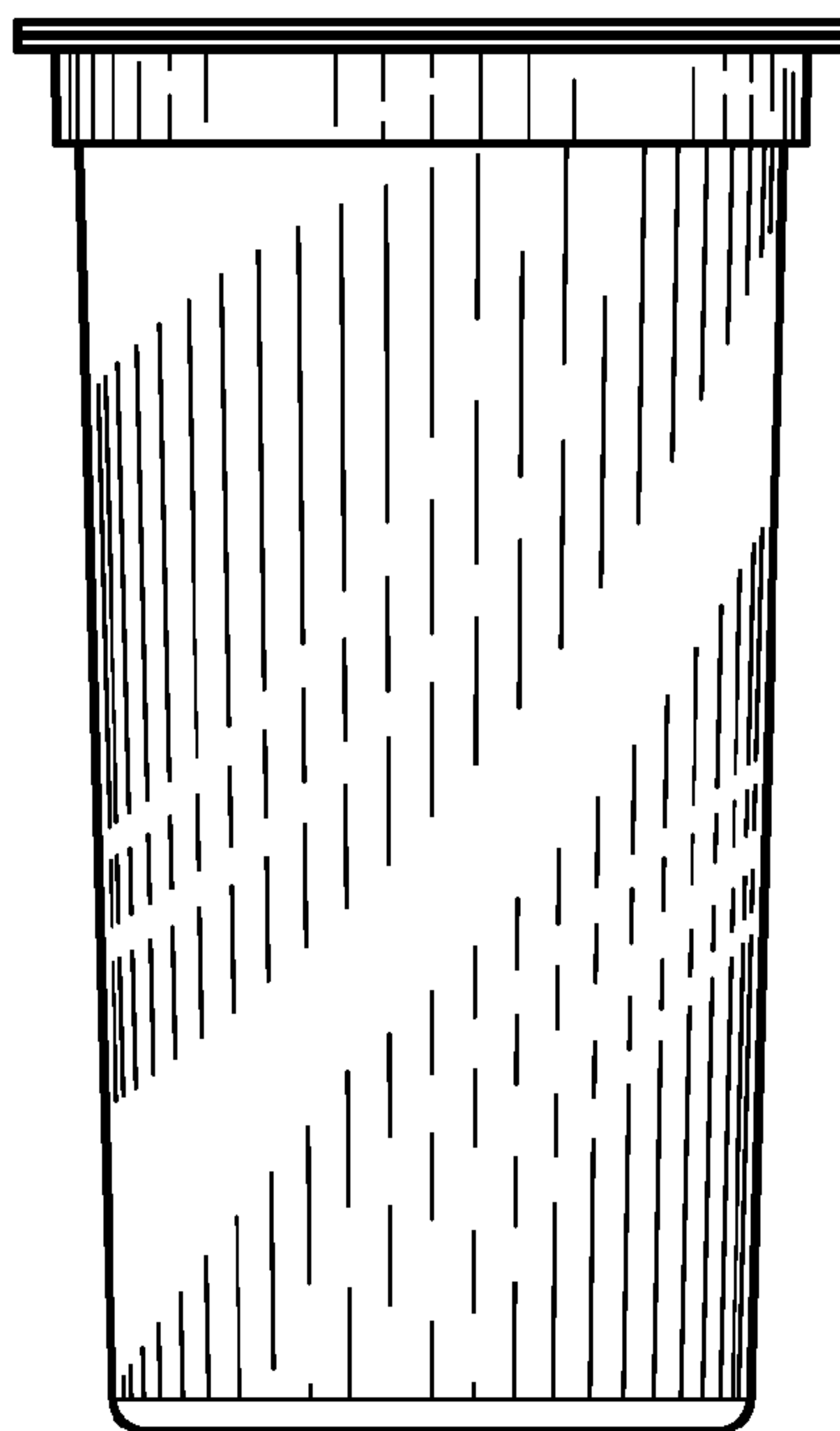

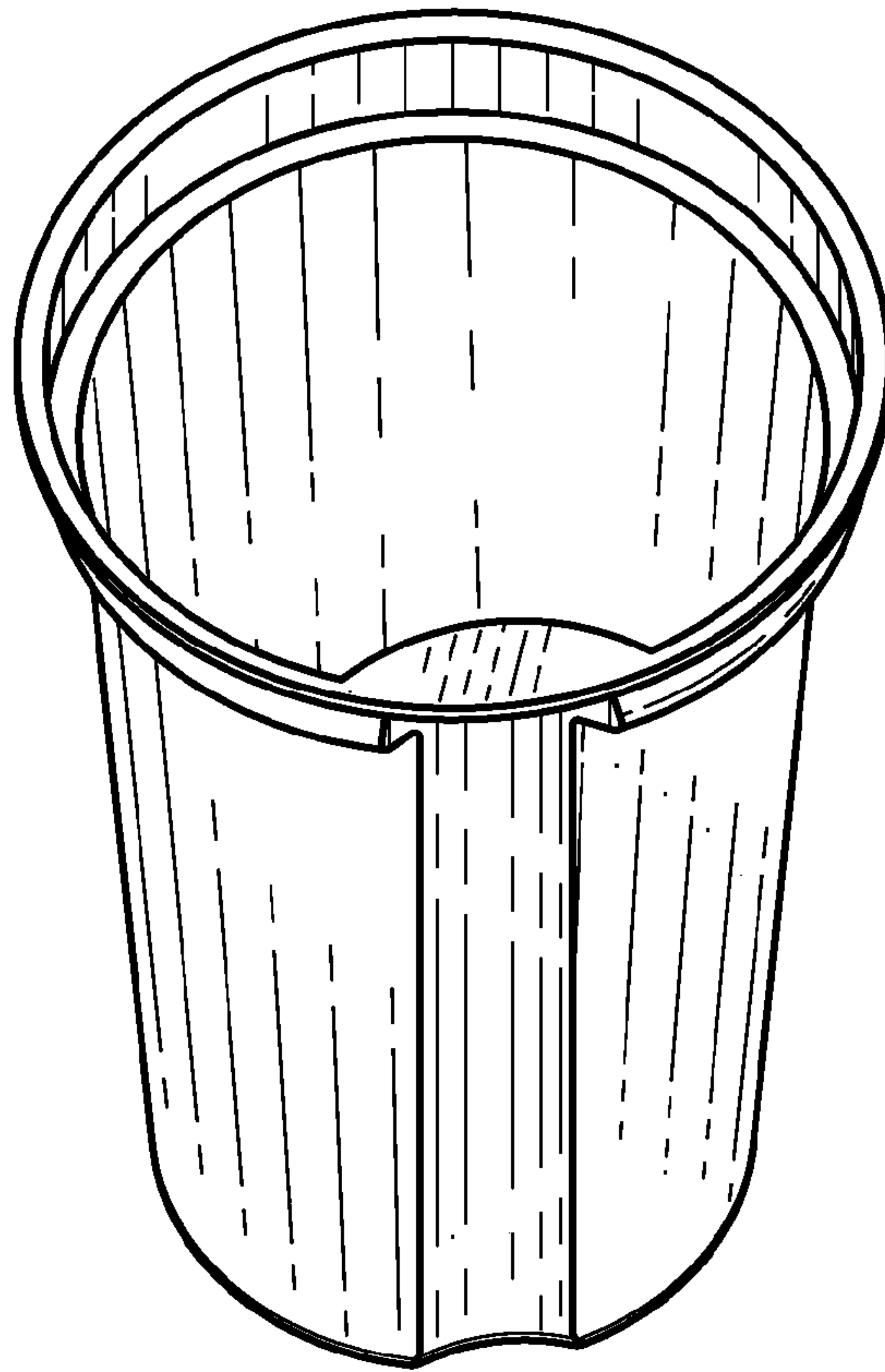

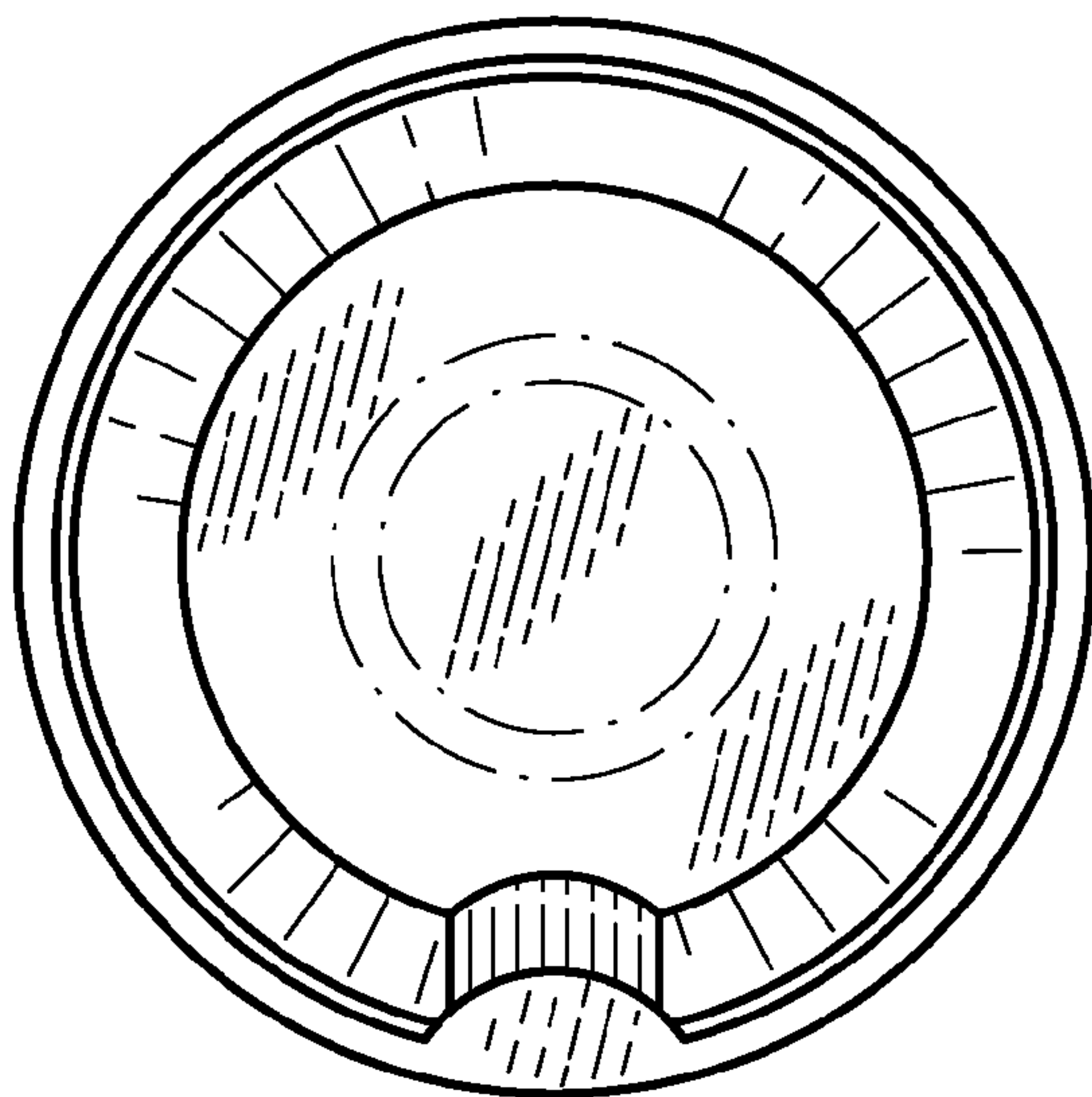

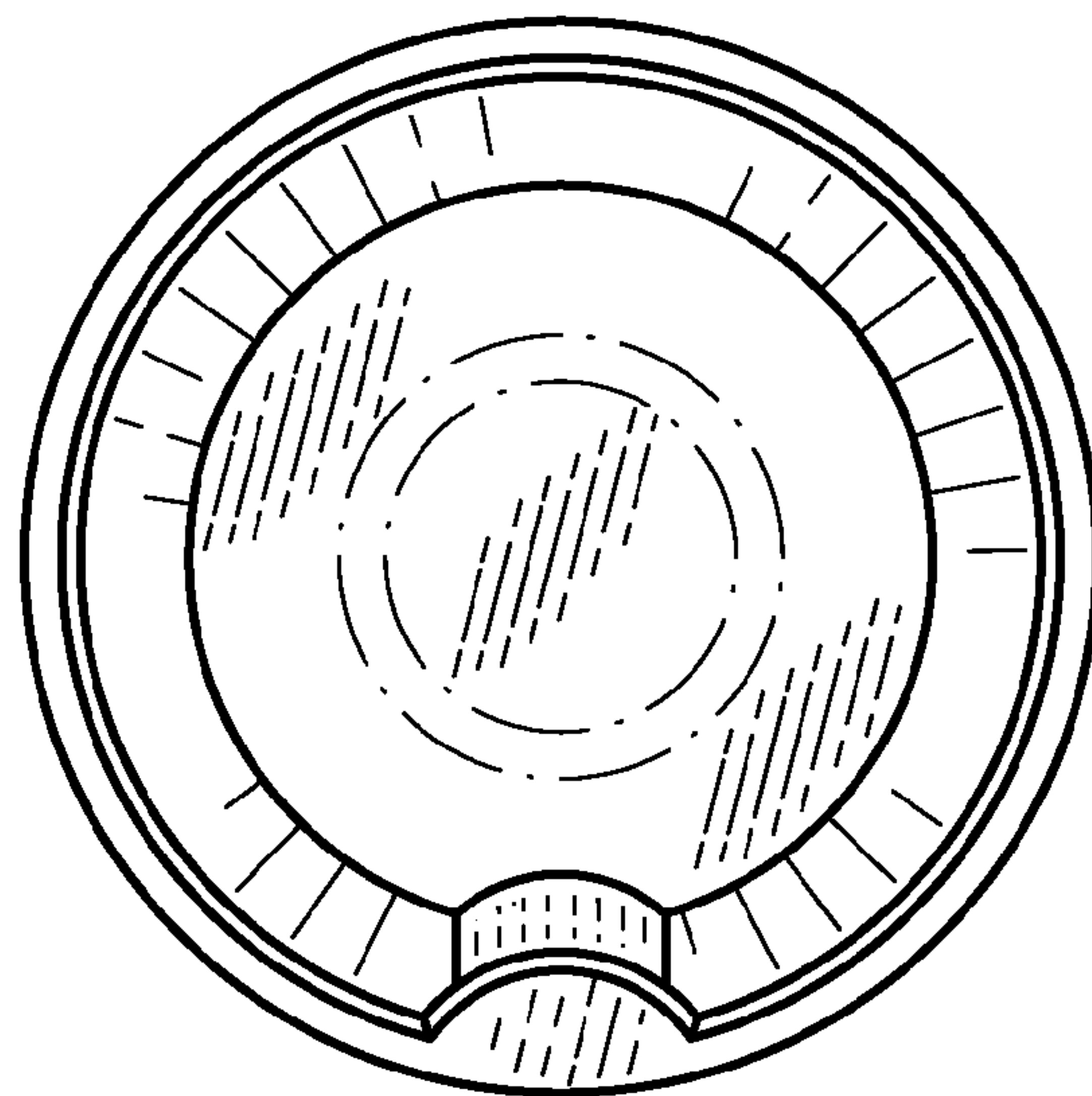

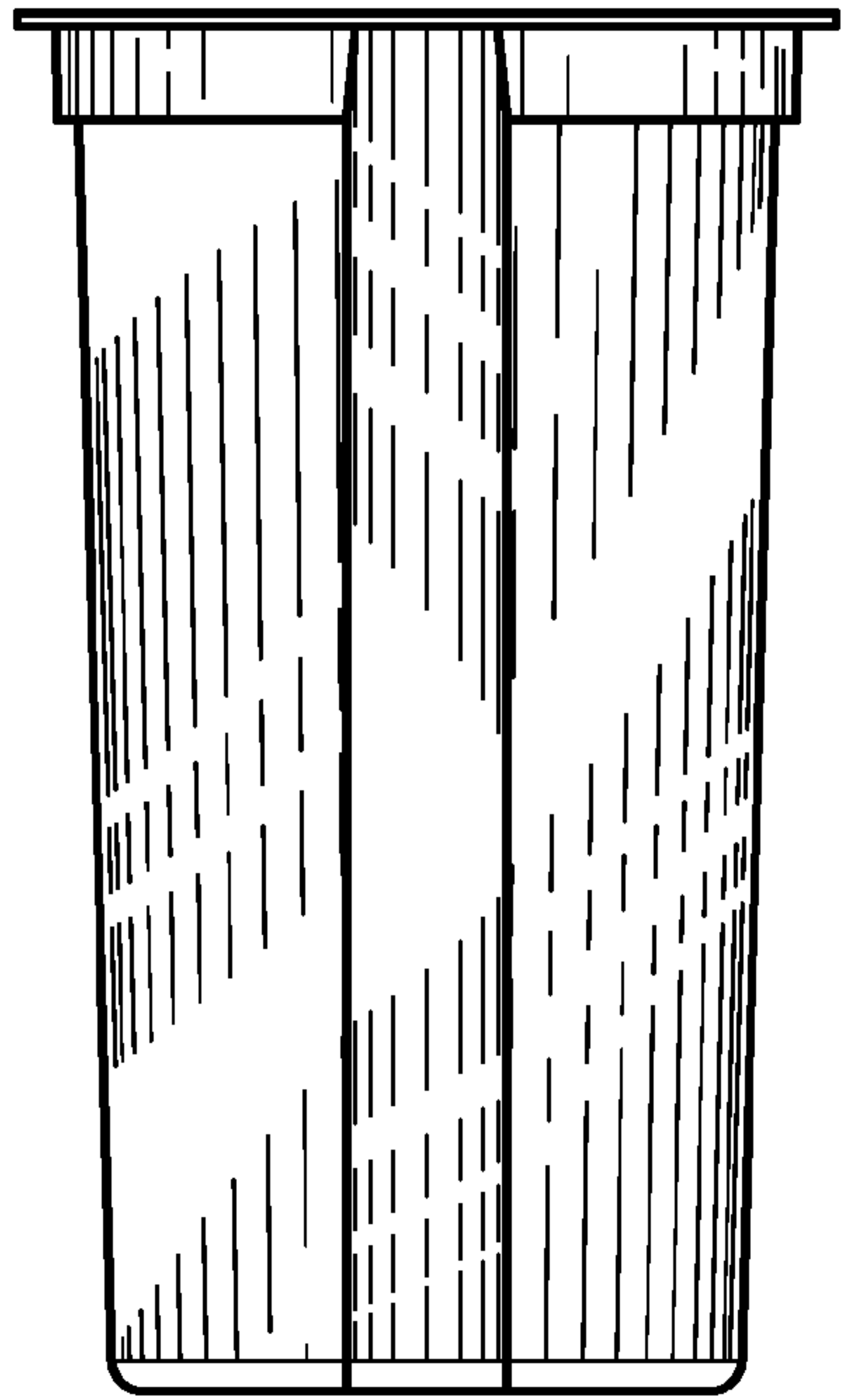

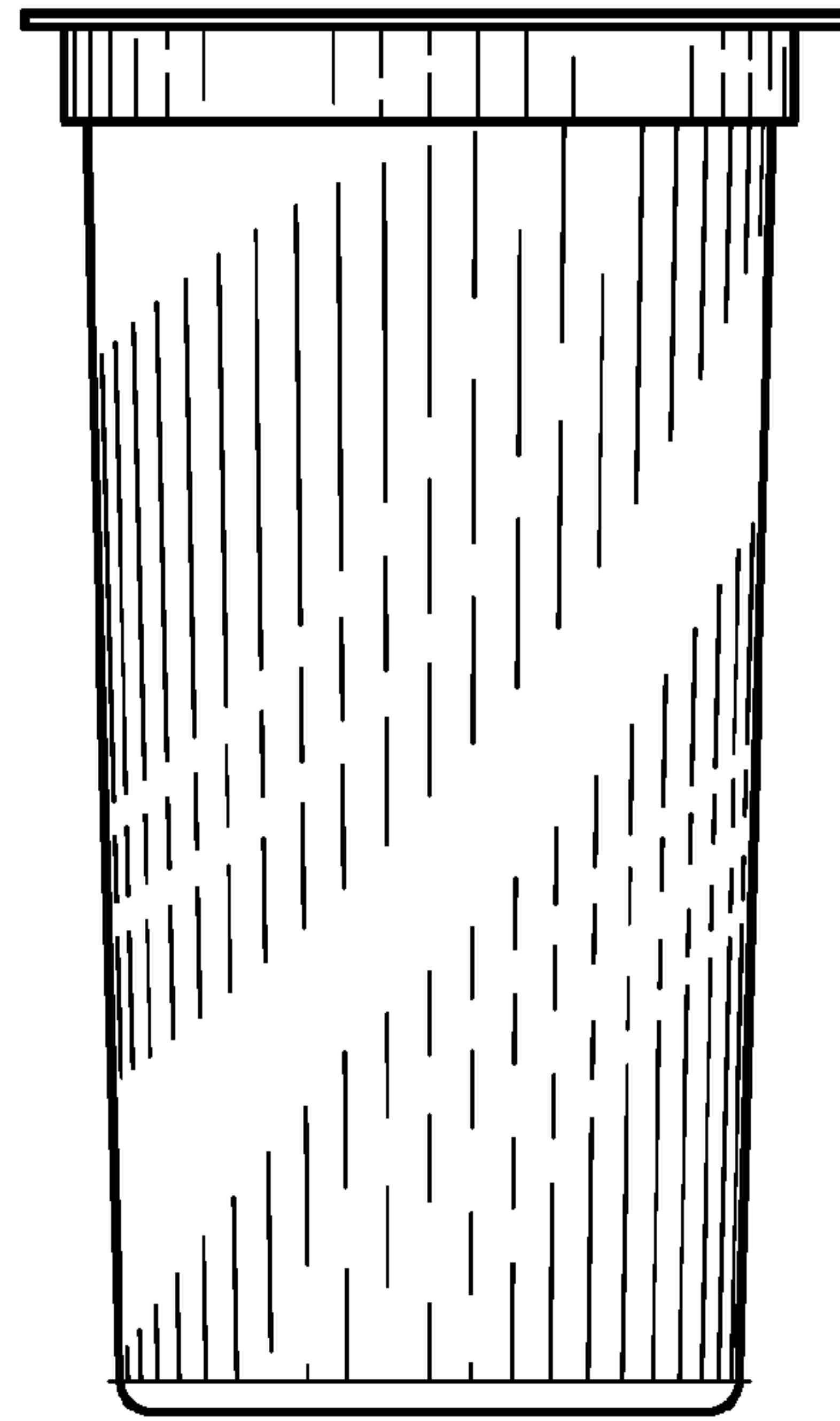

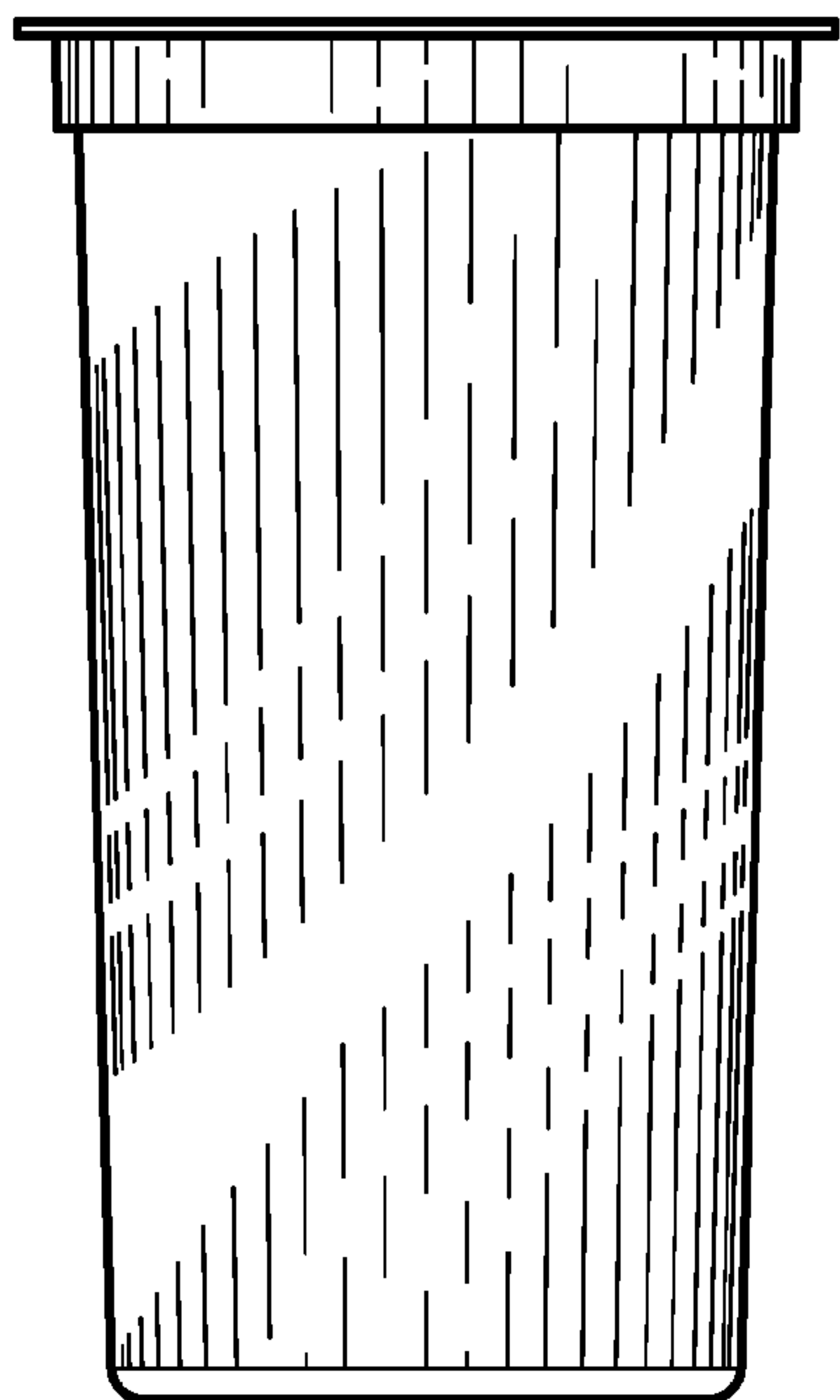

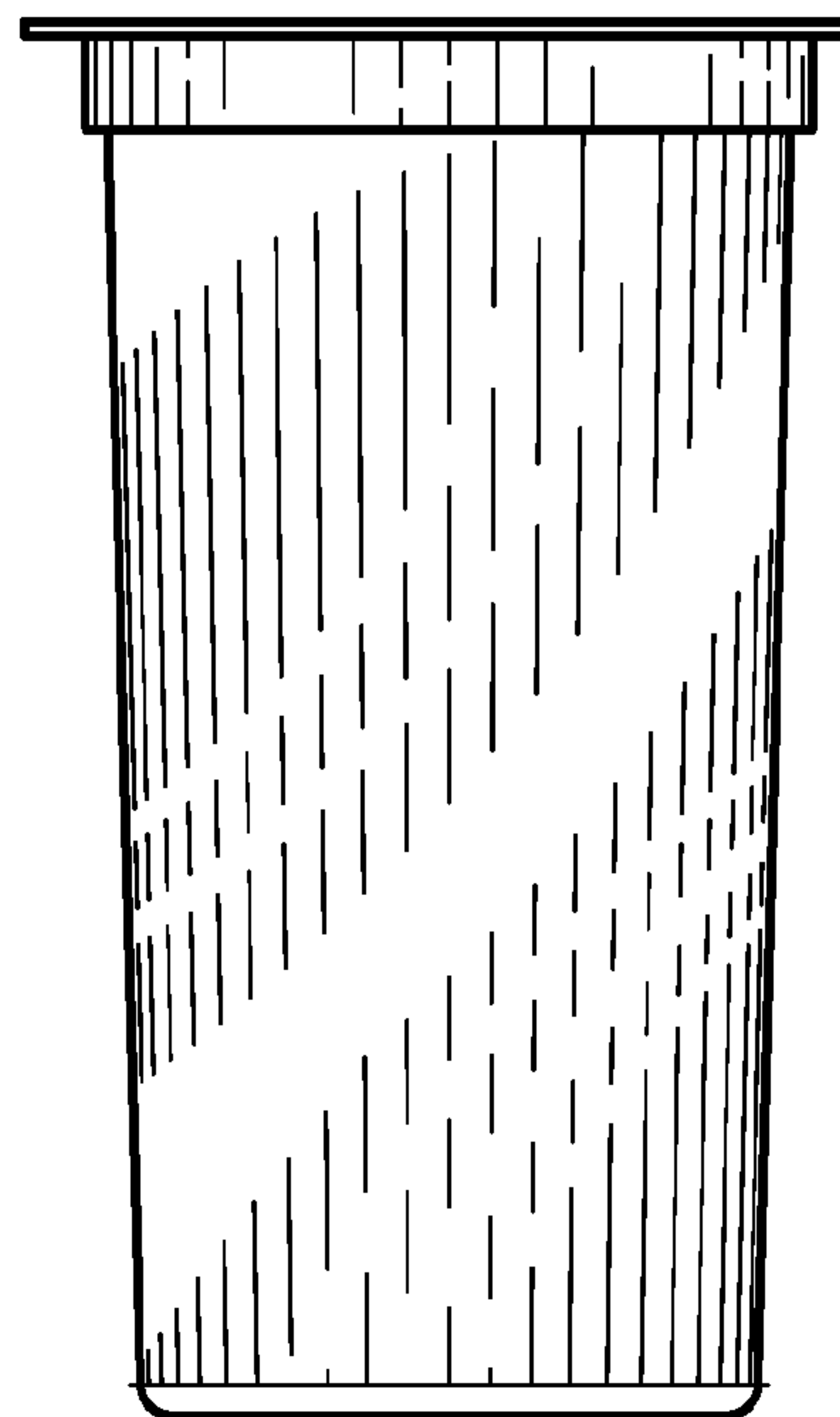

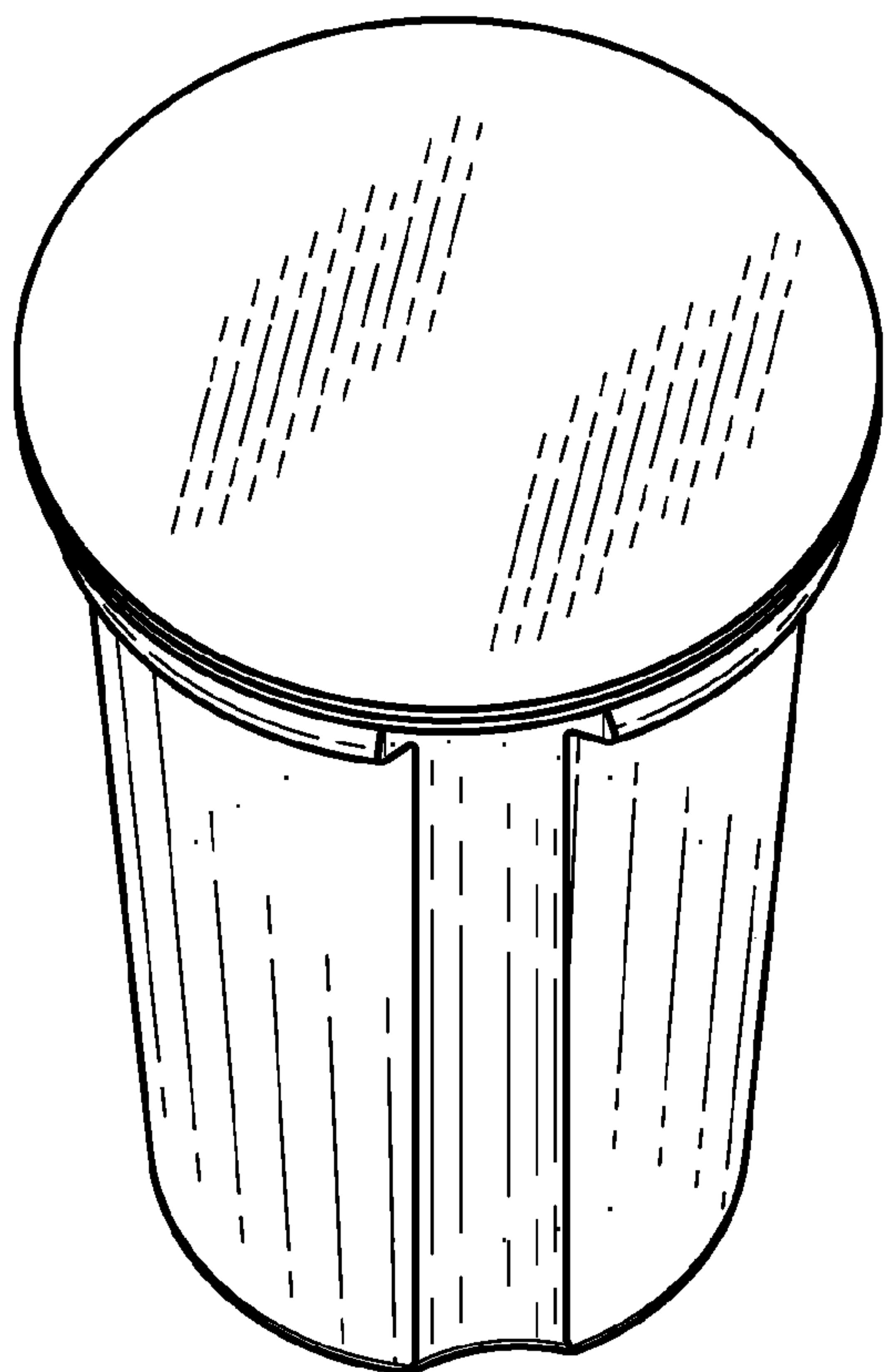

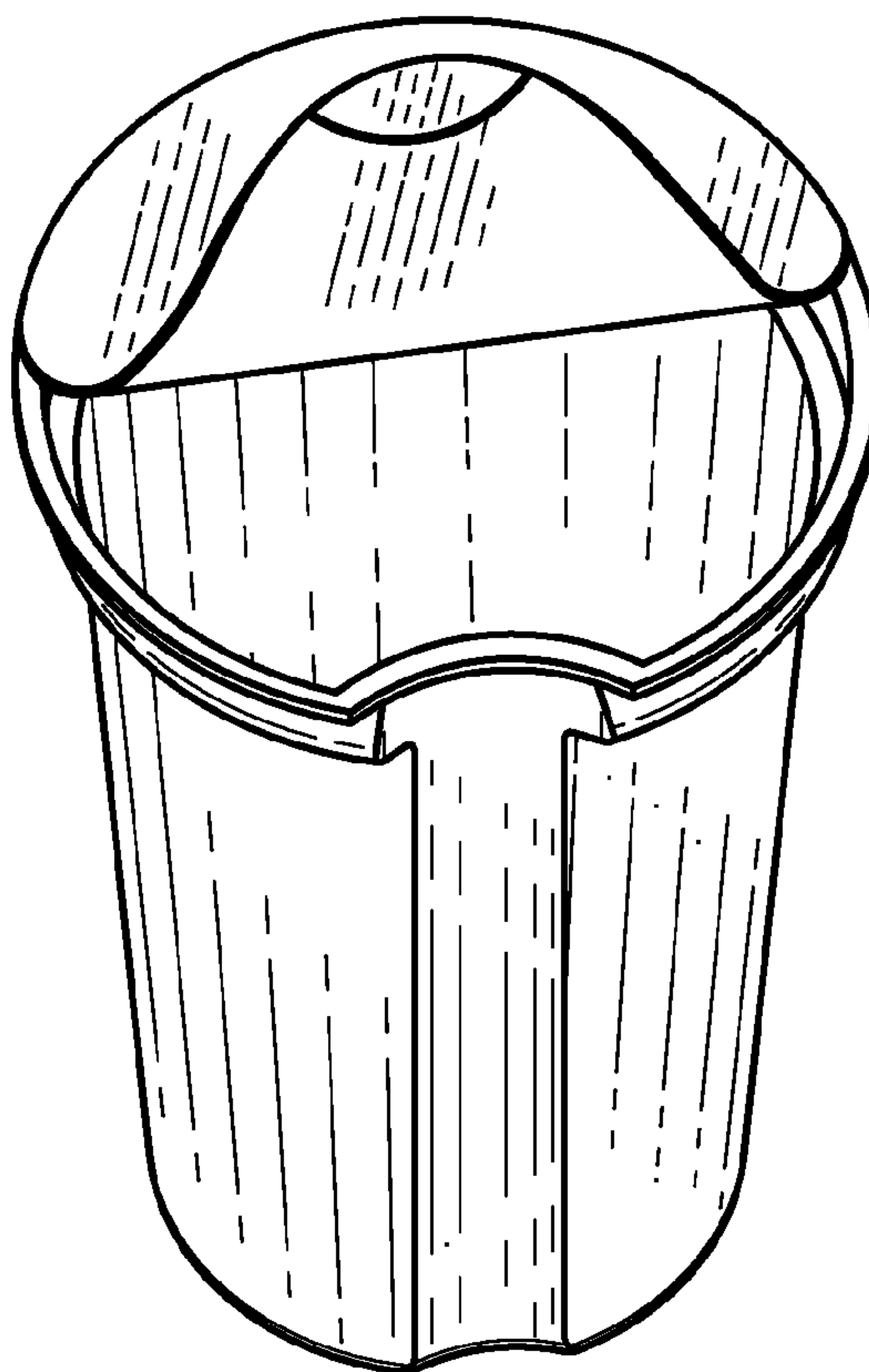

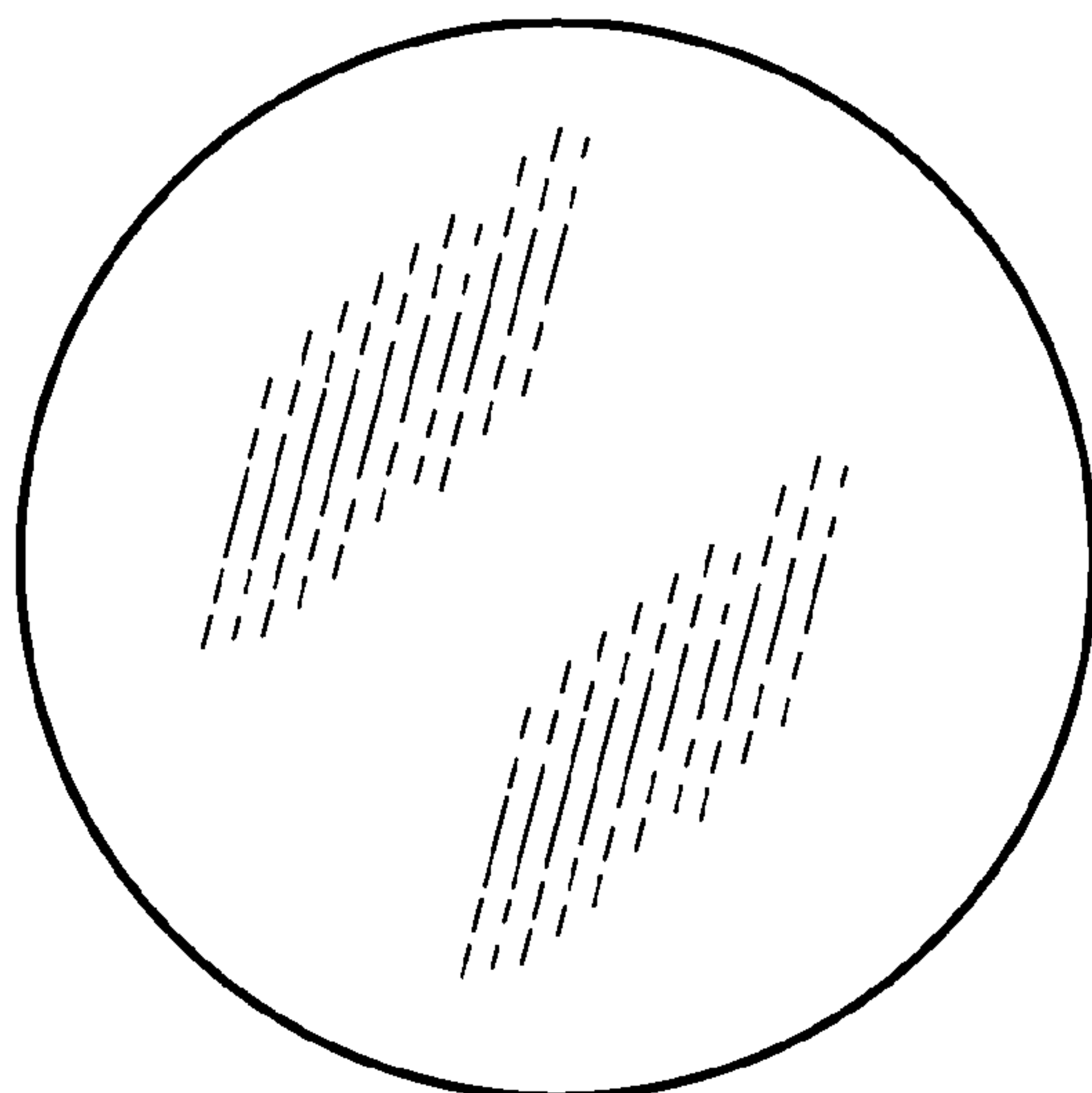

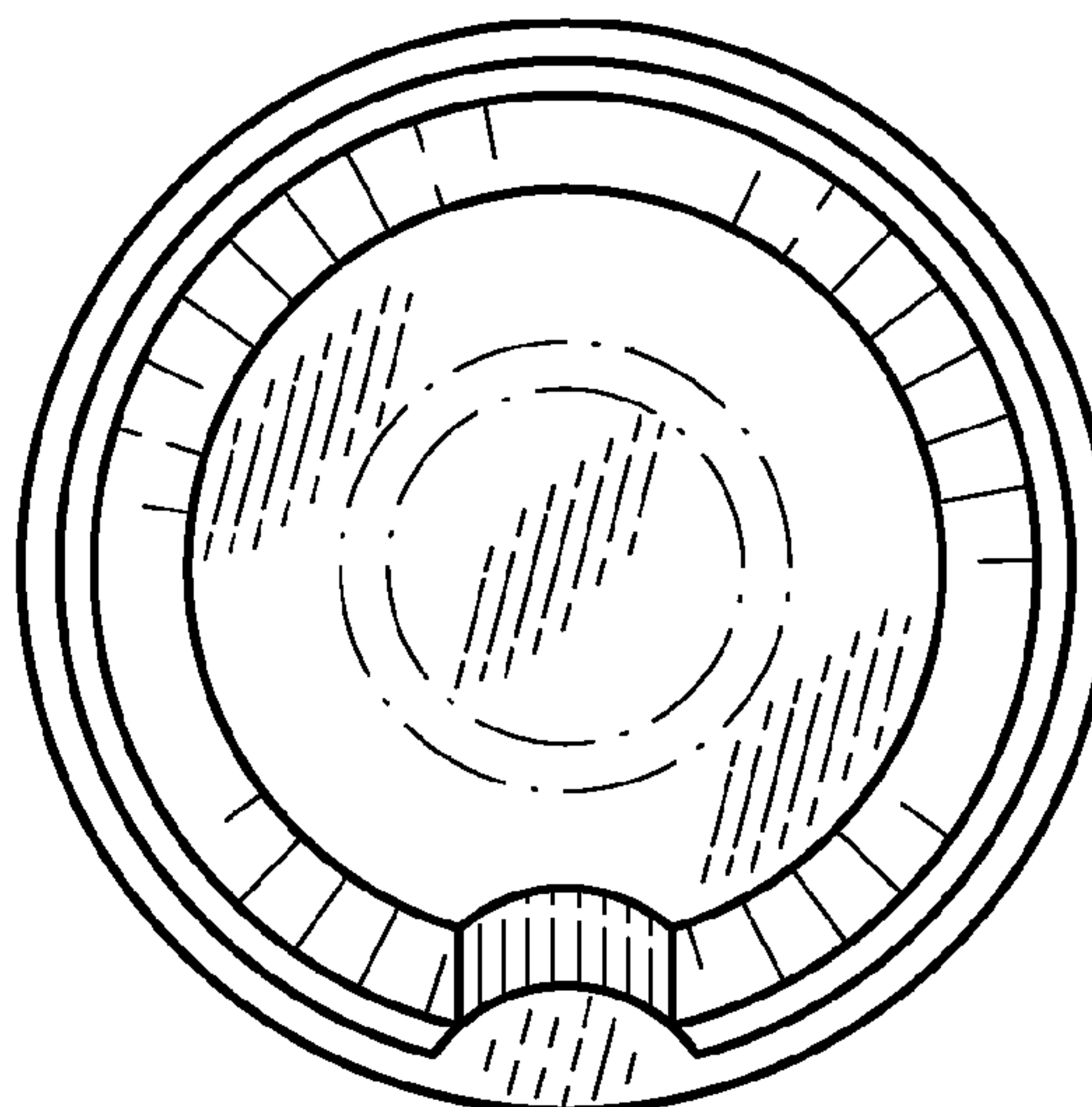

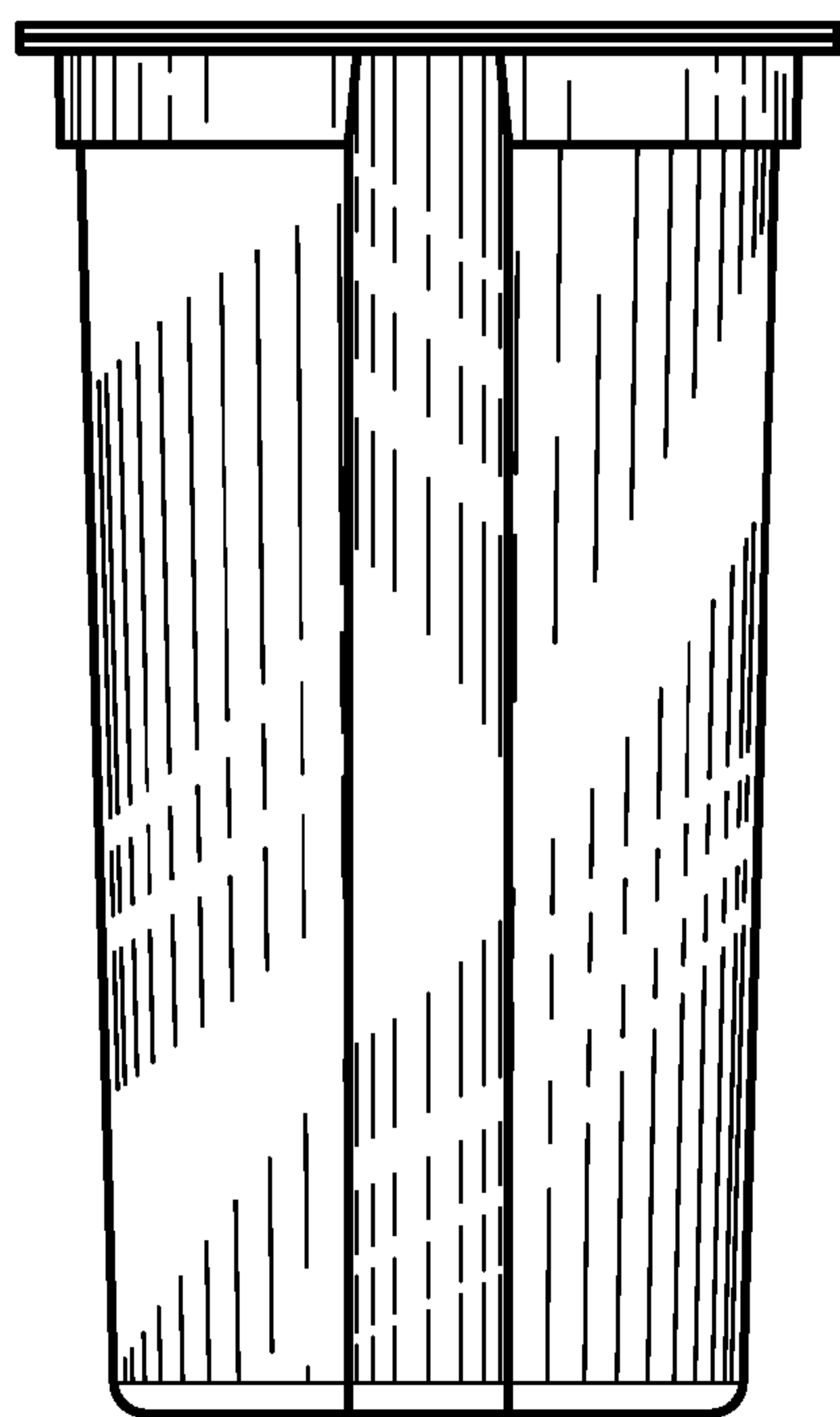

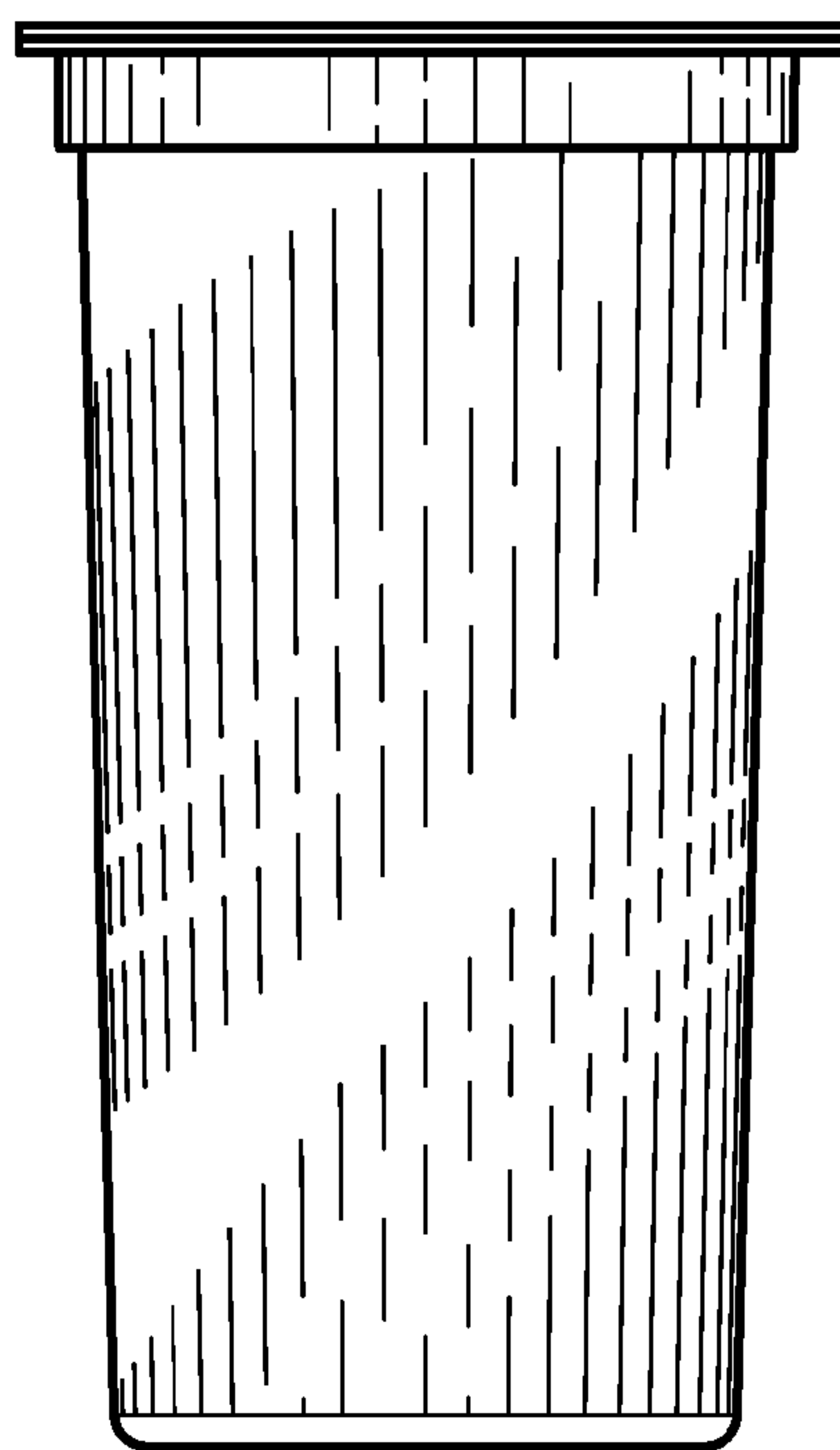

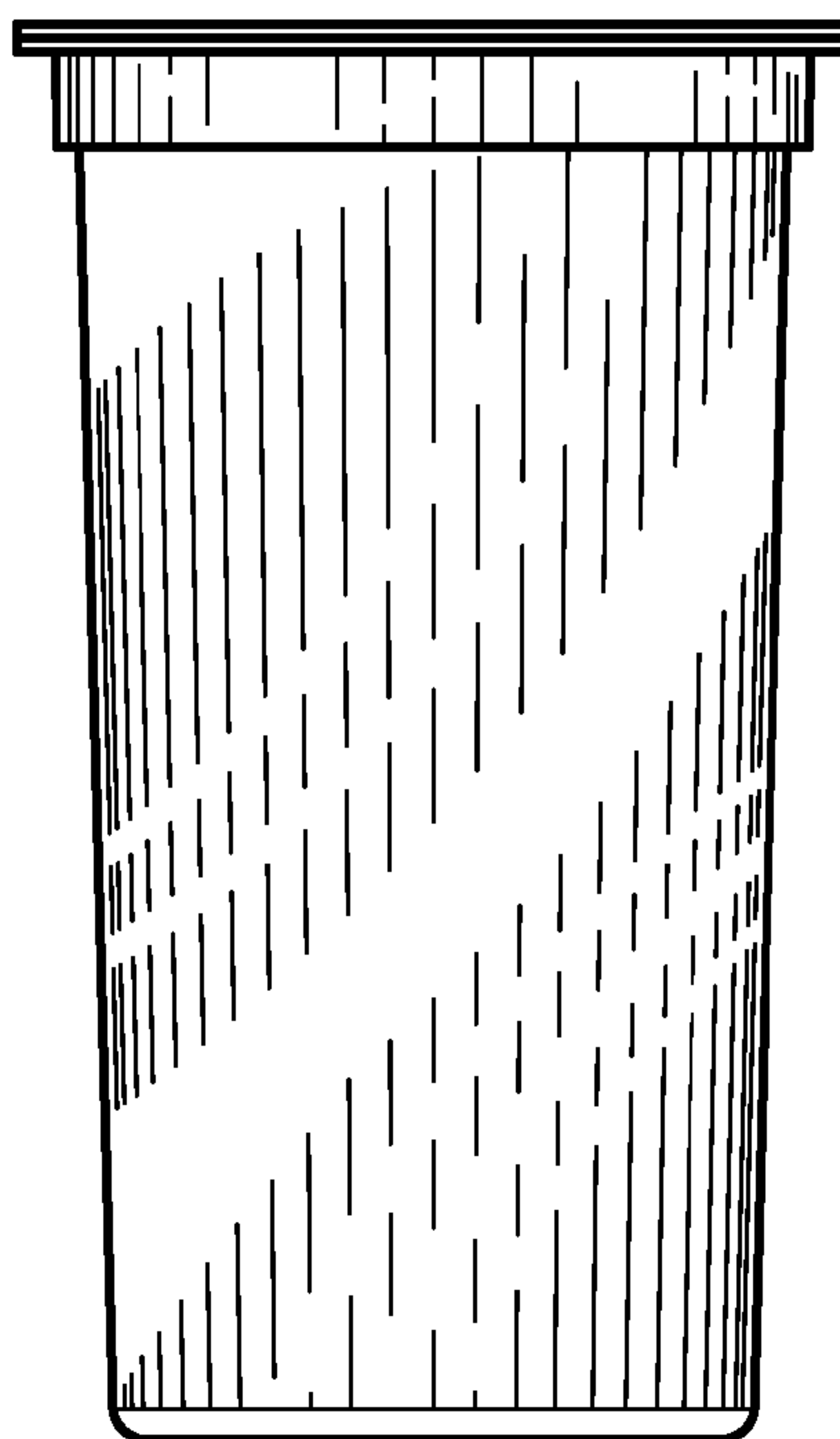
