(57) **CLAIM**

The ornamental design for storage bottle and cap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a storage bottle and cap showing our new design;

FIG. 2 is an elevation view thereof, rotated 45 degrees toward the right side;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is an elevation view thereof, rotated 45 degrees toward the rear side;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is an elevation view thereof, rotated 45 degrees toward the left side;

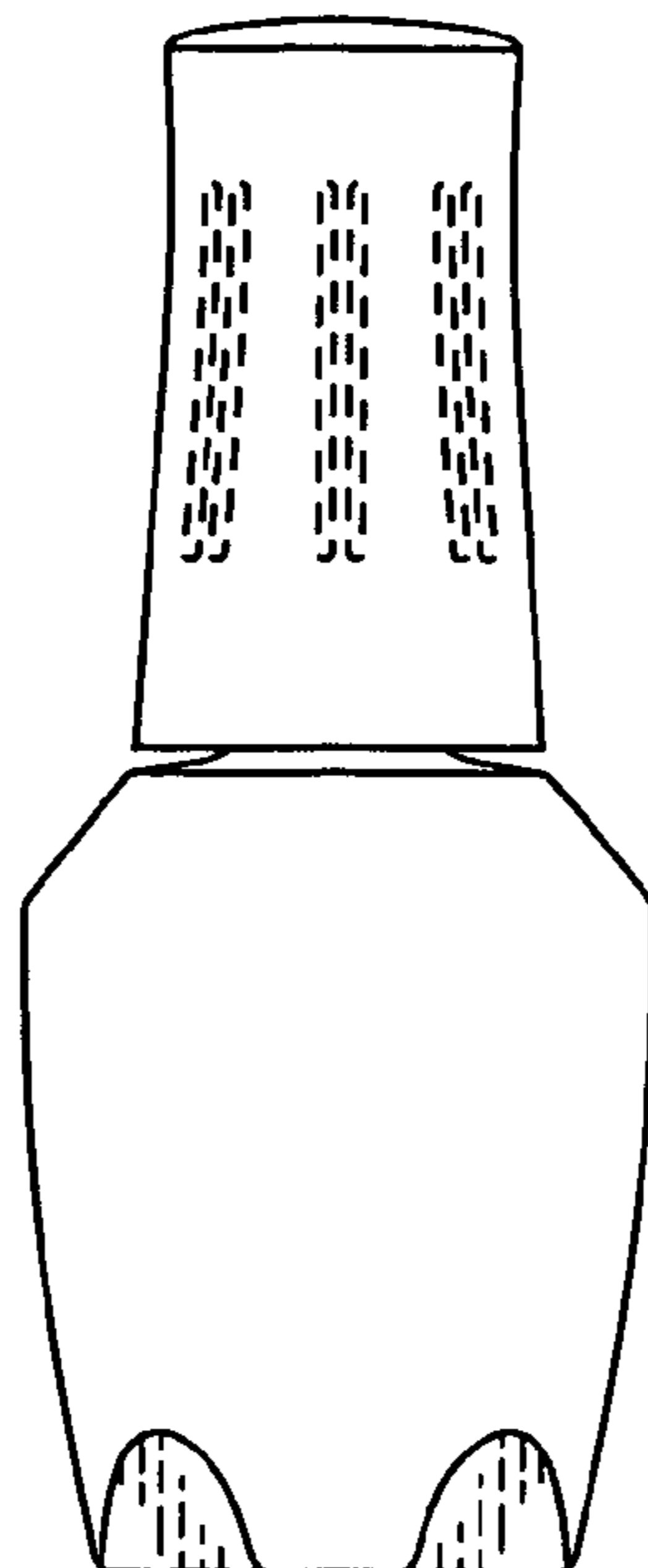
FIG. 7 is a left side elevation view thereof;

FIG. 8 is a top plan view thereof; and,

FIG. 9 is a bottom plan view thereof.

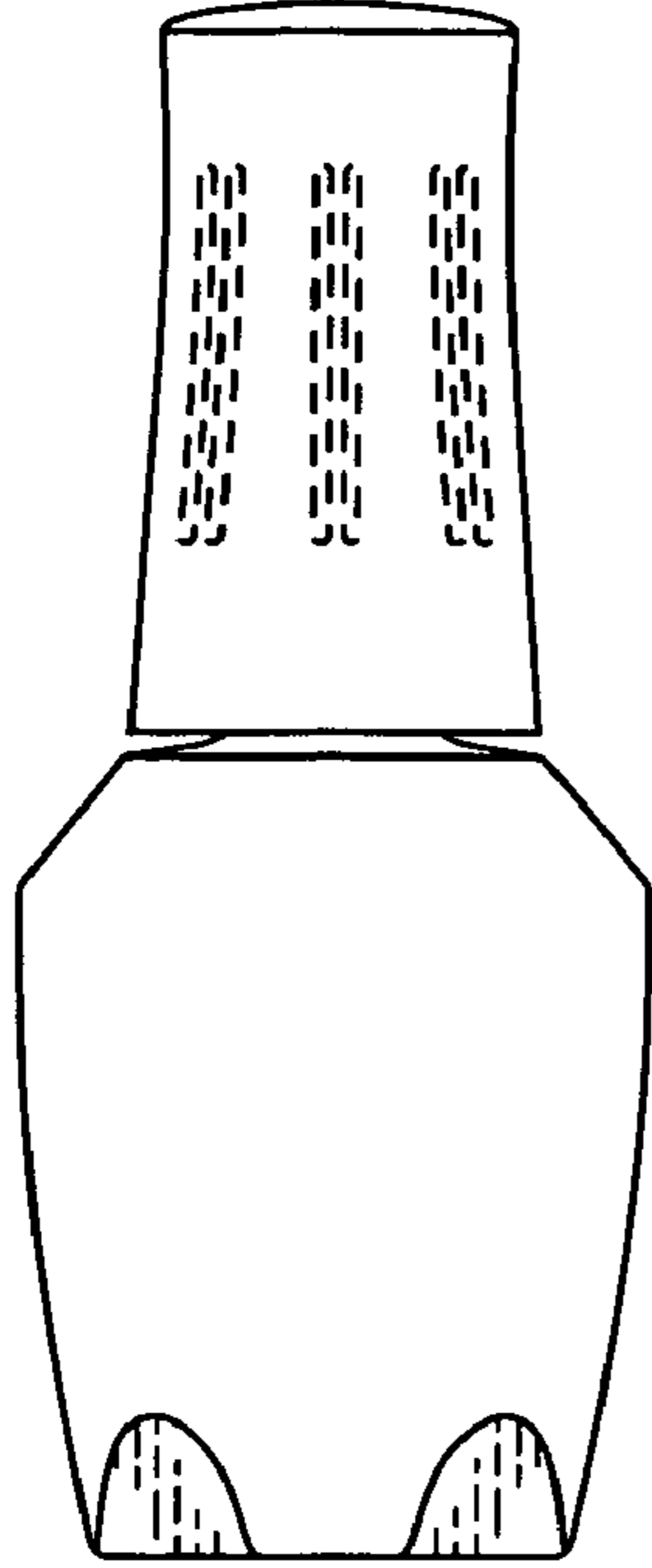

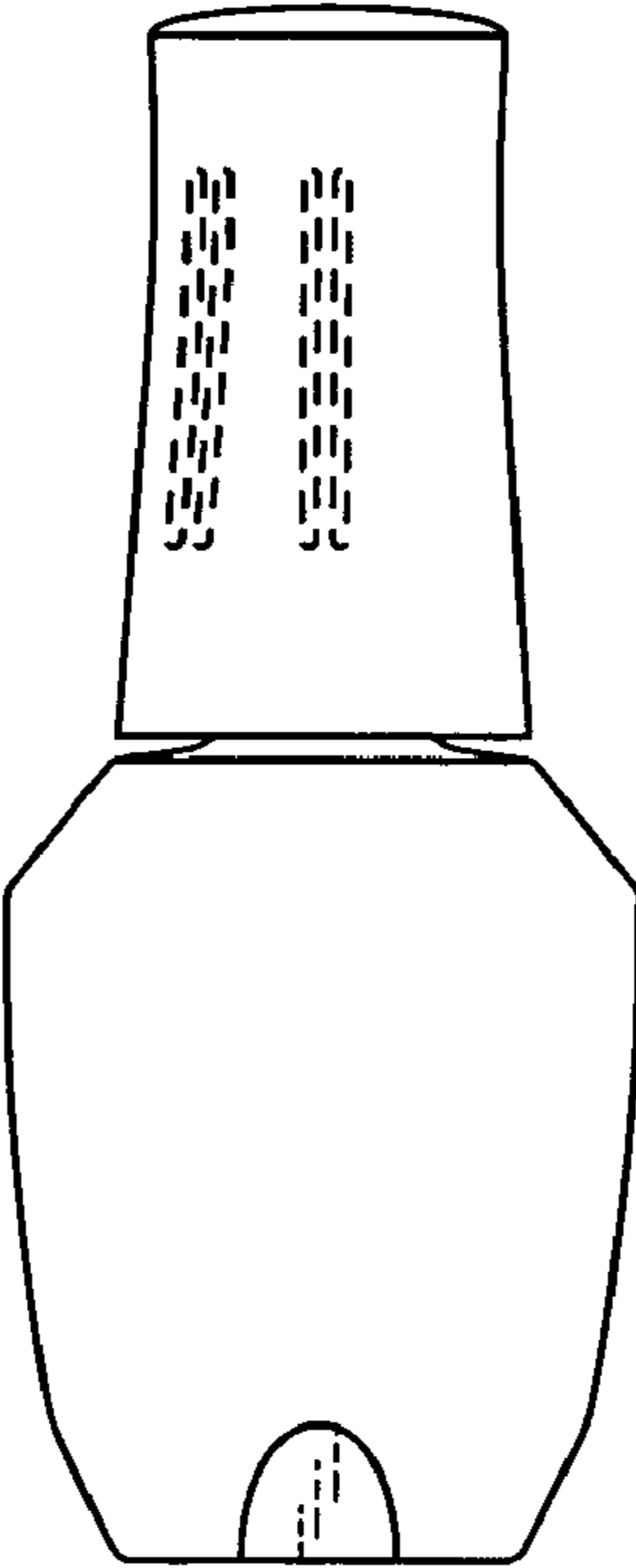

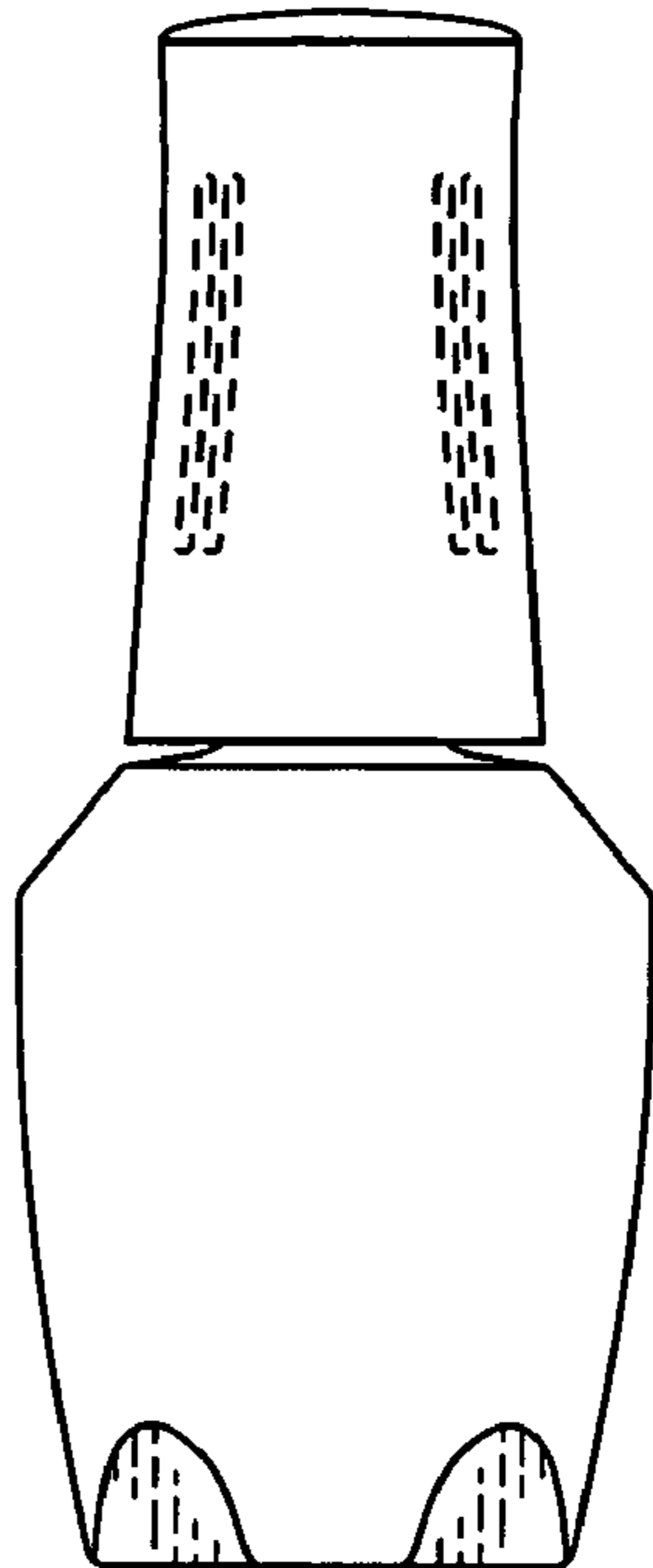

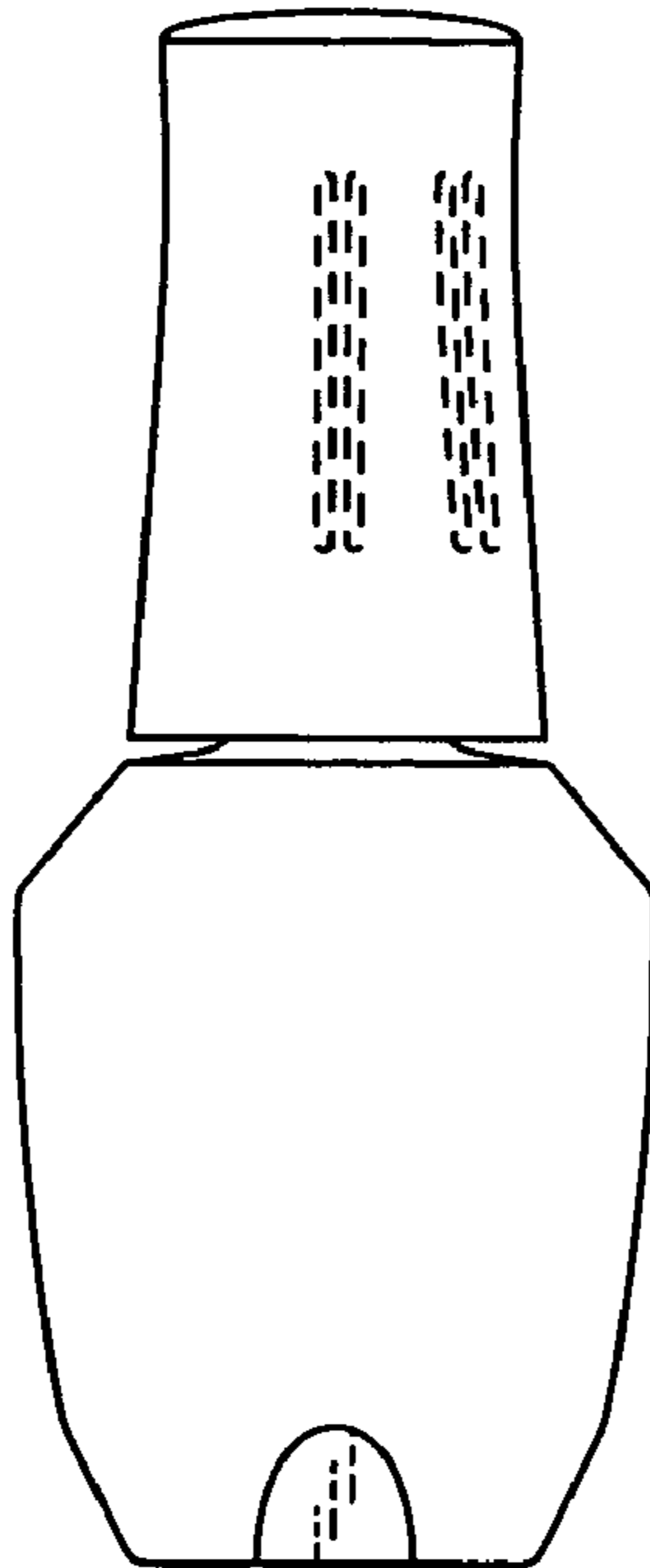

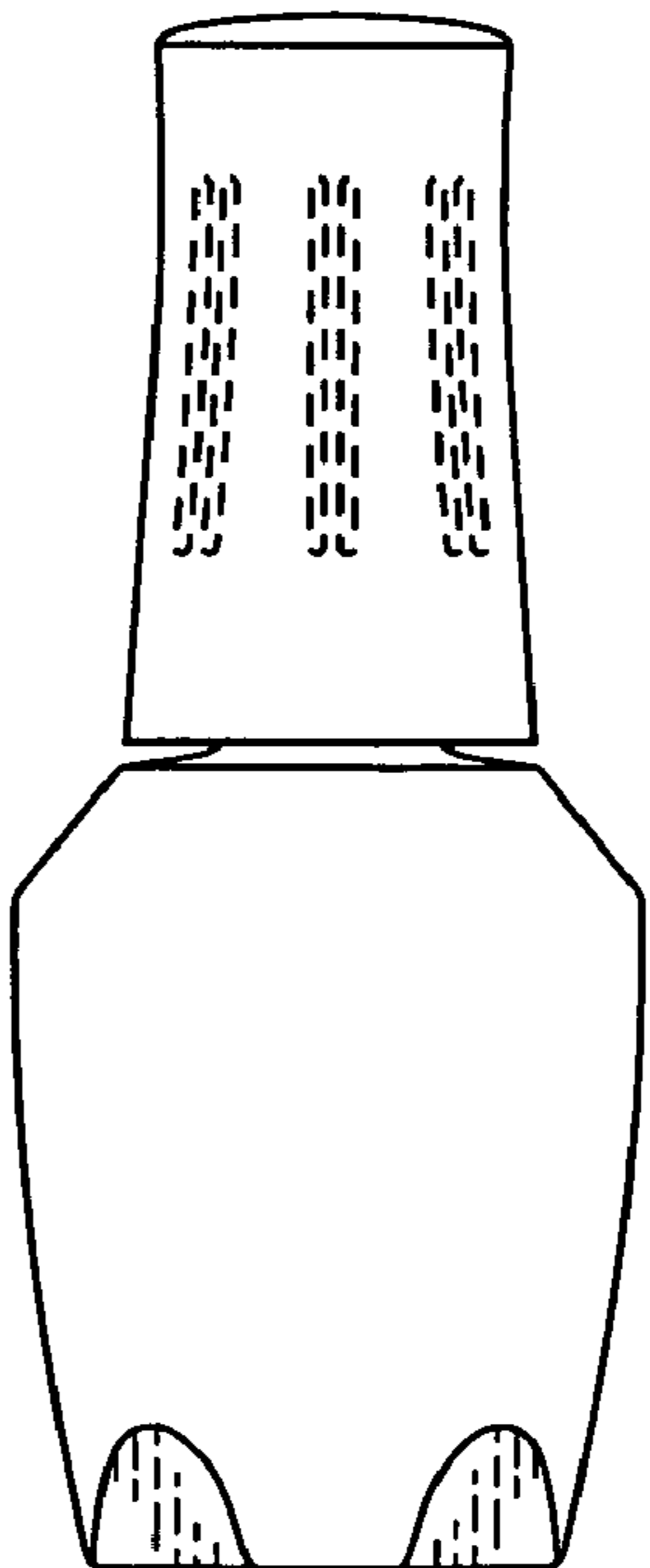

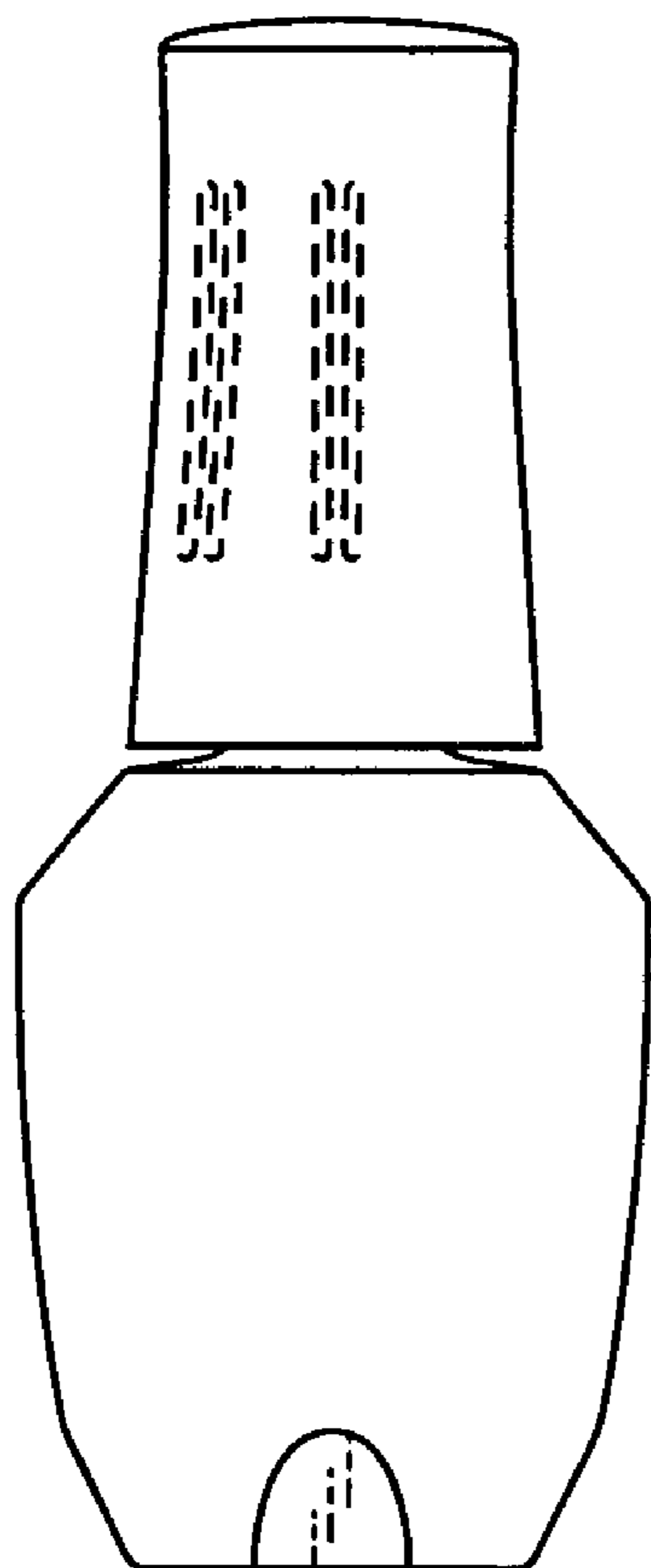

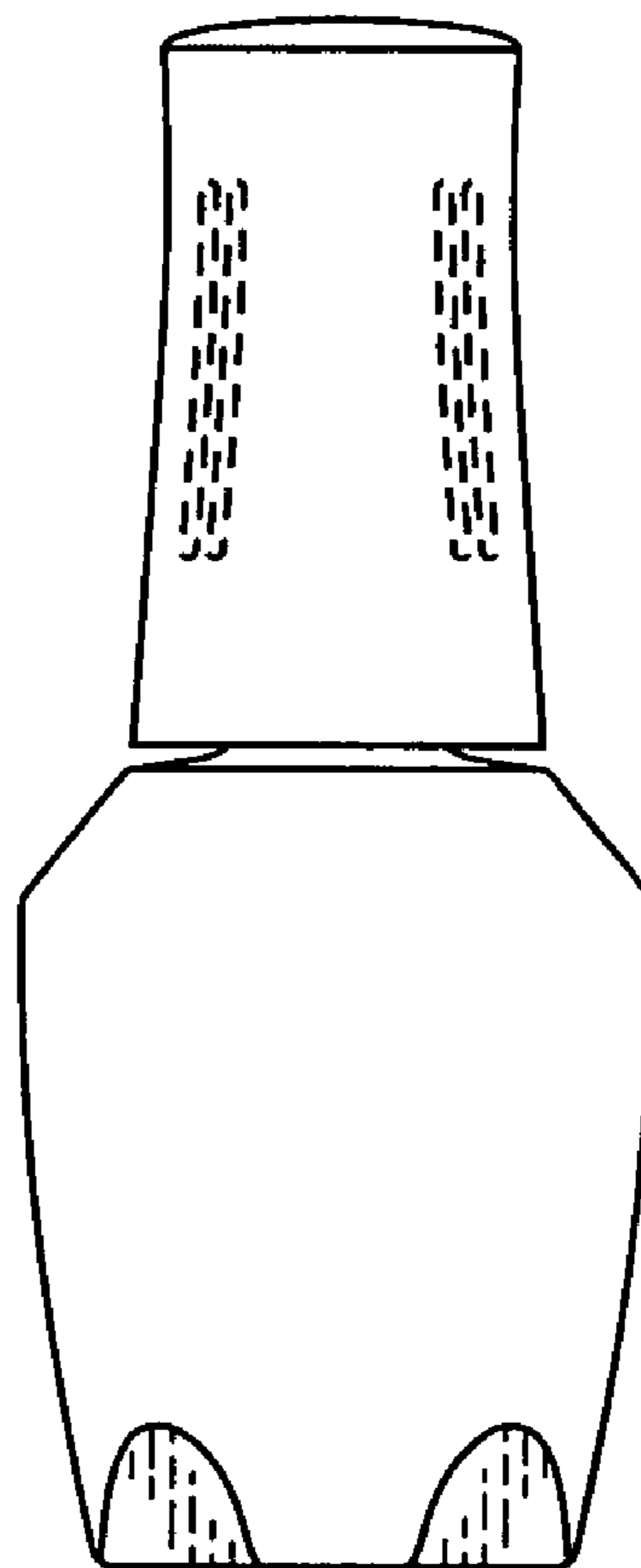

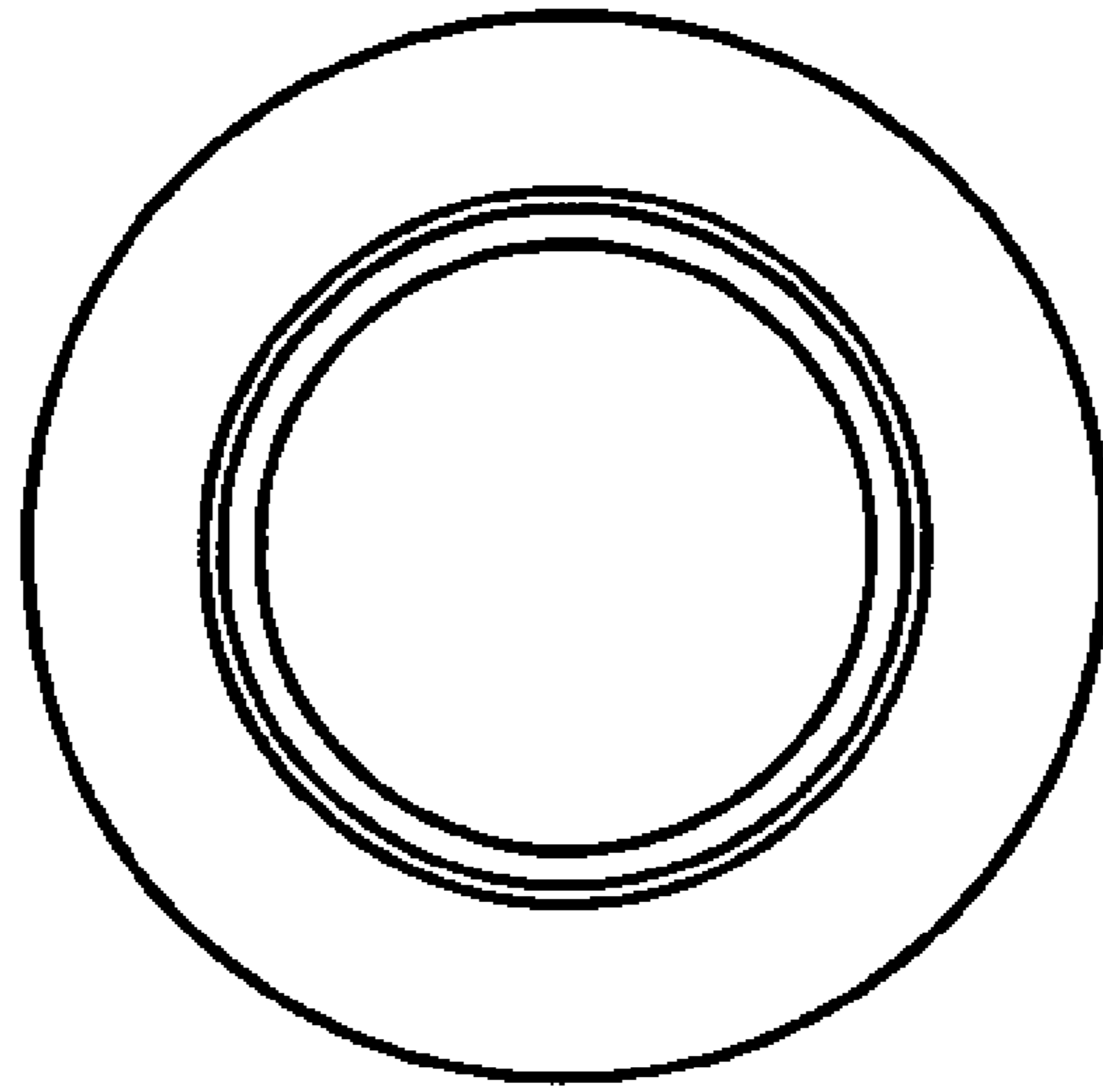

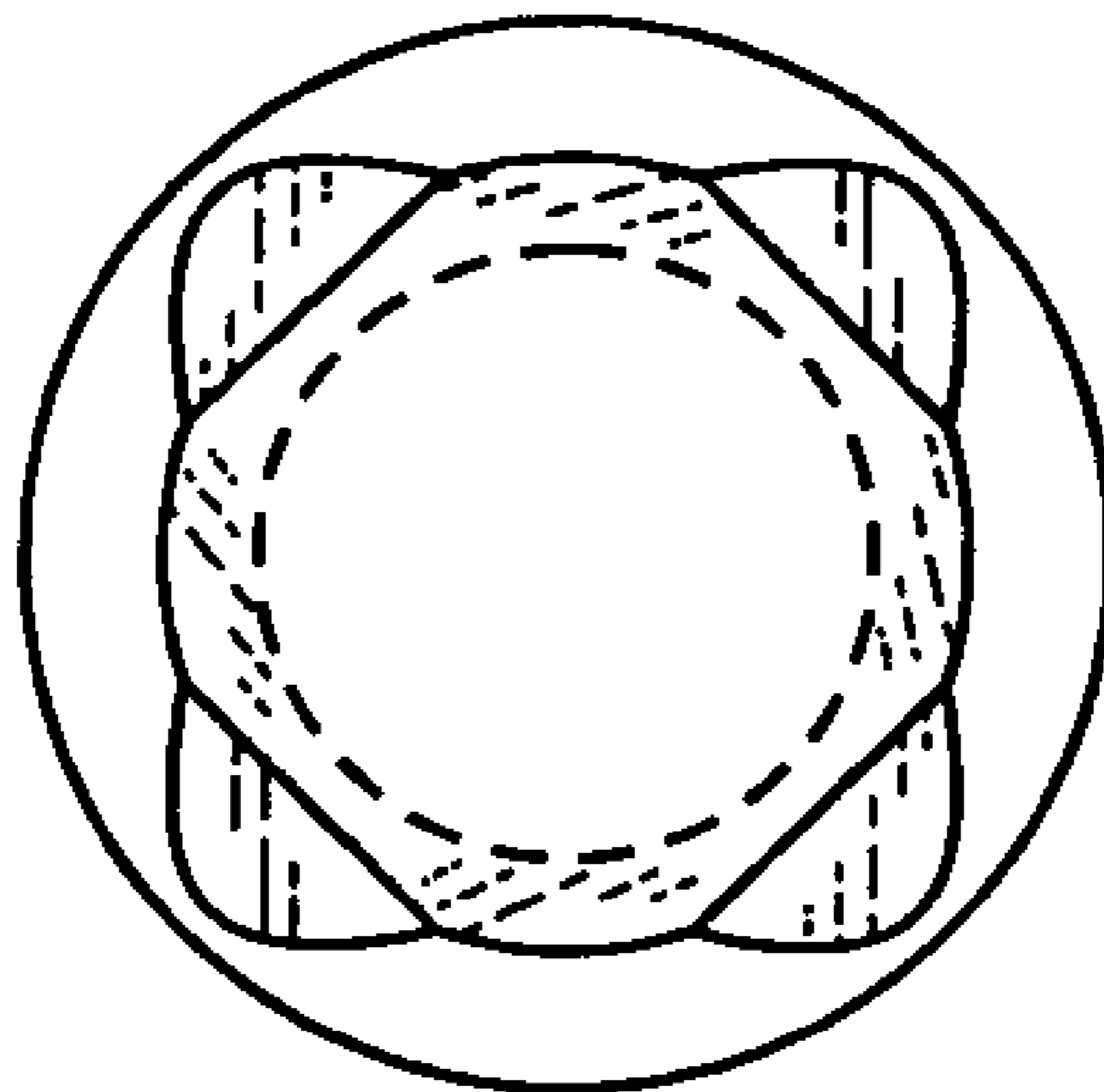
