(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a perfume bottle, showing my new design, shown with the cap separated;

FIG. 2 is a front plan view of my new design, shown with the cap attached;

FIG. 3 is a front plan view of my new design, shown without the cap attached;

FIG. 4 is a rear elevational view of my new design;

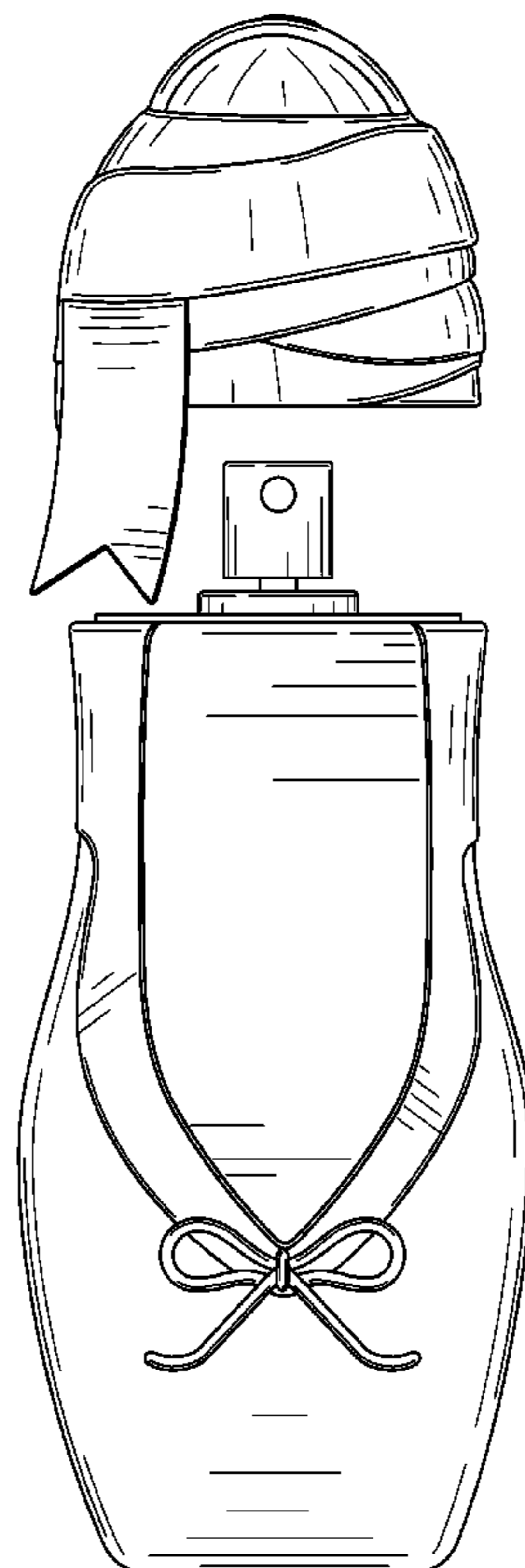
FIG. 5 is a right side elevational view of my design;

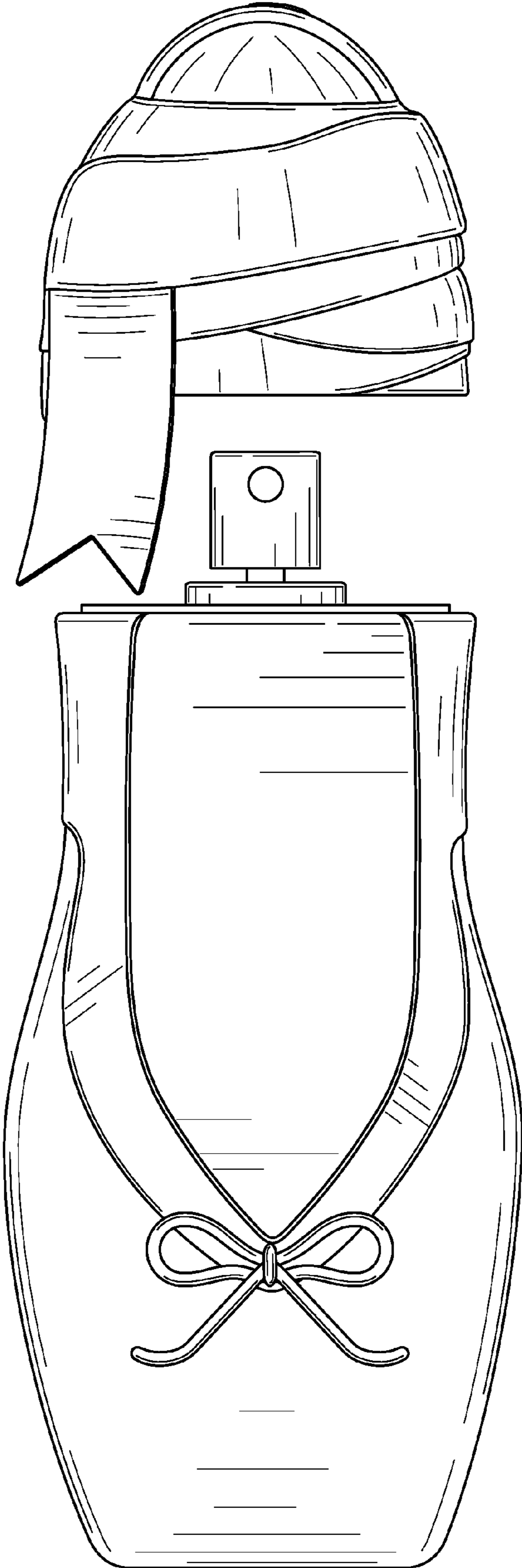

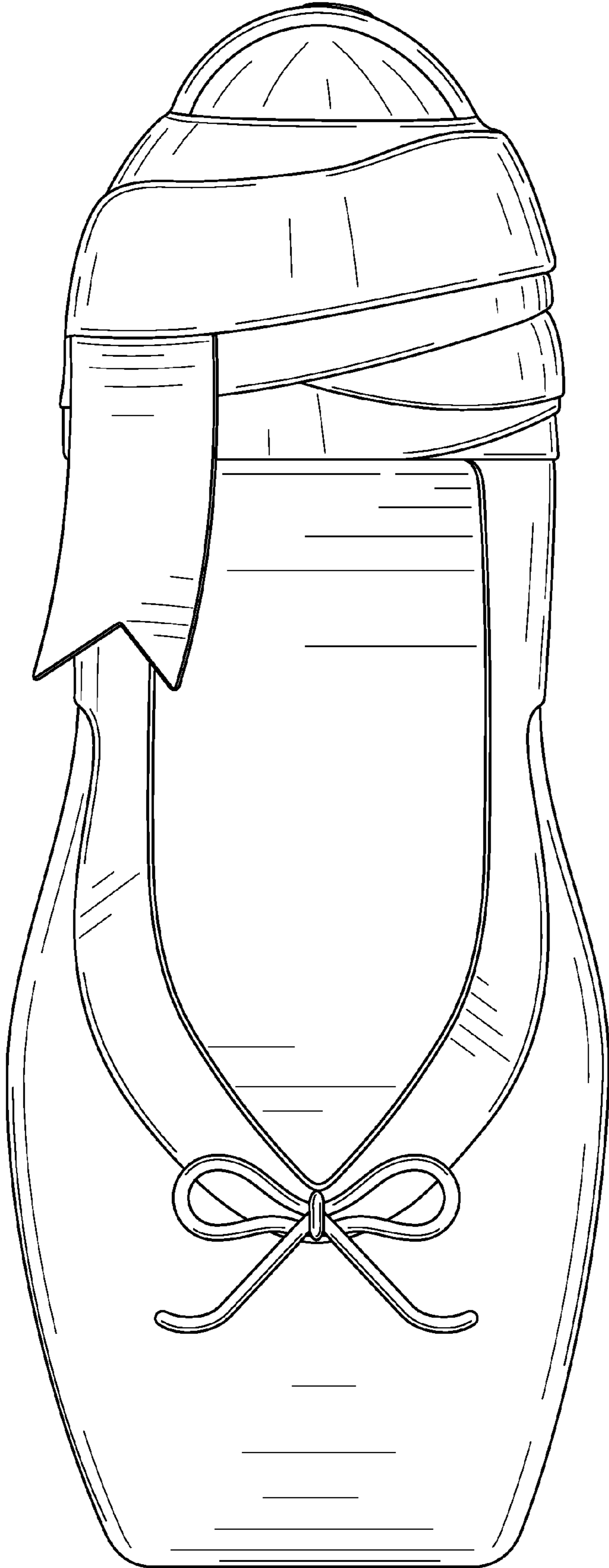

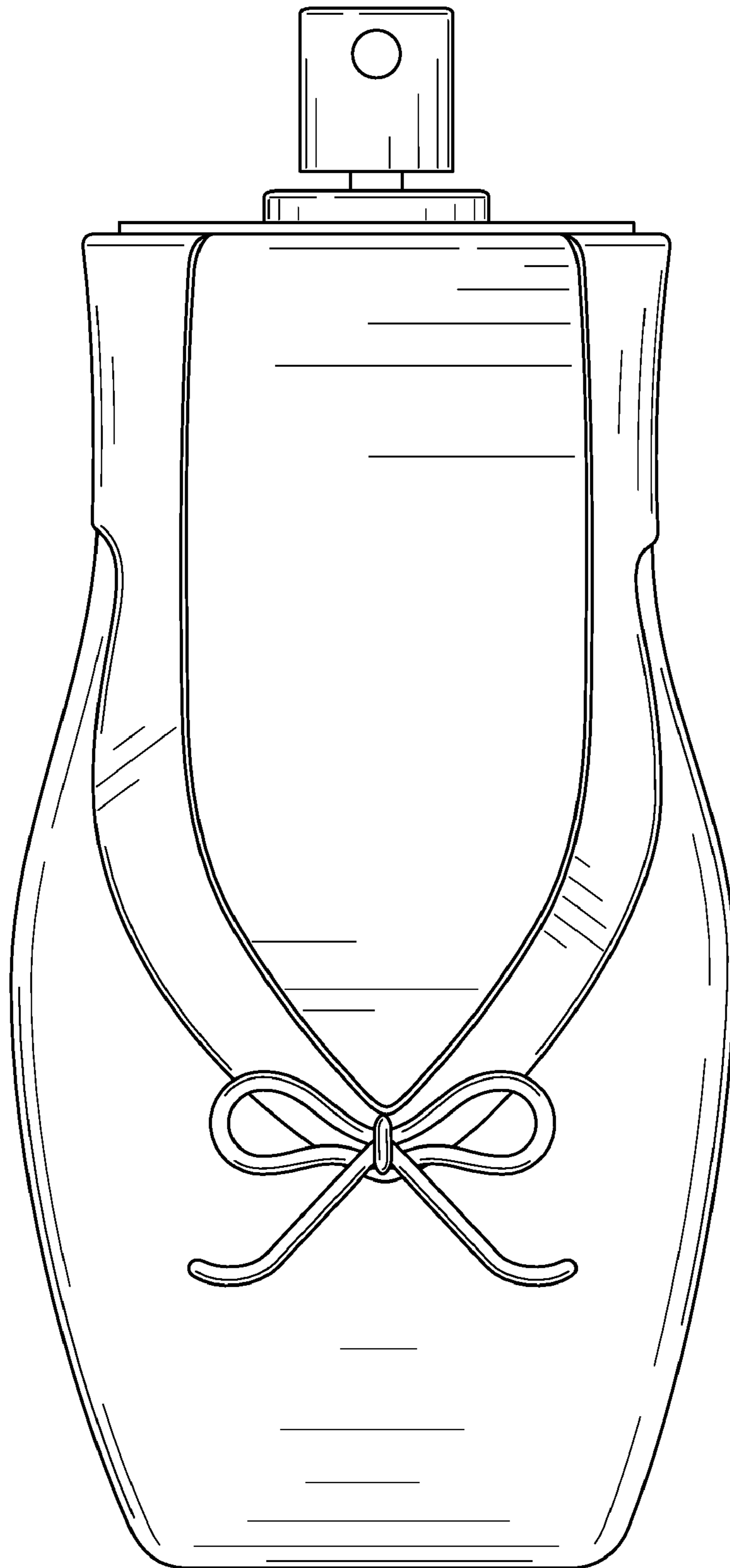

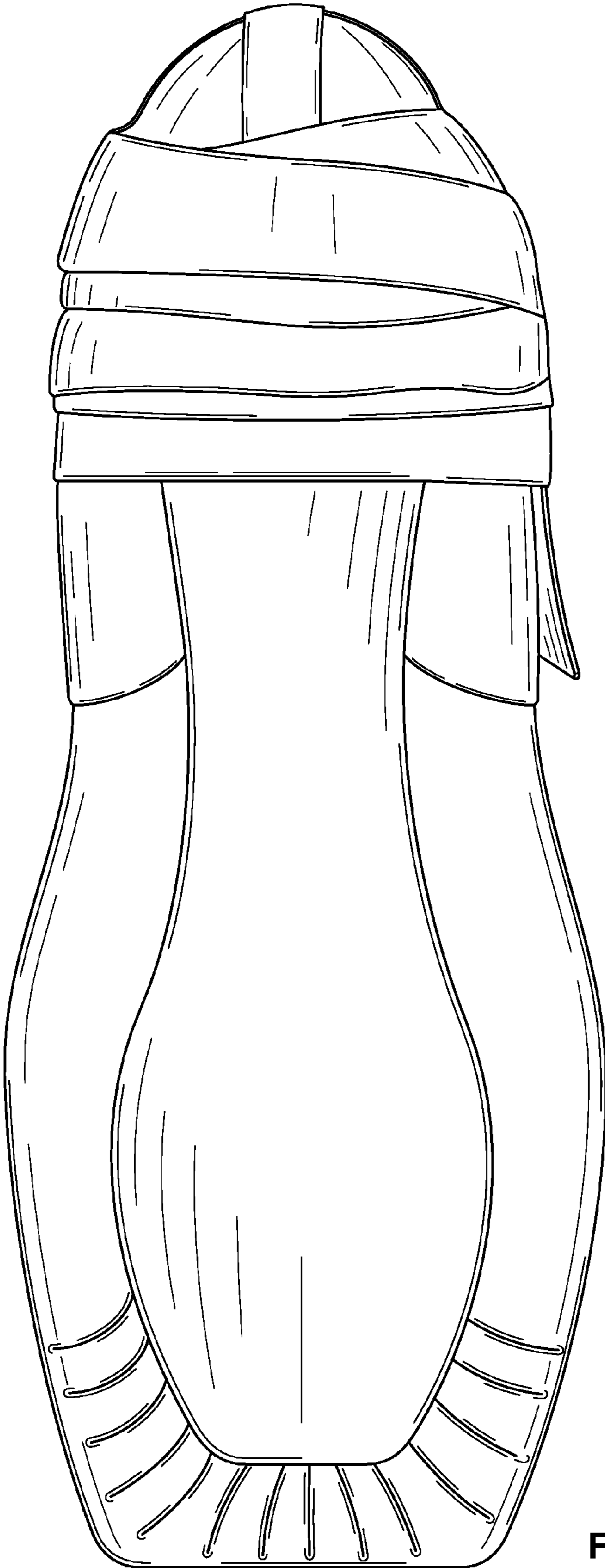

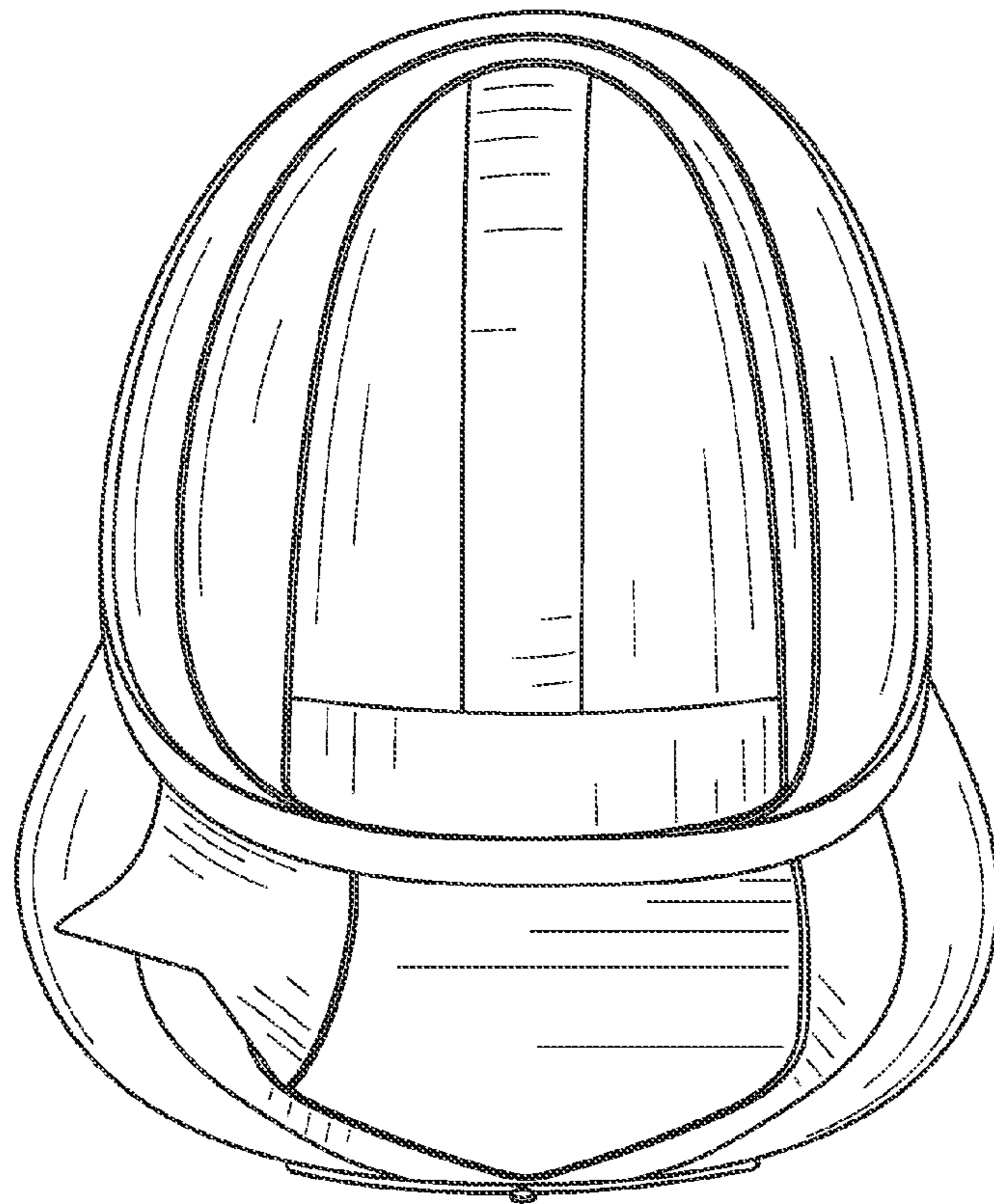

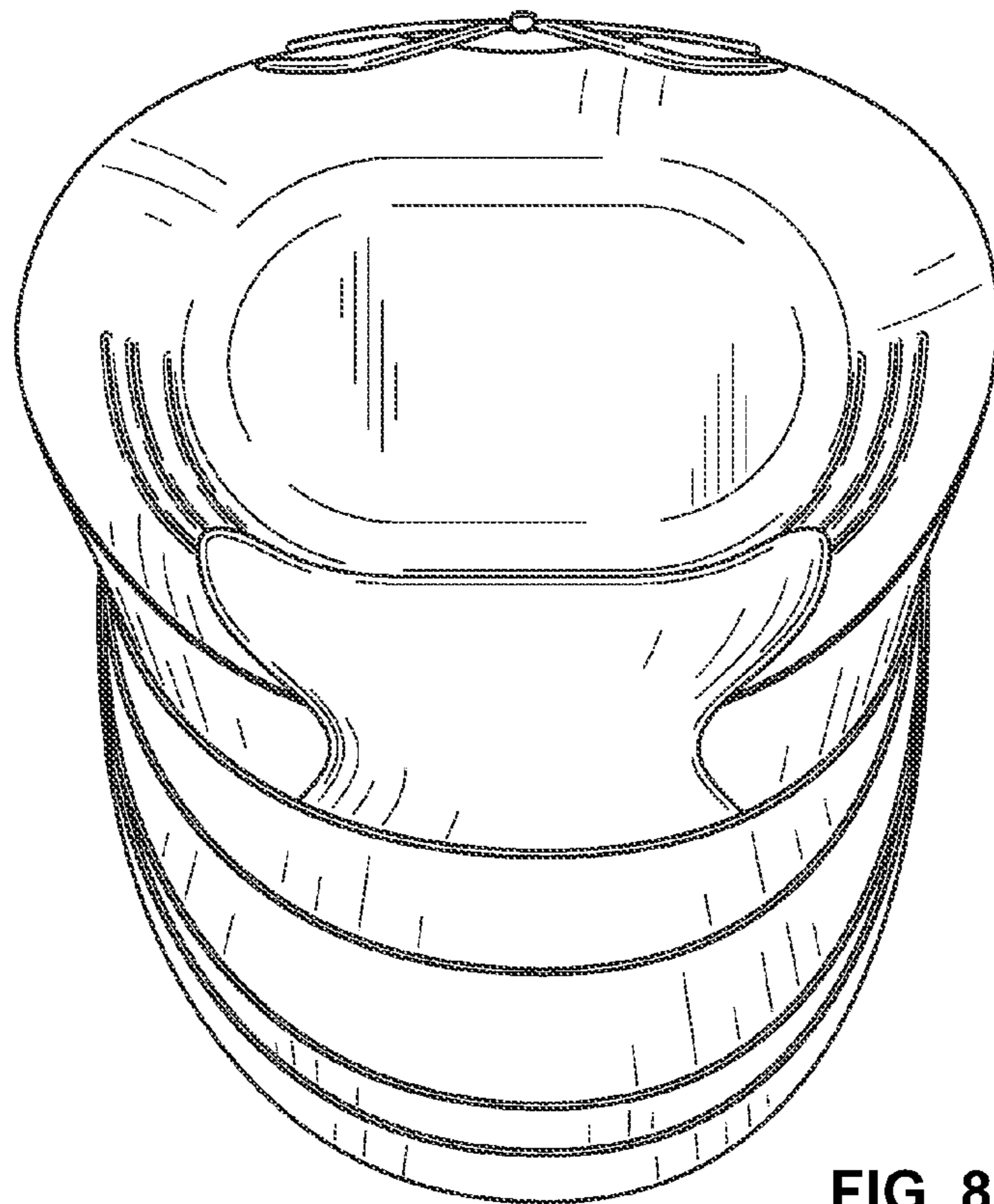
