(57) **CLAIM**

The ornamental design for a front face of an electronic water timer, as shown and described.

DESCRIPTION

Cross reference is made to co-pending U.S. patent applications: Ser. No. 12/346,466, entitled “Water Timer System having Removable Input and Display Module” by Rick L. Leer and William F. Zore; Ser. No. 29/330,183, entitled “Front Face of an Electronic Water Timer” by Rick L. Leer and William F. Zore; and Ser. No. 29/330,187, entitled “Water Timer” by Rick L. Leer and William F. Zore, all of which are assigned to the same assignee of the present invention, and all of which are filed on the same date herewith. All of the above-identified patent applications are herein incorporated by reference in their entirety.

The FIGURE is an elevational view of a front face of an electronic water timer showing my new design.

The broken line showing of portions of the front face of the electronic water timer, including the crisscross surface pattern portion located around the peripheral portion of the front face, is included for illustrative purposes only and forms no part of the claimed design.

The claimed portions of the Front Face of an electronic water timer, which are shown in solid lines in the FIGURE, are flat.
