FIG. 4 is a right side view thereof;

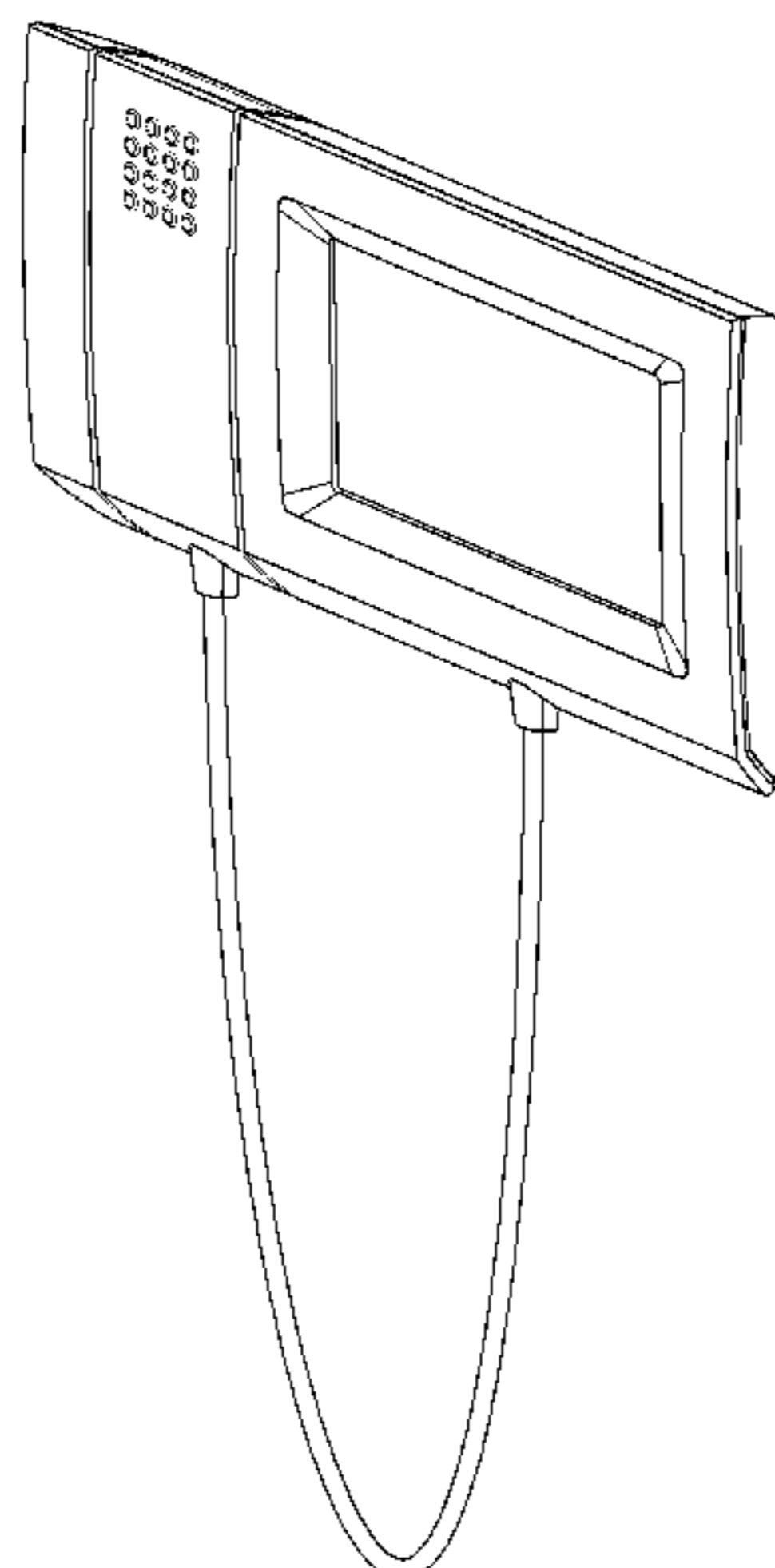
FIG. 5 is a left side view thereof;

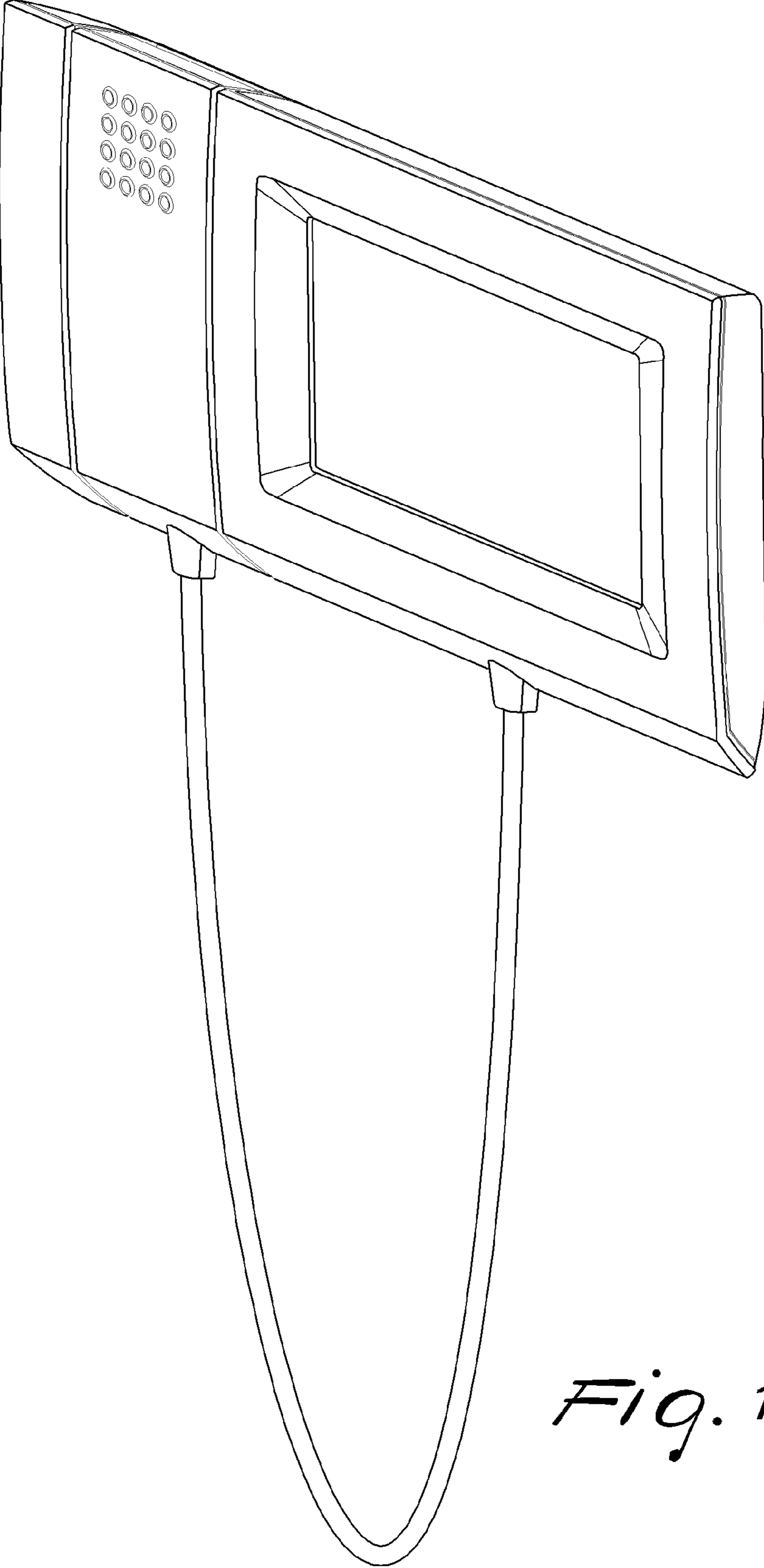
FIG. 6 is a plan view from below thereof; and,

FIG. 7 is a plan view from above thereof.

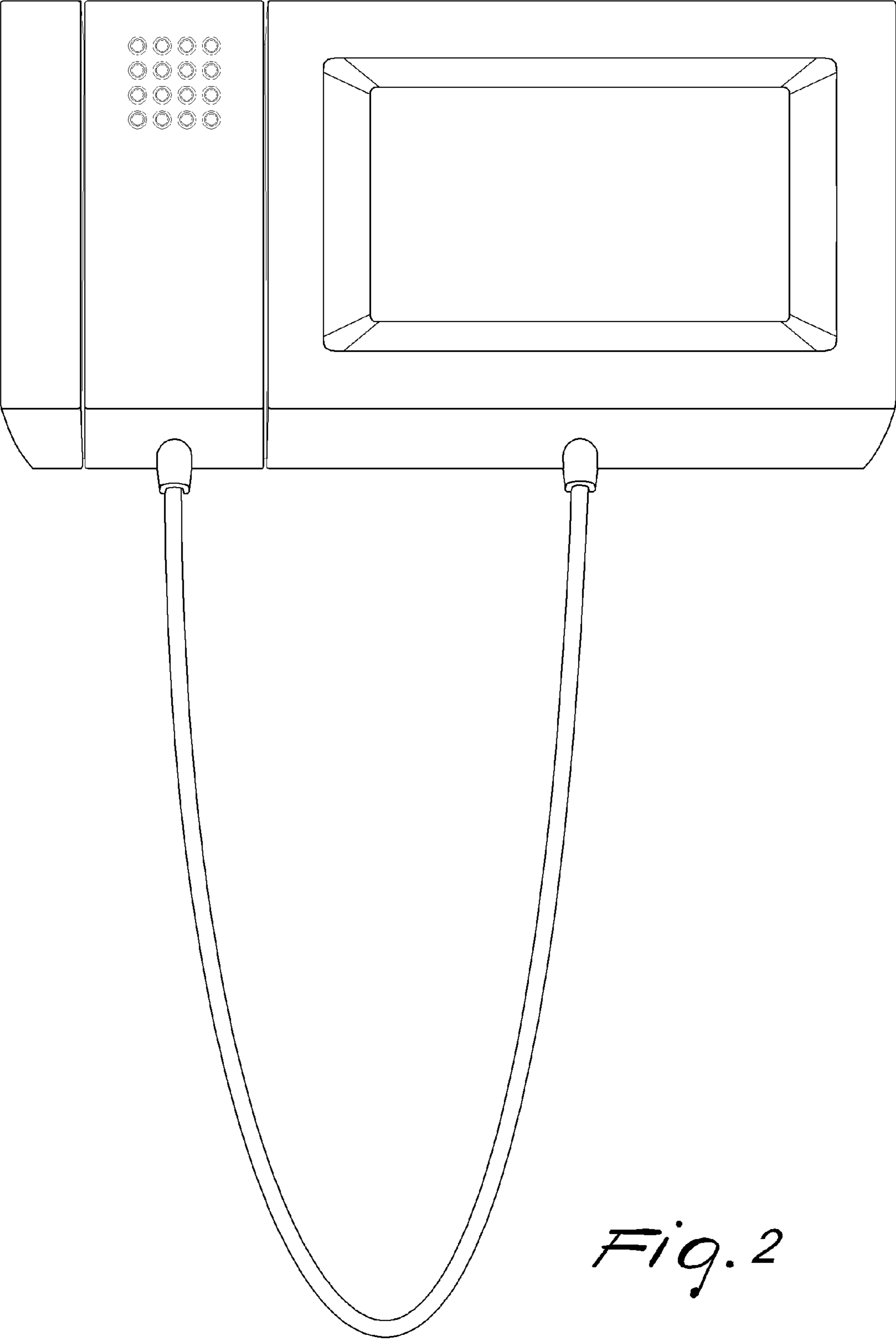
The broken line showing of environmental structures is for illustrative purposes only and forms no part of the claimed design.

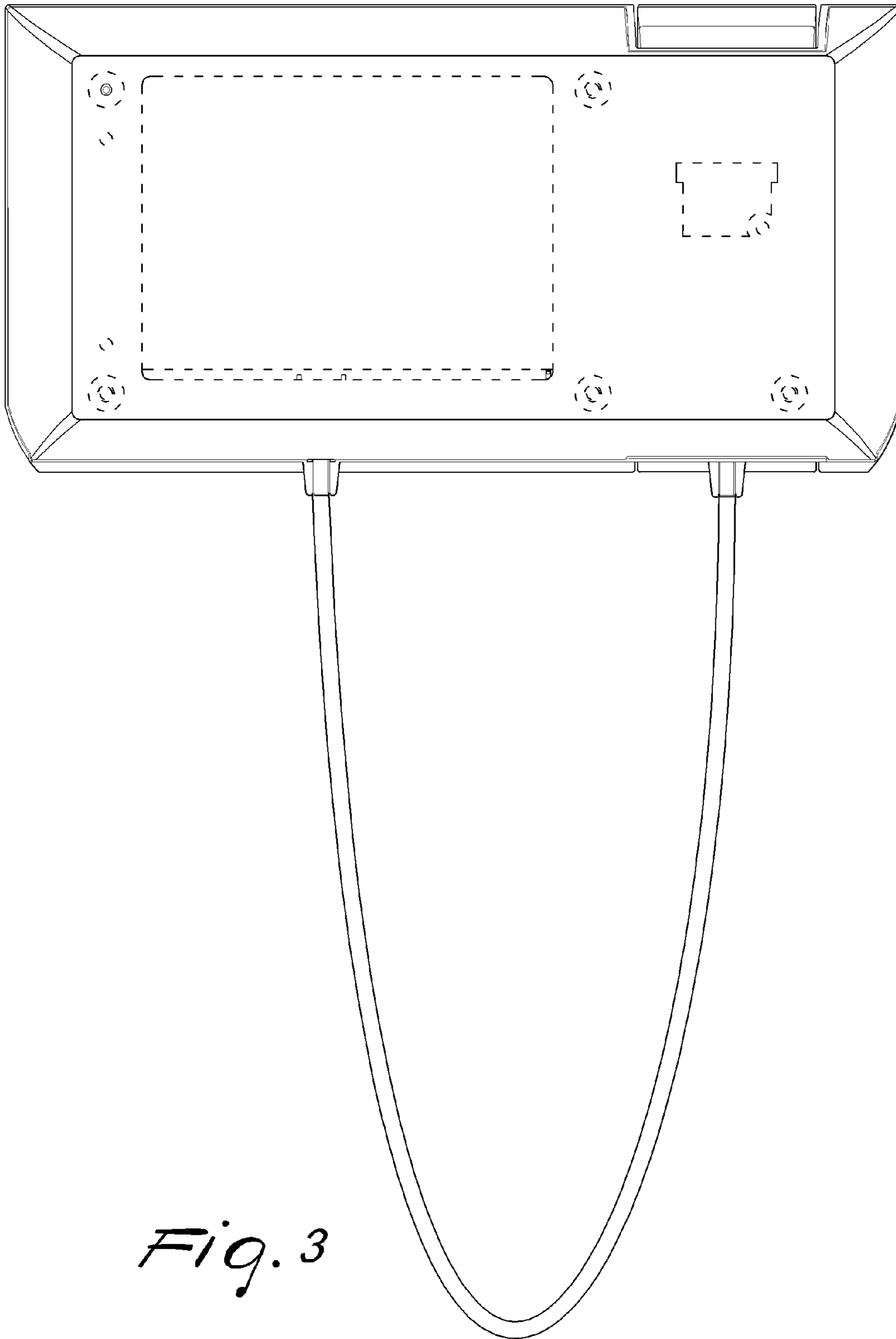




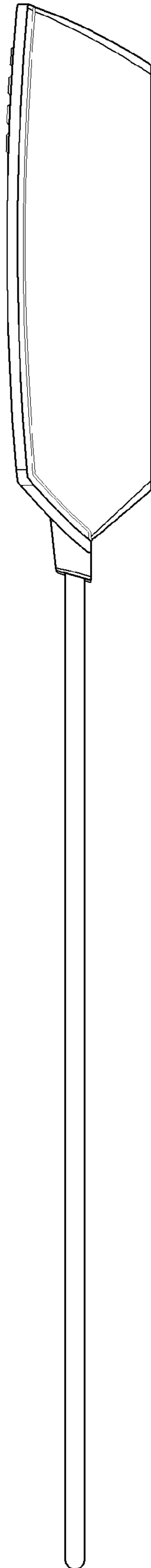

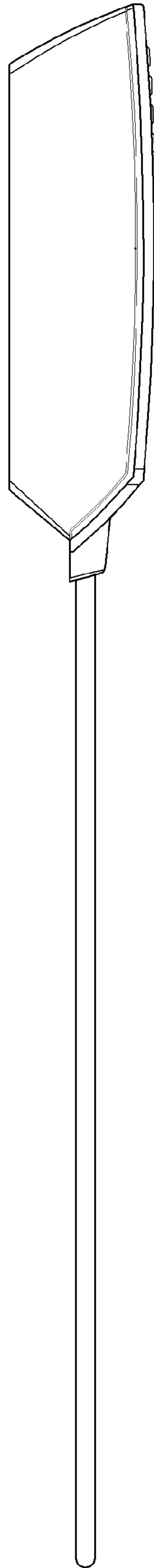

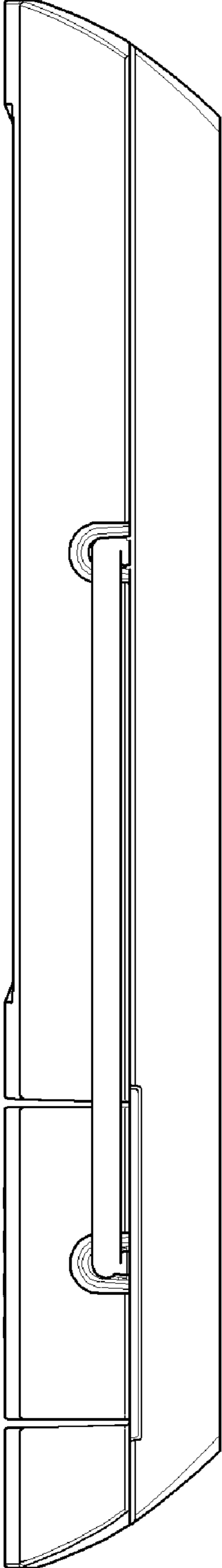

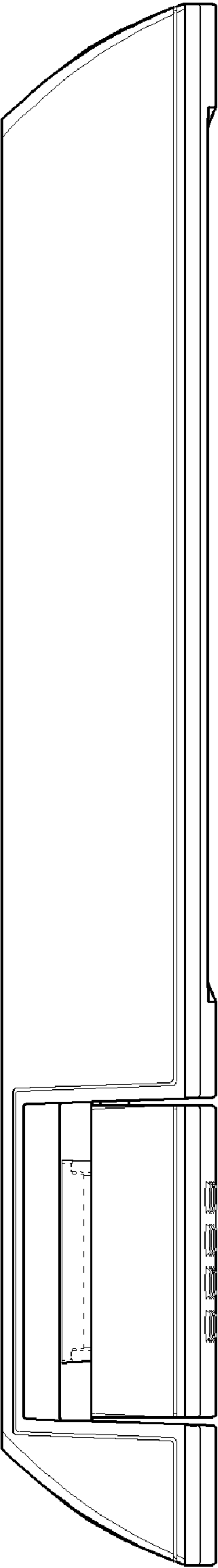
