(57) **CLAIM**

The ornamental design for a combined headset and ear loop clip with interchangeable accessories and interchangeable accessories, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front perspective view of a combined headset and ear loop clip with interchangeable accessories and accessories showing my new design;

FIG. 2 is a perspective view of a combined headset and ear-loop clip (closed) with interchangeable accessories, including interchangeable accessories;

FIG. 3 is a perspective view thereof, shown separately for purposes of illustration;

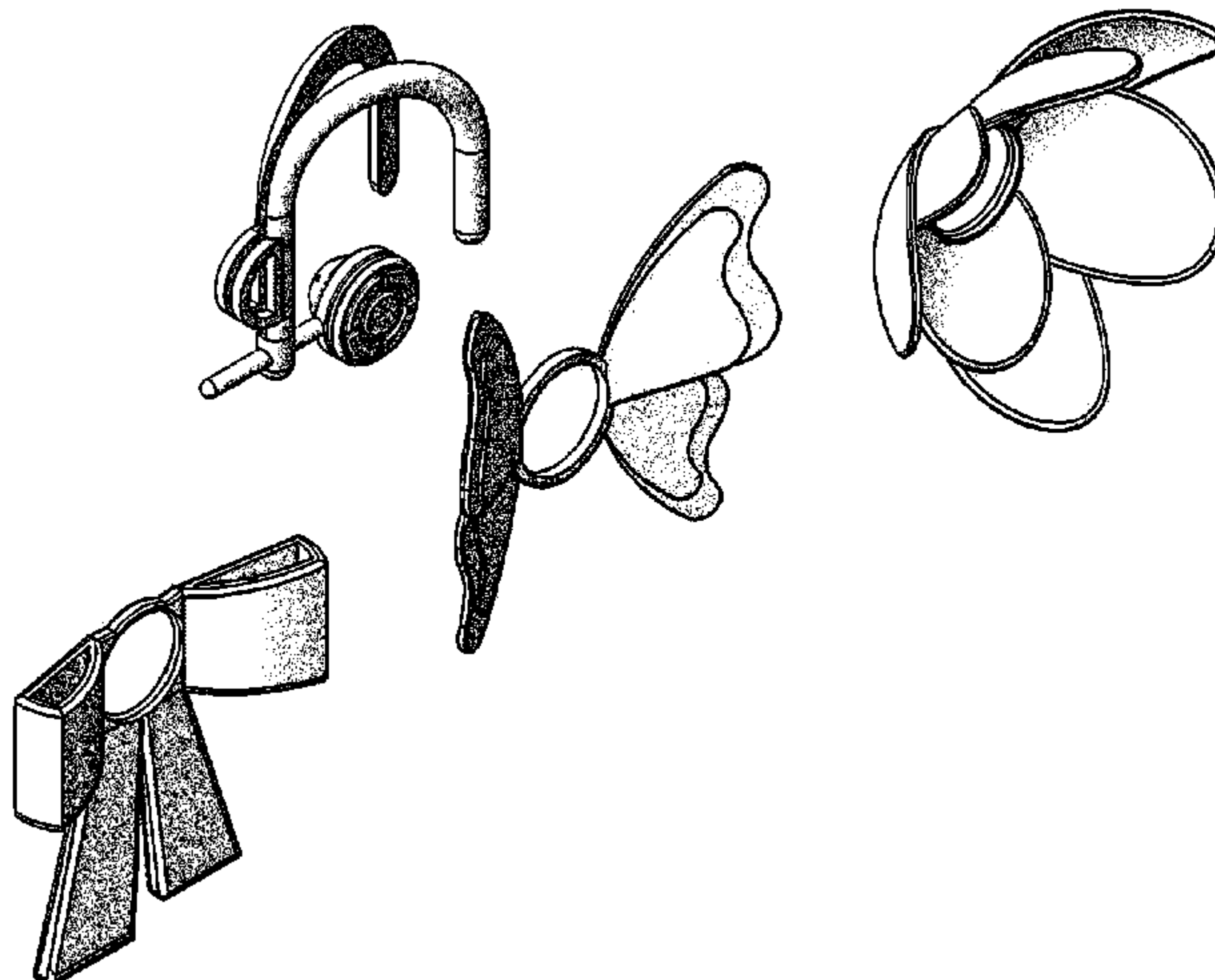
FIG. 4 is a front elevational view of a combined headset and ear-loop clip thereof;

FIG. 5 is a back elevational view of a combined headset and ear-loop clip thereof;

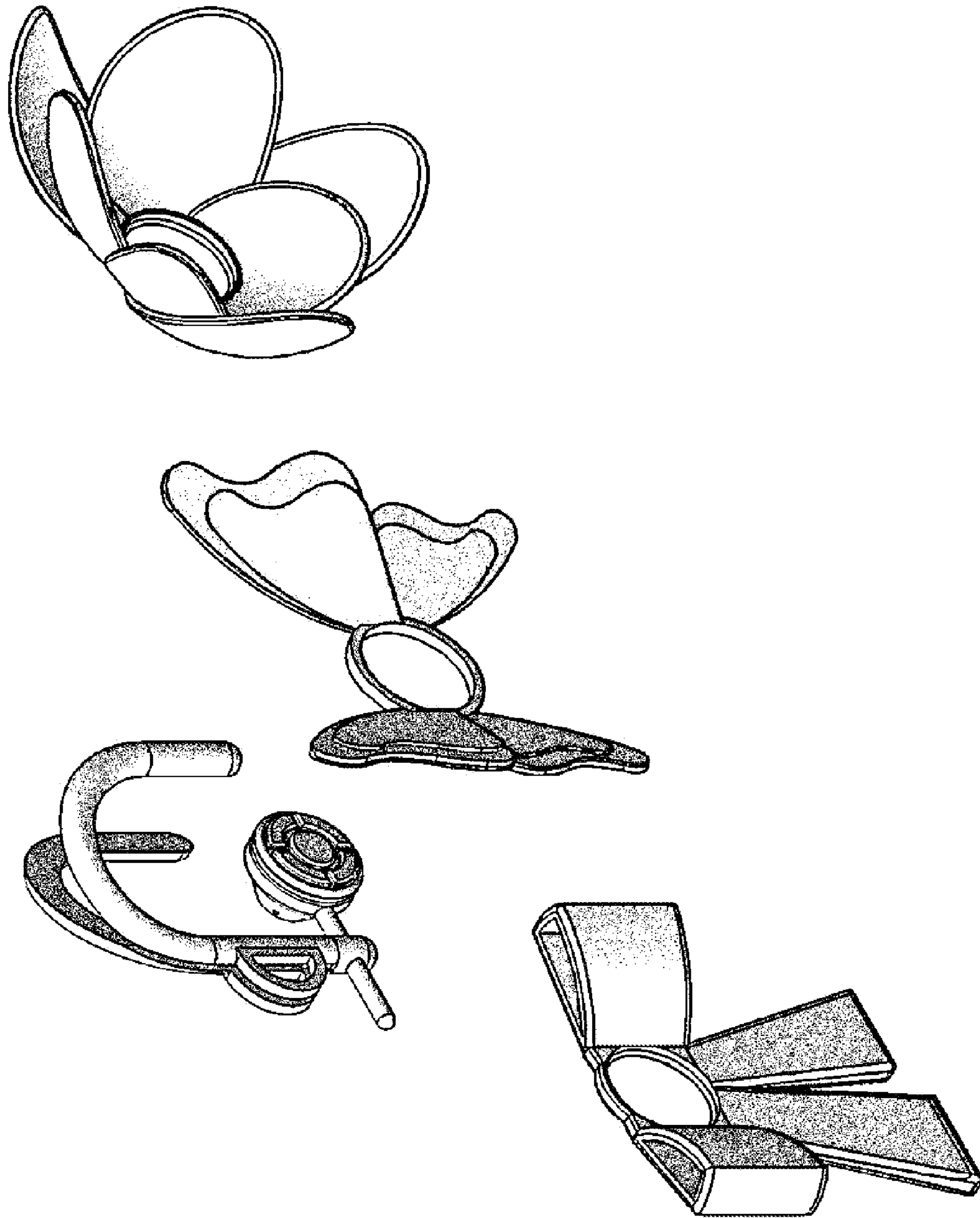

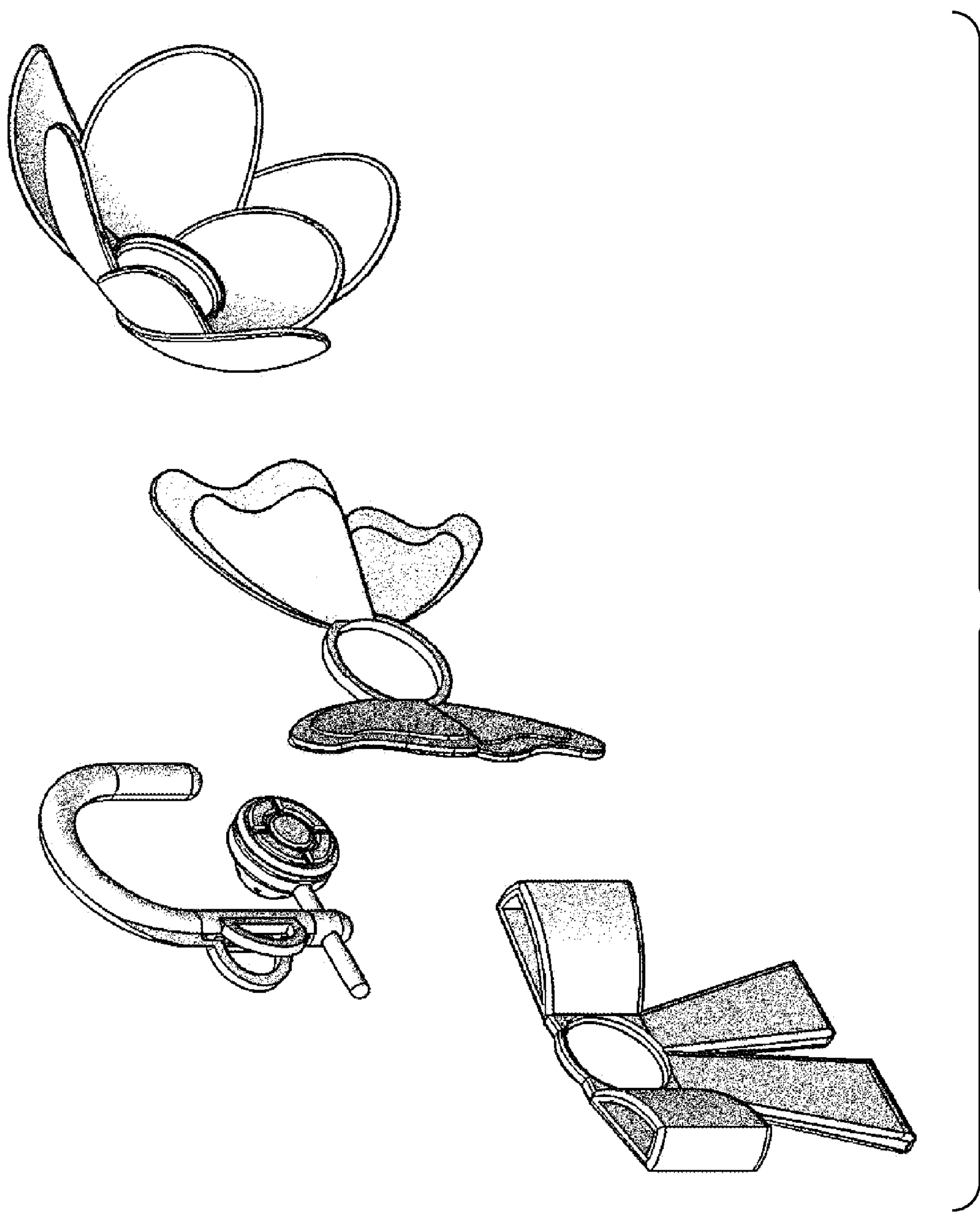

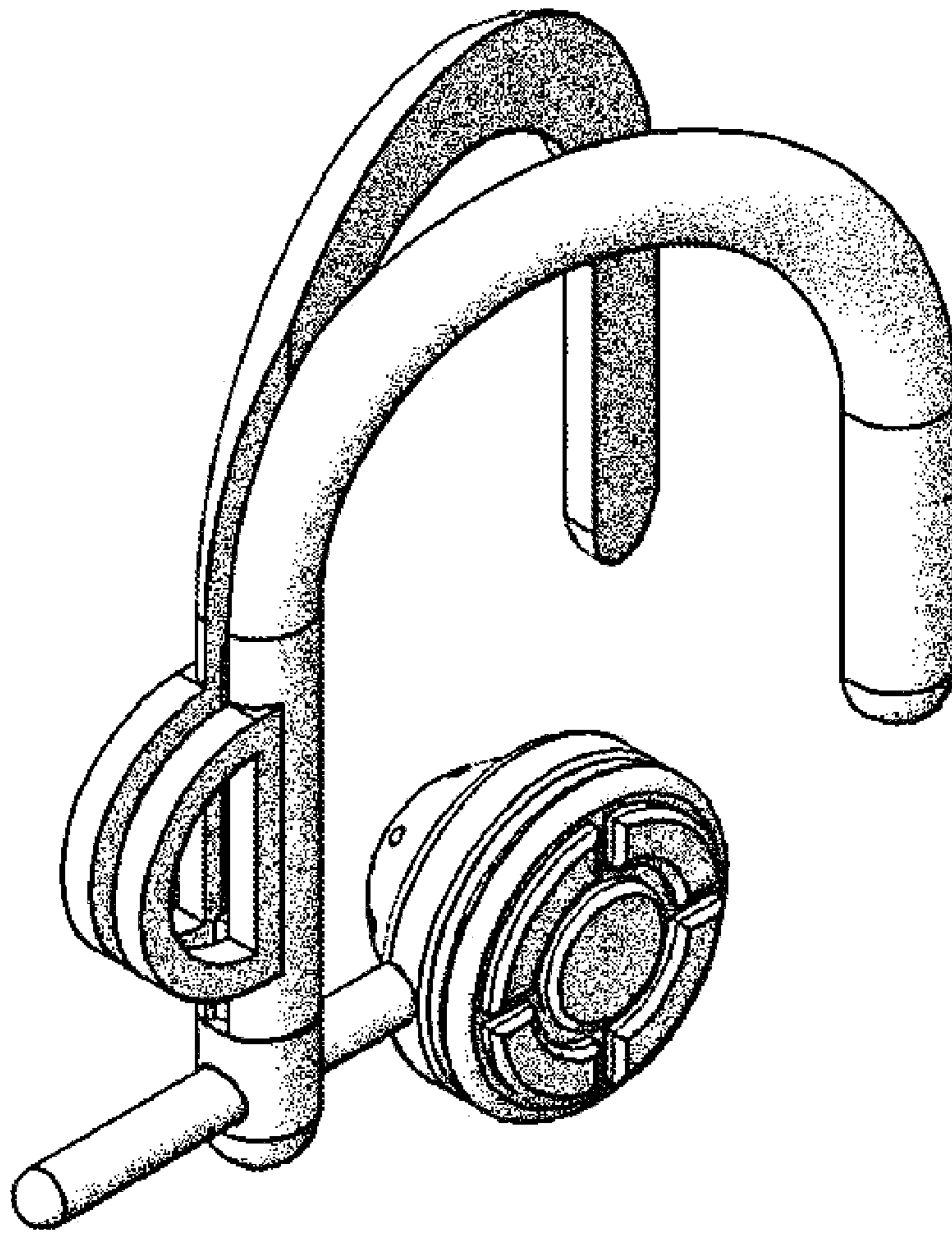

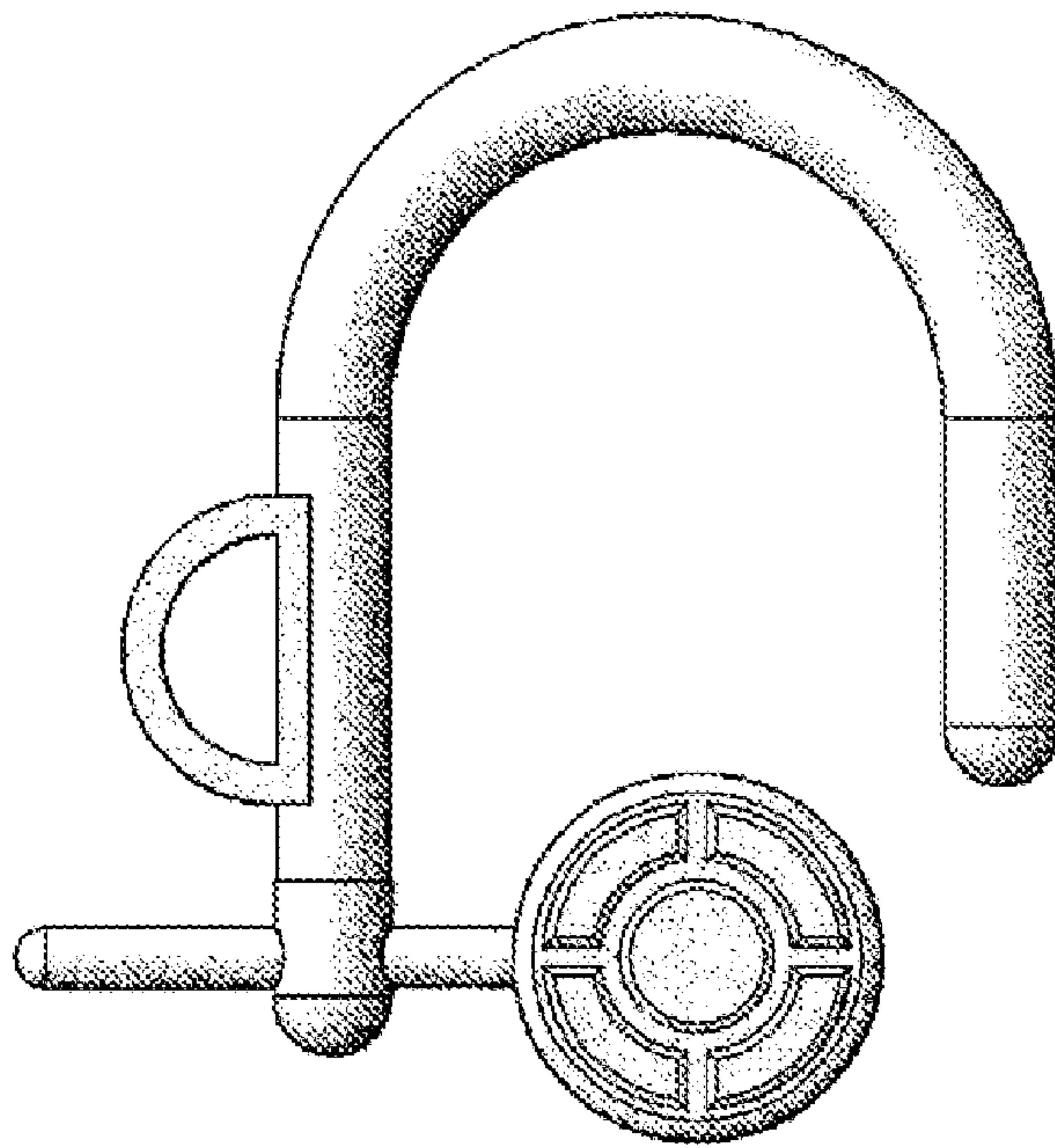

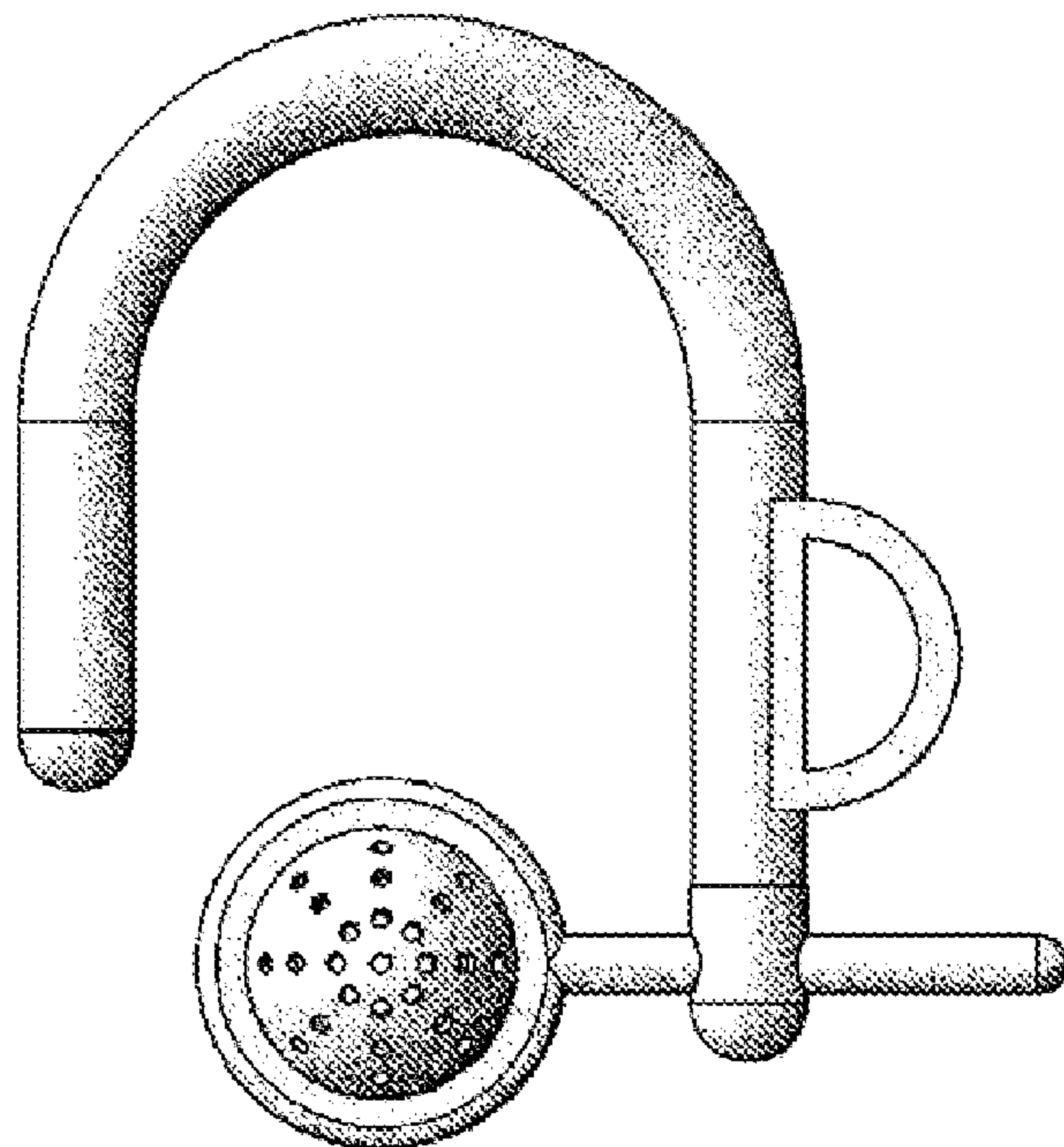
