The ornamental design for a stereo headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a stereo headset showing my new design;

FIG. 2 is a perspective back view thereof;

FIG. 3 is a front elevational view thereof;

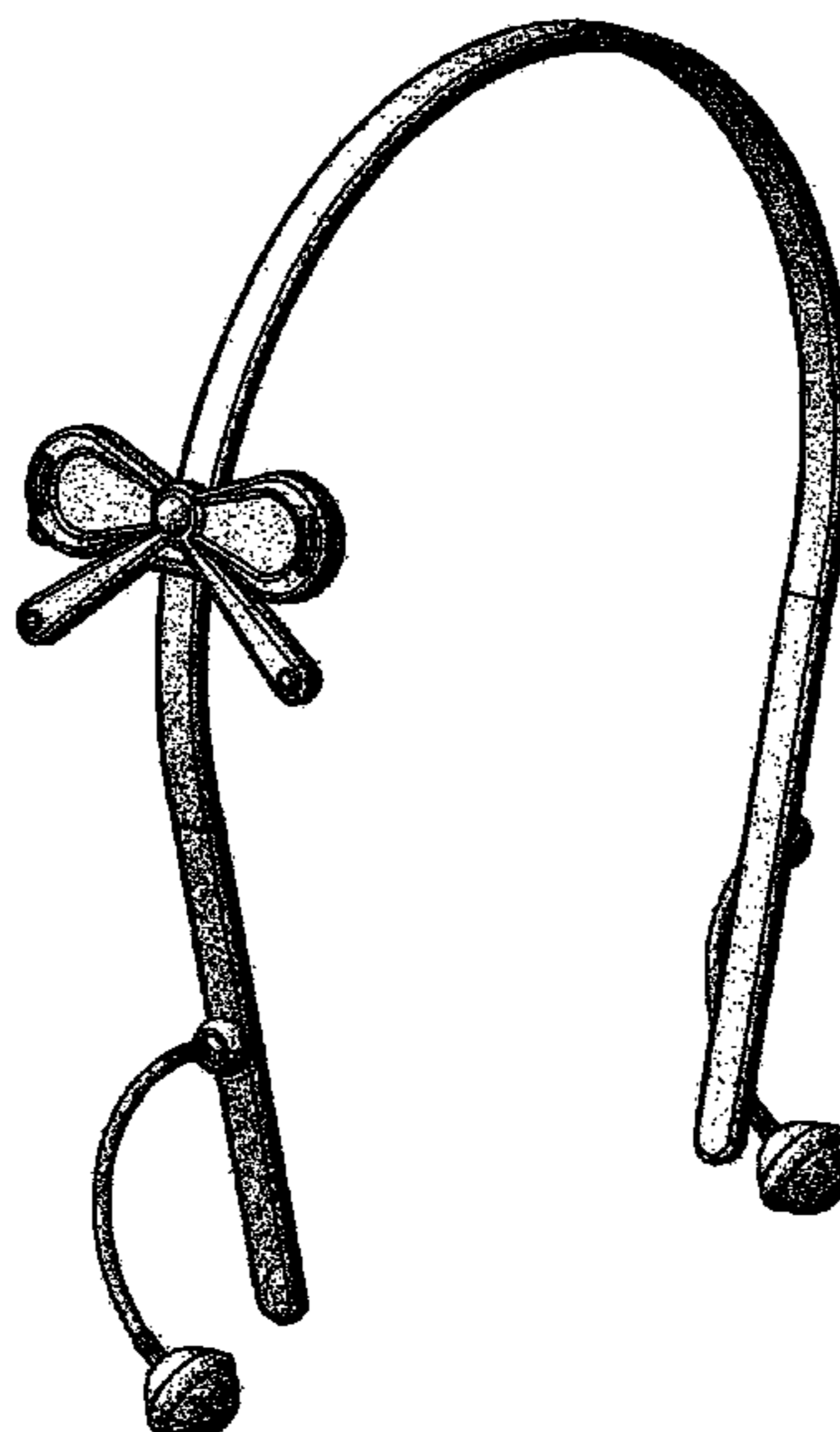
FIG. 4 is a side view of the stereo headset in relation to a human head thereof;

FIG. 5 is a perspective view of adjusted earpieces, rotated forward thereof; and,

FIG. 6 is a perspective view of adjusted earpieces, rotated upwards thereof.

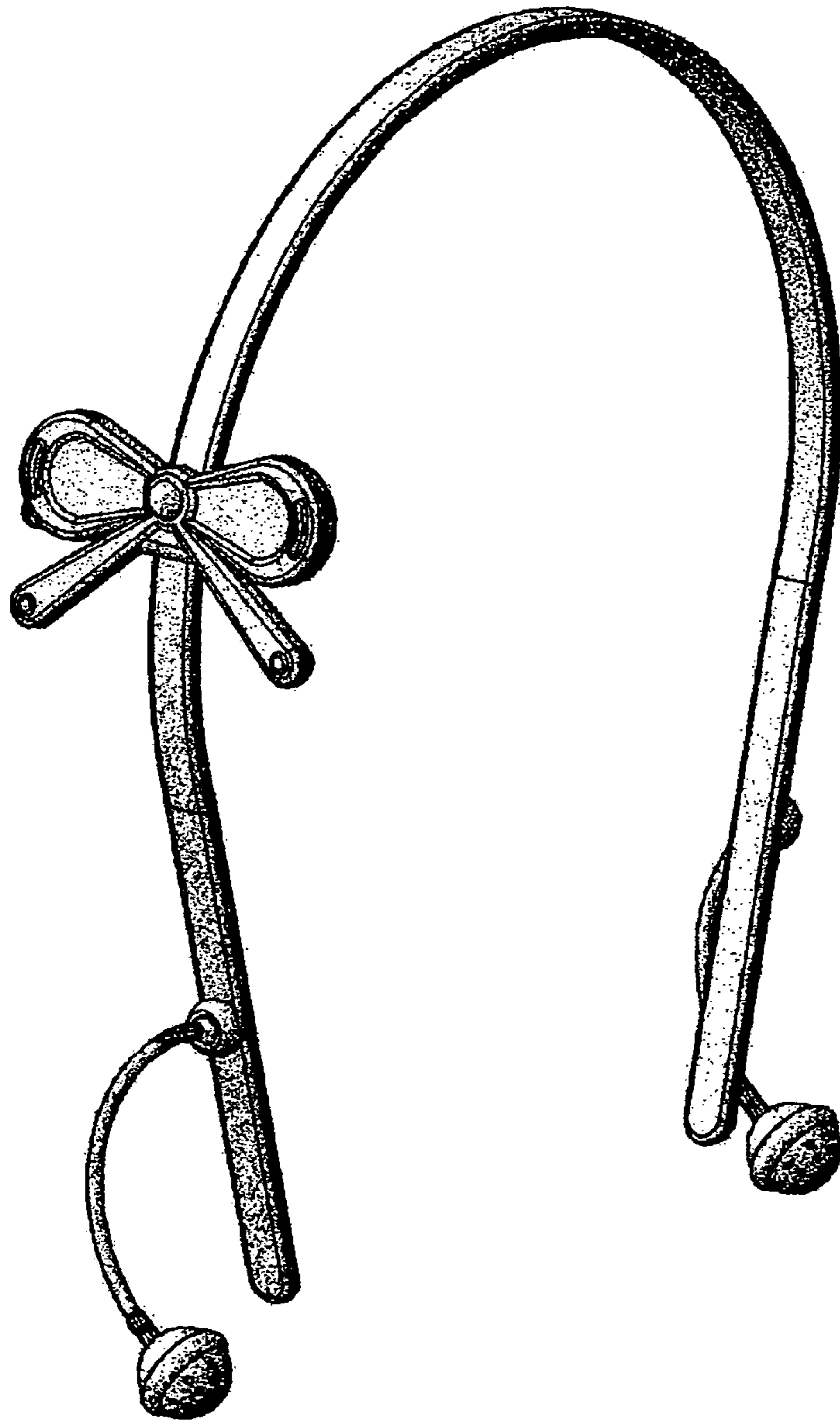

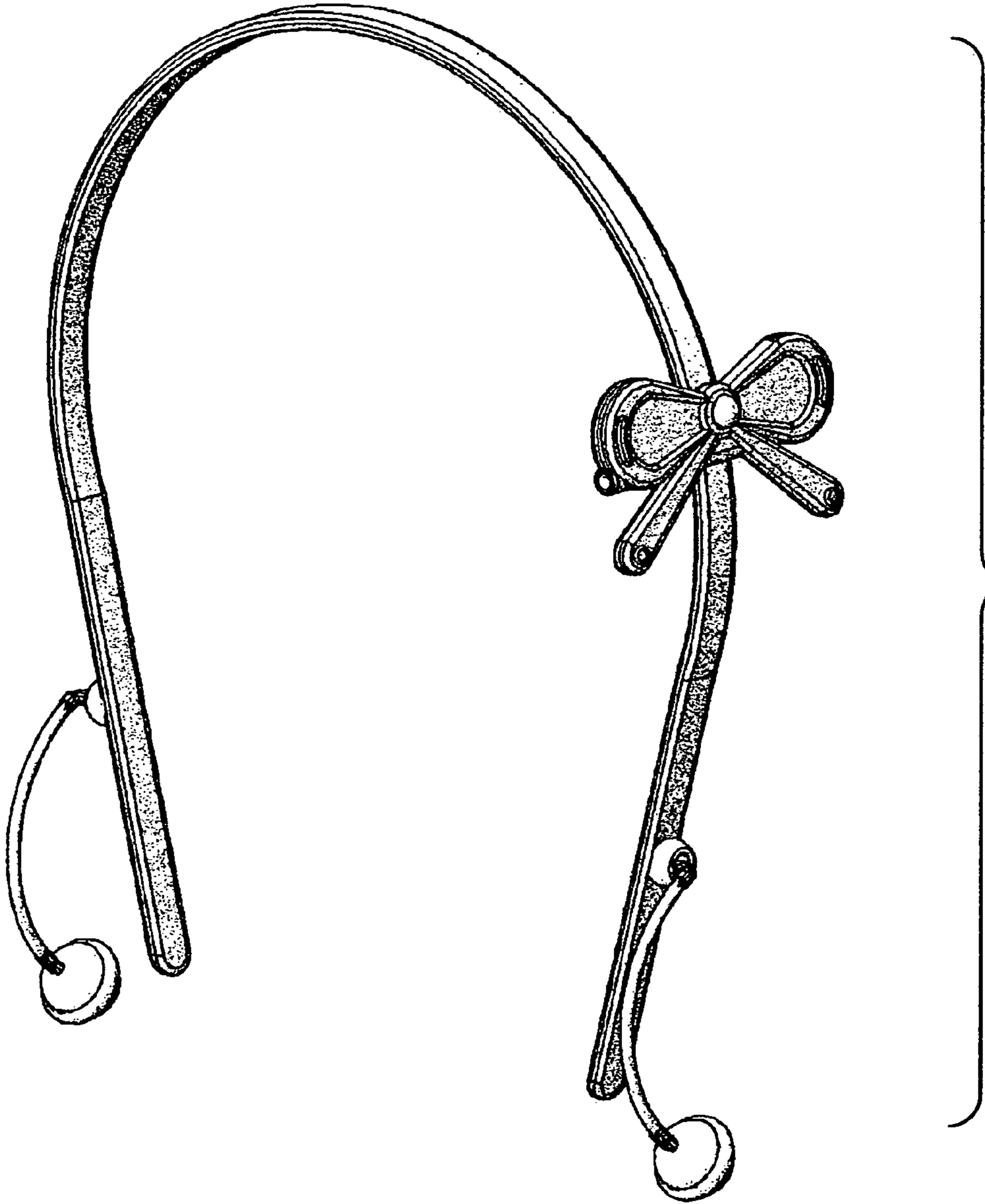

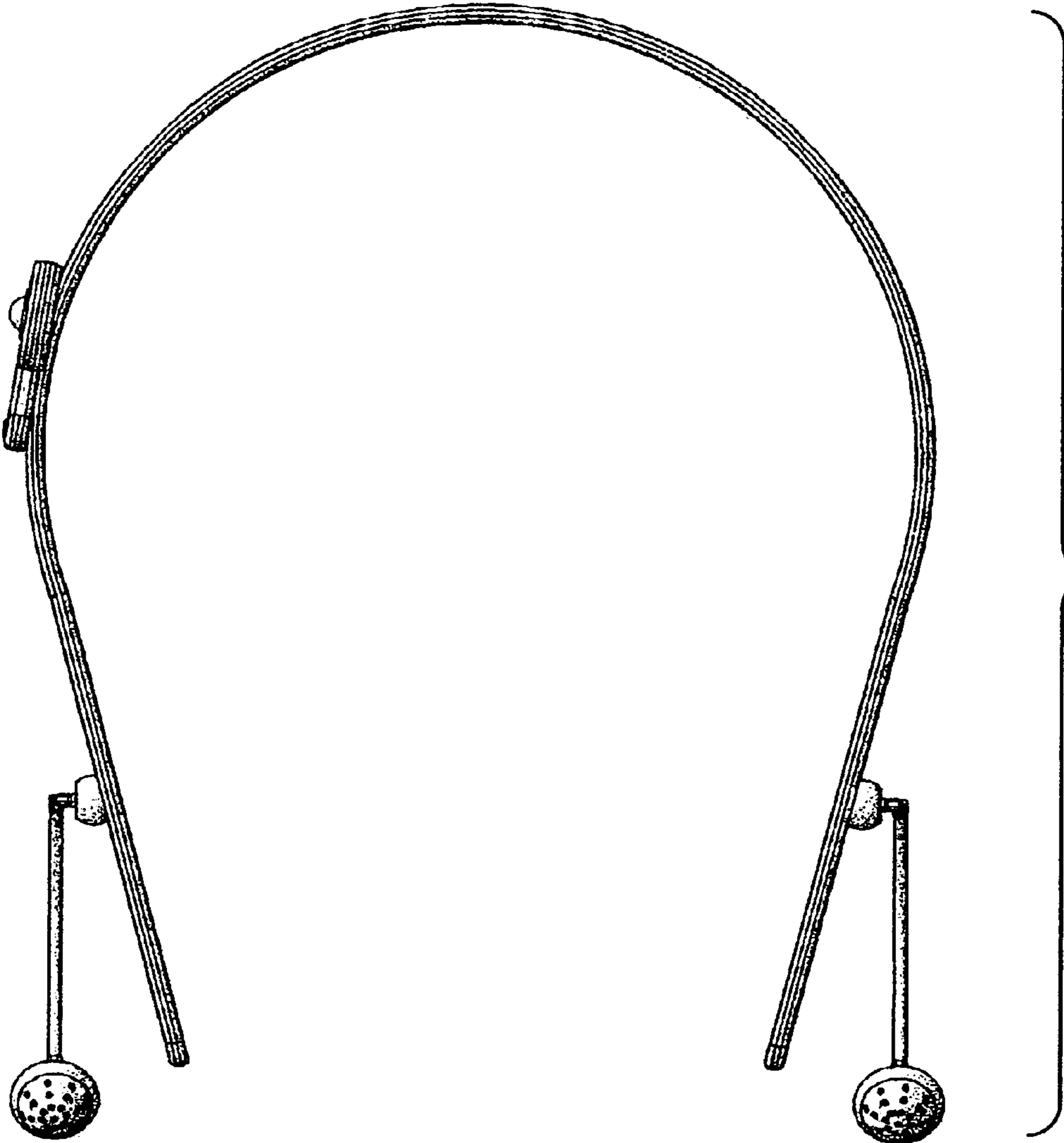

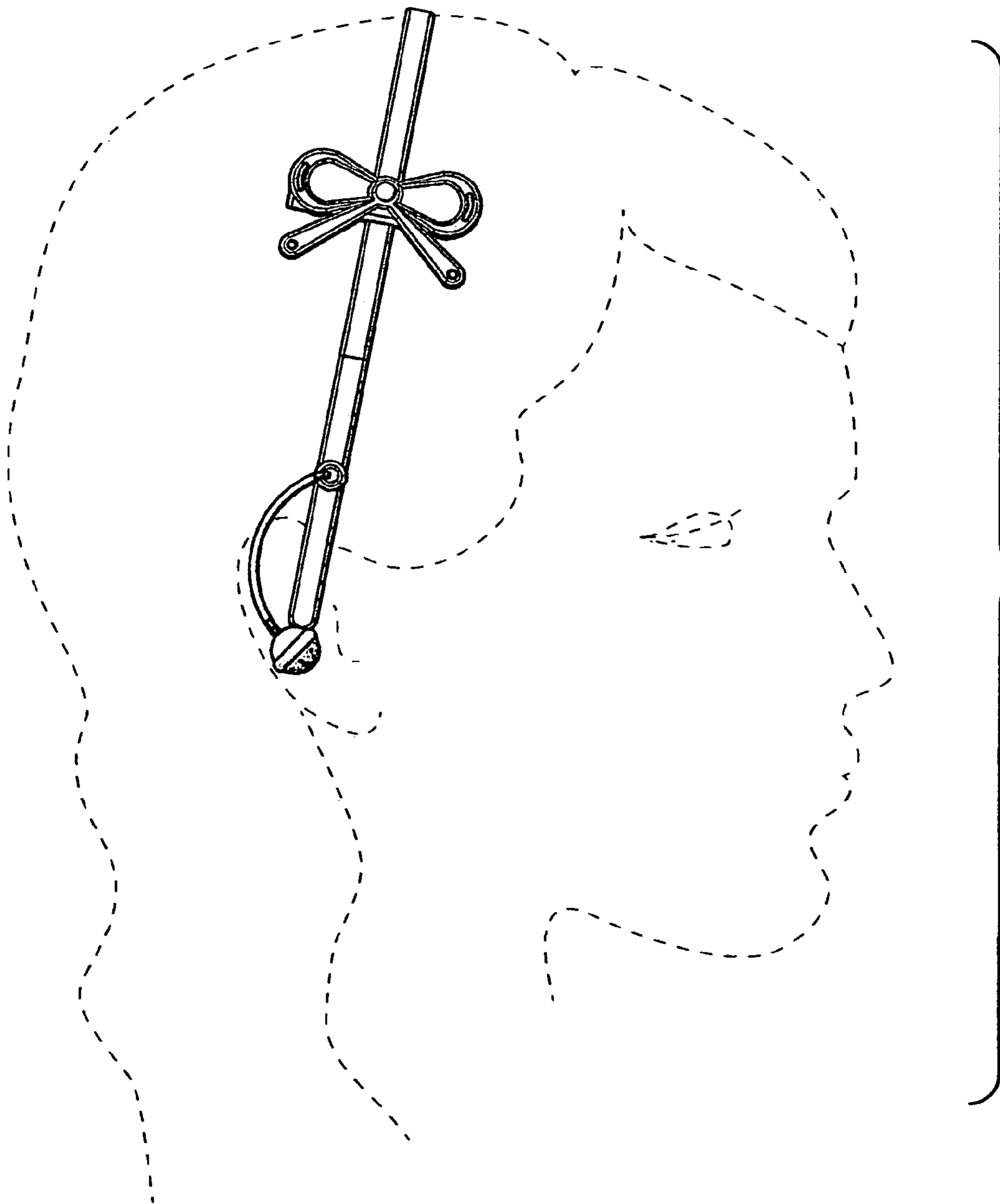

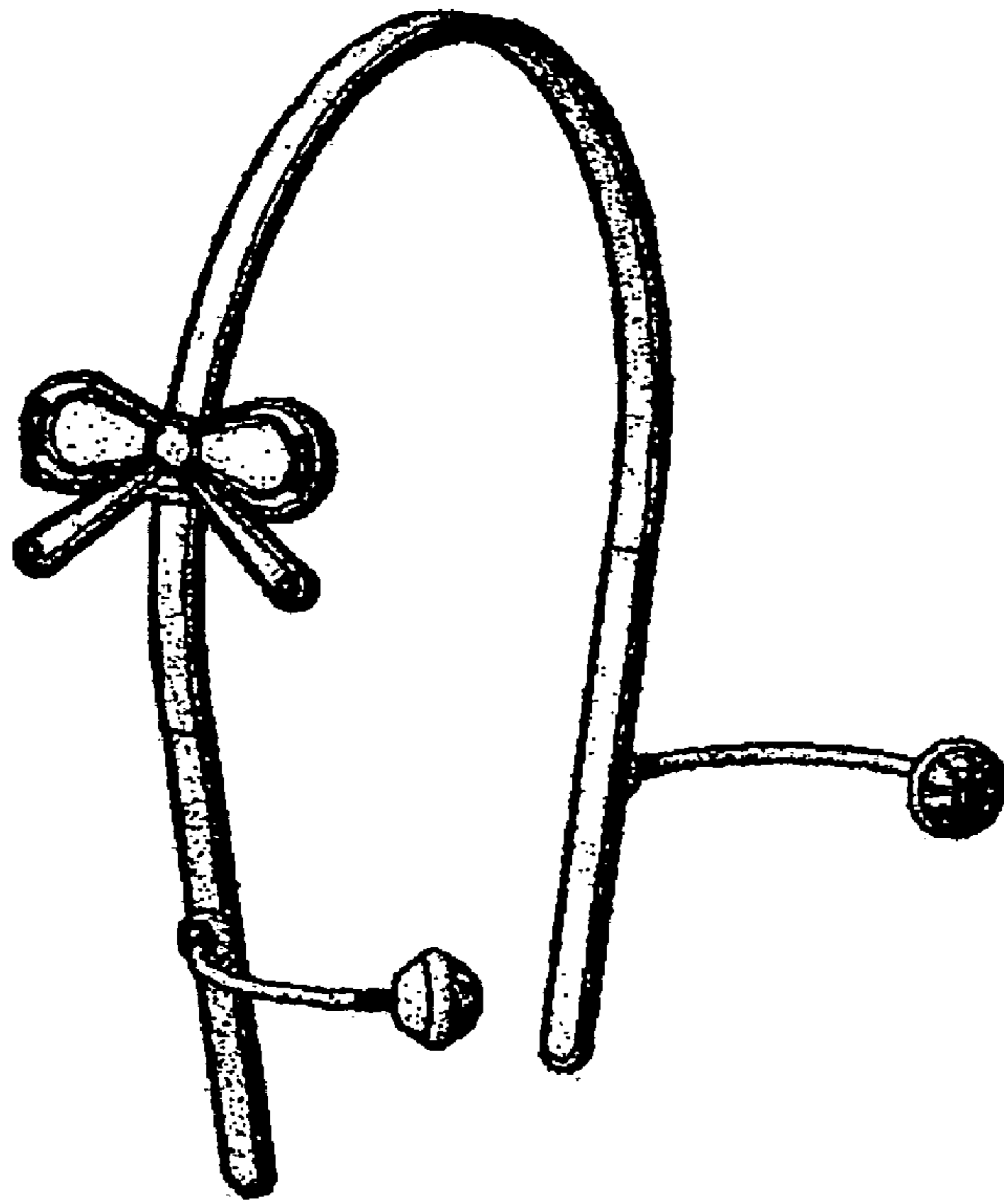

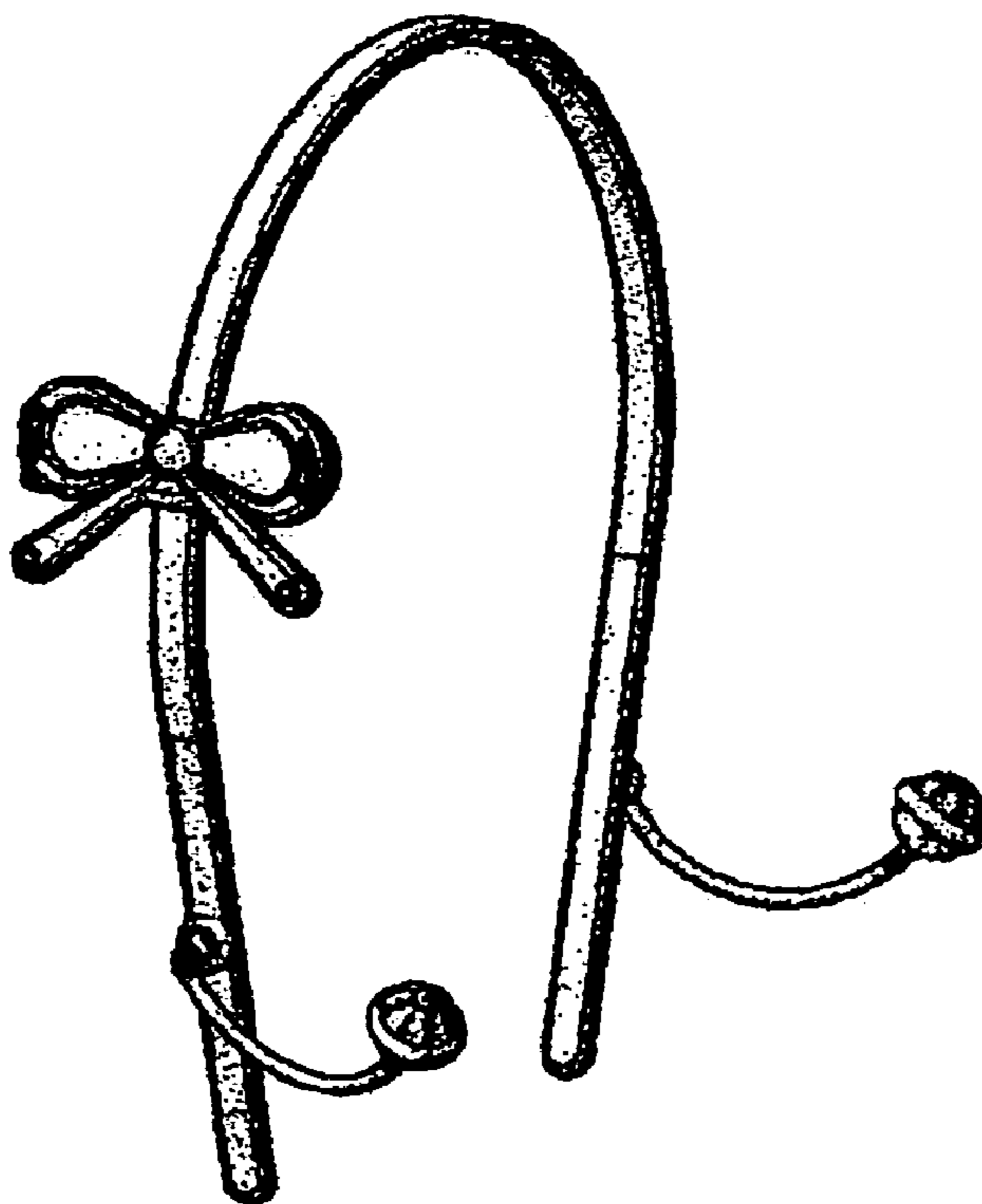
