FIG. 5 is an enlarged front perspective view of the set of keys shown in FIG. 1;

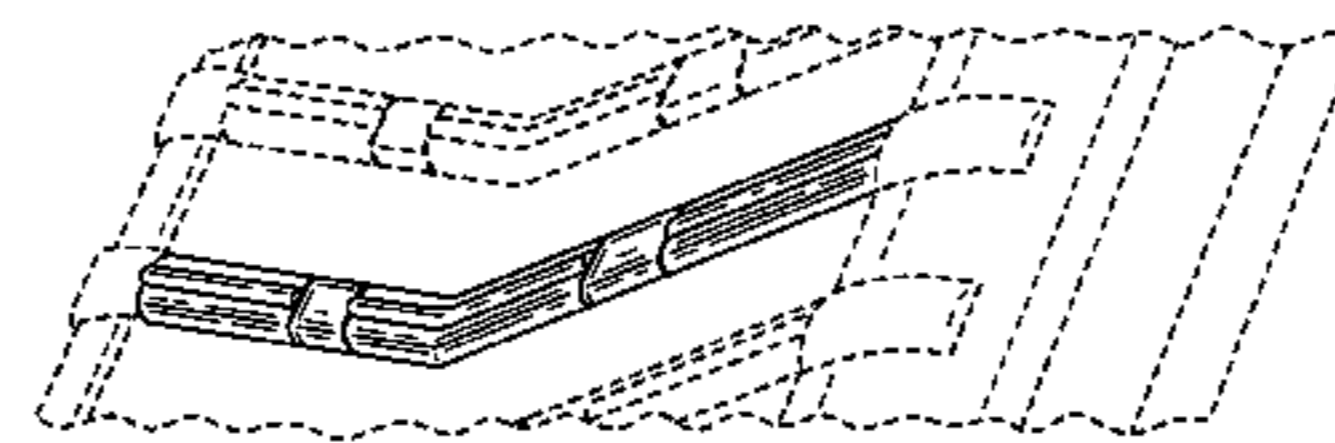
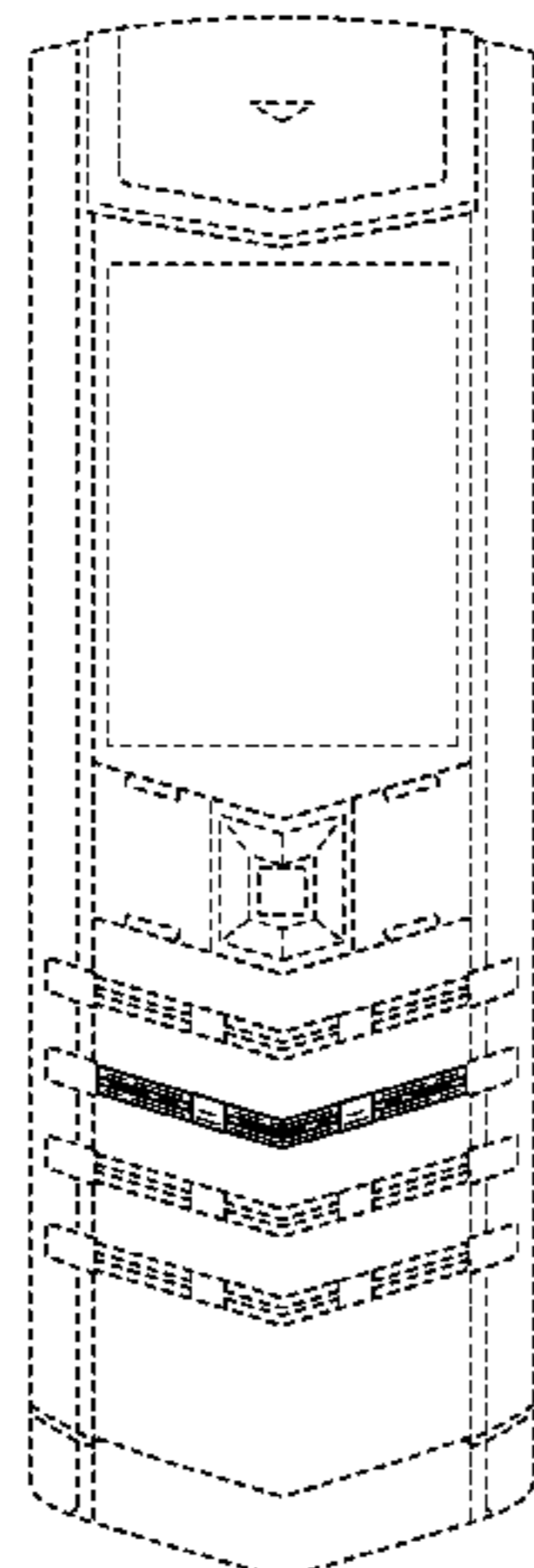
FIG. 6 is an enlarged front view thereof;

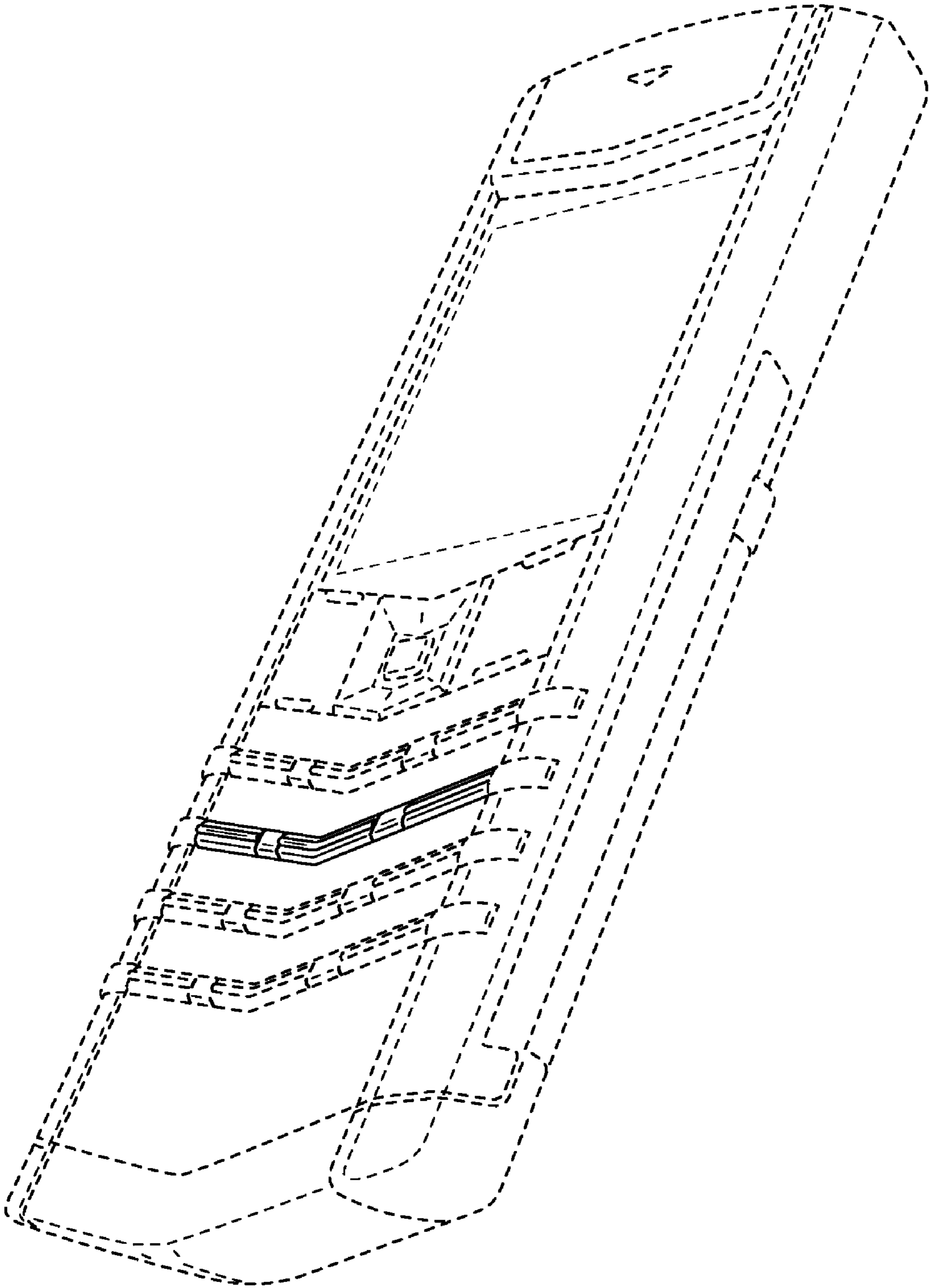

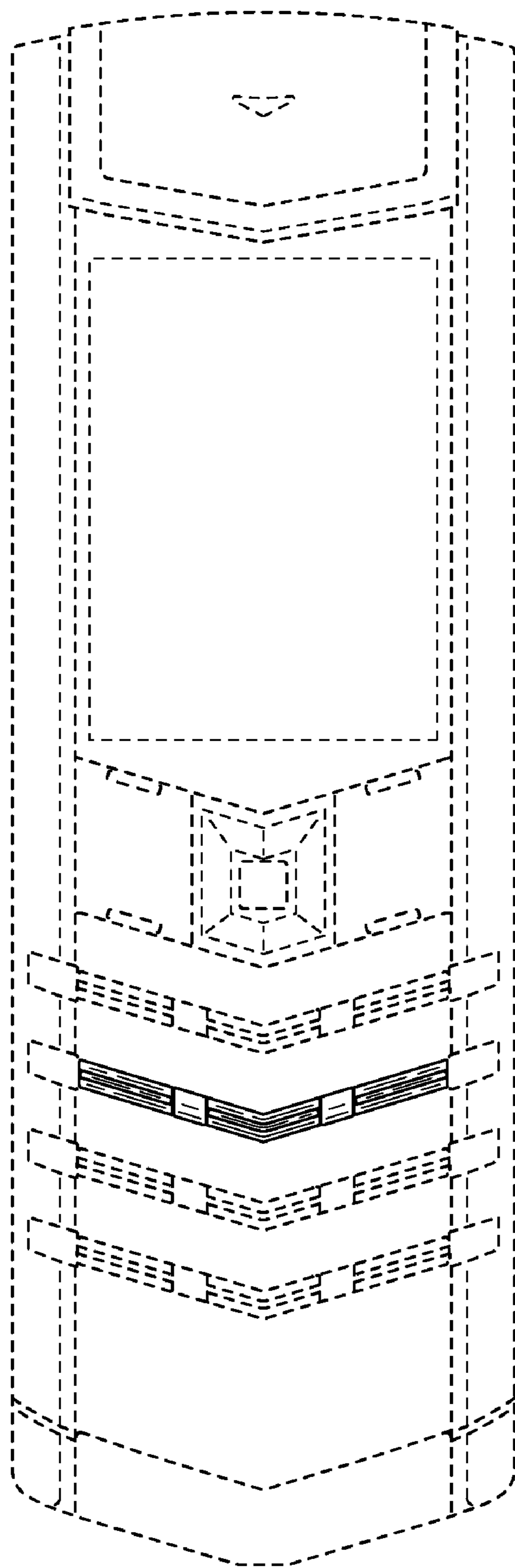

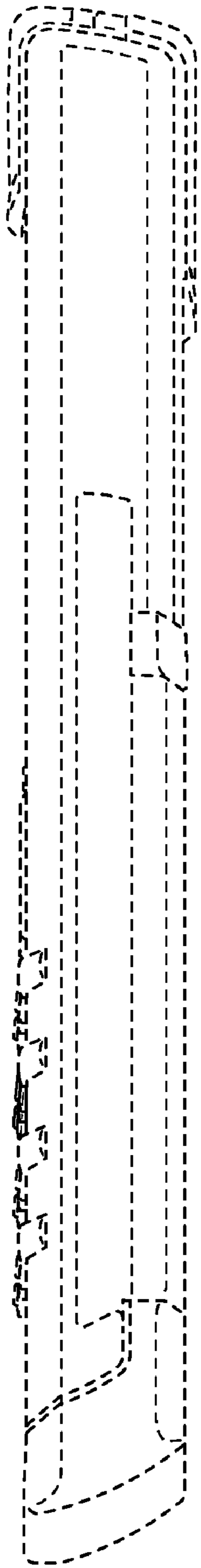

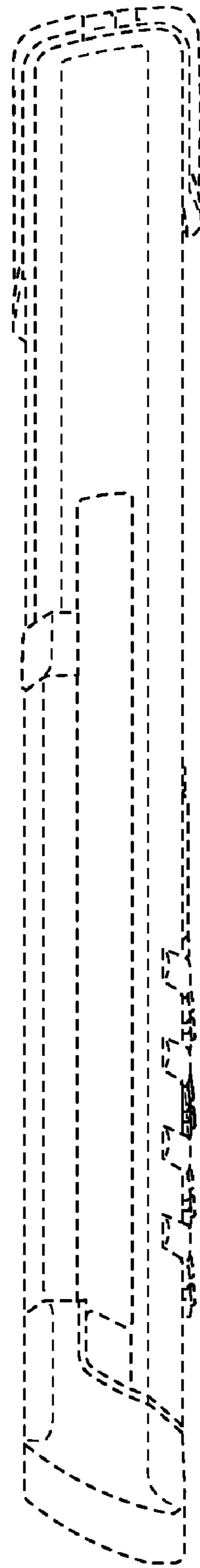

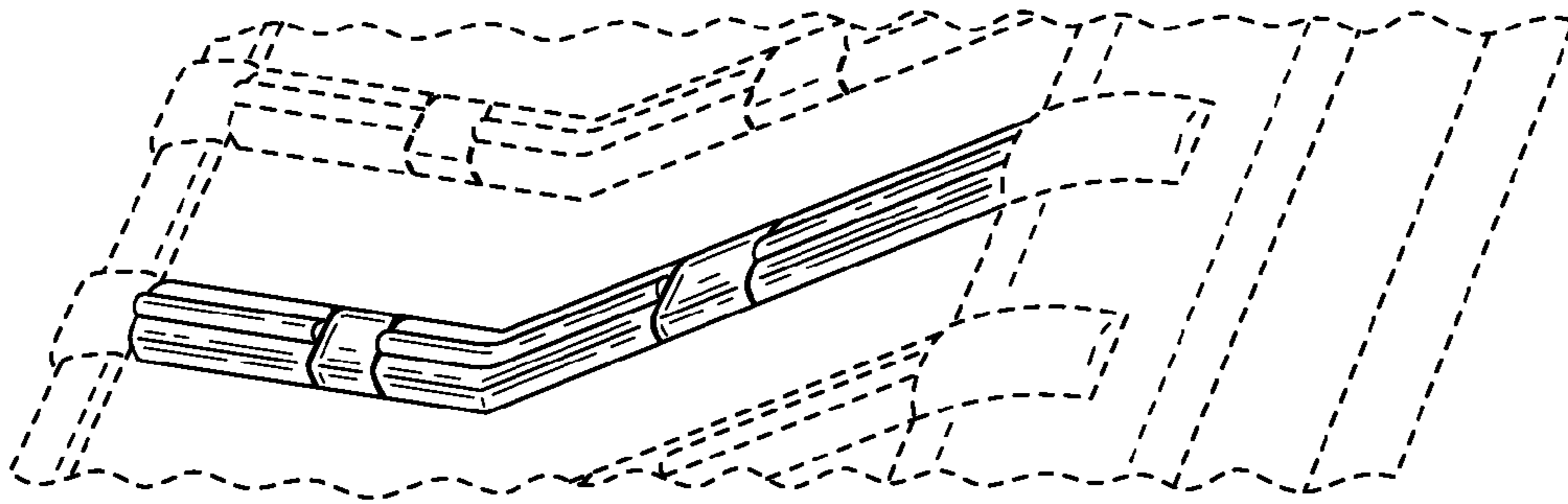

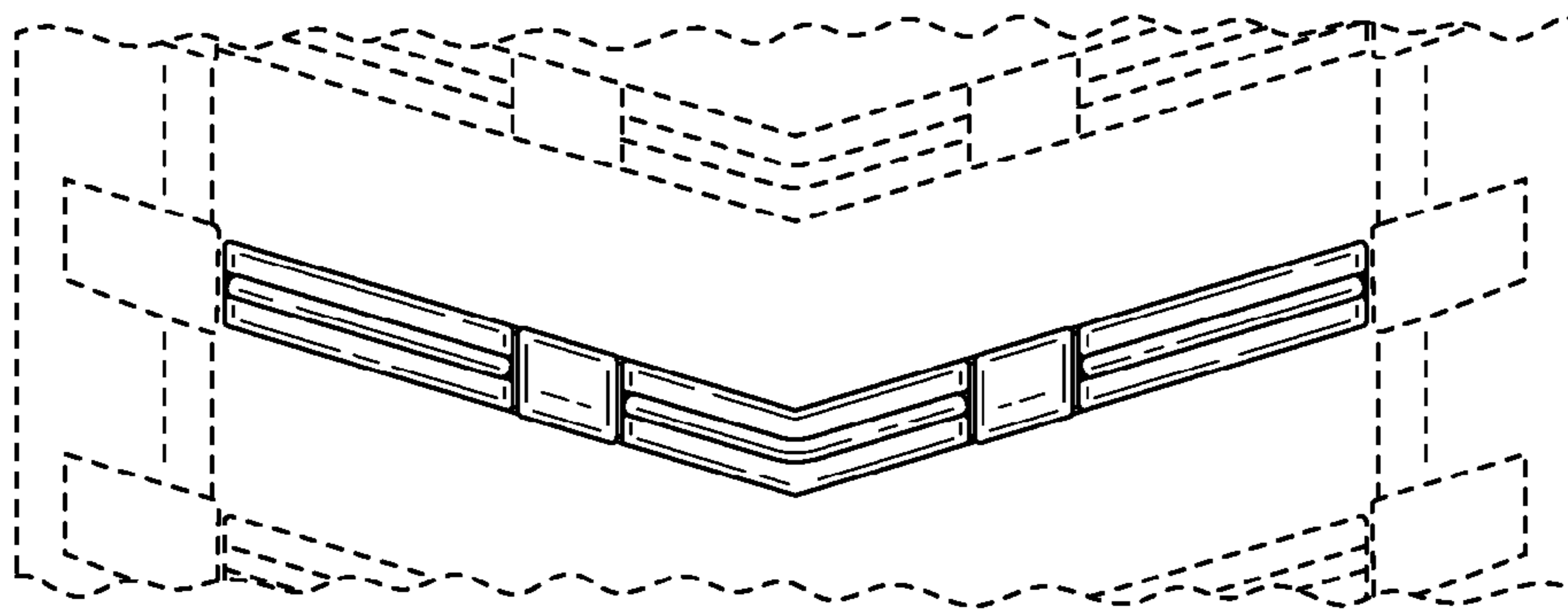

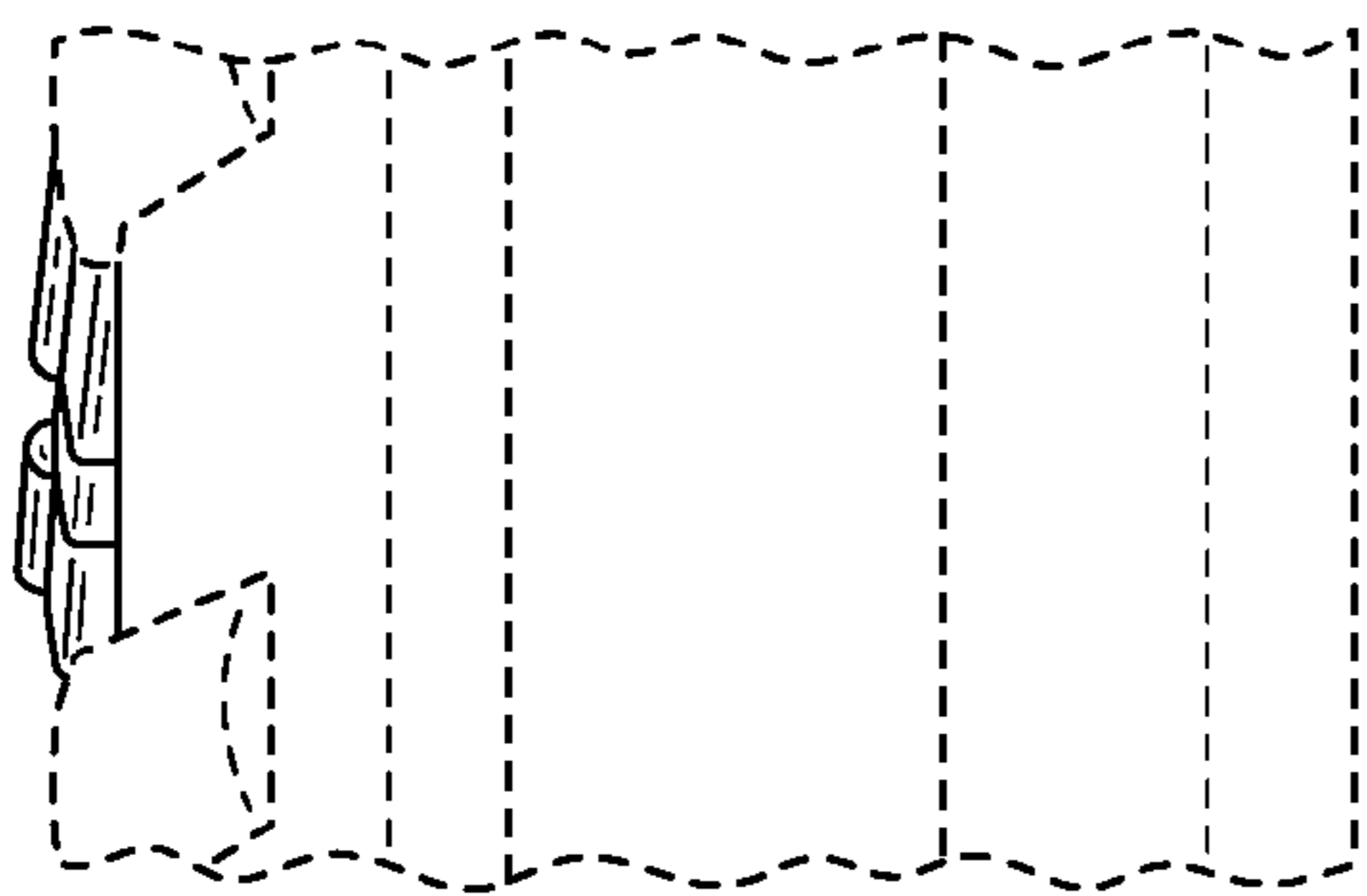

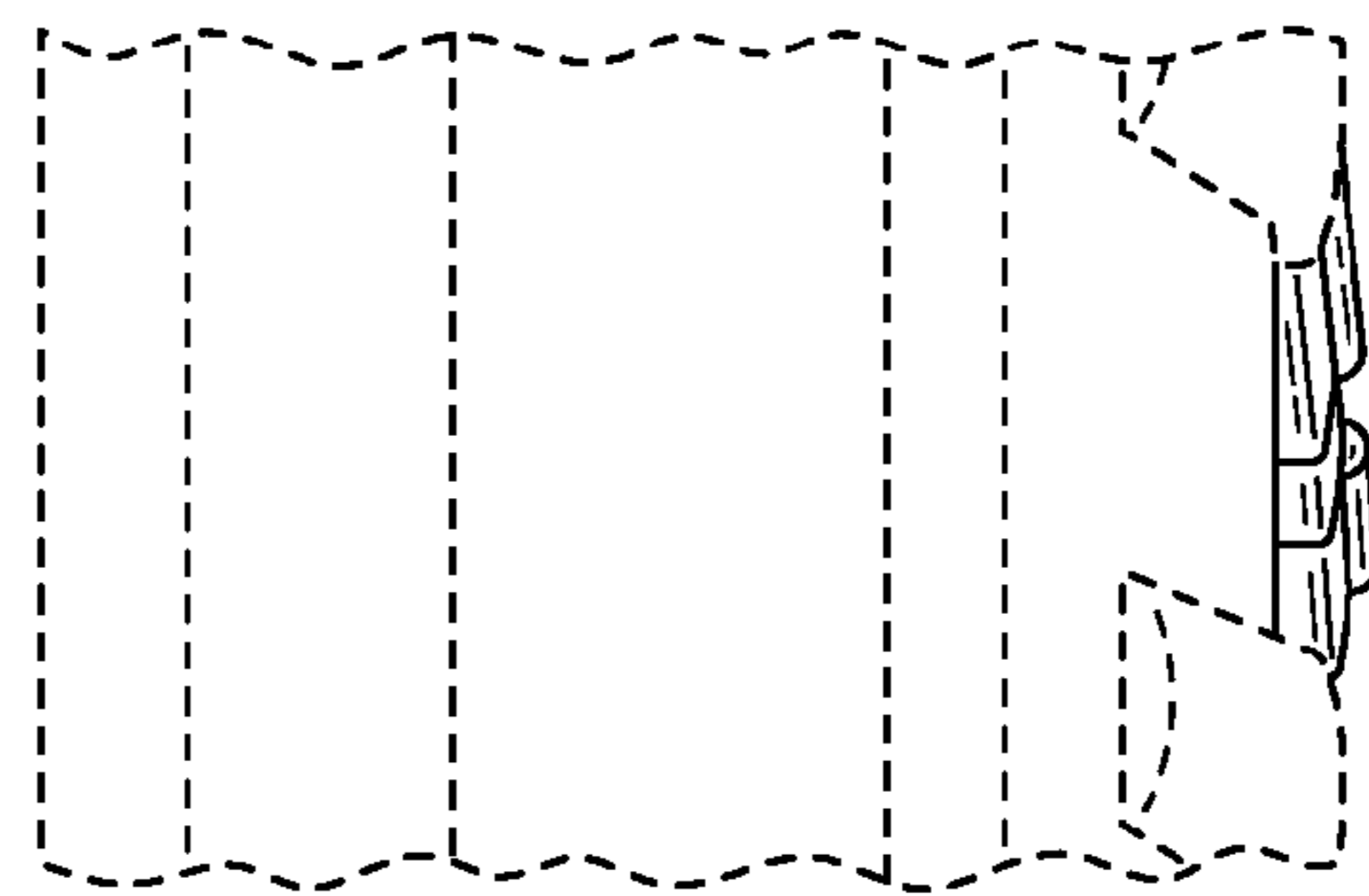
