(57) **CLAIM**

The ornamental design for an inflatable swimming assistance device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a new design for an inflatable swimming assistance device;

FIG. 2 is a front end view of the inflatable swimming assistance device illustrated in FIG. 1;

FIG. 3 is a rear end view of the inflatable swimming assistance device illustrated in FIG. 1;

FIG. 4 is a left side view of the inflatable swimming assistance device illustrated in FIG. 1;

FIG. 9 is a rear end view of the inflatable swimming assistance device illustrated in FIG. 7;

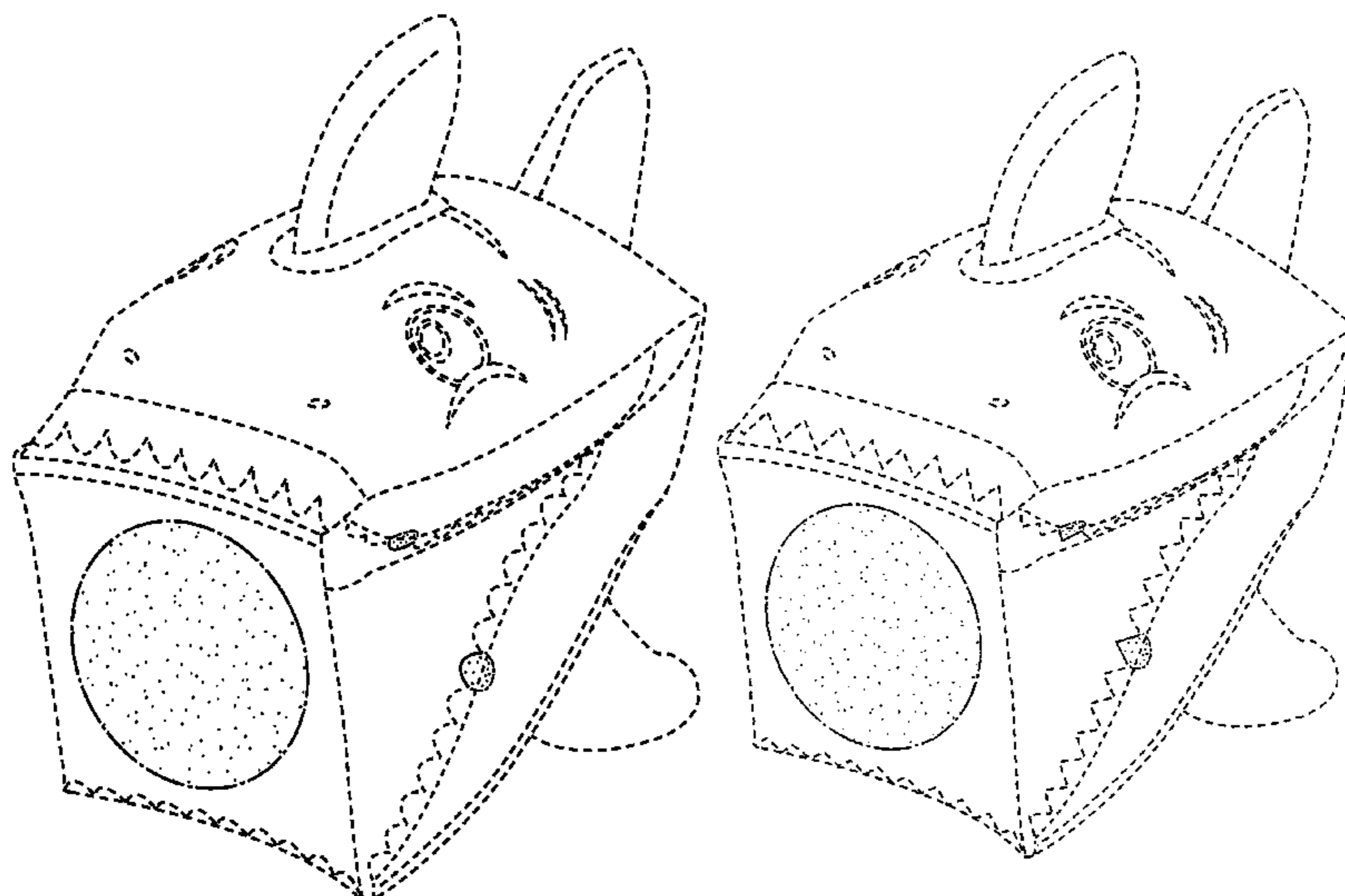
FIG. 10 is a left side view of the inflatable swimming assistance device illustrated in FIG. 7;

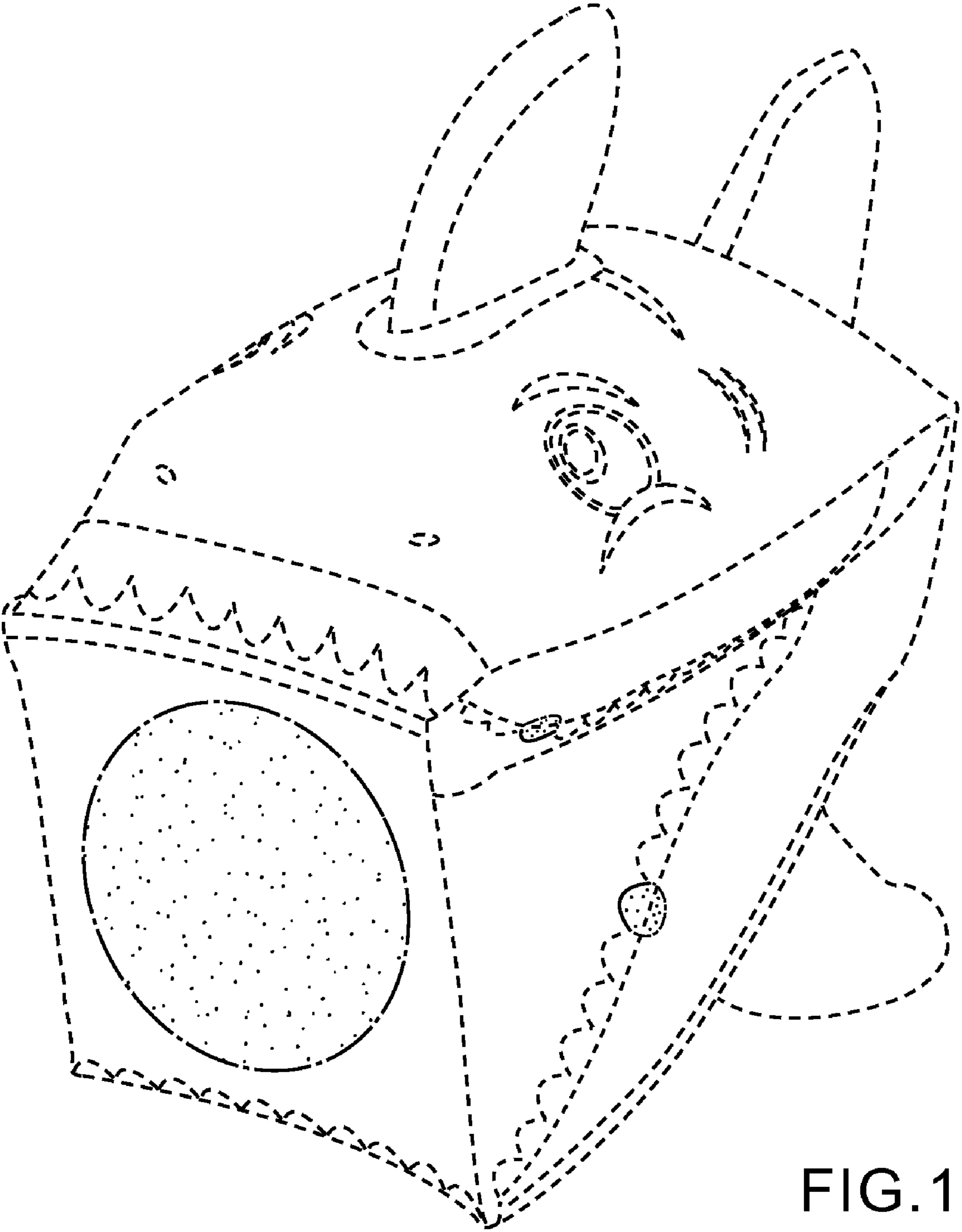

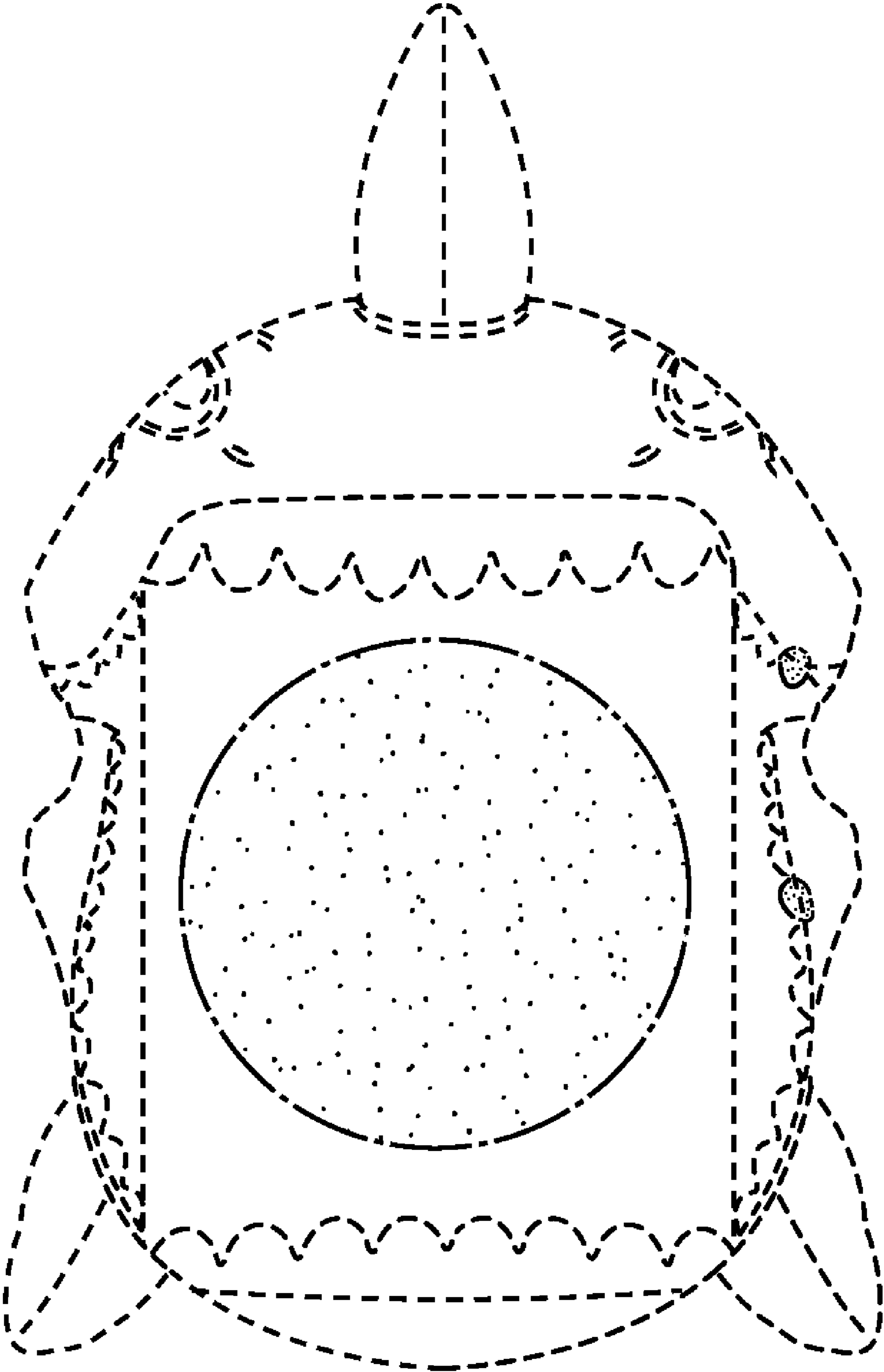

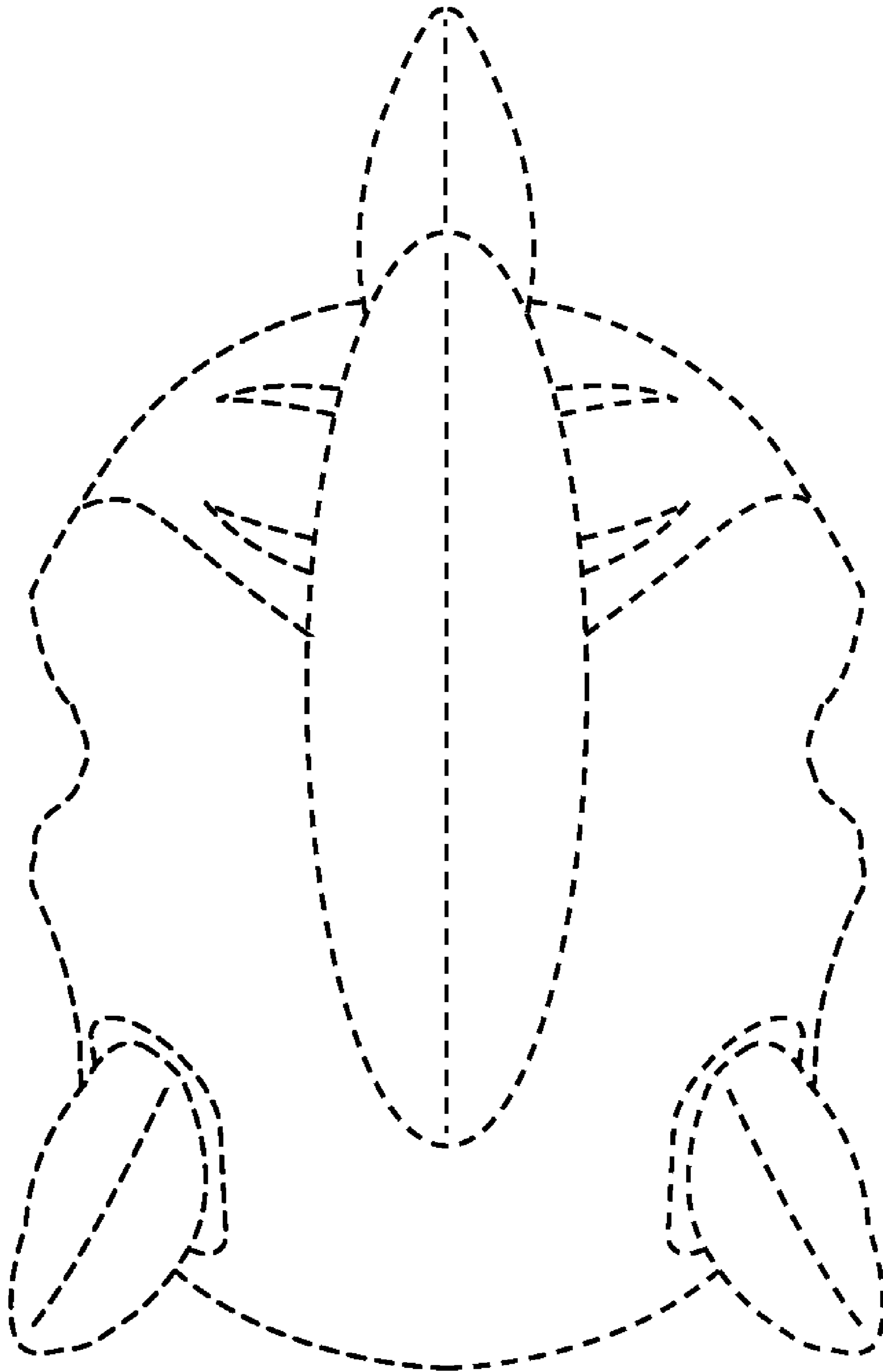

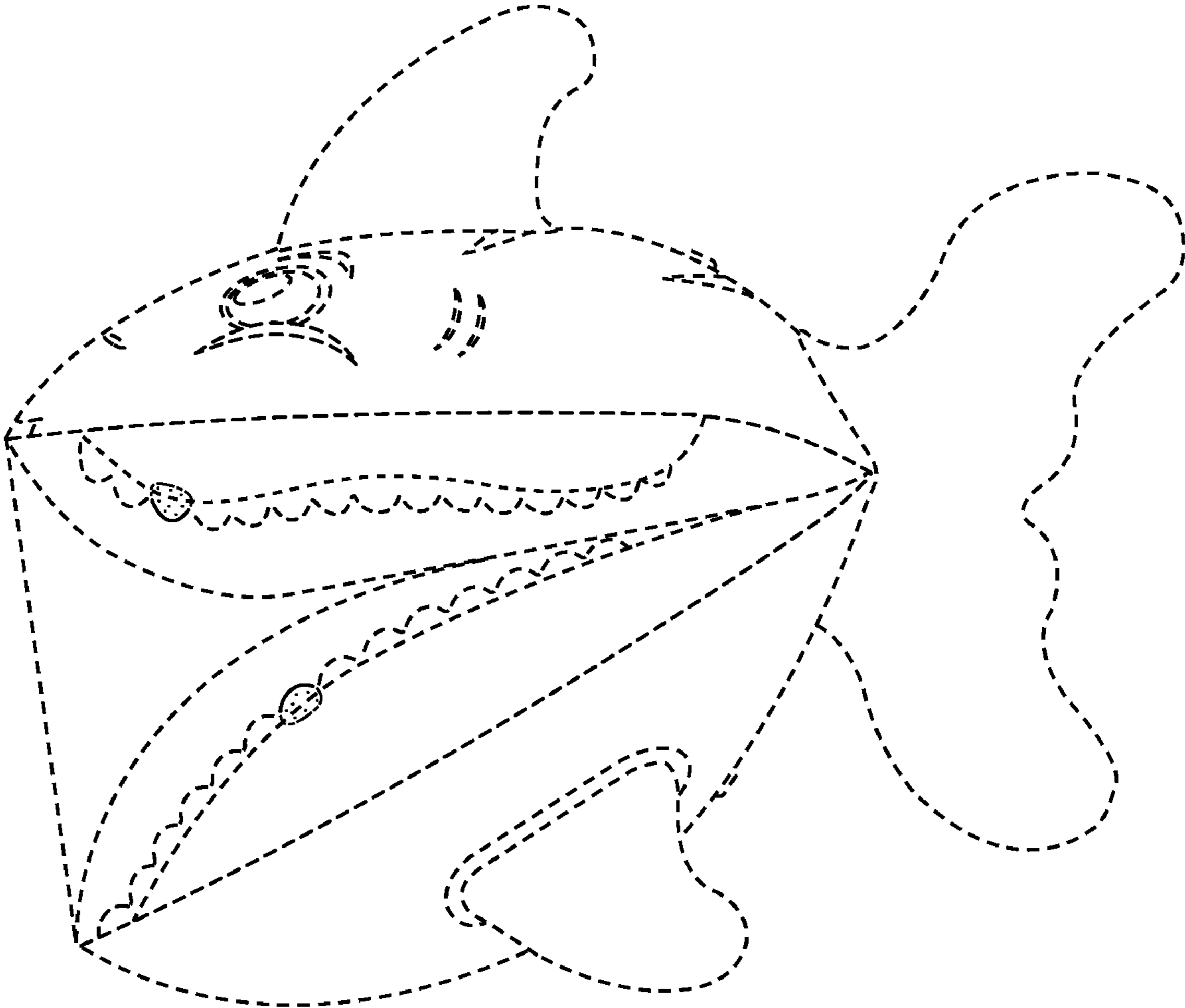

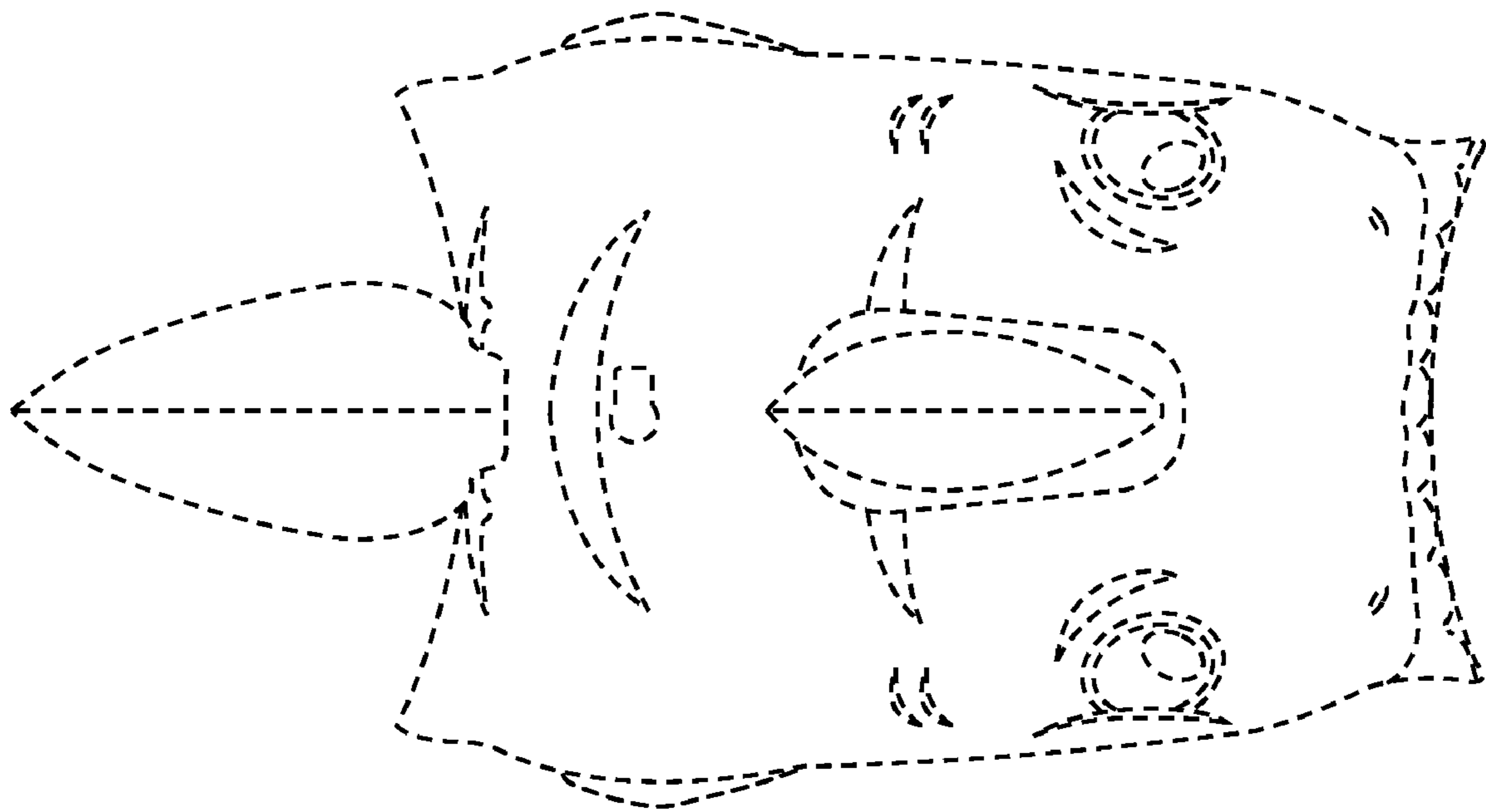

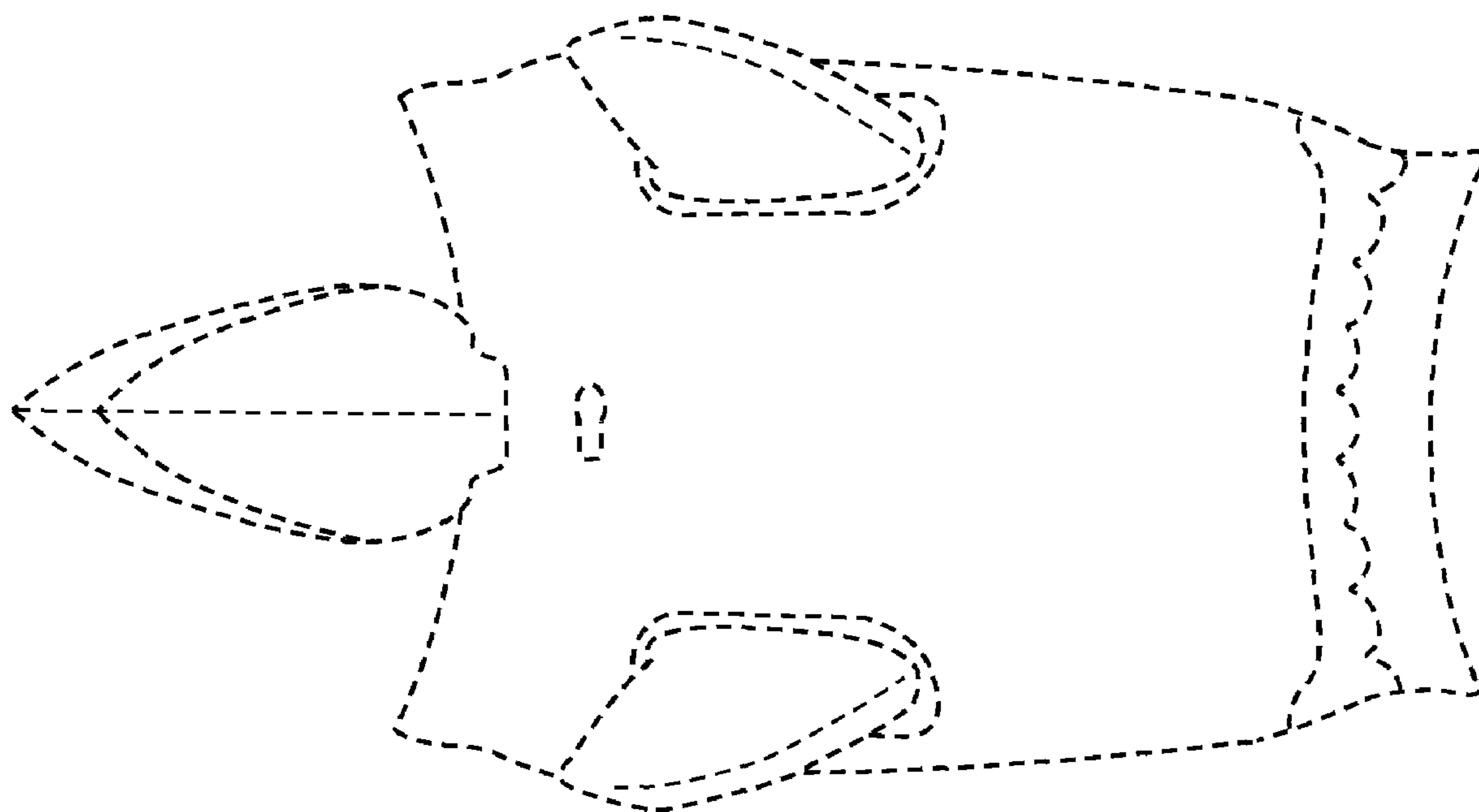

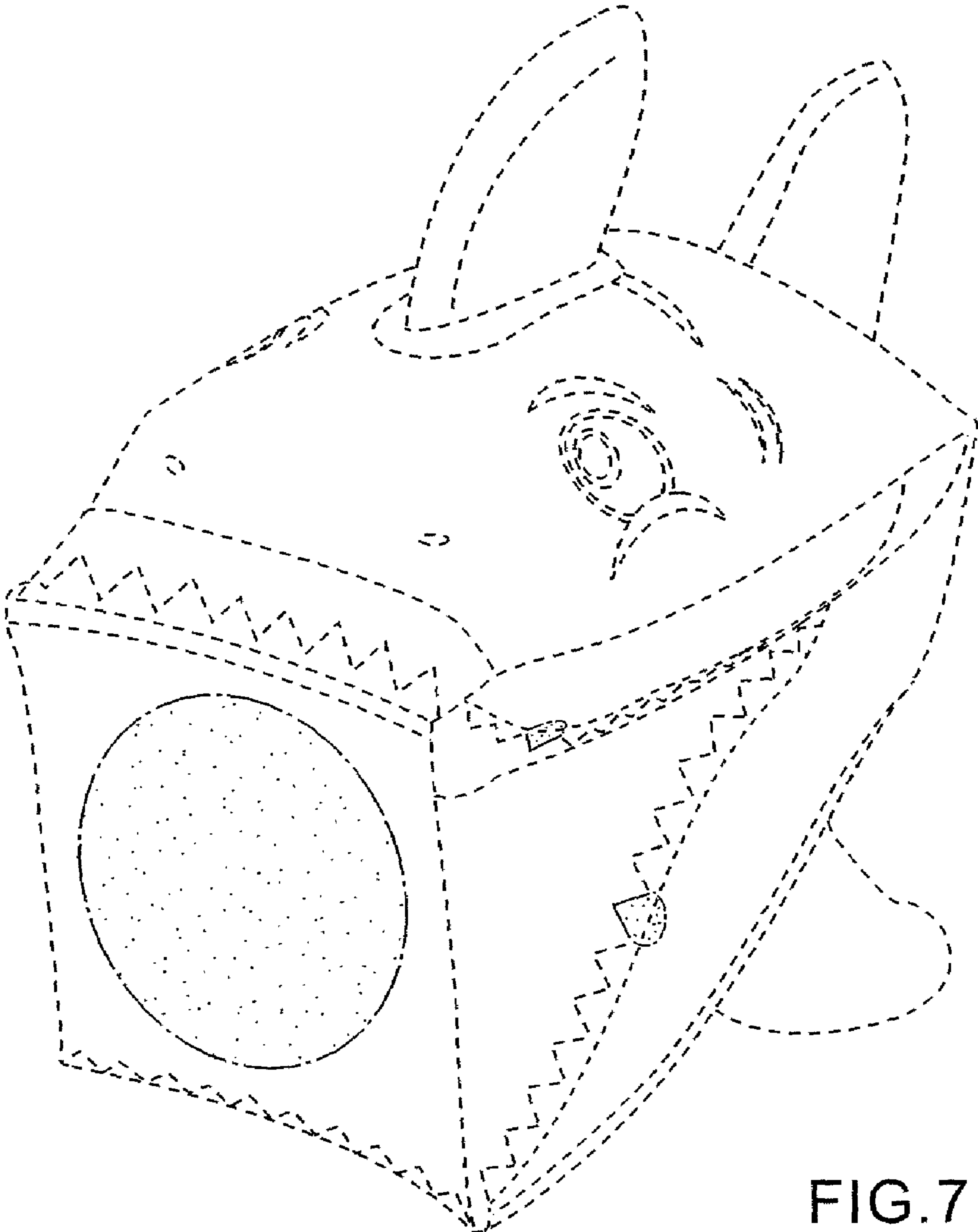

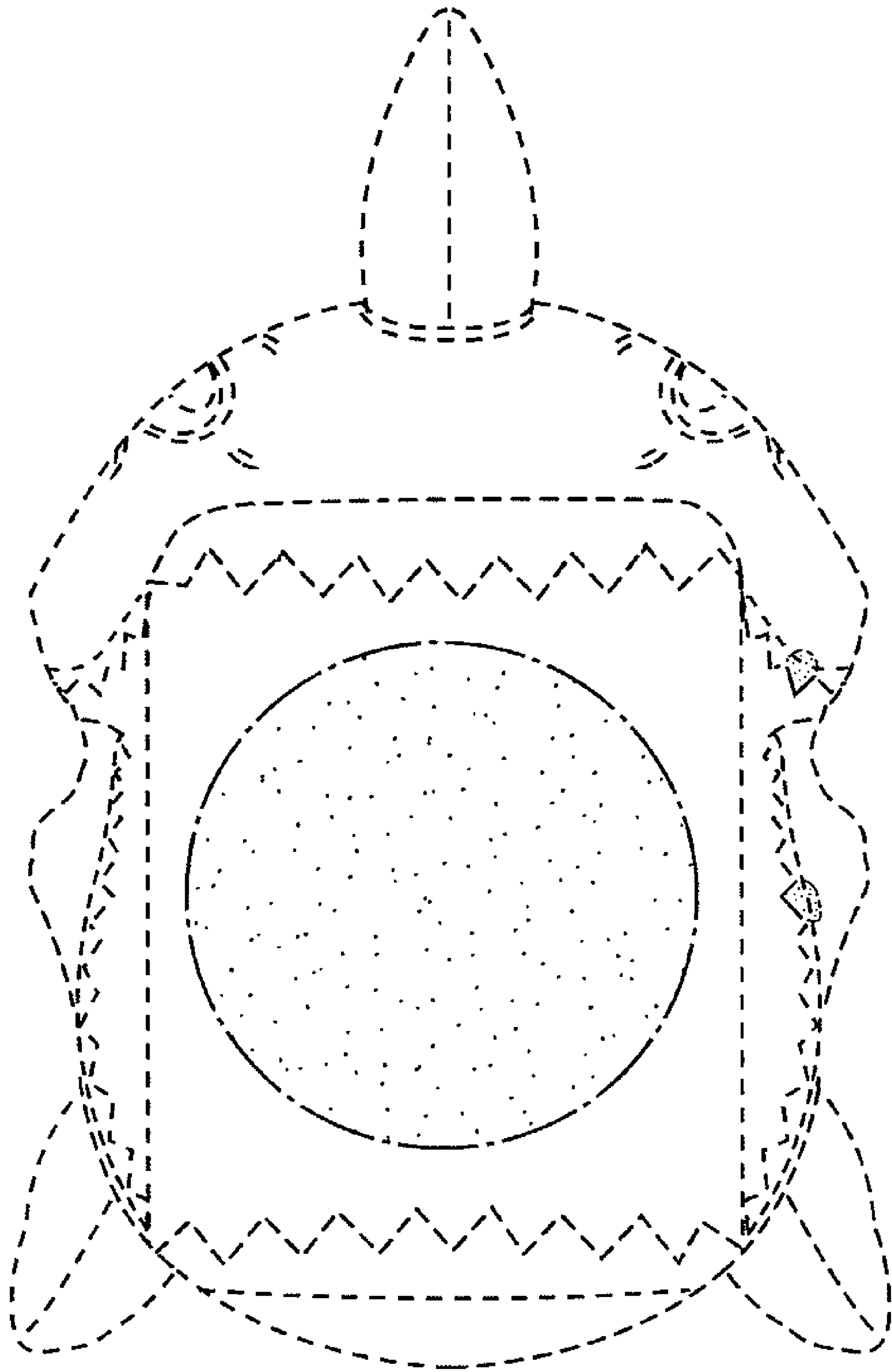

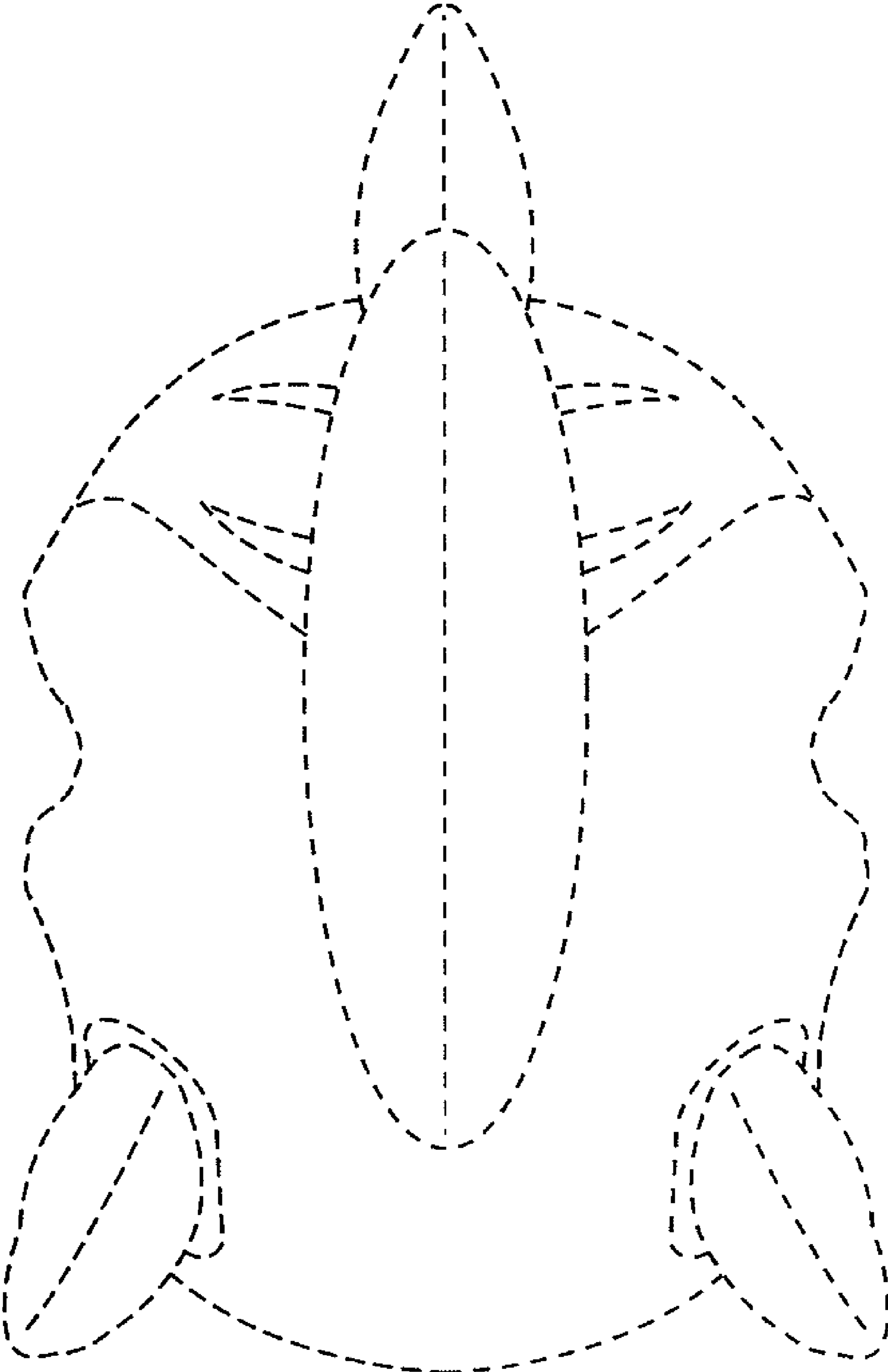

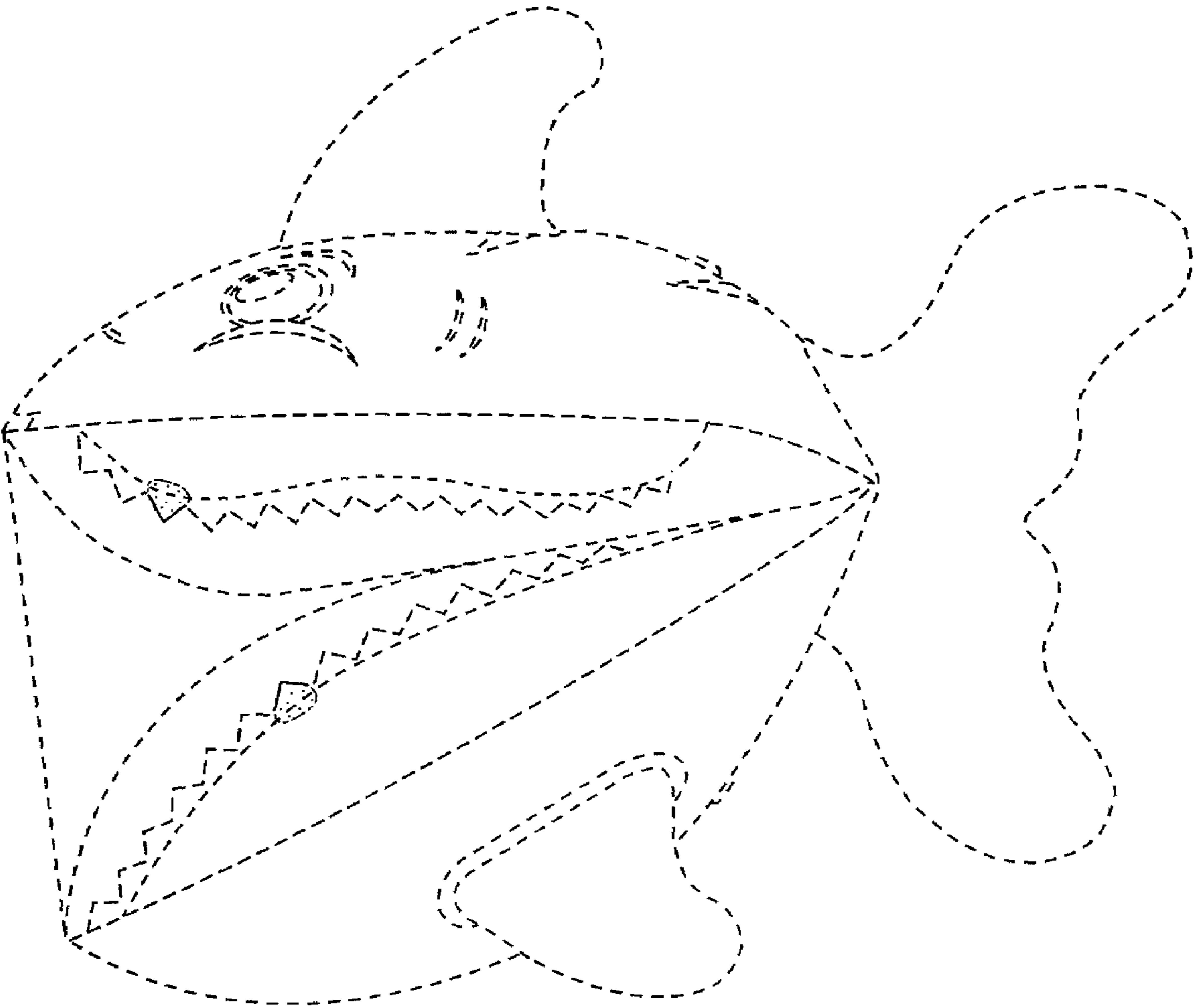

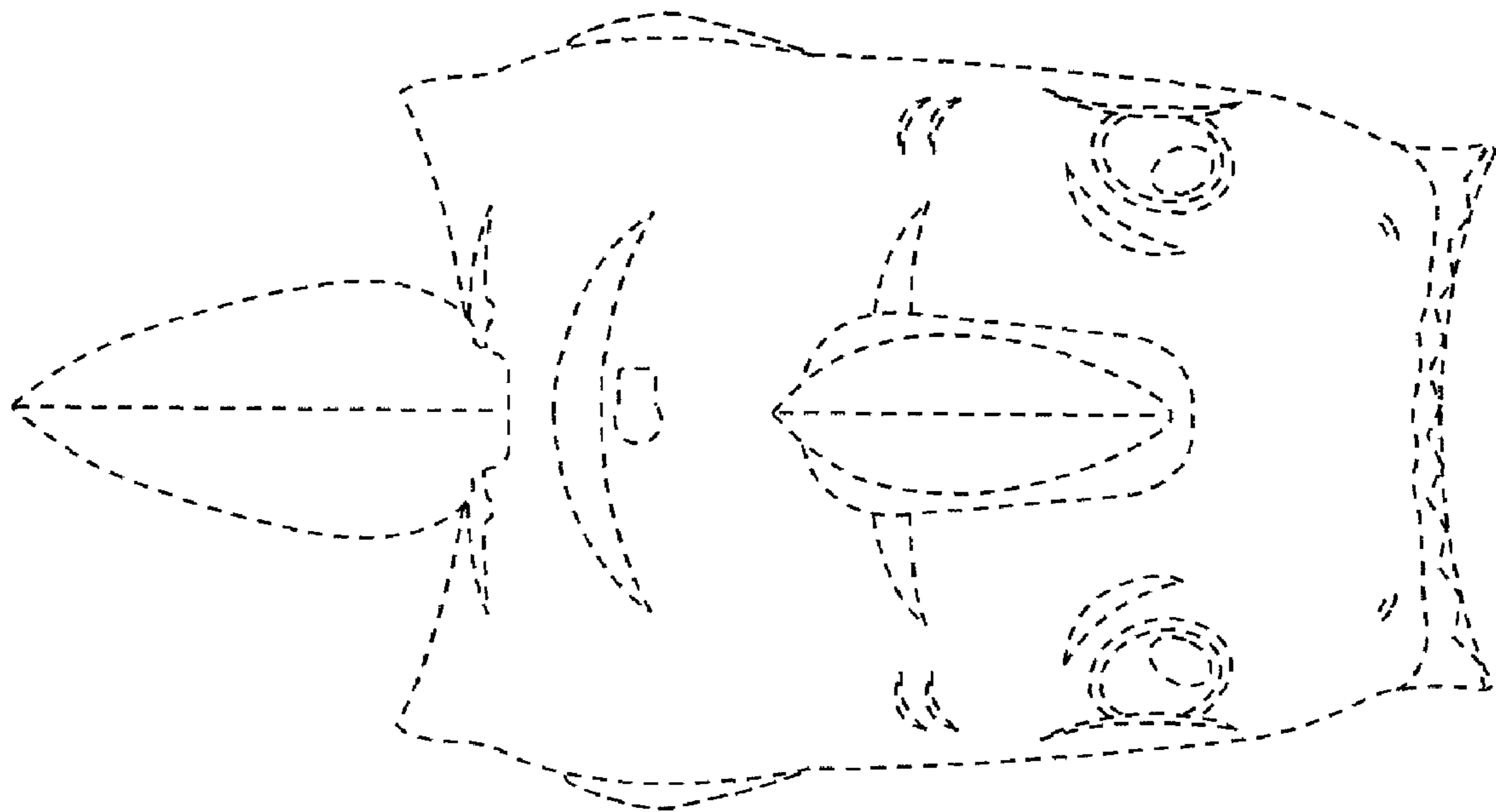

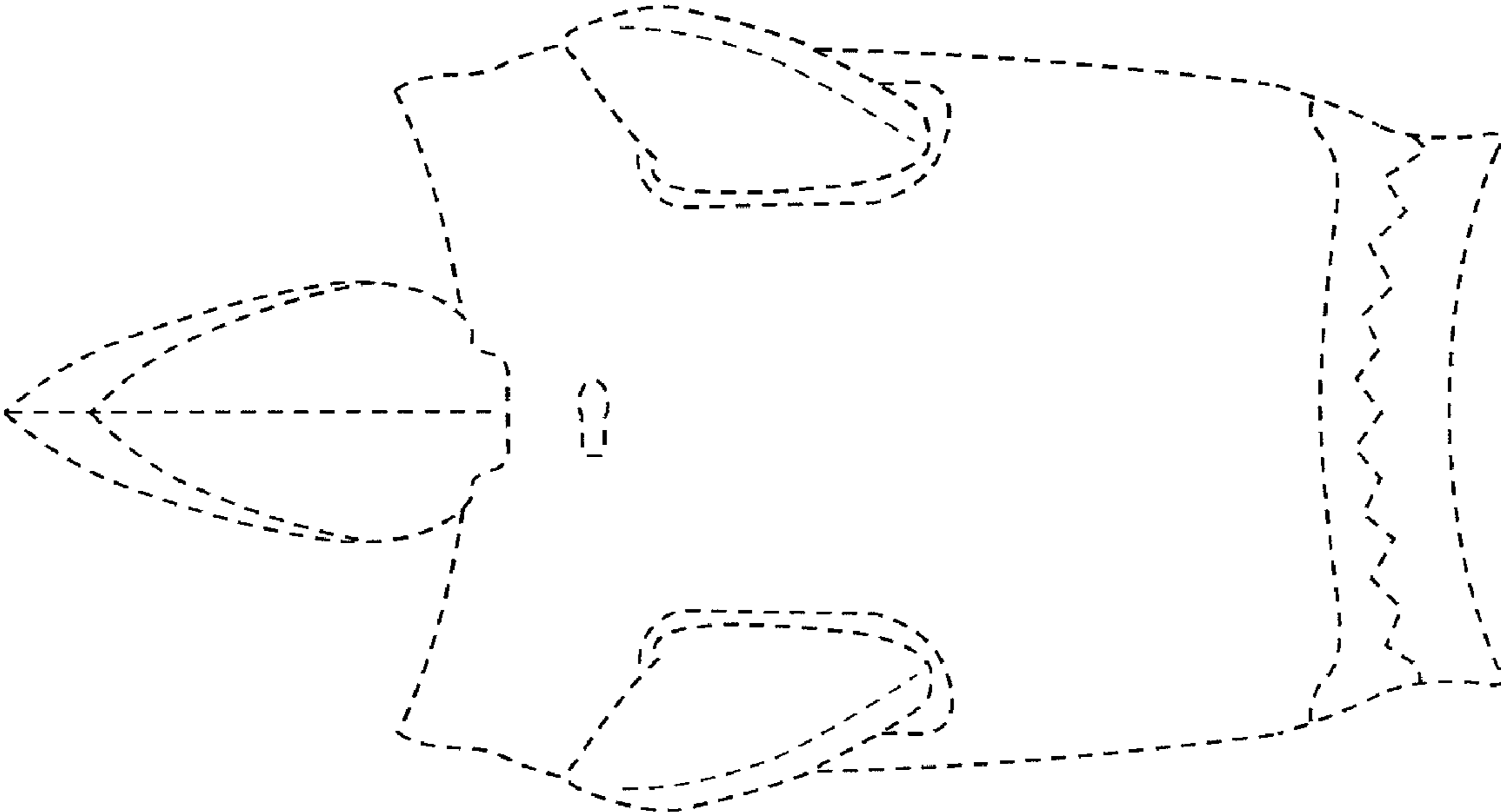
