(57) **CLAIM**

The ornamental design for a lighting fixture with lattice design, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a lighting fixture with lattice design;

FIG. 2 is an enlarged bottom perspective view thereof;

FIG. 3 is an elevational view of a first side thereof;

FIG. 4 is an elevational view of a second side thereof that essentially opposes the first side;

FIG. 5 is an elevational view of a third side thereof;

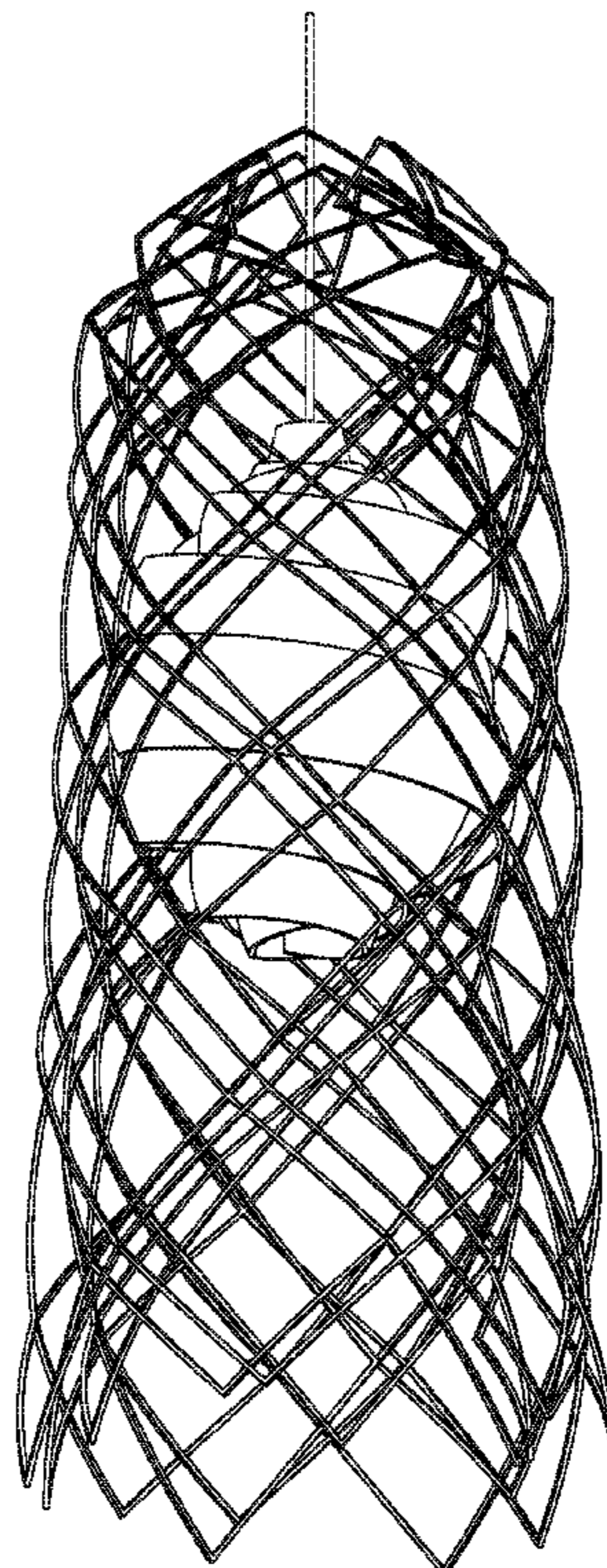
FIG. 6 is an elevational view of a fourth side thereof that essentially opposes the third side;

FIG. 7 is a top plan view thereof; and,

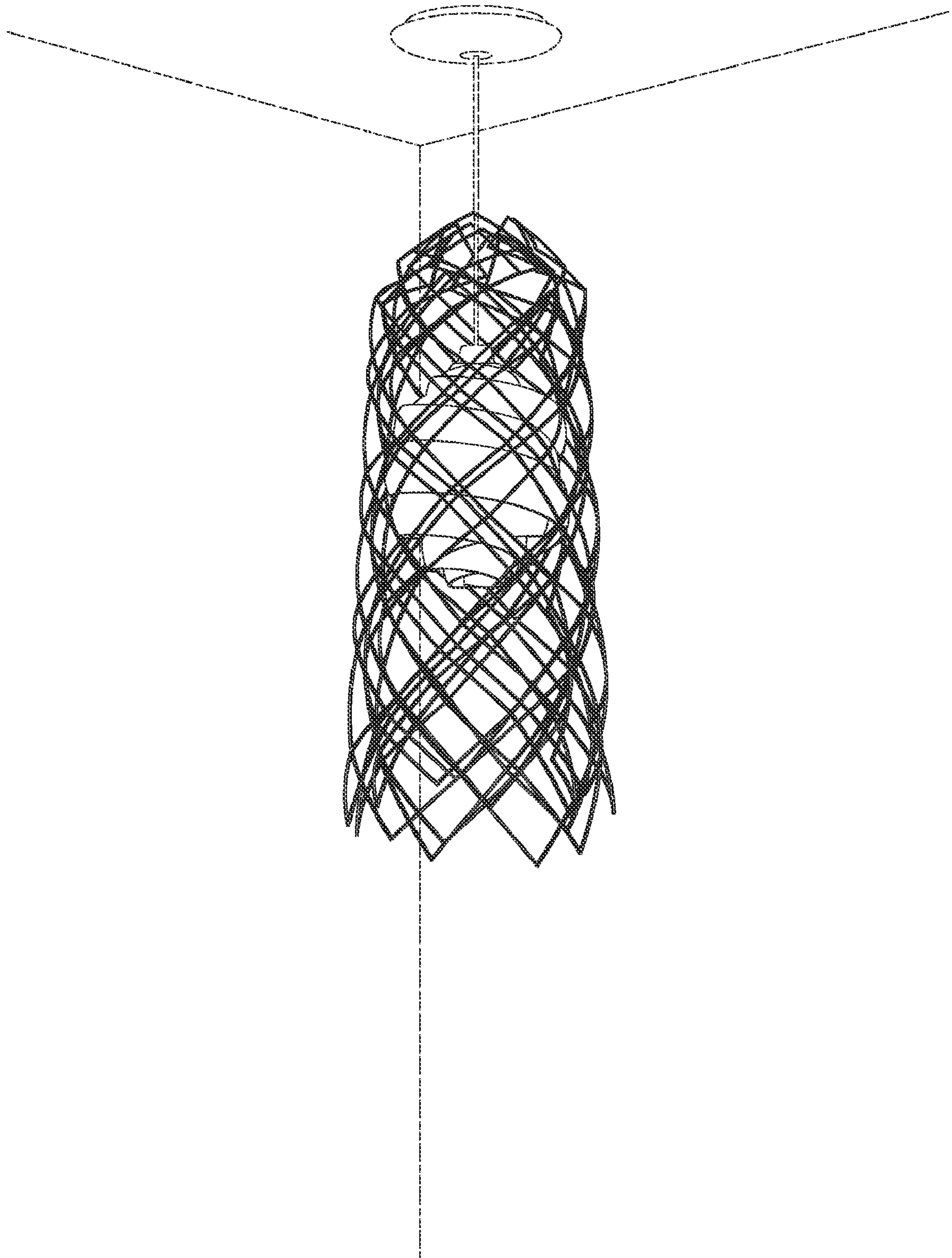

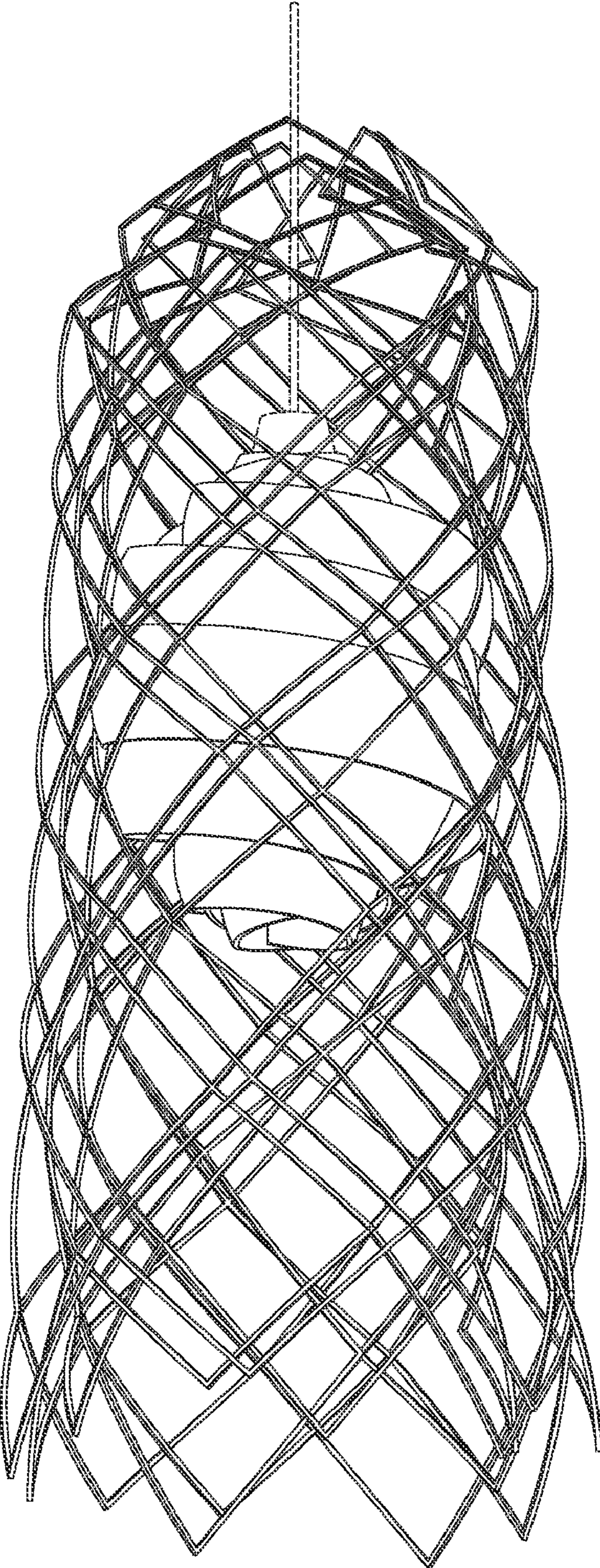

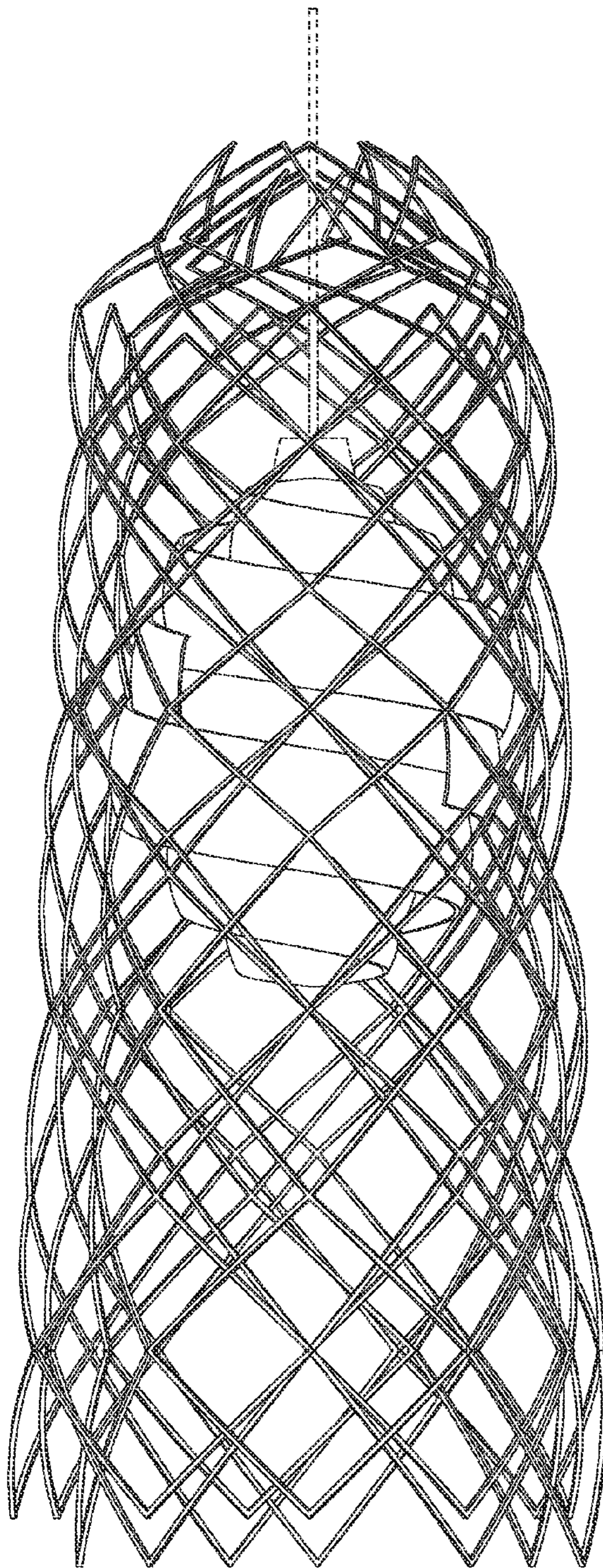

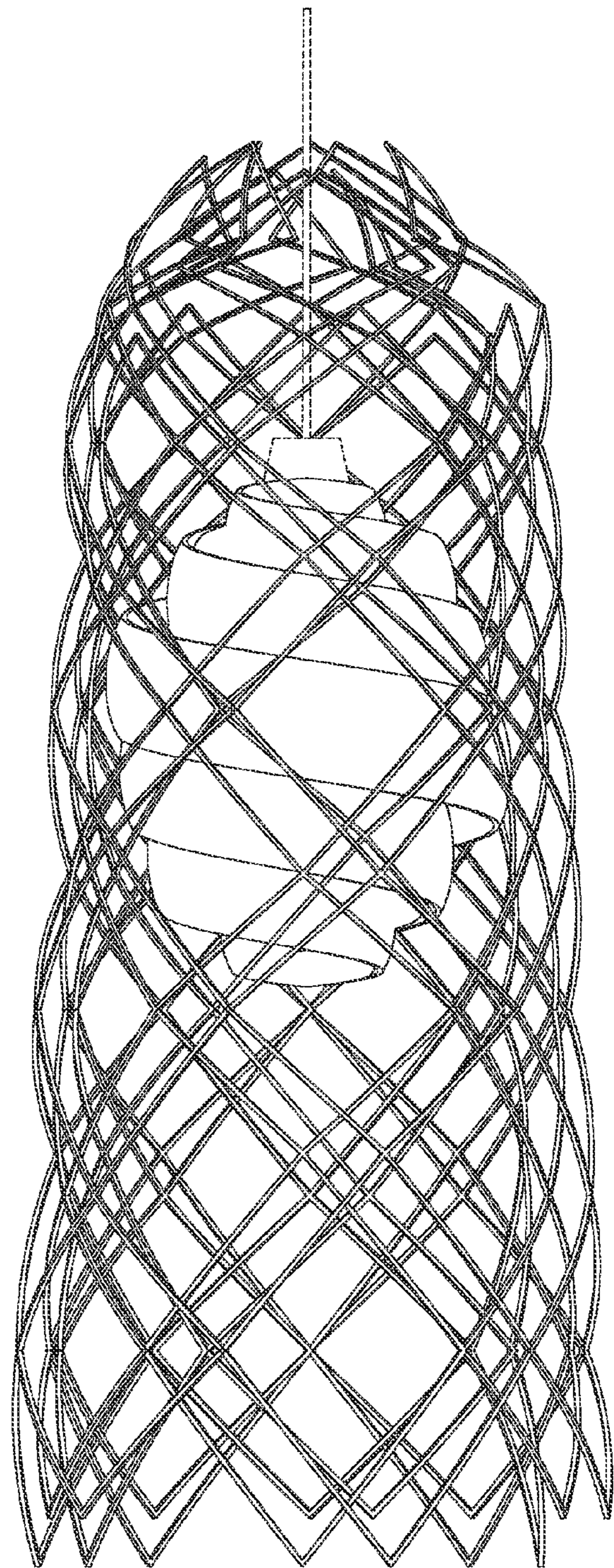

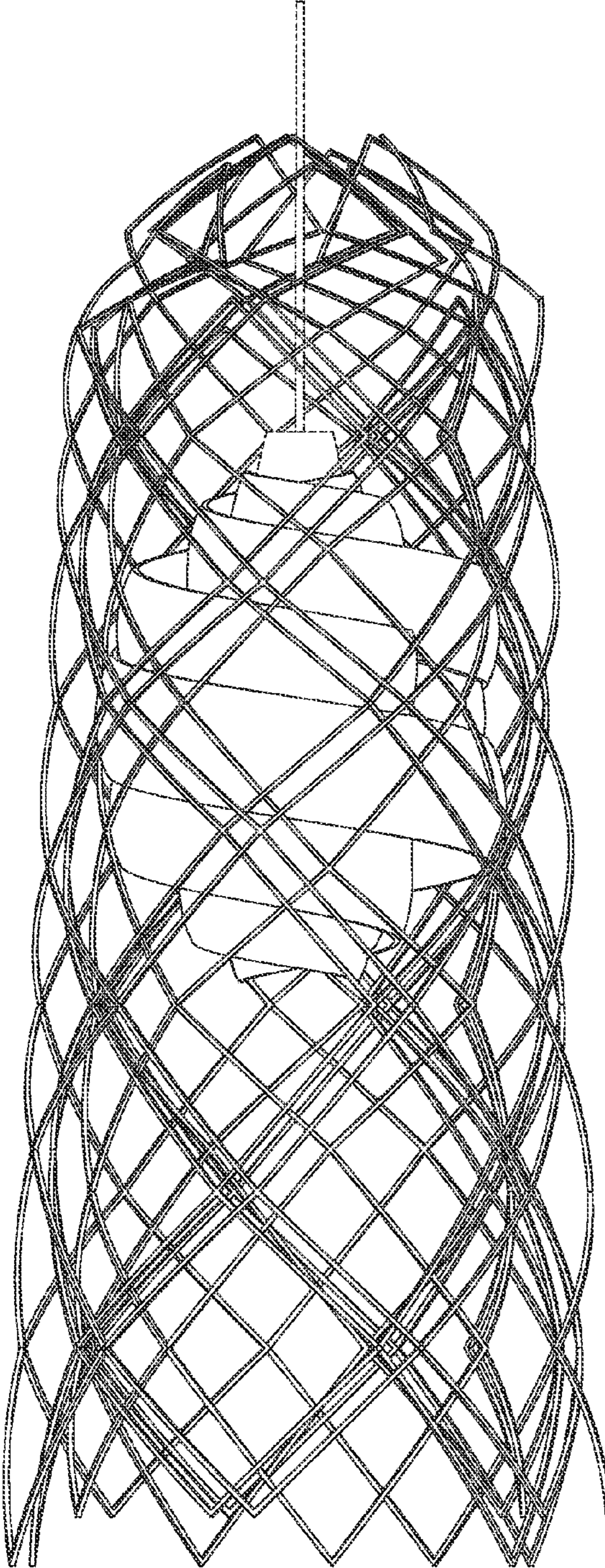

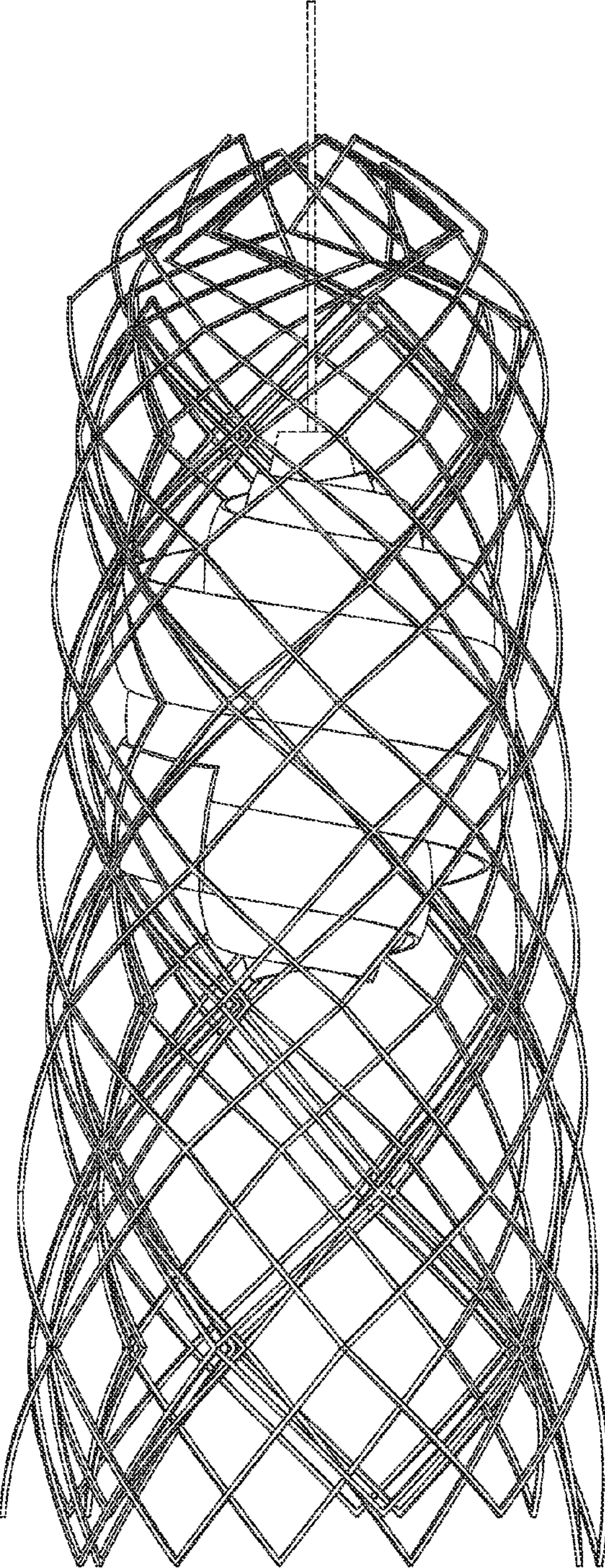

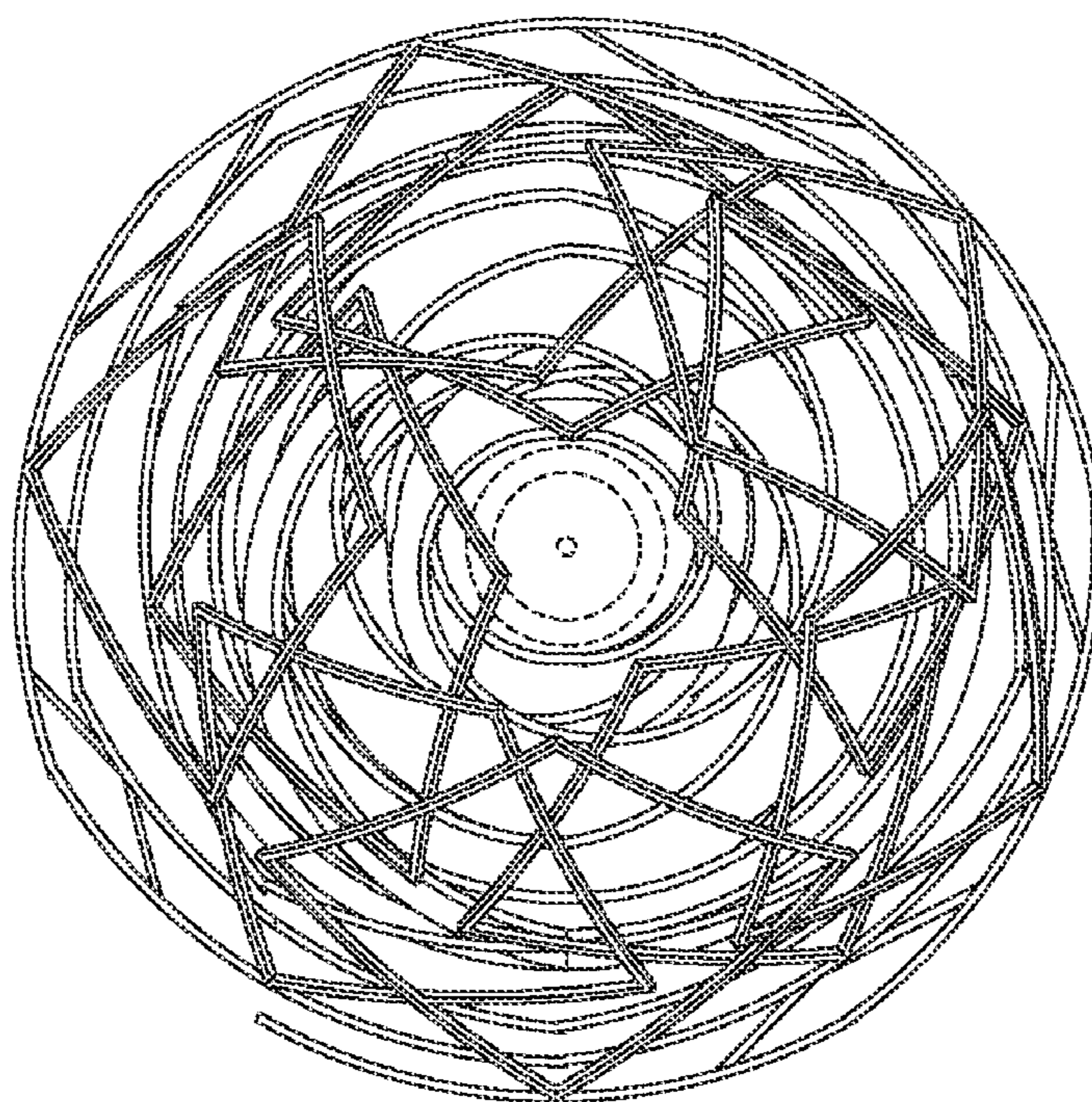

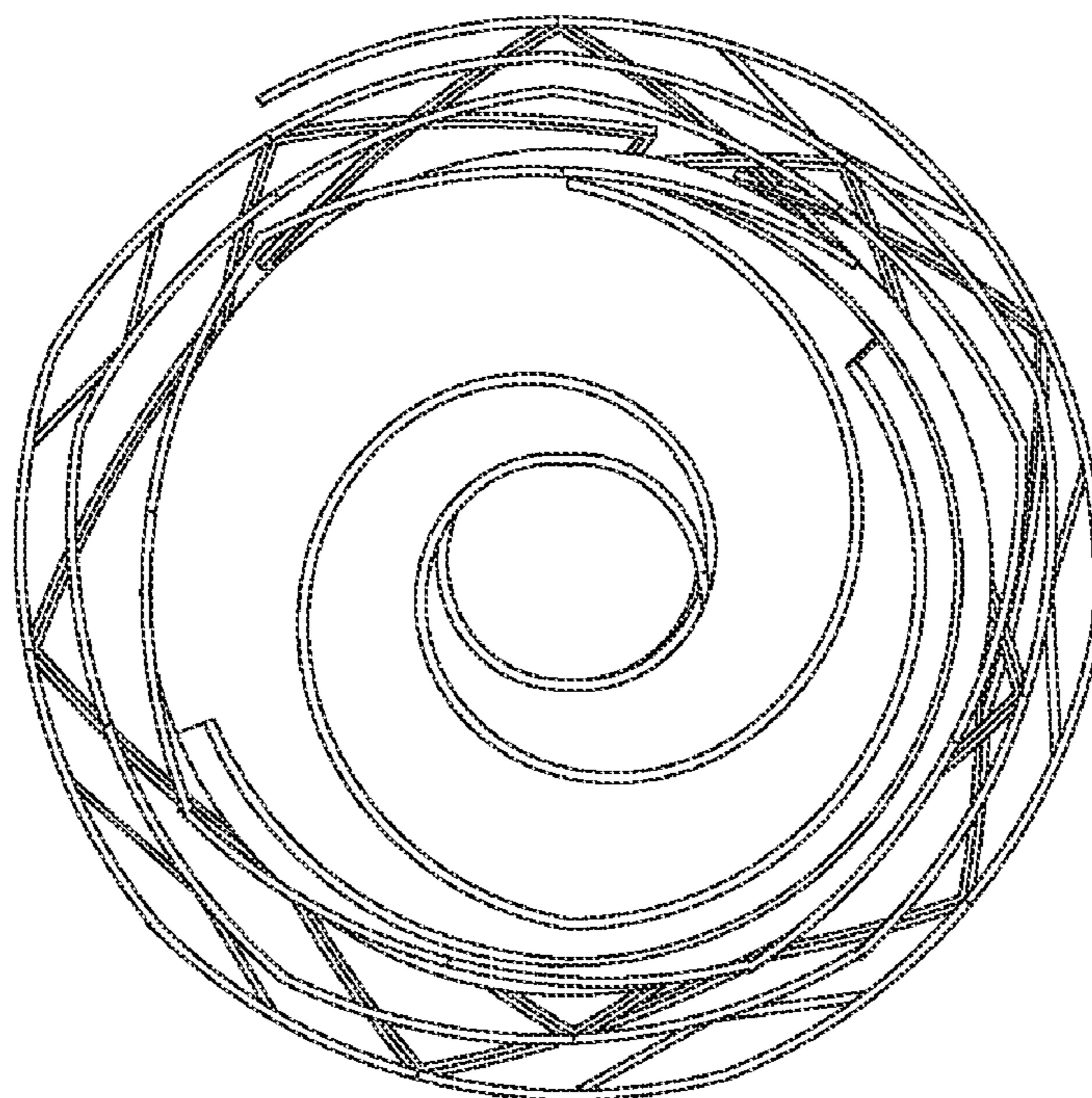
