DESCRIPTION

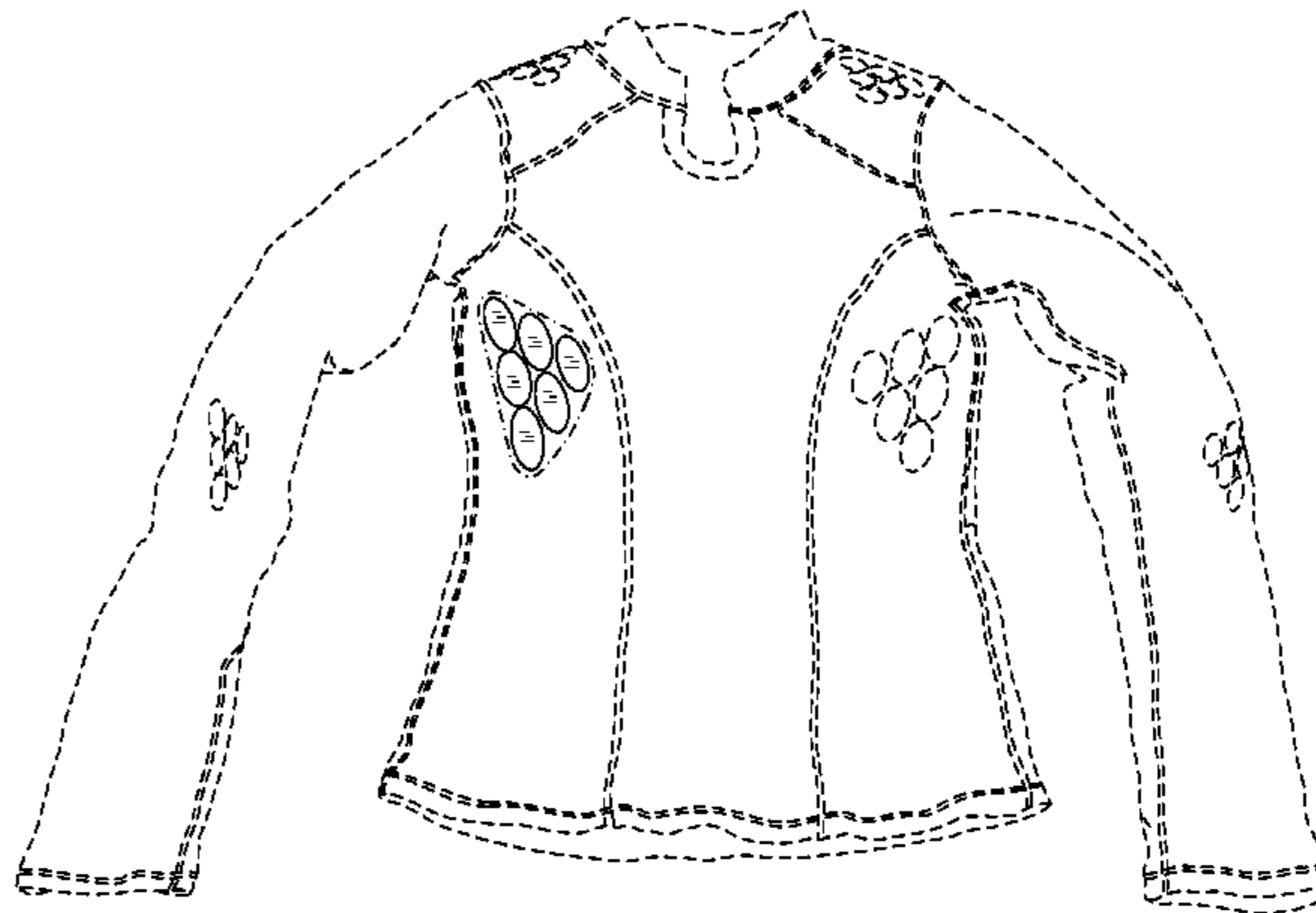
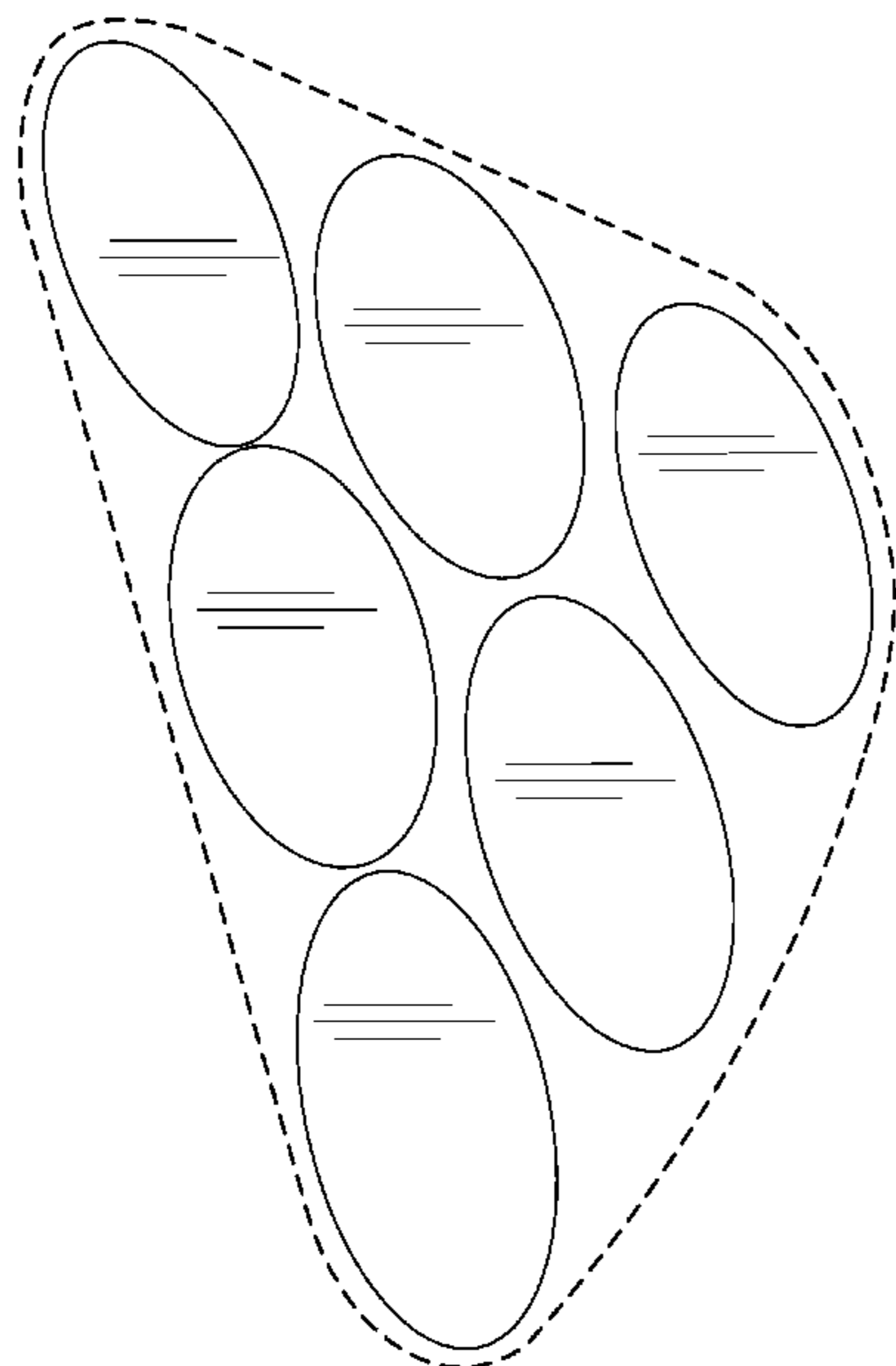
FIG. 1 is an enlarged perspective view of an article of clothing showing the claimed design.

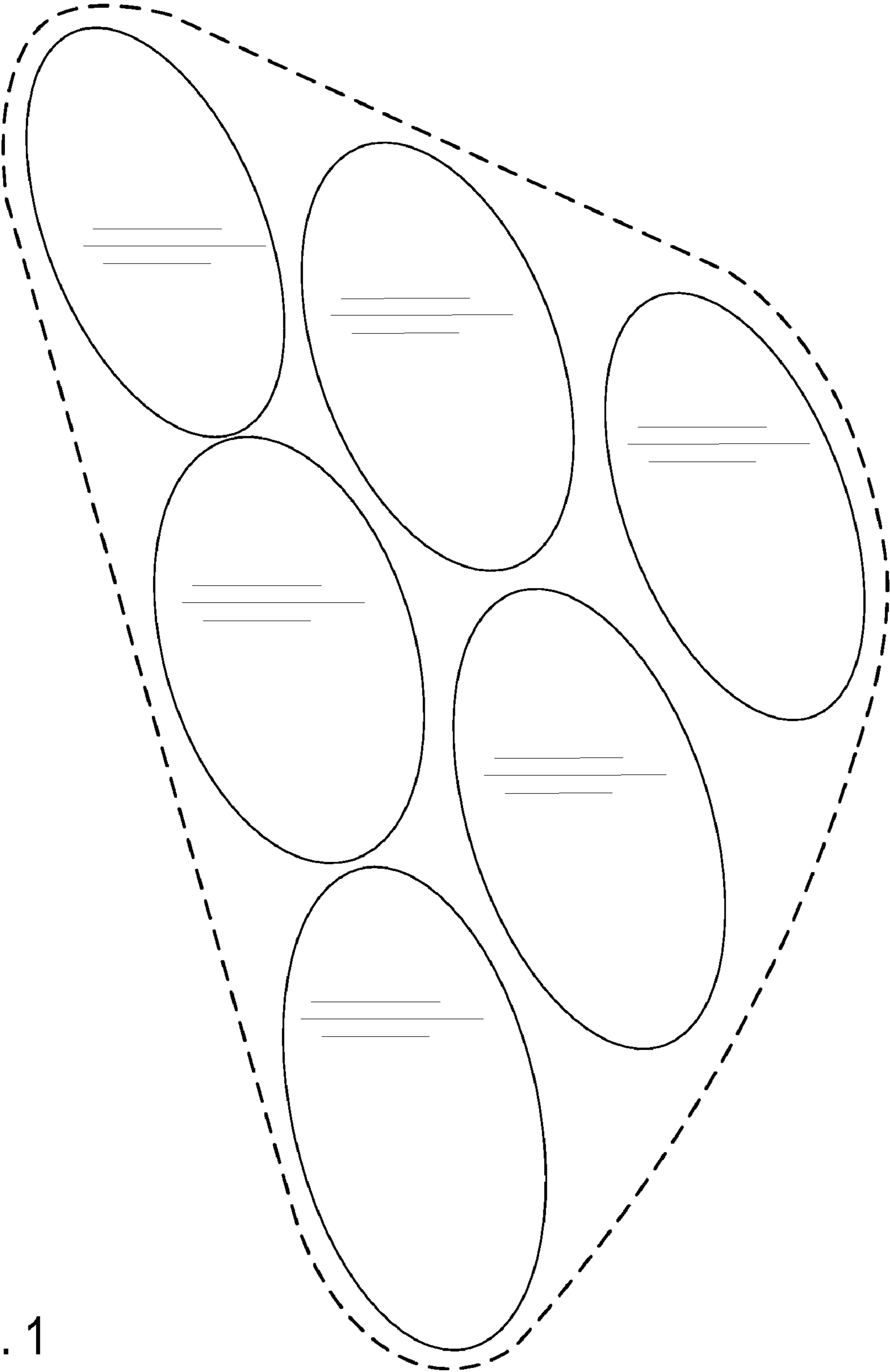

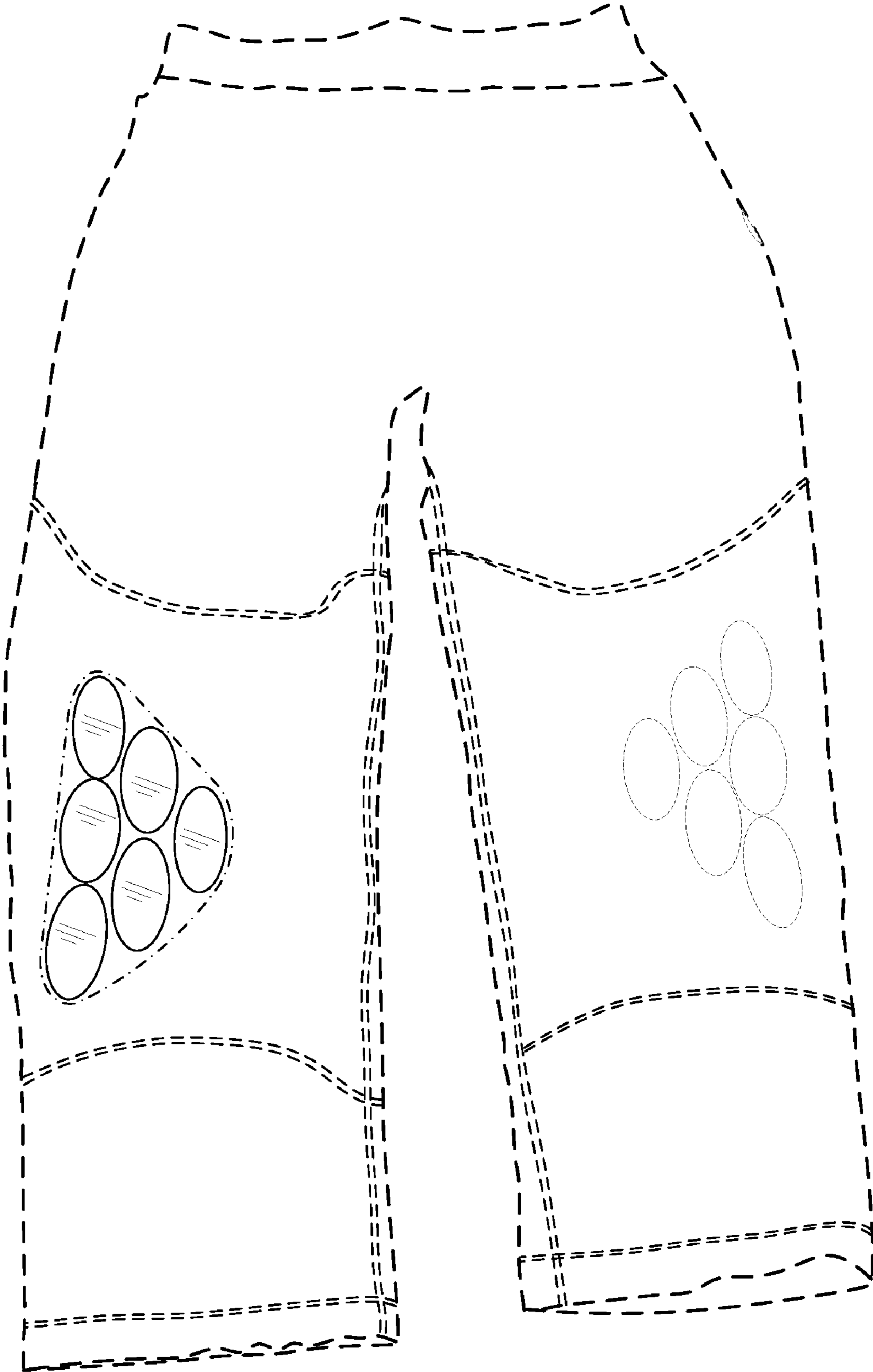
