The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

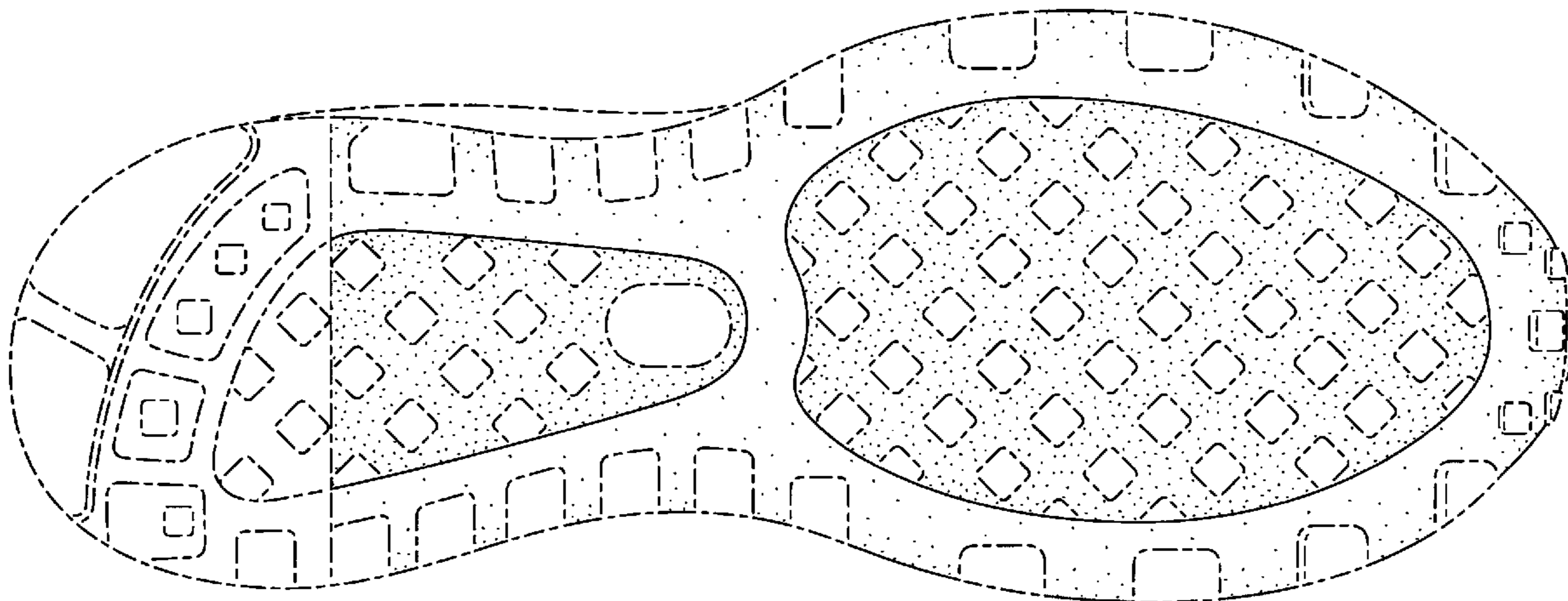
FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is a rear perspective view thereof; and,

FIG. 3 is a bottom view thereof.

The depicted contrast in shading represents a change in appearance due to material, texture, or color. The broken line showing that is immediately adjacent to the shaded area represents an unclaimed boundary of the design. The broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

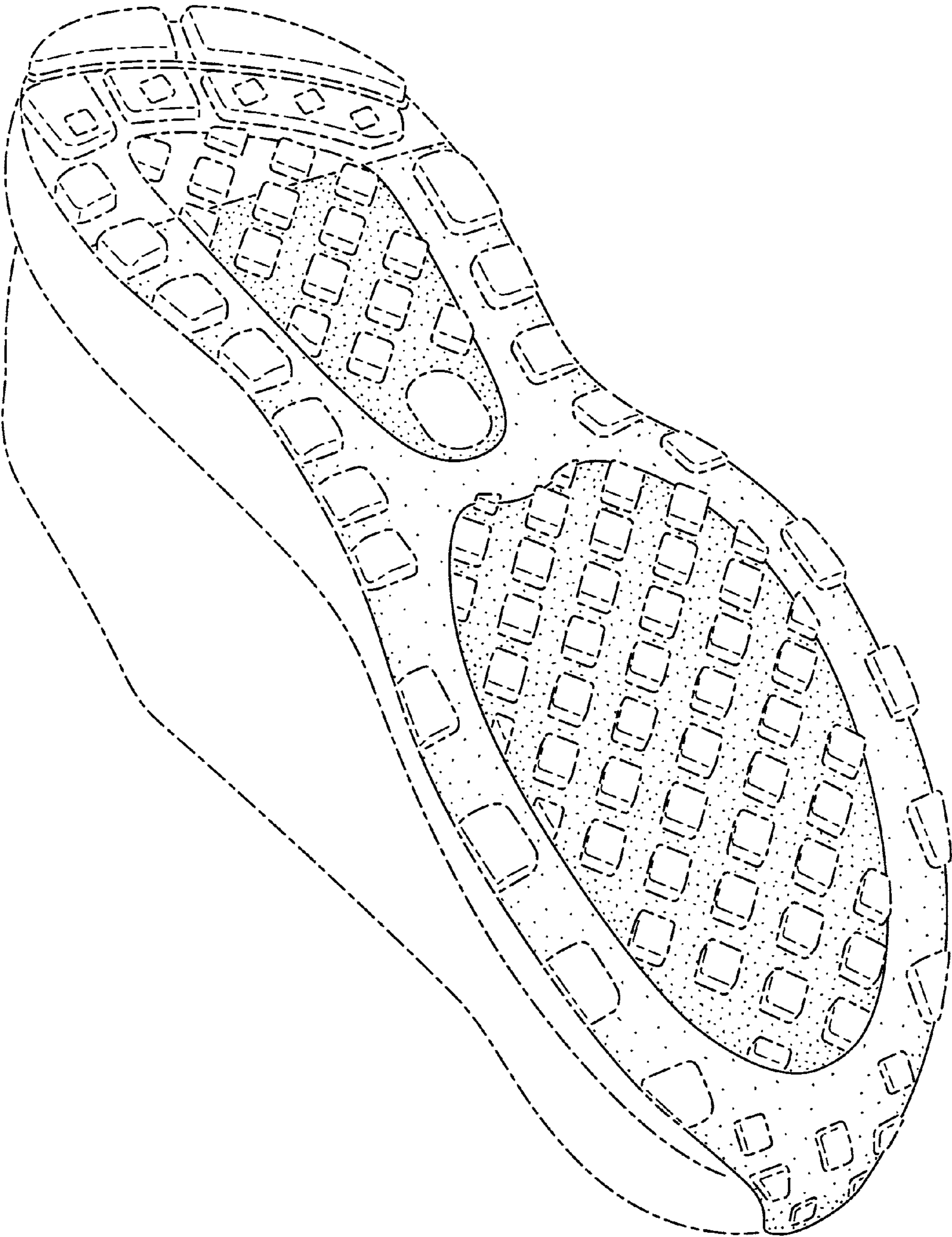

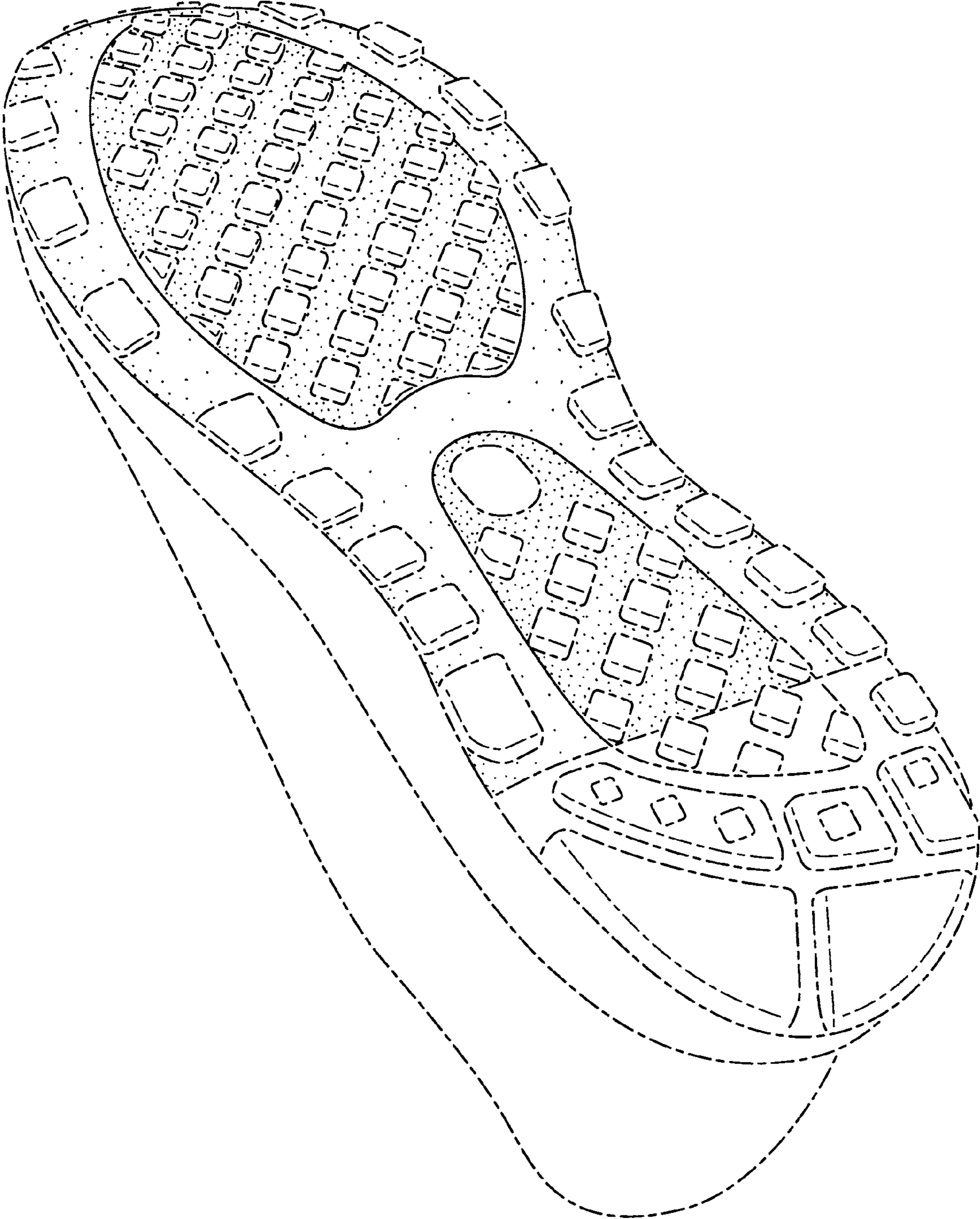

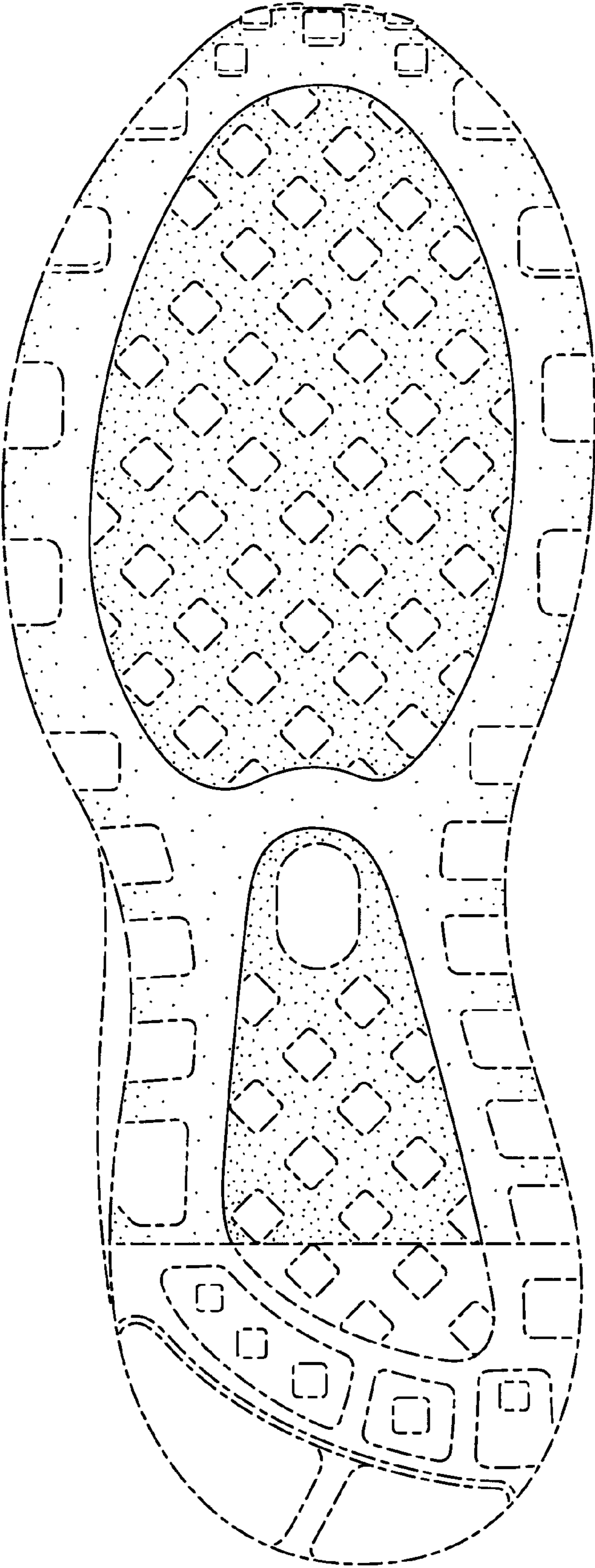
