(57) **CLAIM**

The ornamental design for a mascara brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a mascara brush, embodying the new design;

FIG. 10 is a back view of the design shown in FIG. 8;

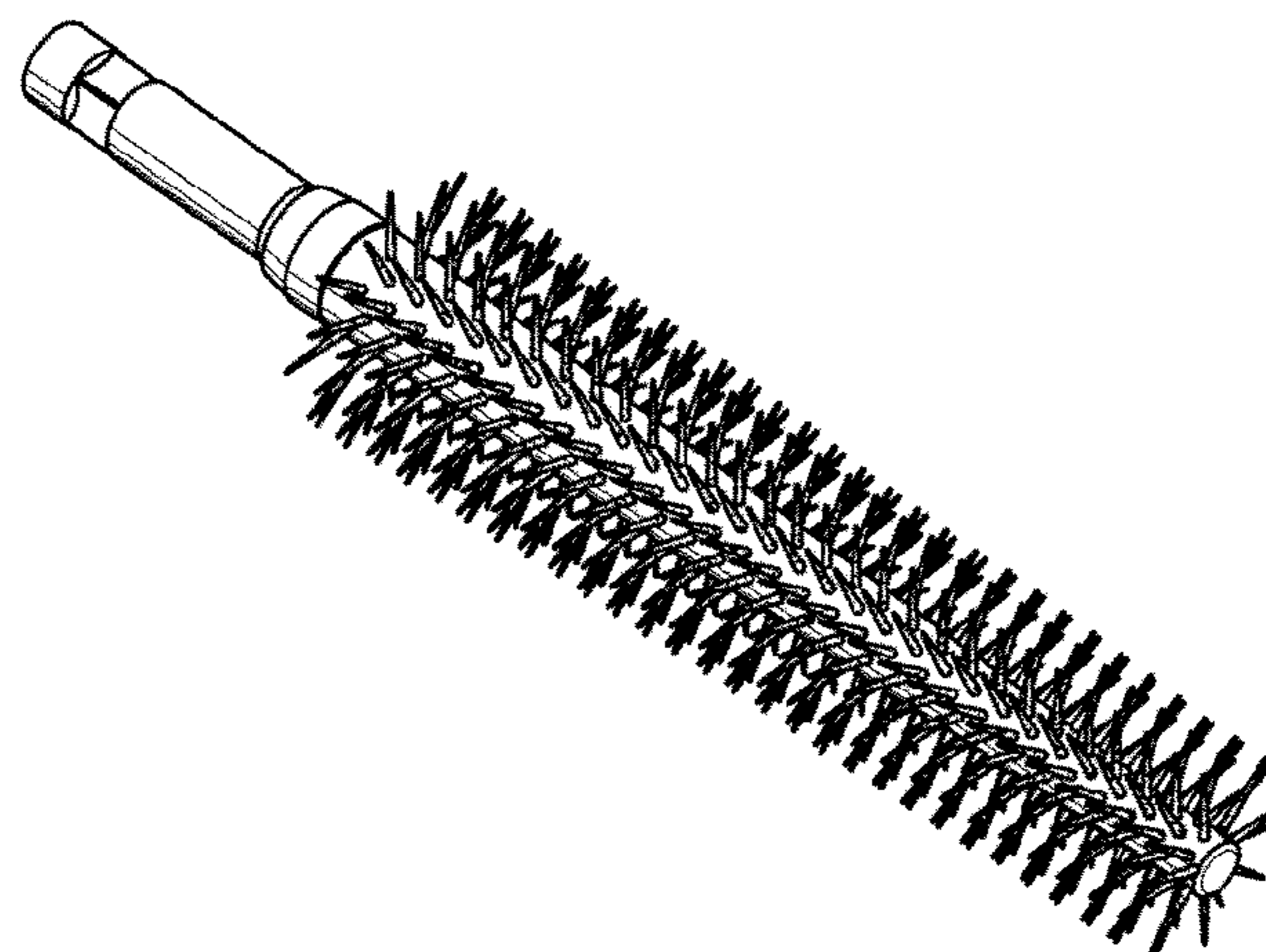
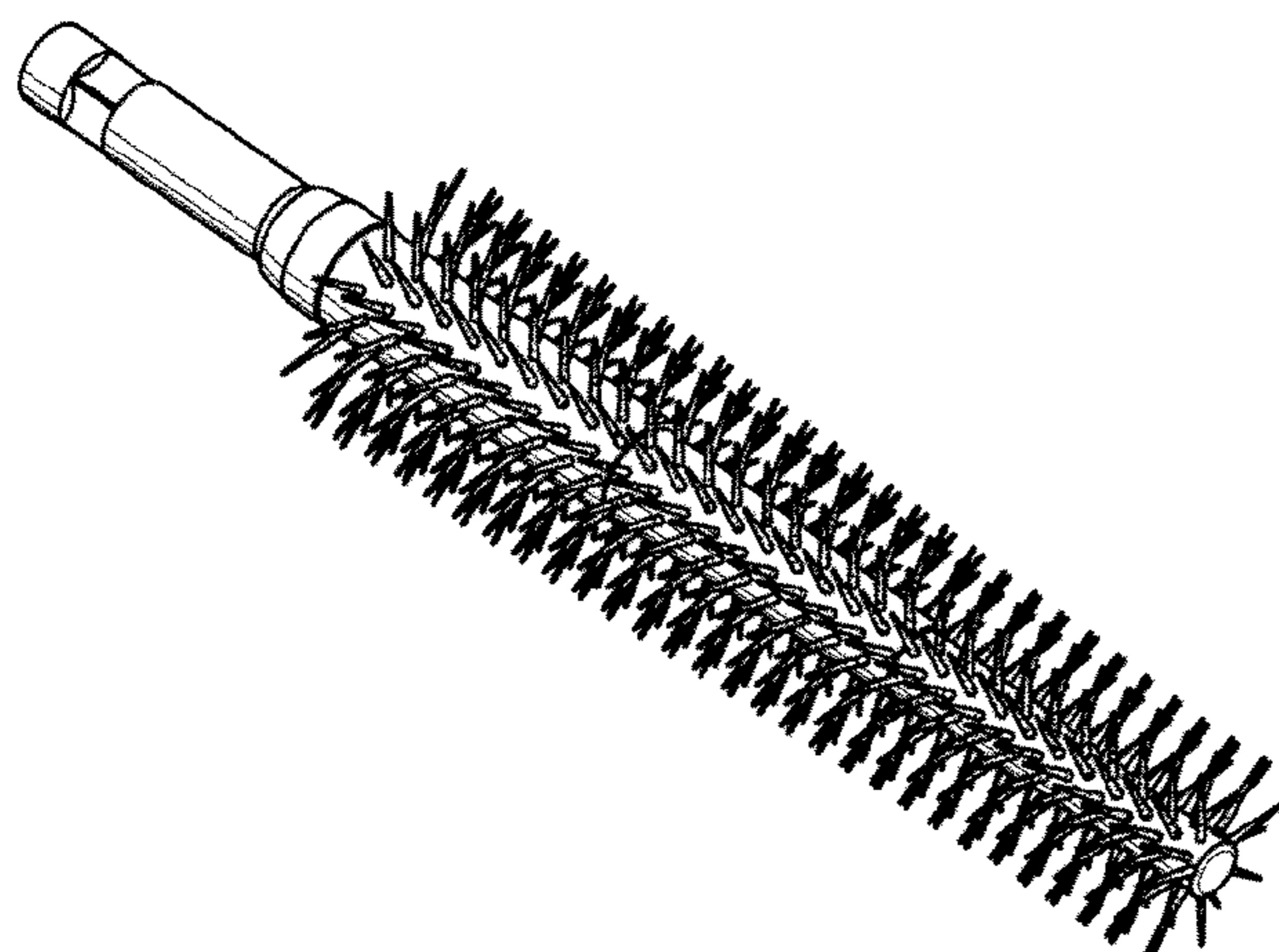
FIG. 11 is a left side view of the design shown in FIG. 8;

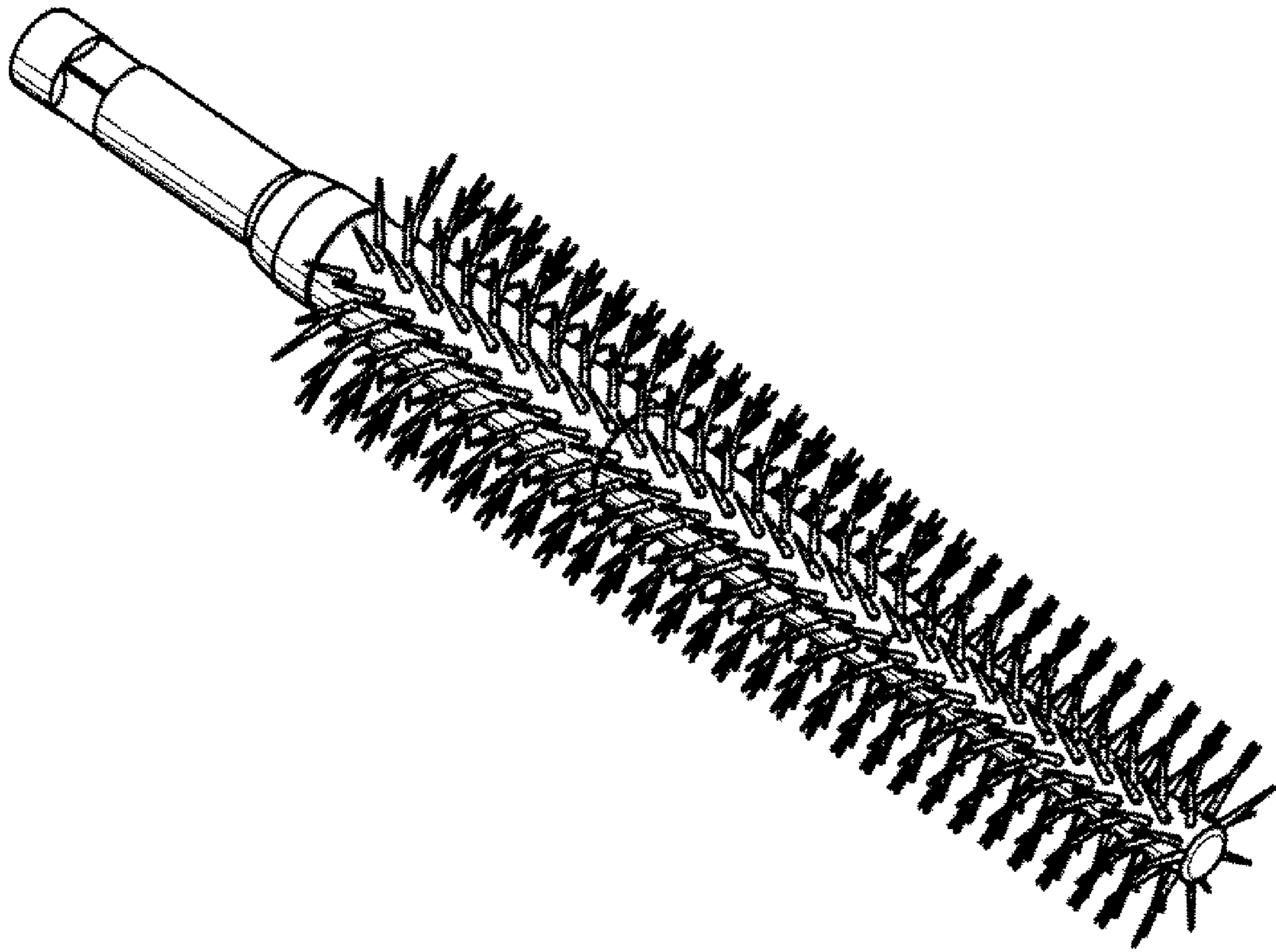
FIG. 12 is a right side view of the design shown in FIG. 8;

FIG. 13 is a top view of the design shown in FIG. 8; and,

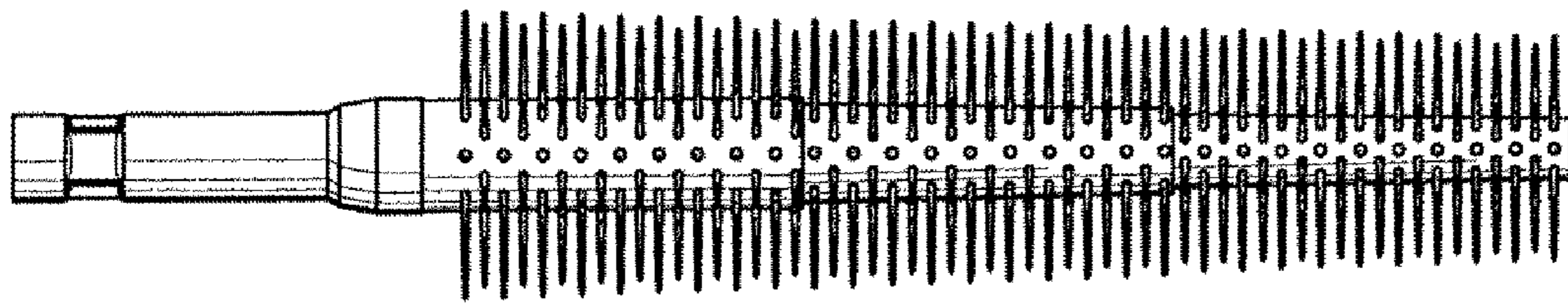
FIG. 14 is a bottom view of the design shown in FIG. 8.

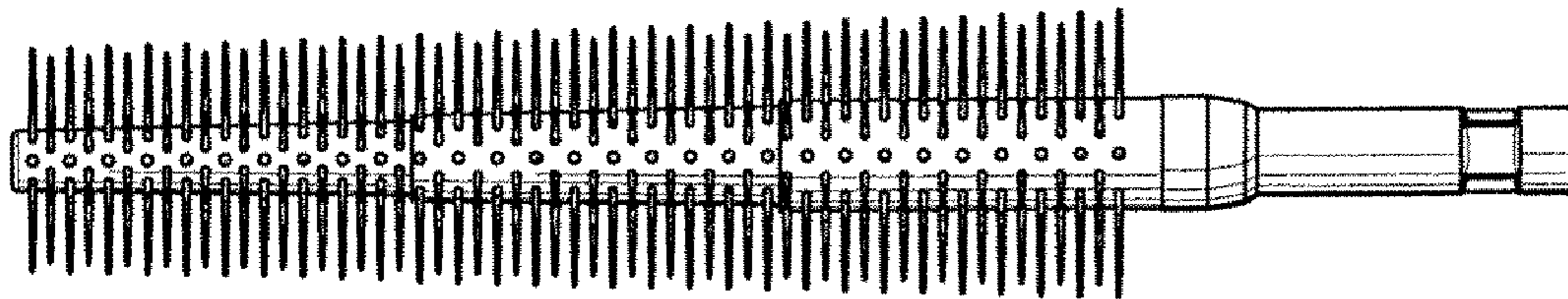

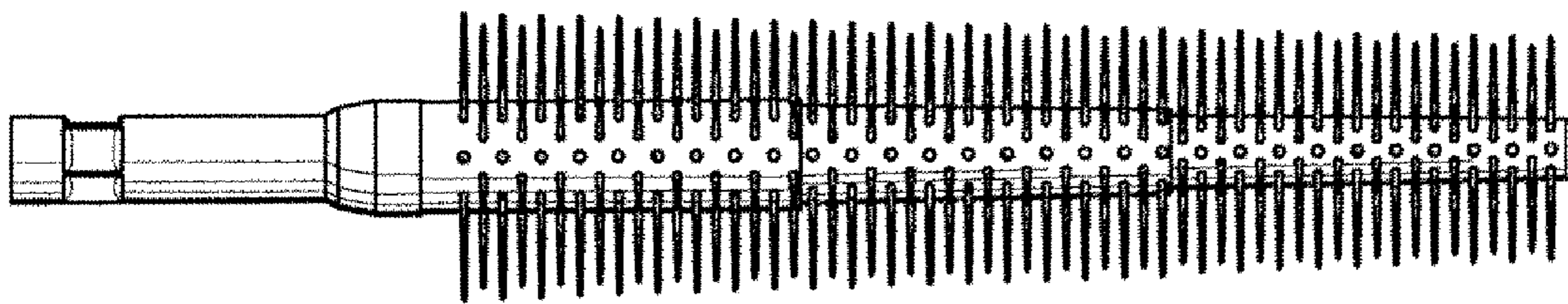

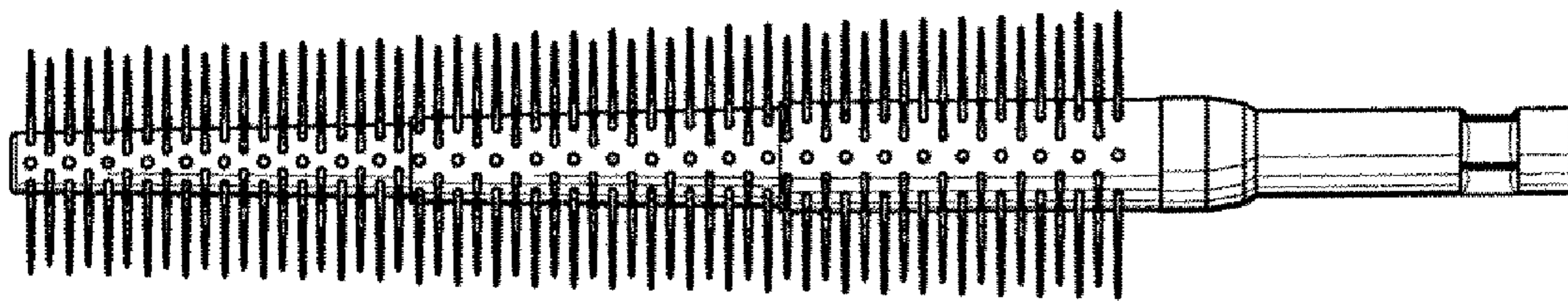

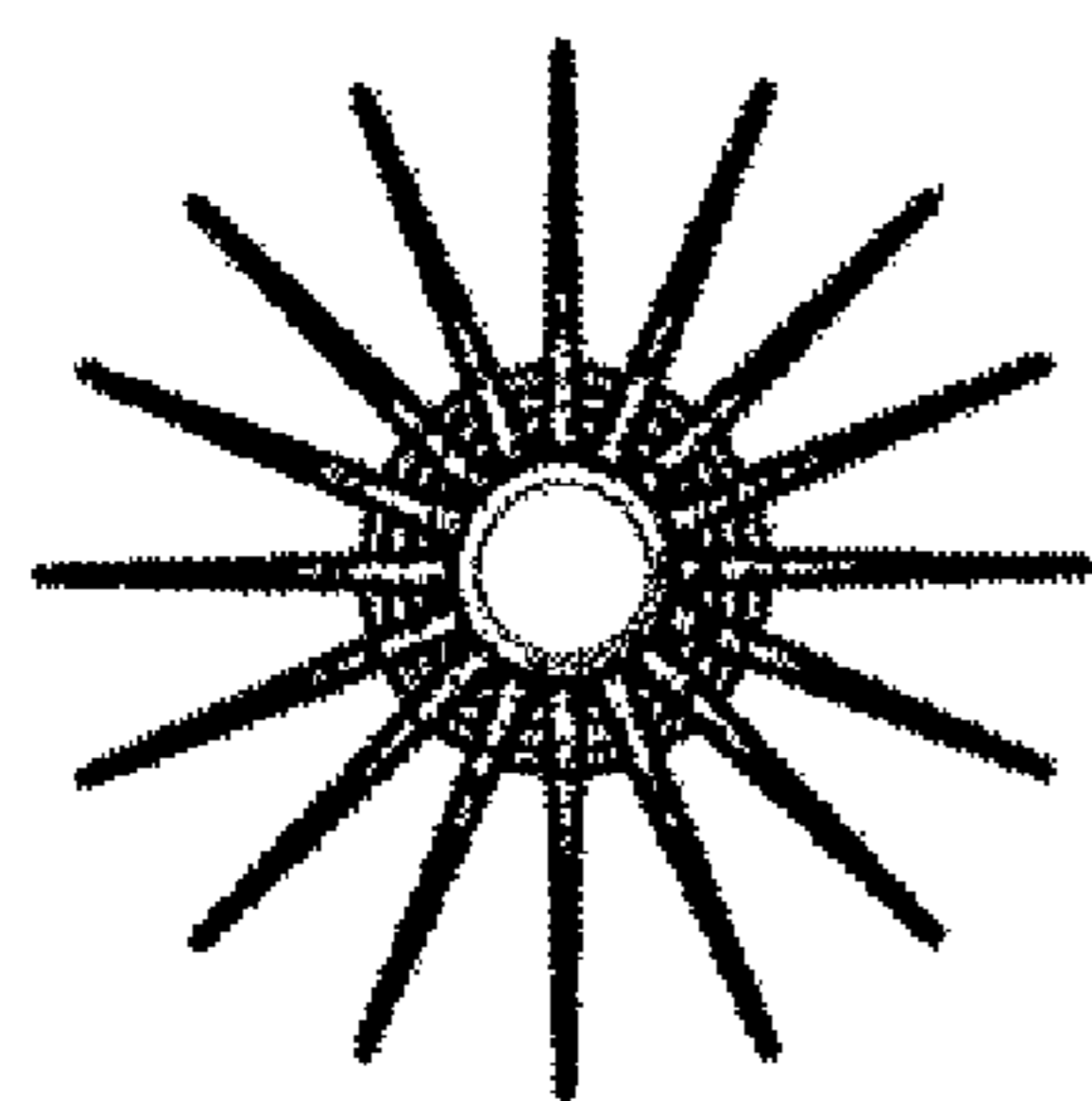




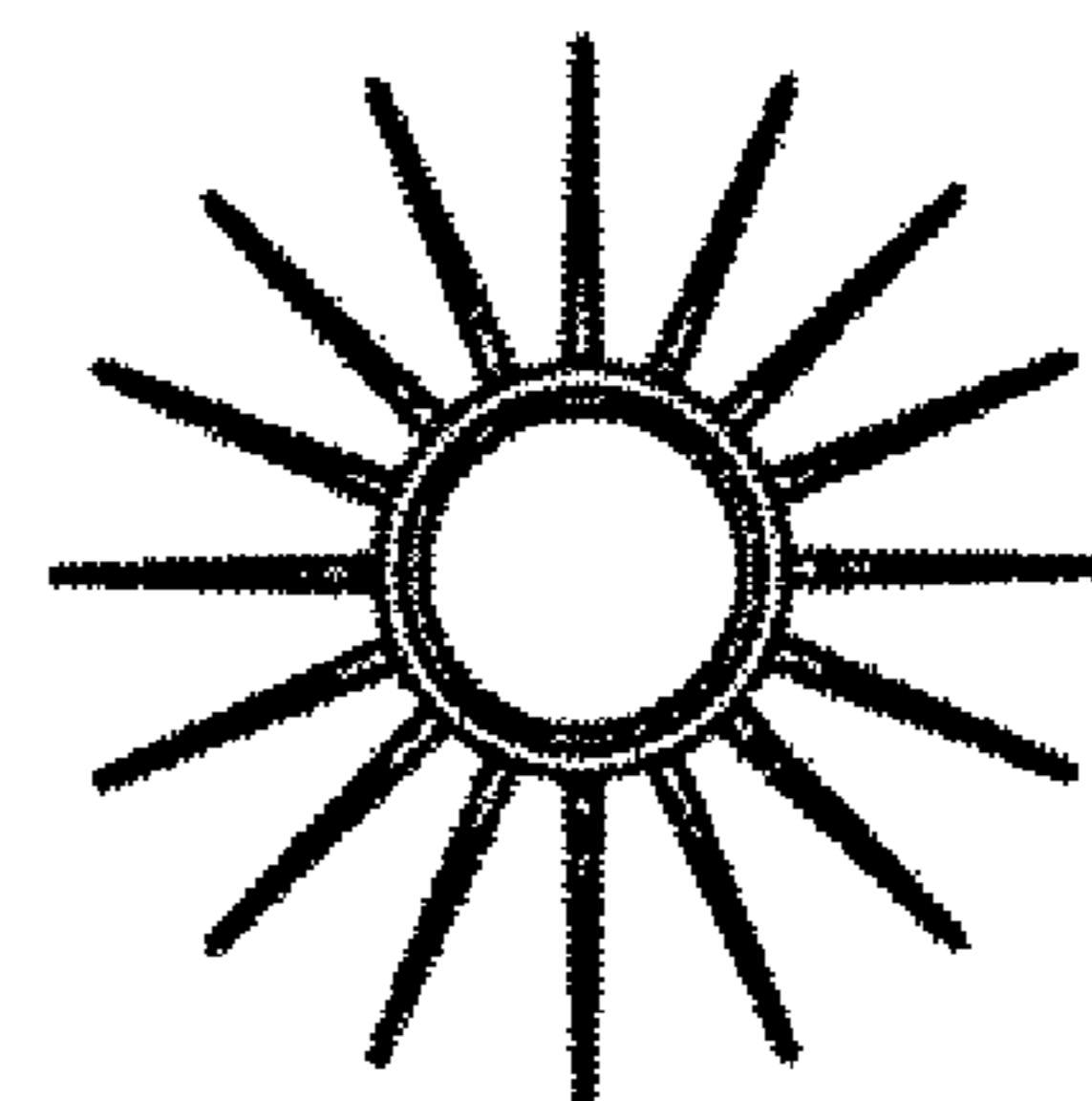

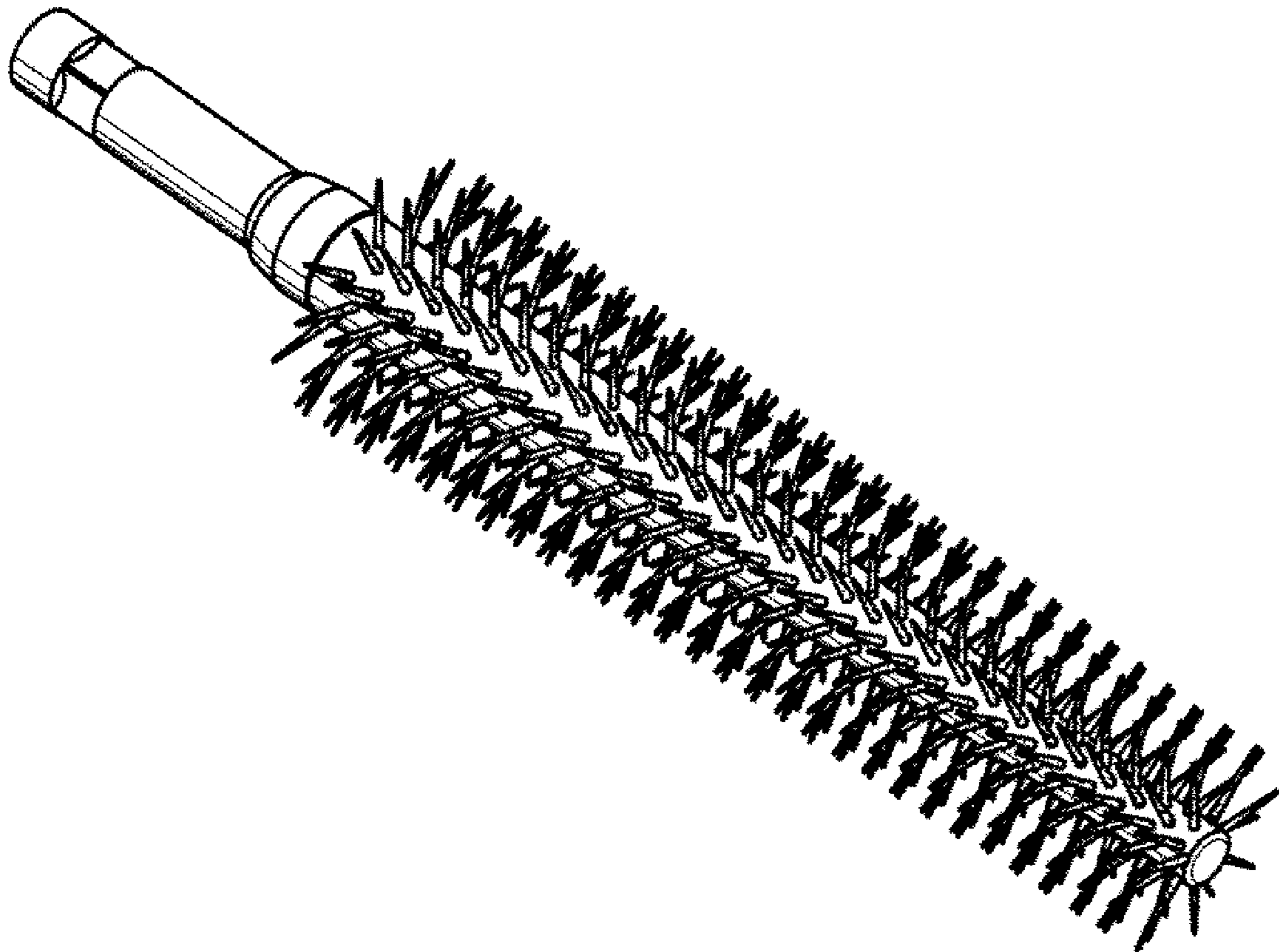

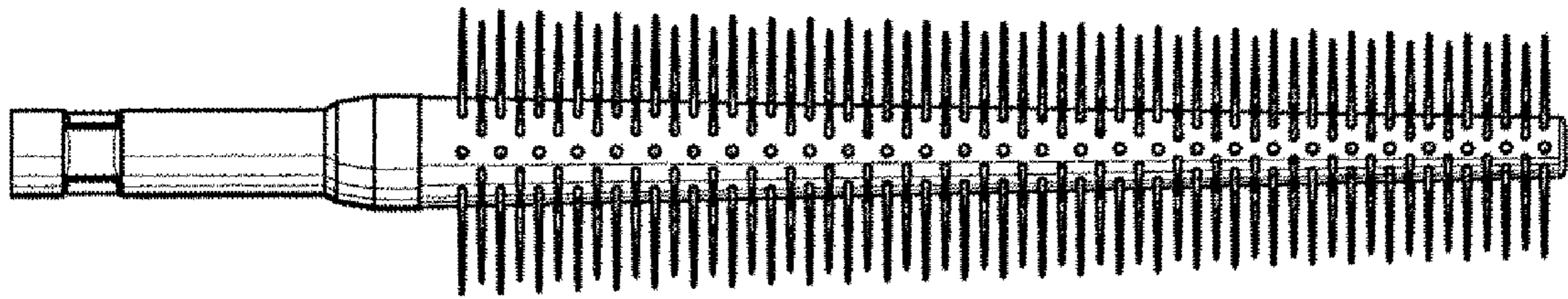

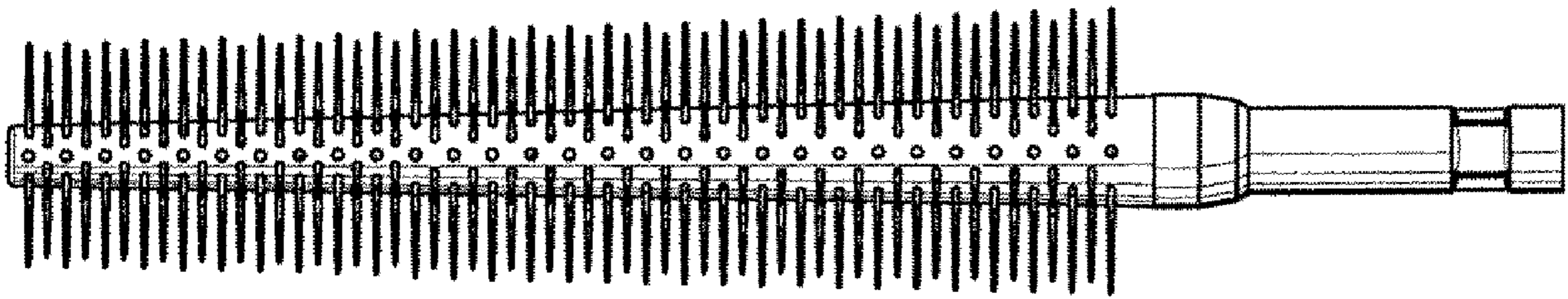

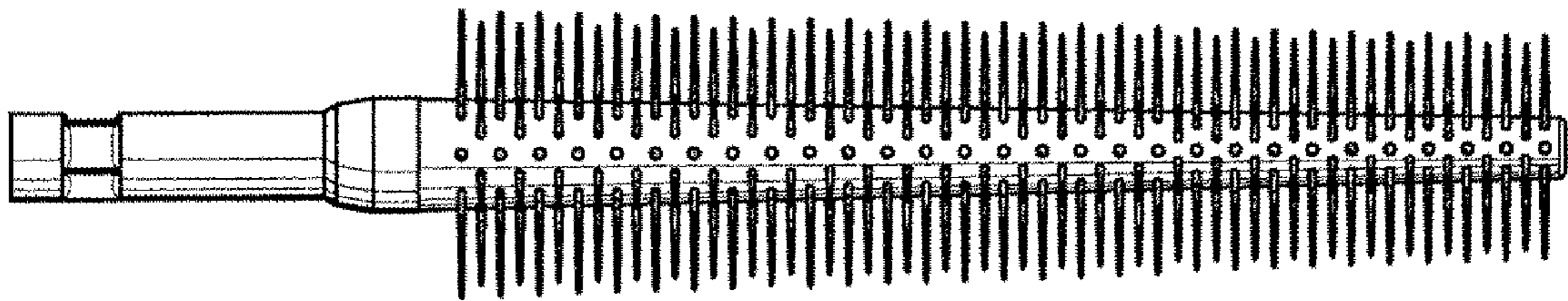

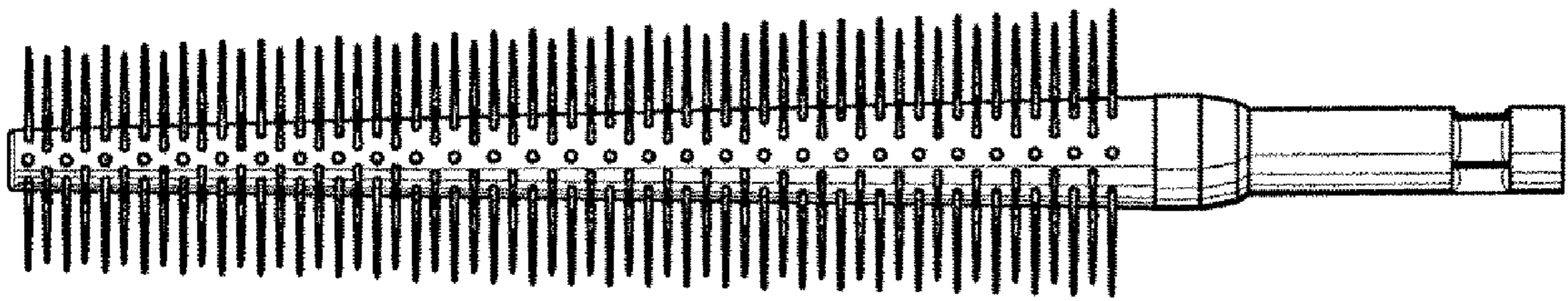

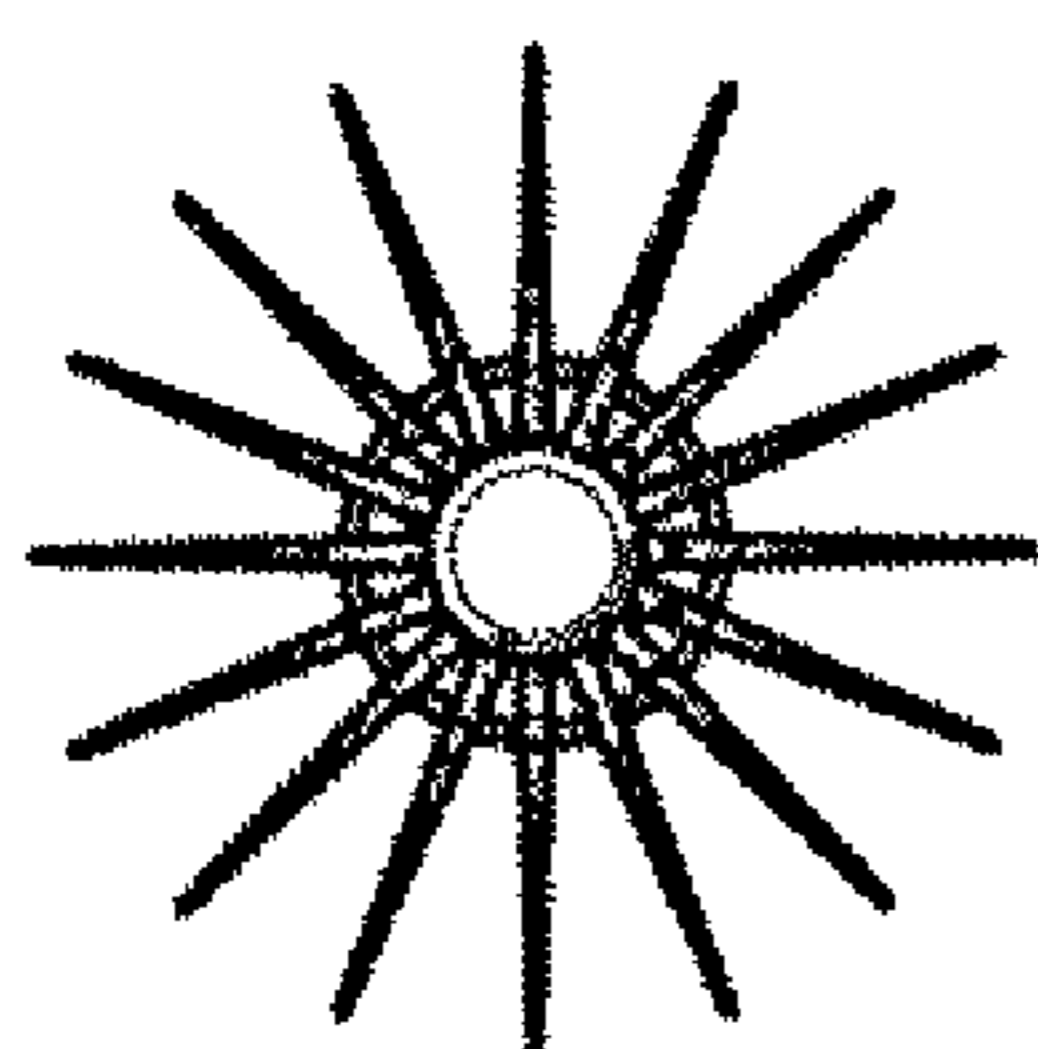

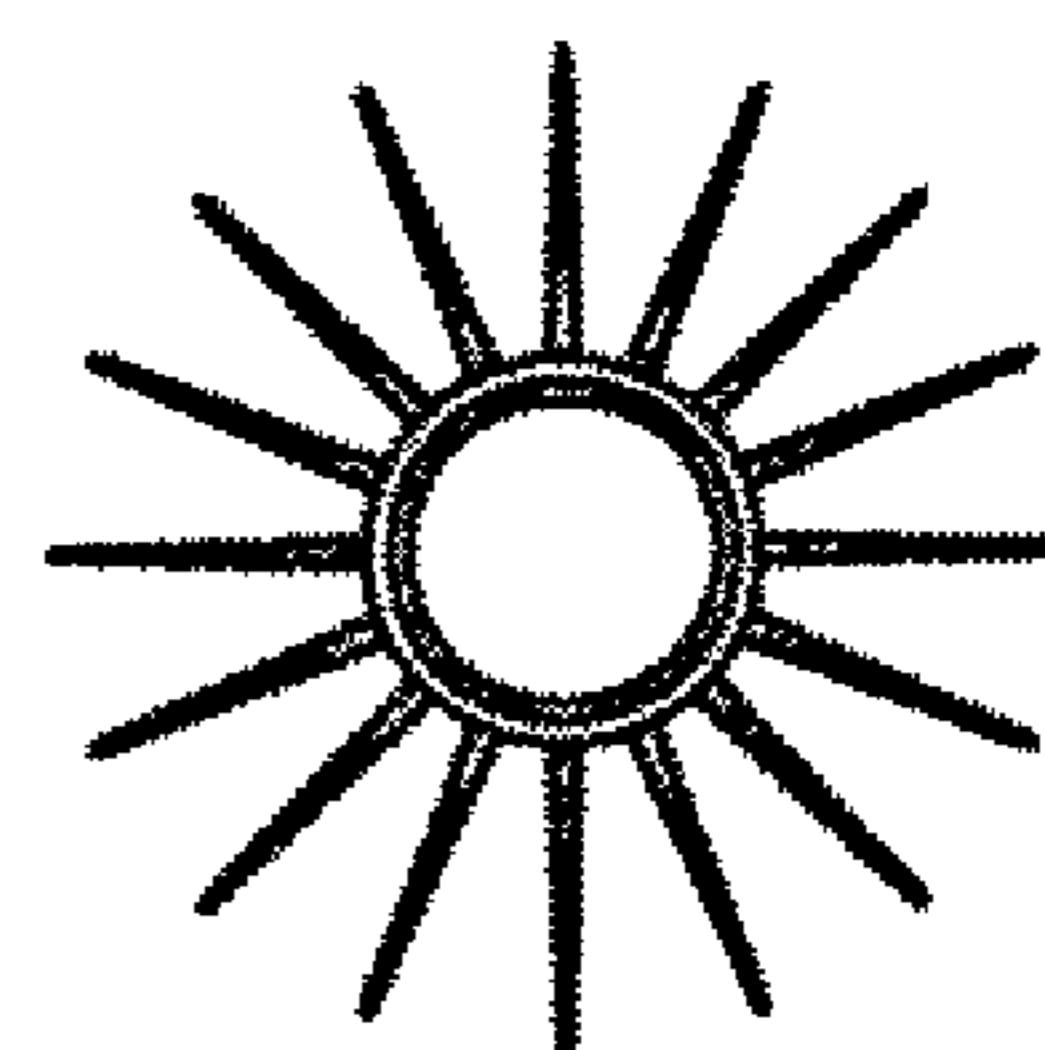
