(57) **CLAIM**

The ornamental design for a multi function cooking sheet, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a multi function cooking sheet showing my new design, the opposite side being a mirror image thereof;

FIG. 2 is a bottom view thereof;

FIG. 3 is a front elevational view thereof, the rear elevation being a mirror image;

FIG. 4 is an enlarged scale fragmentary front elevational view thereof;

FIG. 5 is a left side elevational view thereof;

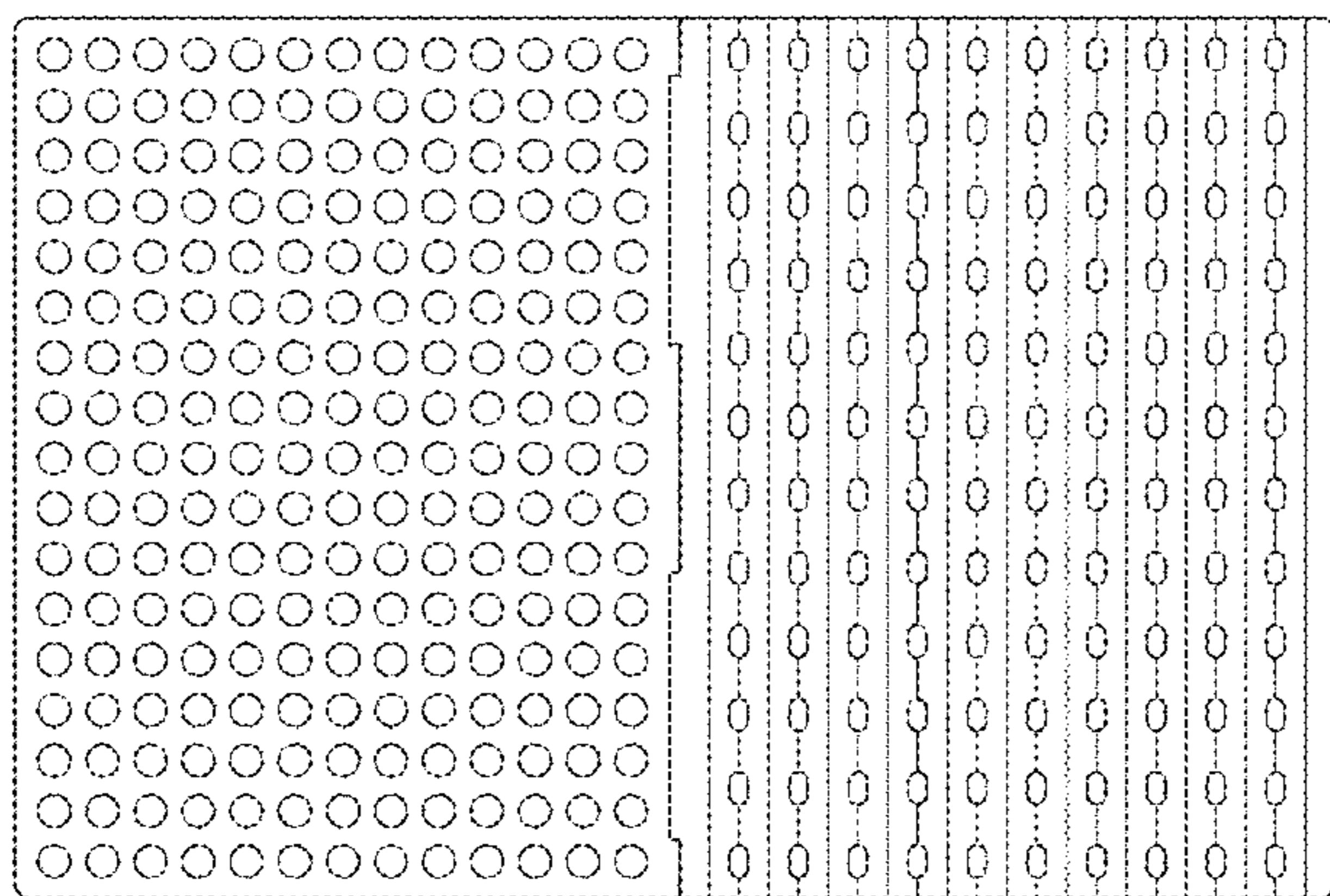
FIG. 6 is a right side elevational view thereof;

FIG. 7 is a front elevational view thereof with panels folded over one another;

FIG. 8 is a left elevational view thereof with the panels in their FIG. 7 position; and,

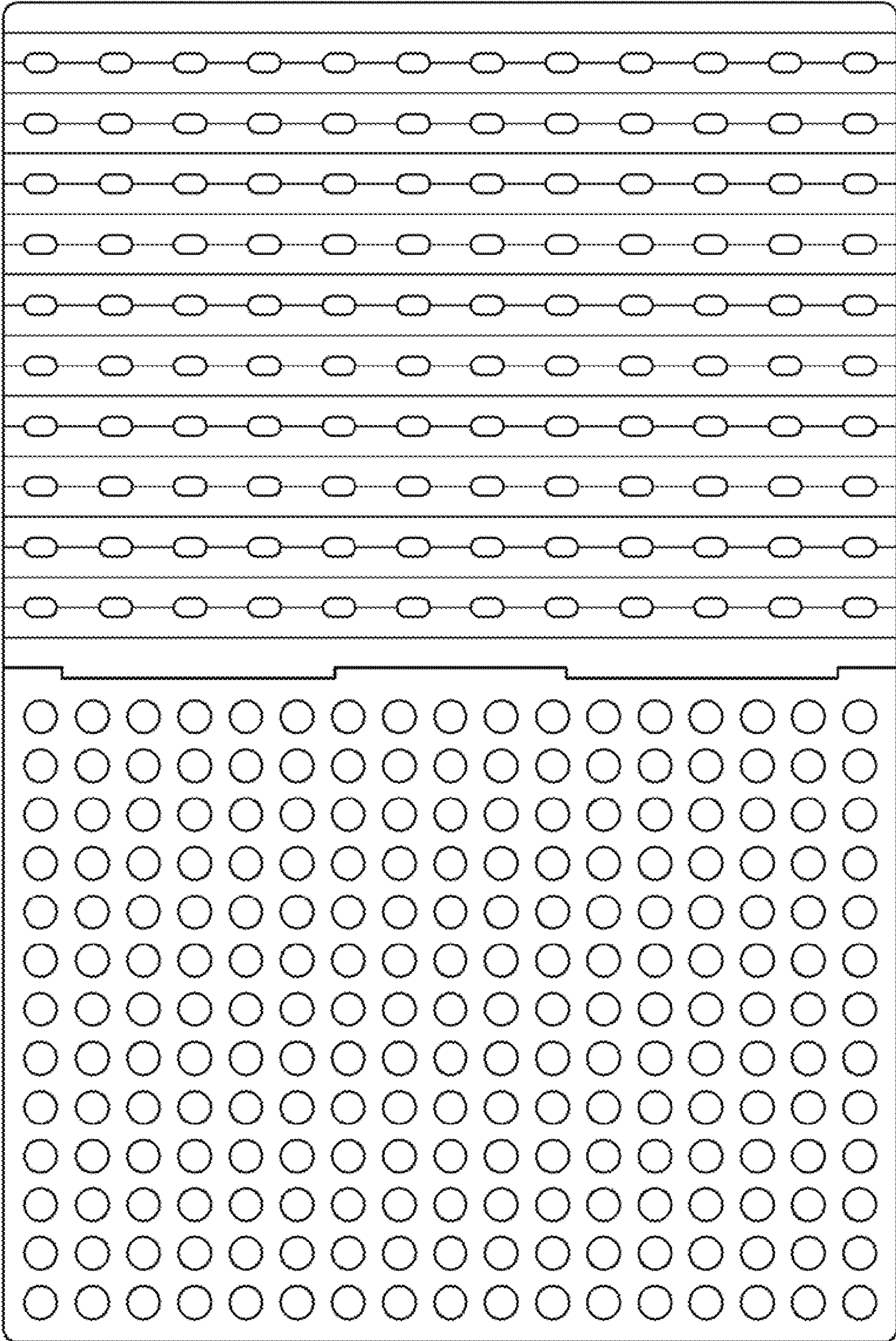

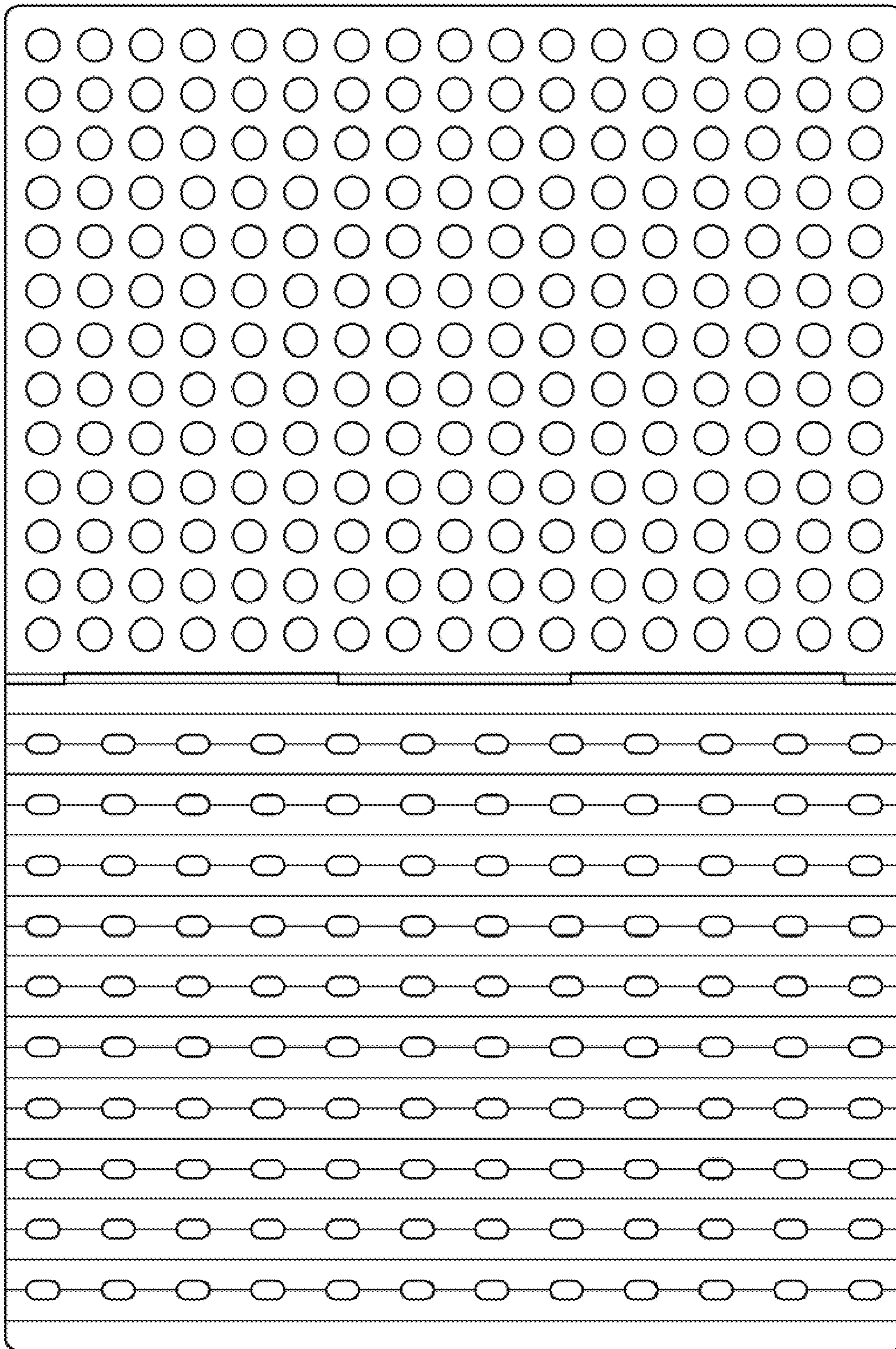

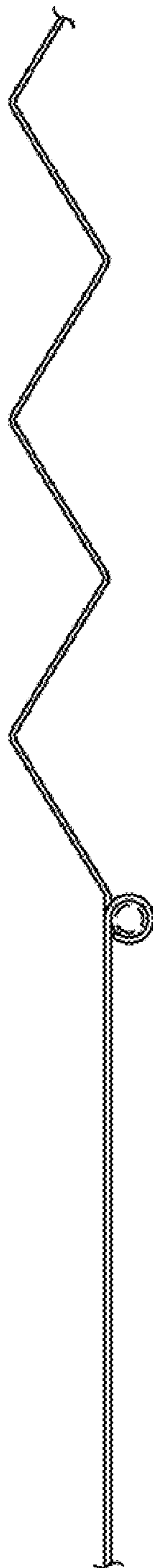

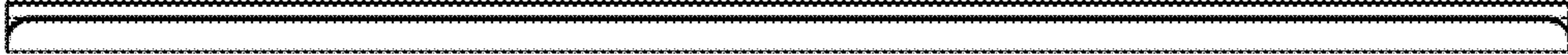
