I claim the ornamental design of a golf ball tumbler, as shown and described.

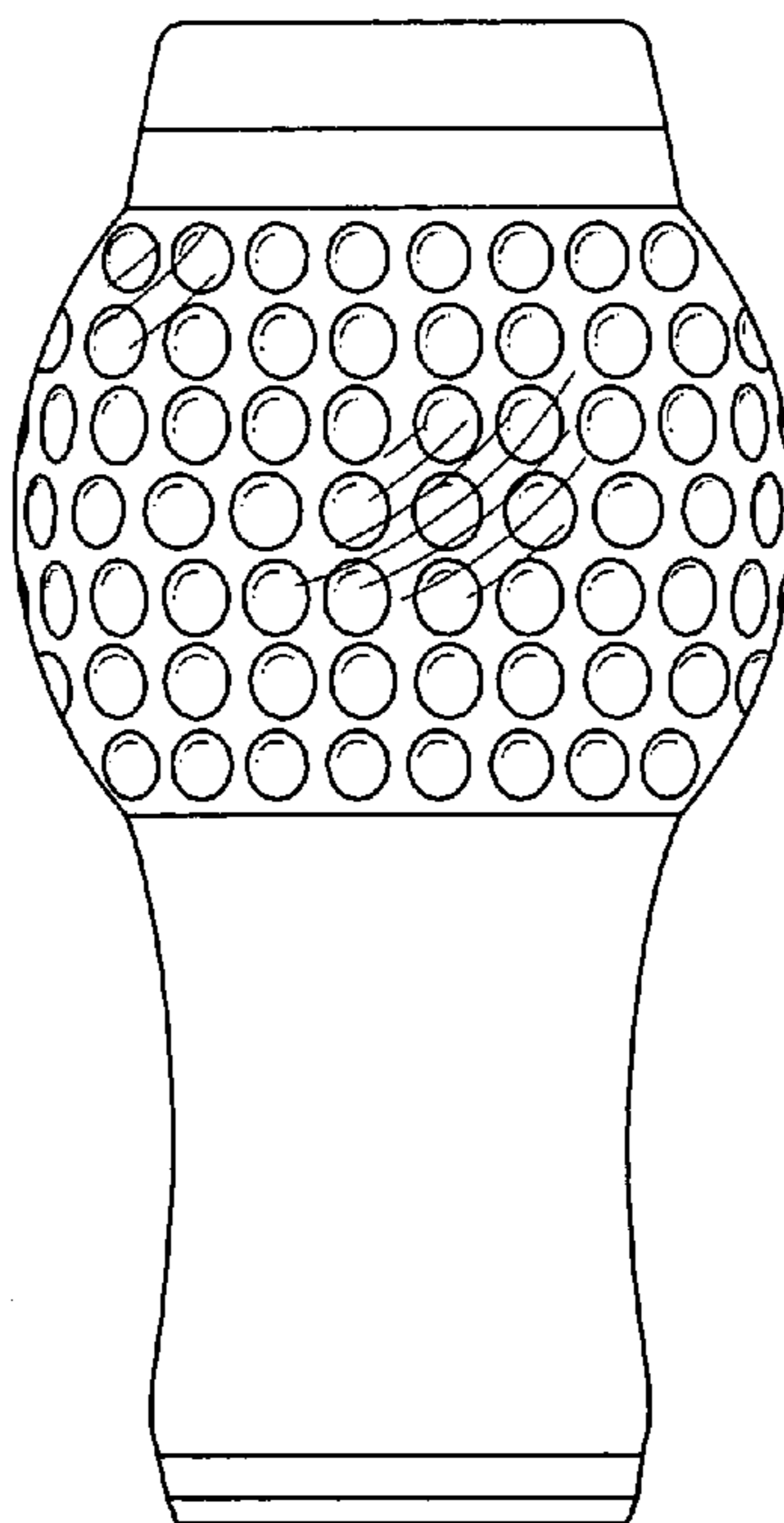
**DESCRIPTION**

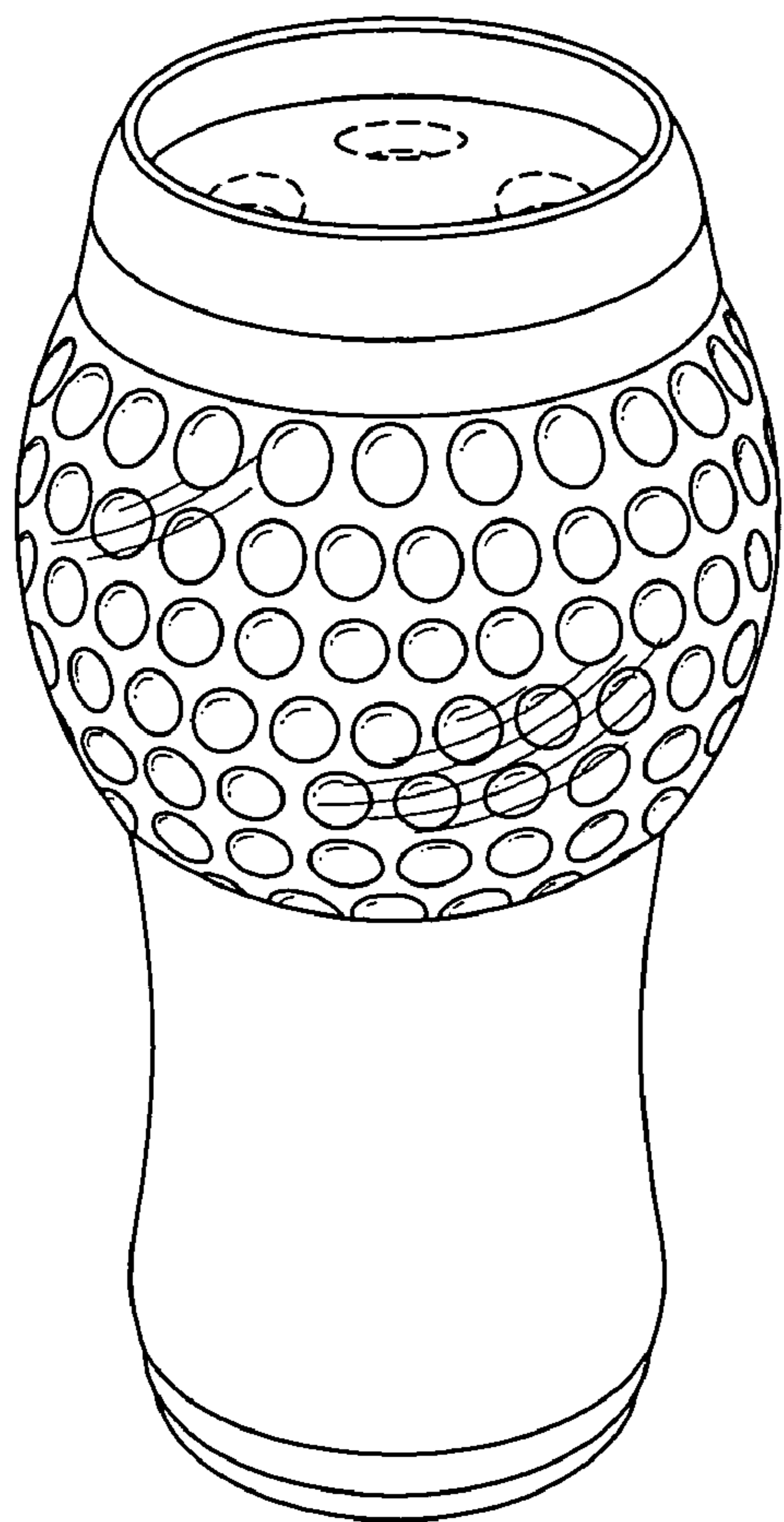

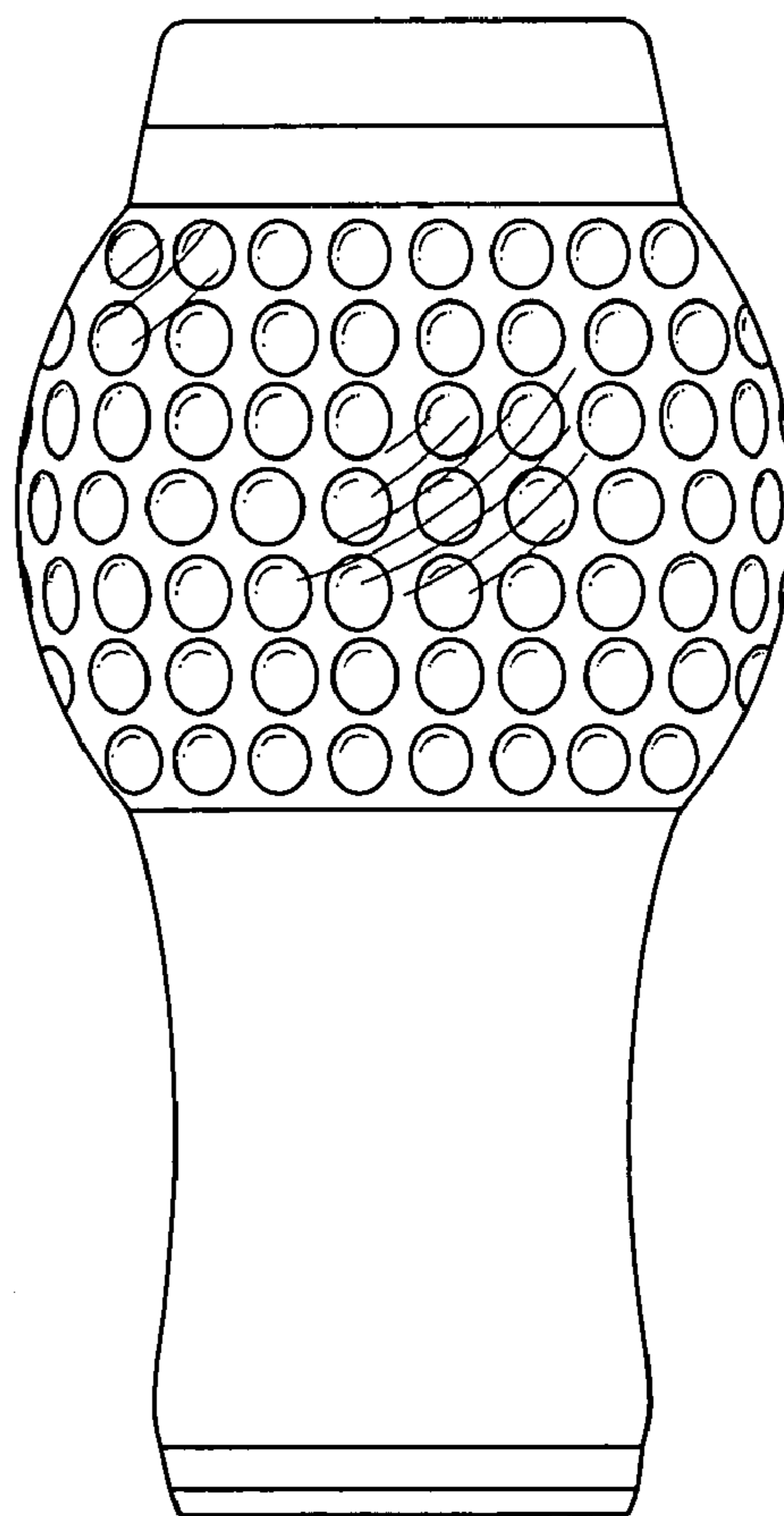
