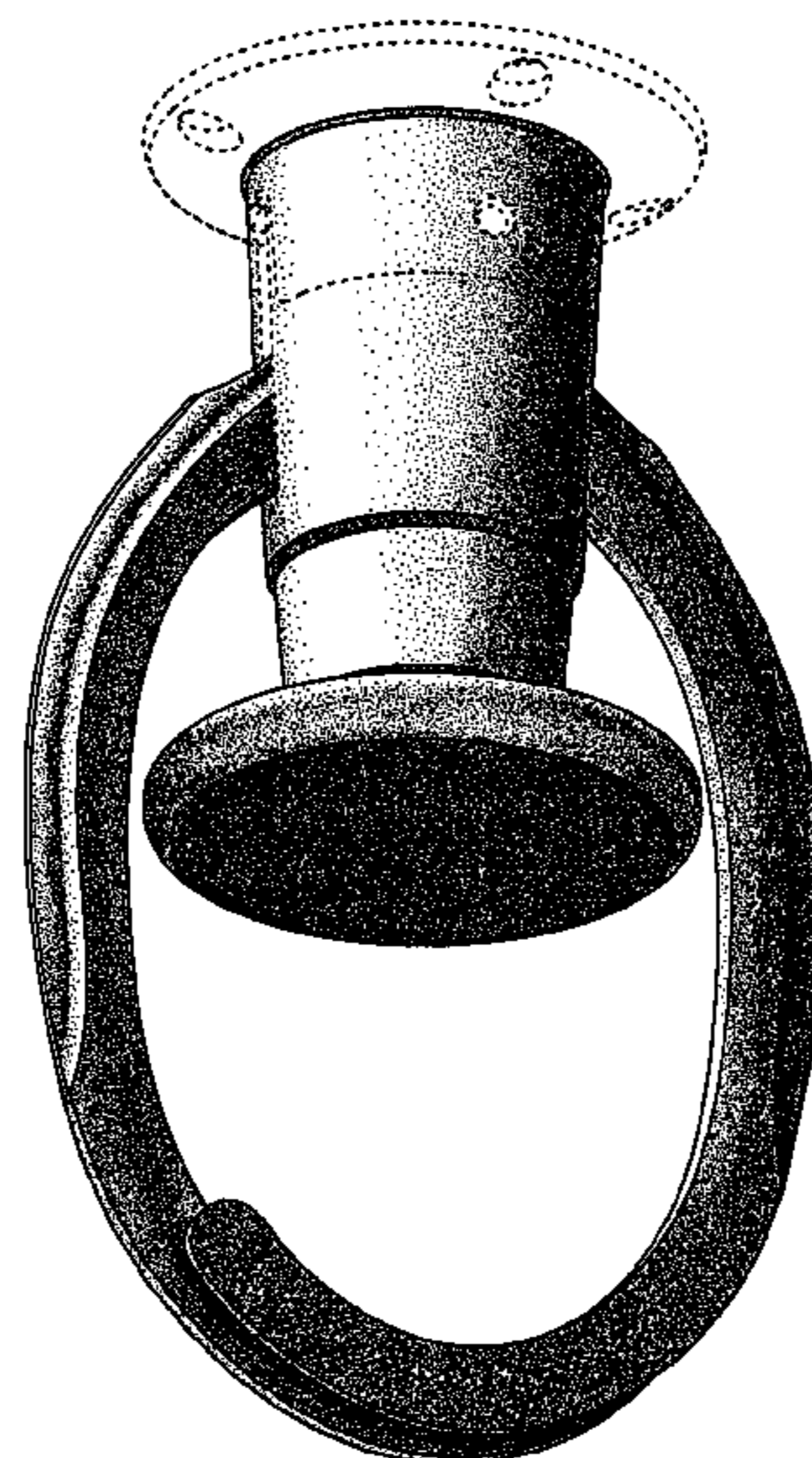
FIG. 2 is a lower-front perspective view of the ornamental design for an entire configuration for an actuatable holding system according to the invention, with the arms shown in an opened position.

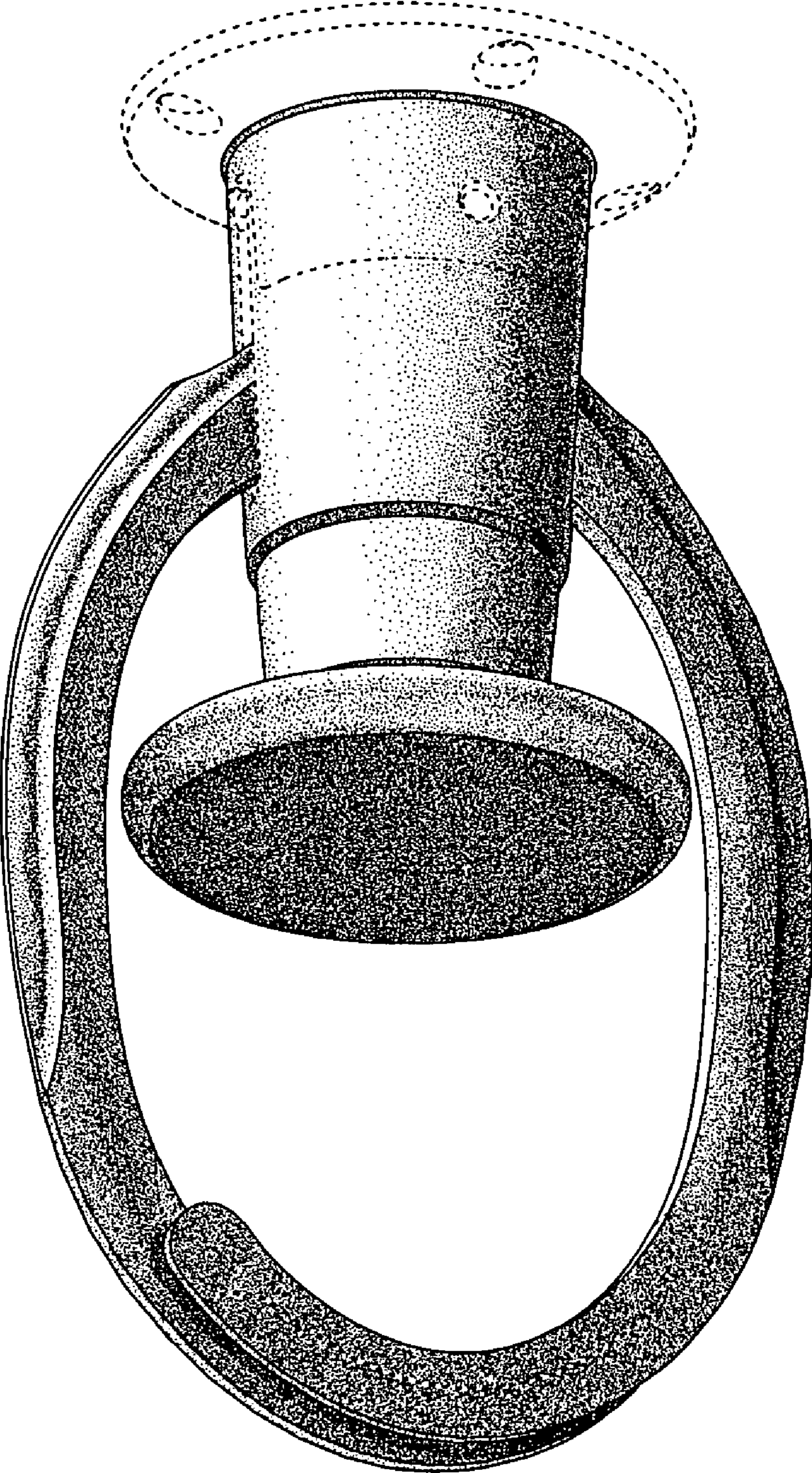

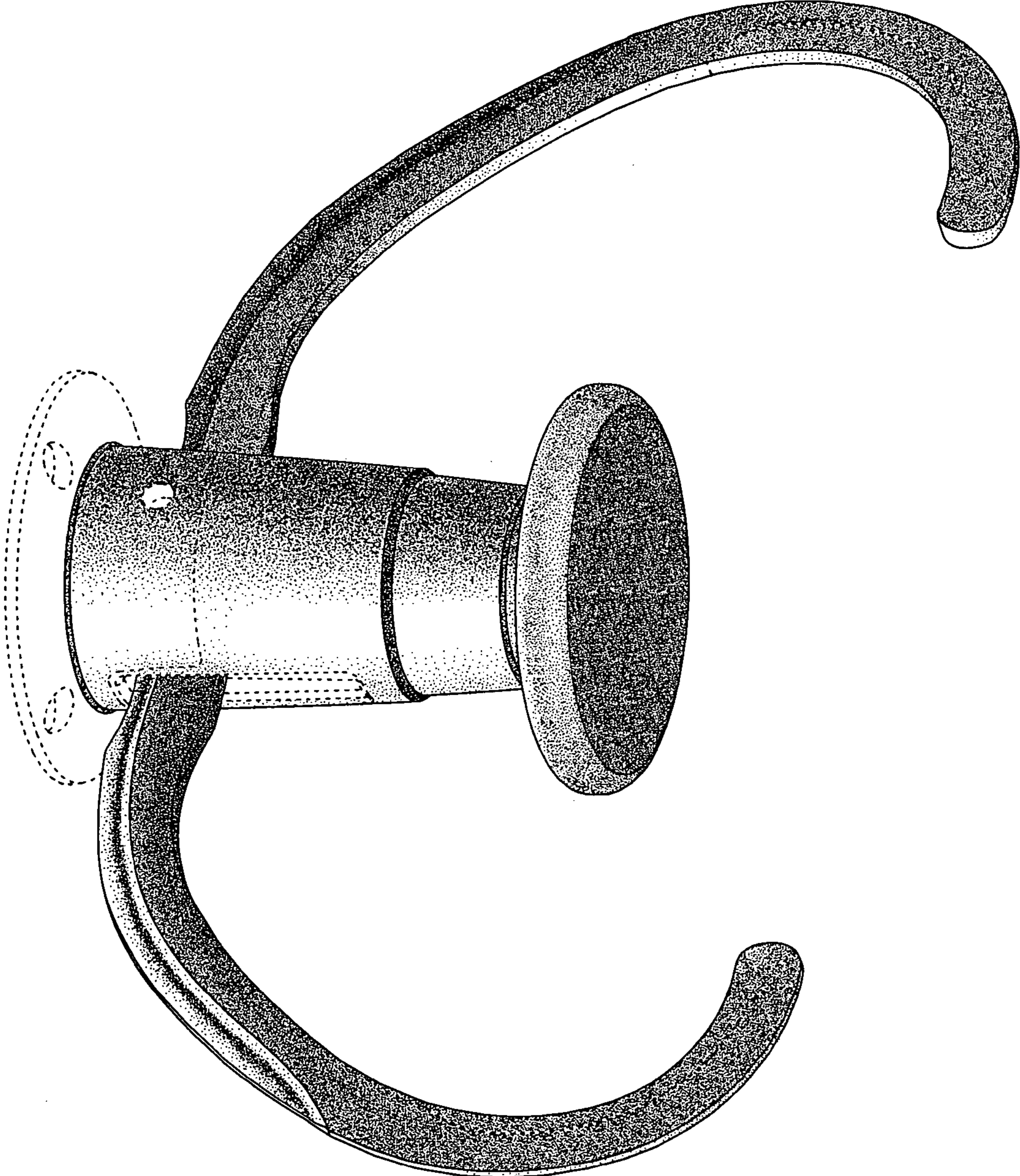

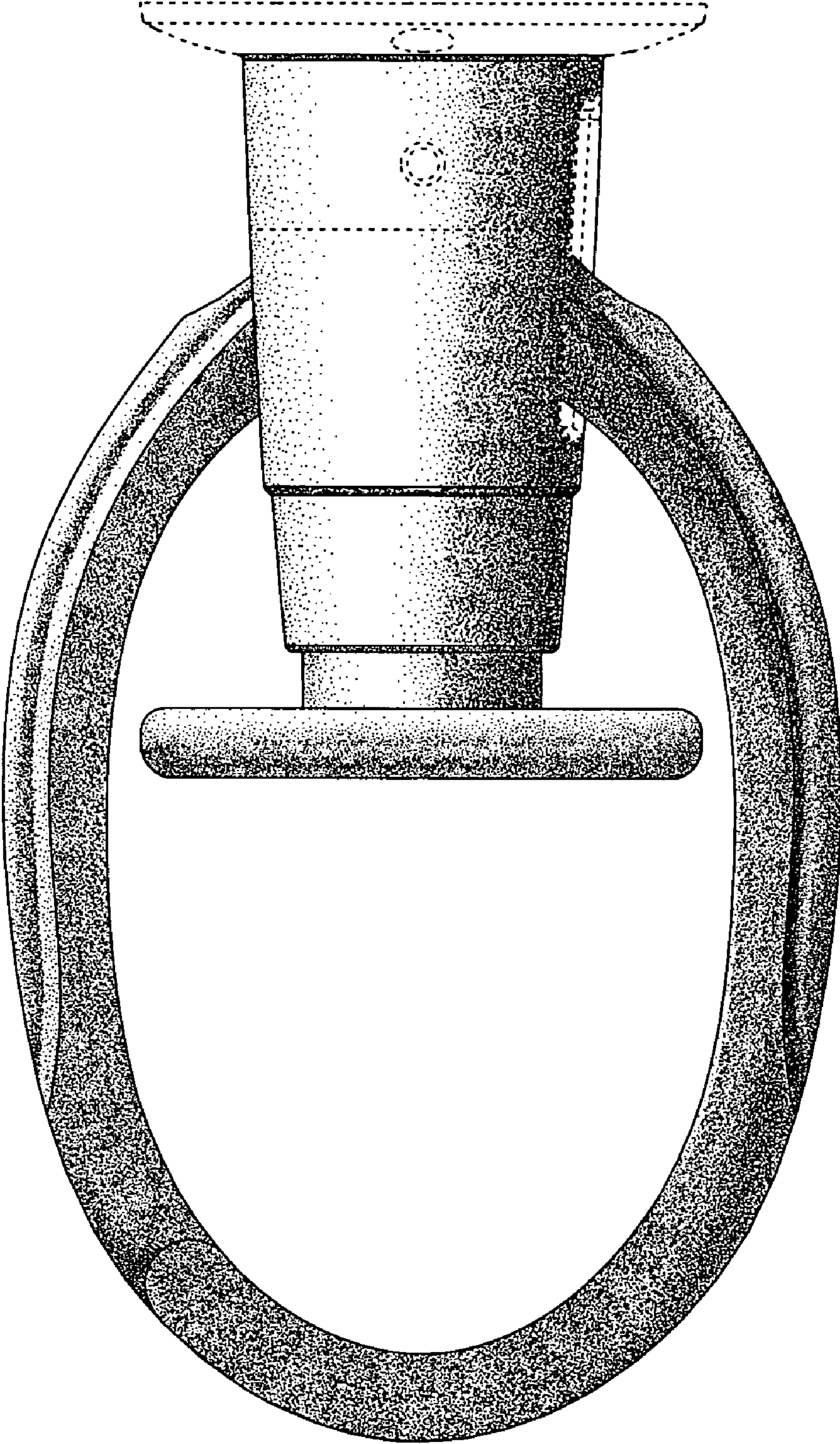

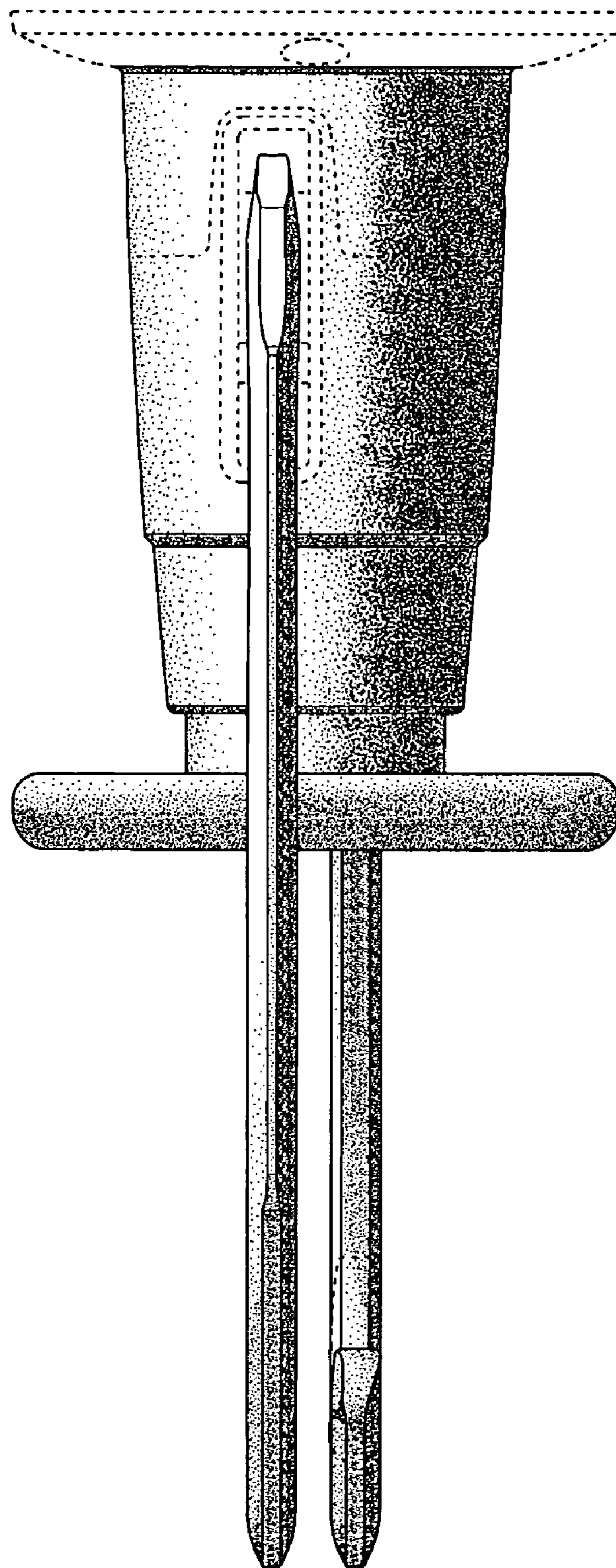
