(57) **CLAIM**

The ornamental design for a floral delivery box with remov-
able upper portion, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the floral delivery box with removable
upper portion.

FIG. 2 is a right side view of the of FIG. 1.

FIG. 3 is a left side view of the of FIG. 1.

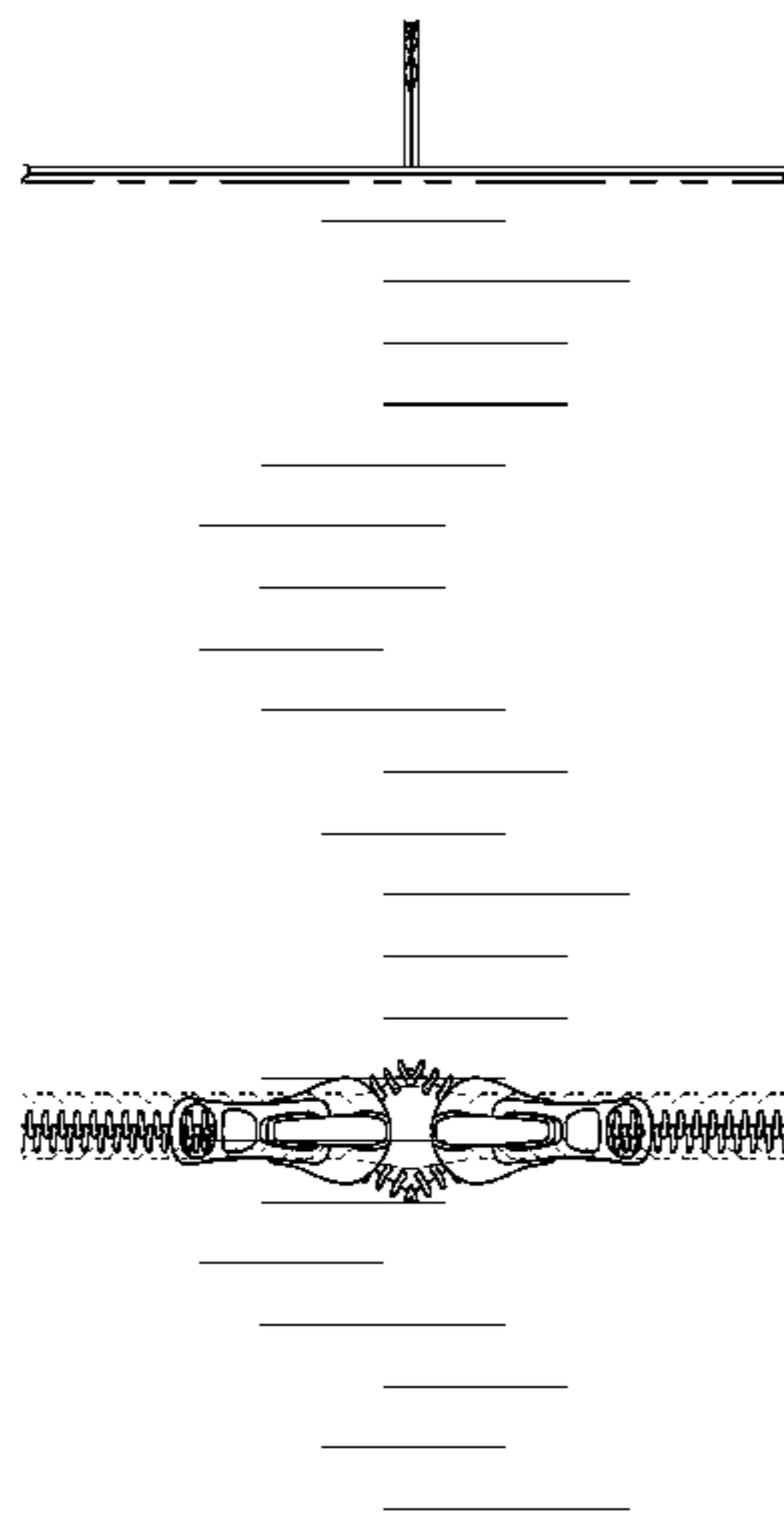
FIG. 4 is a rear view of the of FIG. 1.

FIG. 5 is a top view of the of FIG. 1; and,

FIG. 6 is a bottom view of the of FIG. 1.

The broken lines in the drawing represent a perforated tear
strip which is decorated to resemble a zipper and which may
be removed to separate the floral delivery box with removable
upper portion. The broken lines in FIG. 5 represent portions
of the floral delivery box with removable upper portion that
form no part of the claimed design.

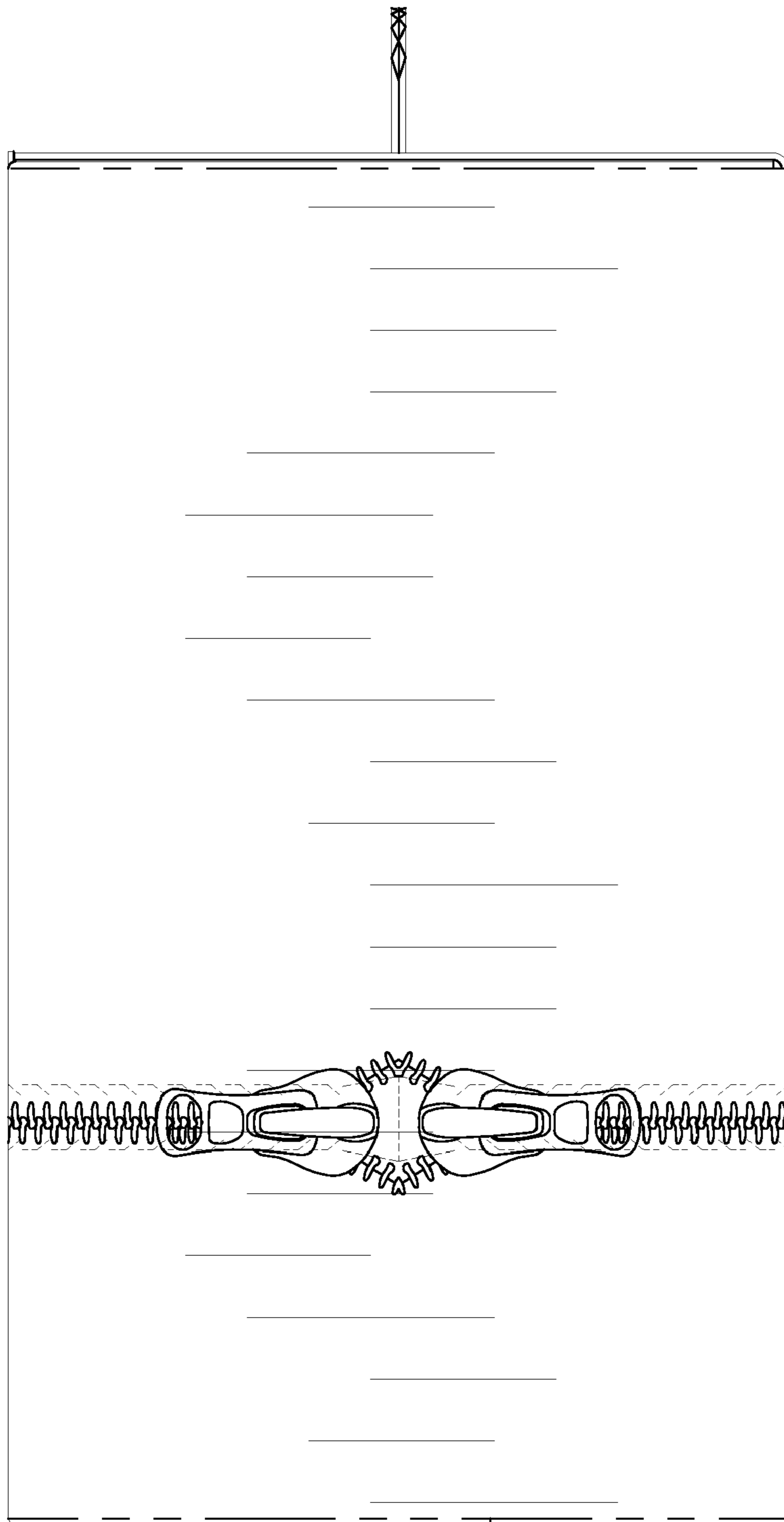

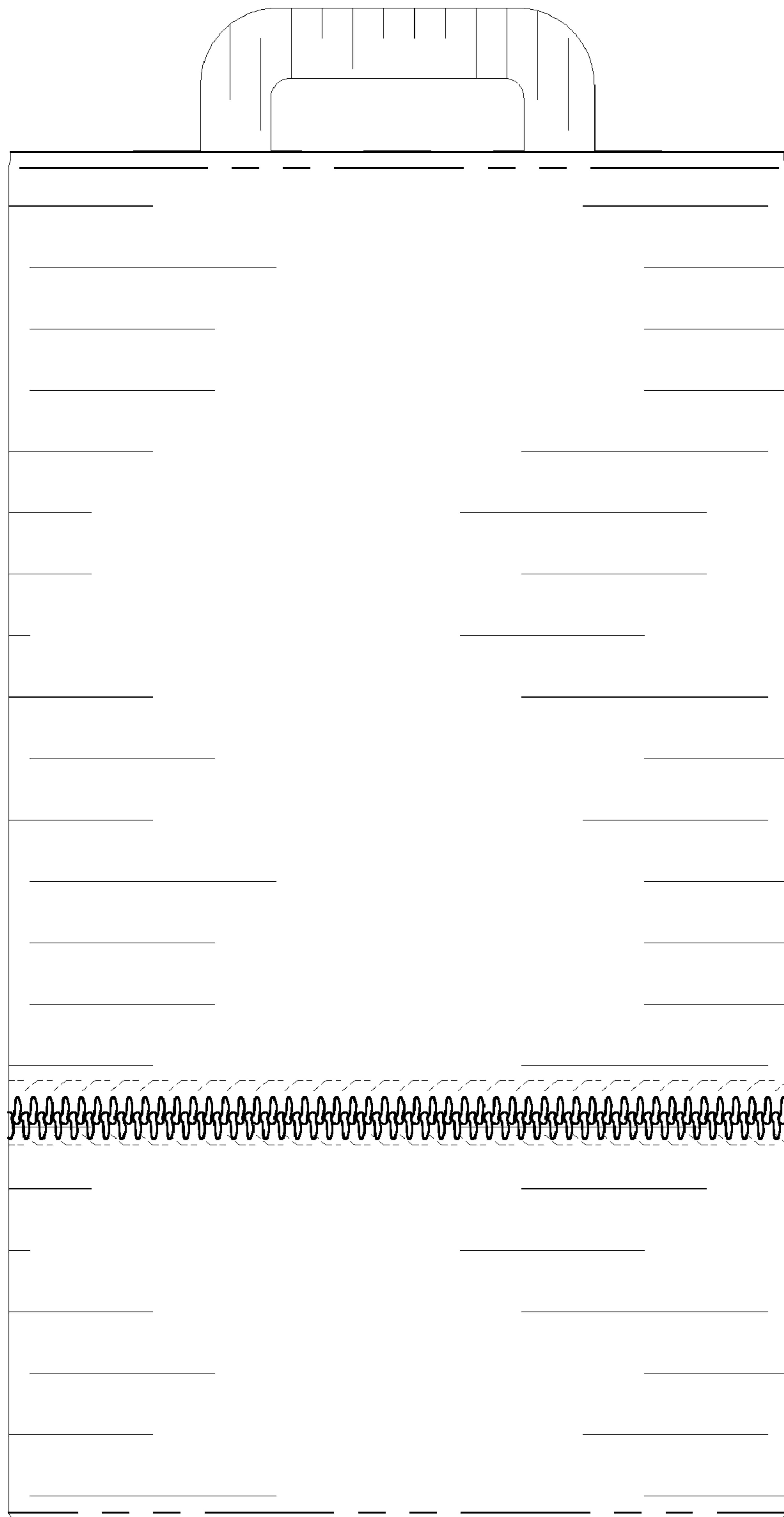

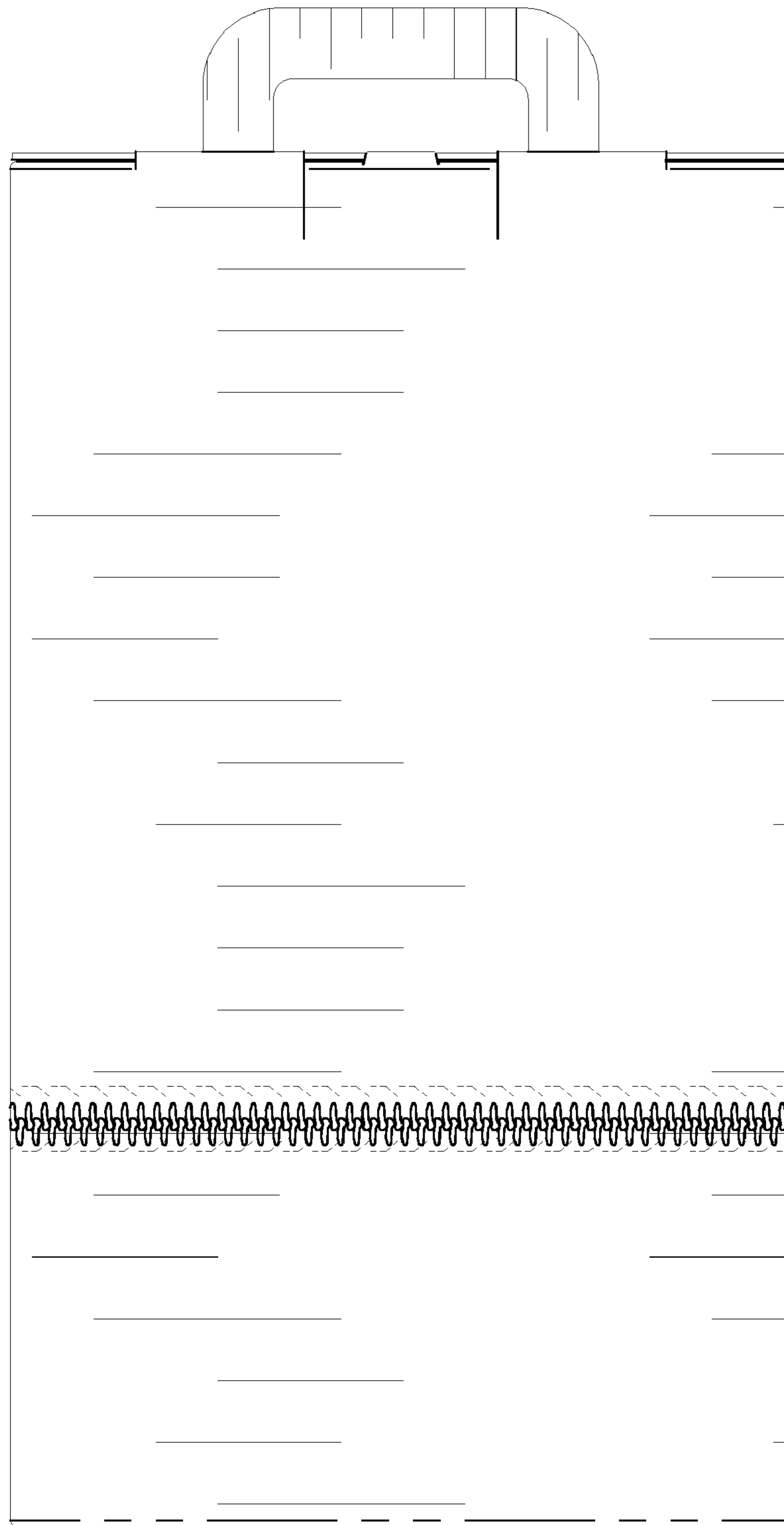

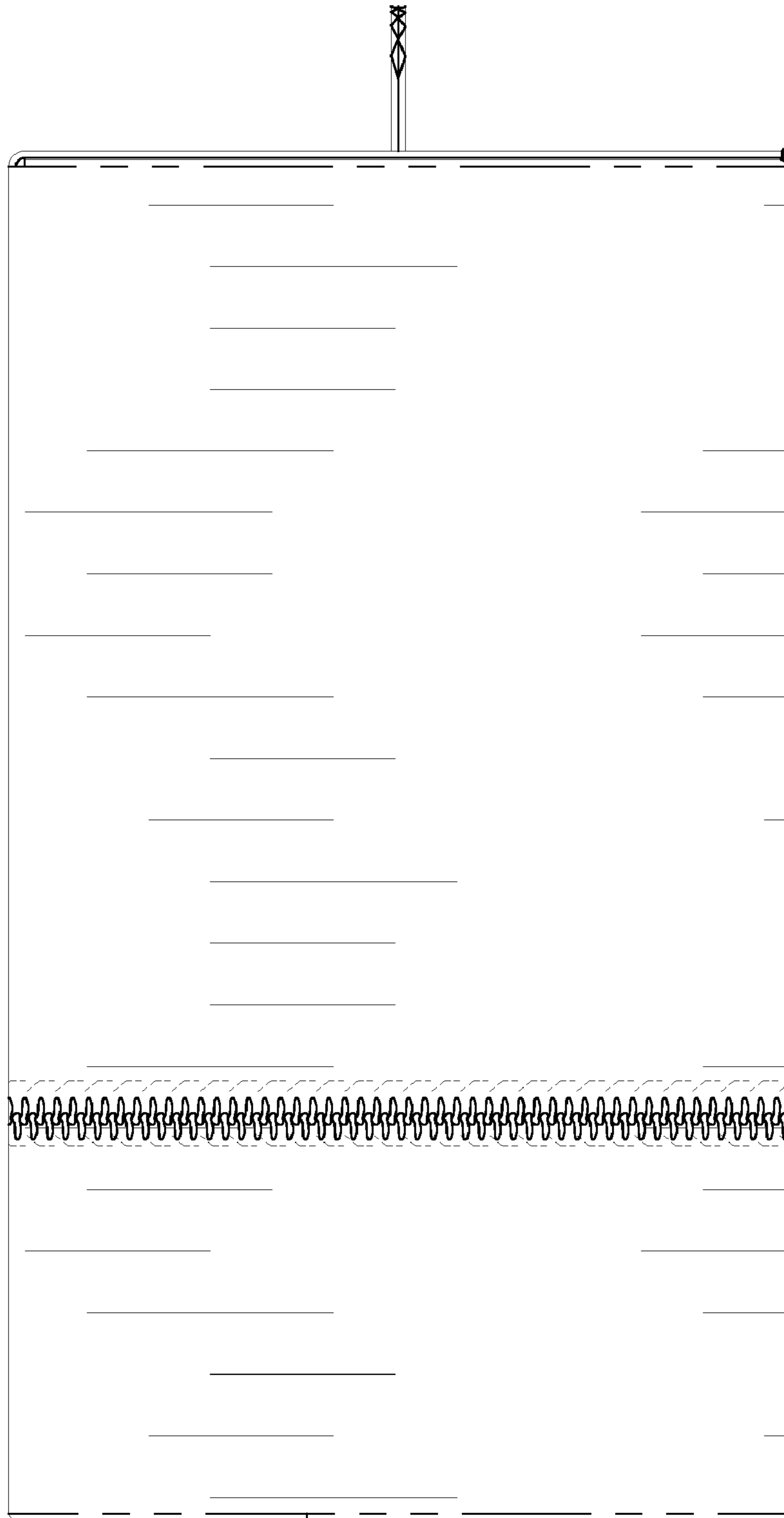

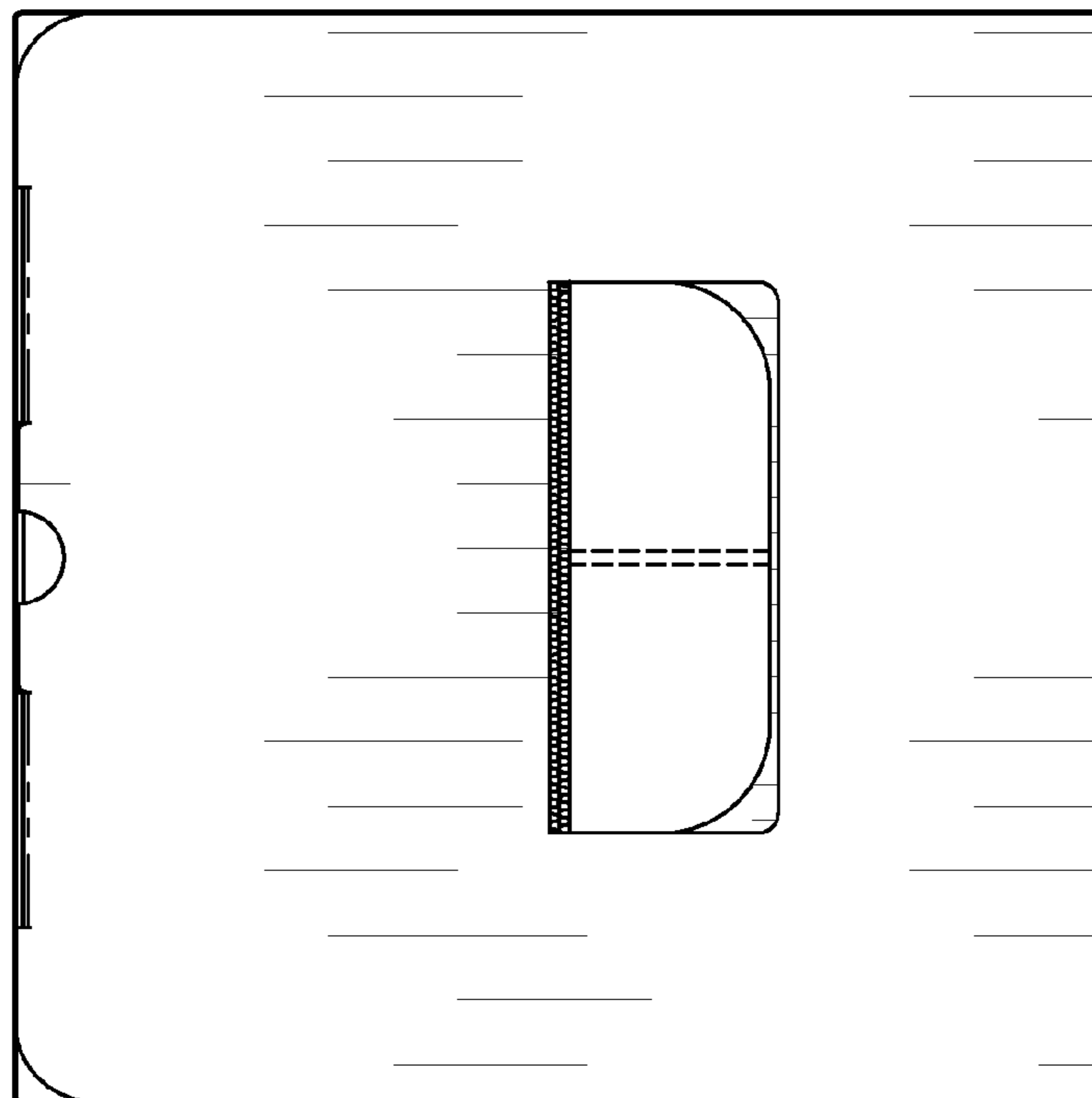

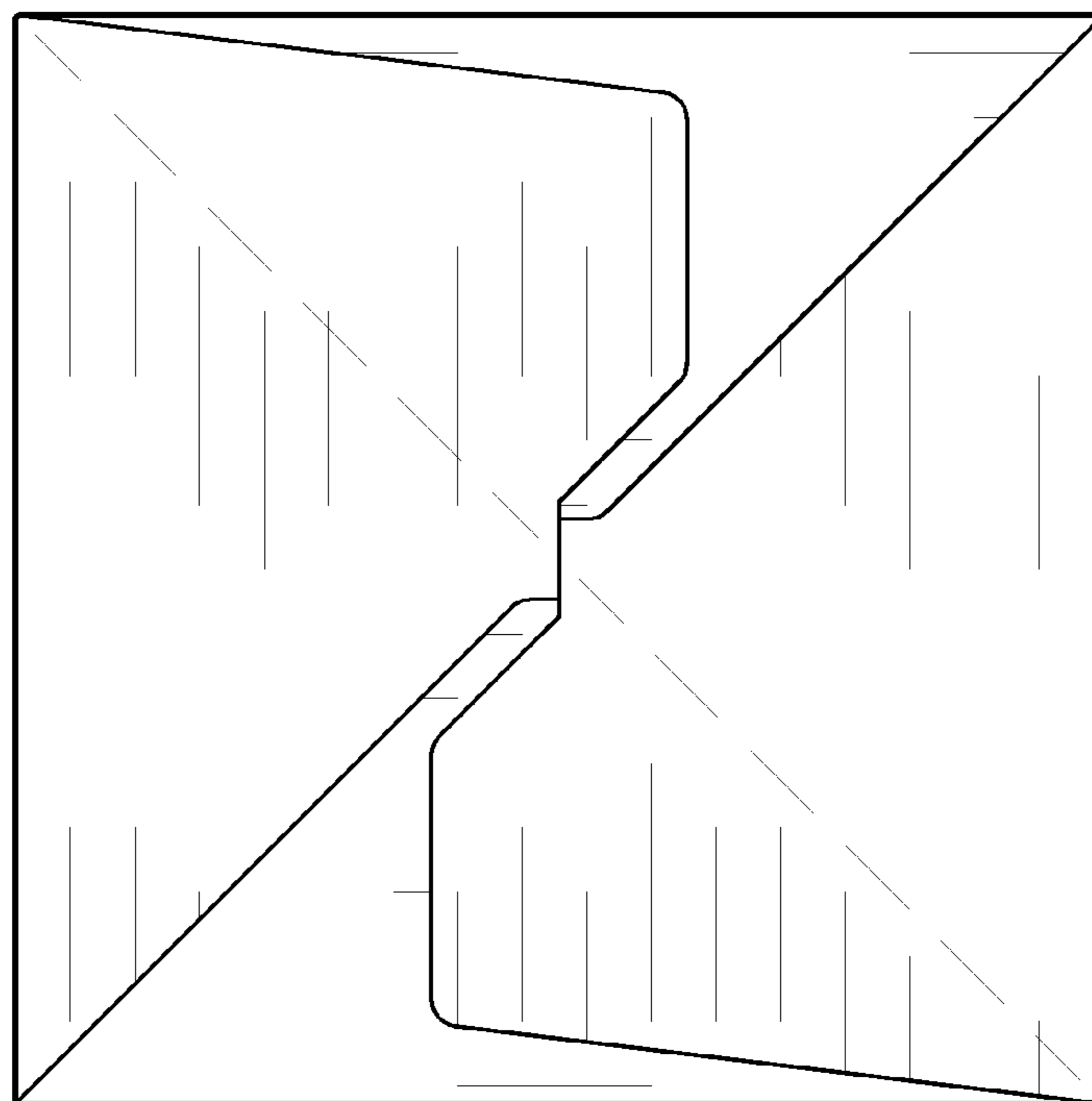
