FIG. 1 is a perspective view of a beverage can according to the present invention;

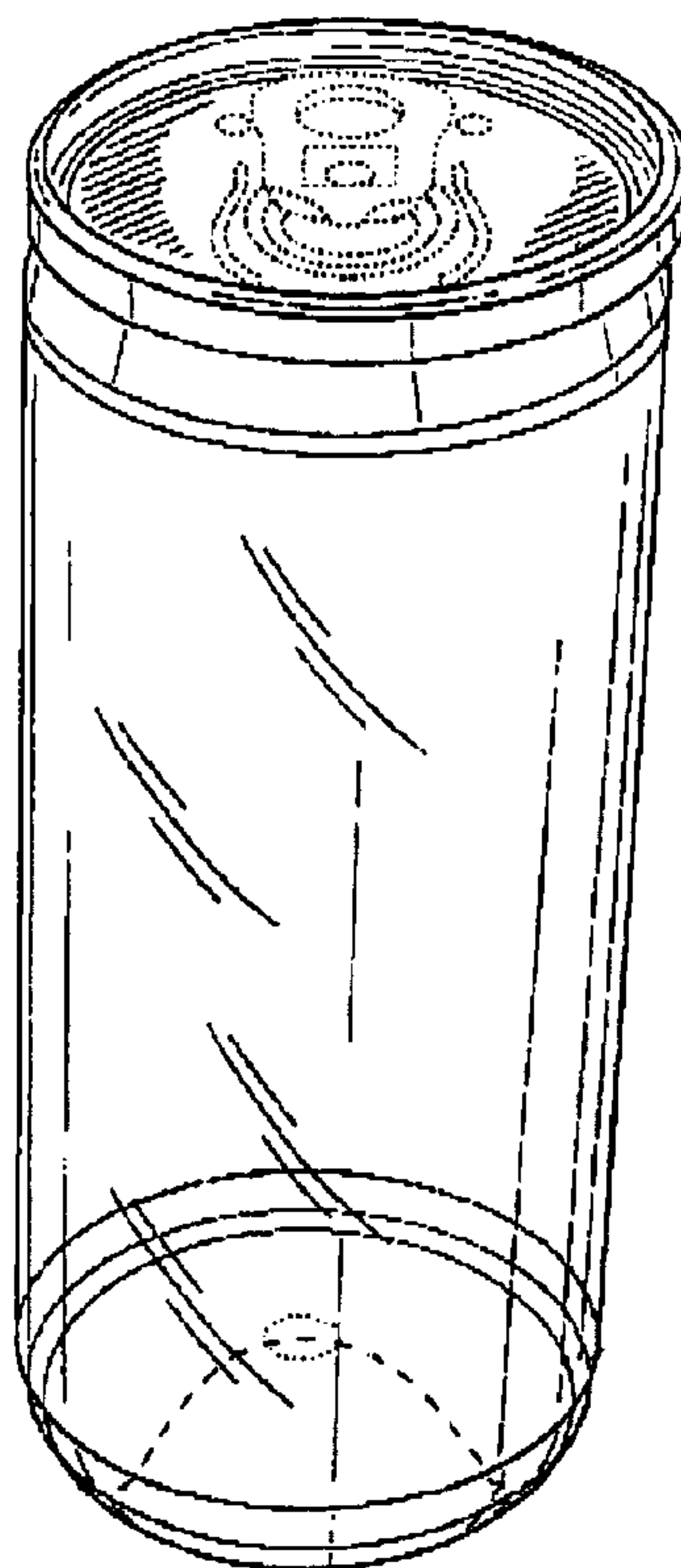
FIG. 2 is a top plan view of the beverage can as shown in FIG. 1;

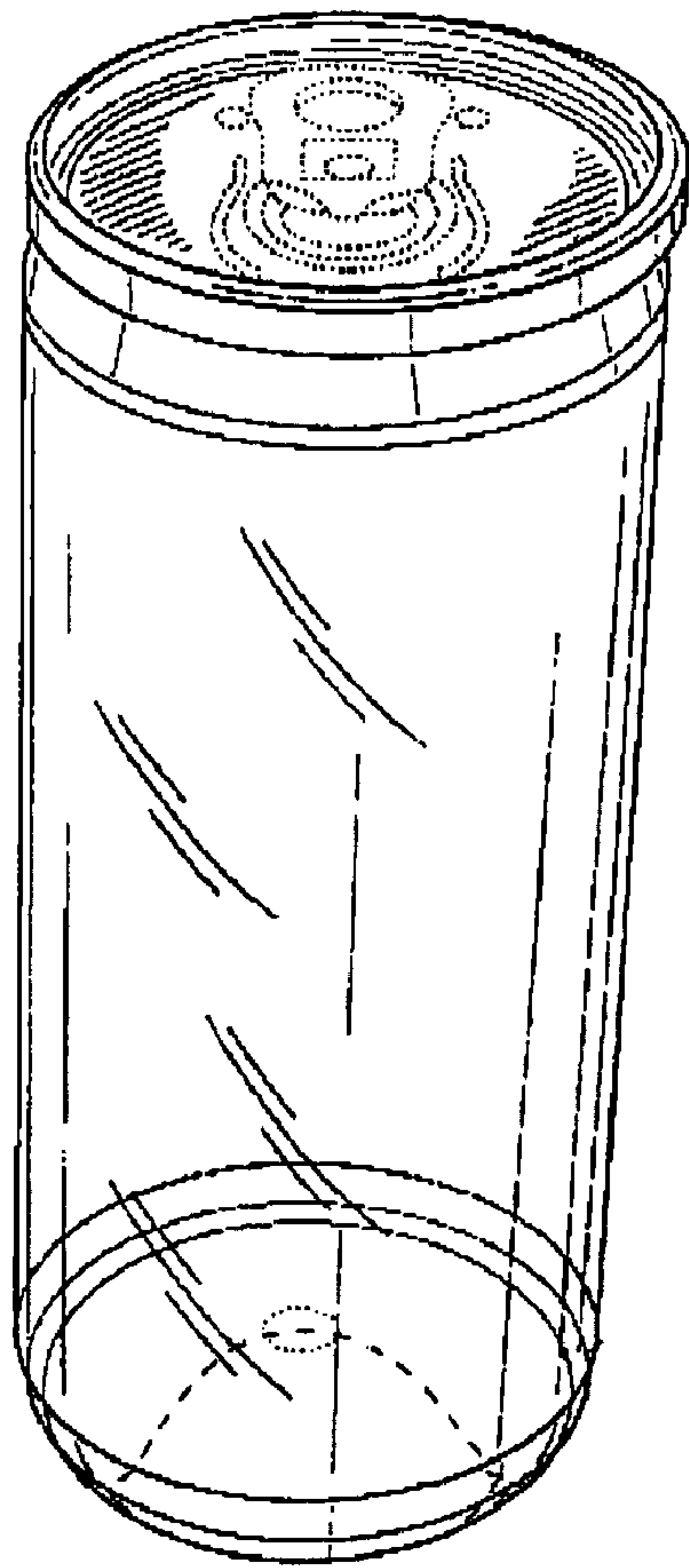

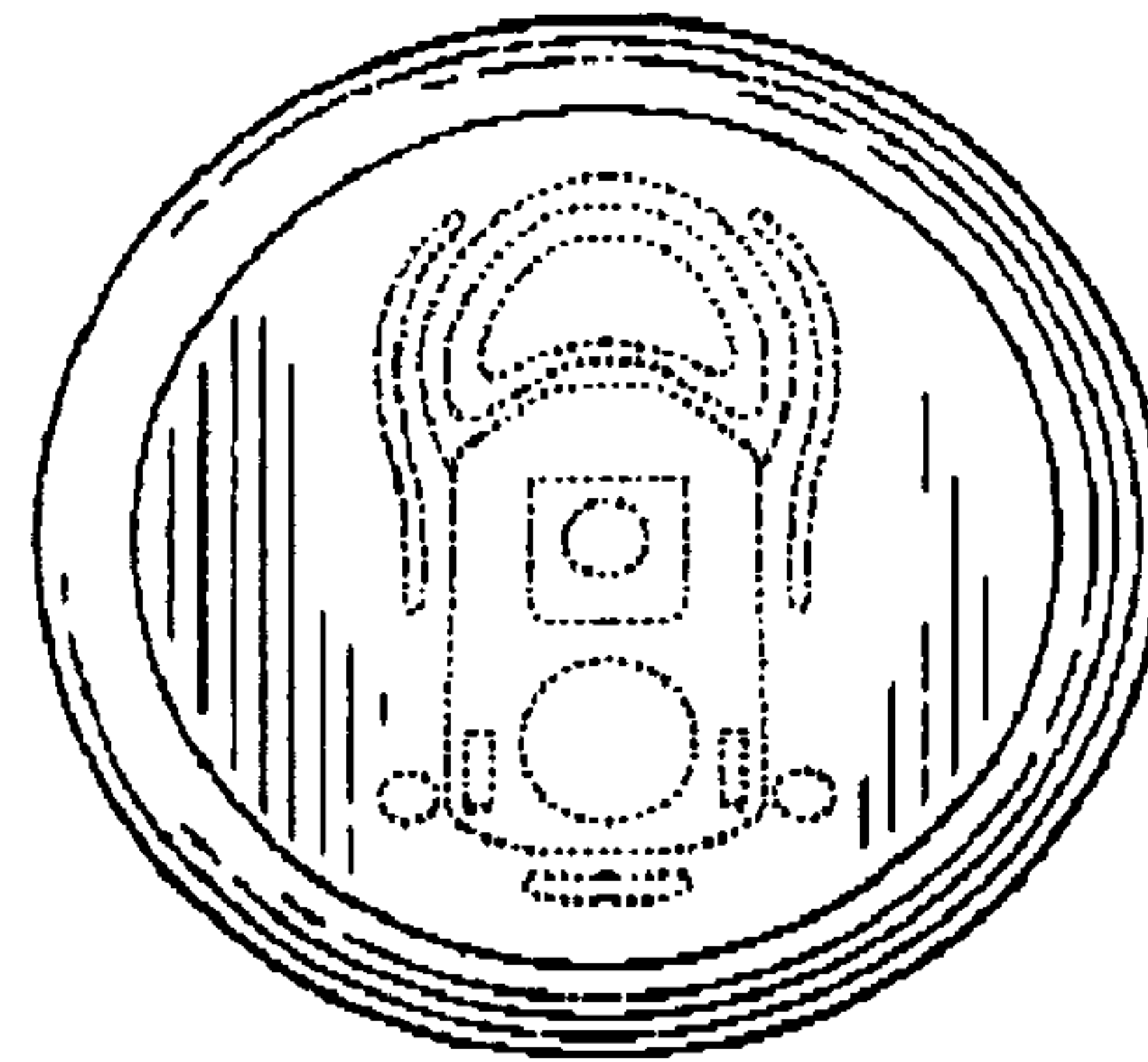

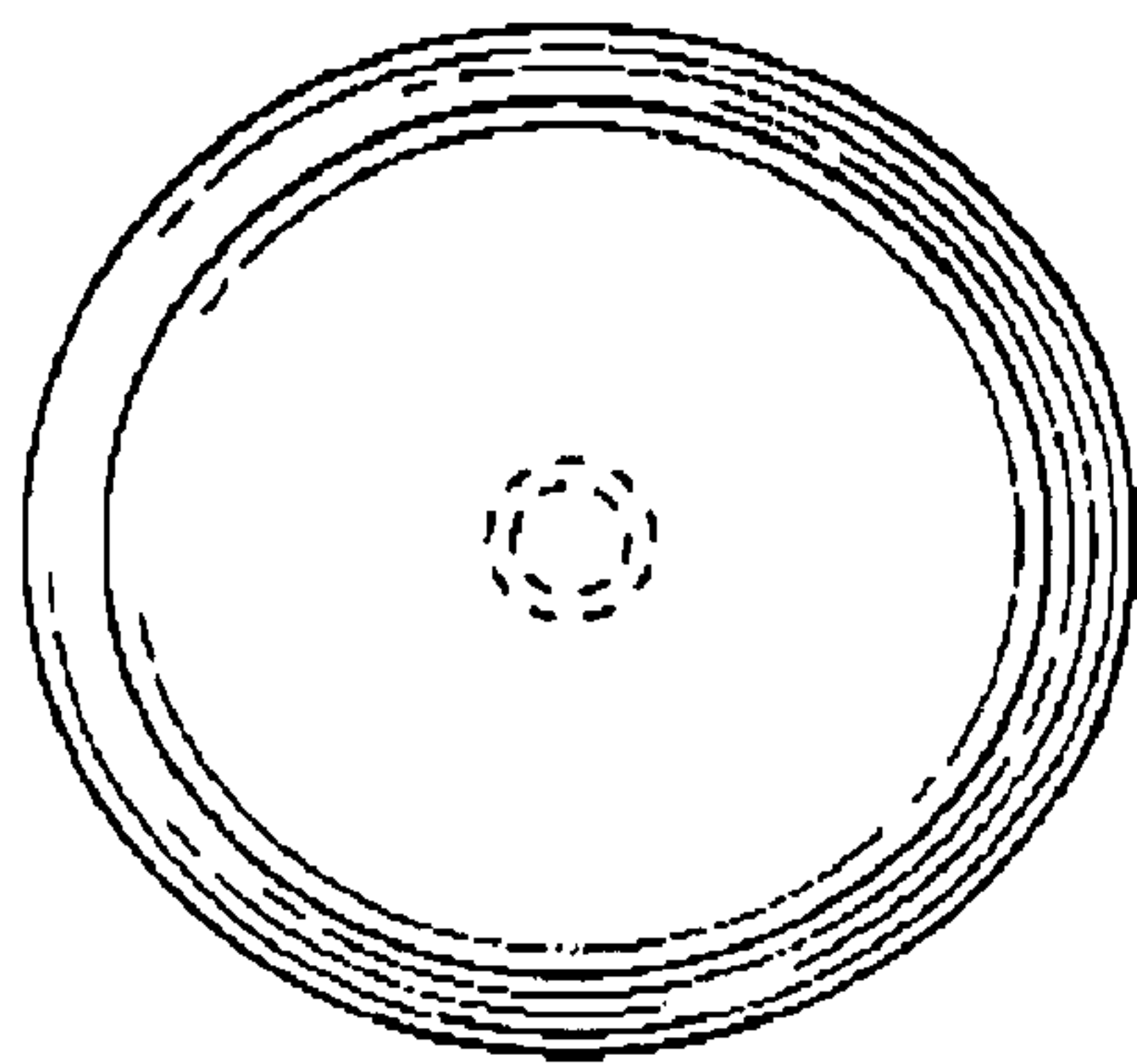

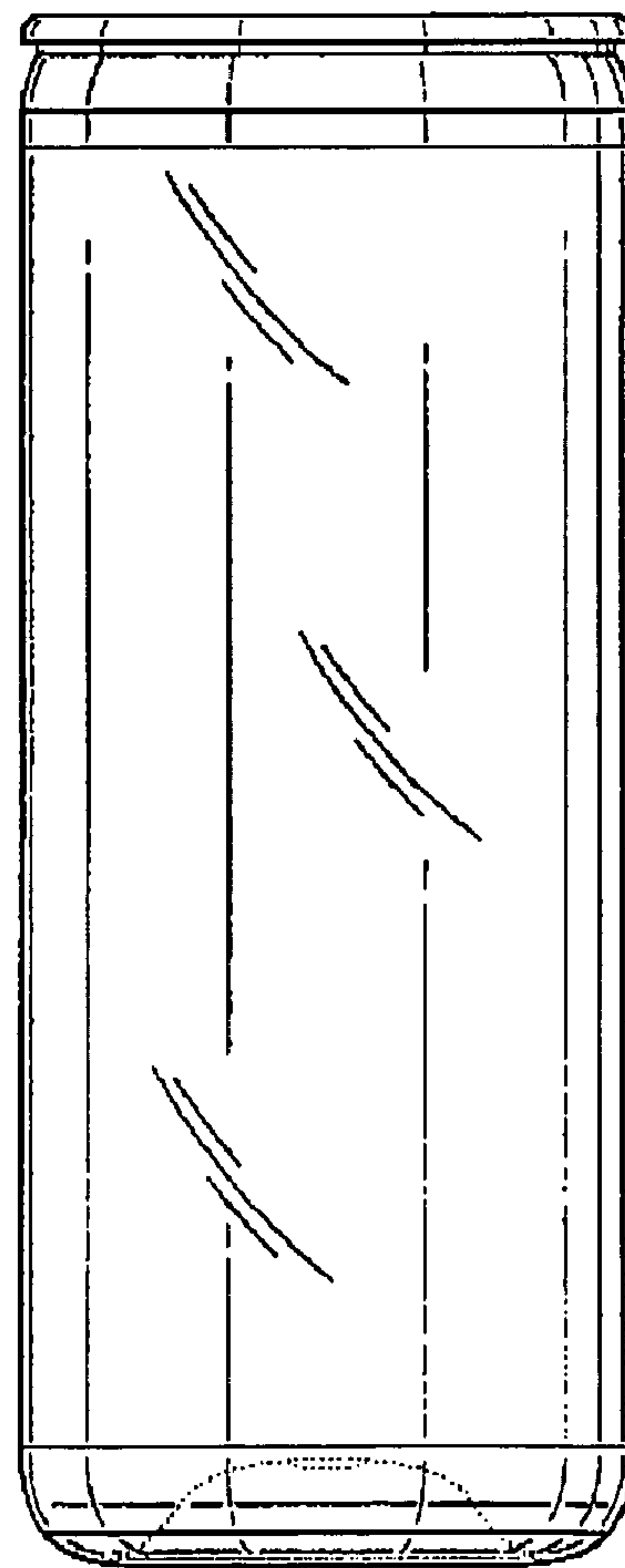
