(57) **CLAIM**

The ornamental design for an omnidirectional wireless microphone for use with a multi-user audio system, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an omnidirectional wireless microphone for use with a multi-user audio system;

FIG. 2 is a back perspective view of an omnidirectional wireless microphone for use with a multi-user audio system;

FIG. 3 is a front view of an omnidirectional wireless microphone for use with a multi-user audio system;

FIG. 4 is a side view of an omnidirectional wireless microphone for use with a multi-user audio system;

FIG. 5 is a back view of an omnidirectional wireless microphone for use with a multi-user audio system;

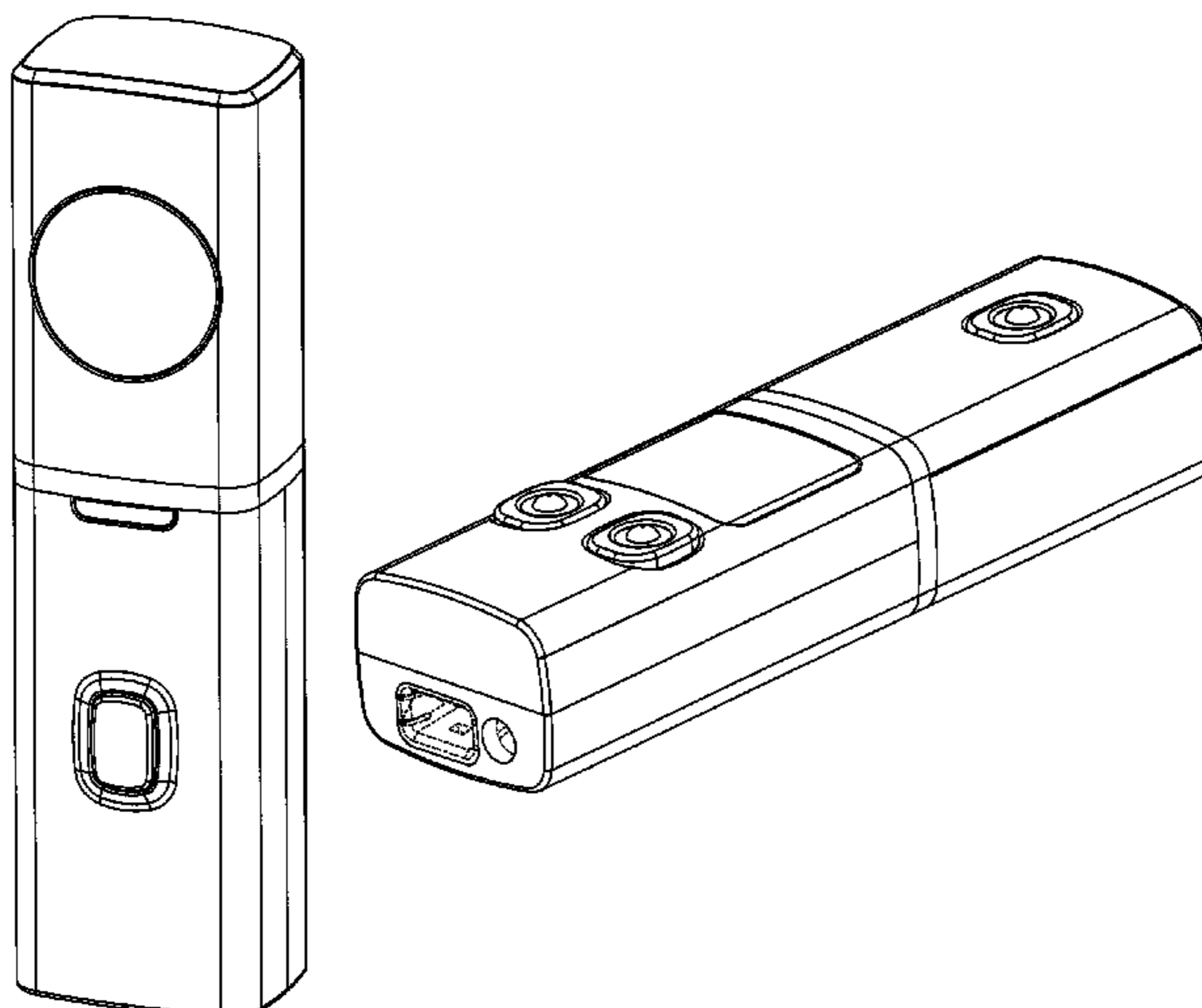
FIG. 6 is a side view of an omnidirectional wireless microphone for use with a multi-user audio system;

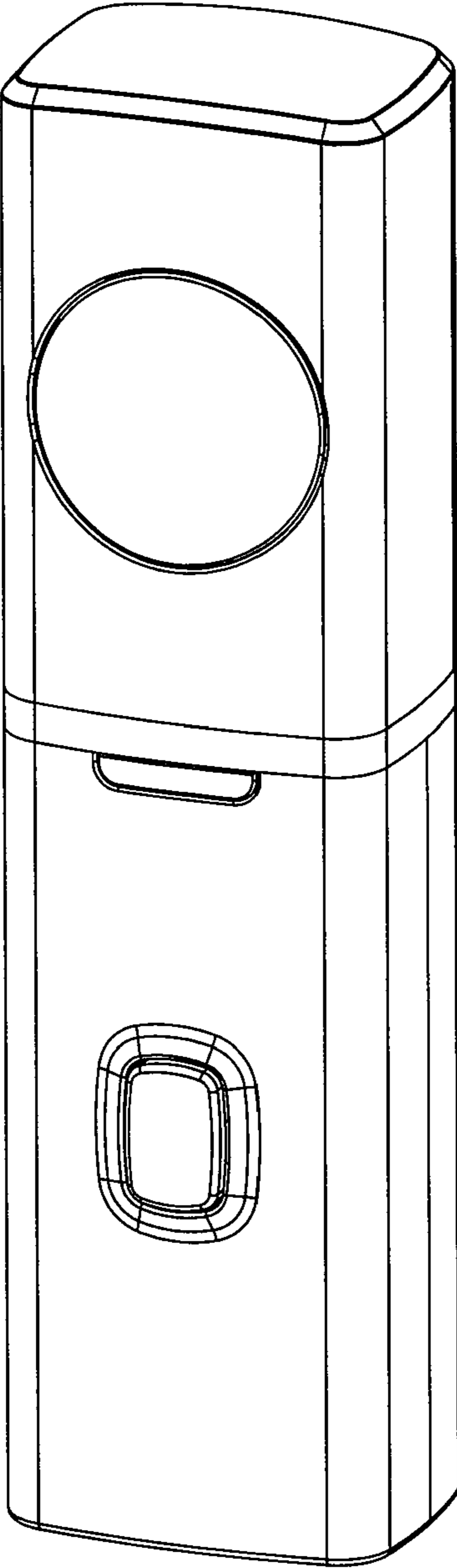

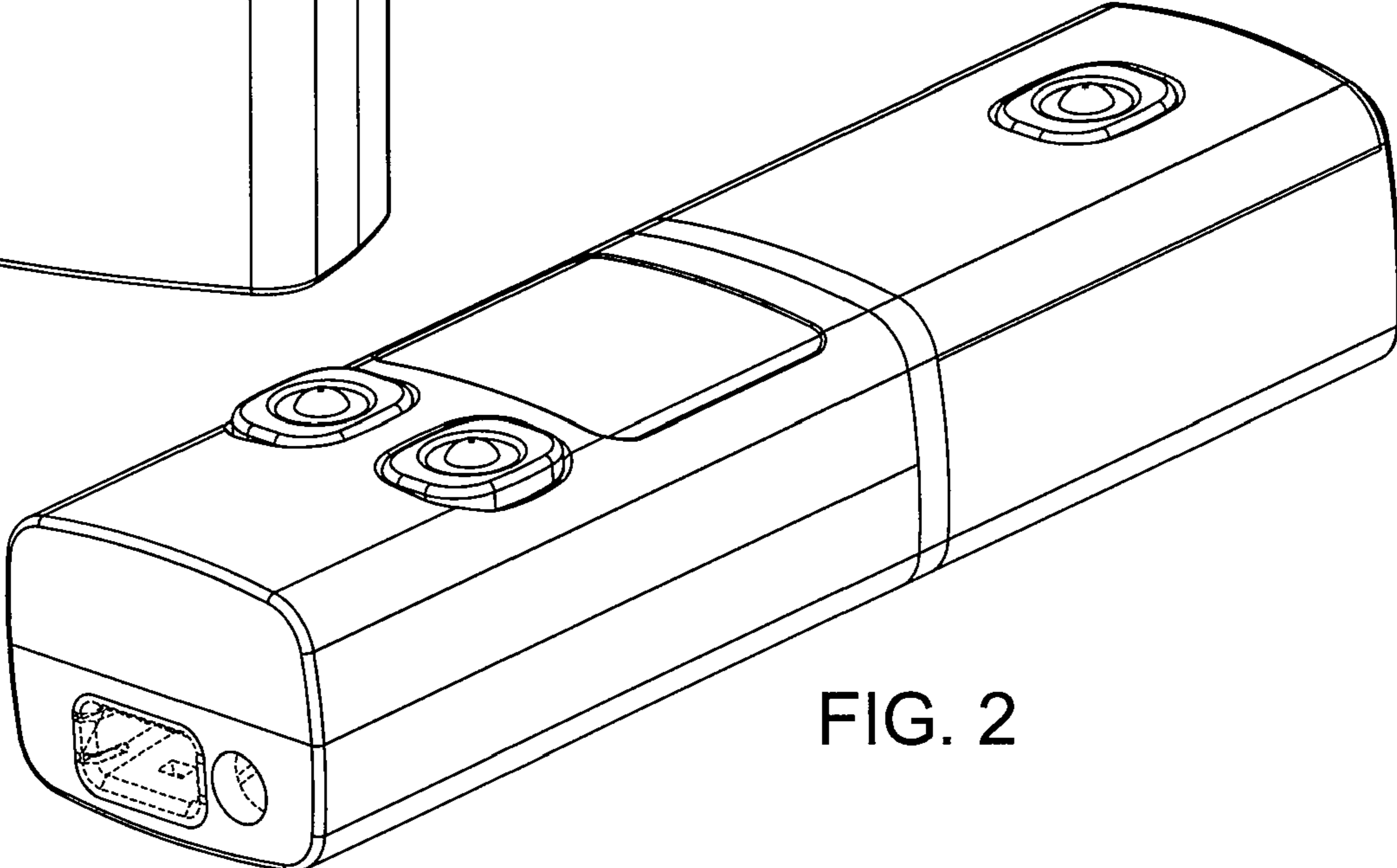

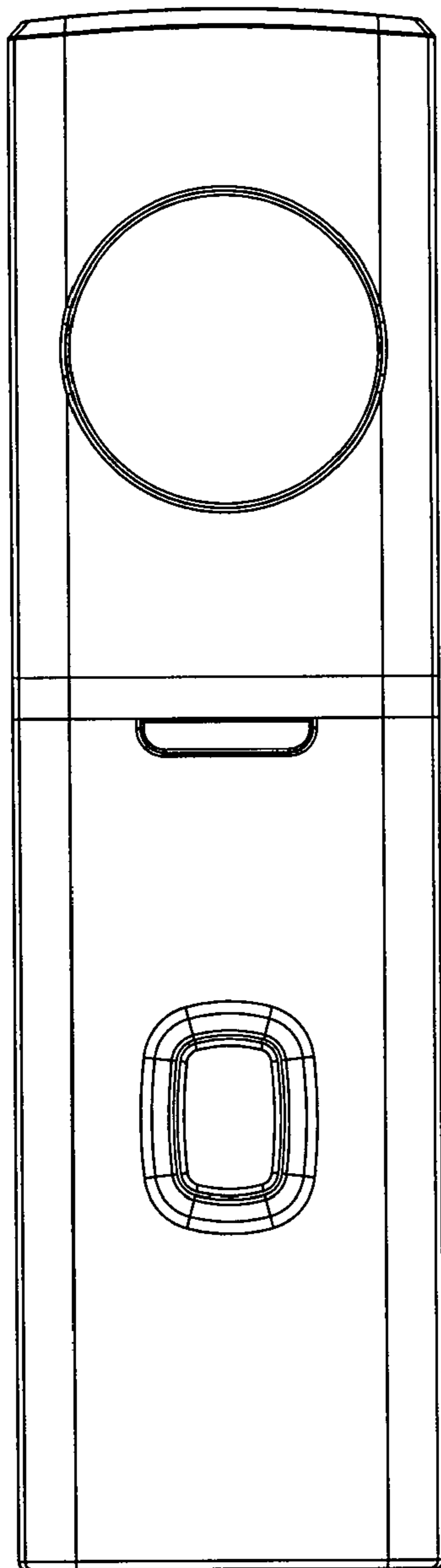

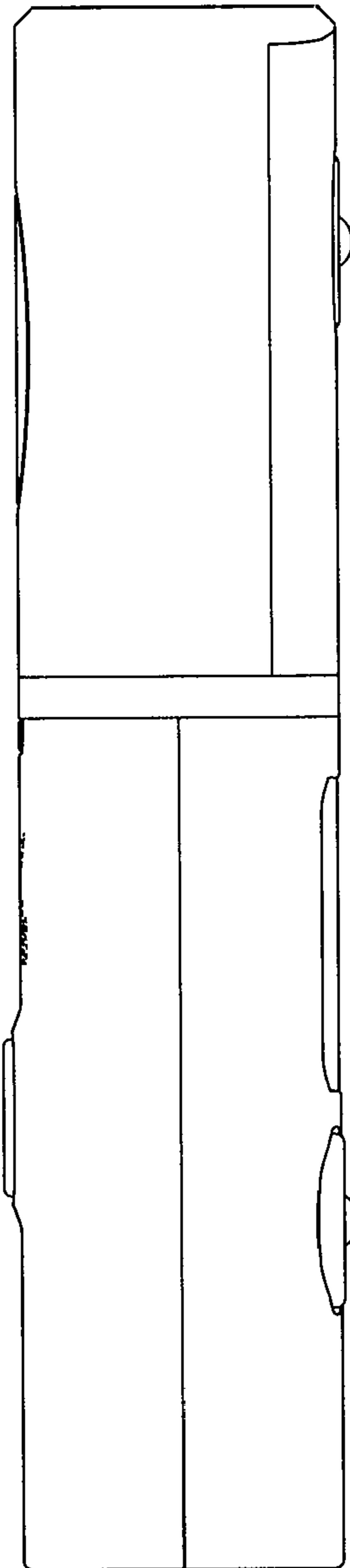

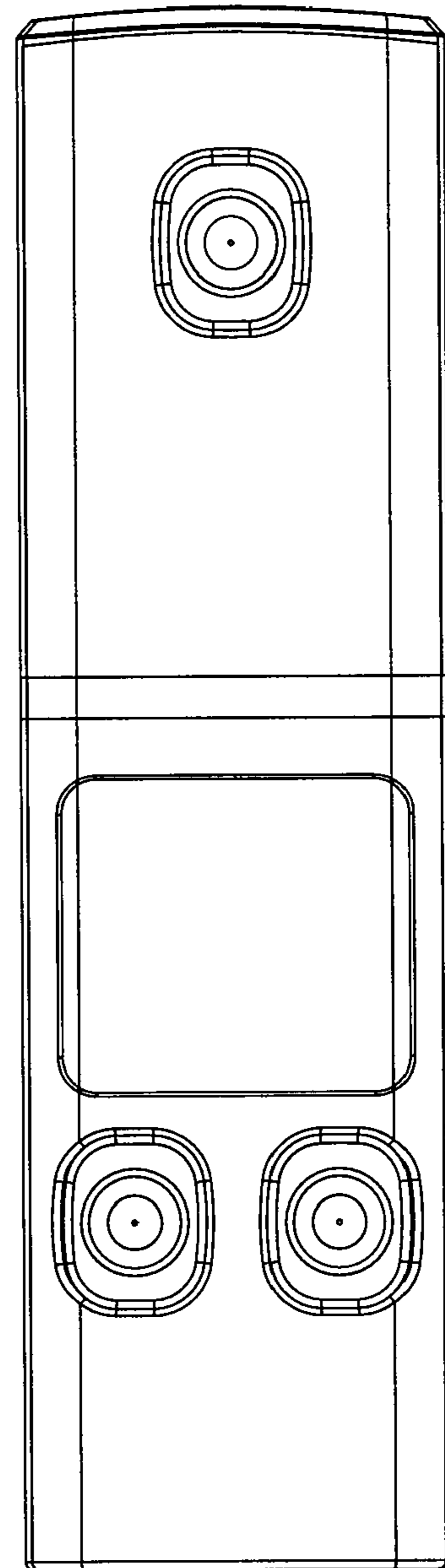

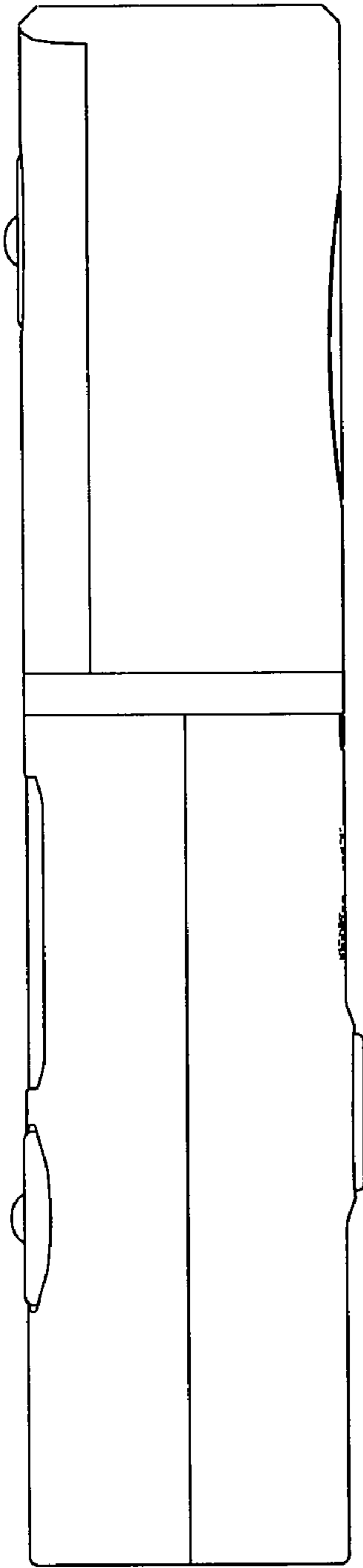

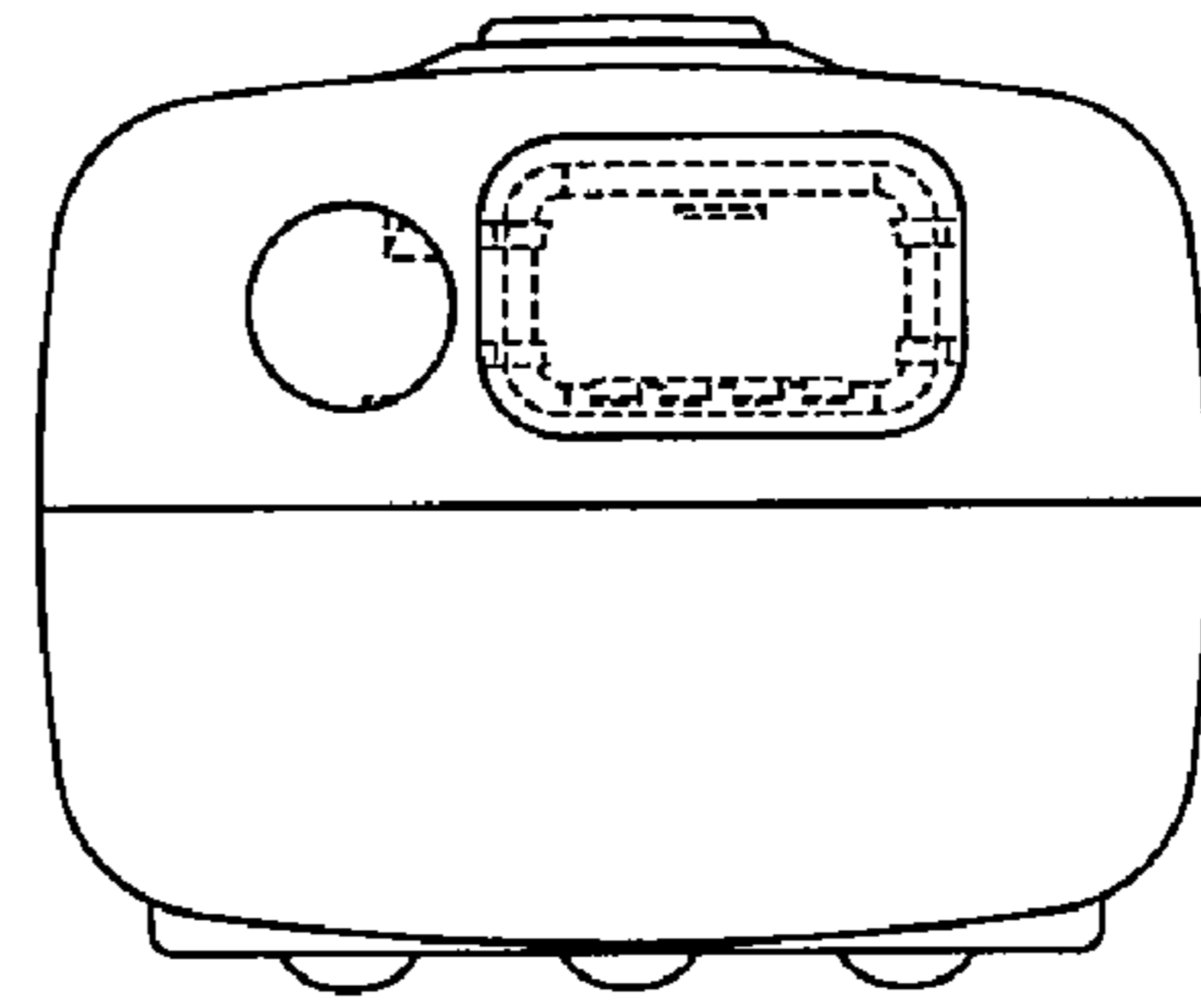

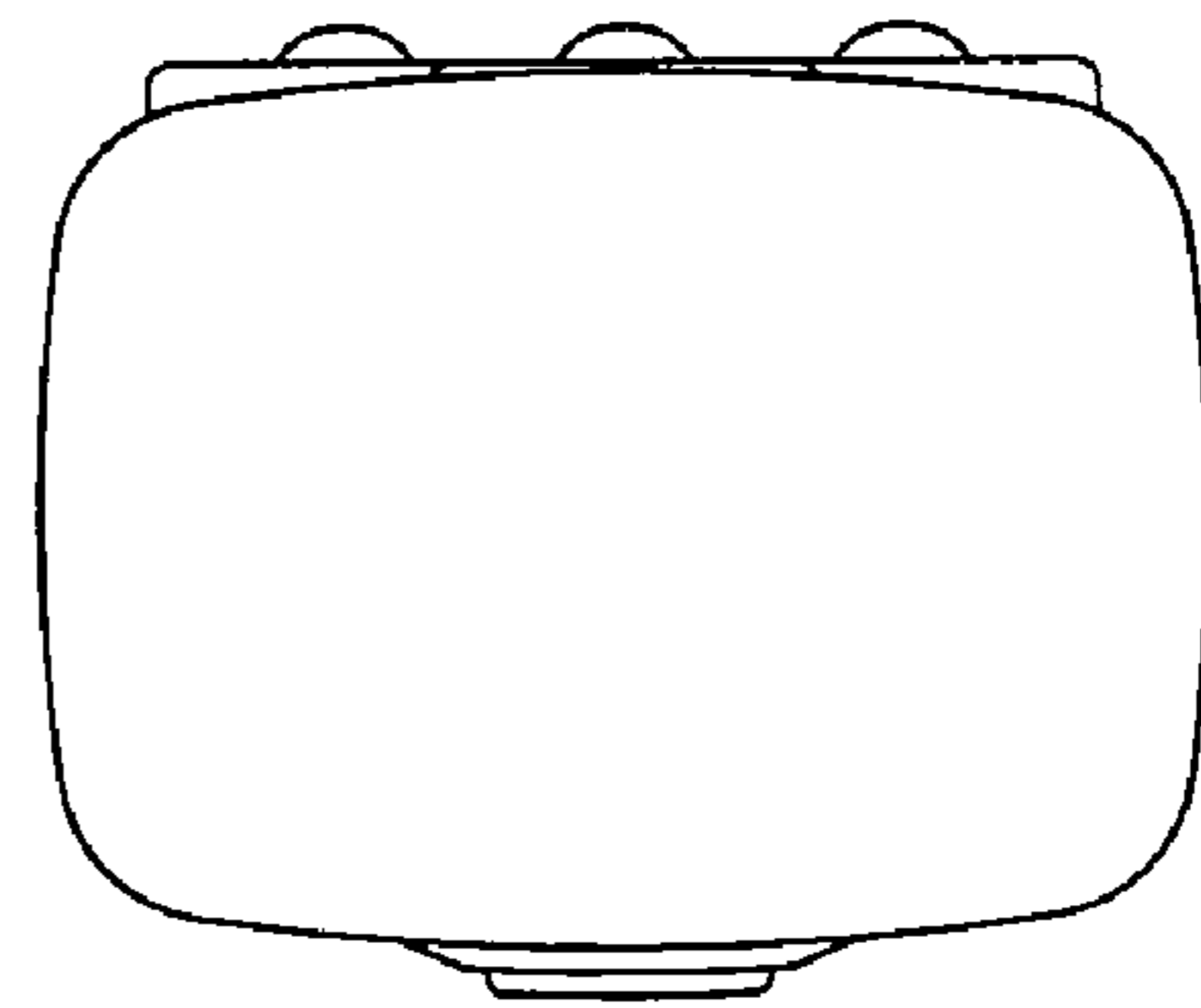
