FIG. 3 is a left side view of the first embodiment;

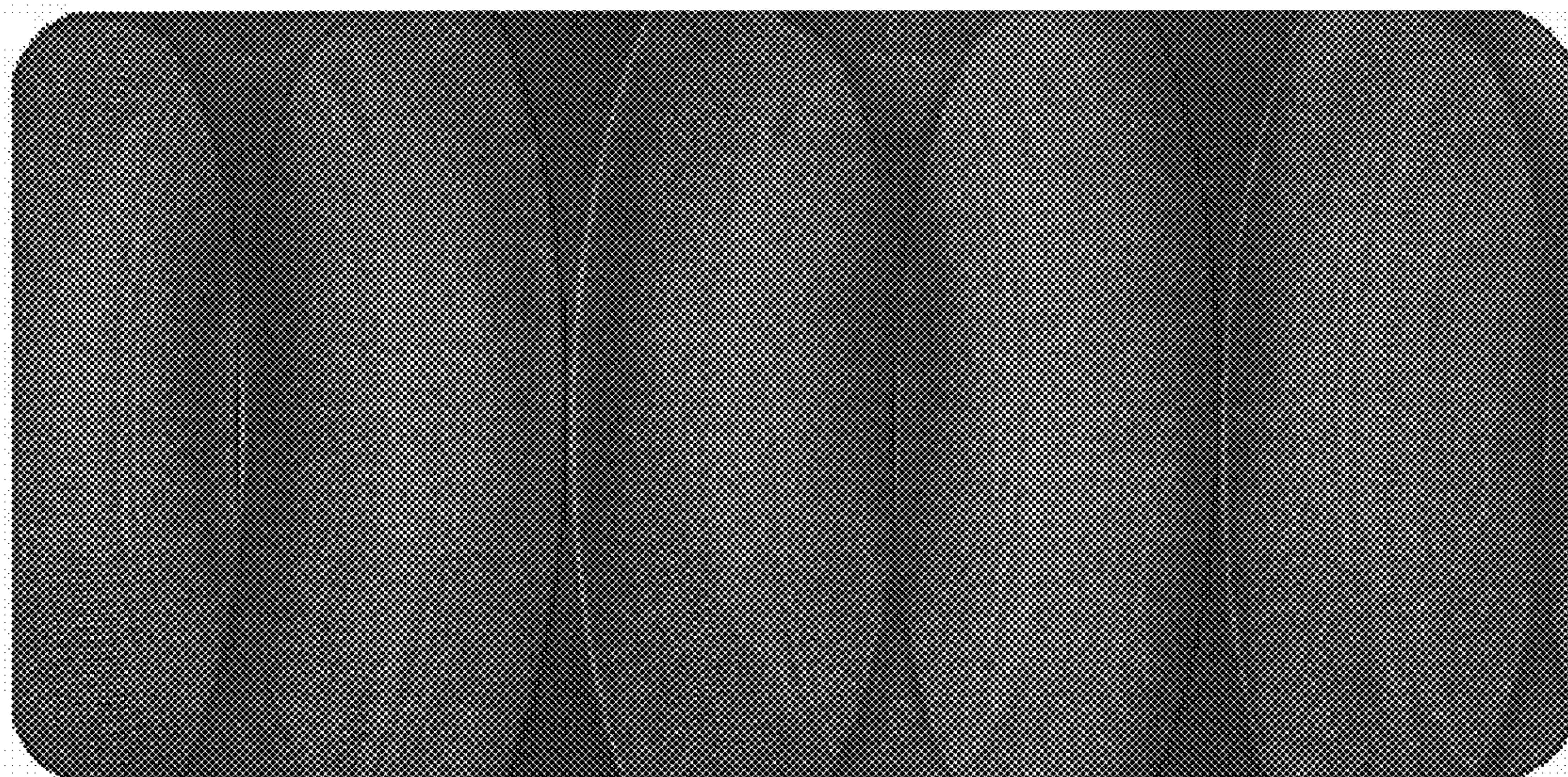
FIG. 4 is a perspective view of back cover for electronic device showing a second embodiment of our design;

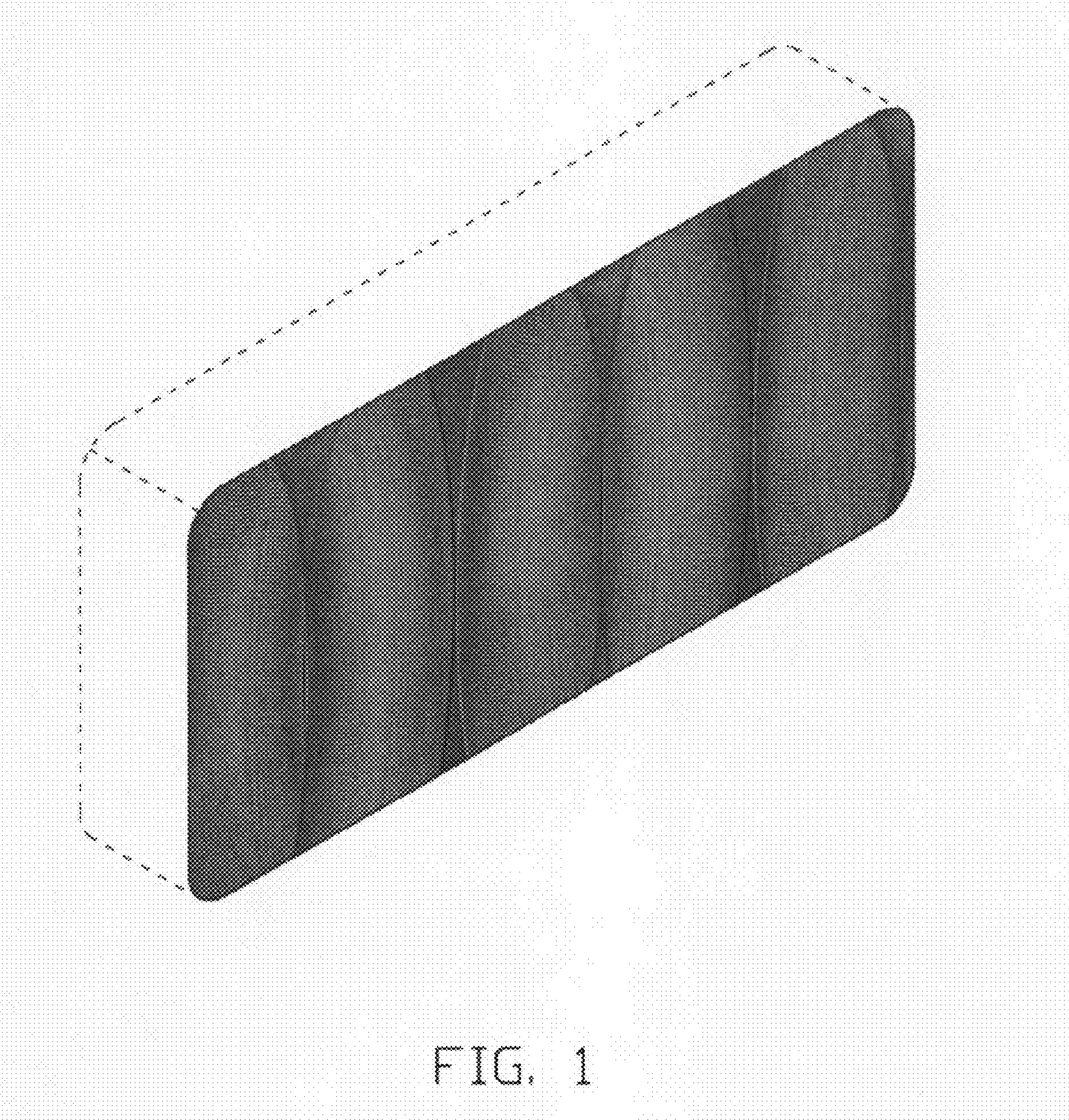
FIG. 5 is a front elevational view of the second embodiment of our design; and,

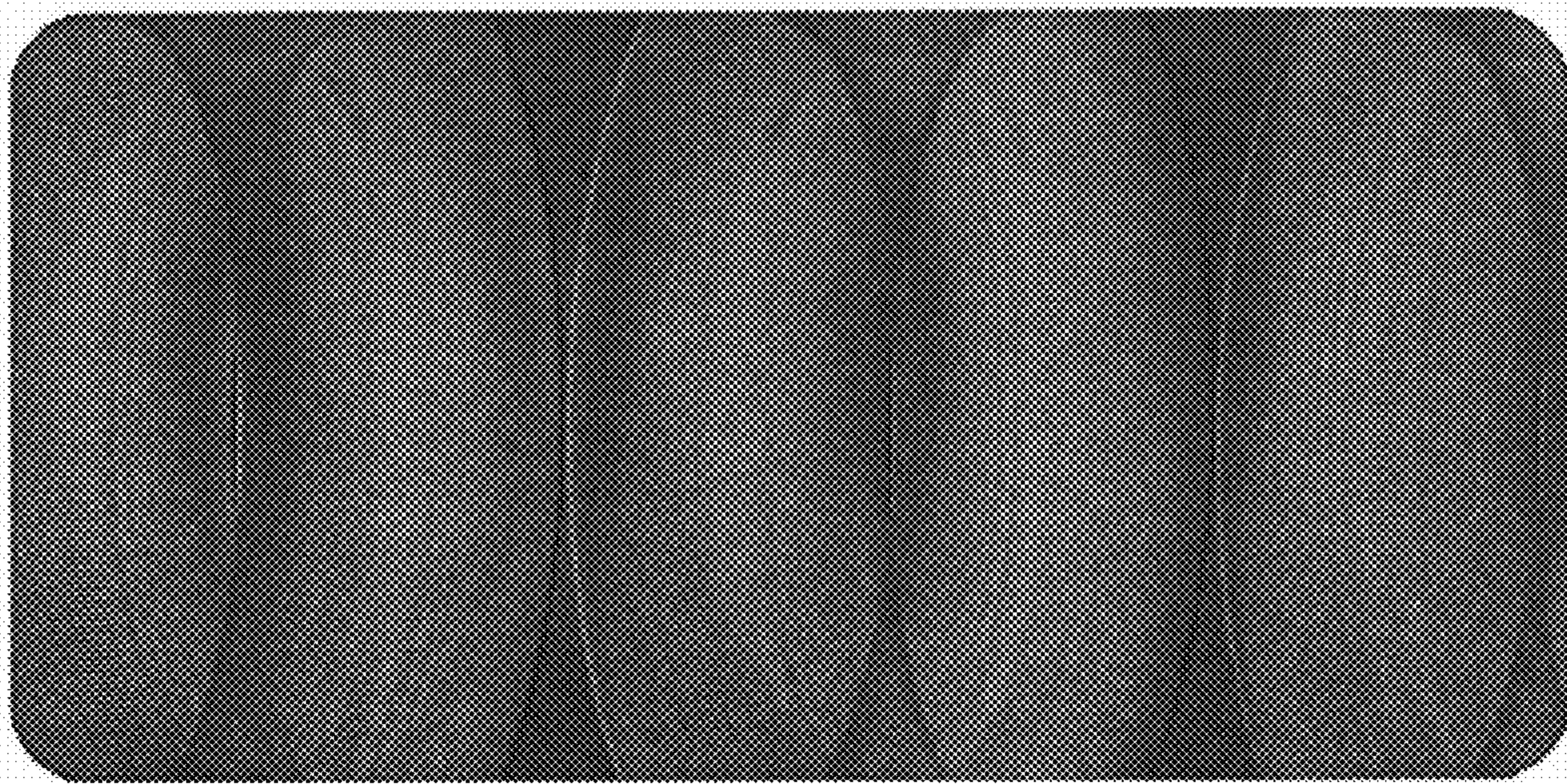

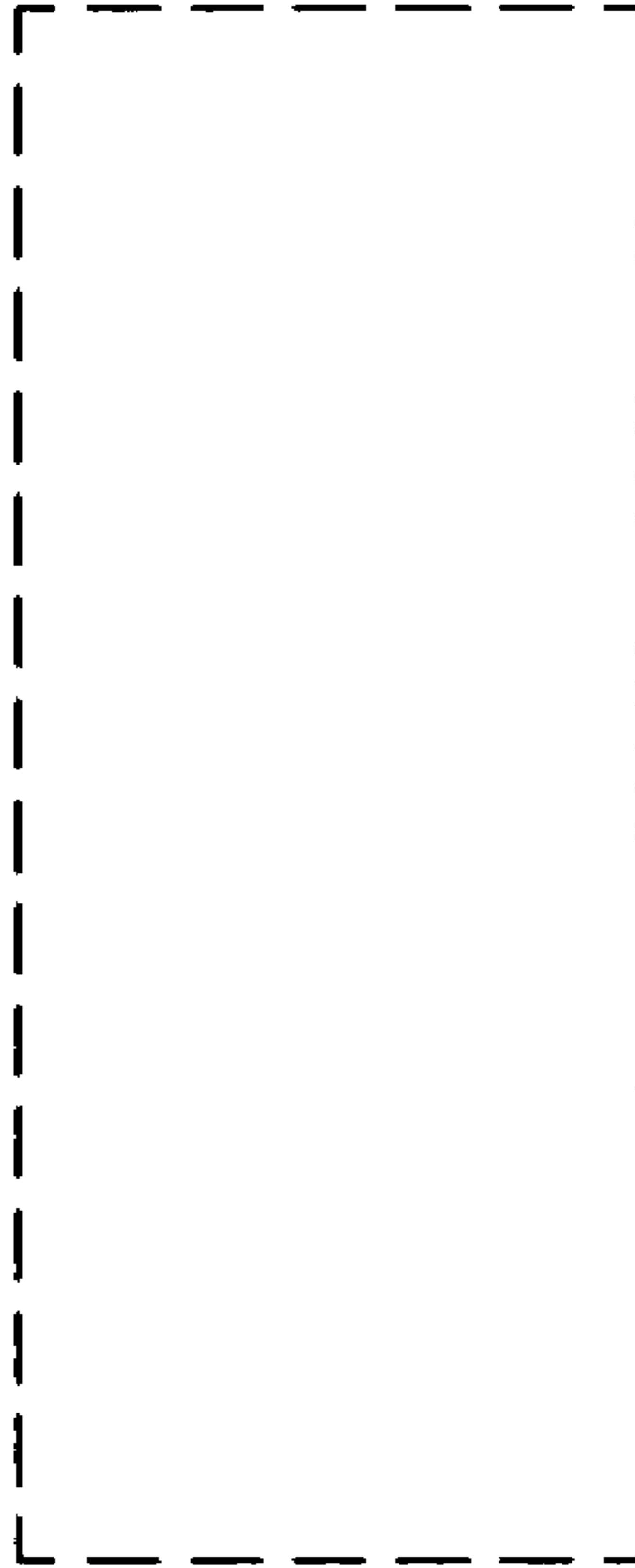

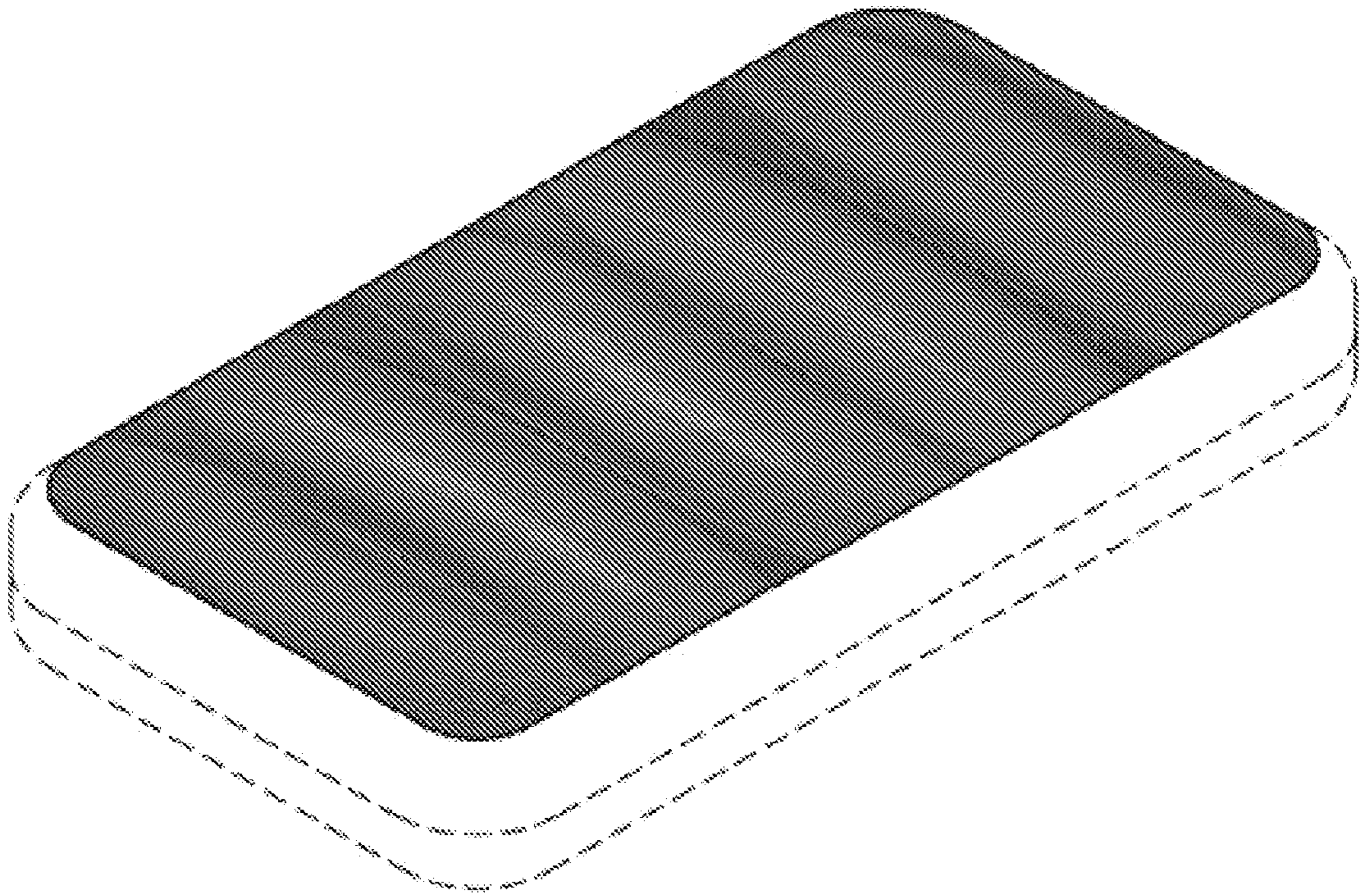

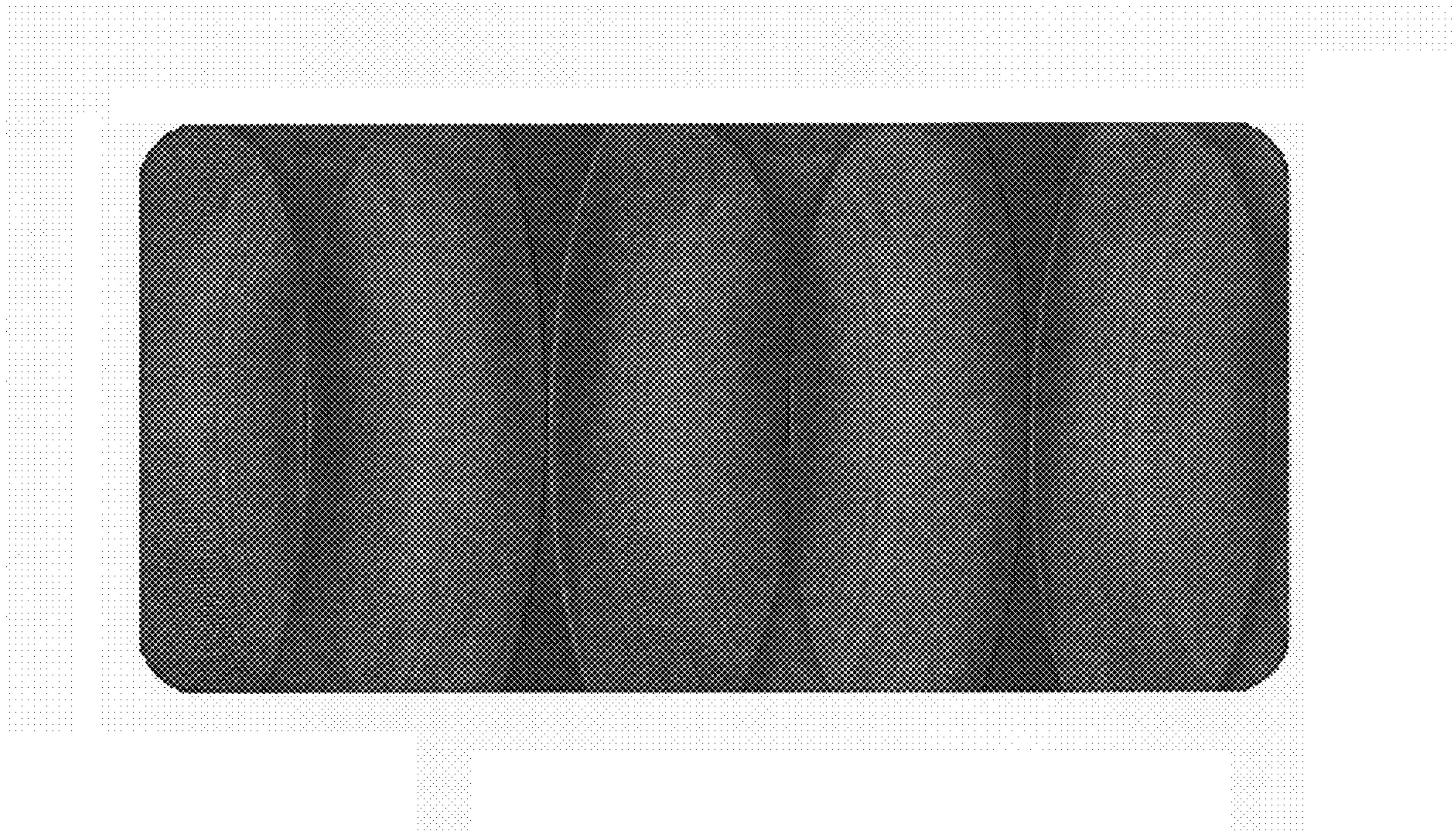

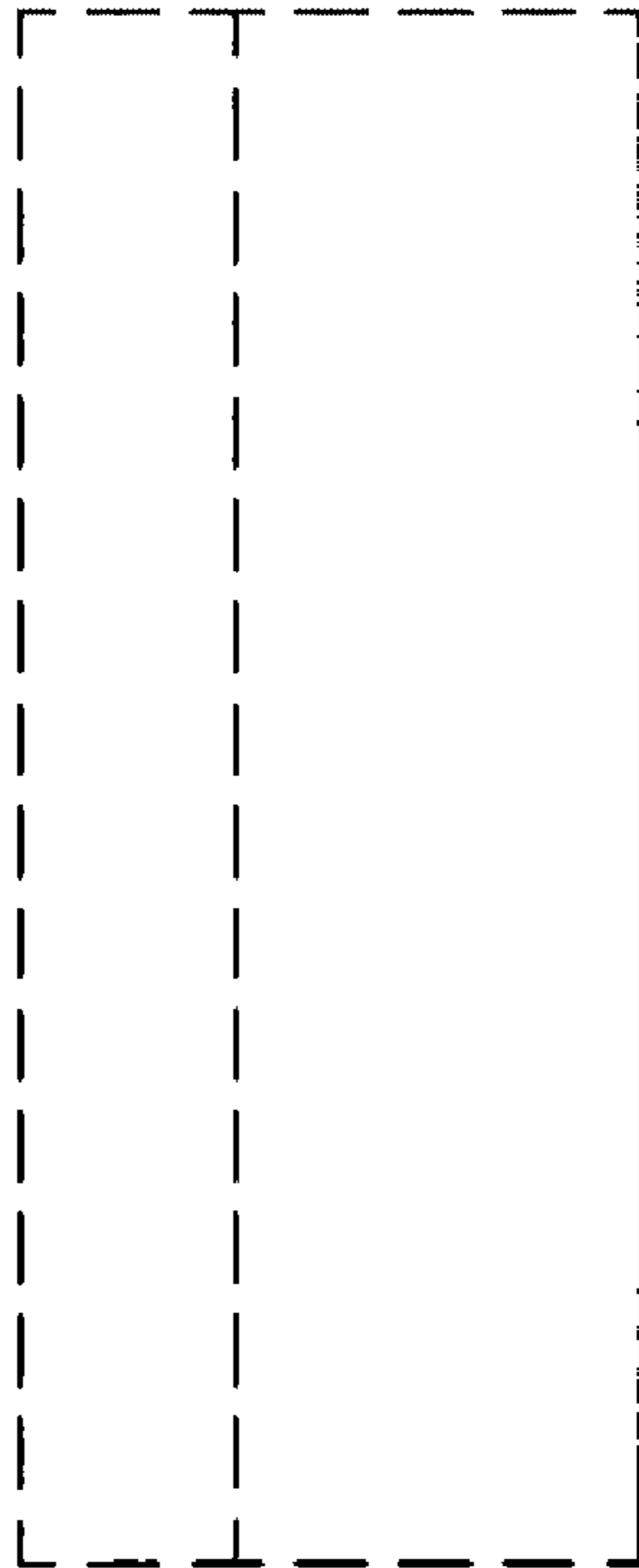
