(57) **CLAIM**

The ornamental design for a front cover of a handset, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a front cover of a handset showing our new design in an environment of a disclaimed remainder of a handset.

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a perspective front view thereof;

FIG. 7 is a bottom plan view of a front cover of a handset showing our new design with front cover shown in isolation;

FIG. 8 is a top plan view thereof;

FIG. 9 is a right side view thereof;

FIG. 10 is a front view thereof;

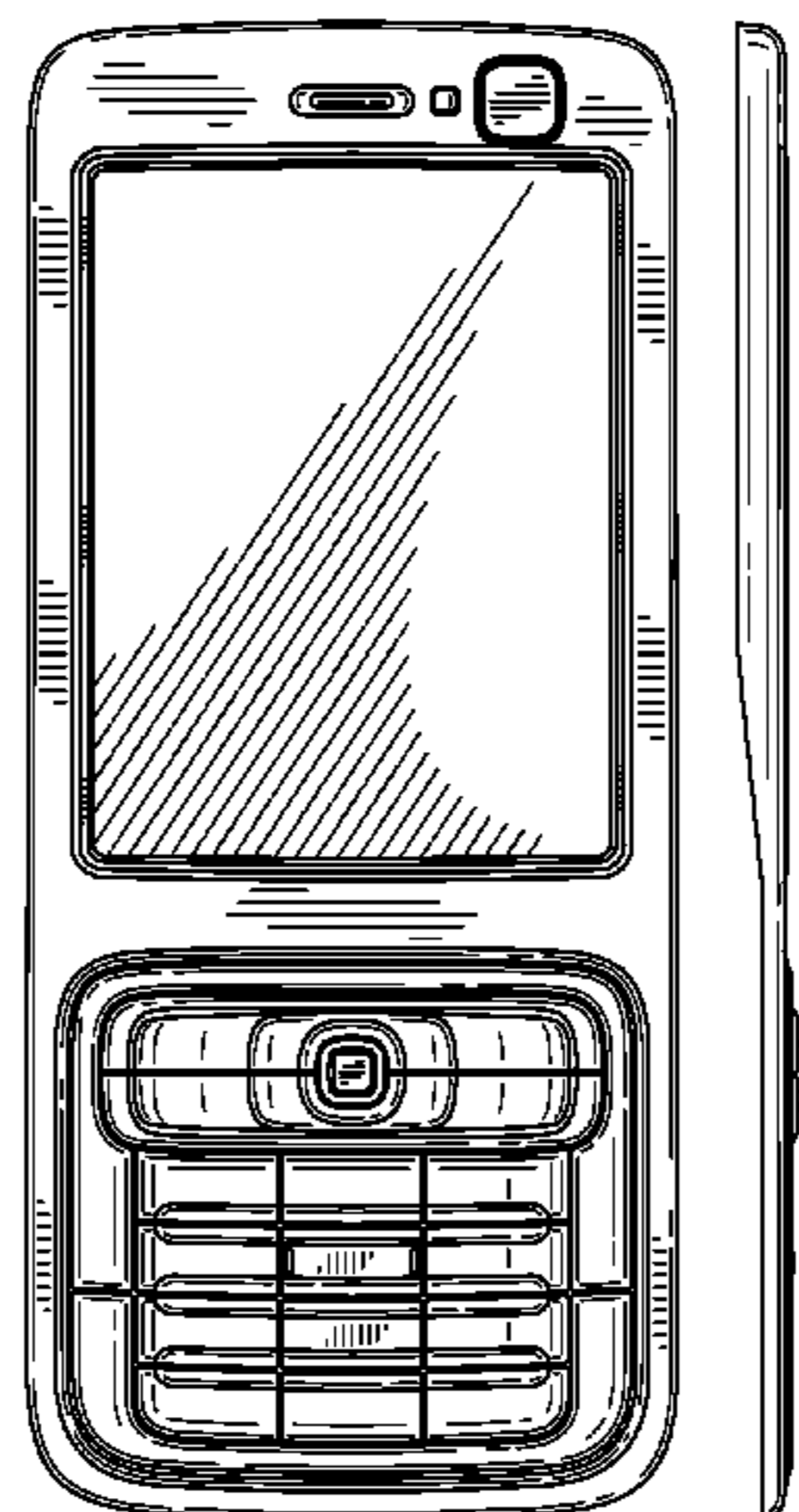
FIG. 11 is a left side view thereof; and,

FIG. 12 is a perspective front view thereof.

The broken line showing of environmental structures is for illustrative purposes only and forms no part of the claimed design.

The solid lines that surround and define this unshaded unclaimed region represent portions of the design that are claimed, as is shown in FIGS. 2-3, 5-6, 8-9, and 11-12.

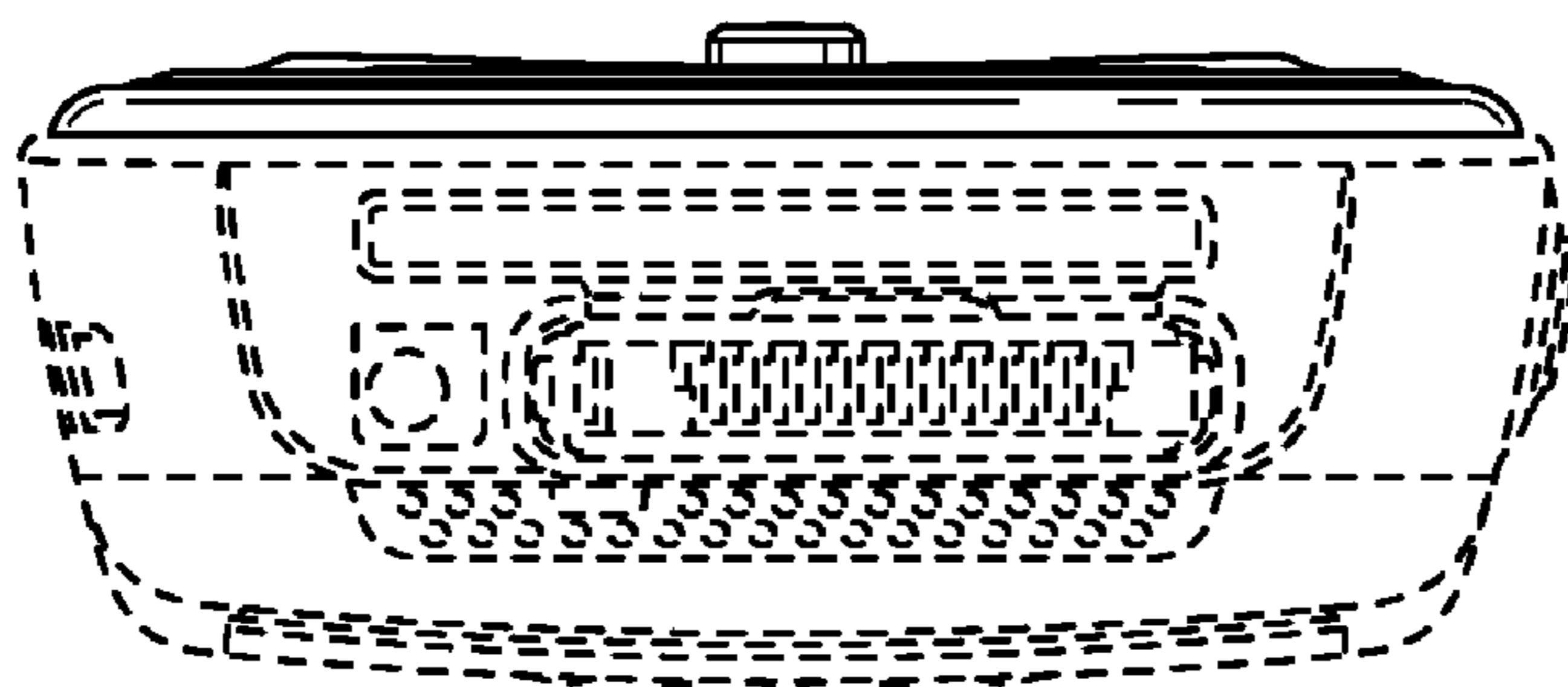

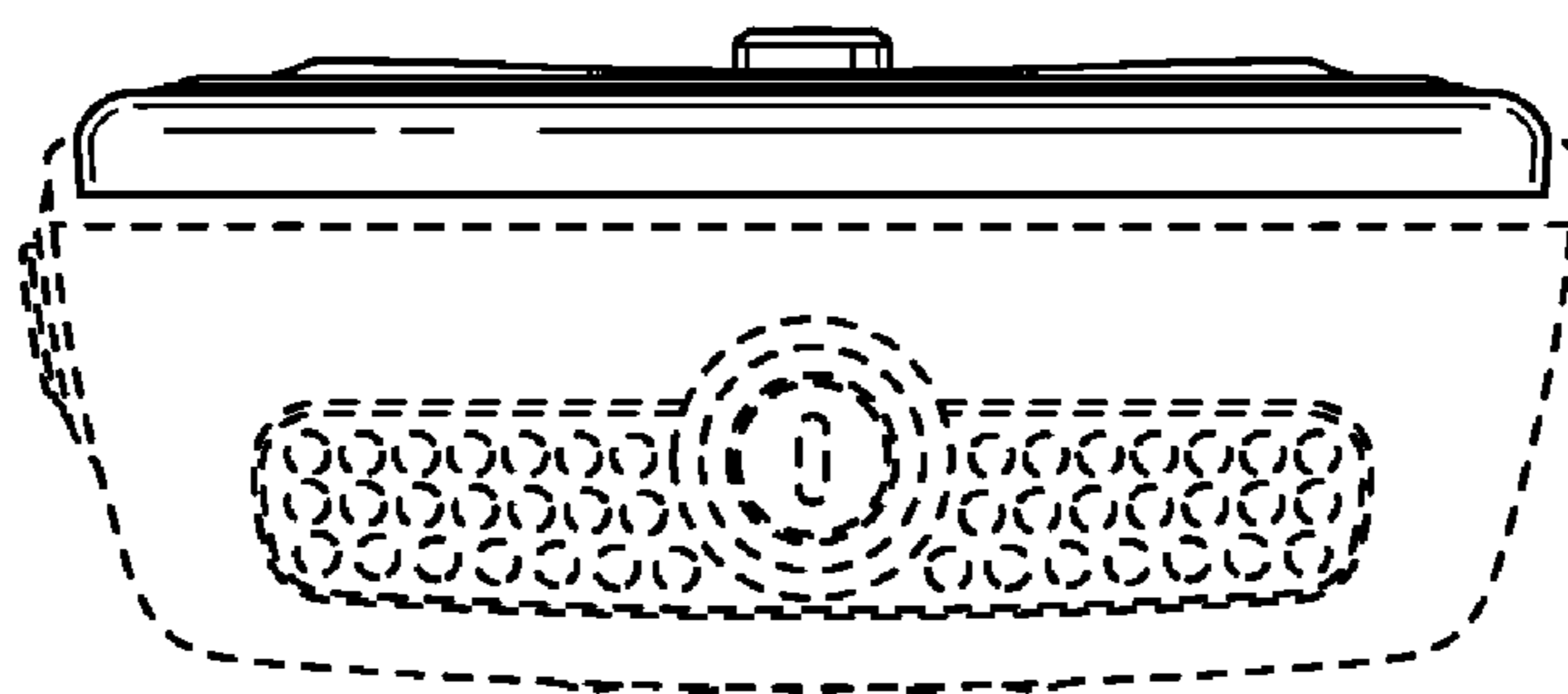

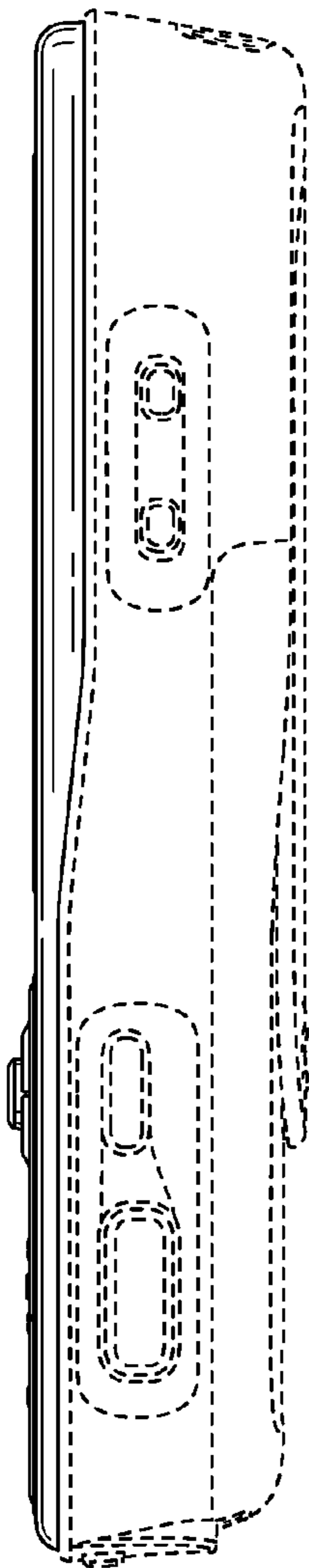

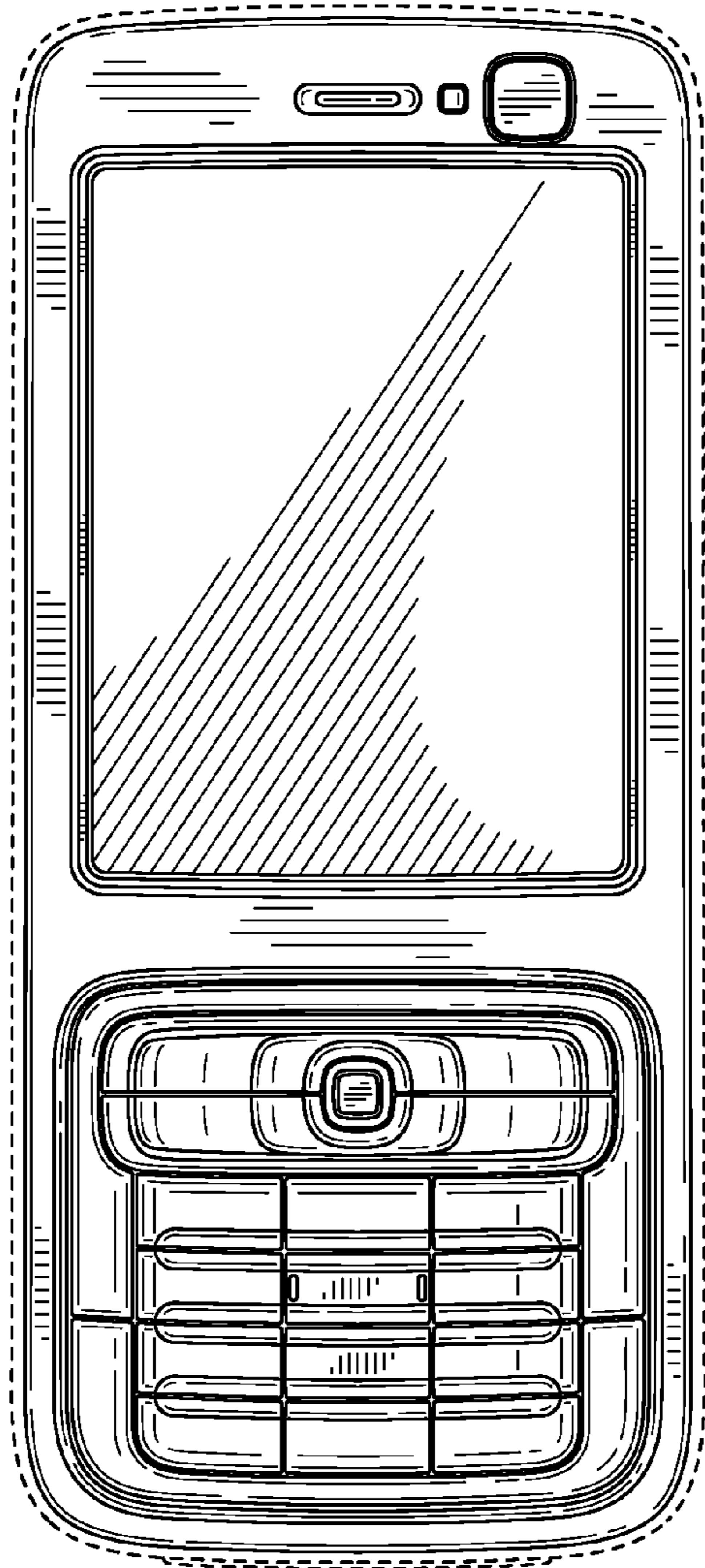

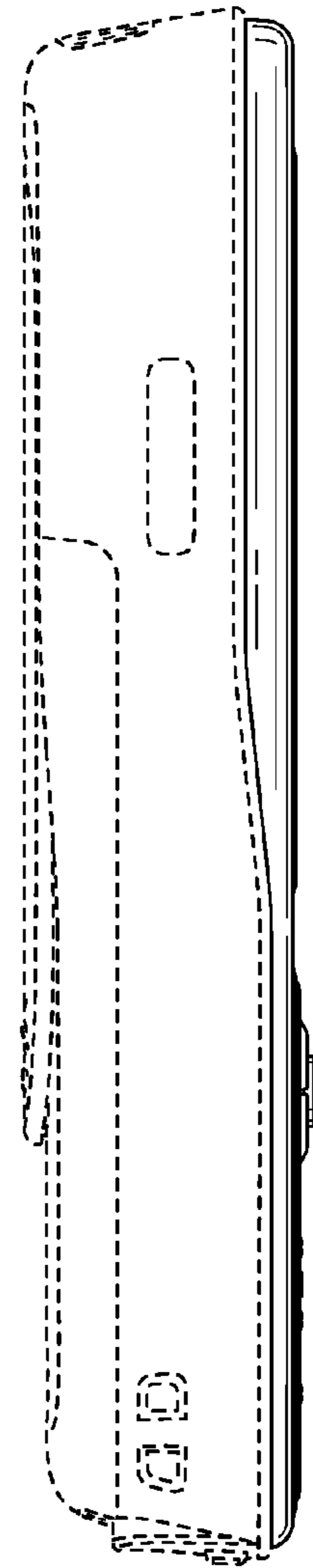

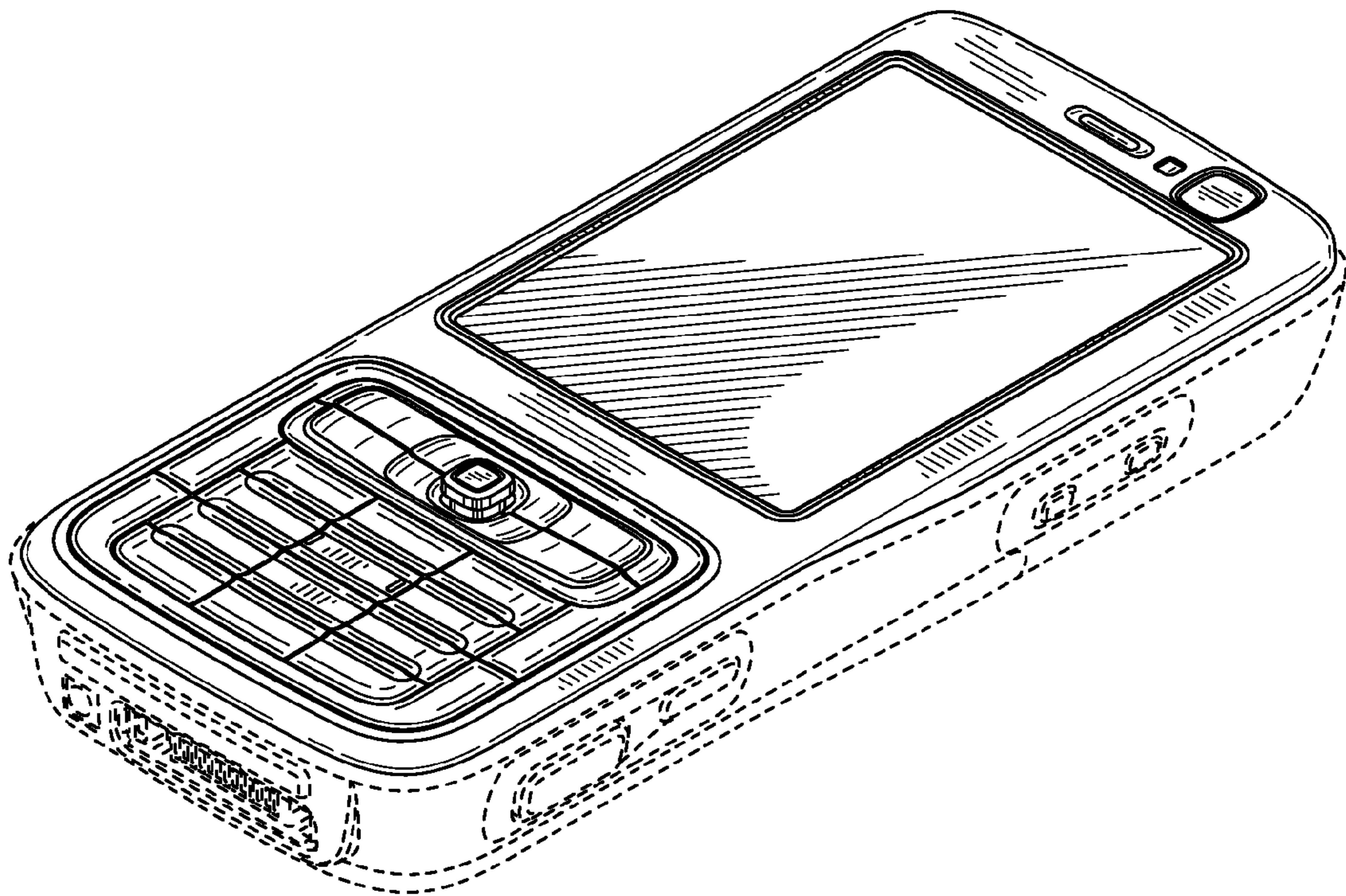

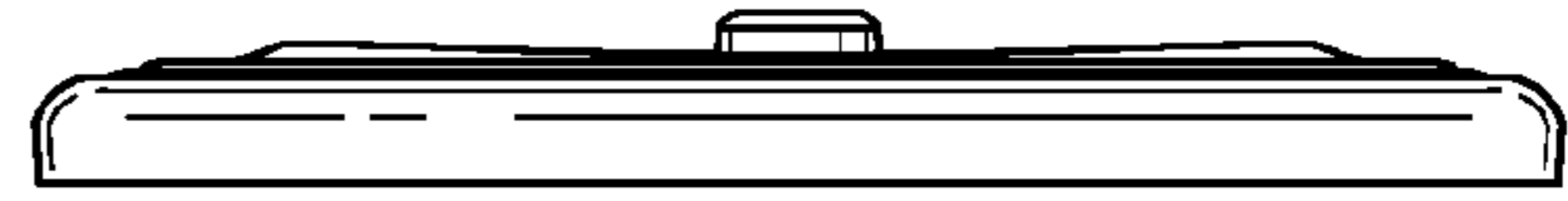

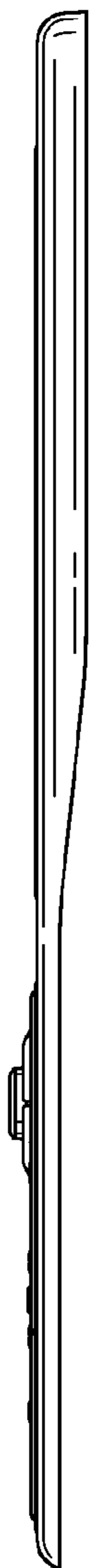

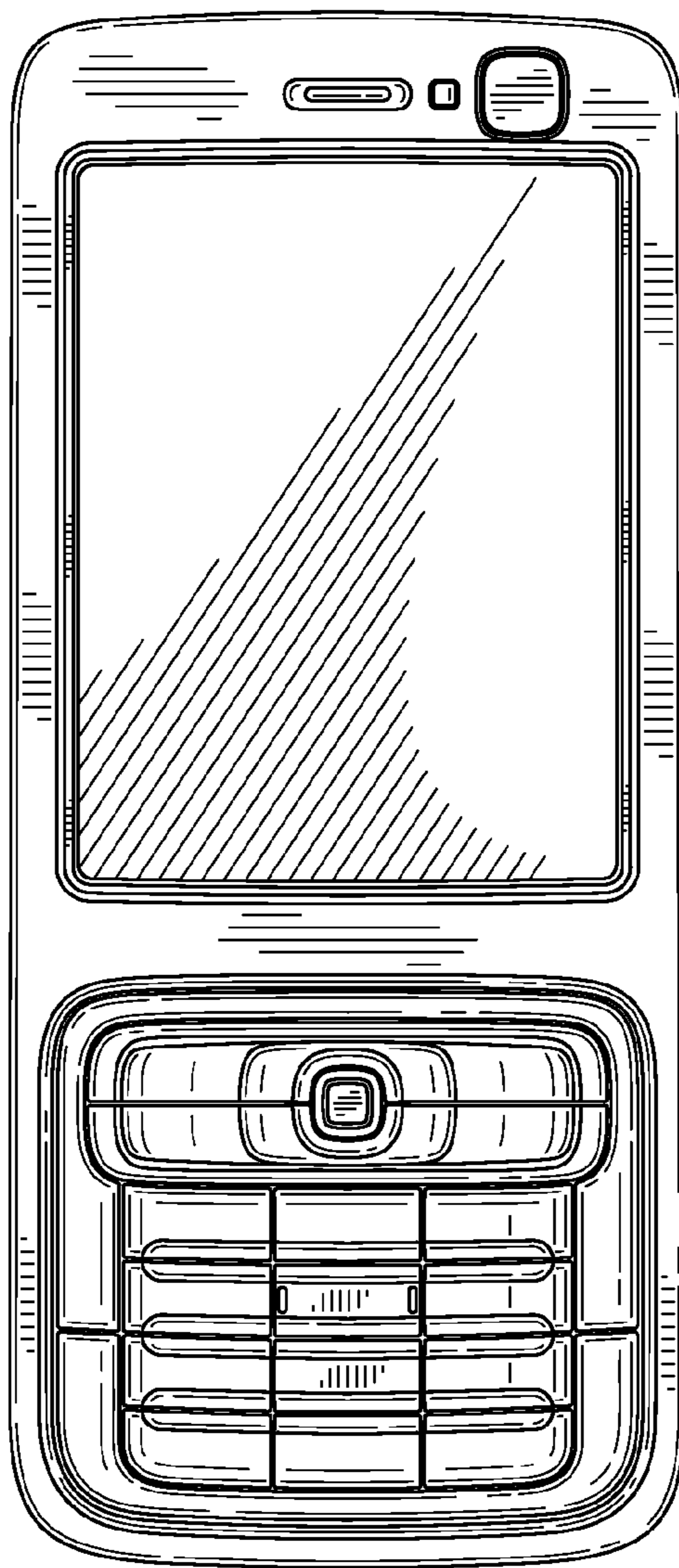

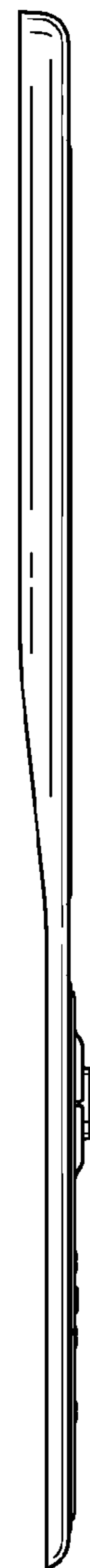

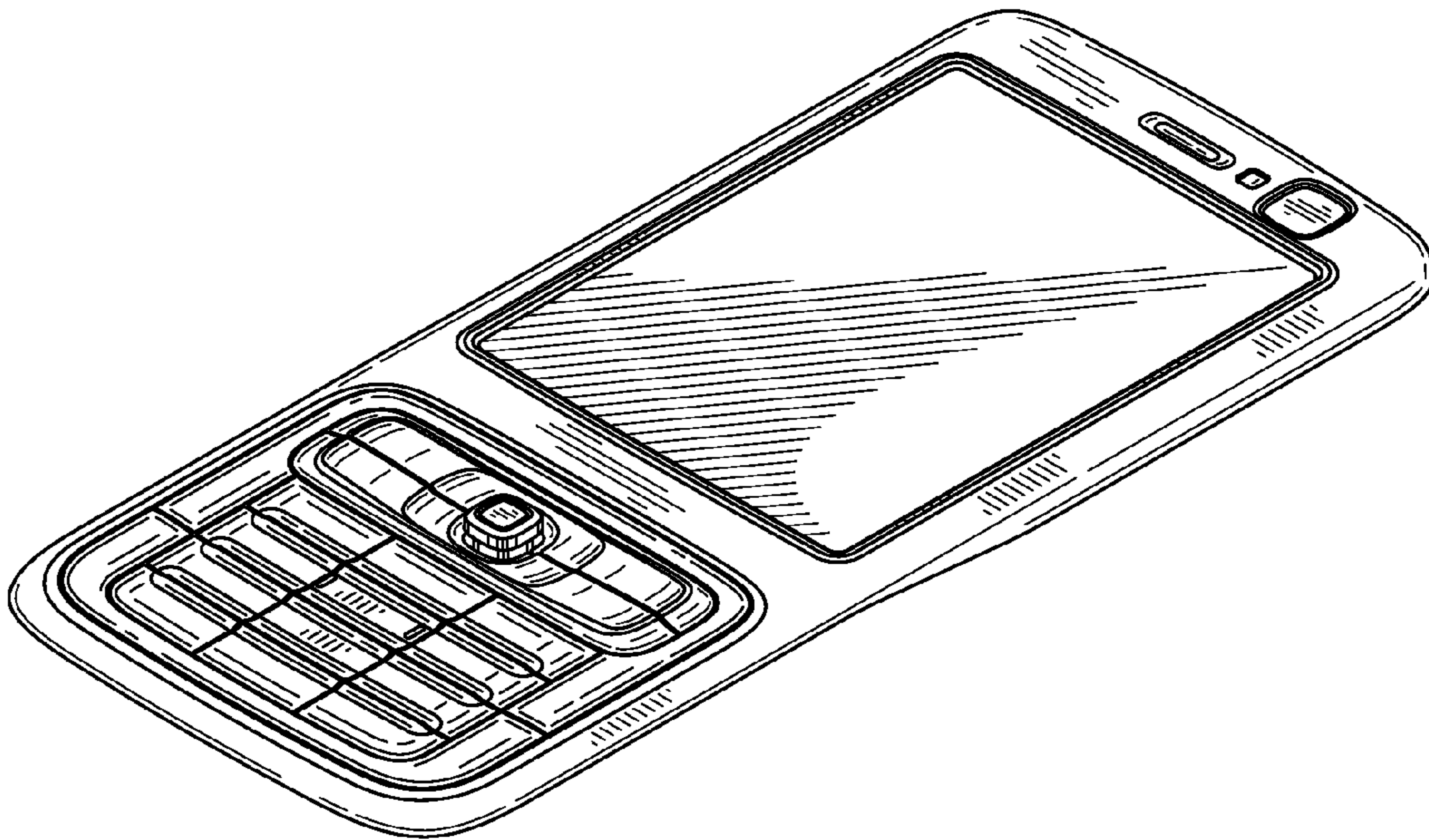
