(57) **CLAIM**

The ornamental design for a adjustable grip for a firearm, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side and bottom perspective view of the adjustable grip for a firearm, showing the grip member off the mount member in an exploded view showing the set screw removed;

FIG. 2 is a left side elevational view of the adjustable grip for a firearm, shown in place on the pistol grip portion of a rifle stock;

FIG. 3 is a left side elevational view of the adjustable grip for a firearm;

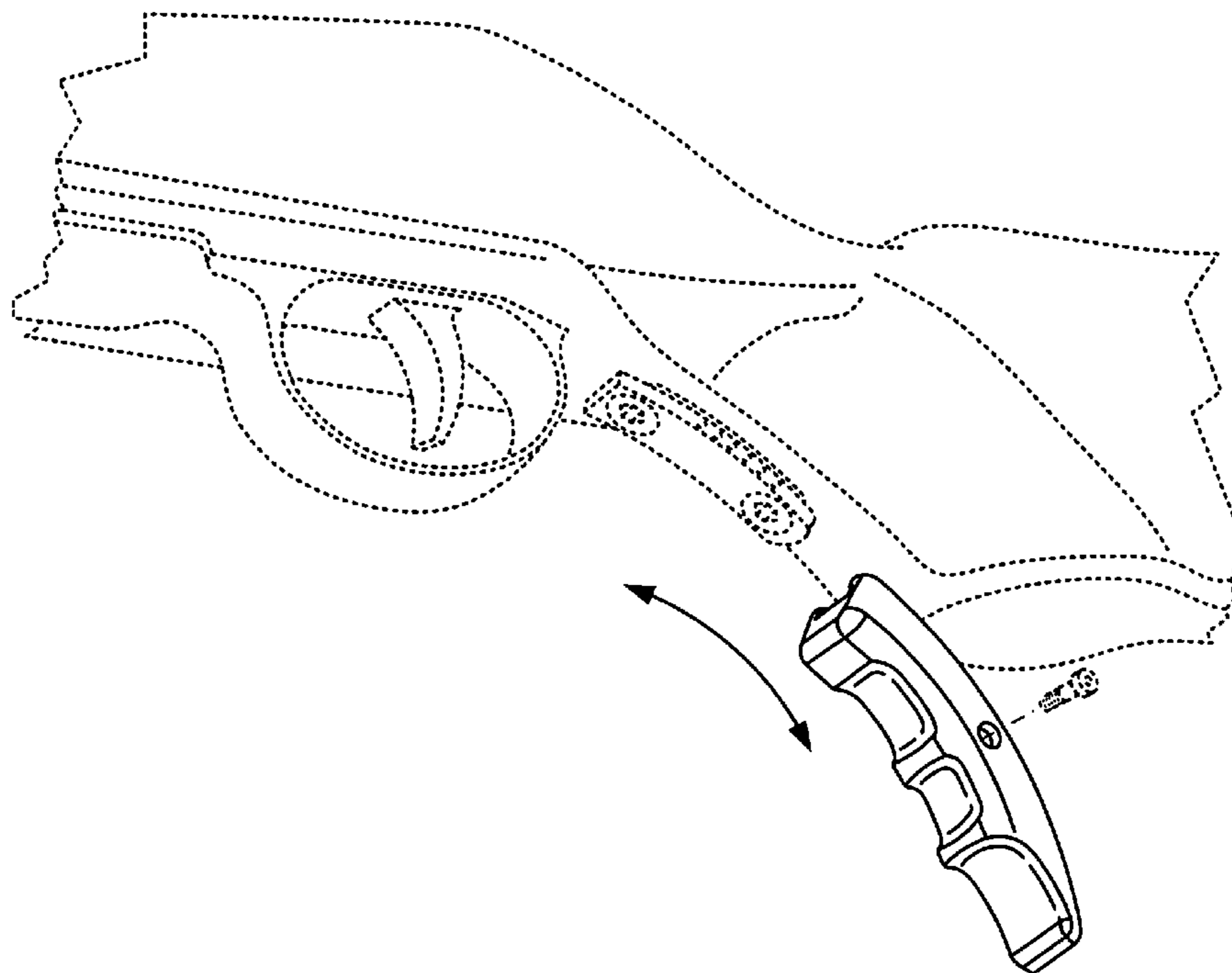
FIG. 4 is a top plan view of the adjustable grip for a firearm; FIG. 5 is a front elevational view of the adjustable grip for a firearm;

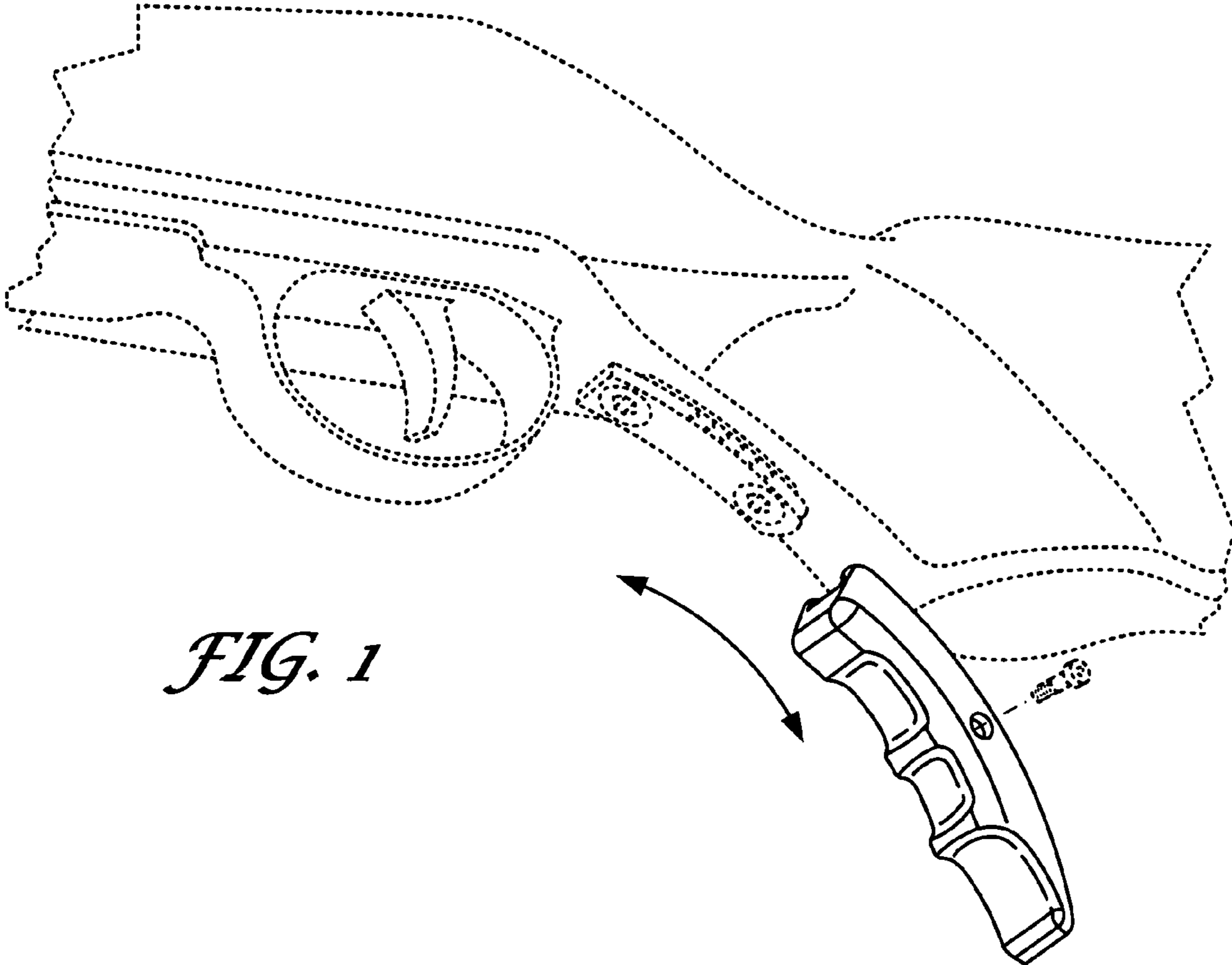
FIG. 6 is a rear elevational view of the adjustable grip for a firearm; and,

FIG. 7 is a bottom plan view of the adjustable grip for a firearm.

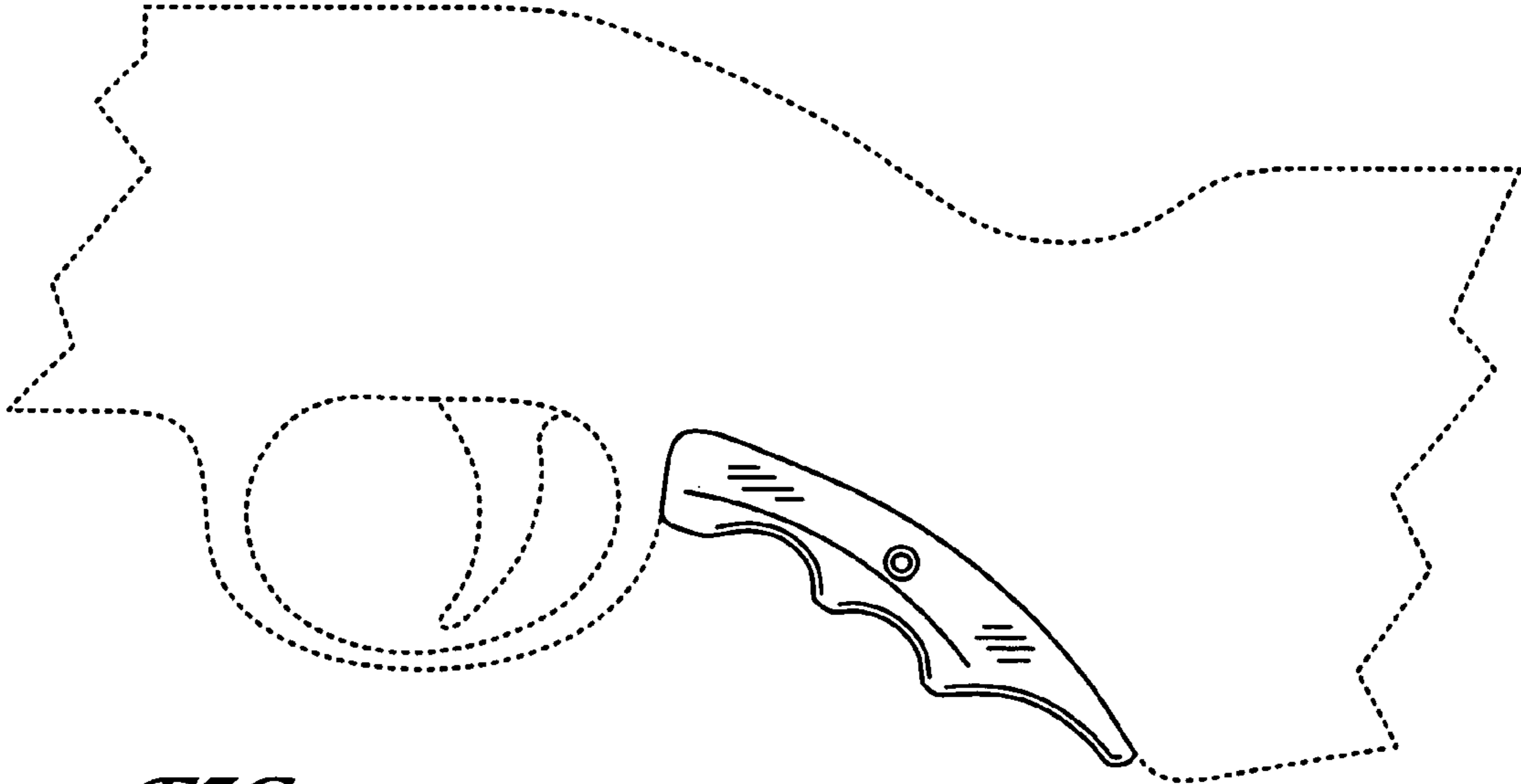
The broken lines depict environmental structure that forms no part of the claimed design.

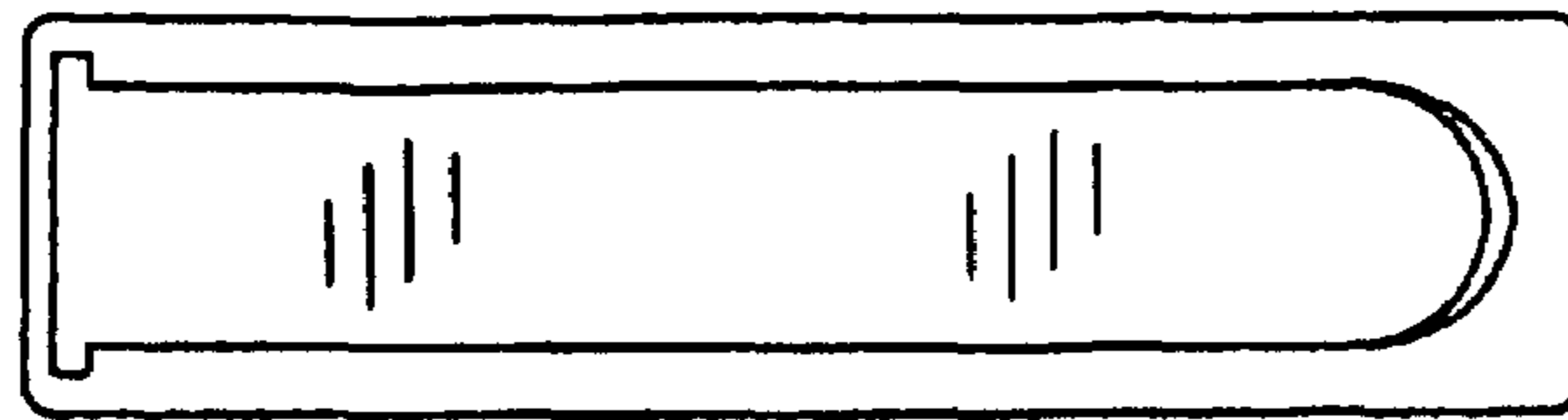




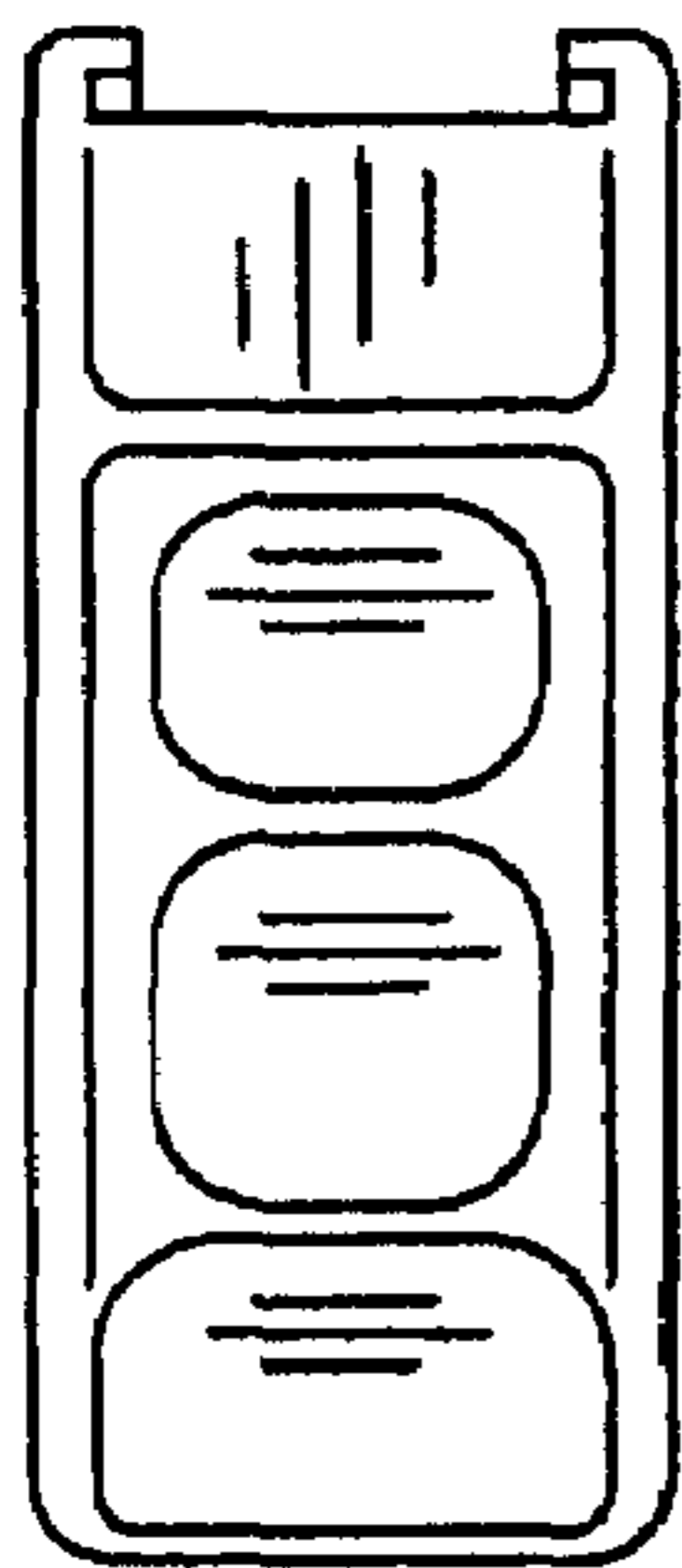

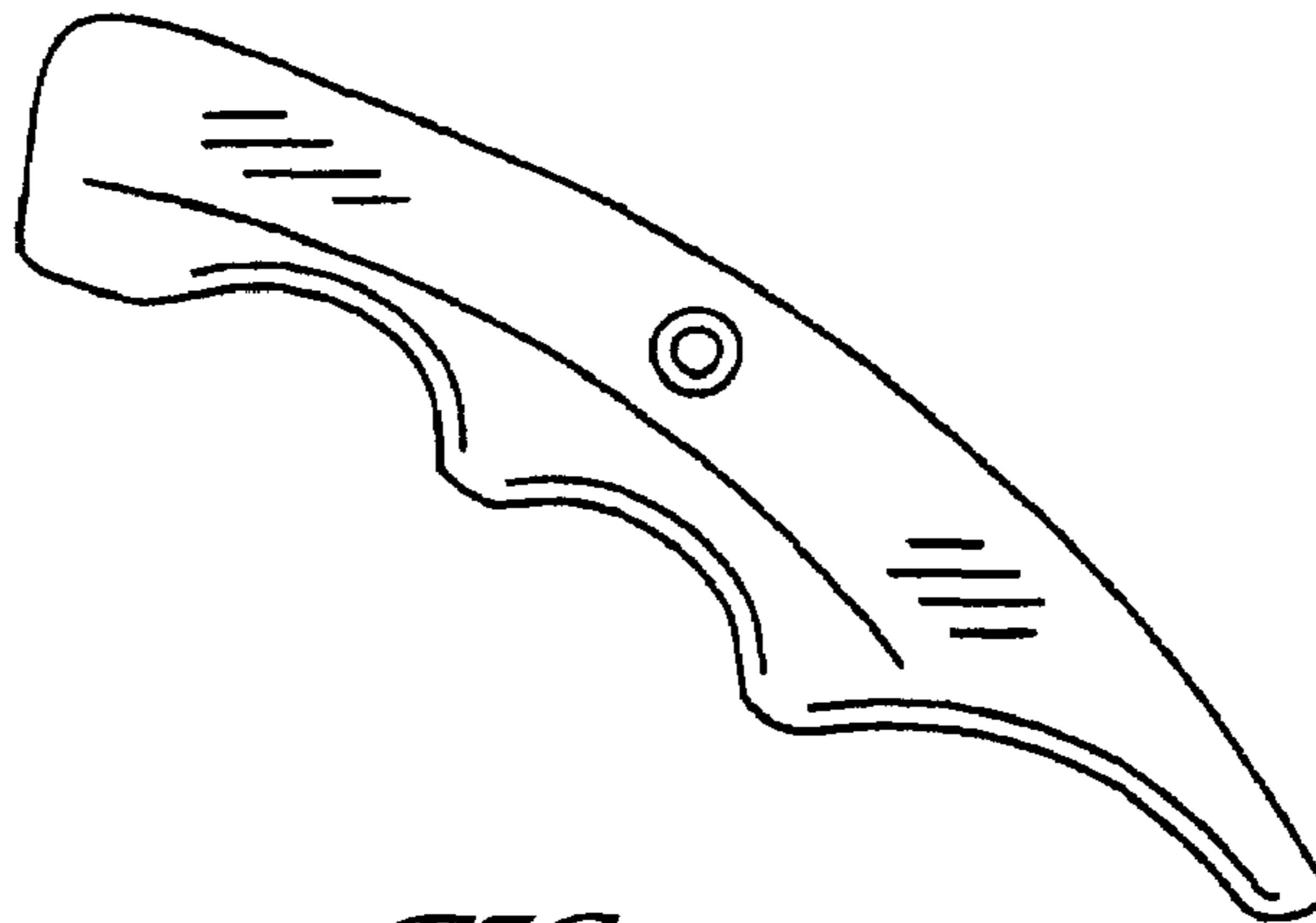

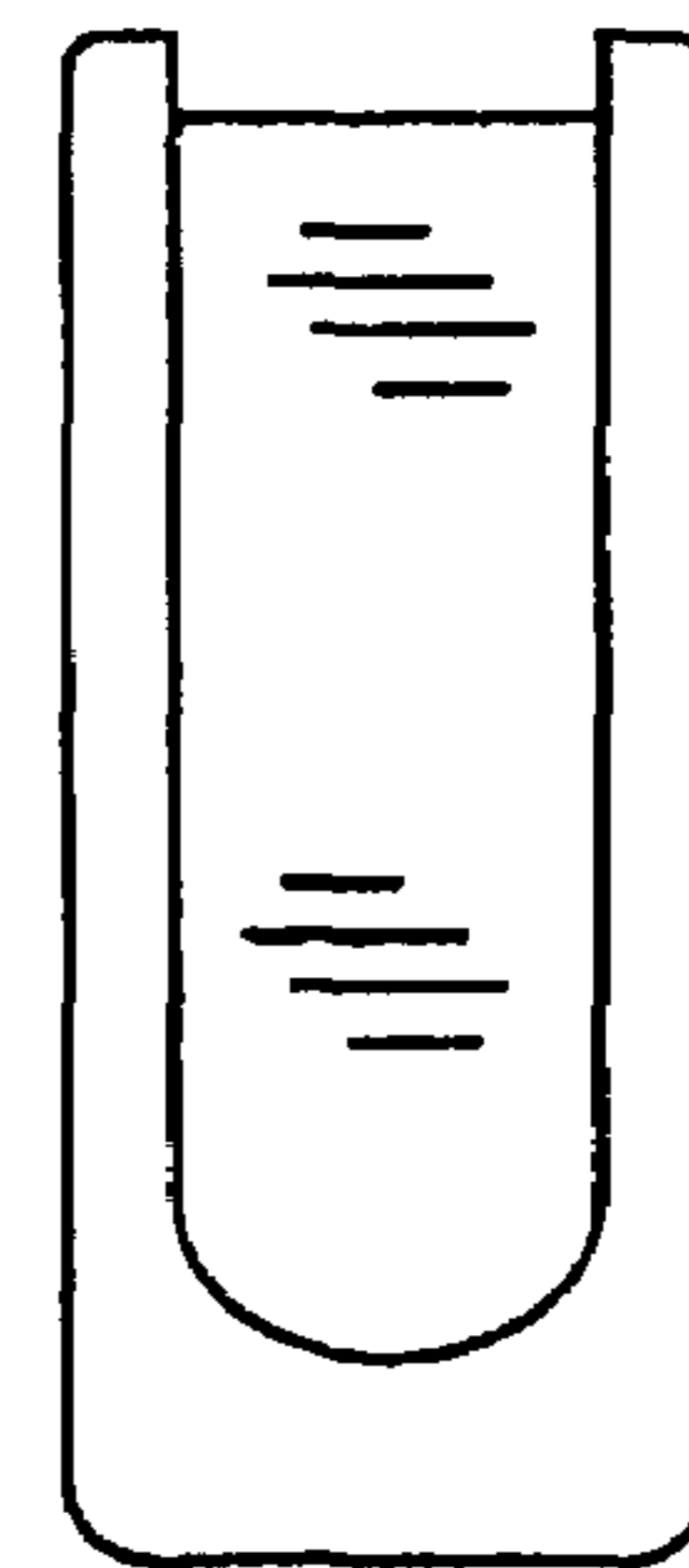

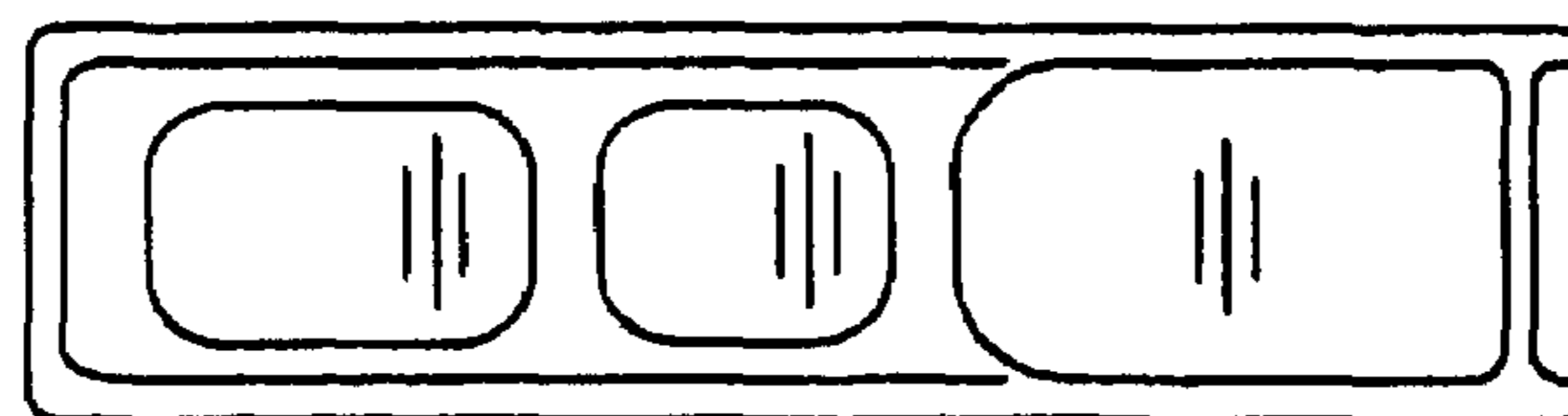
