The ornamental design for a dual function insulated floor and roof panel with angled ends, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a dual function insulated floor and roof panel with angled ends showing my new design;

FIG. 2 is a bottom, rear and right side perspective view thereof;


FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;


FIG. 5 is a front elevational view thereof, the rear elevational view being a mirror image of the front elevational view;

FIG. 6 is a top plan view thereof; and,


FIG. 7 is a bottom plan view thereof.






