FIG. 1 is a bottom perspective view of a lighting fixture;

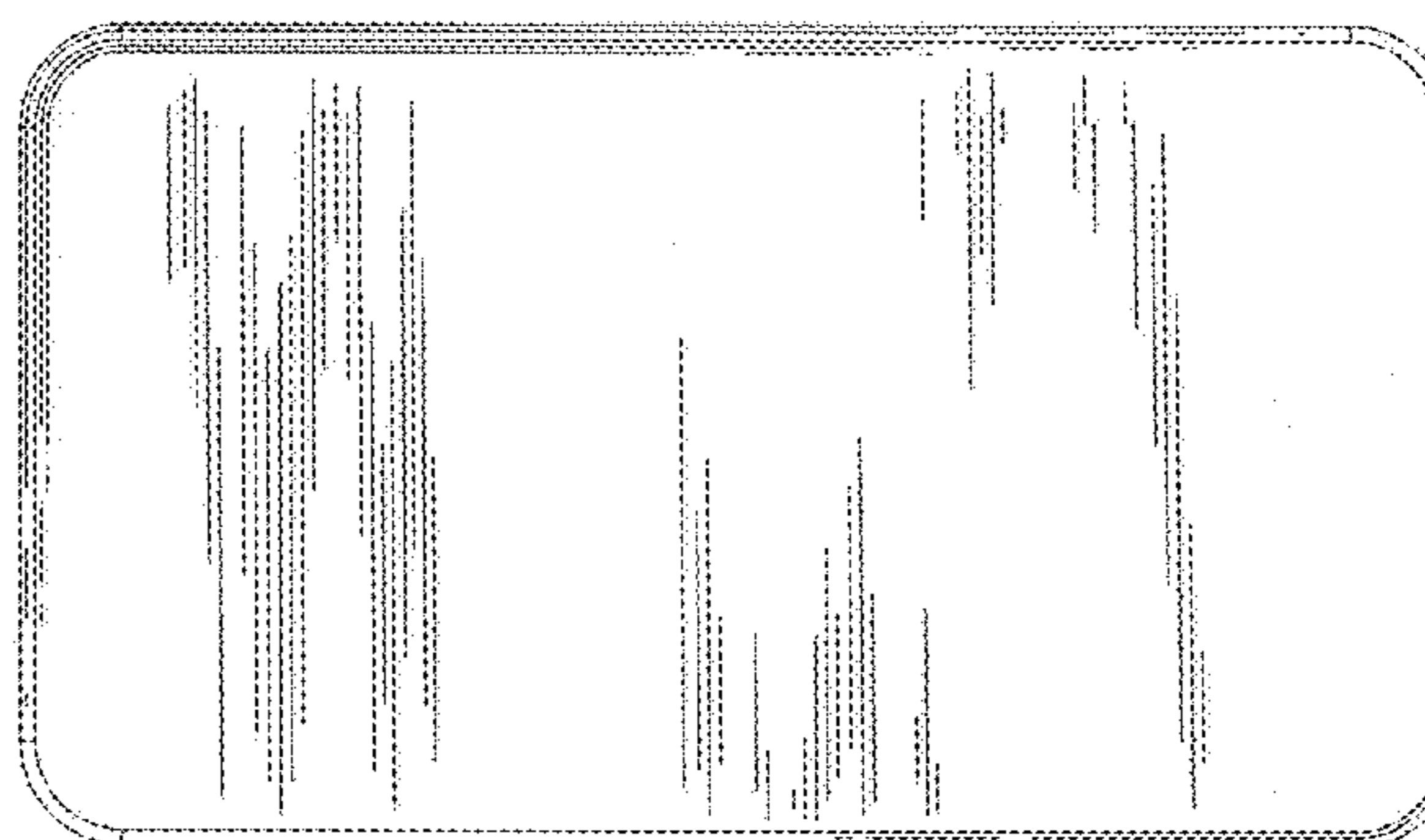
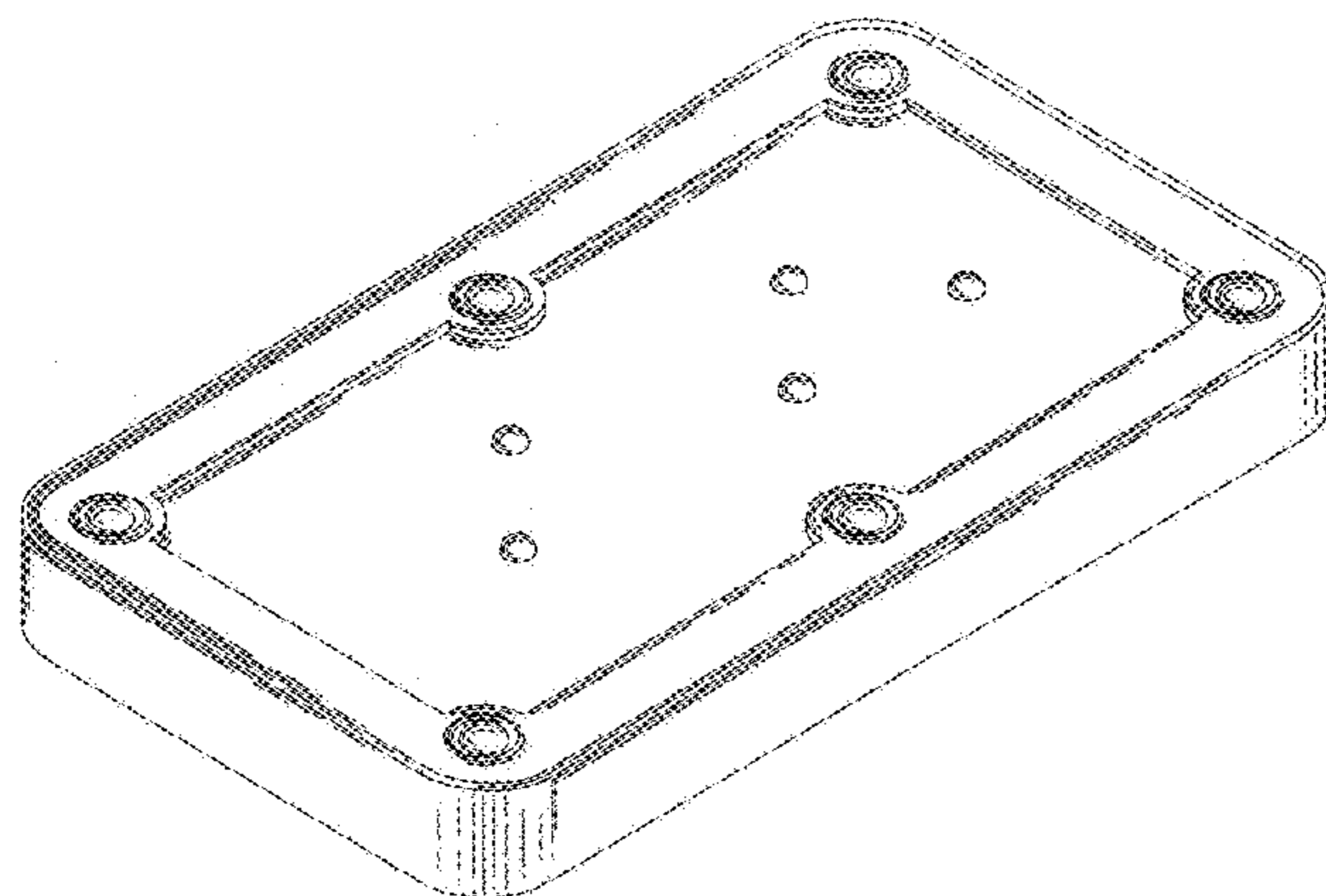
FIG. 2 is a bottom plan view of a lighting fixture;

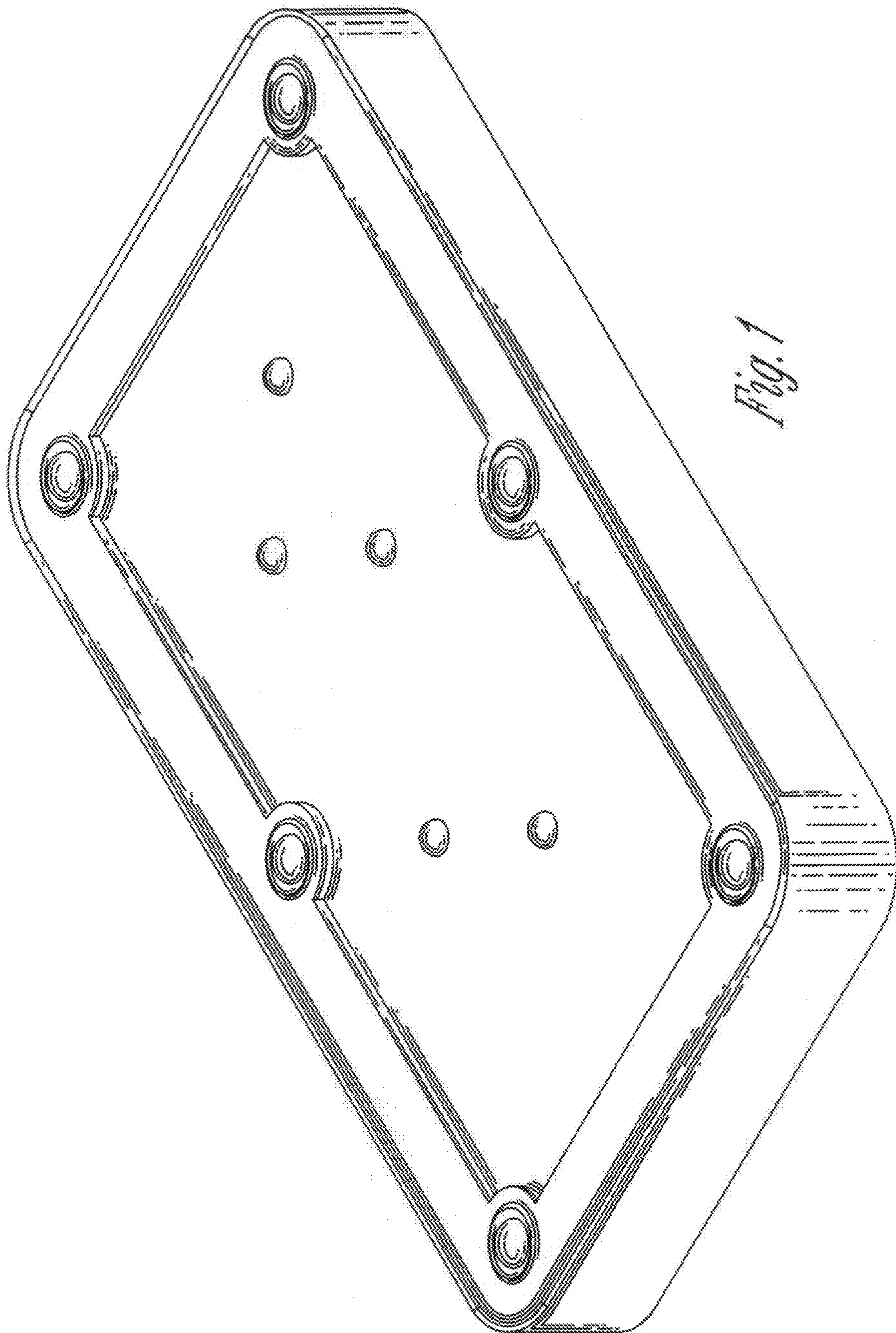

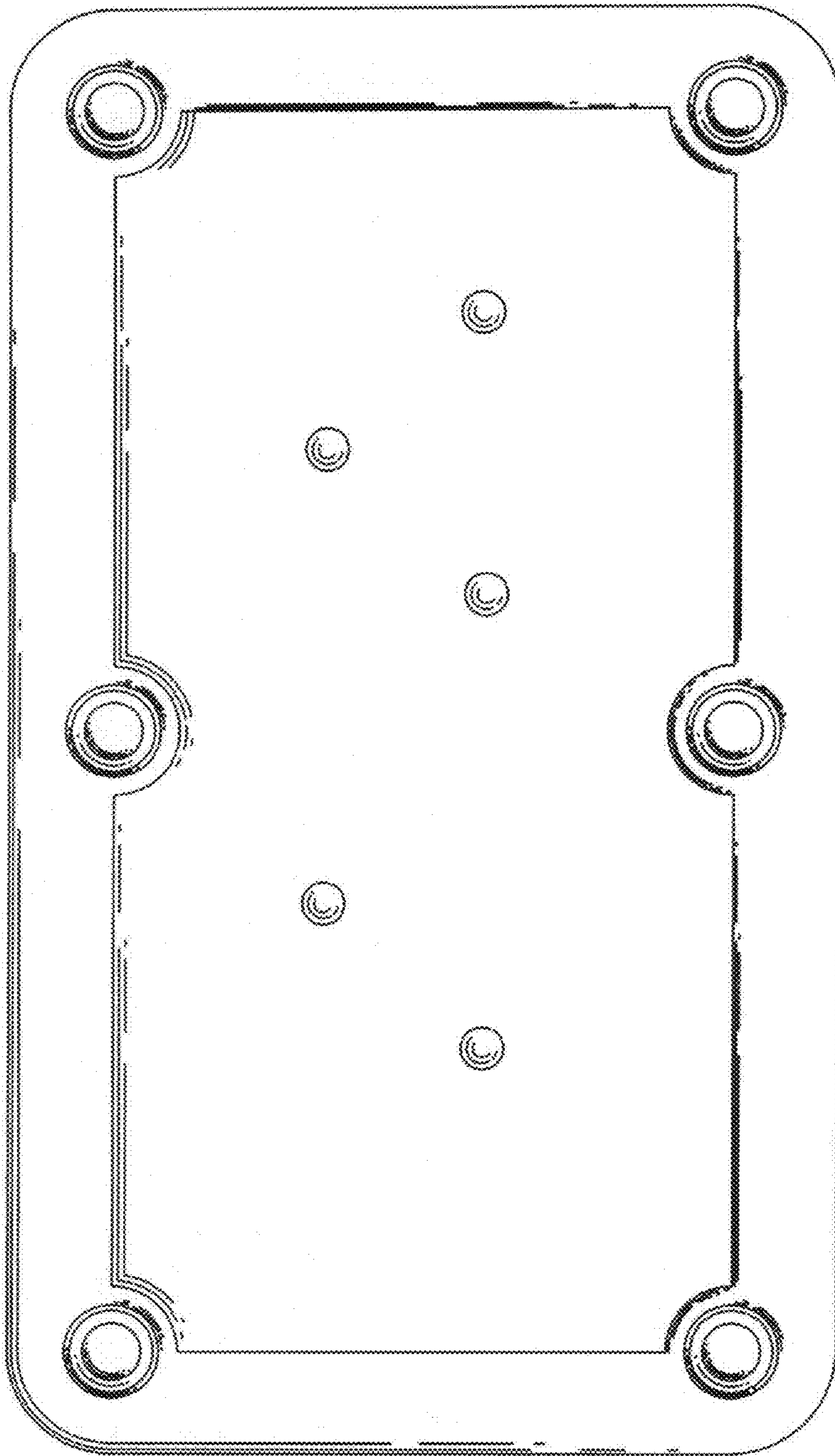

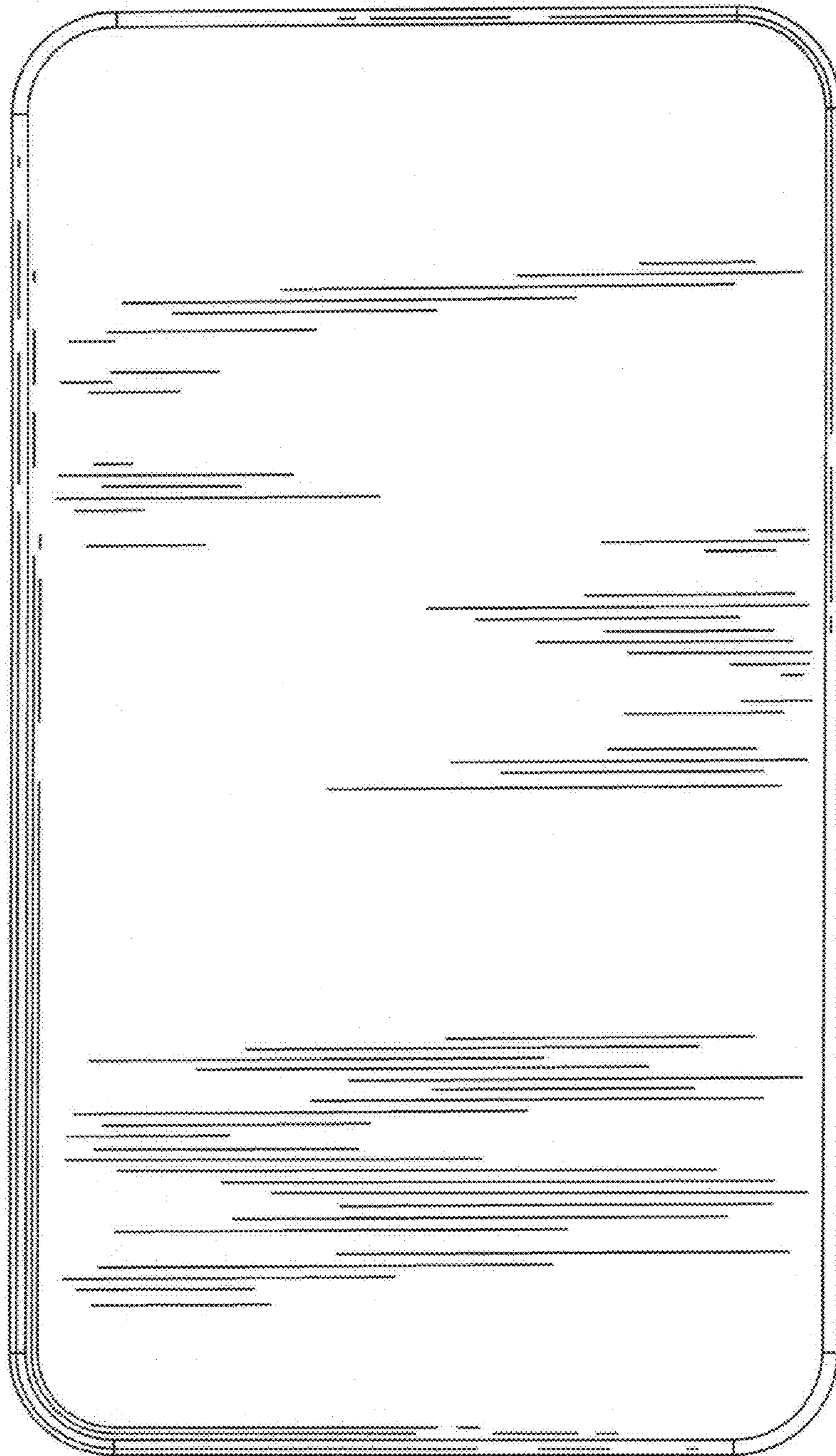

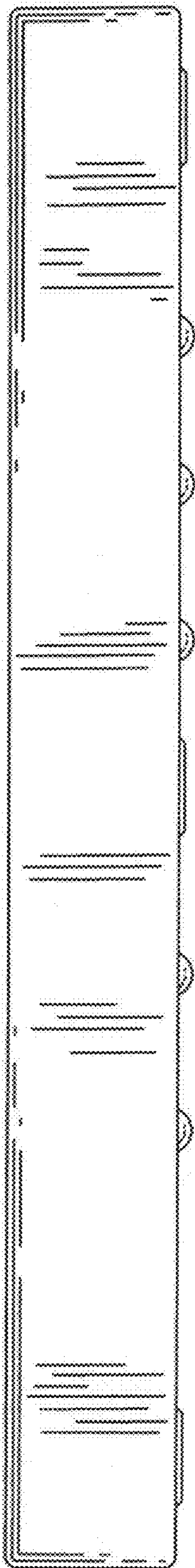

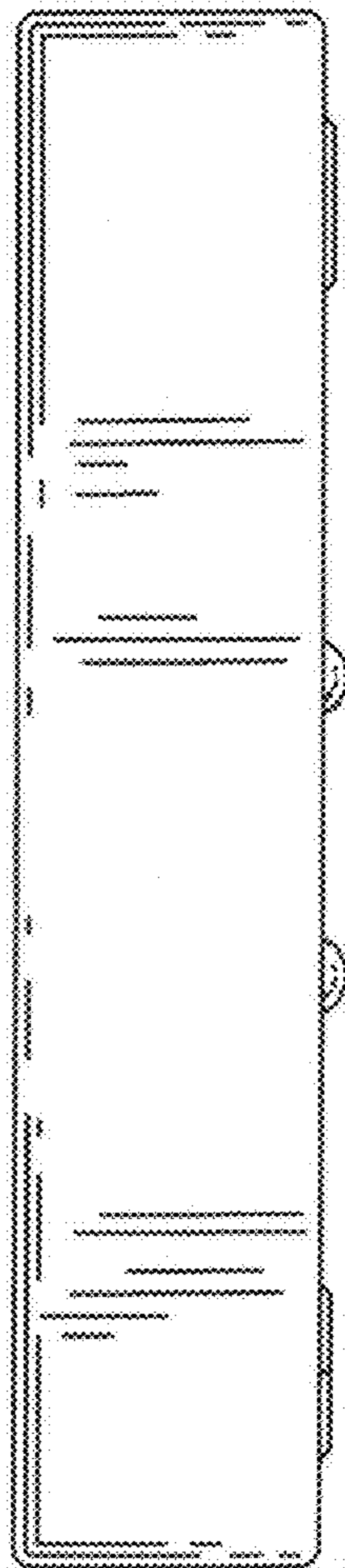
