**DESCRIPTION**

FIG. 1 is a perspective view of the lotion applicator shown in use;

FIG. 3 is a top view thereof;

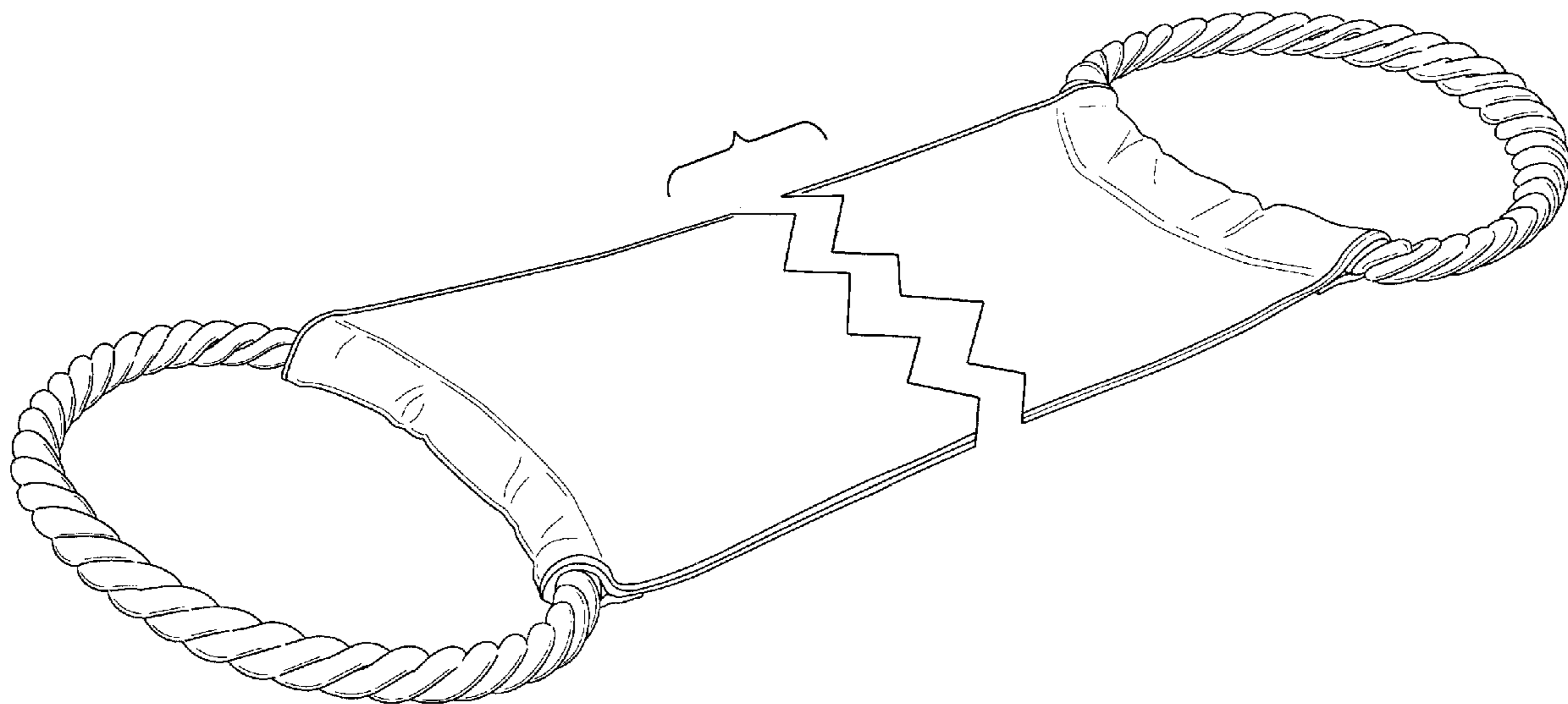
FIG. 4 is a right end view, the left end view being a mirror image thereof; and,

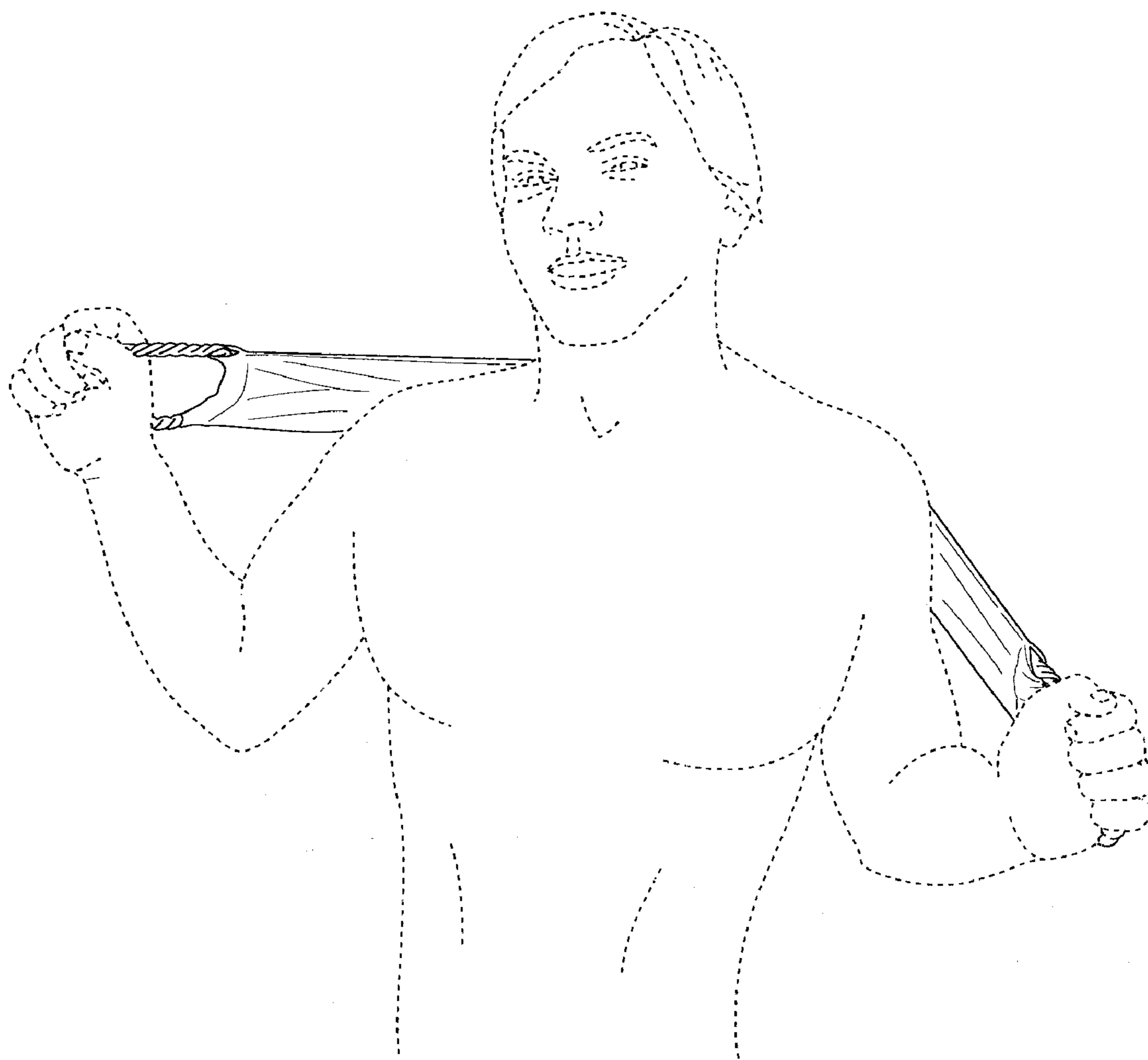
FIG. 5 is a right side view, the left side view being a mirror image thereof.

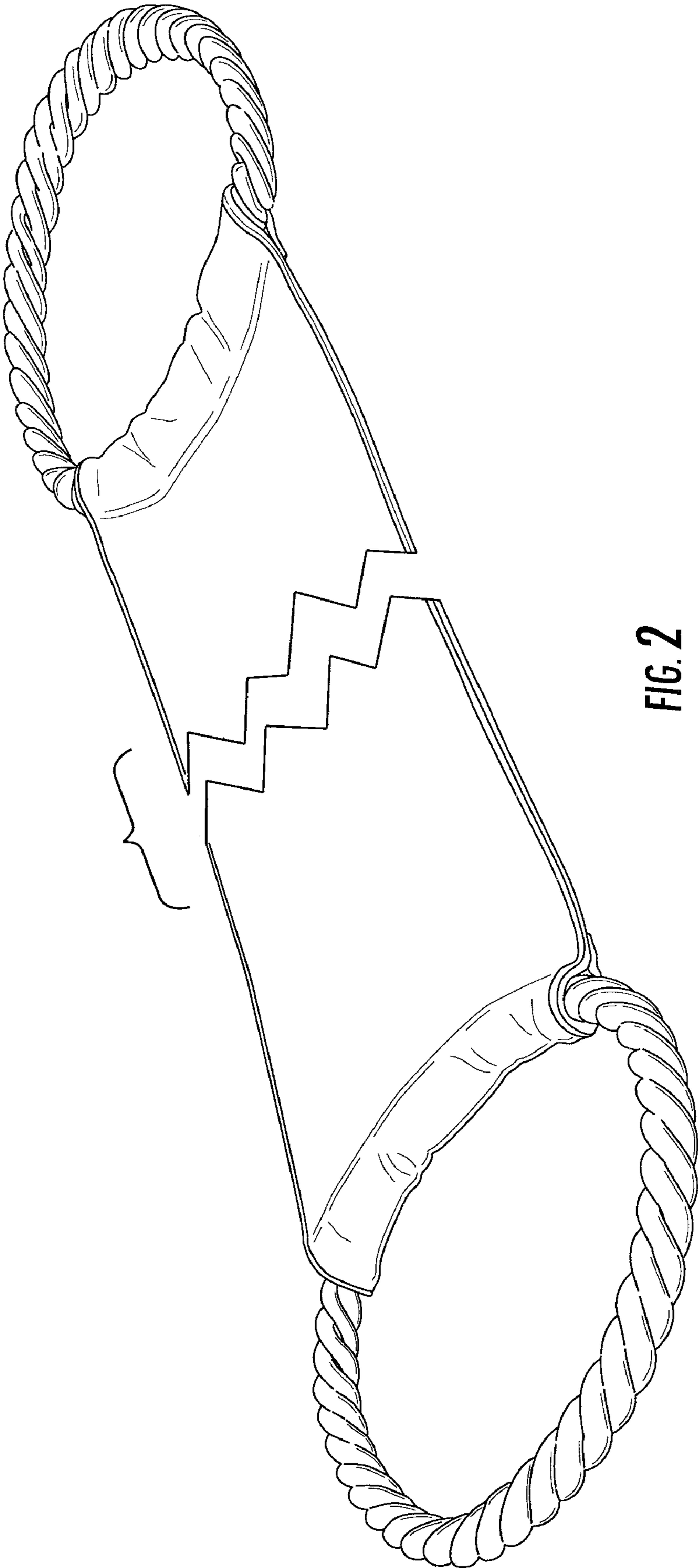

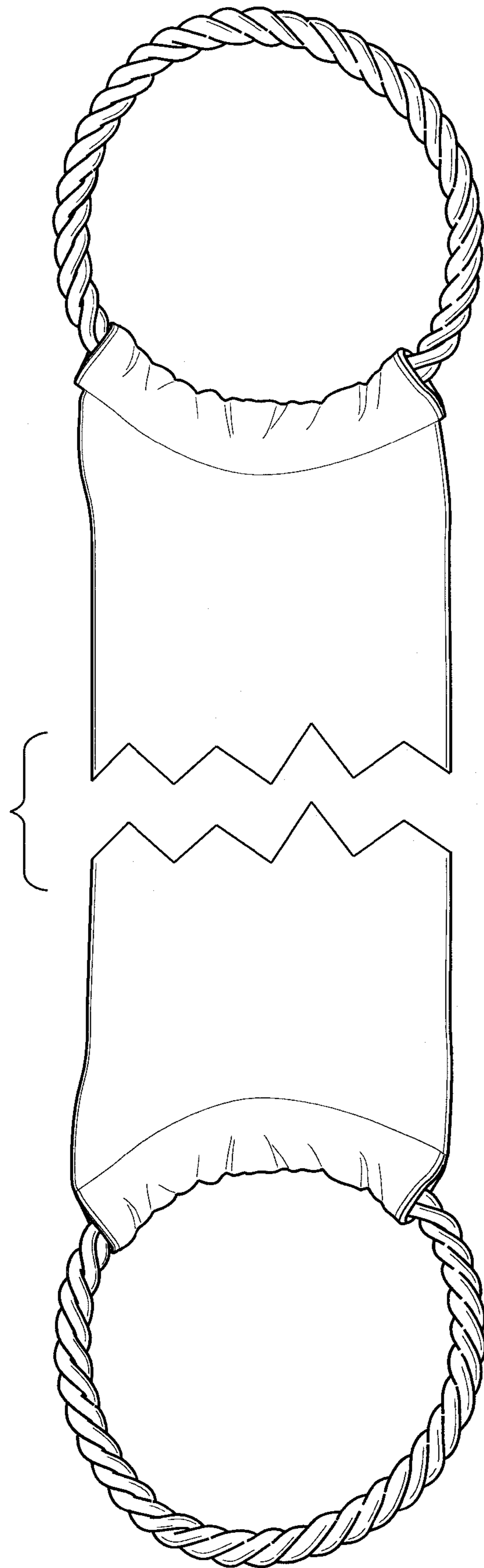

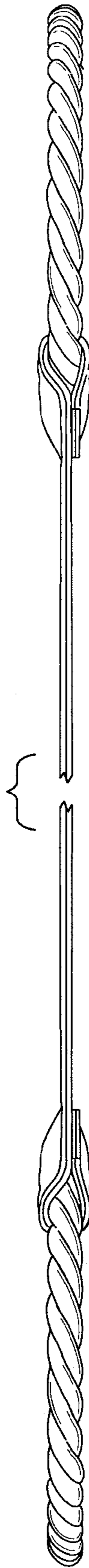
