FIG. 3 is a rear view of the shaving razor handle;

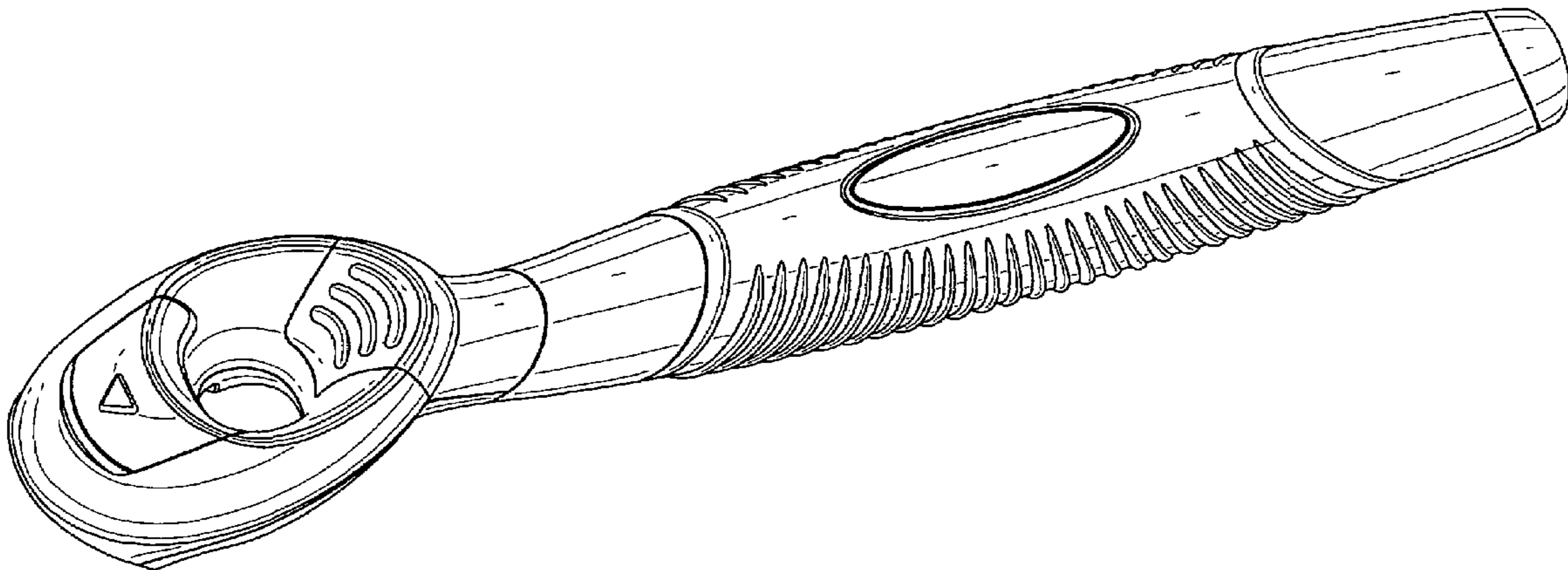
FIG. 4 is a side view of the shaving razor handle;

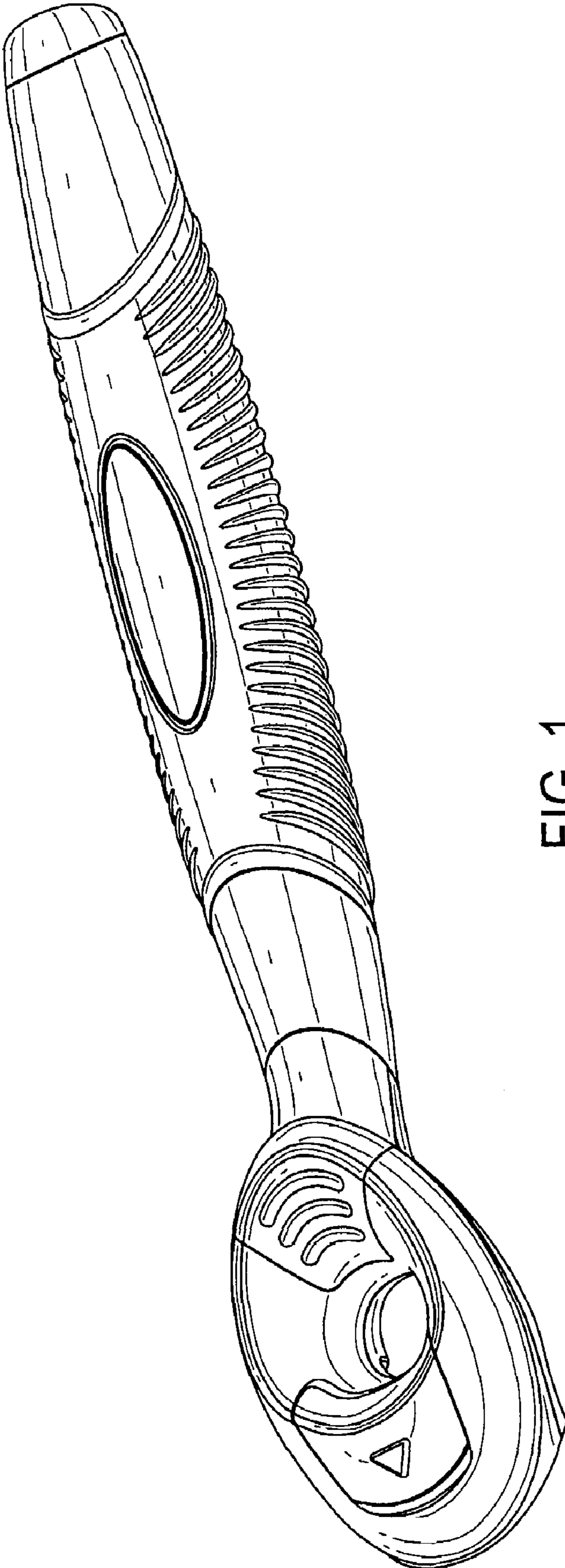

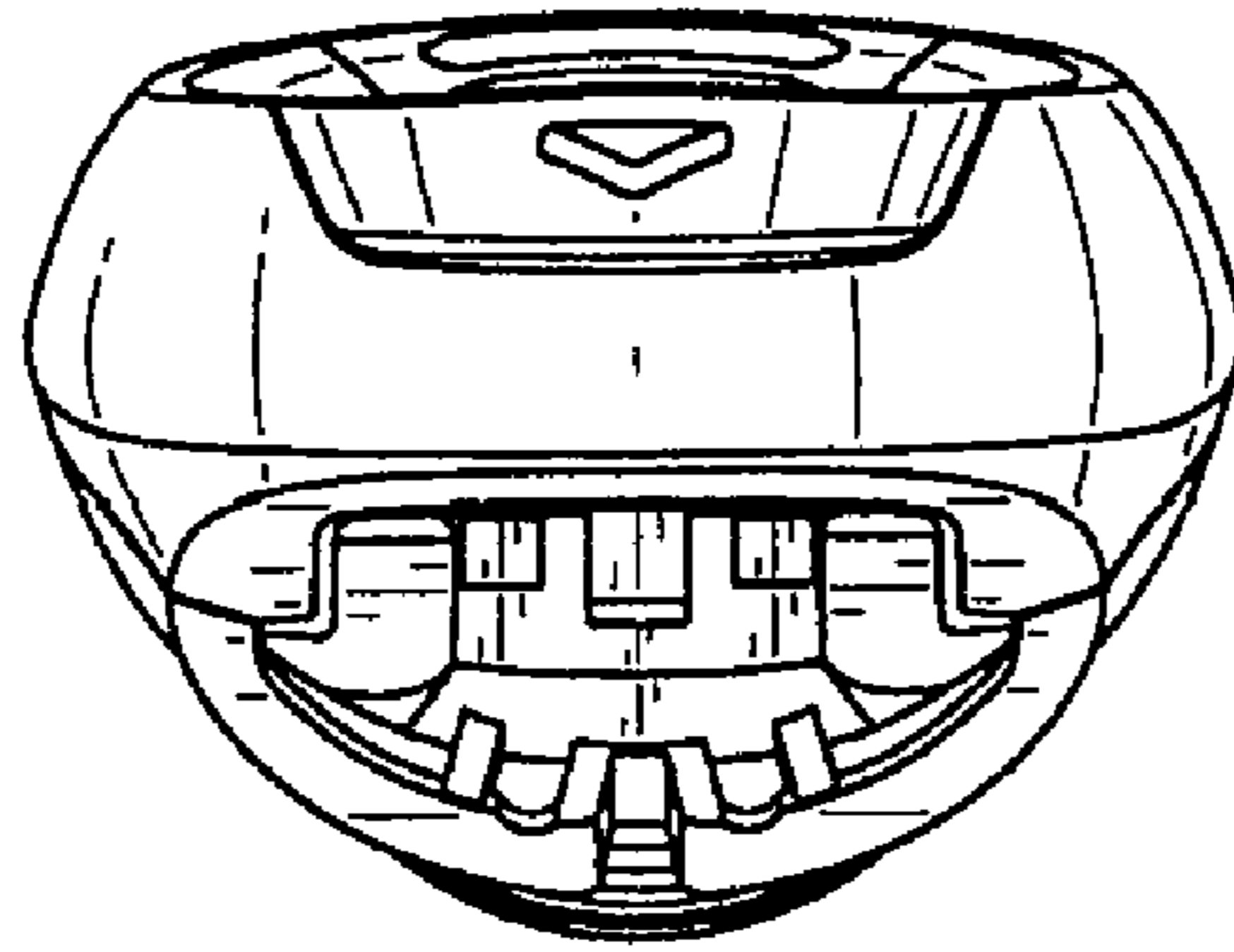

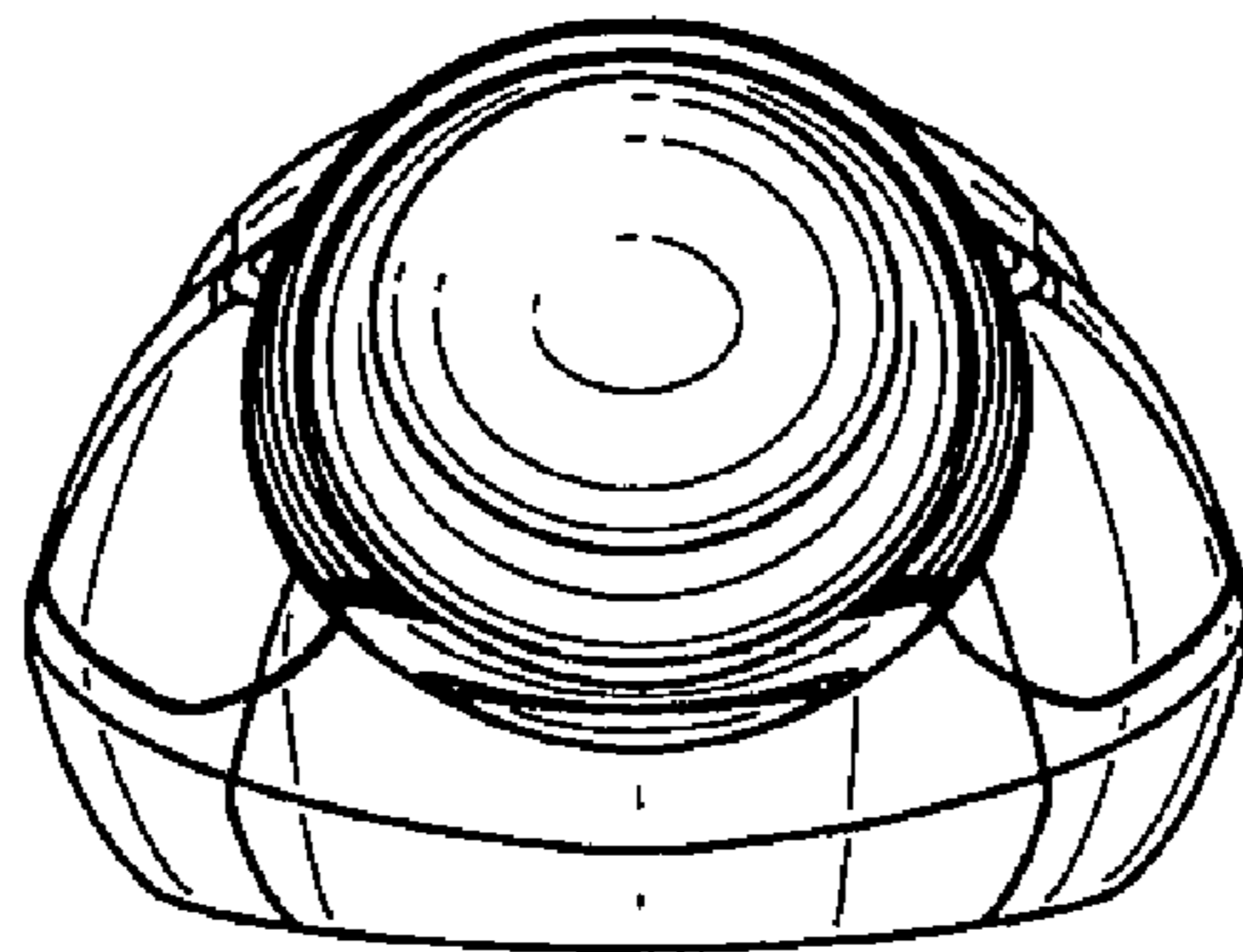

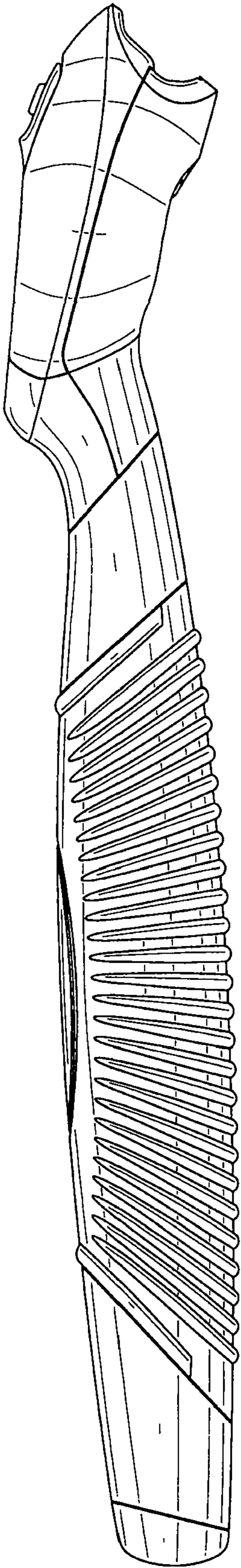

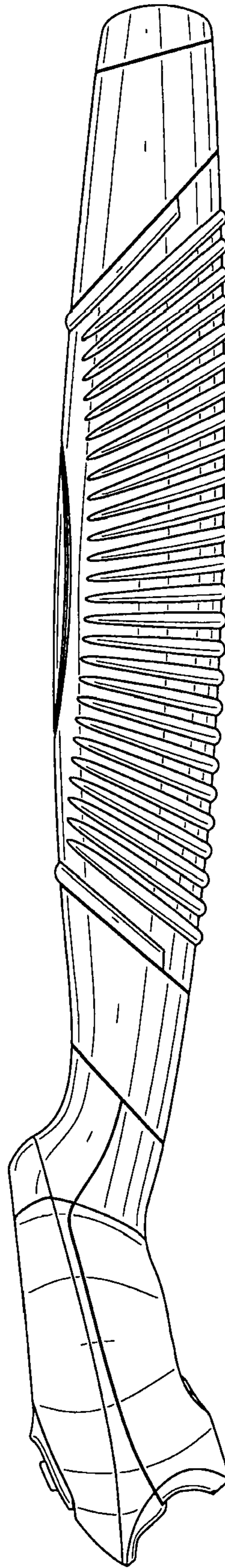

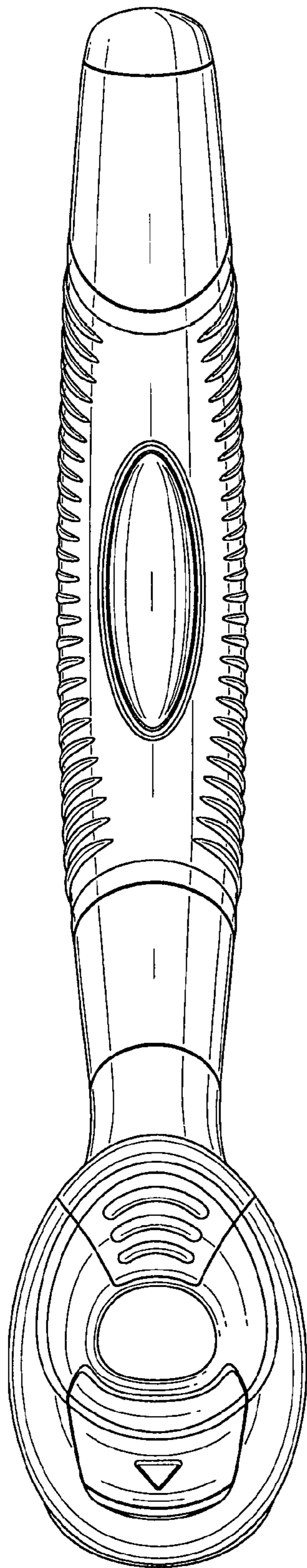

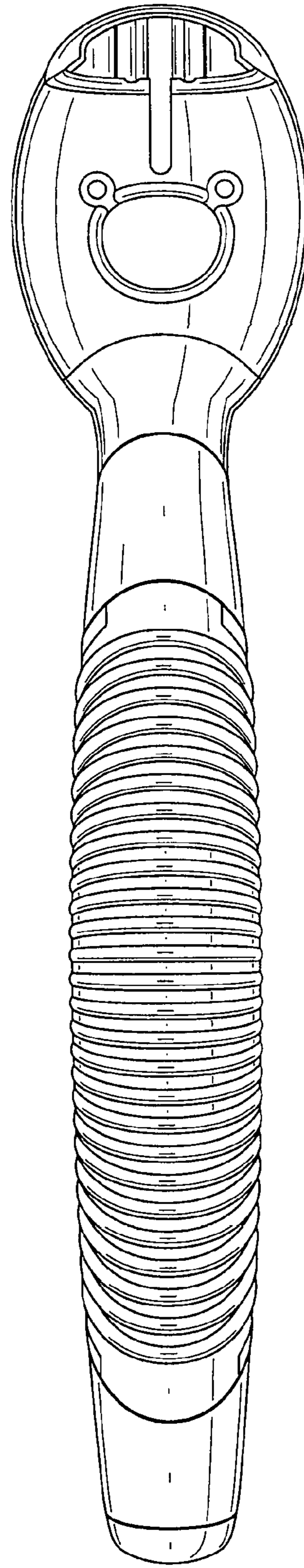
