FIG. 3 is a left side view of the edible fruit sheet of FIG. 1;

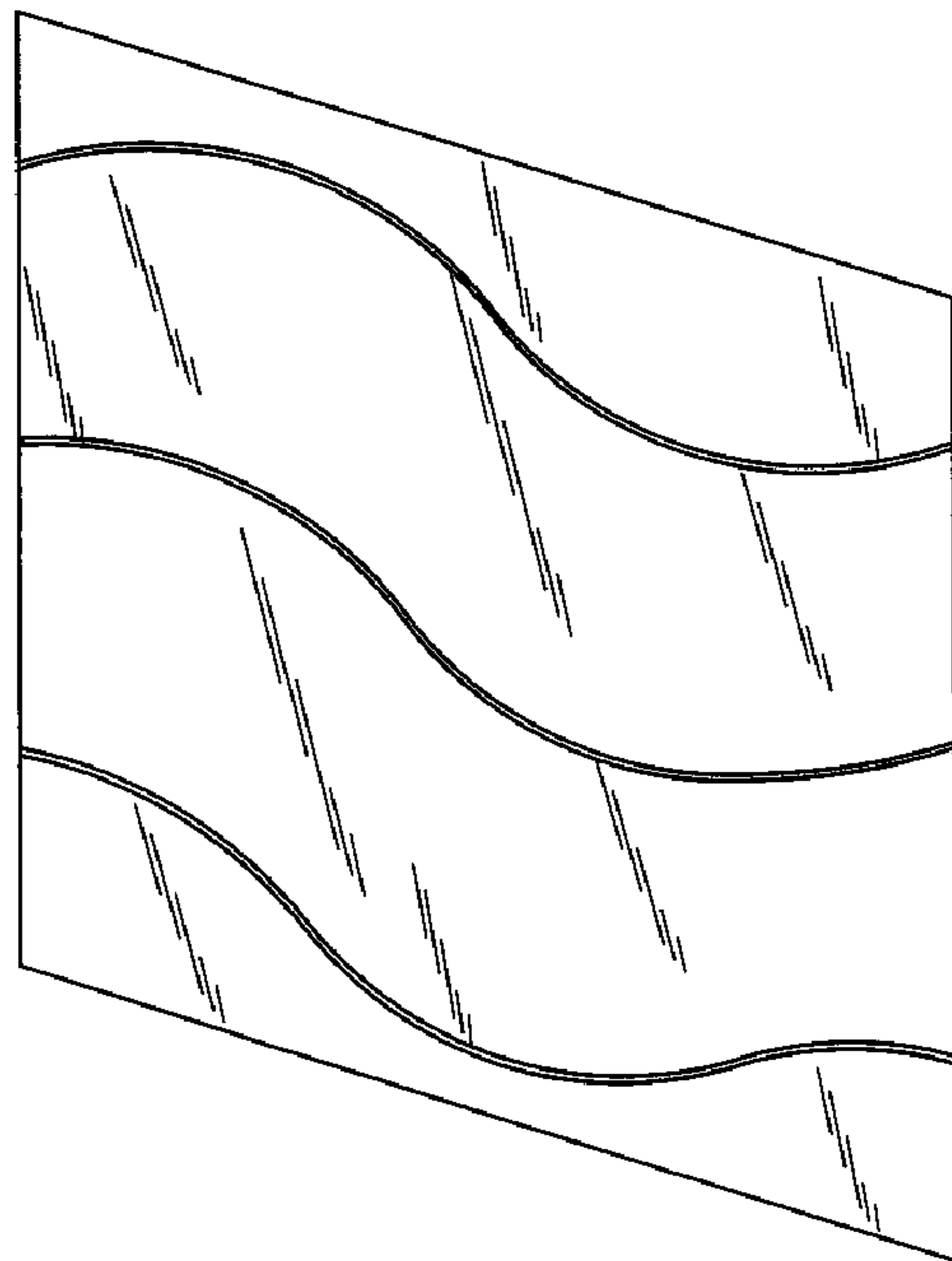
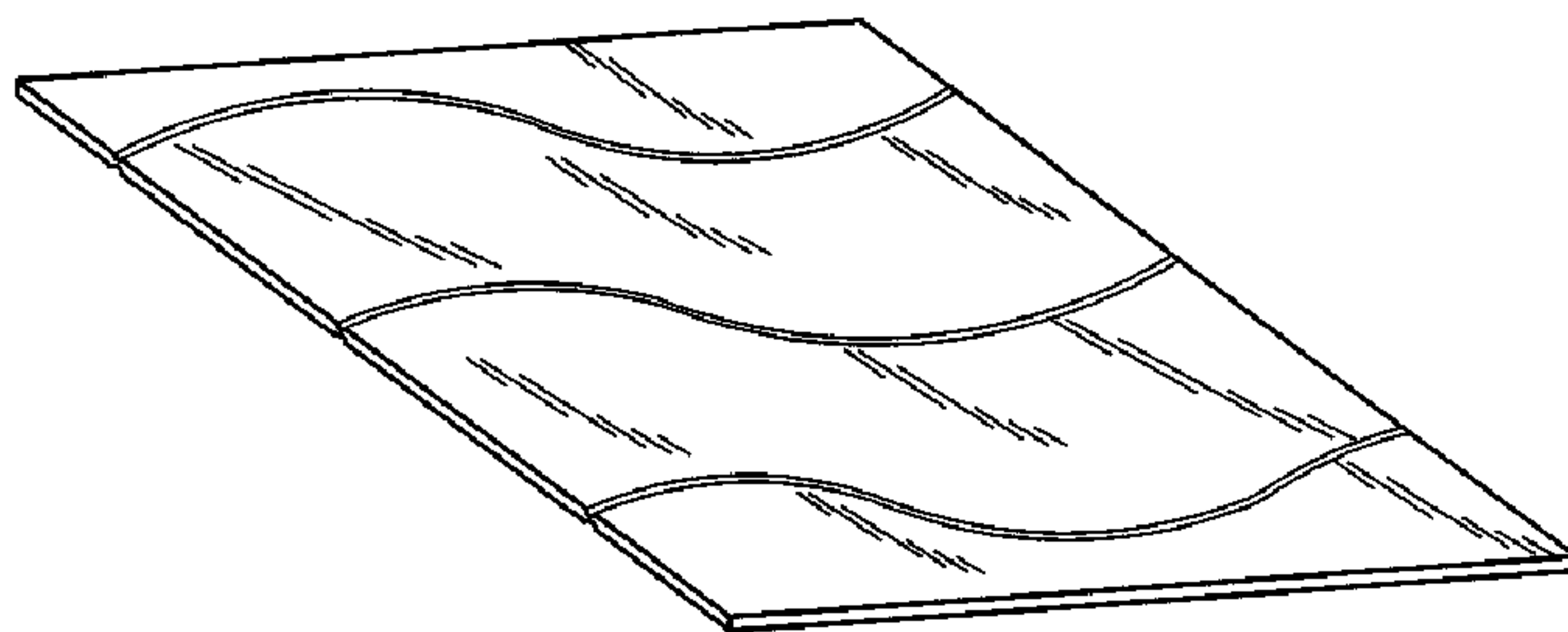
FIG. 4 is a top end view of the edible fruit sheet of FIG. 1;

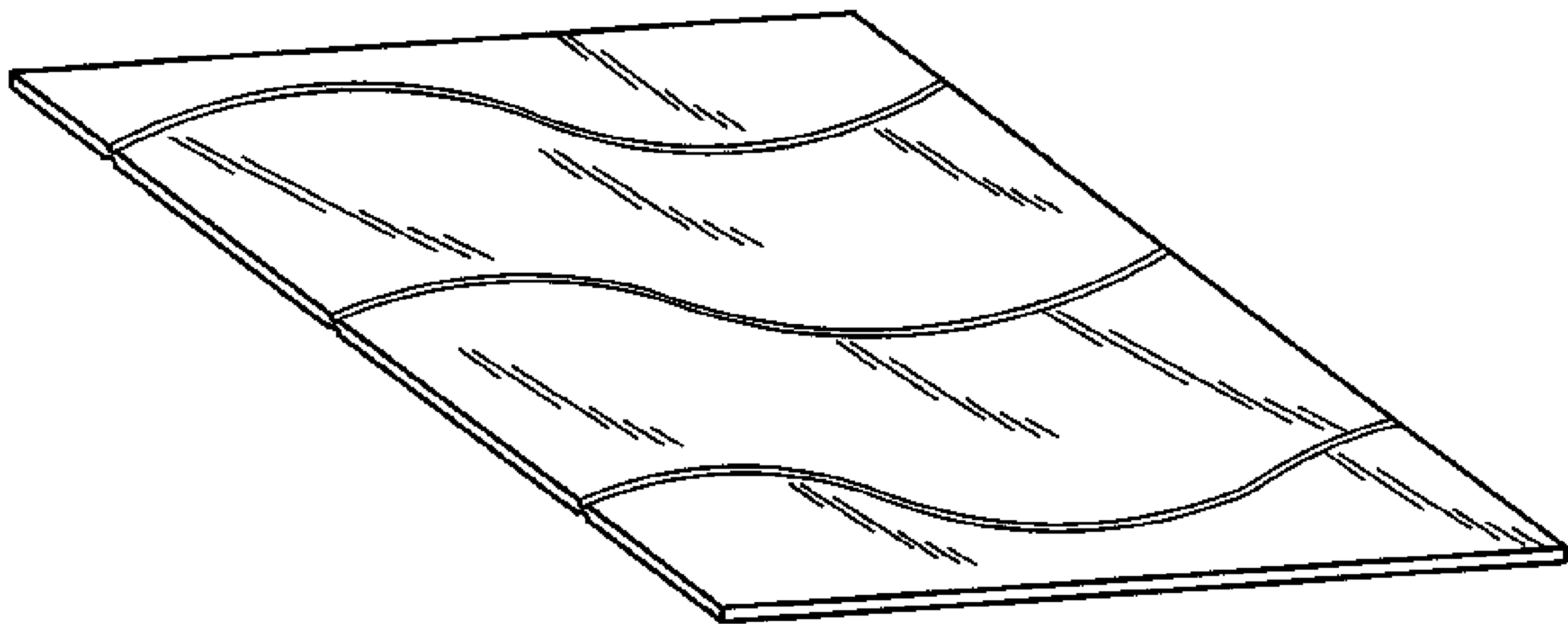
FIG. 5 is a bottom end view of the edible fruit sheet of FIG. 1;

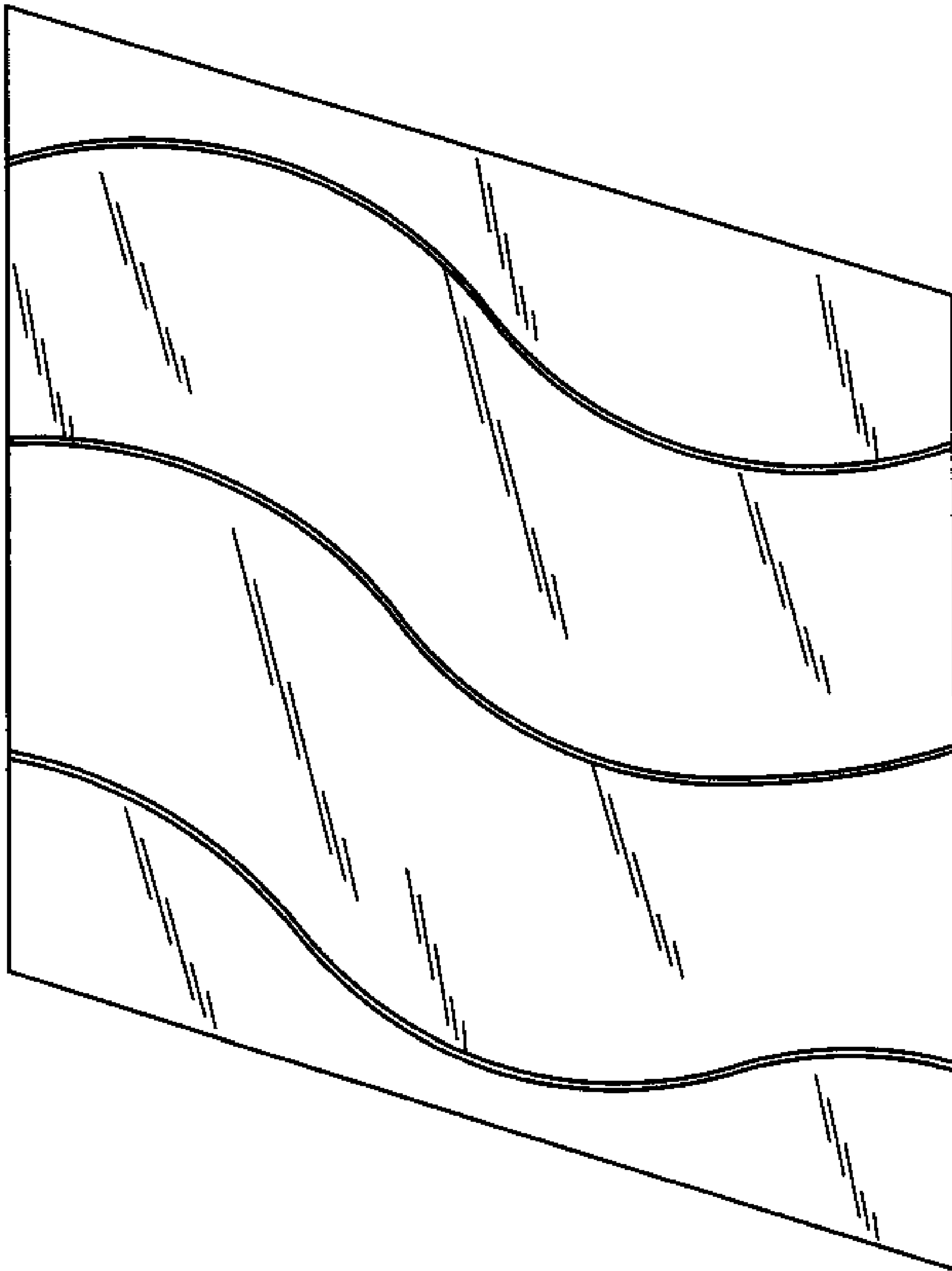

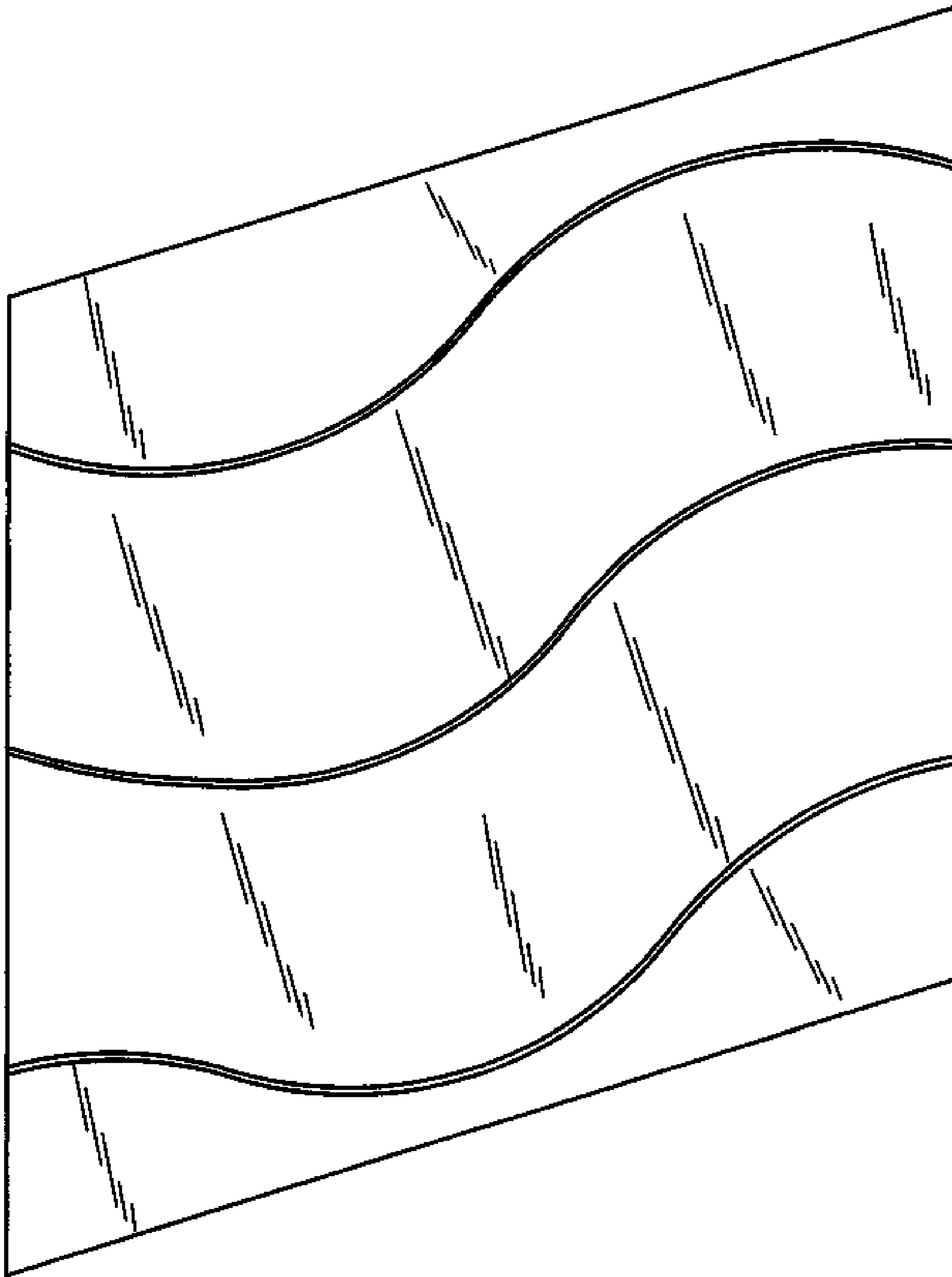
