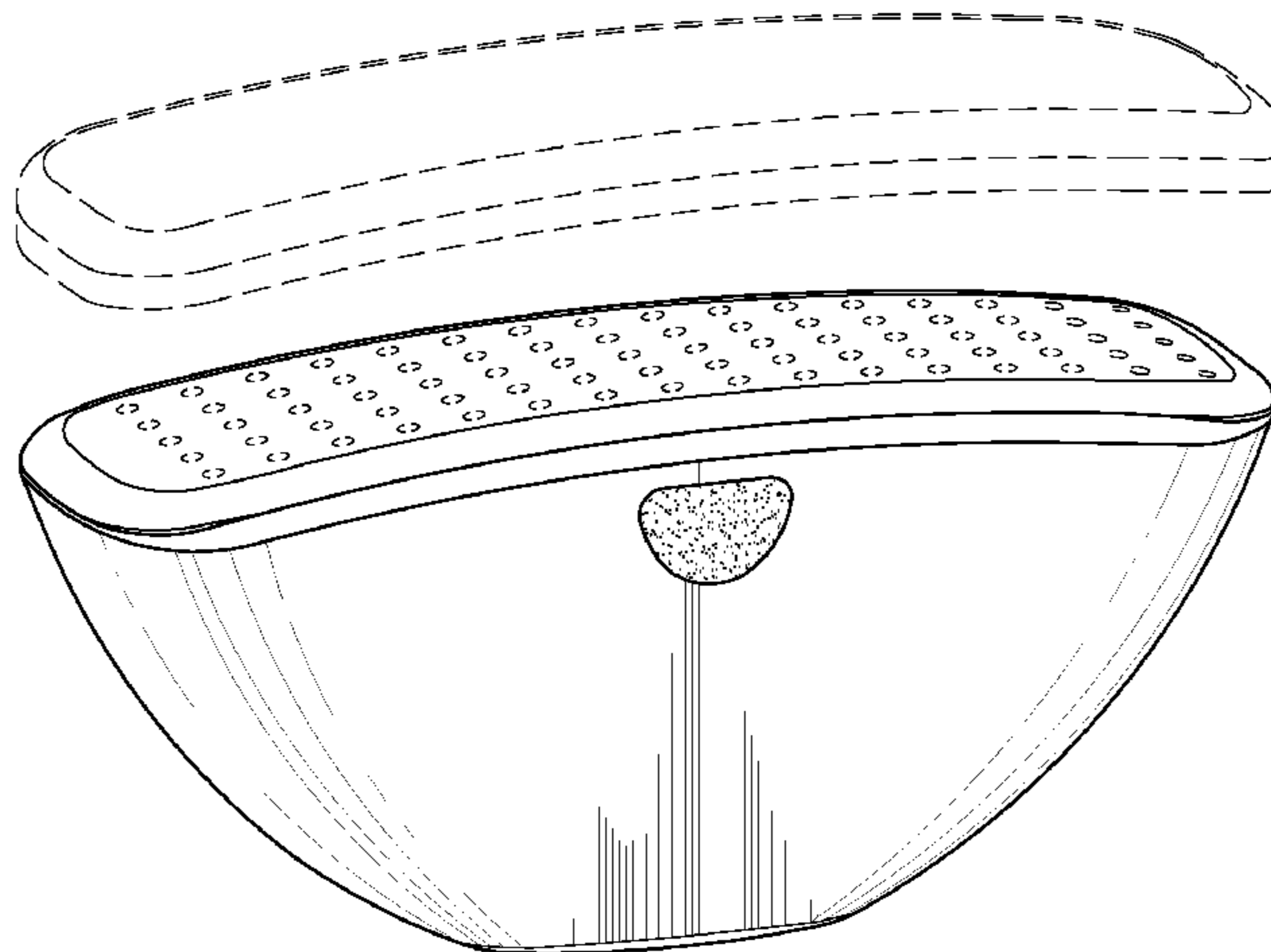
(57) **CLAIM**

We claim the ornamental design for a zester, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a zester according to the new design;  
FIG. 2 is a front view of a zester shown in FIG. 1;  
FIG. 3 is a top view of a zester shown in FIG. 1;  
FIG. 4 is a rear view of the zester shown in FIG. 1;  
FIG. 5 is a bottom view of a zester shown in FIG. 1;

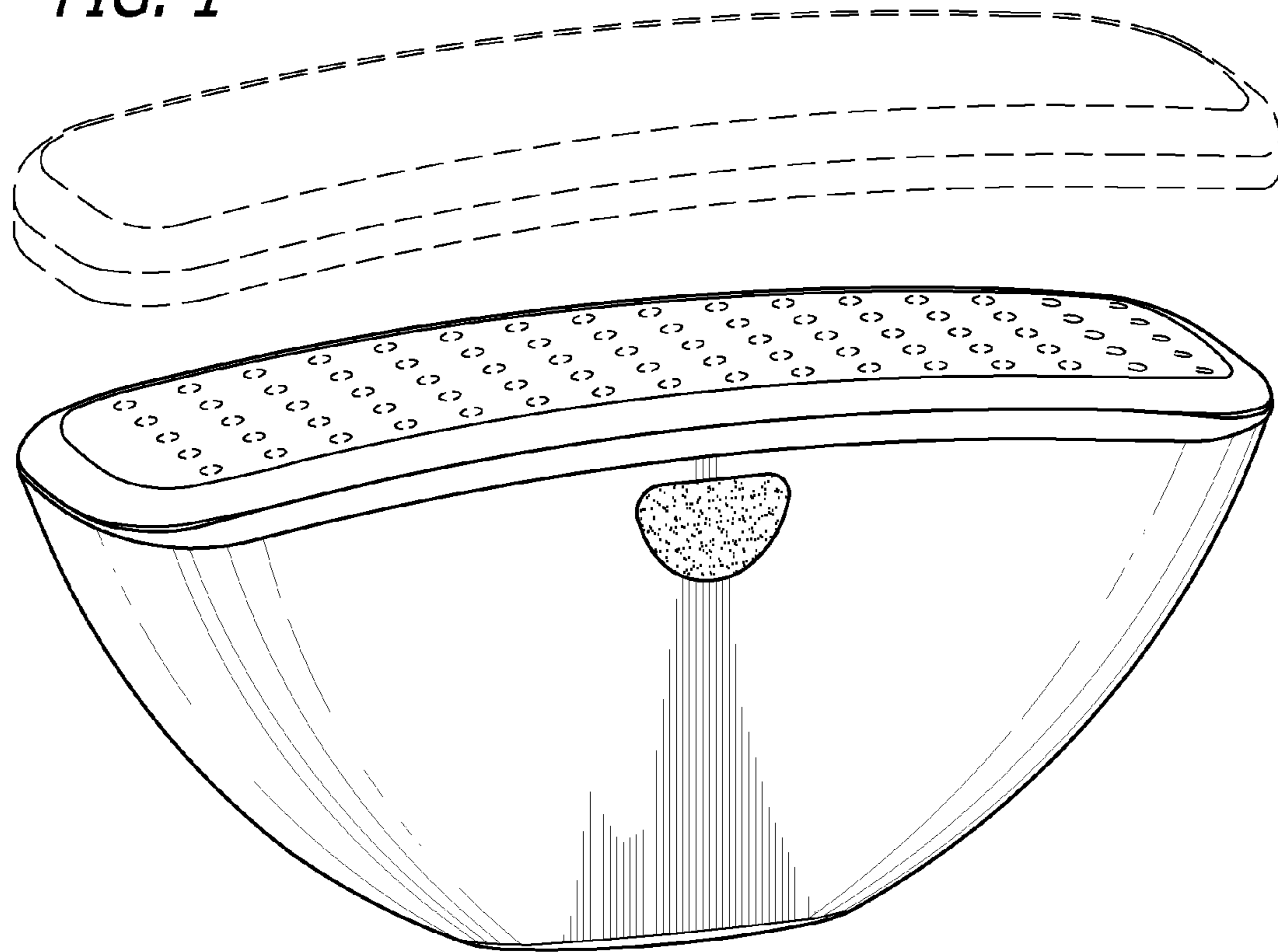

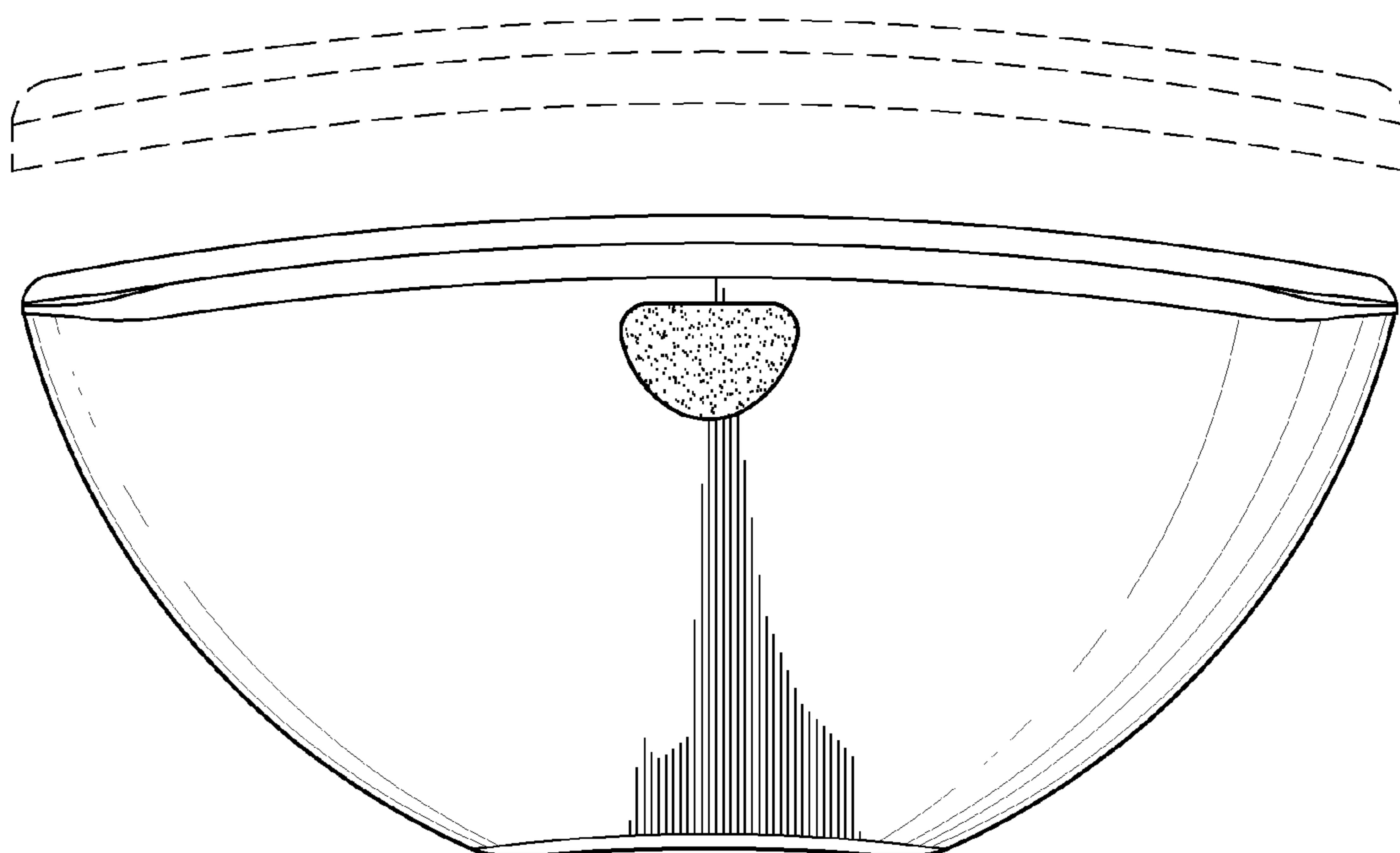

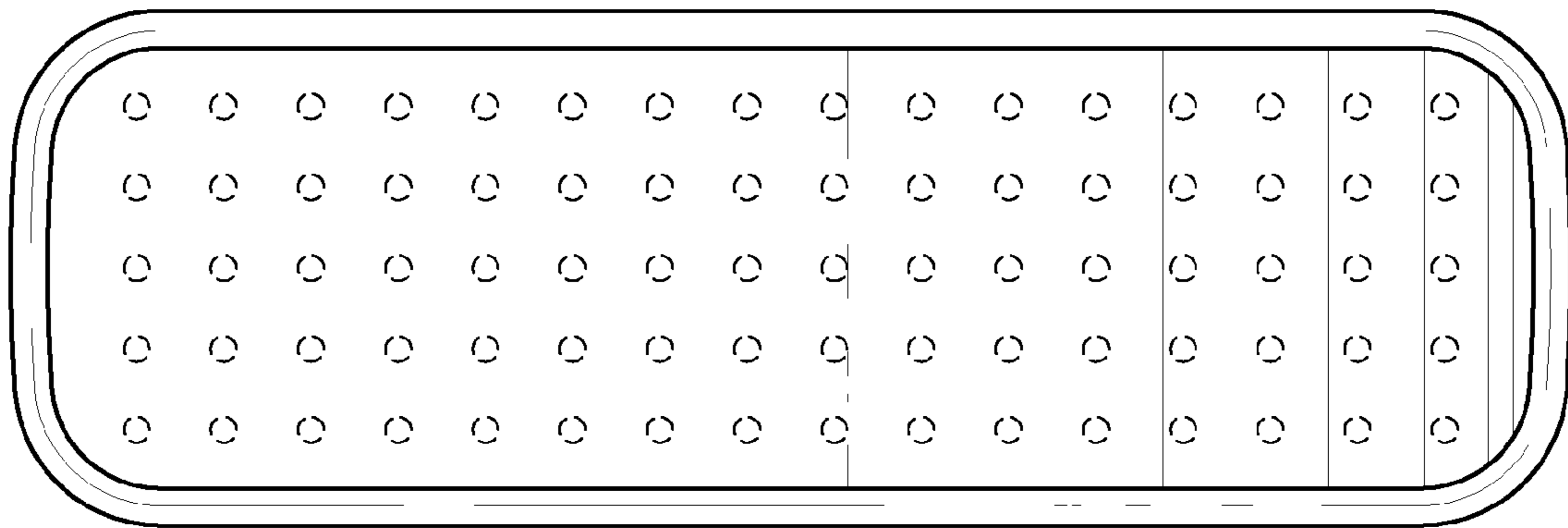

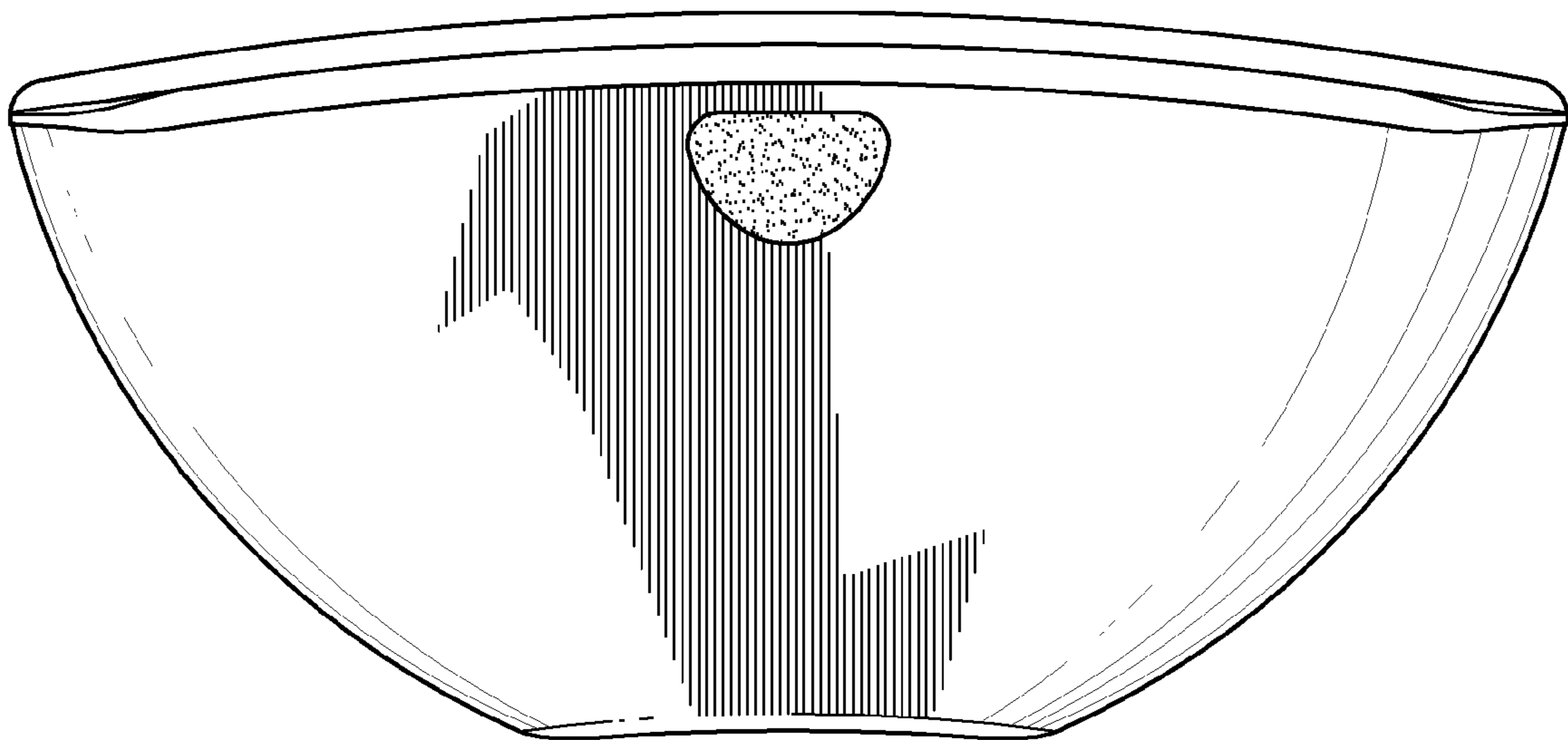

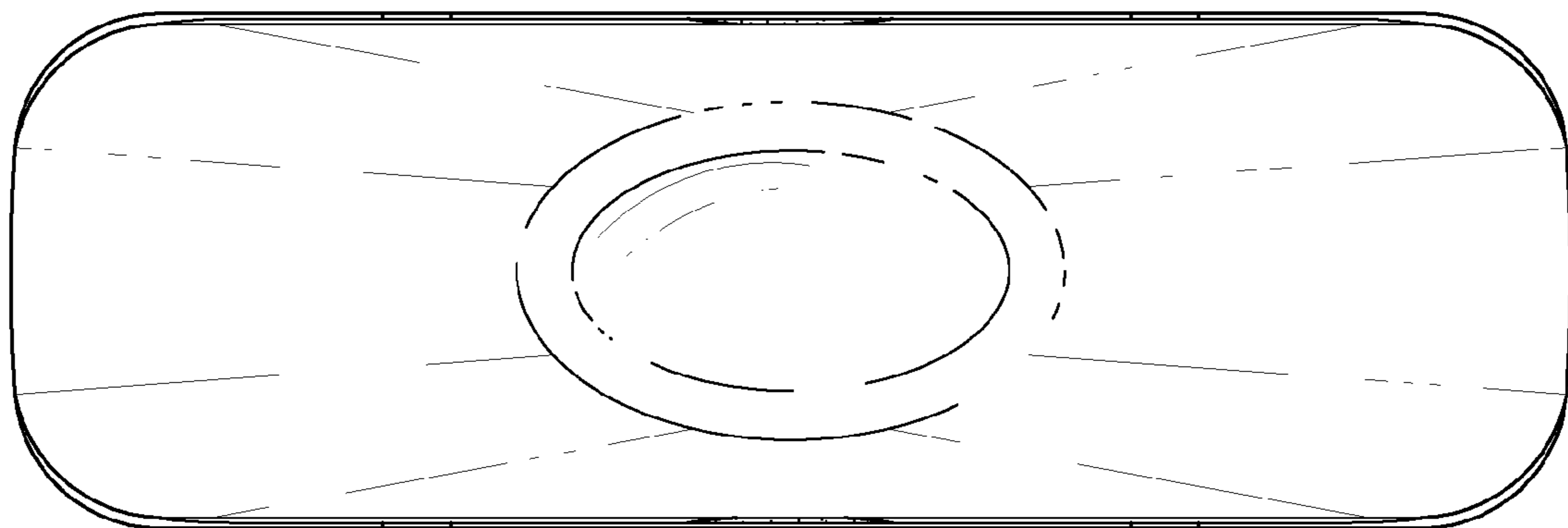

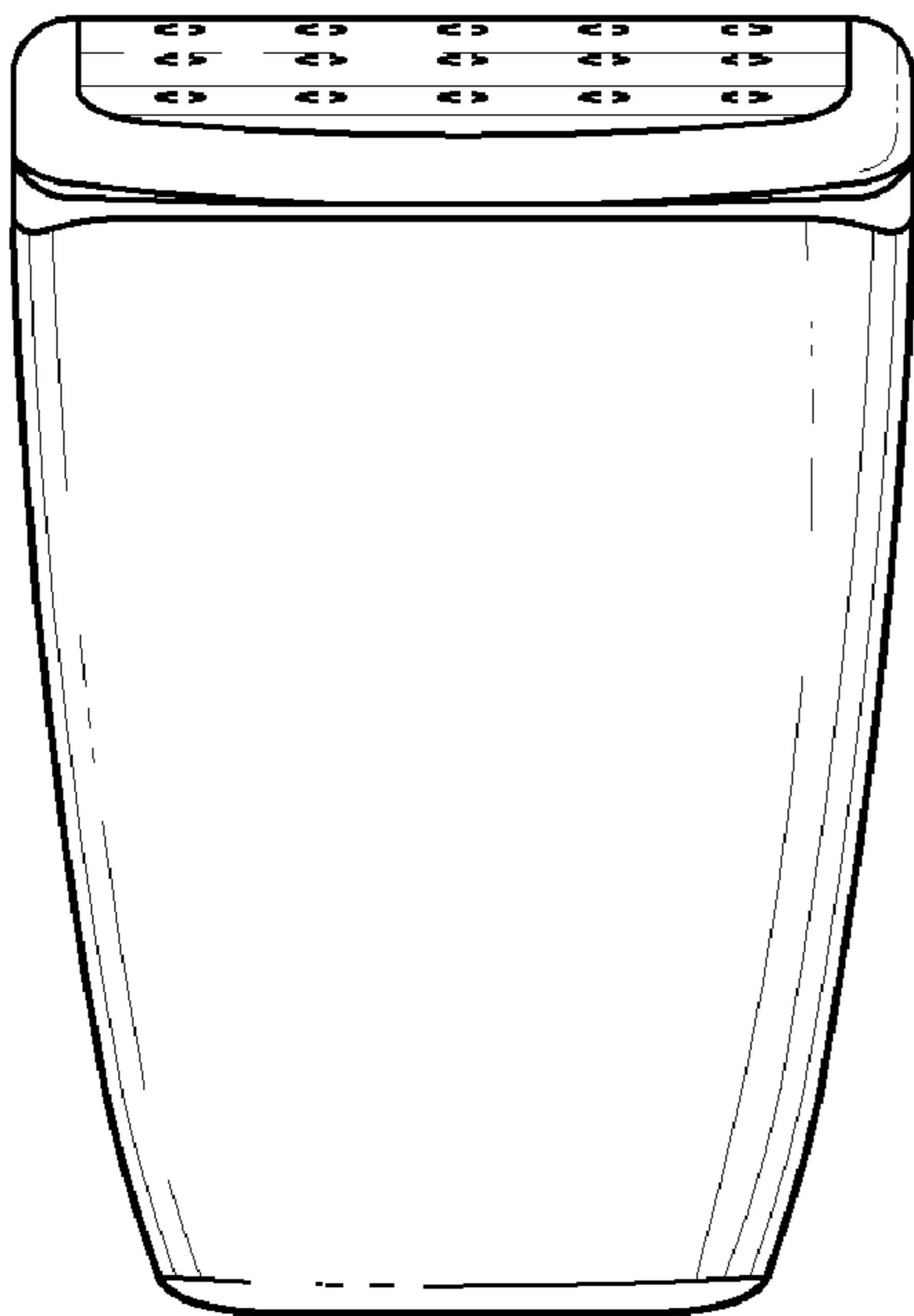
