FIG. 13 is a top perspective view of the stake with two attached clips.

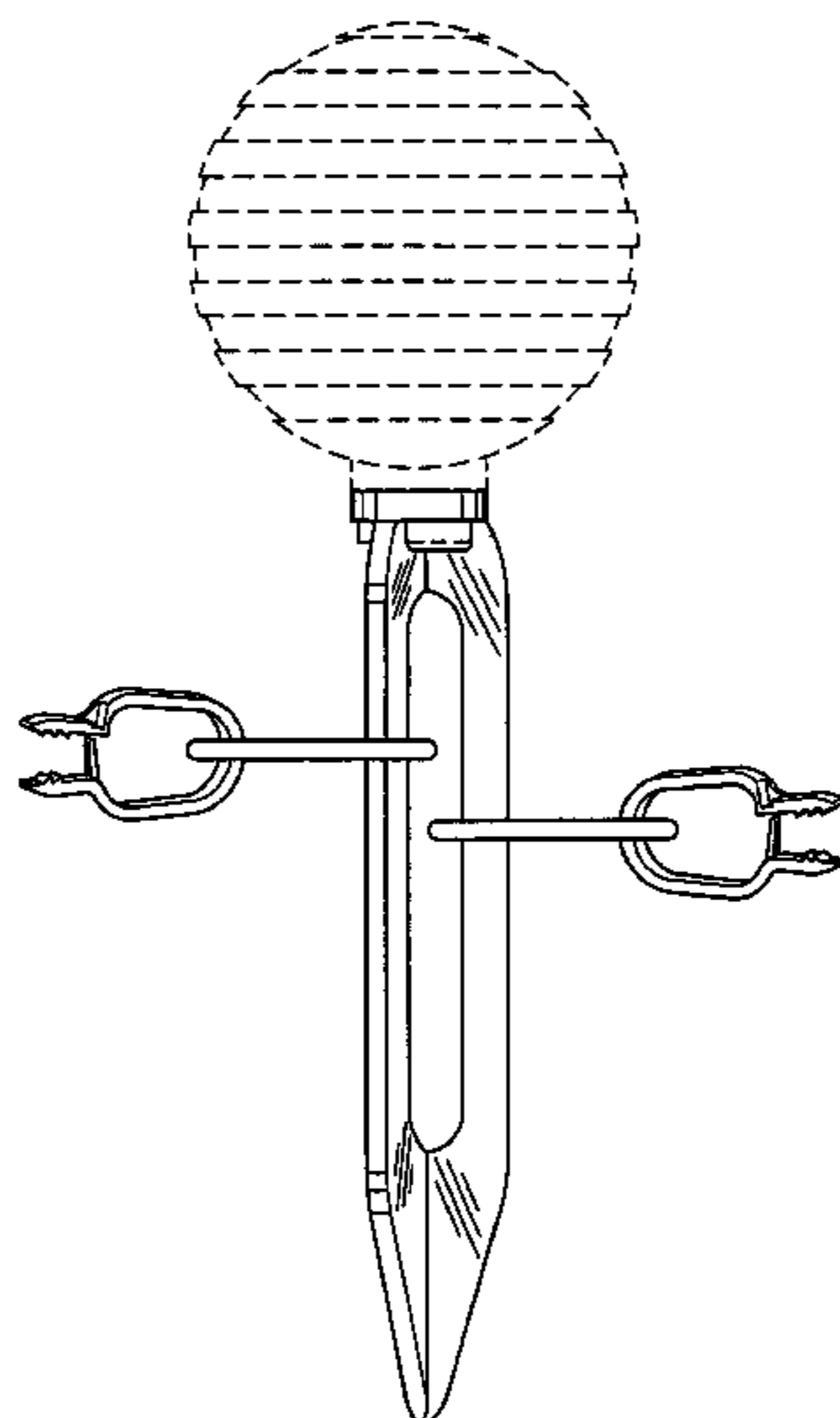
FIGS. 2–13 are shown separated for ease of illustration.

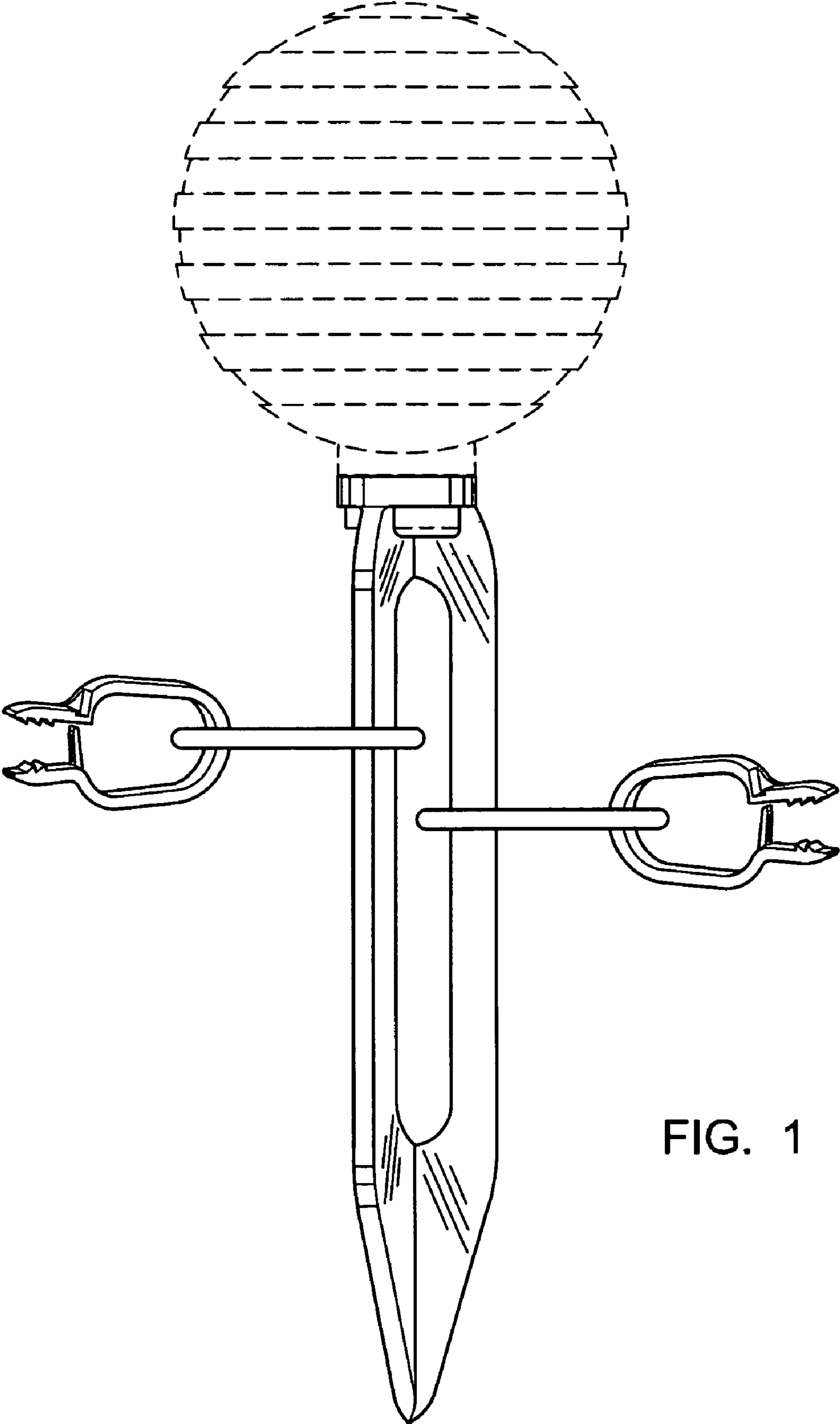

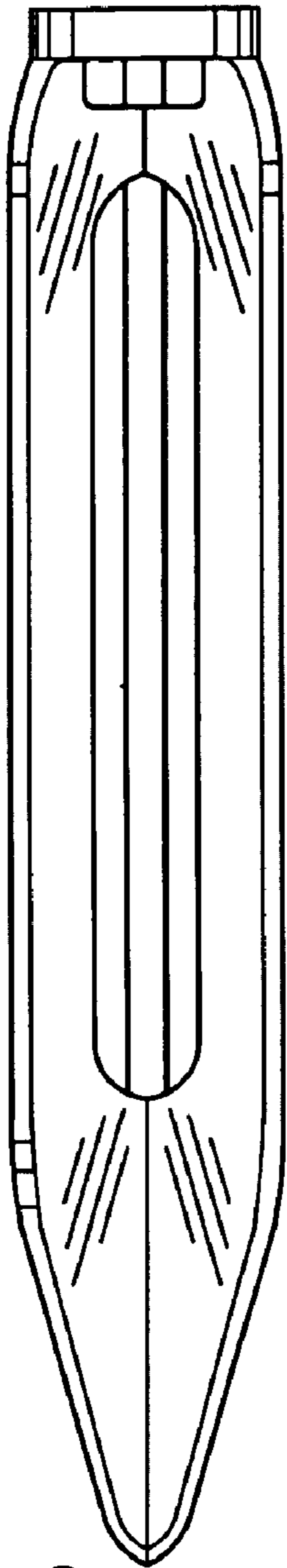

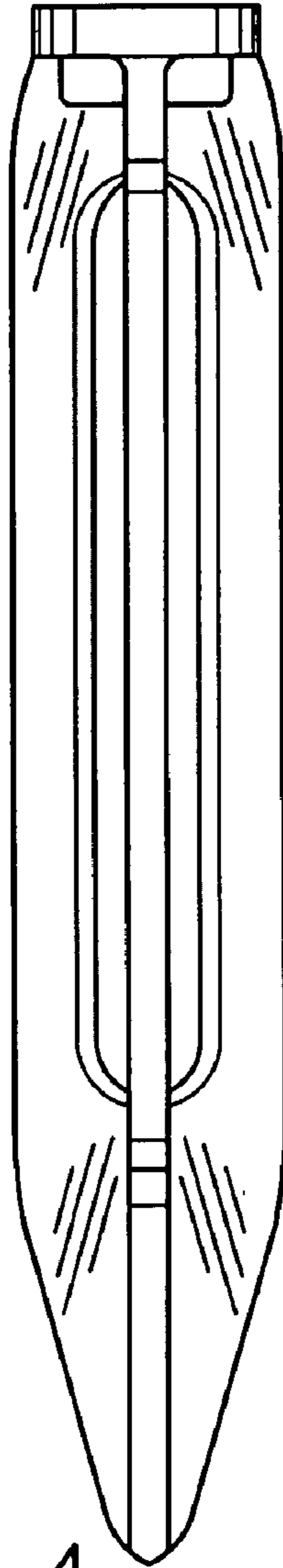

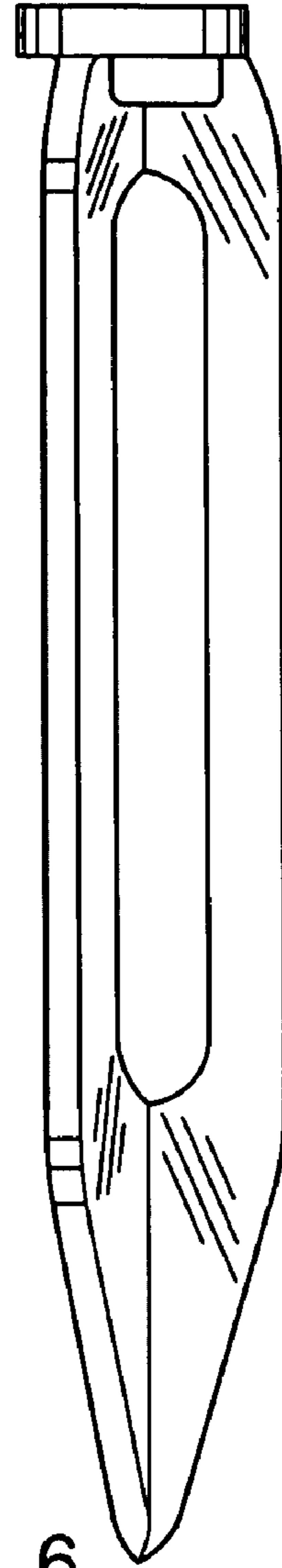

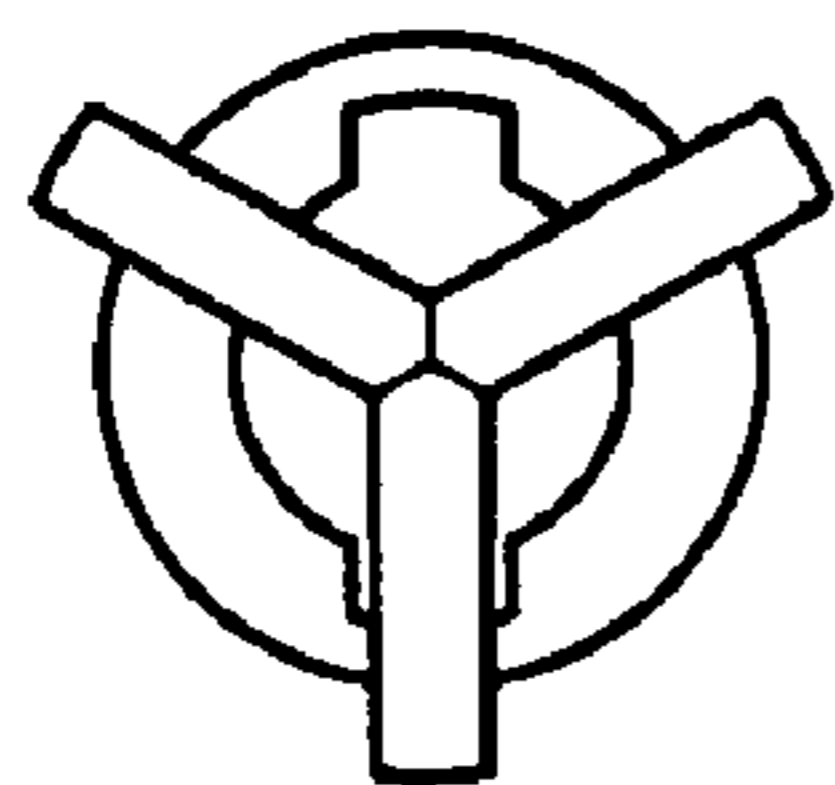

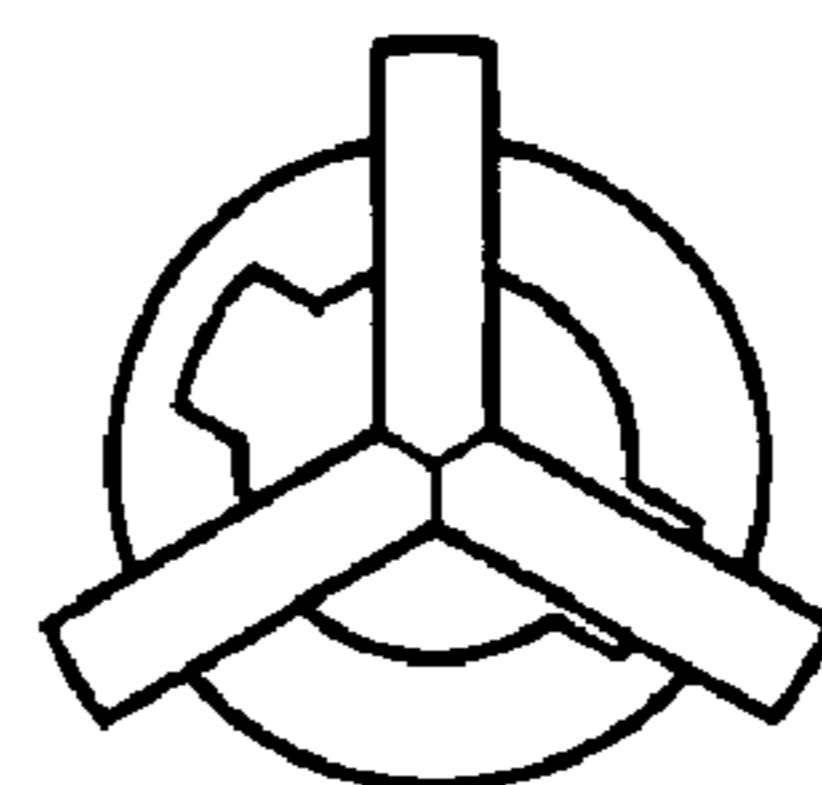

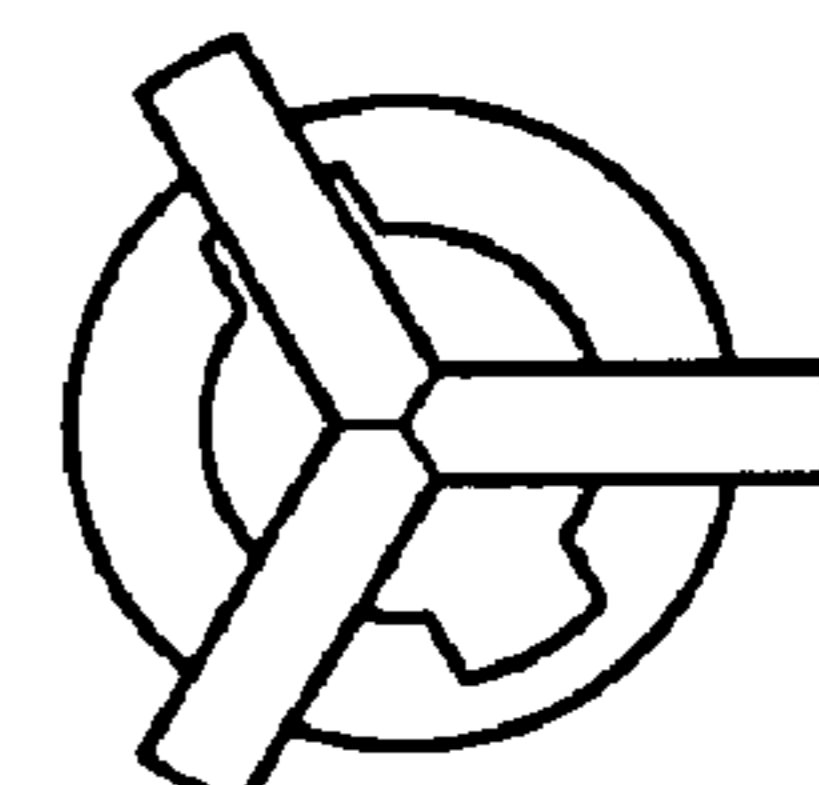

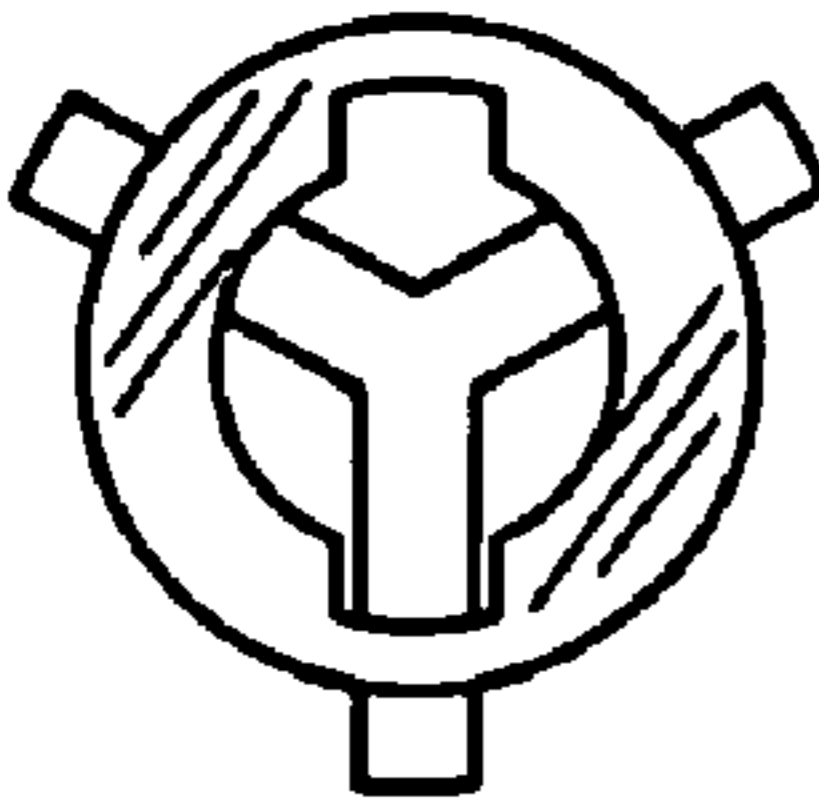

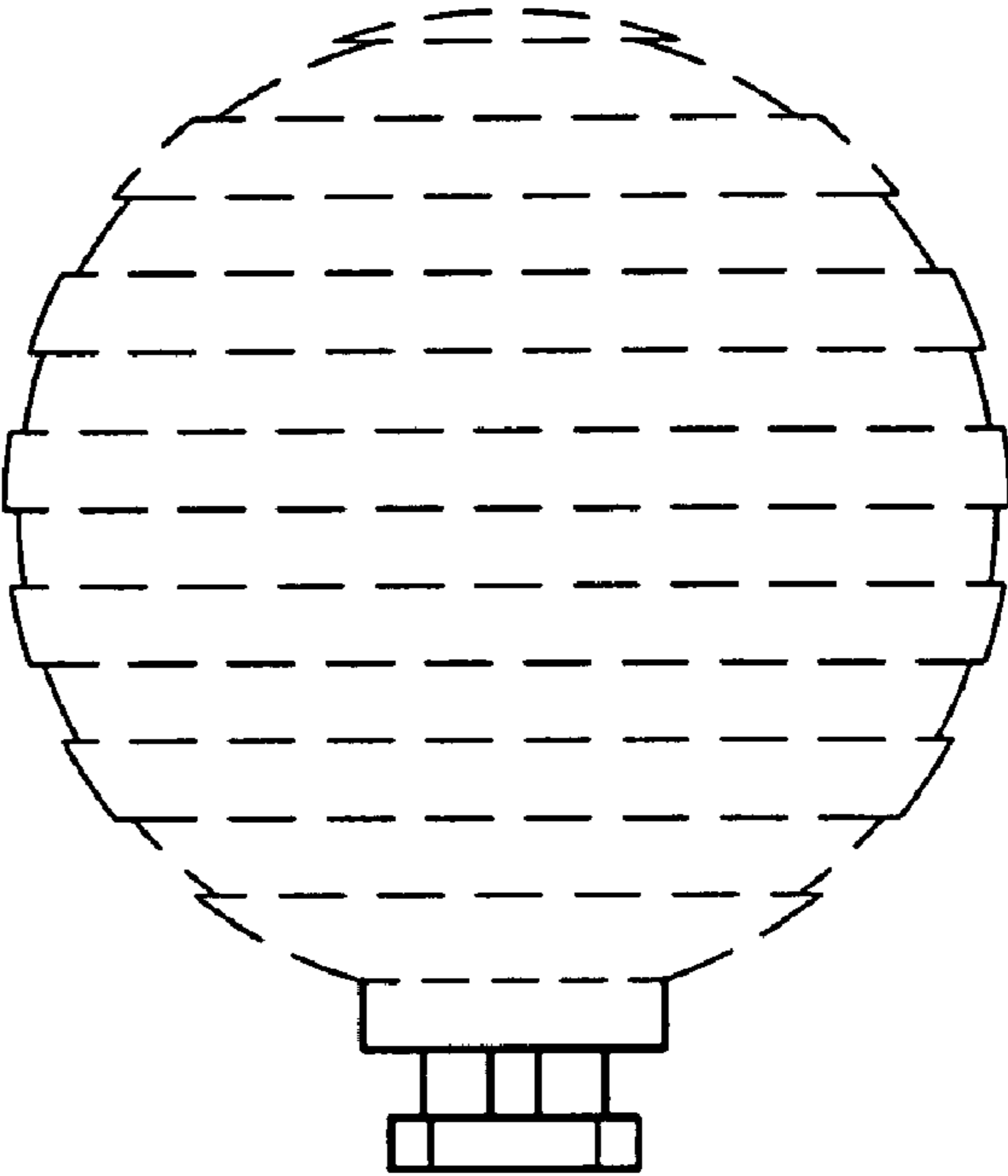

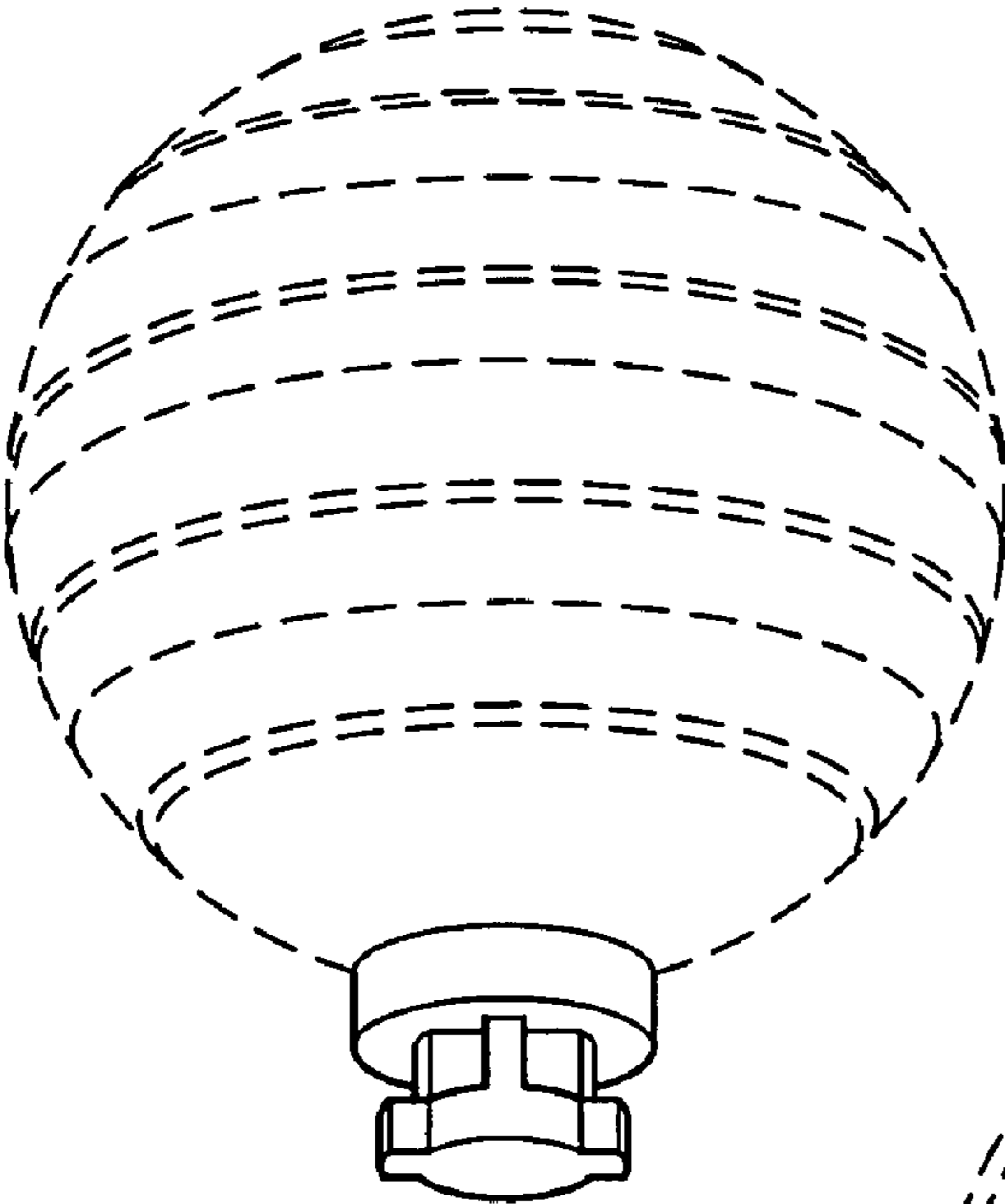

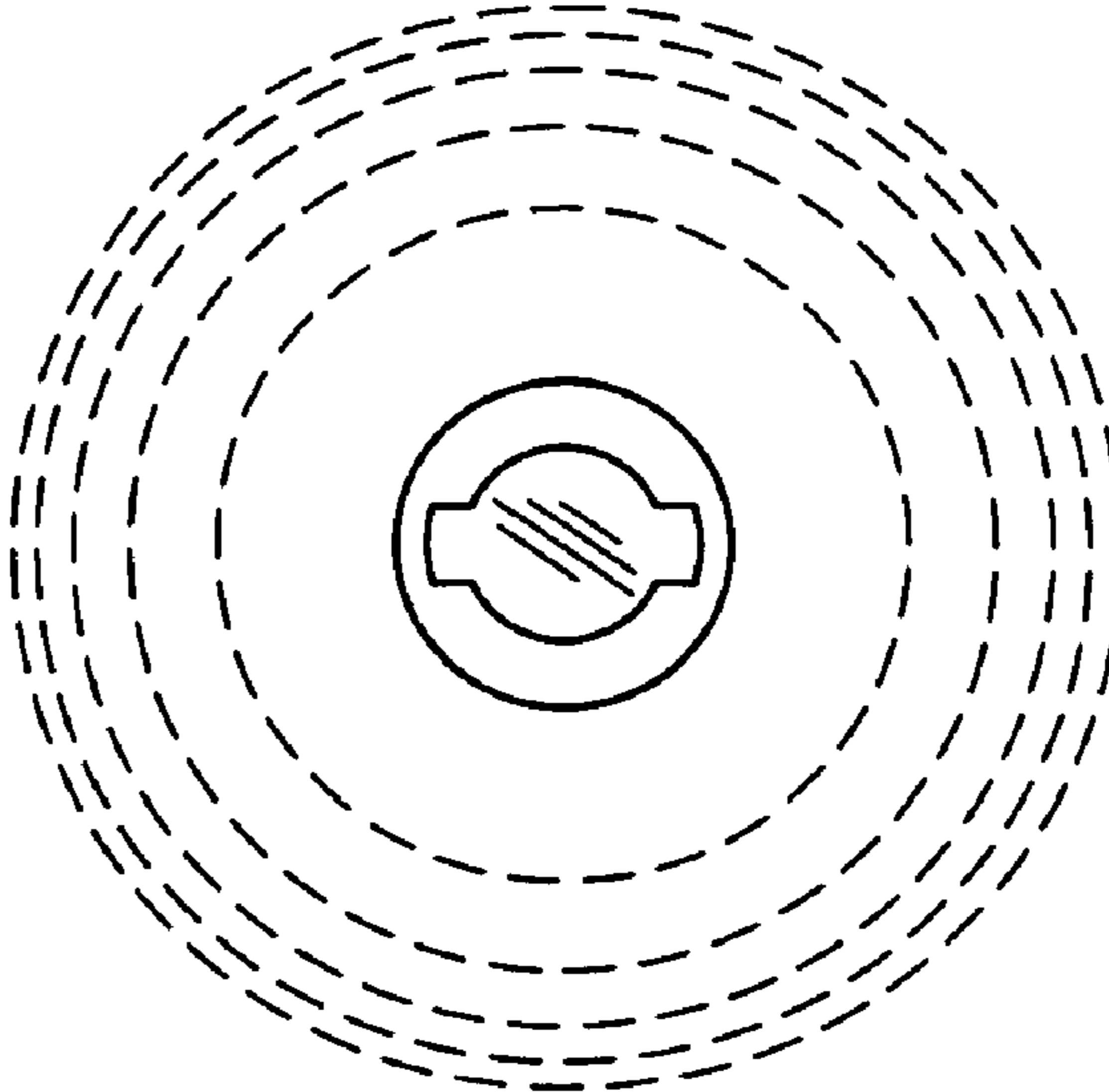

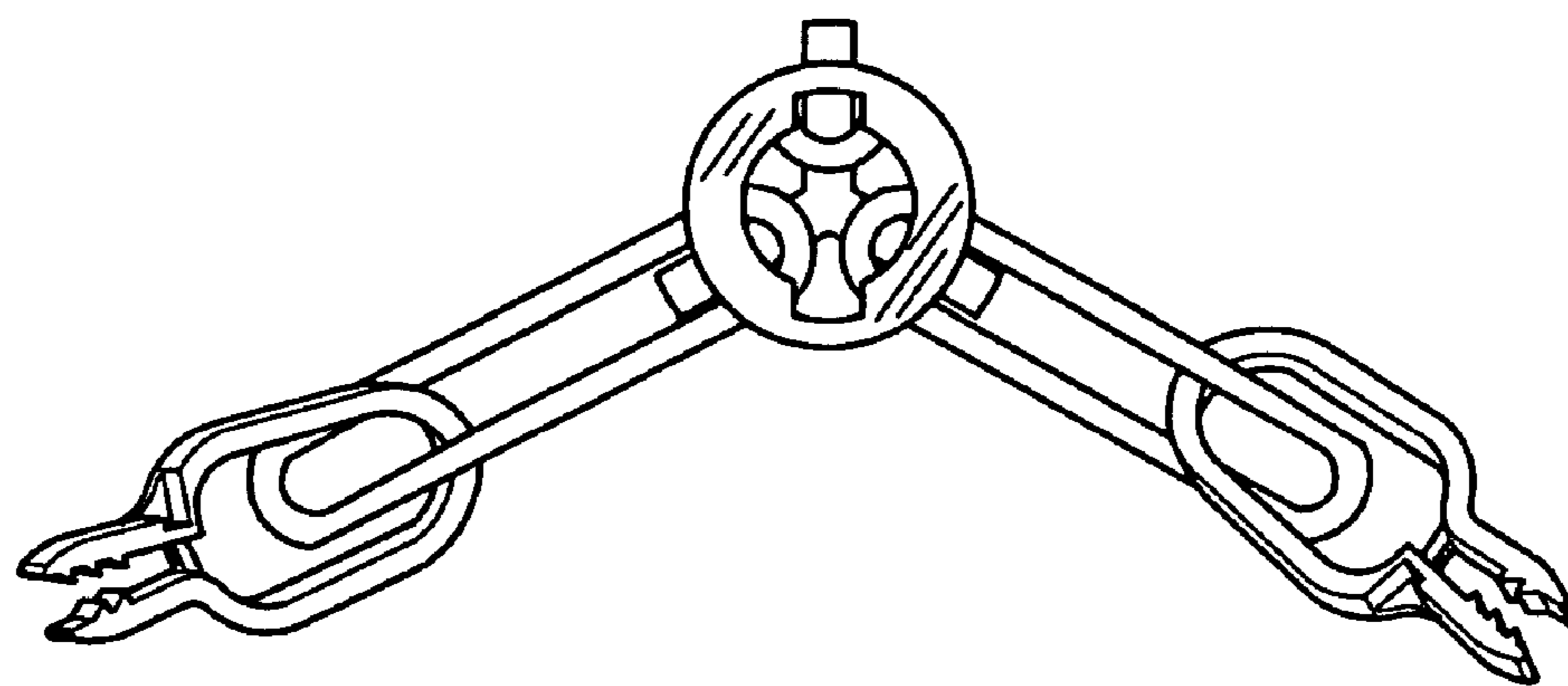

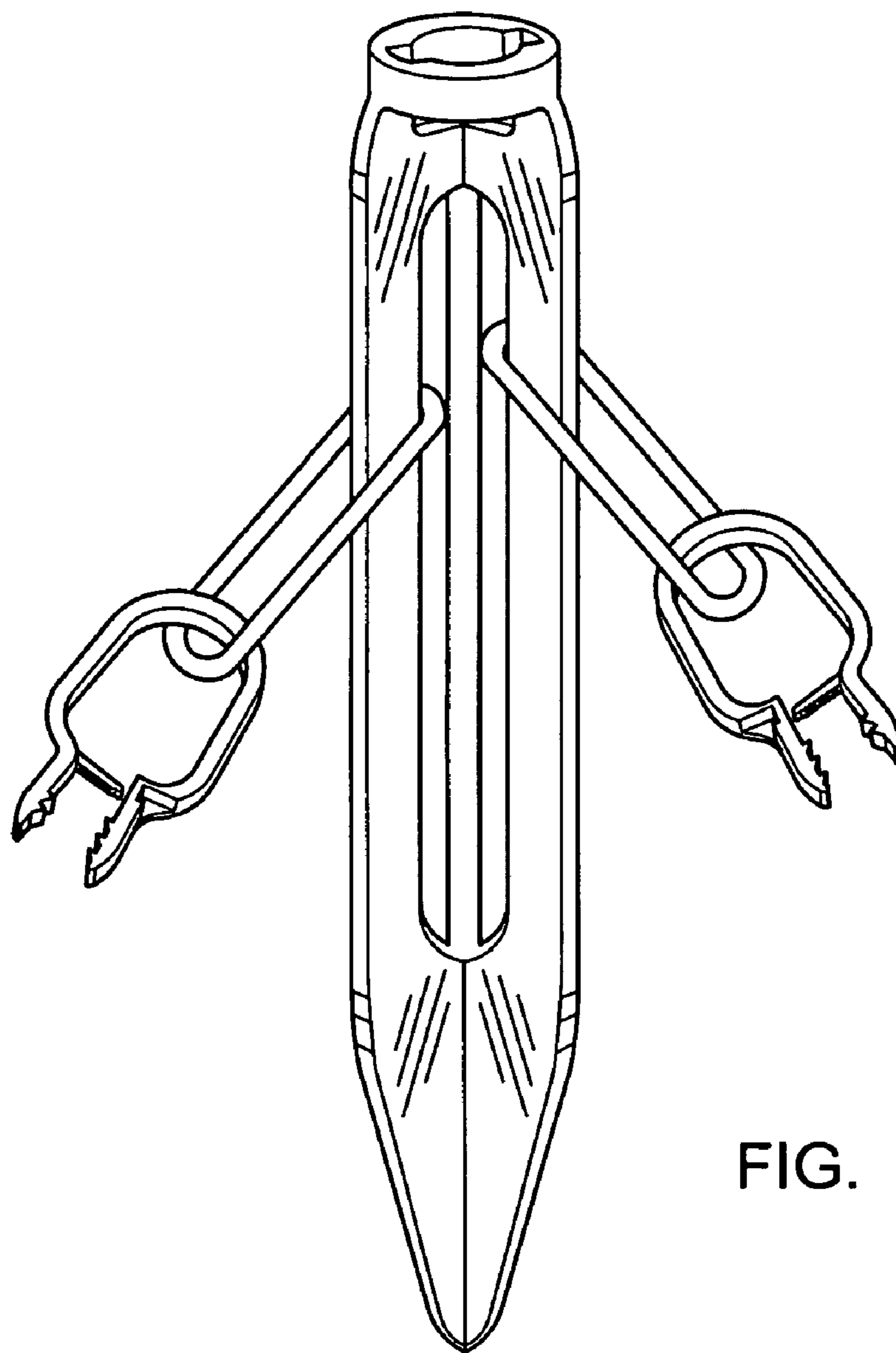
