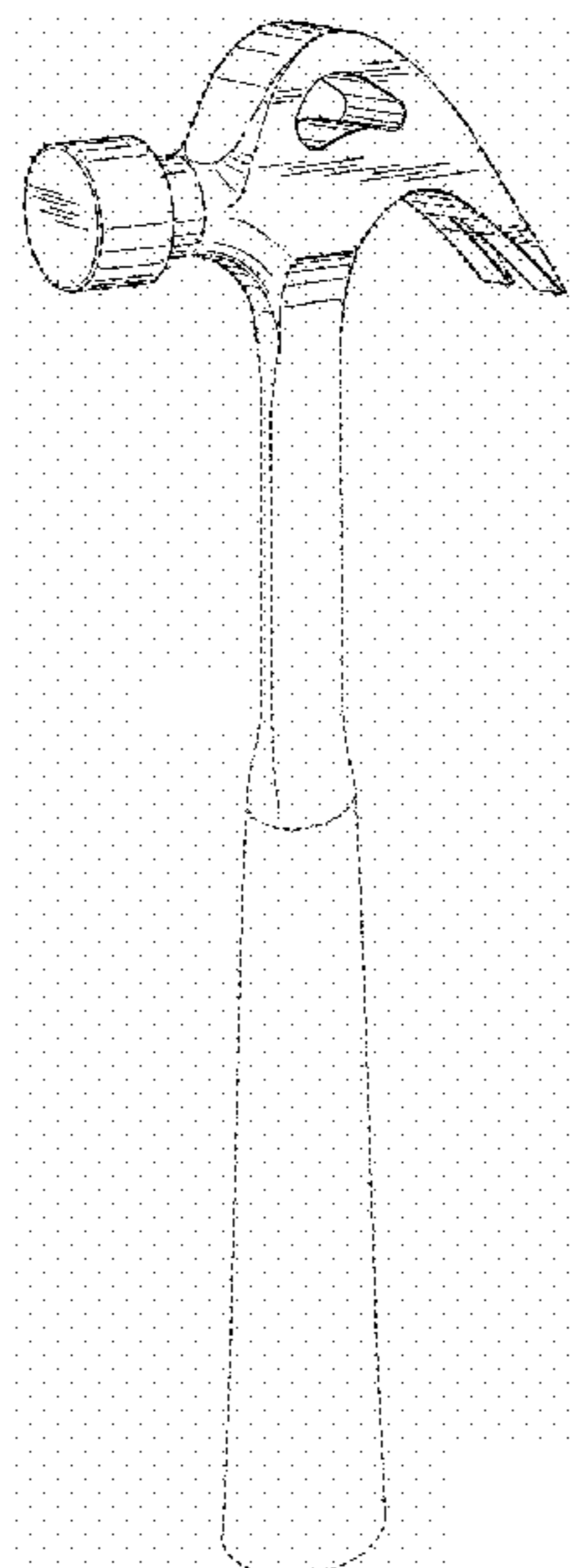
The ornamental design for a hammer, as shown.

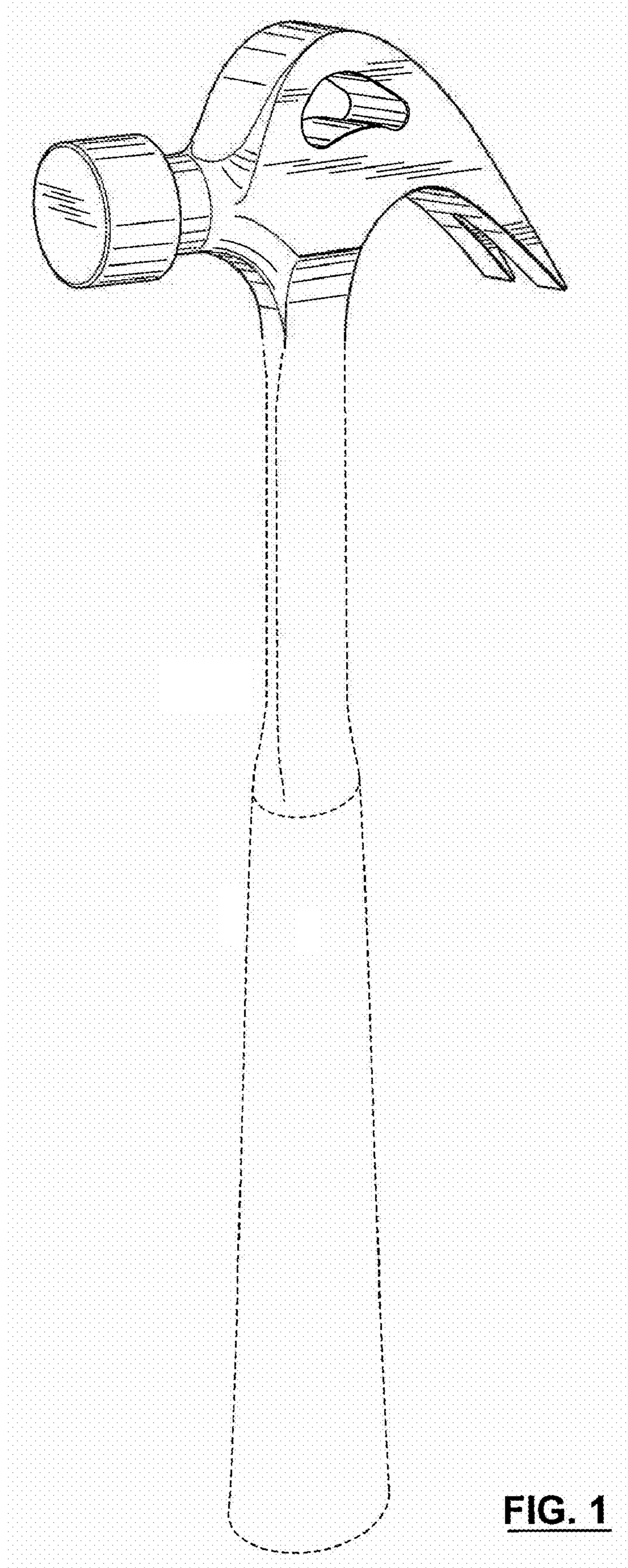

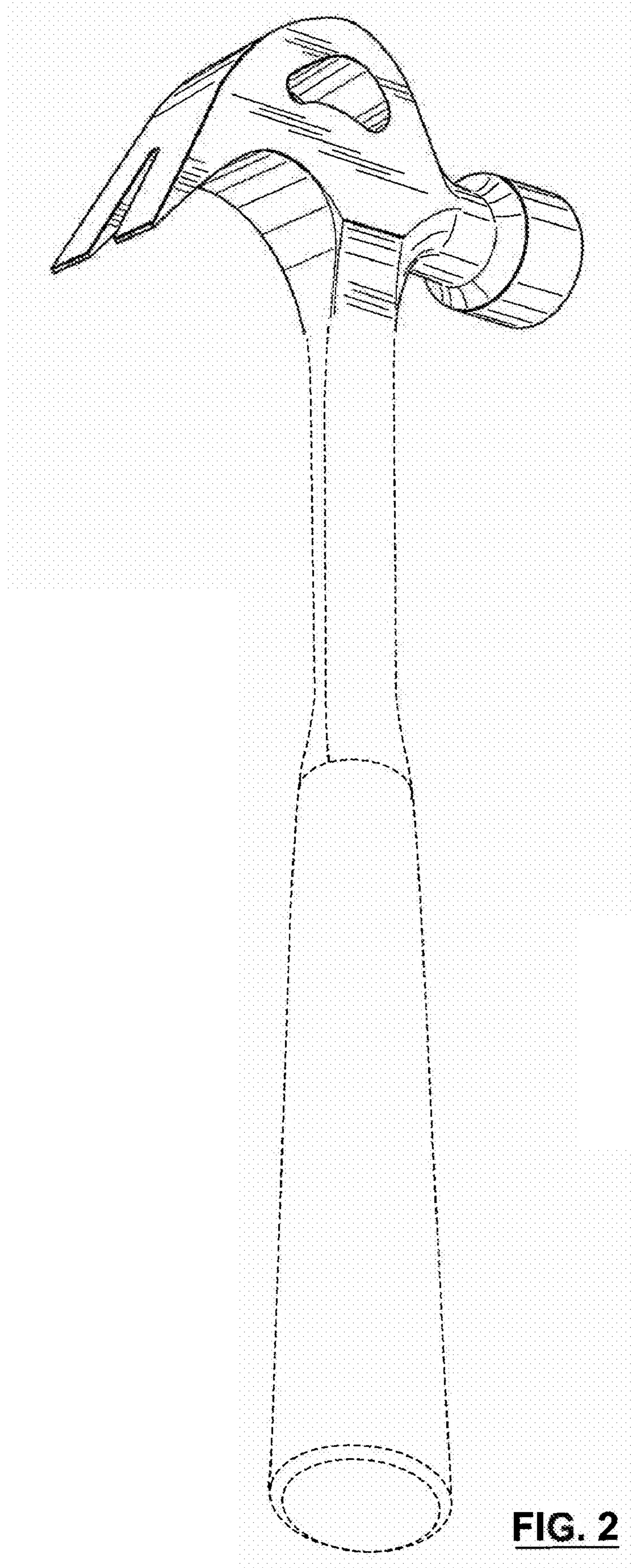

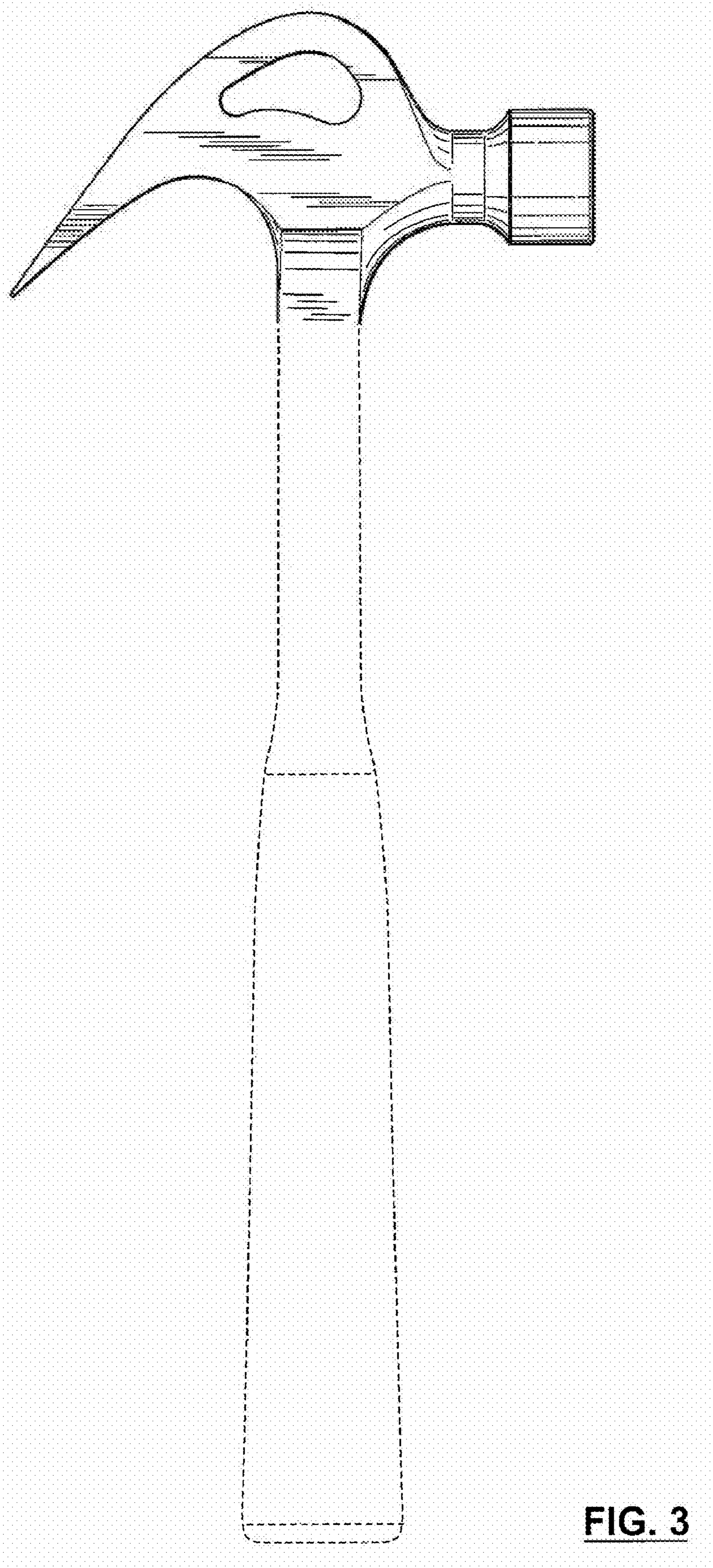

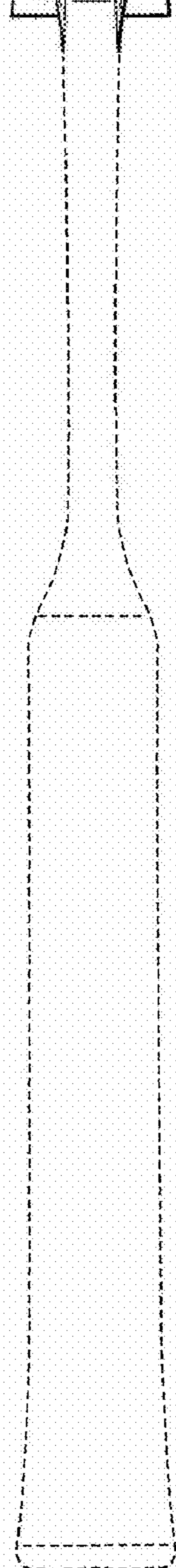
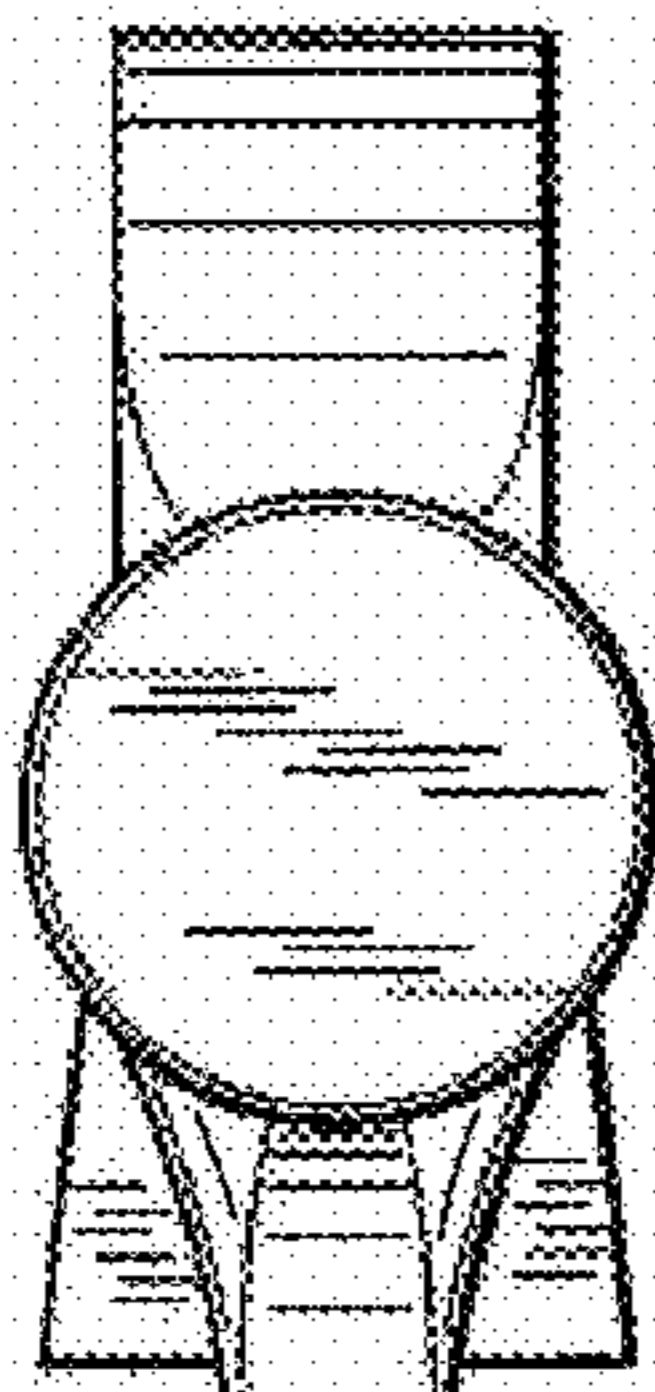

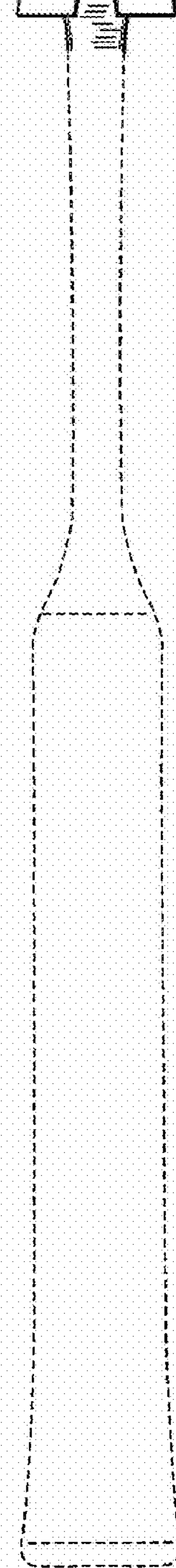
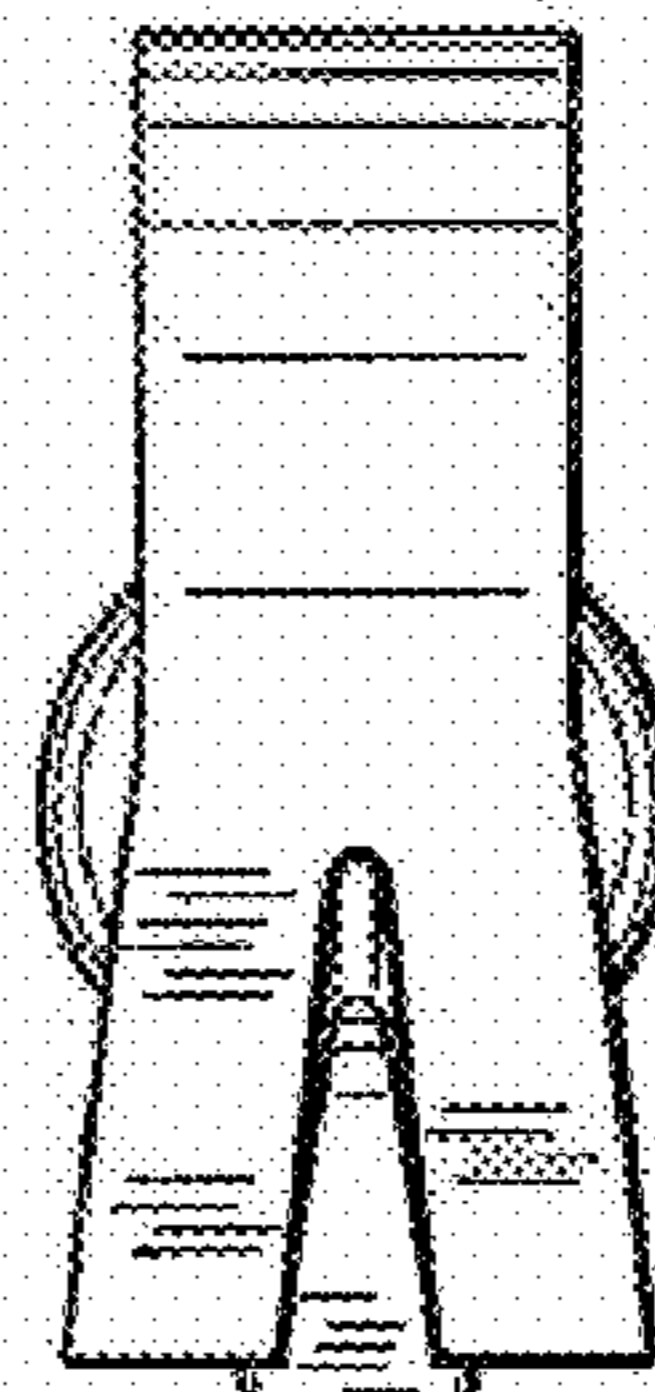

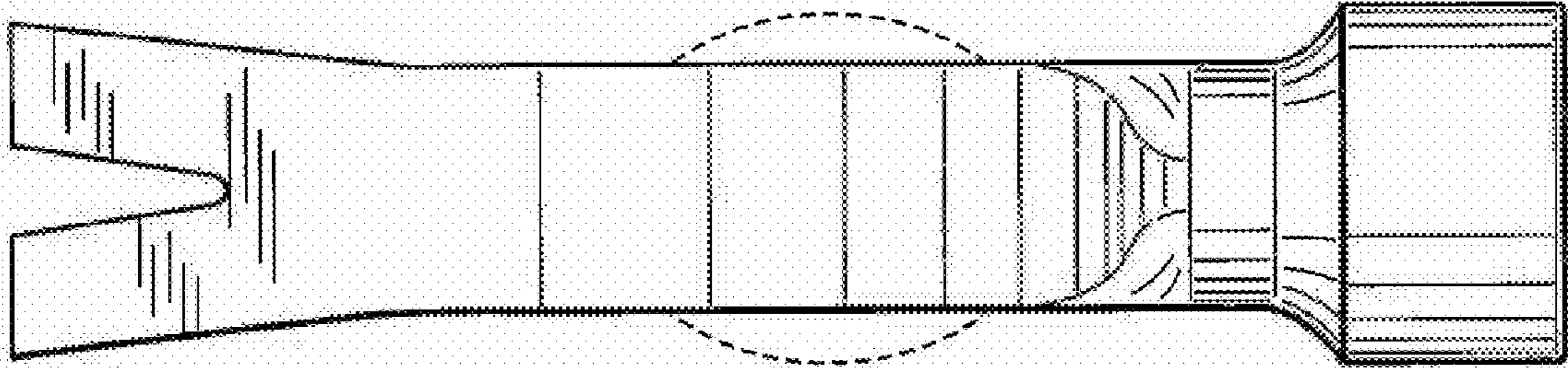

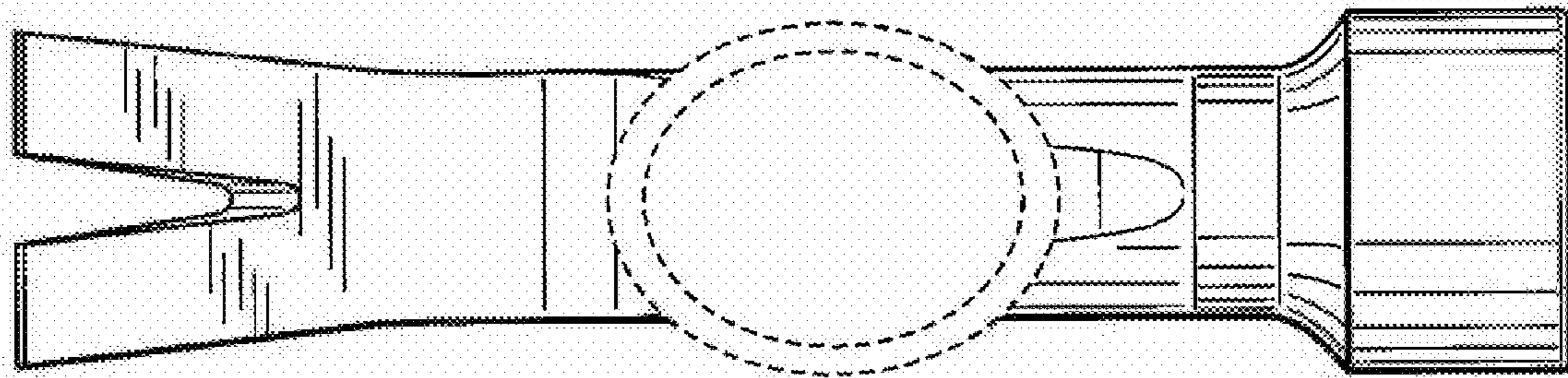
