FIG. 4 is a top view thereof;

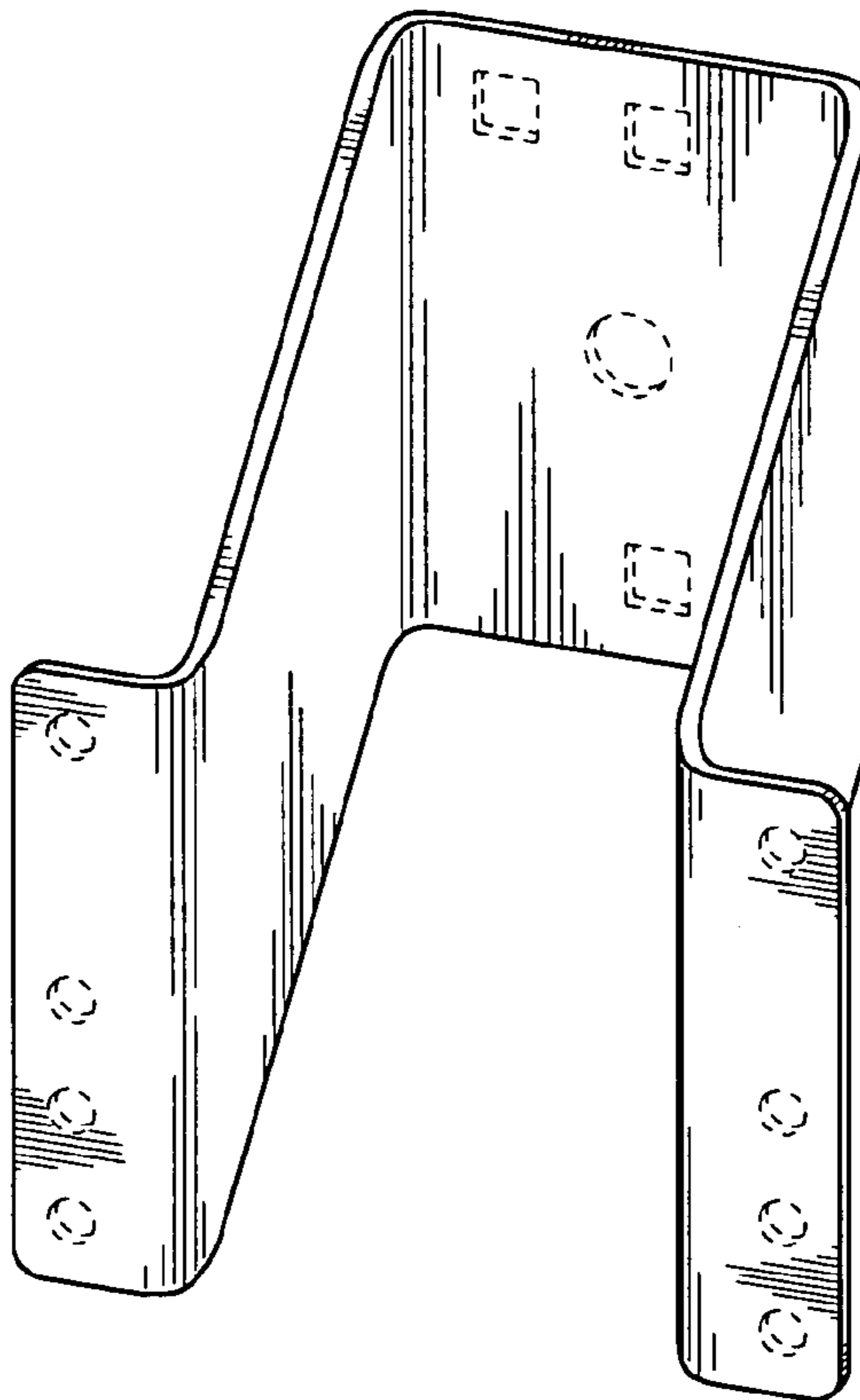
FIG. 5 is a bottom view thereof;

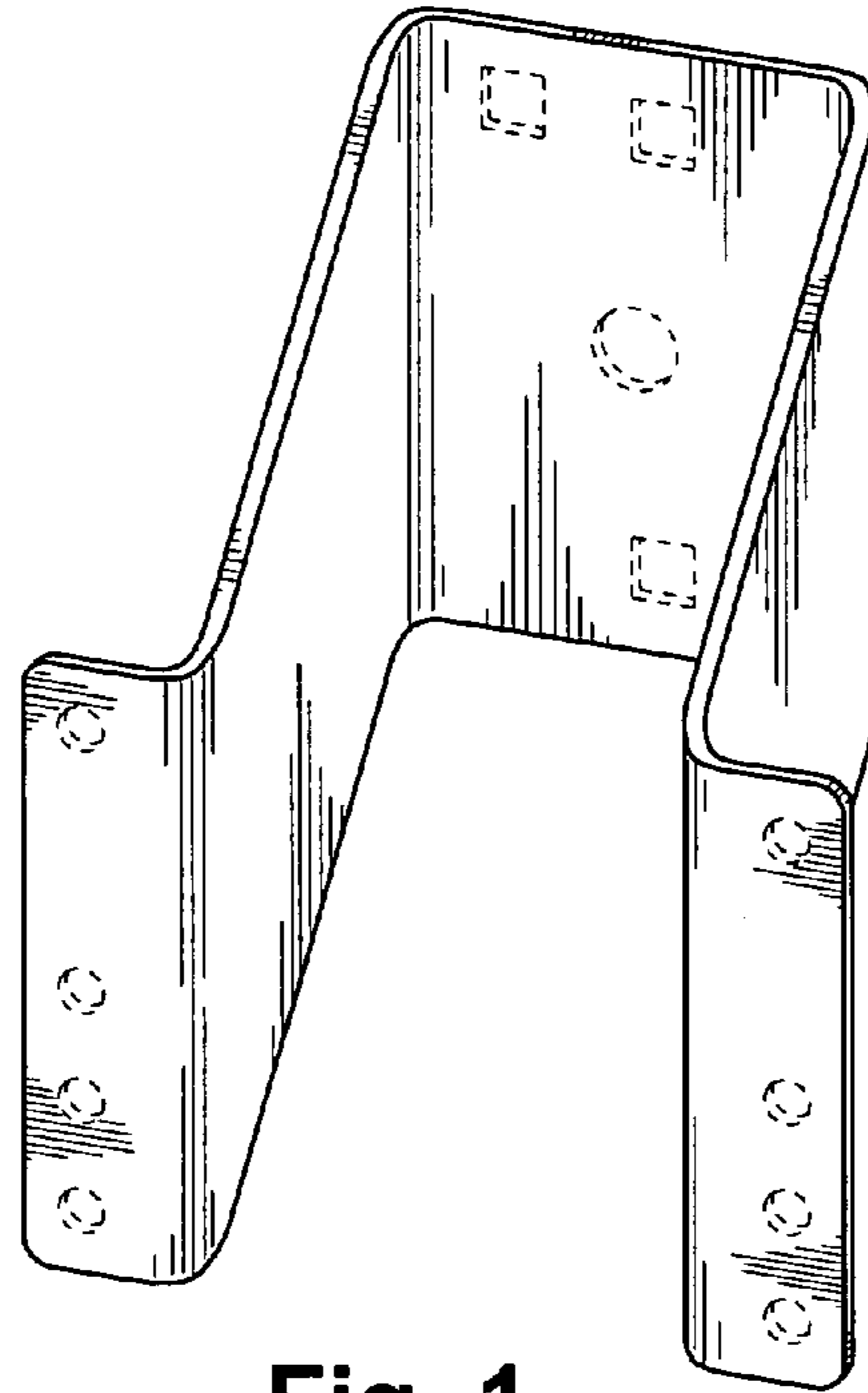
FIG. 6 is a left side view thereof; and,

FIG. 7 is a right side view thereof.

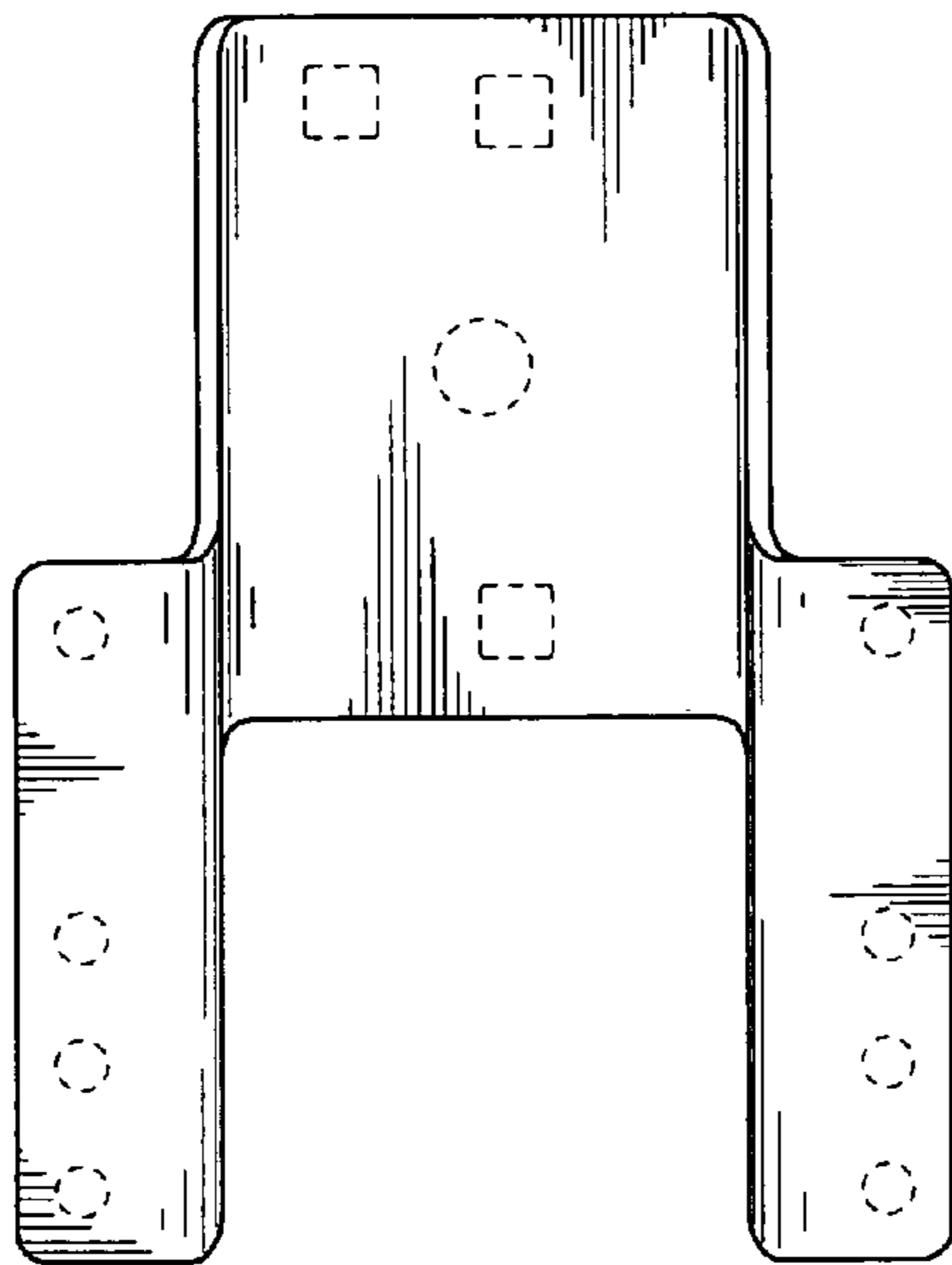
The broken lines of FIGS. 1, 2, and 3 are included for the purpose of illustrating environment and form no part of the claimed design.

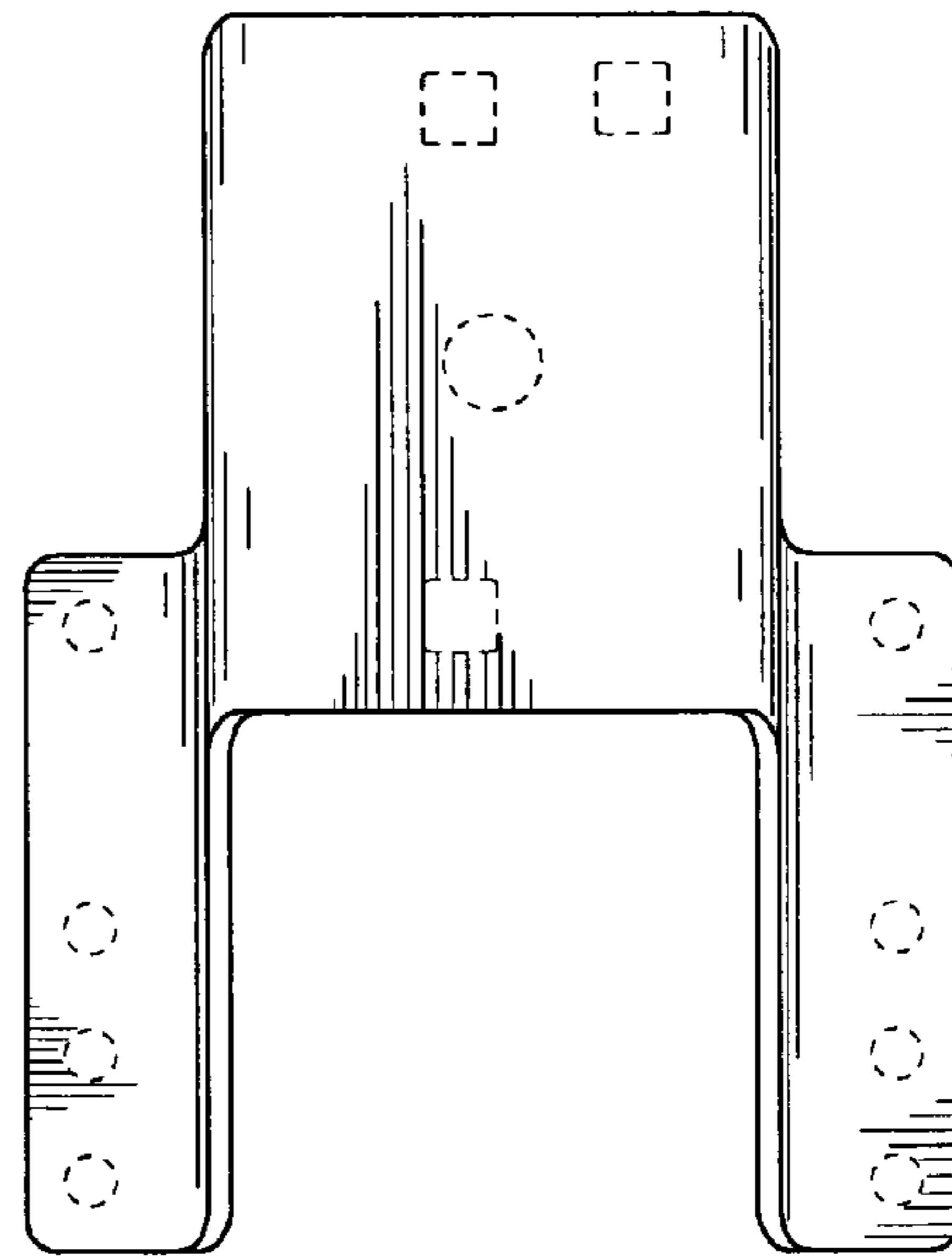




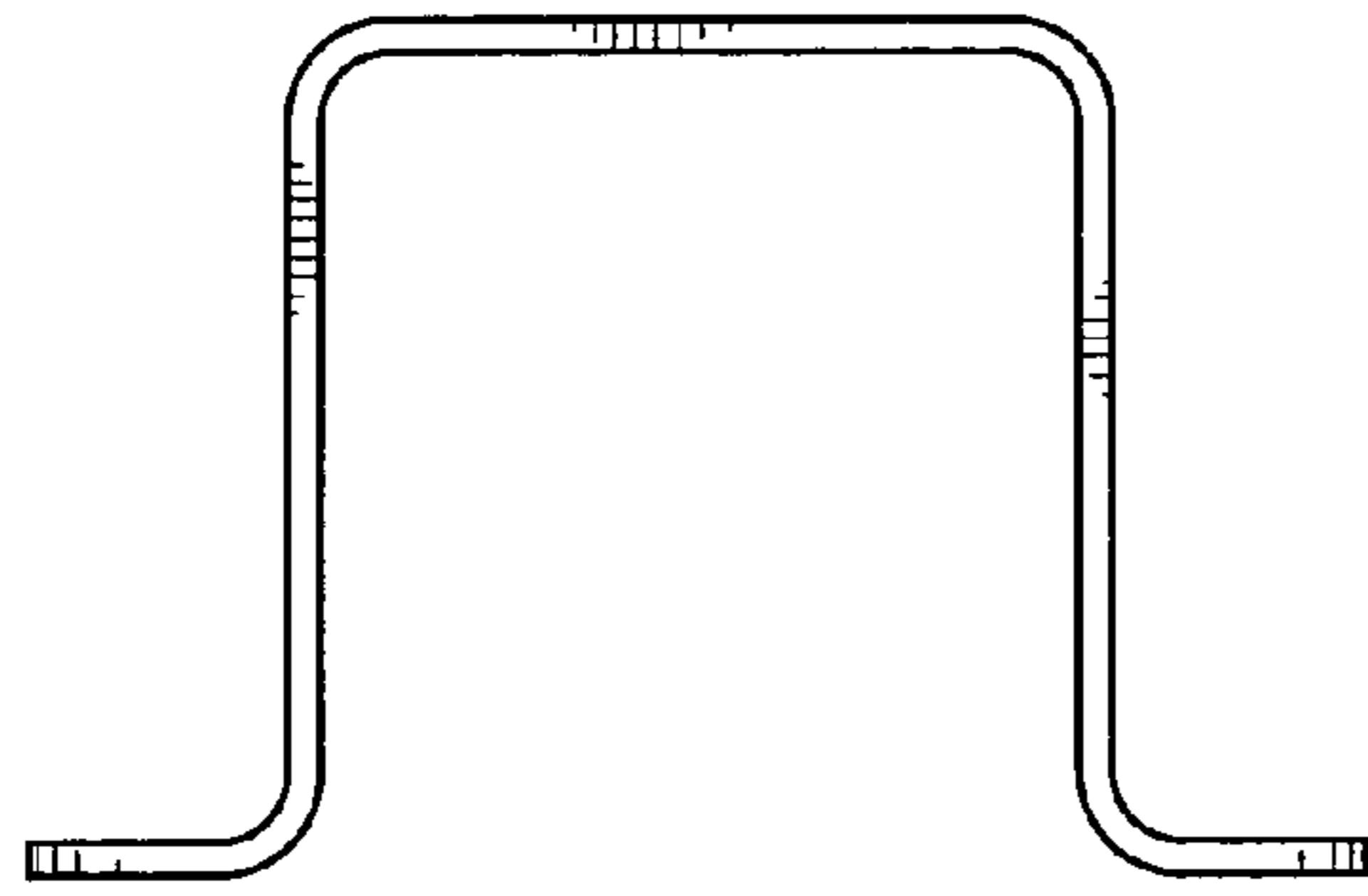

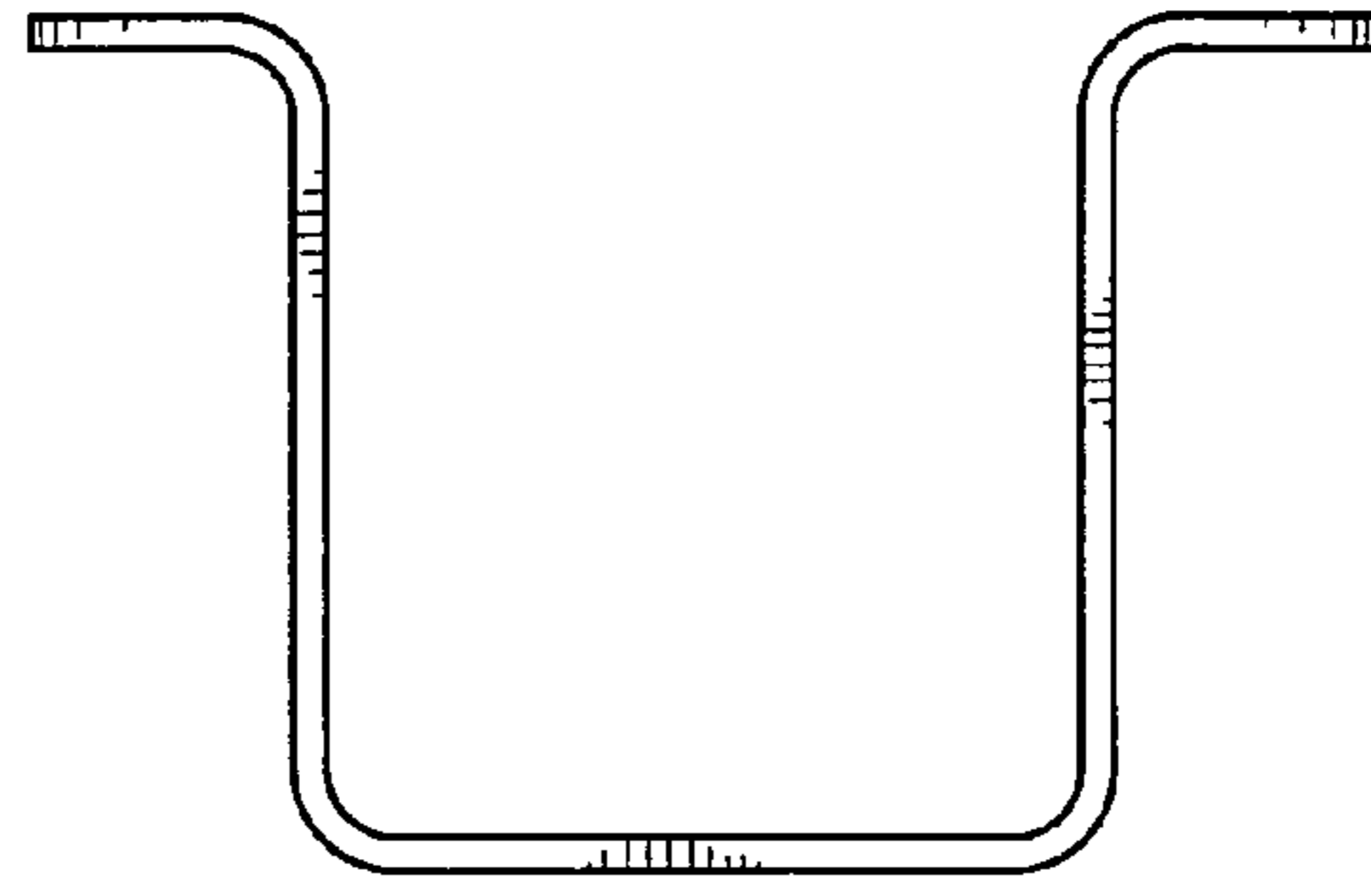

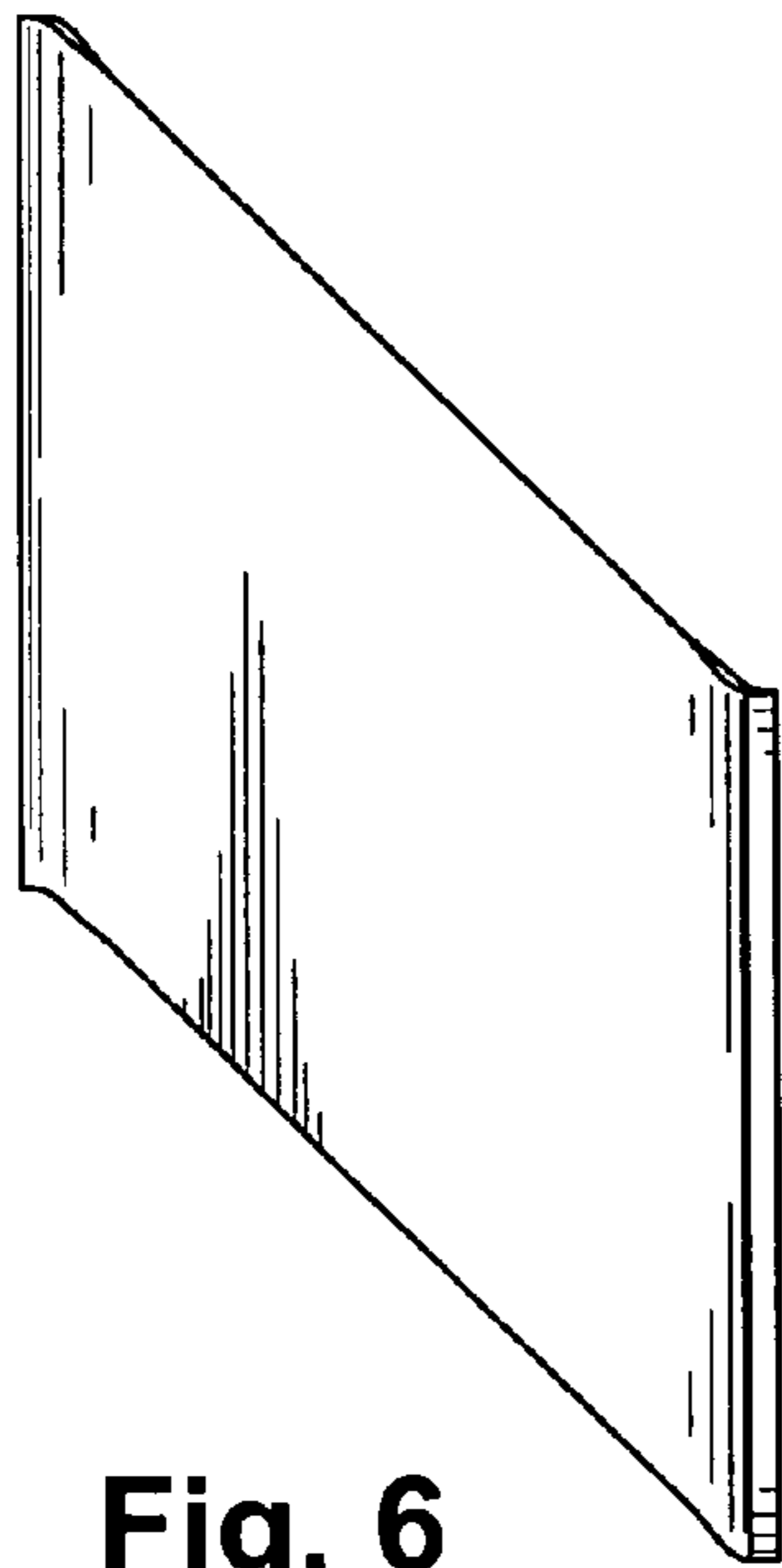

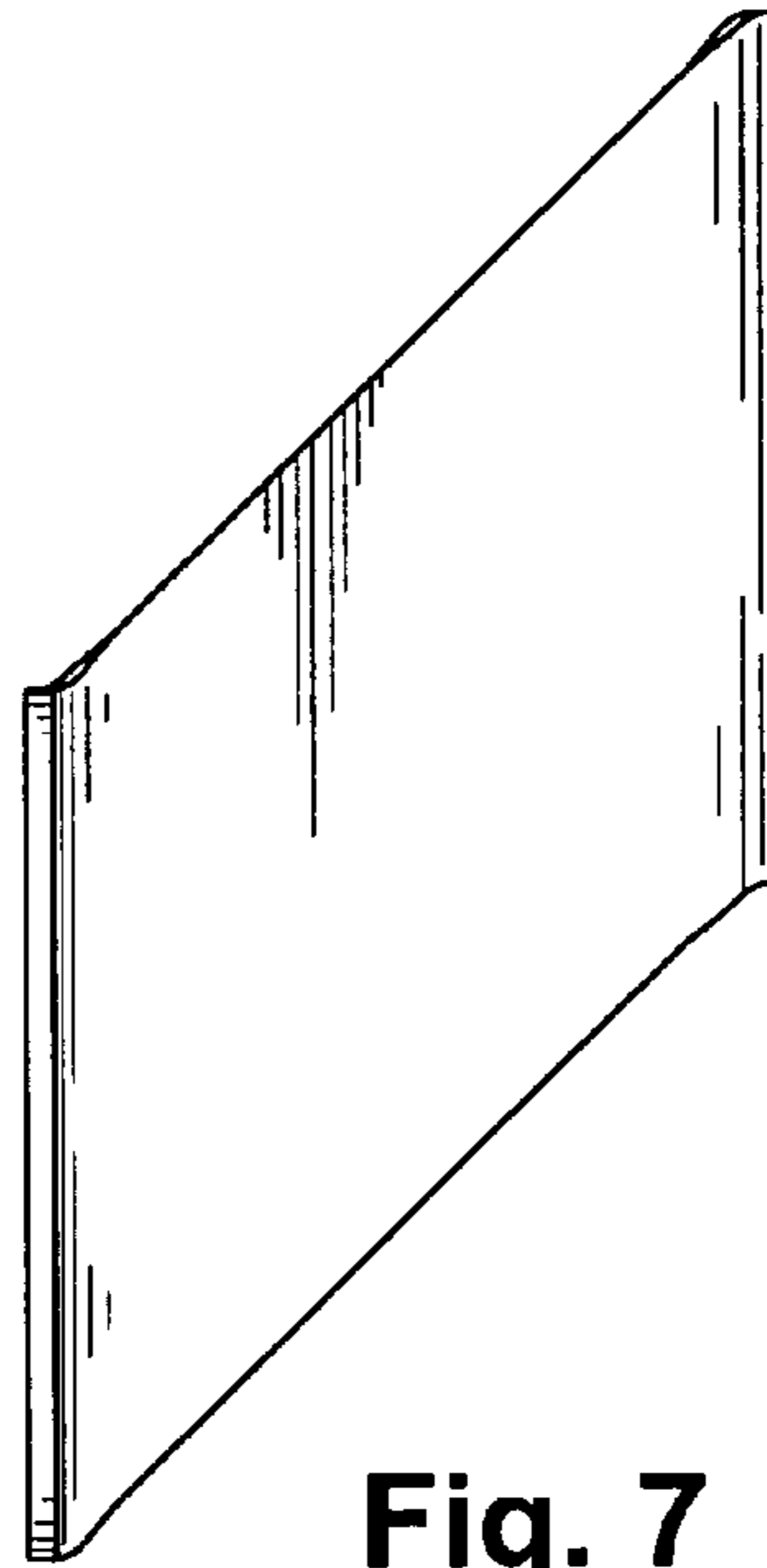
