(57) **CLAIM**

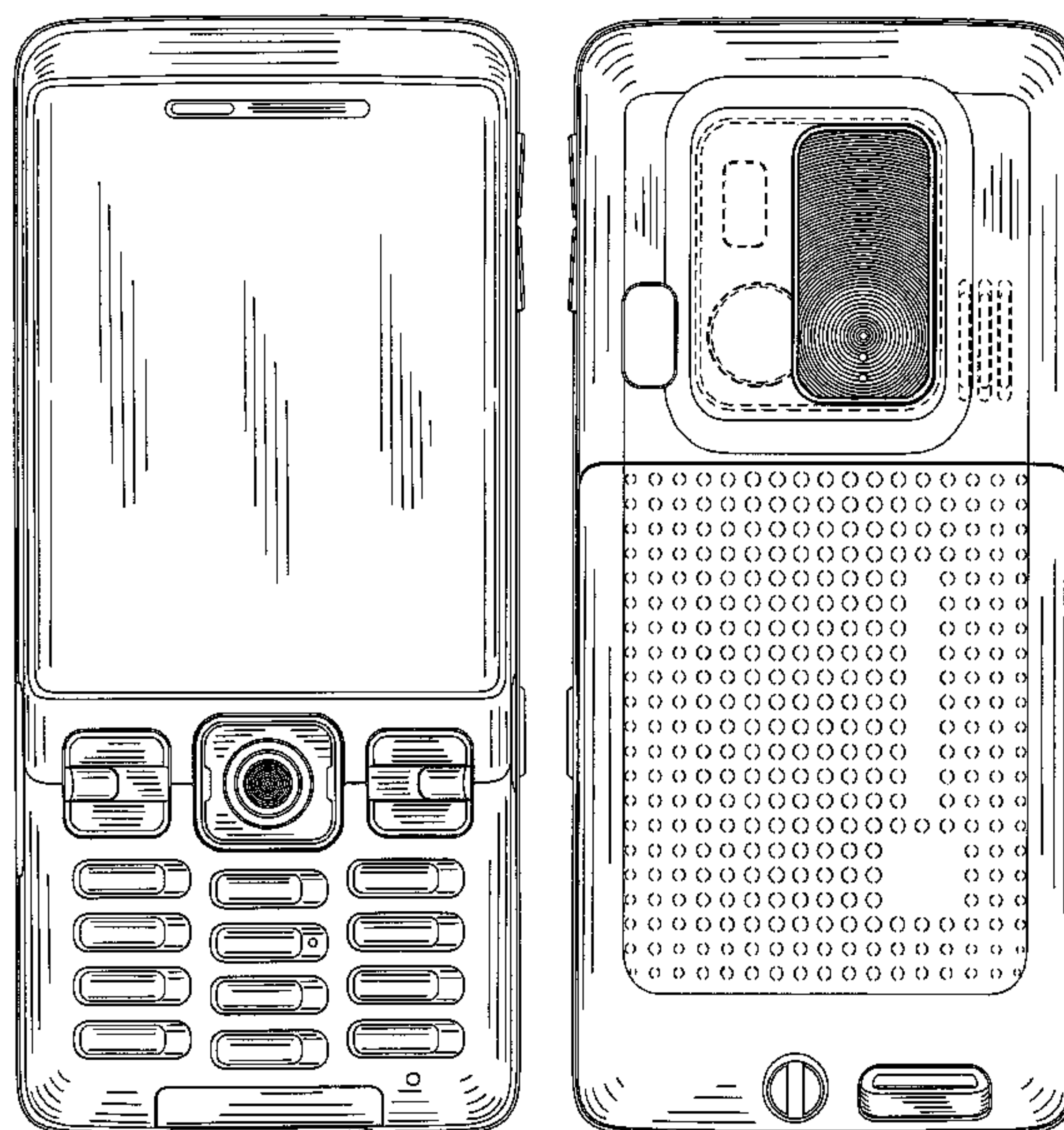
The ornamental design for a mobile telephone, as shown and described.

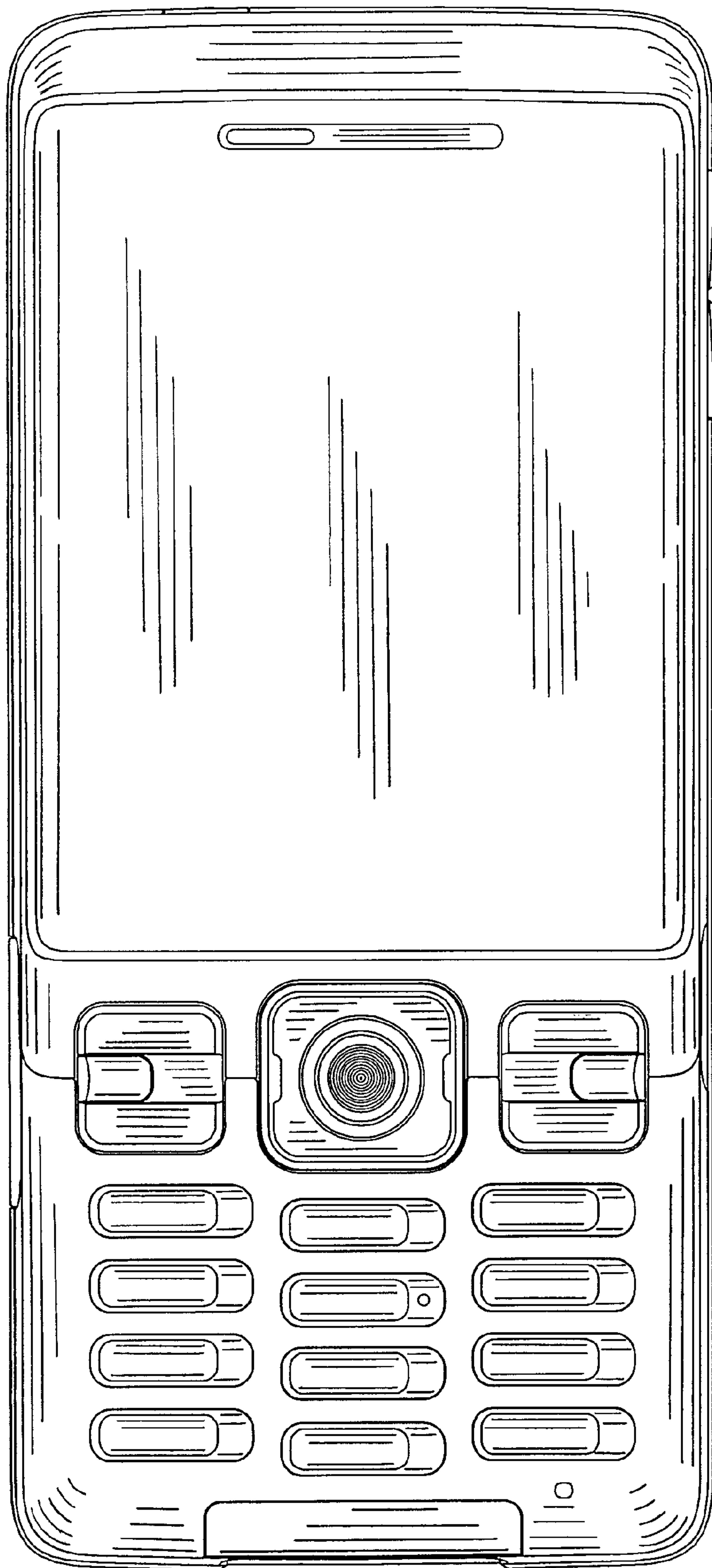

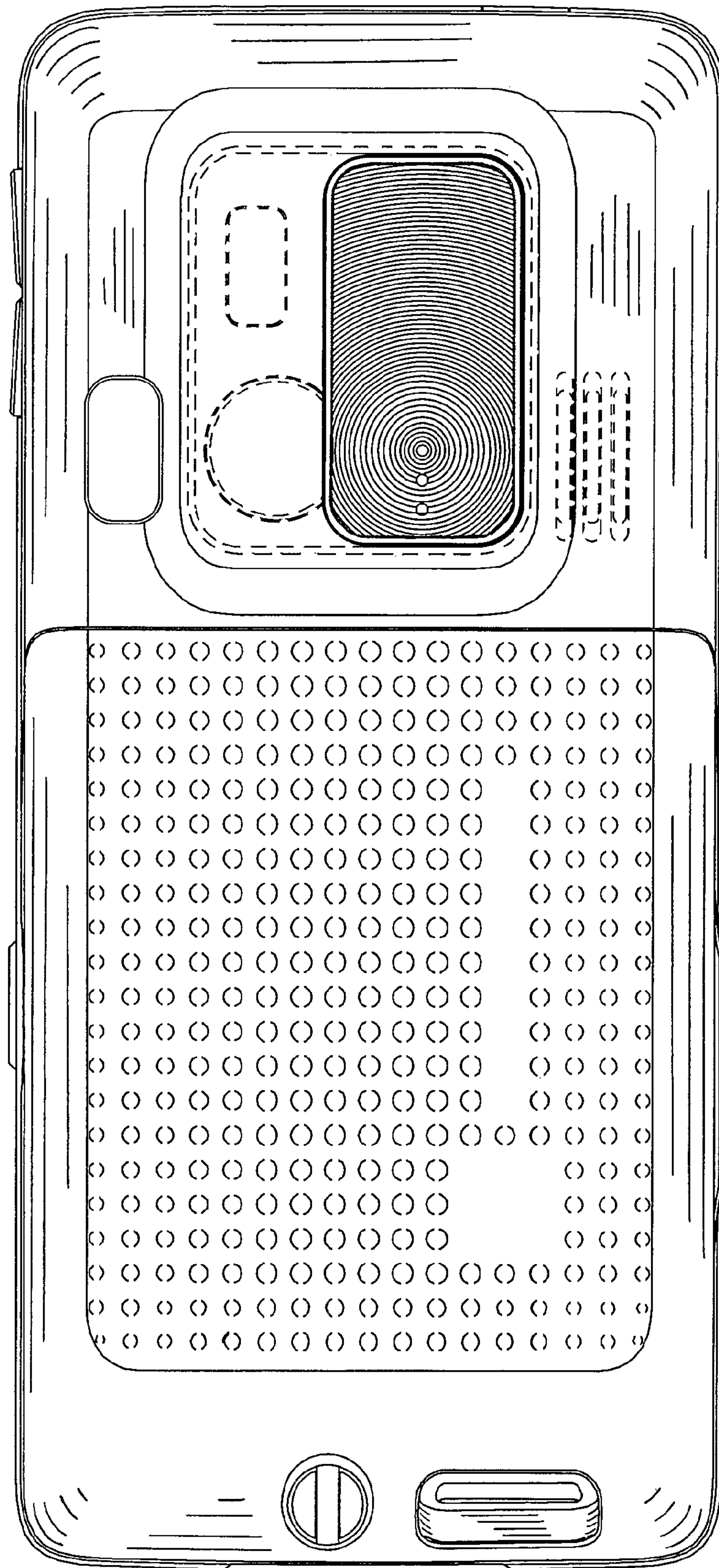

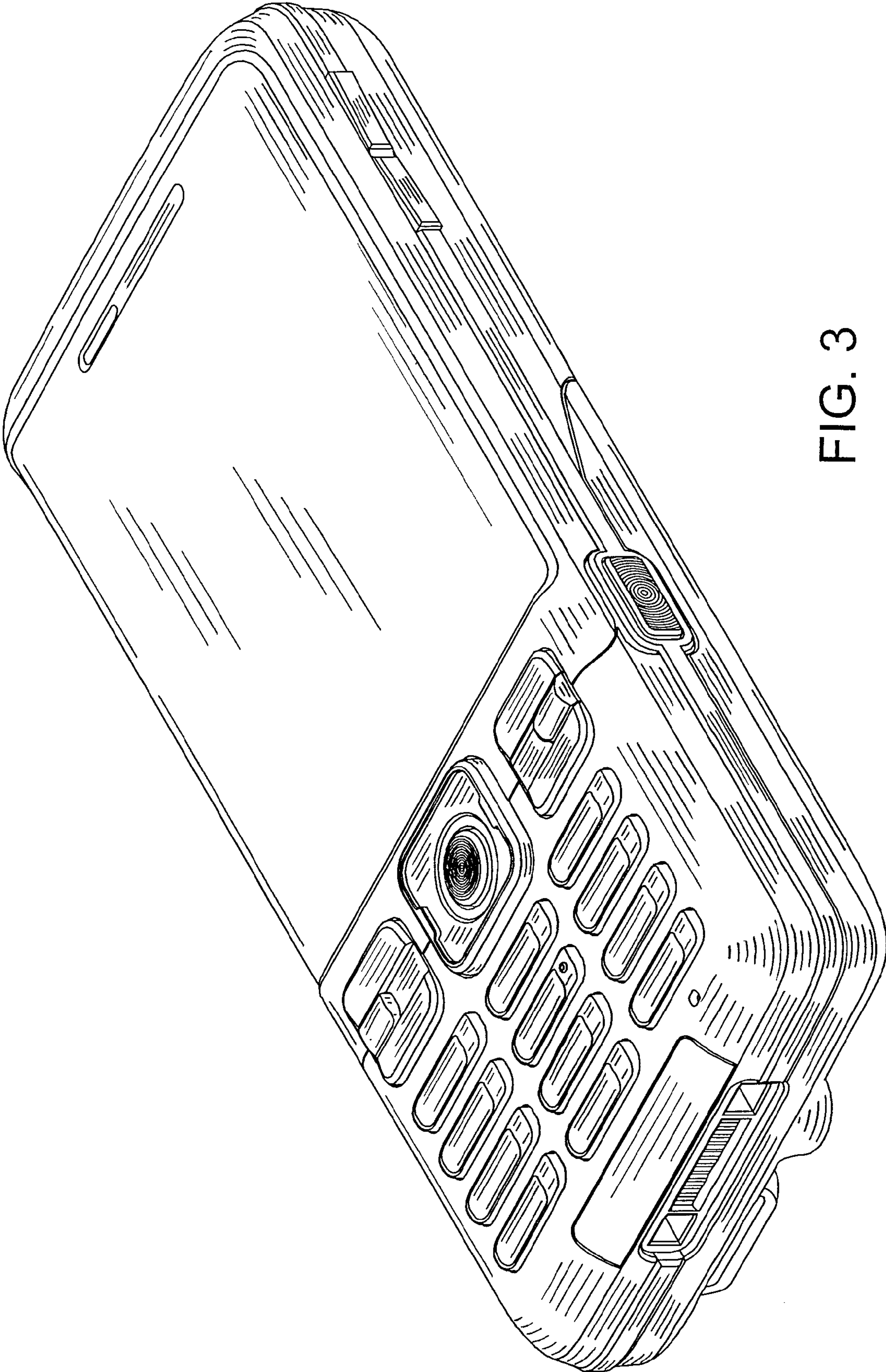

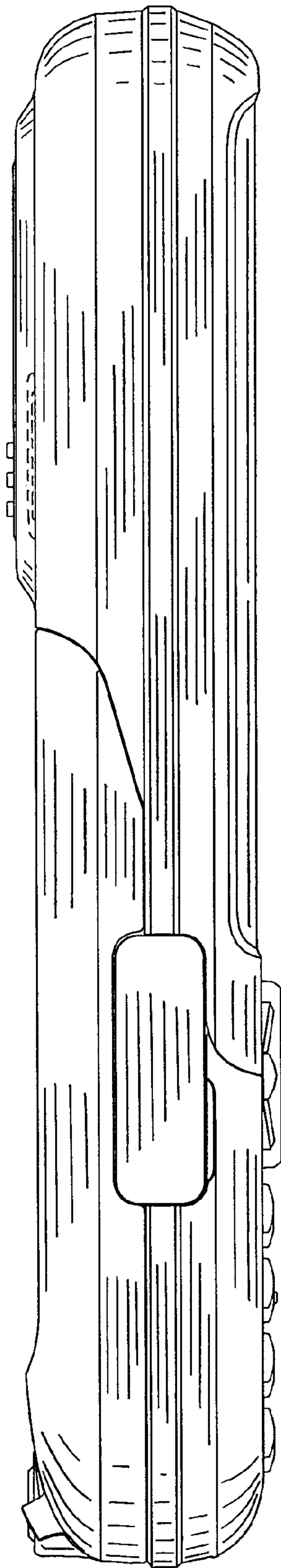

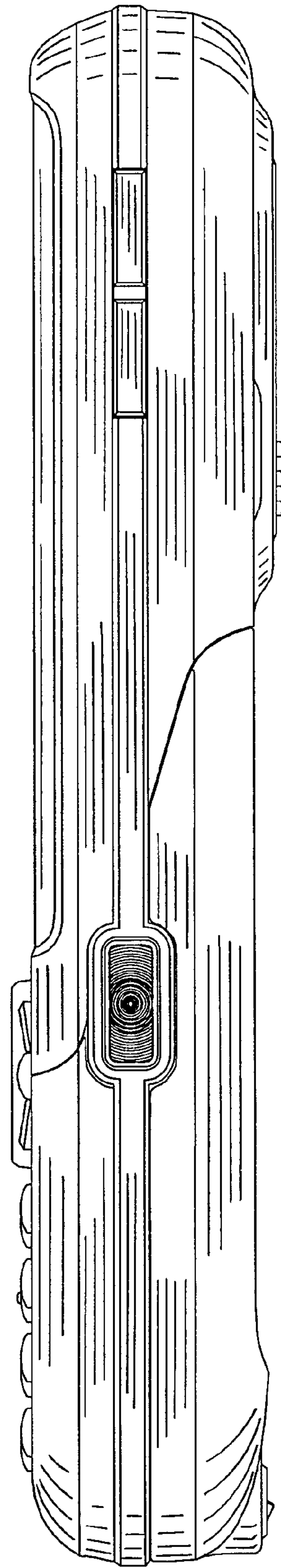

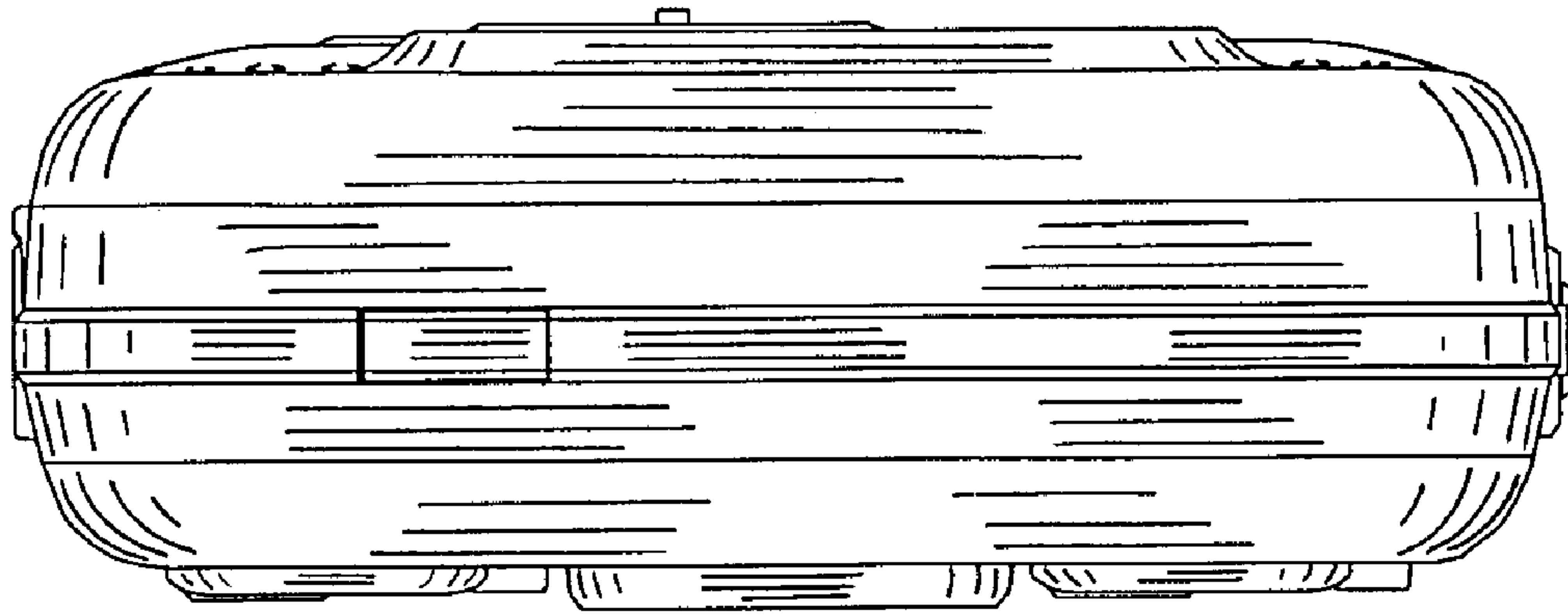

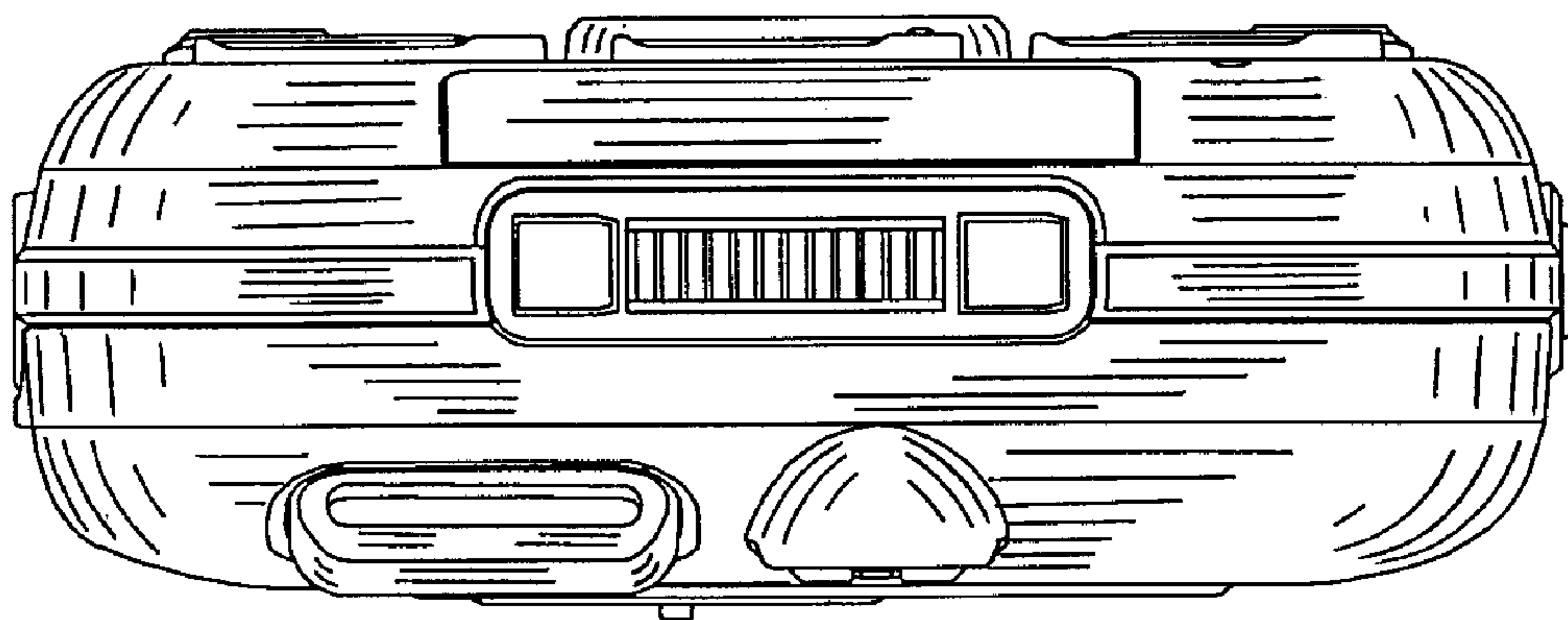
