DESCRIPTION

FIG. 1 is a front perspective view of a headphone showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

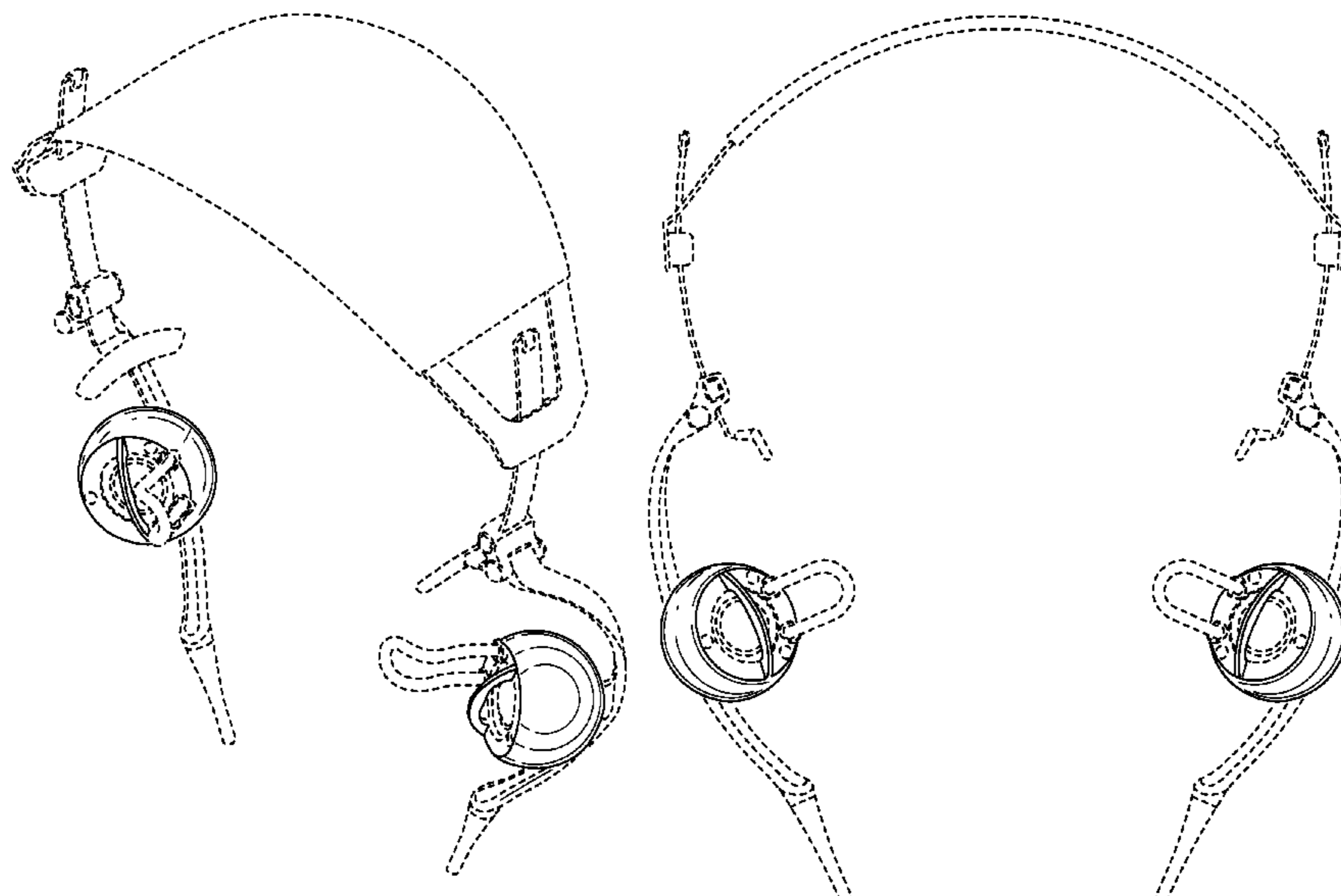

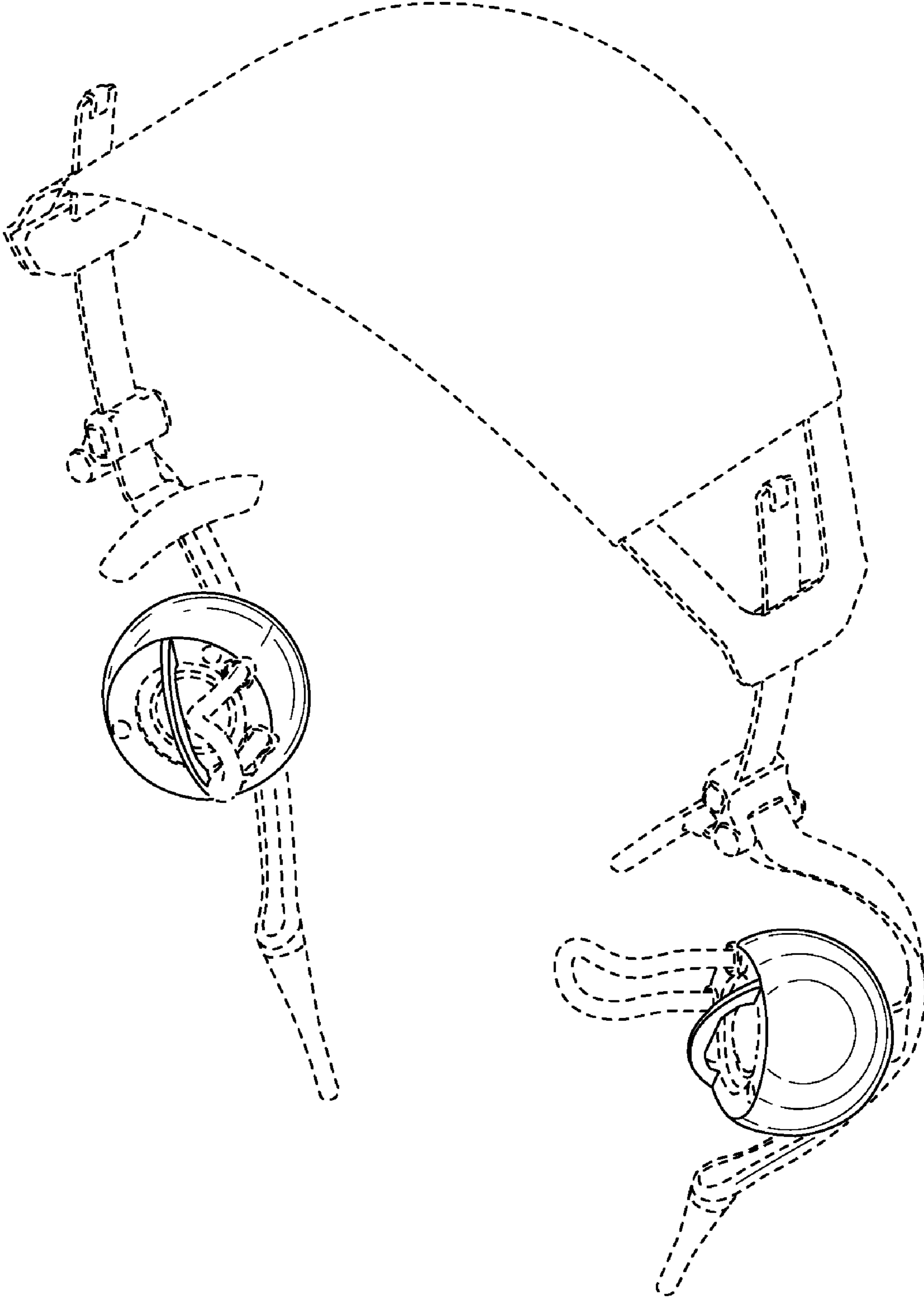

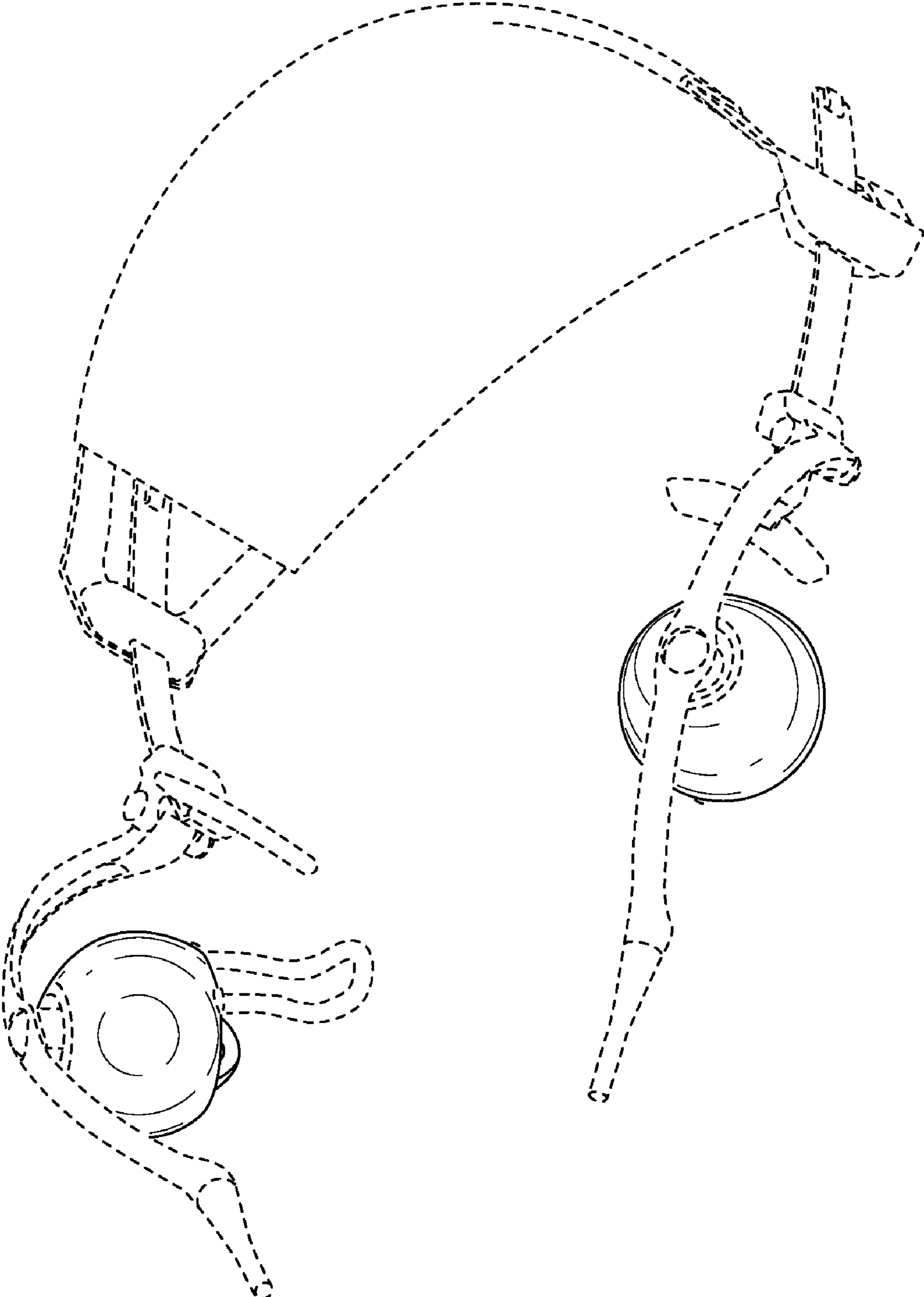

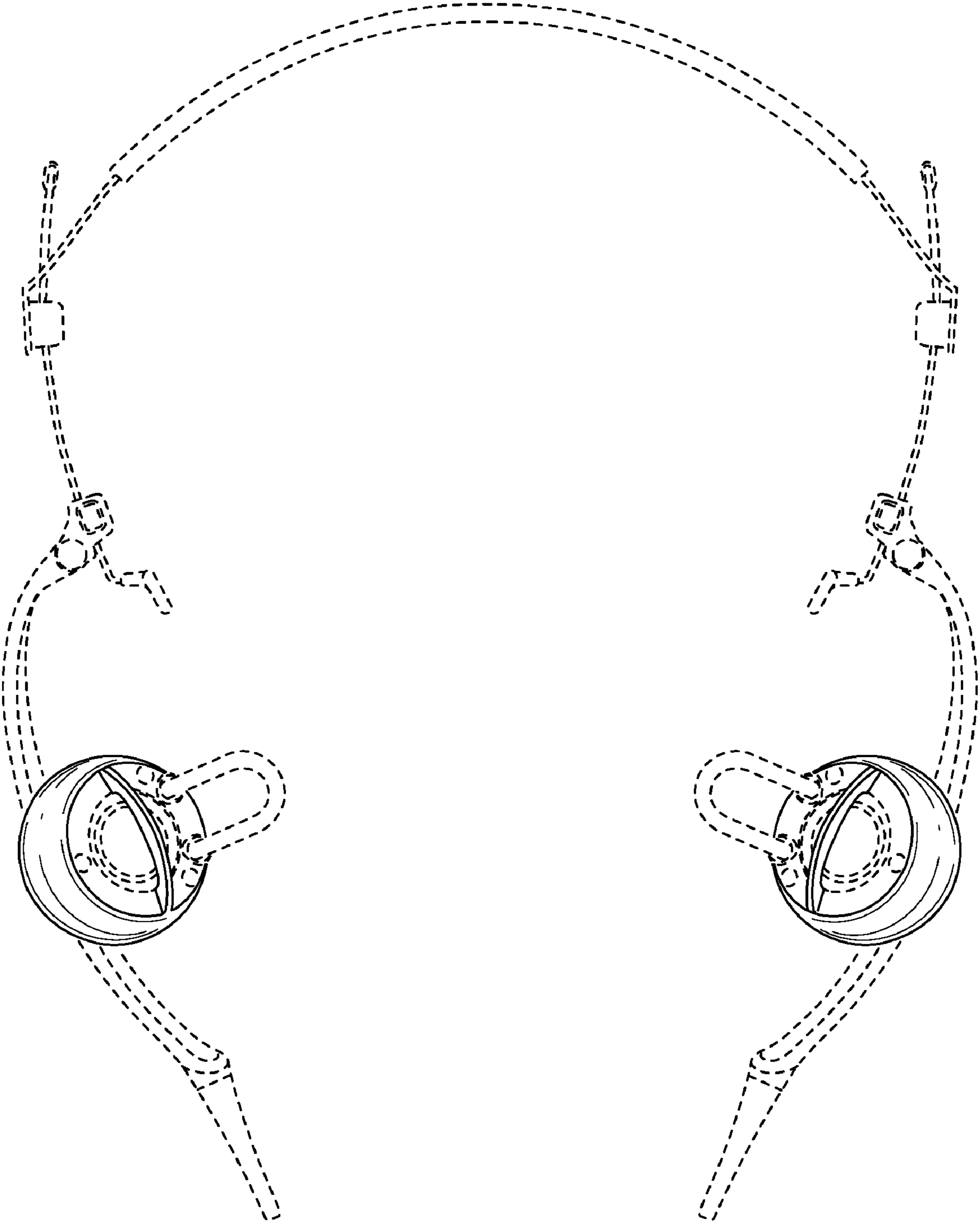

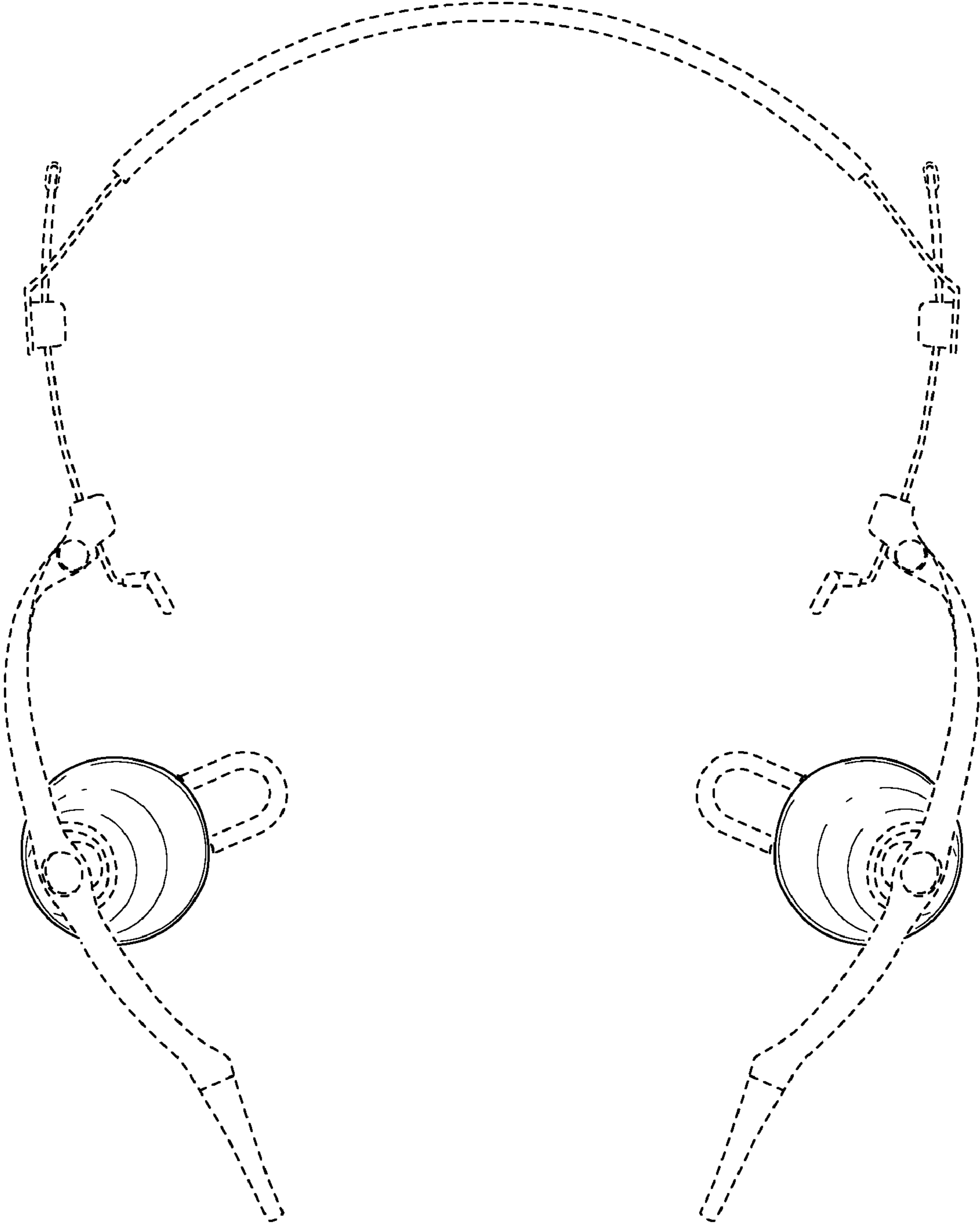

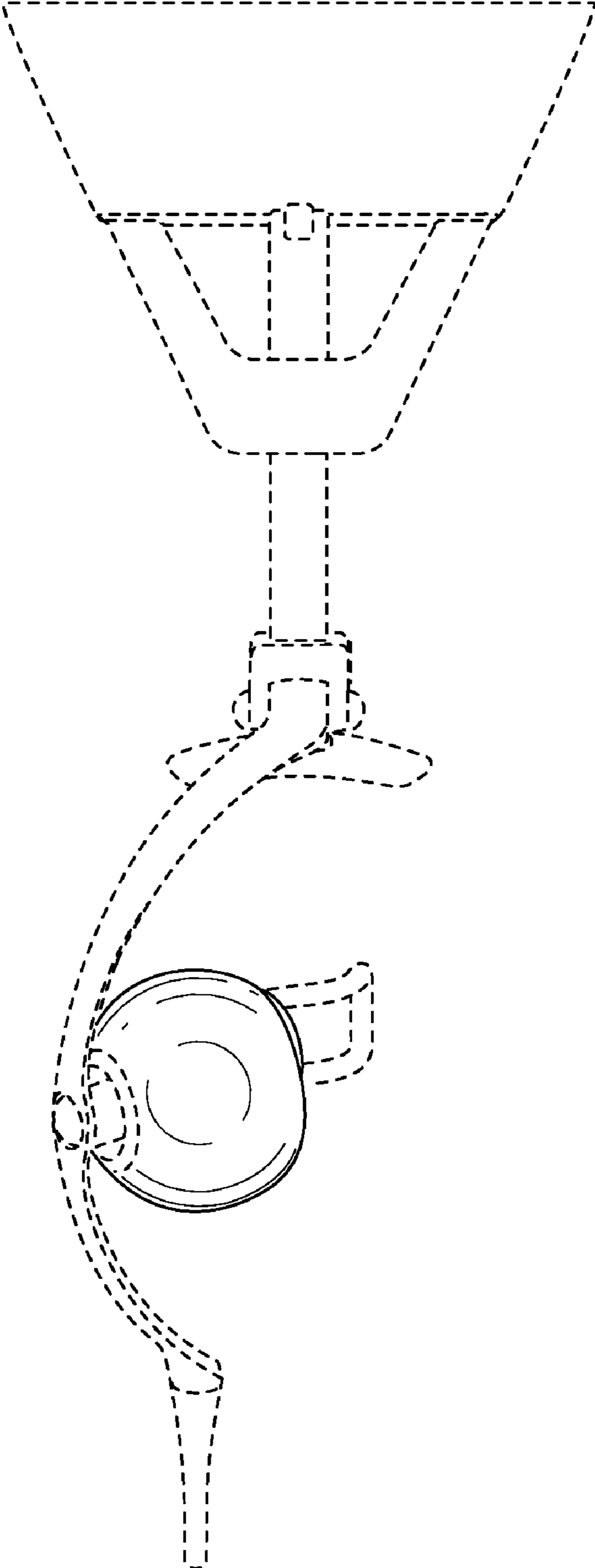

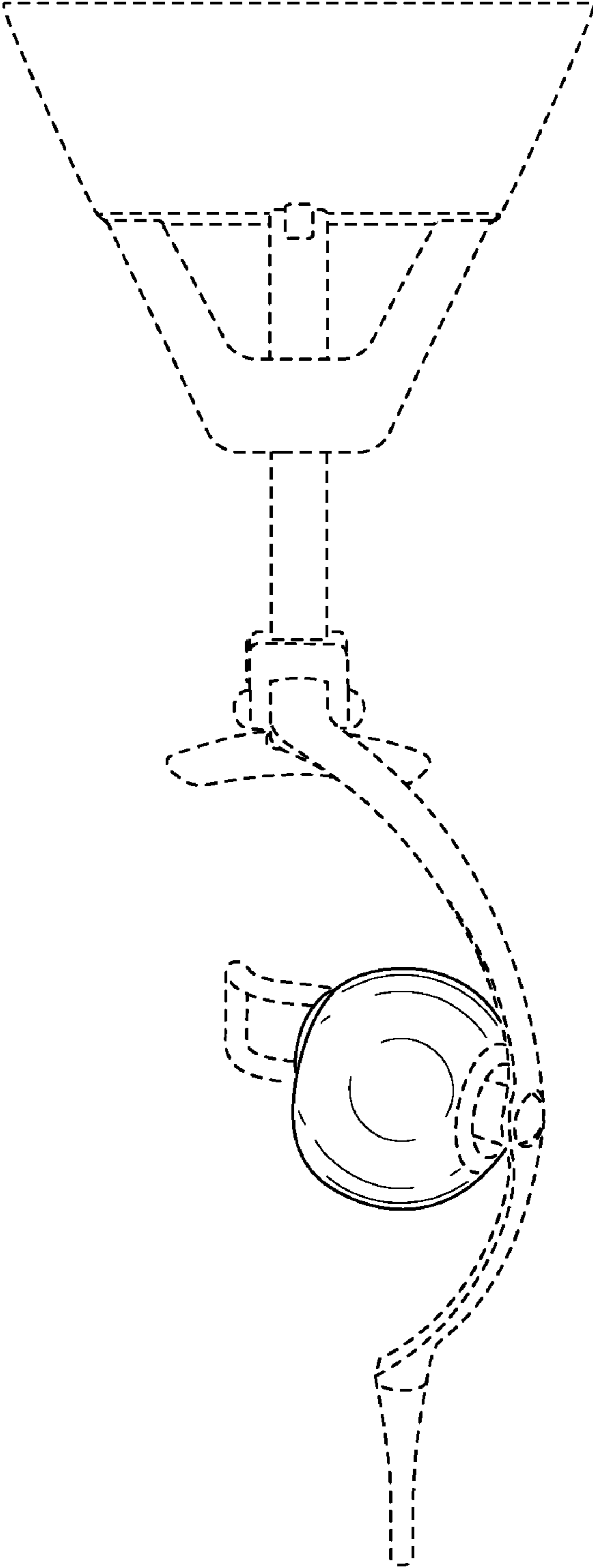

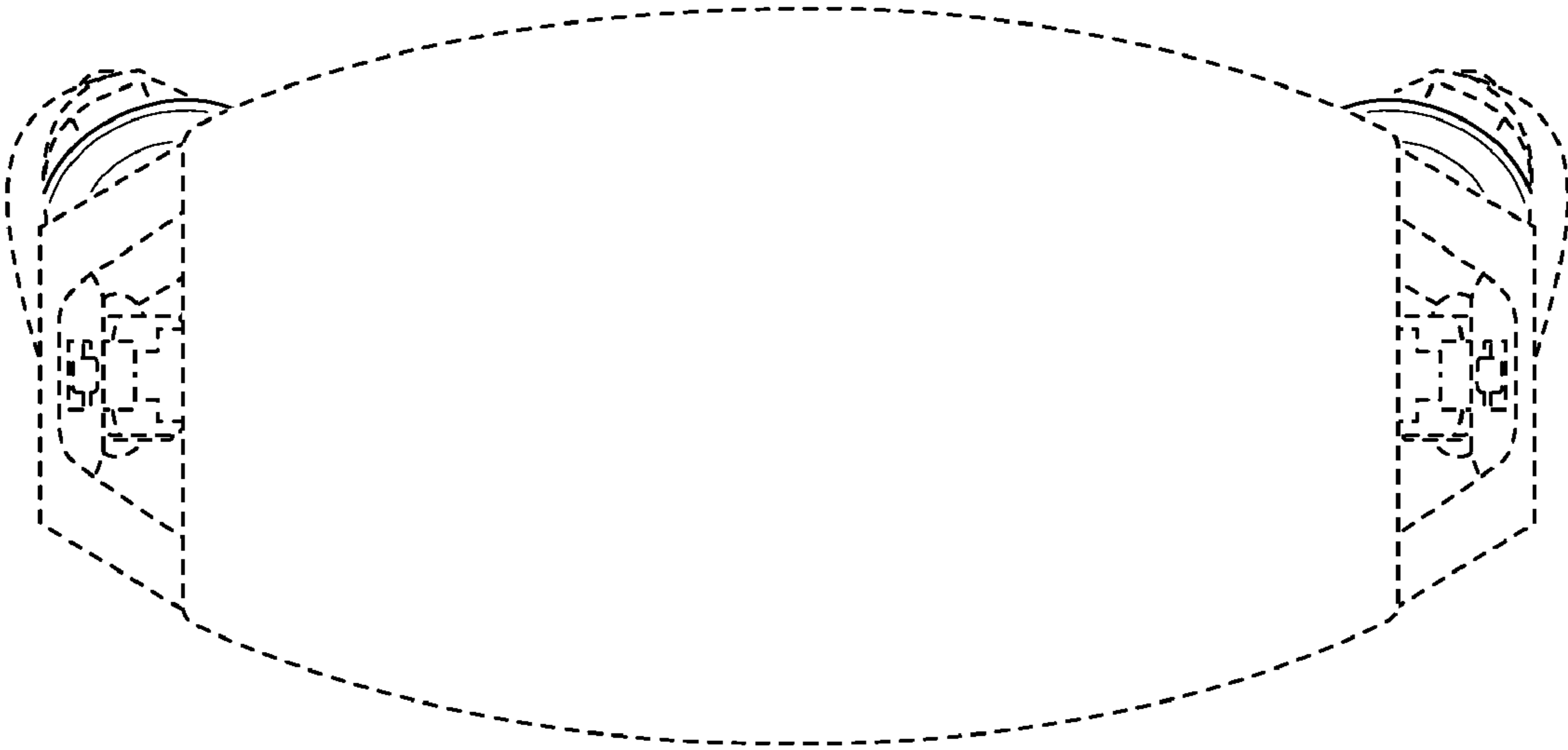
