The ornamental design for a graphical user interface for a portion of a display, shown and described.

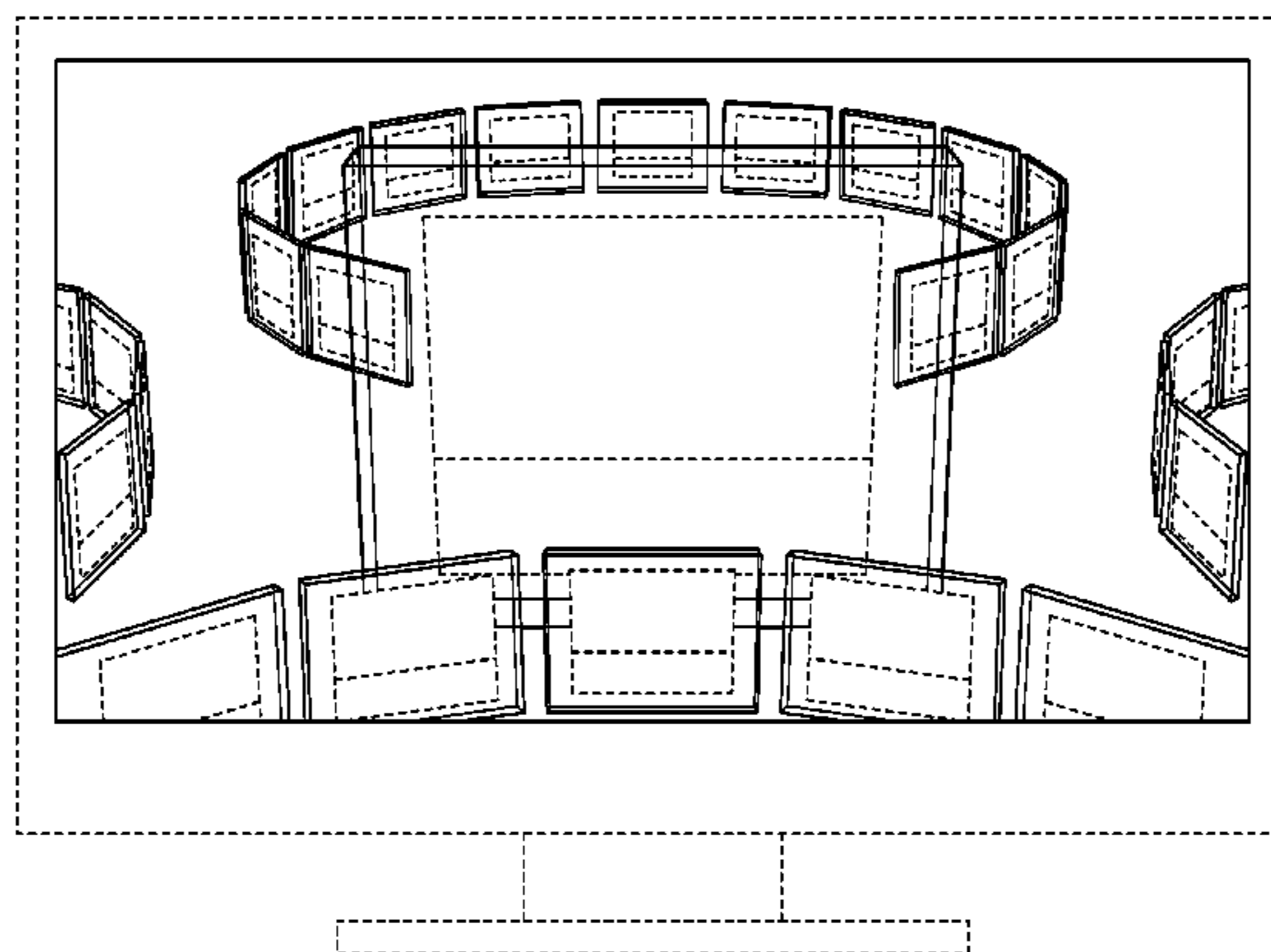
DESCRIPTION

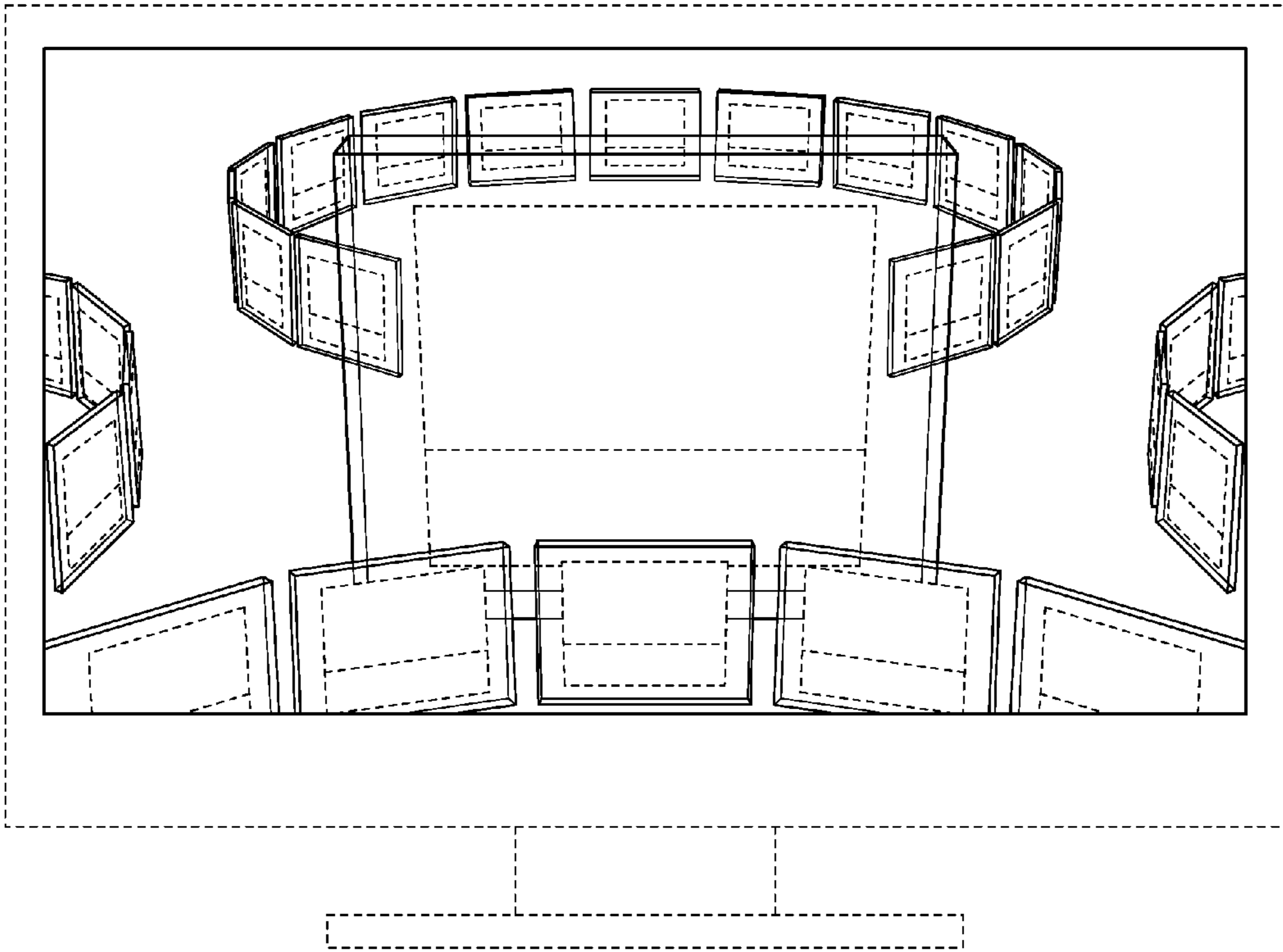
