The ornamental design for an operating device for an audio and video device, as shown.

DESCRIPTION

FIG. 1 is a front elevation view of an operating device for an audio and video device showing our new design;

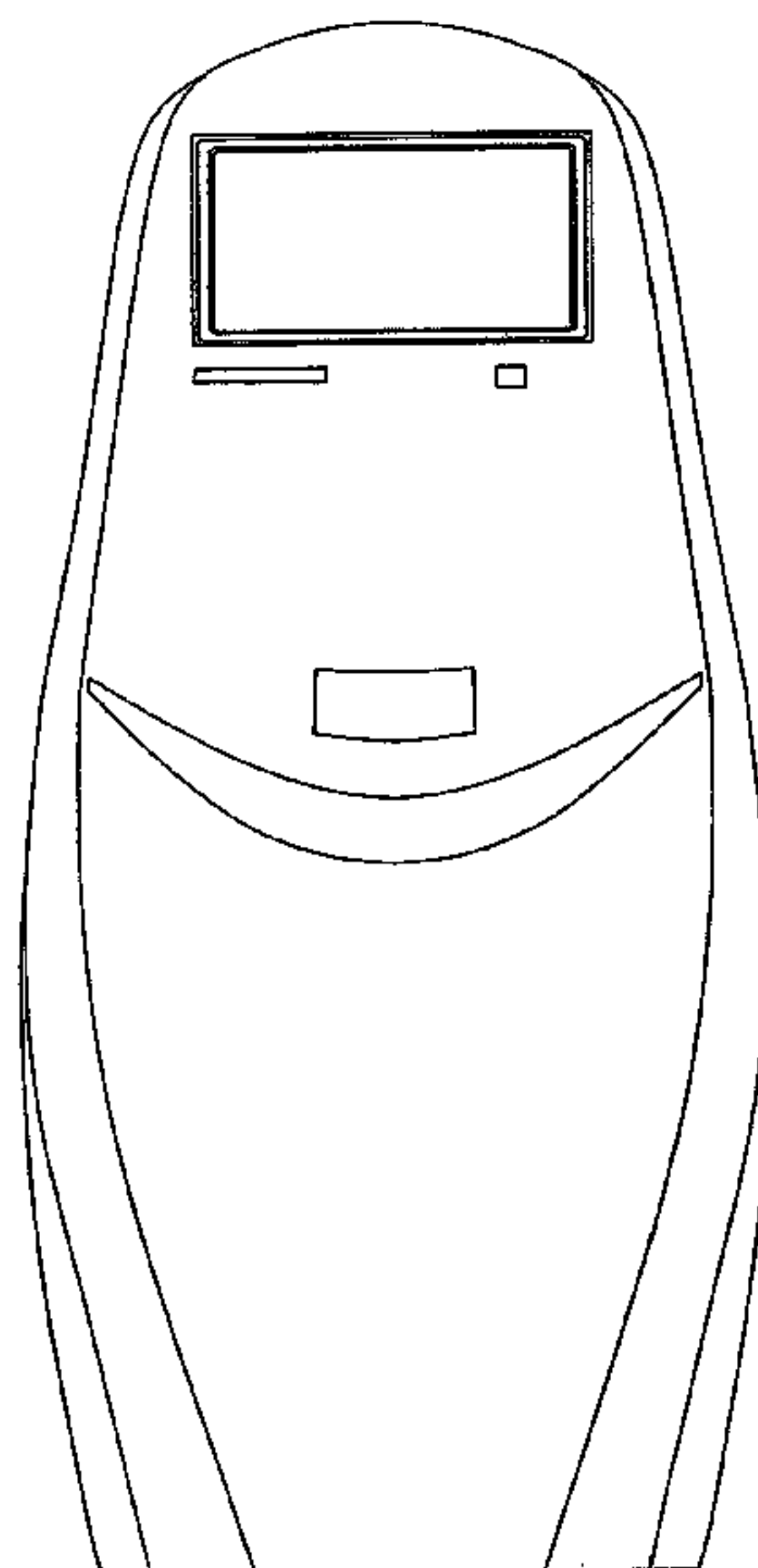

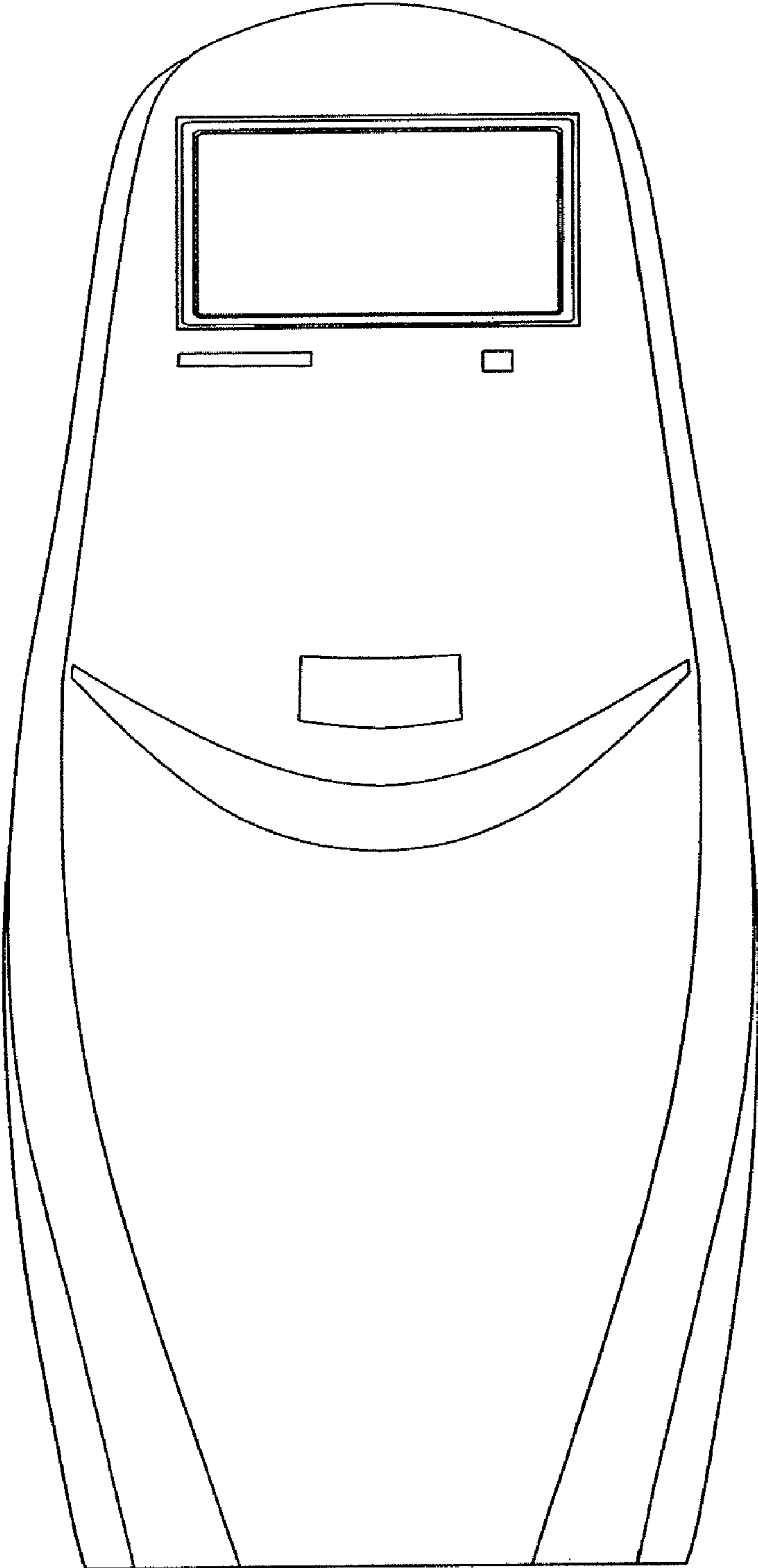

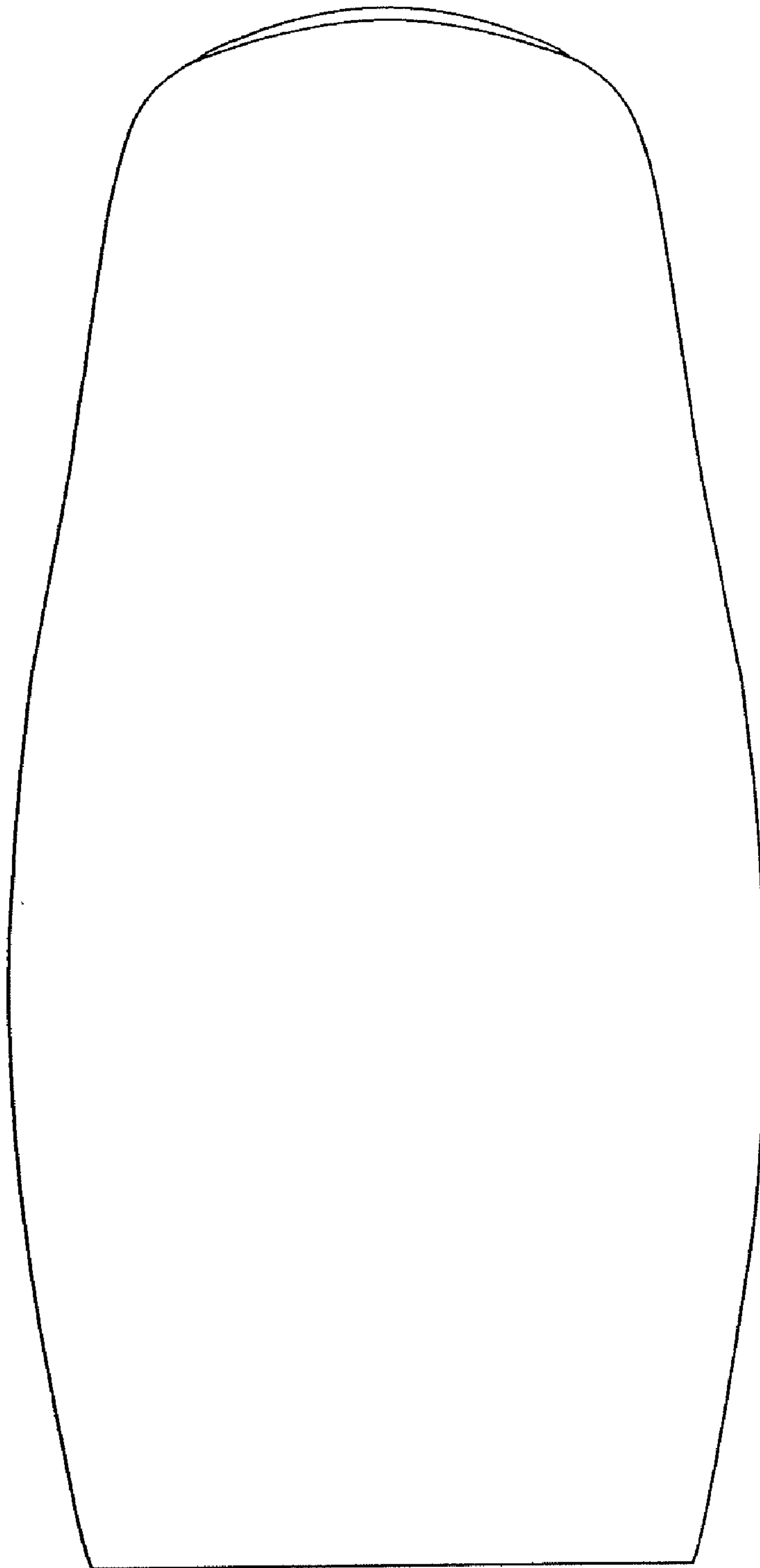

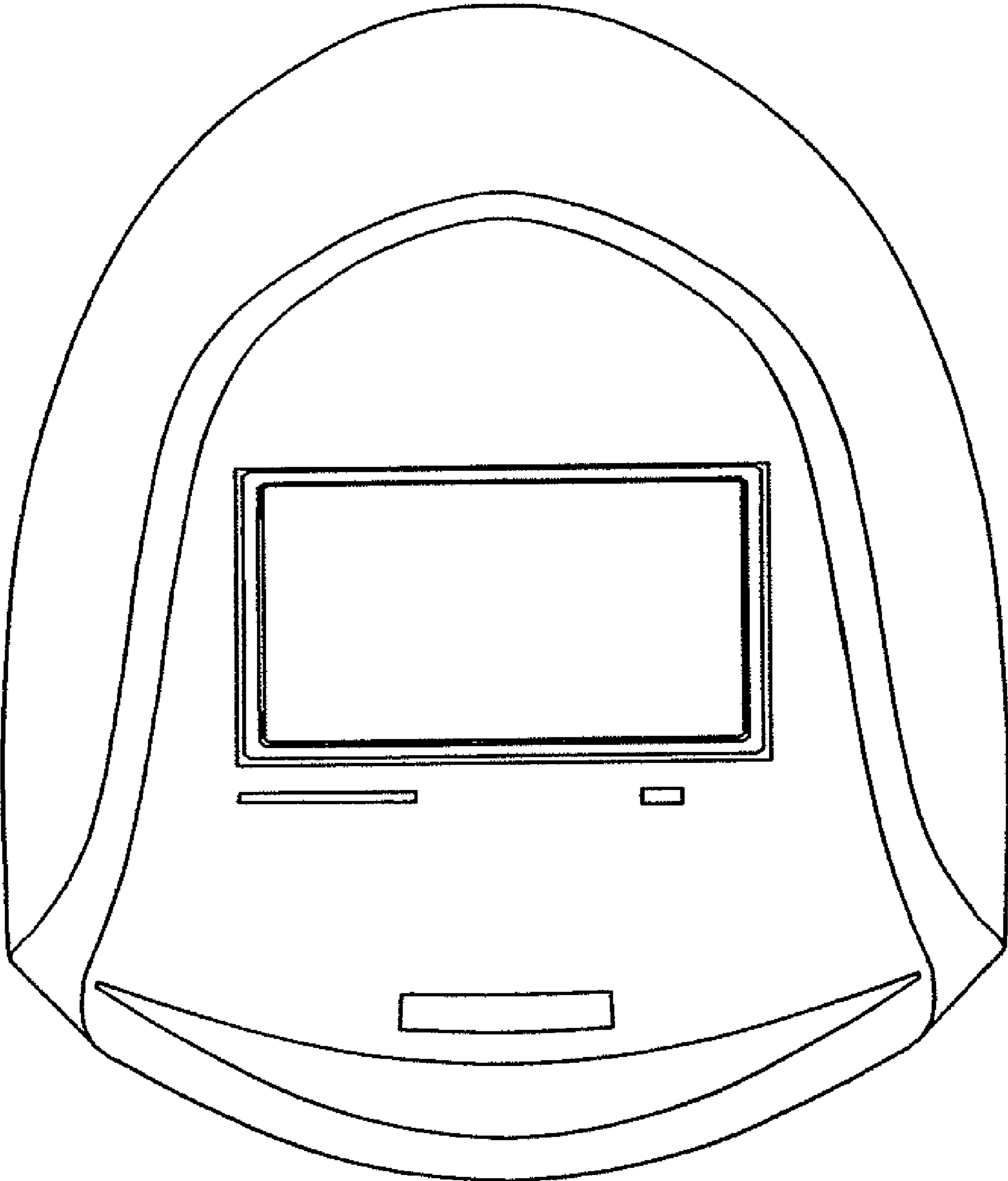

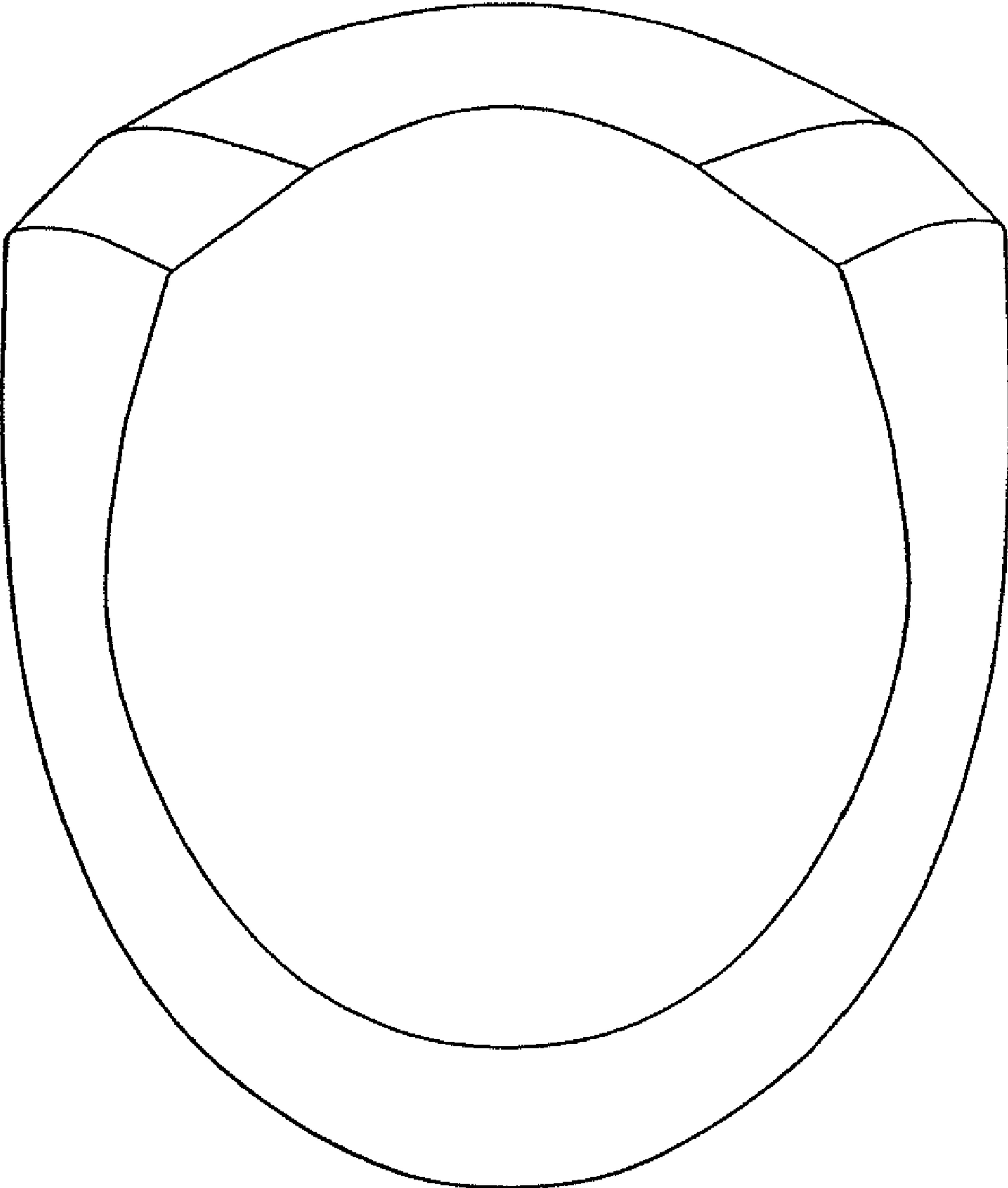

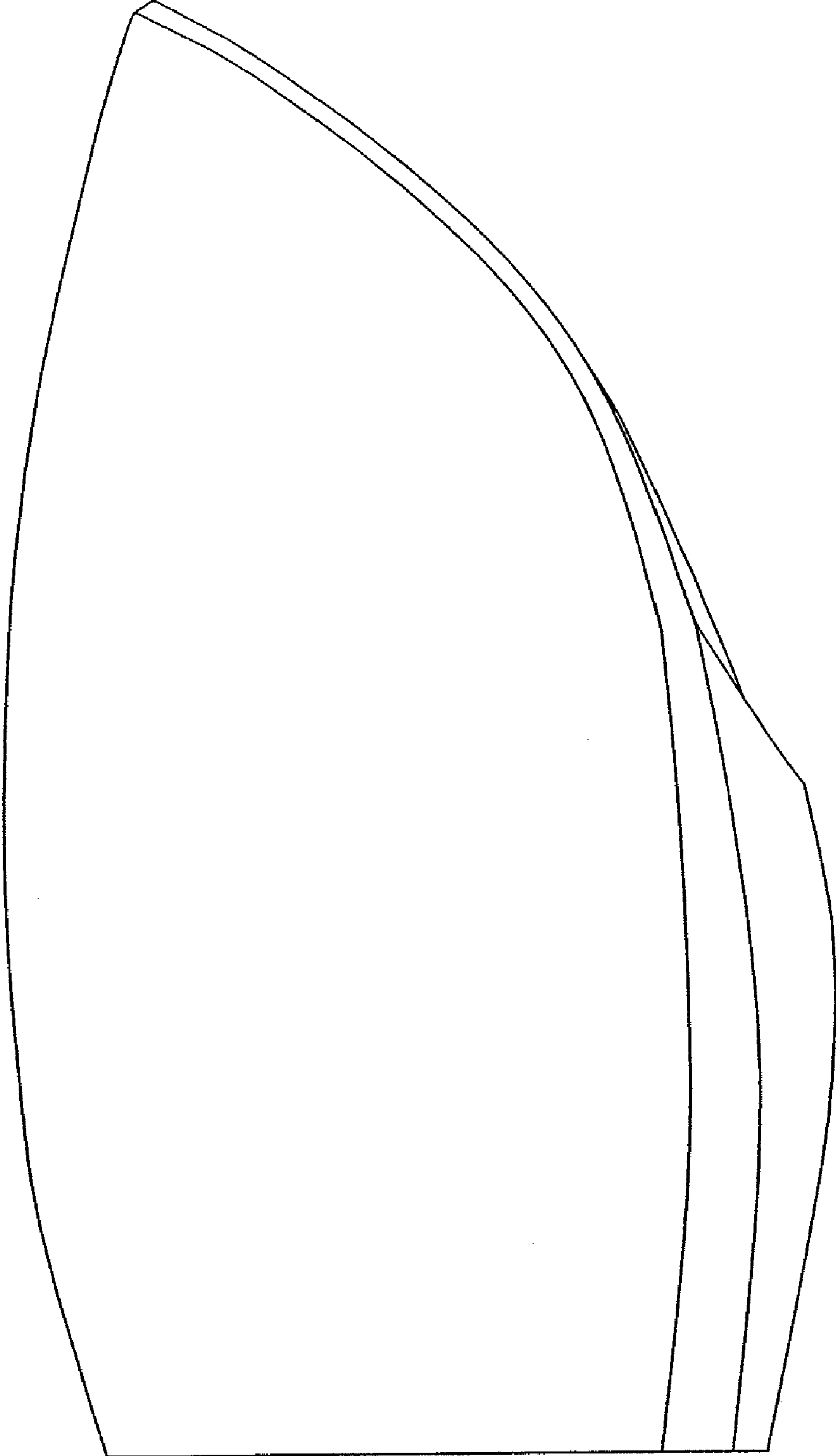
