(57) **CLAIM**

The ornamental design for an aromatherapy elastic band, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an aromatherapy elastic band showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

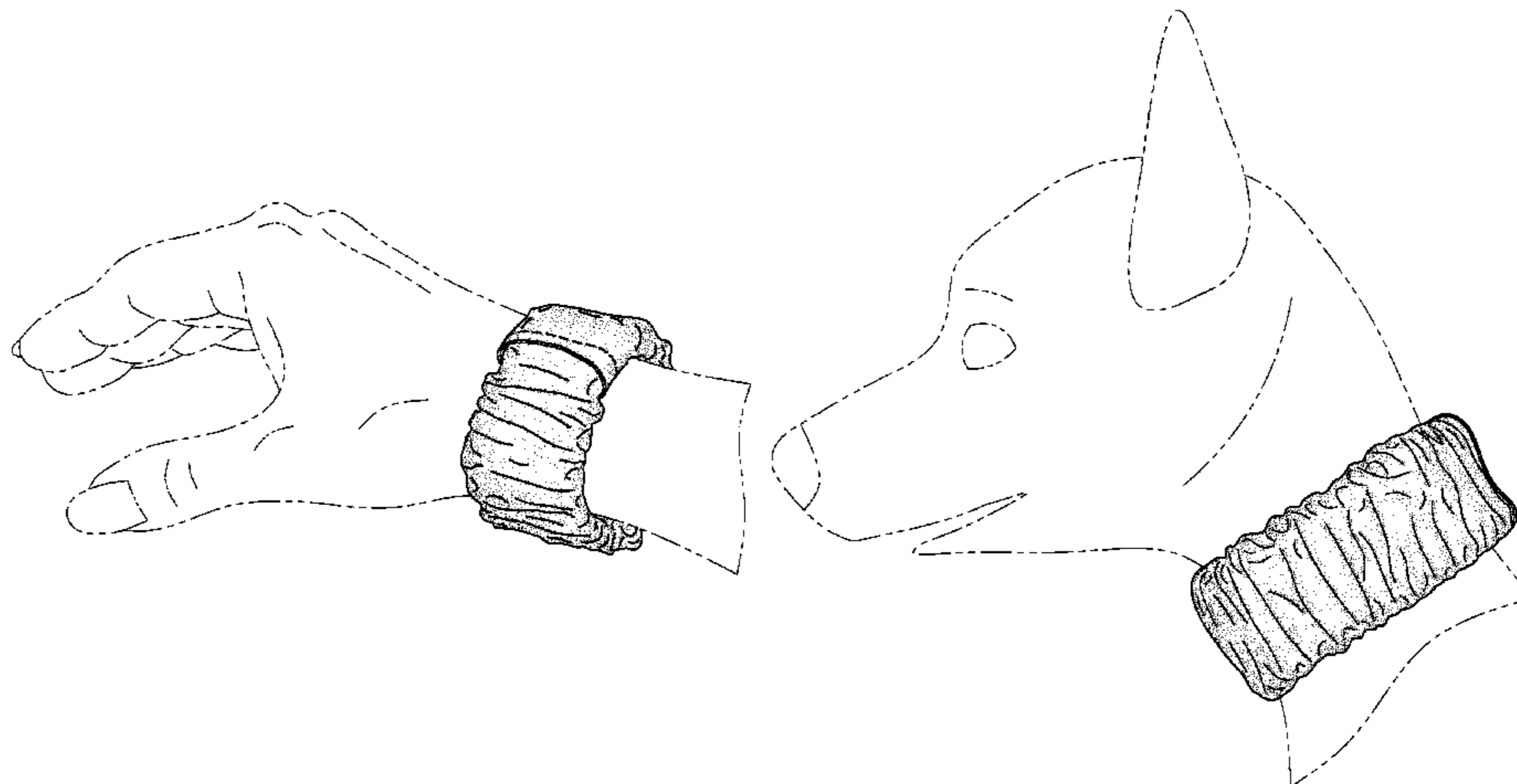
FIG. 8 is a perspective view of my invention shown being worn on the wrist of a person shown in phantom;

FIG. 9 is a perspective view showing installation of an aromatherapy pad shown in phantom into a pocket of the invention; and,

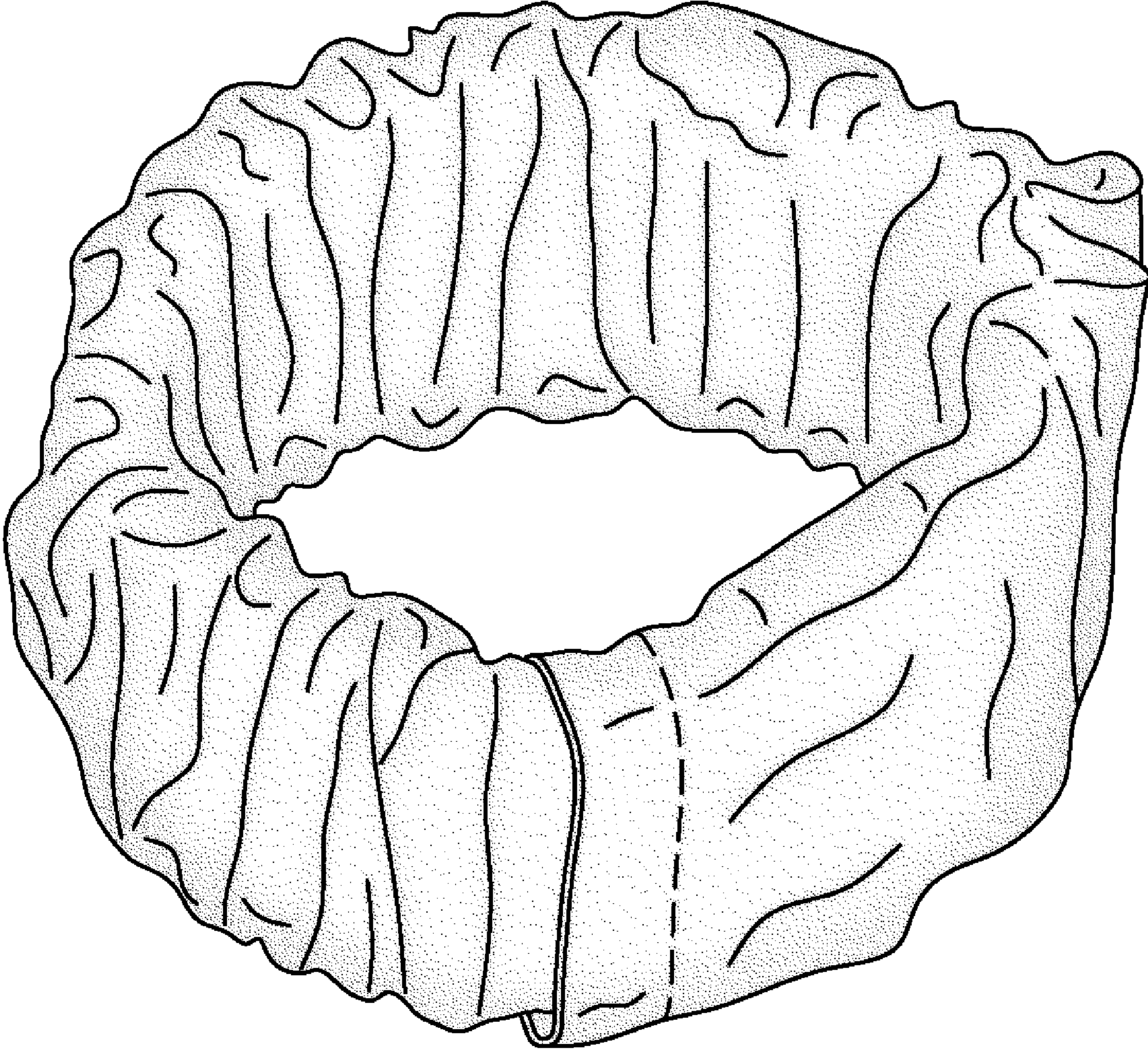

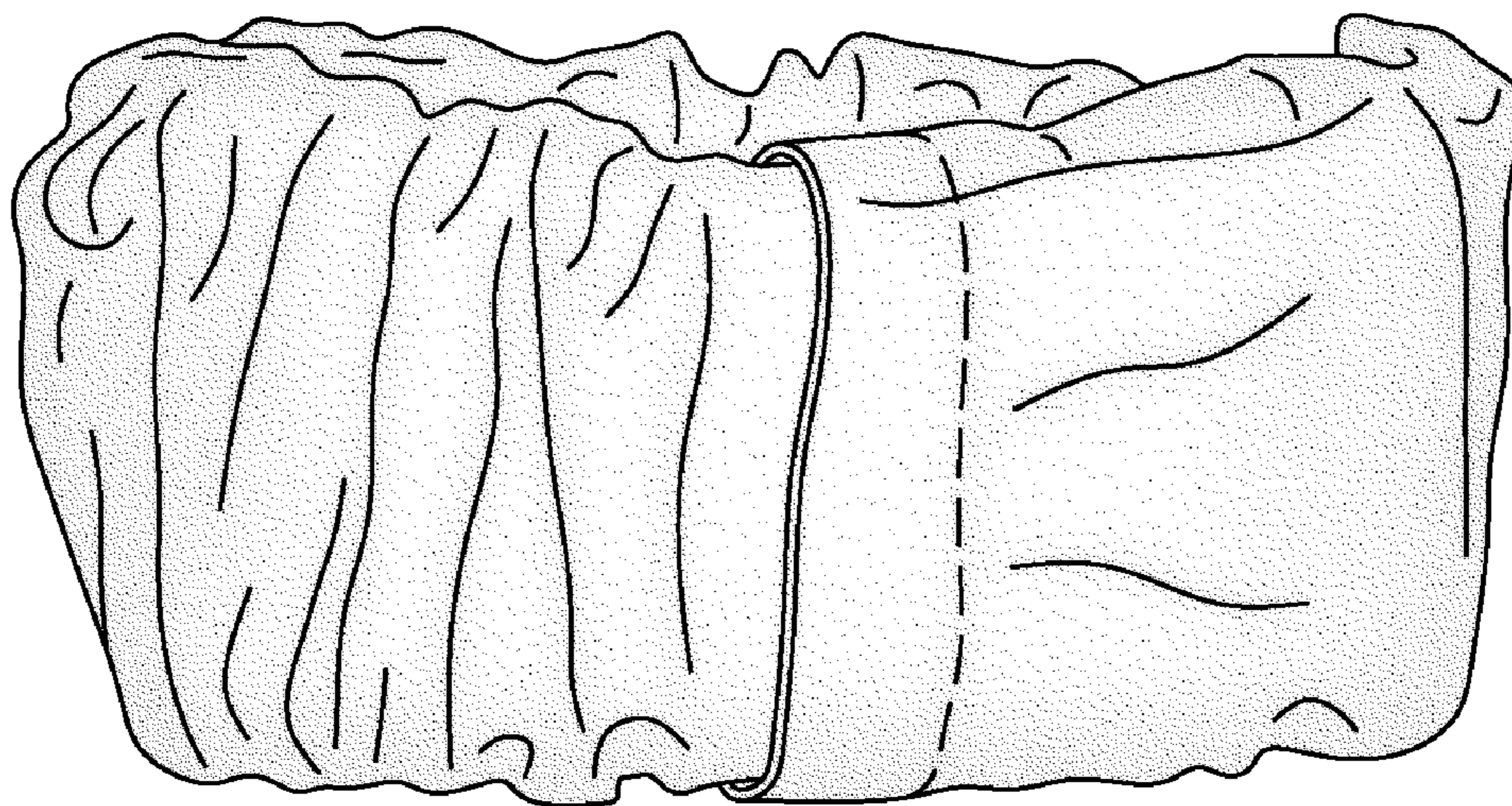

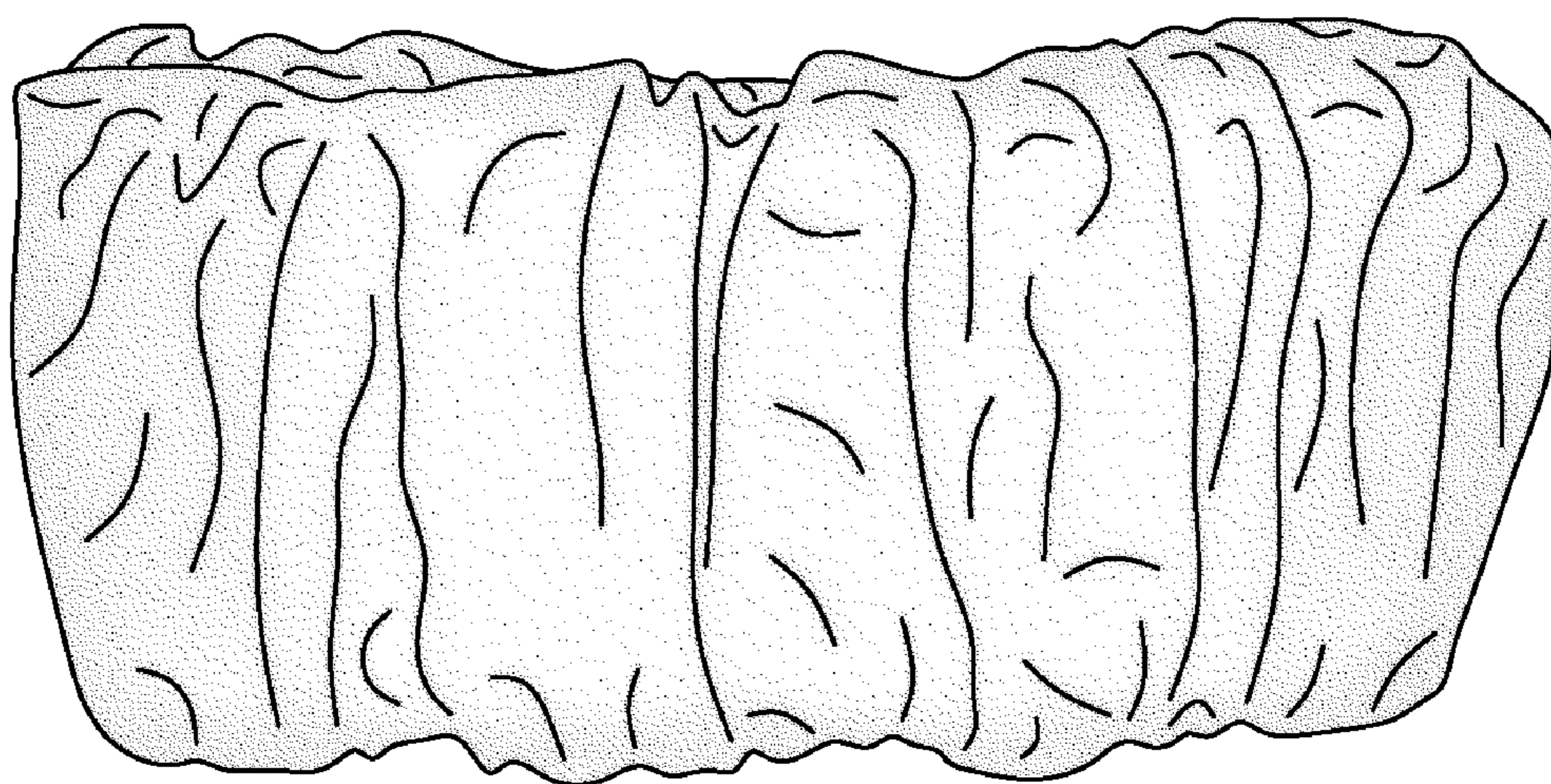

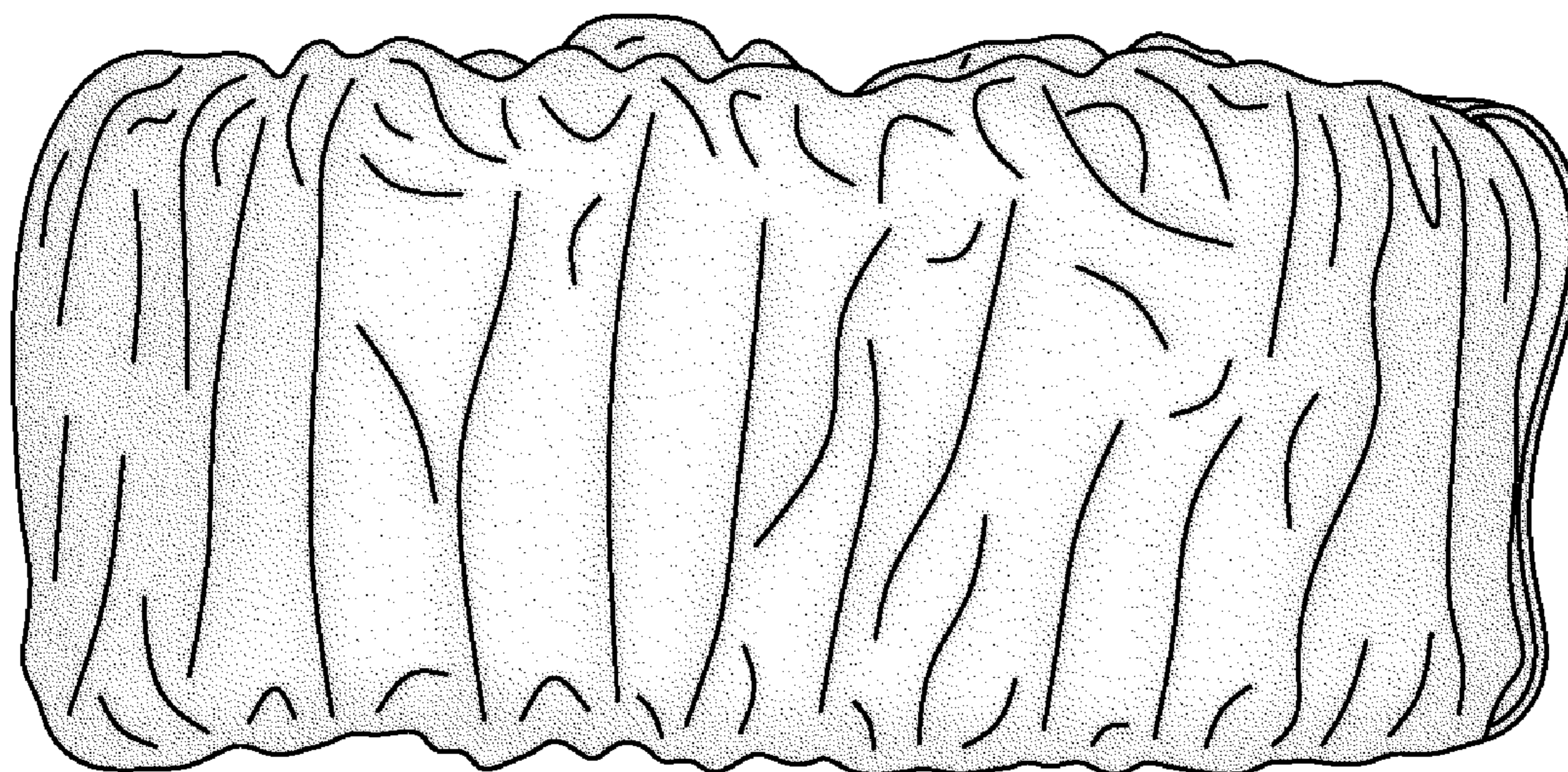

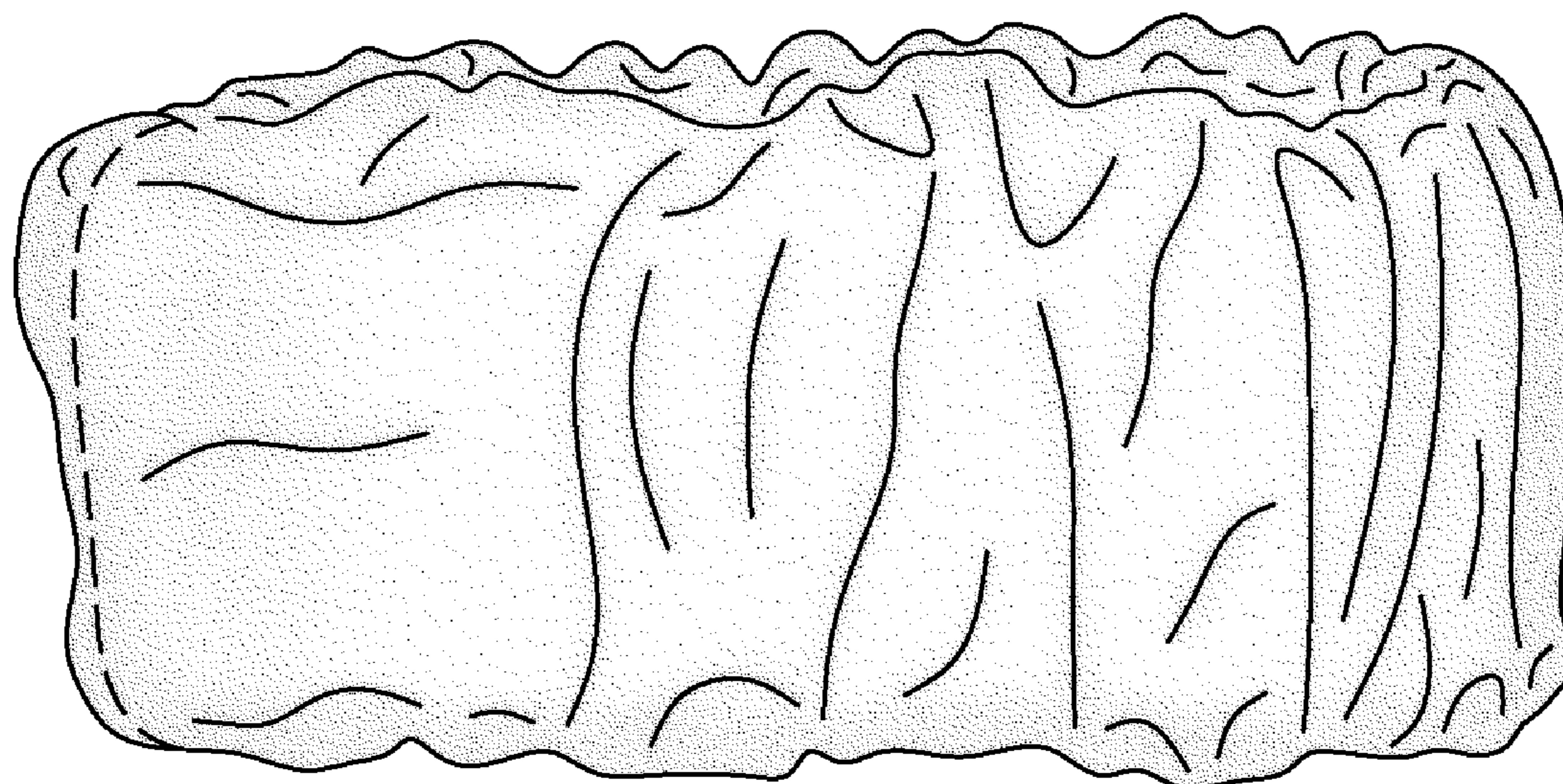

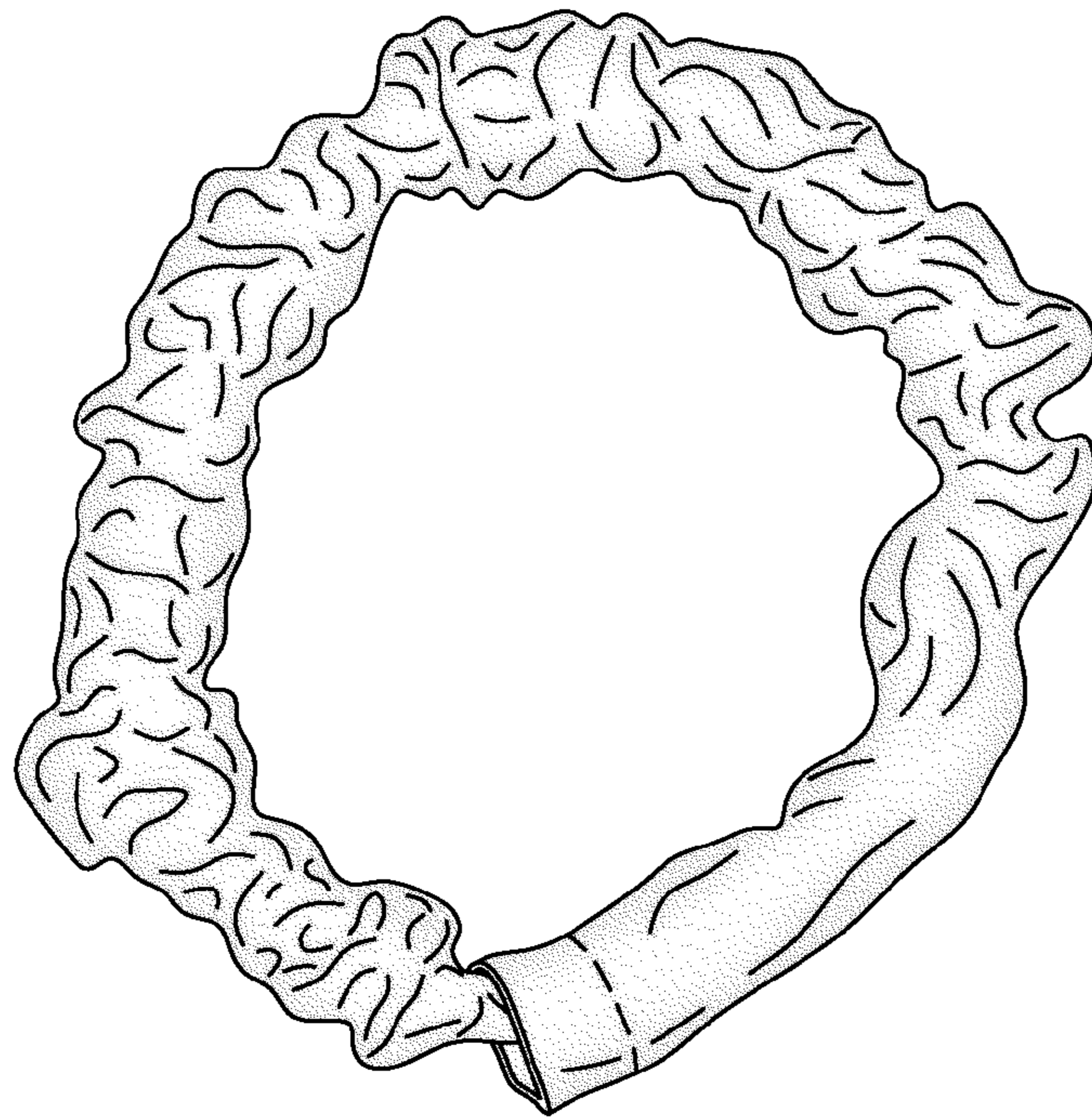

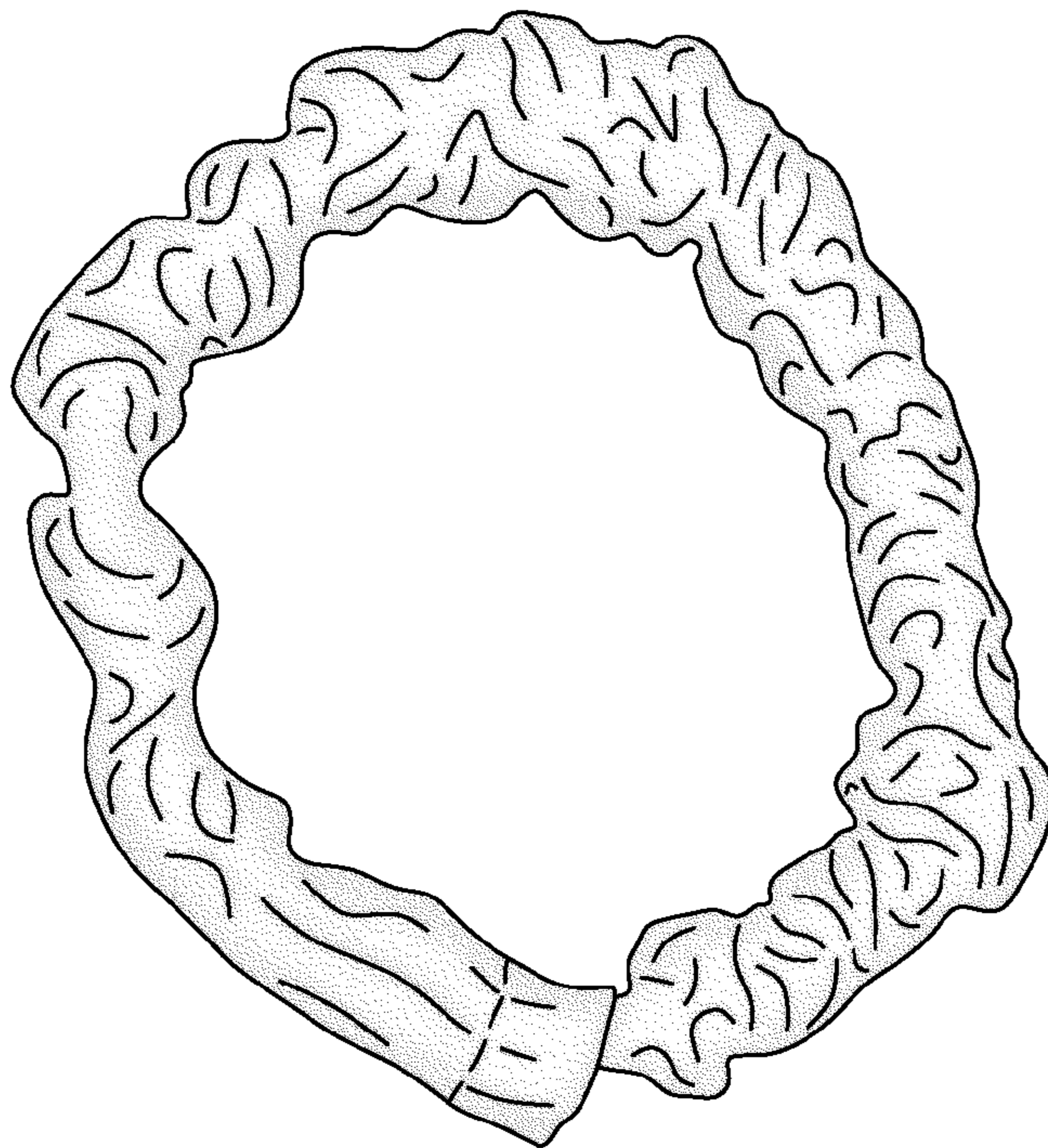

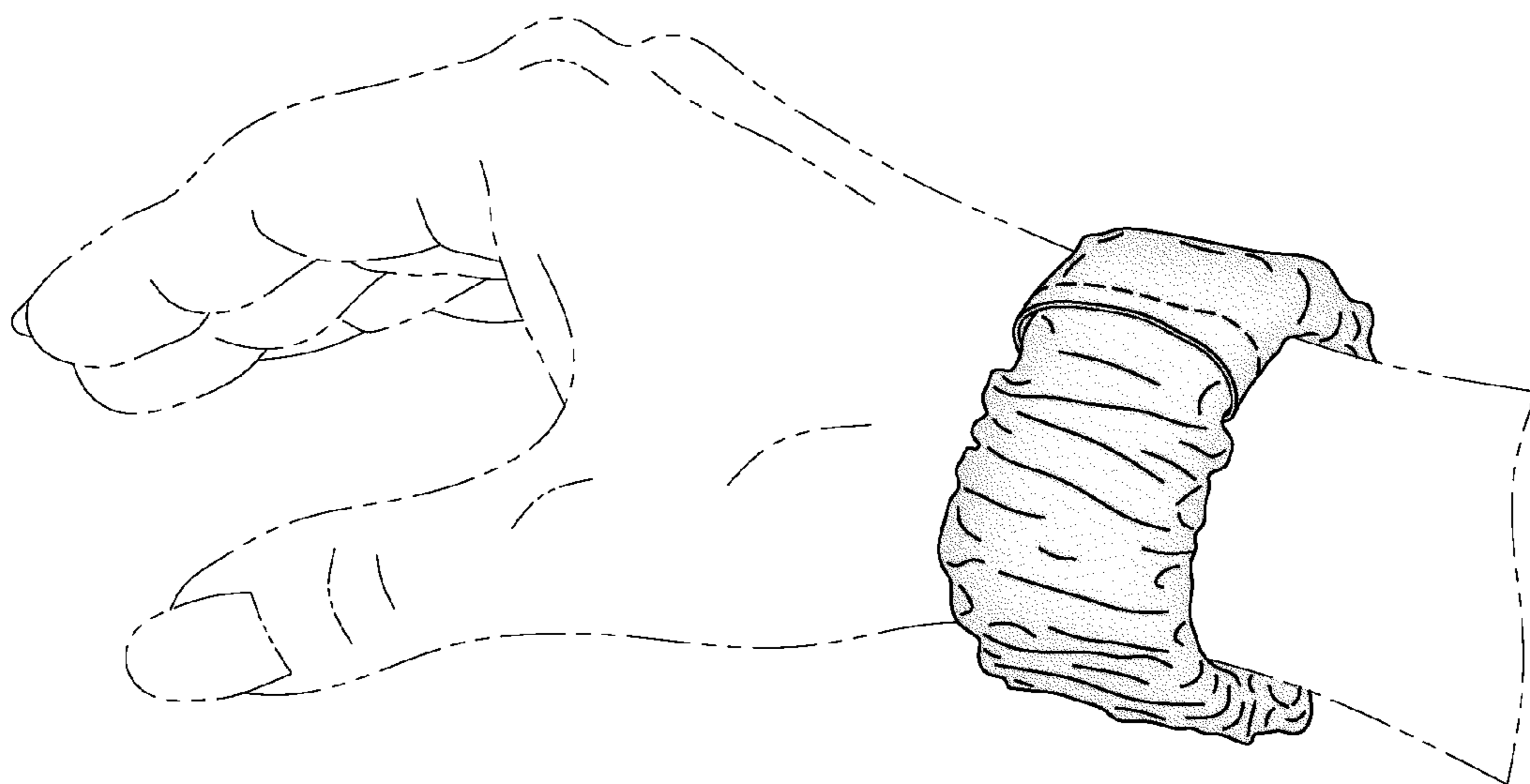

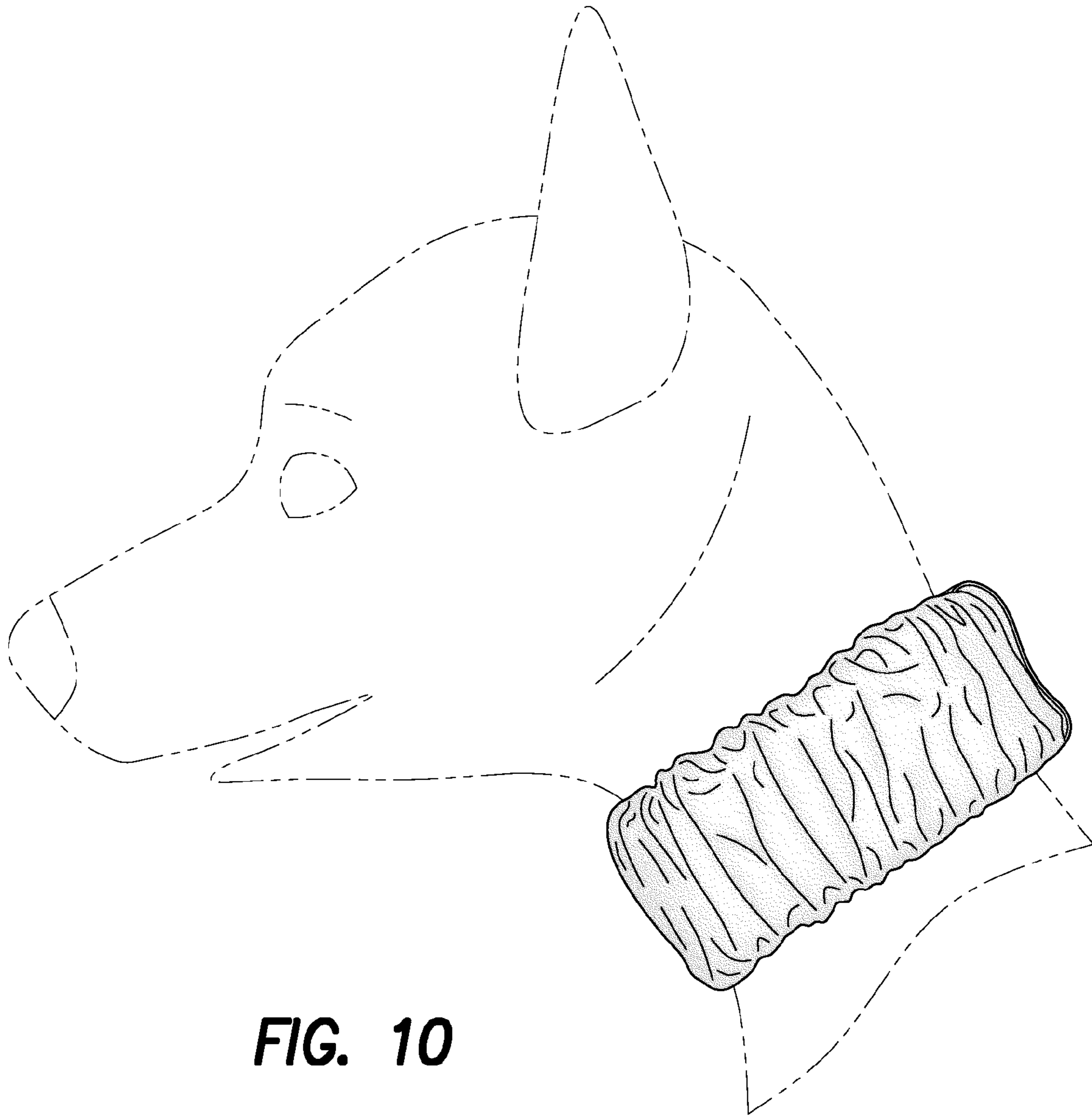
