**DESCRIPTION**

FIG. 3 is a rear elevational view of the invention;

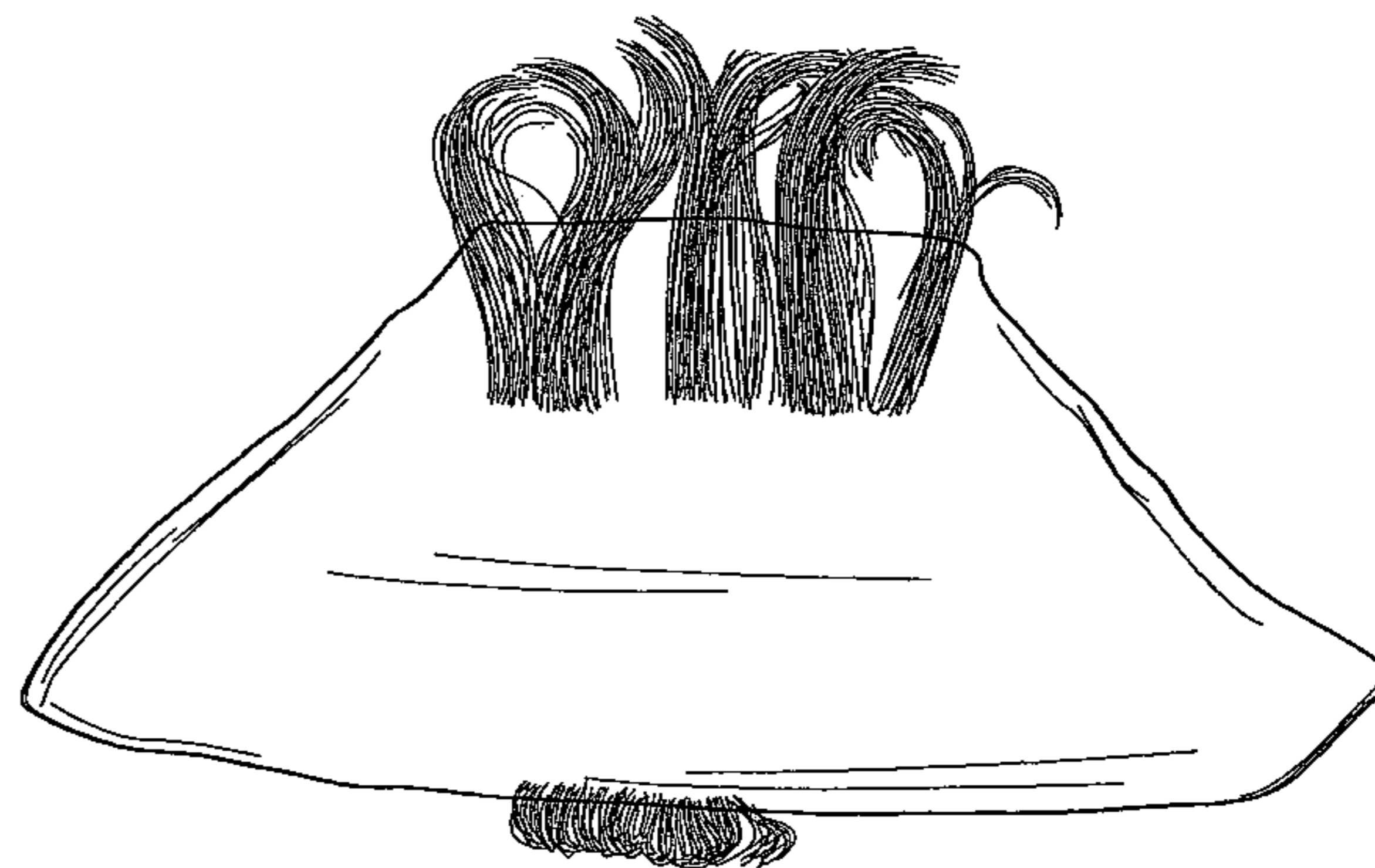
FIG. 4 is a left-side elevational view of the invention;

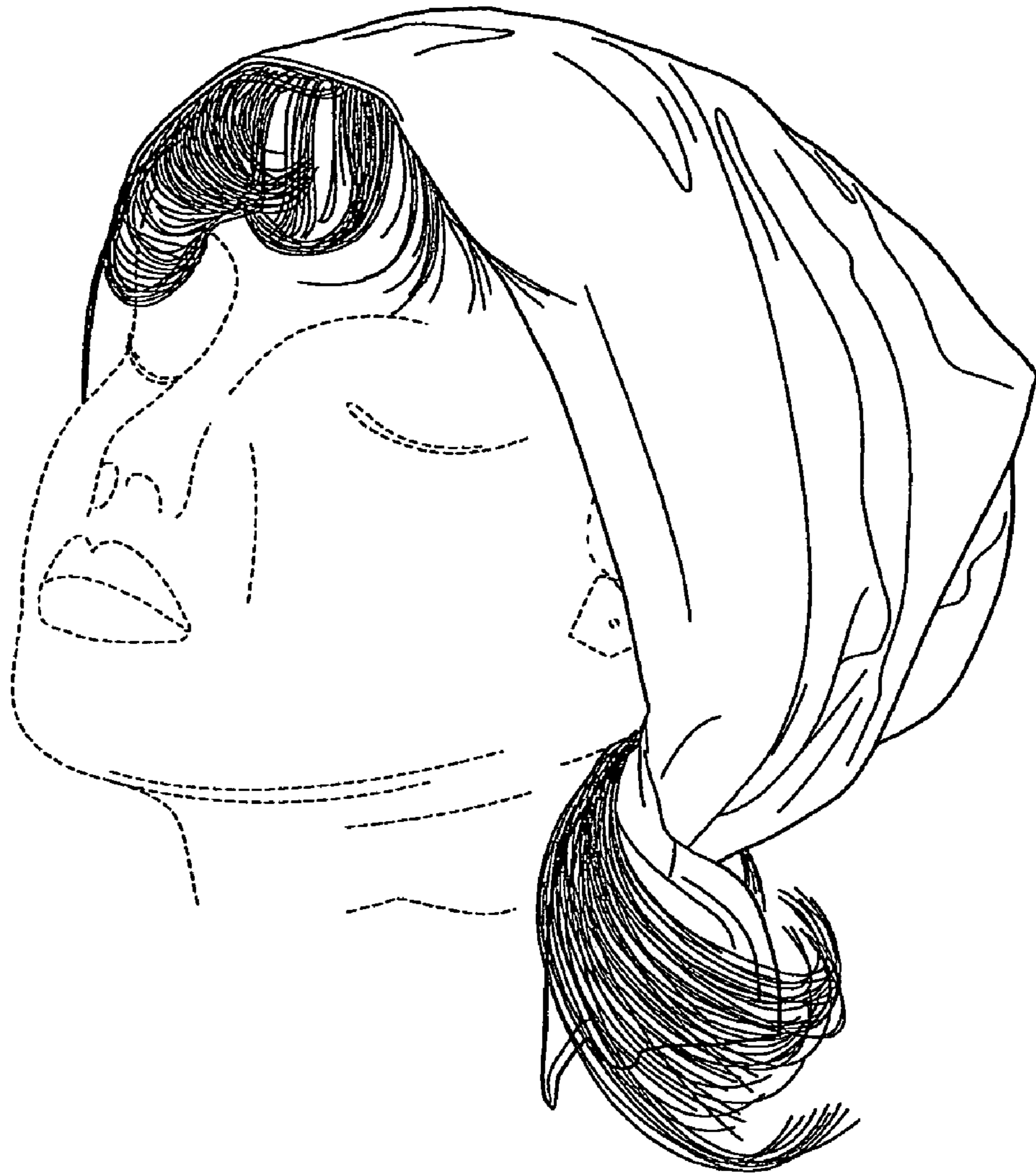

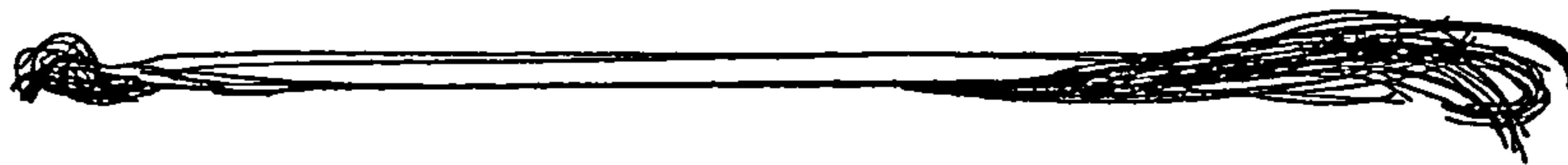

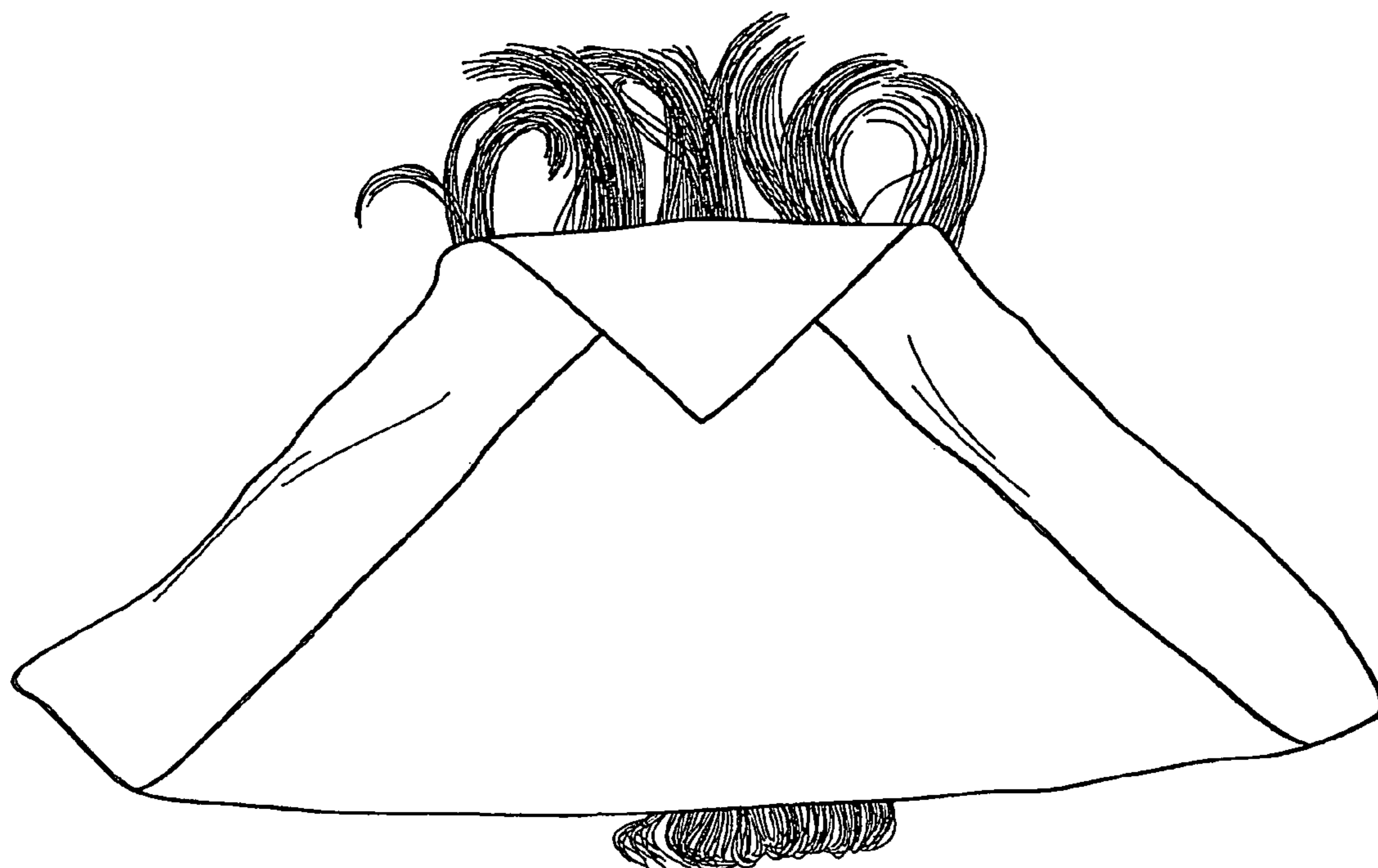

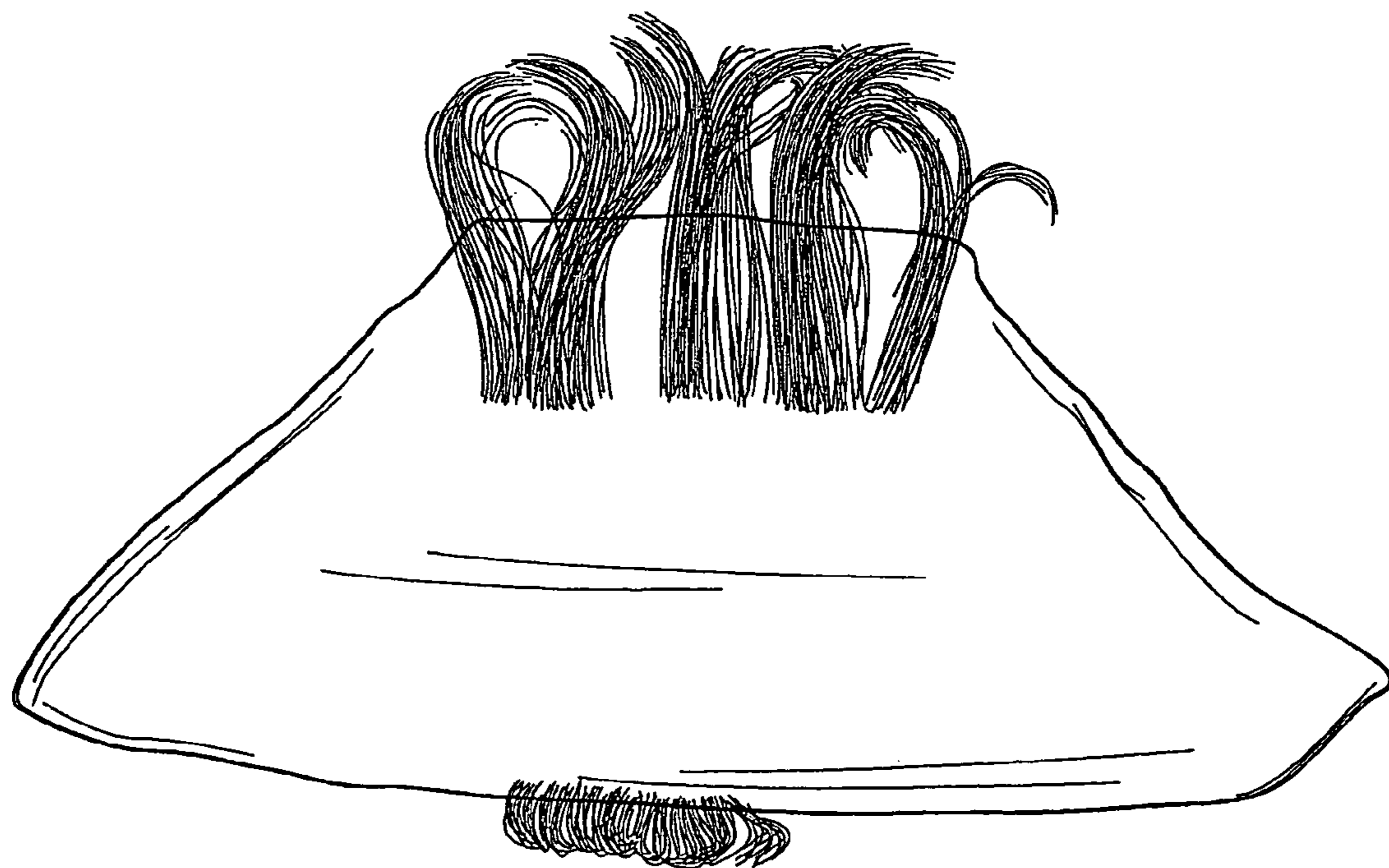
