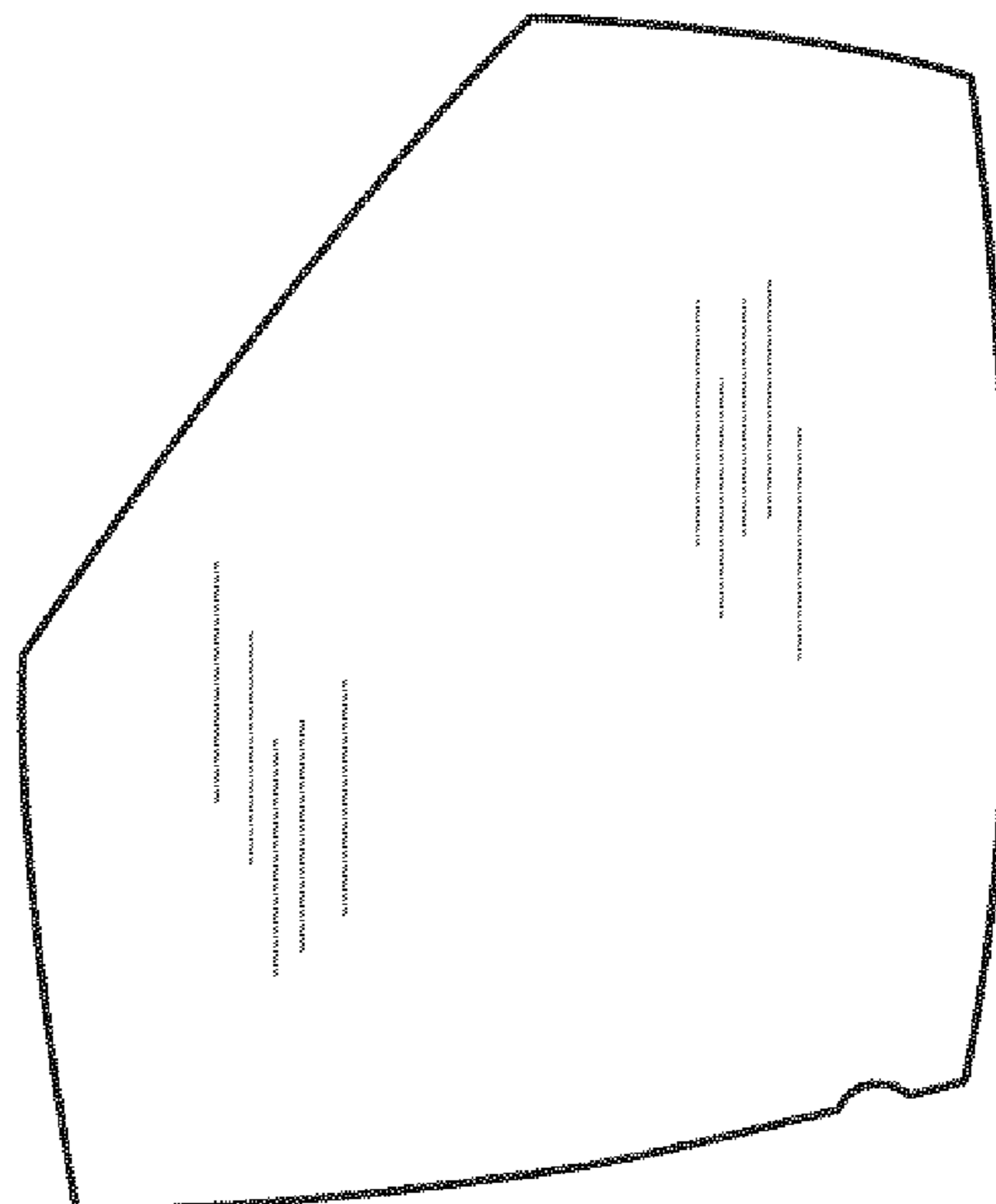

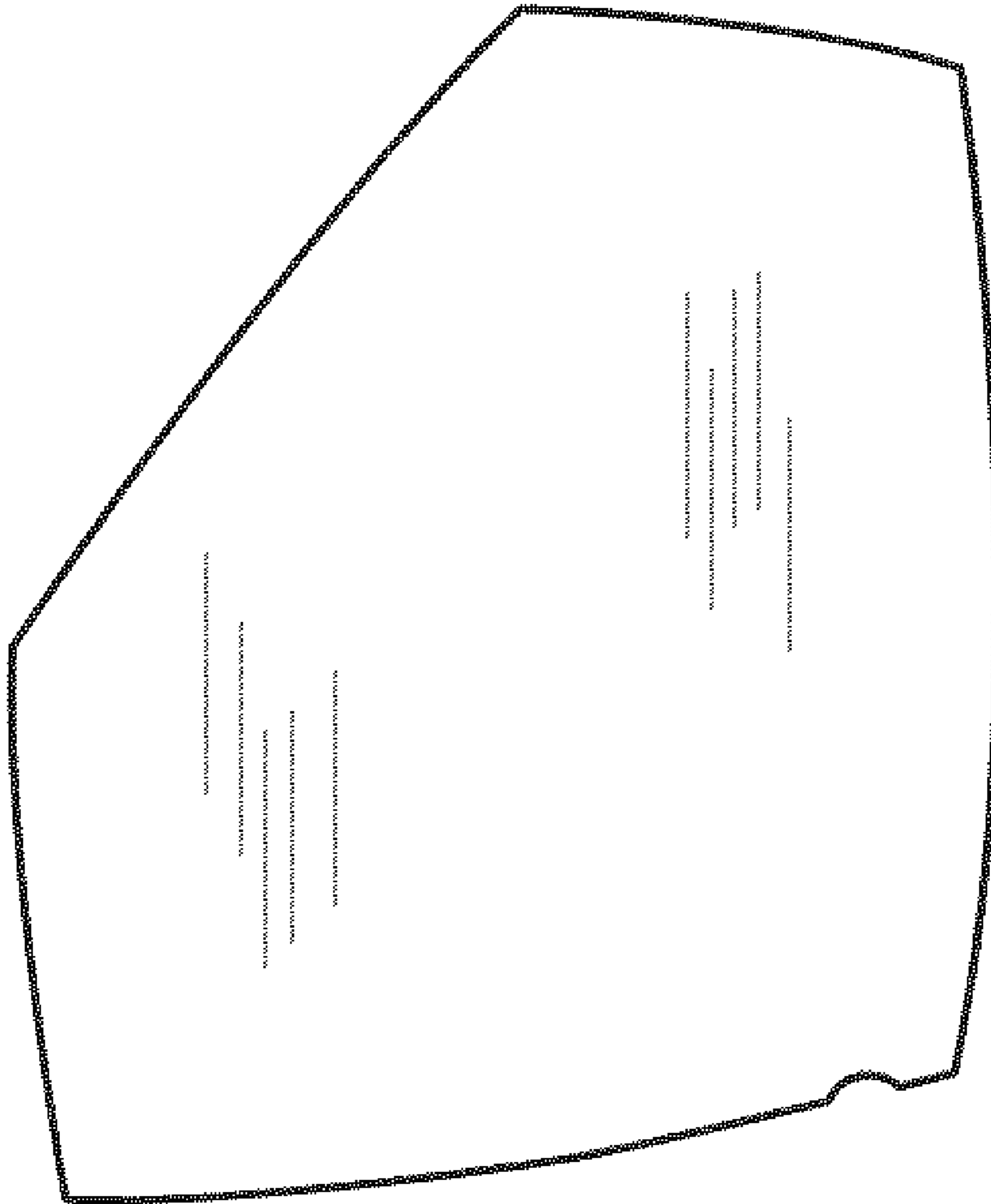
The ornamental design for a mirror for a commercial aircraft passenger cabin lavatory, as shown and described.
