FIG. 8 is a detail of the front element shown in FIG. 1; and,

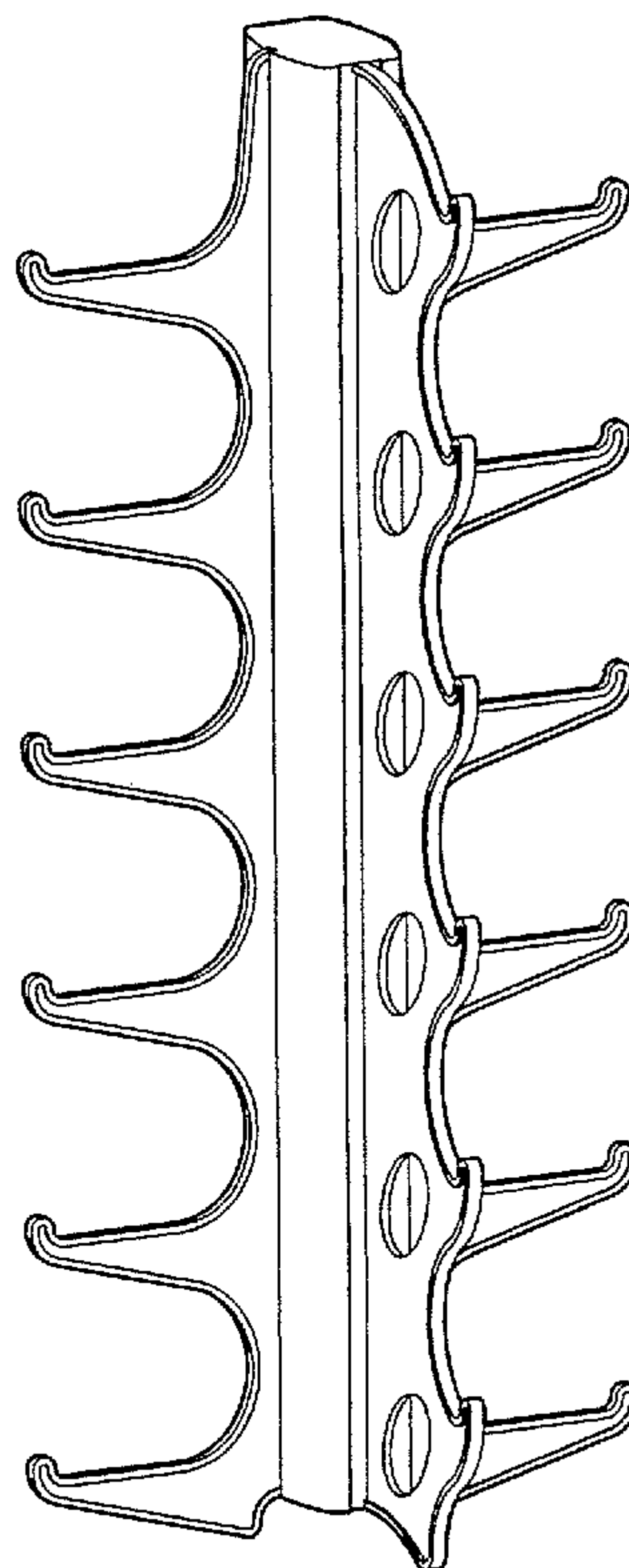
FIG. 9 is a detail of the side element shown in FIG. 1.

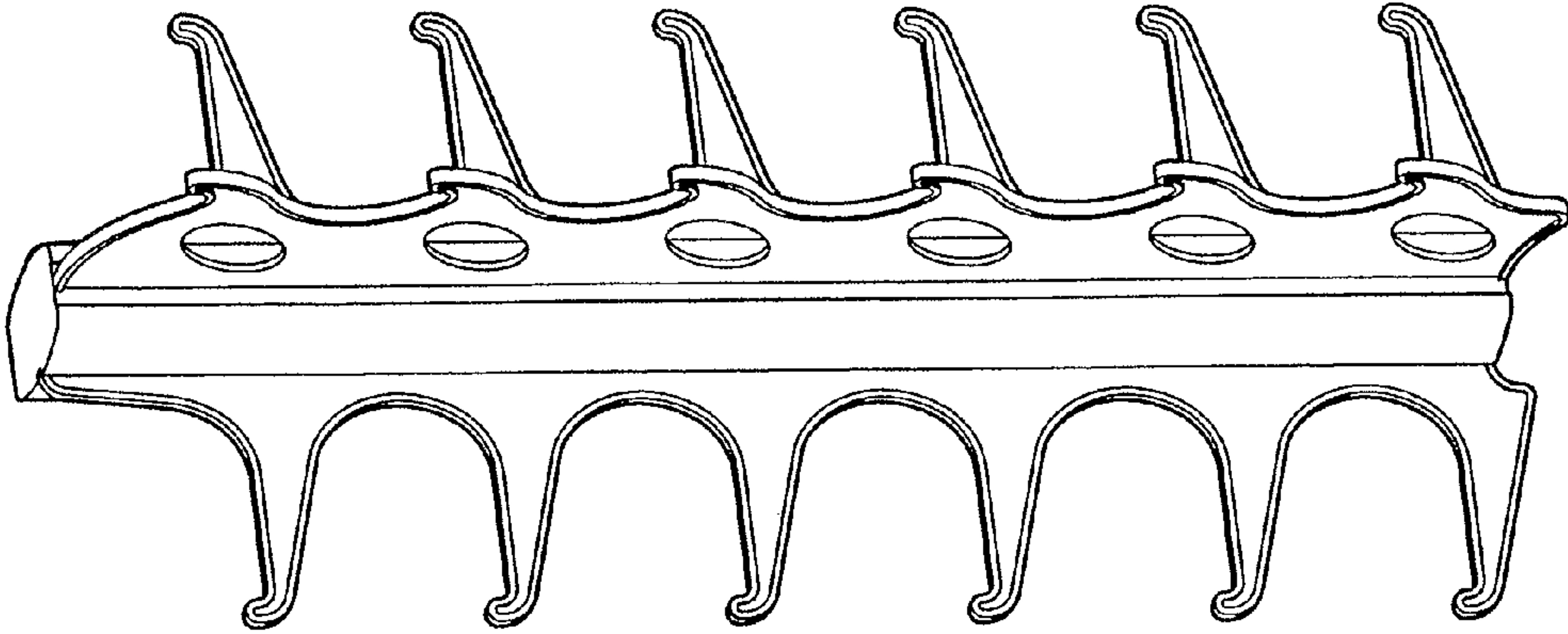

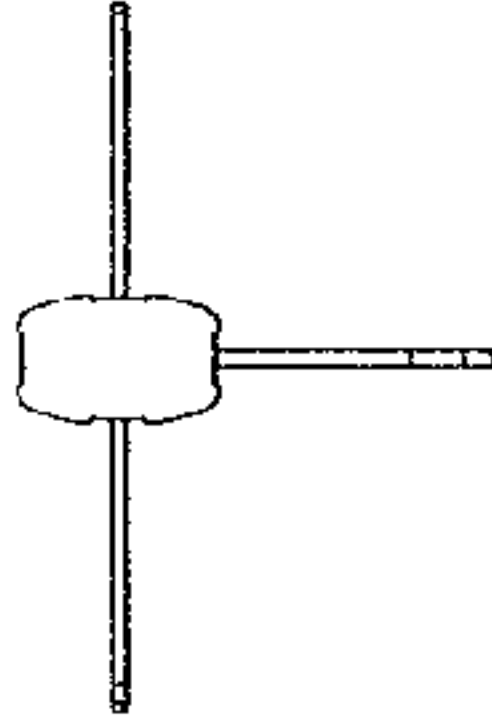

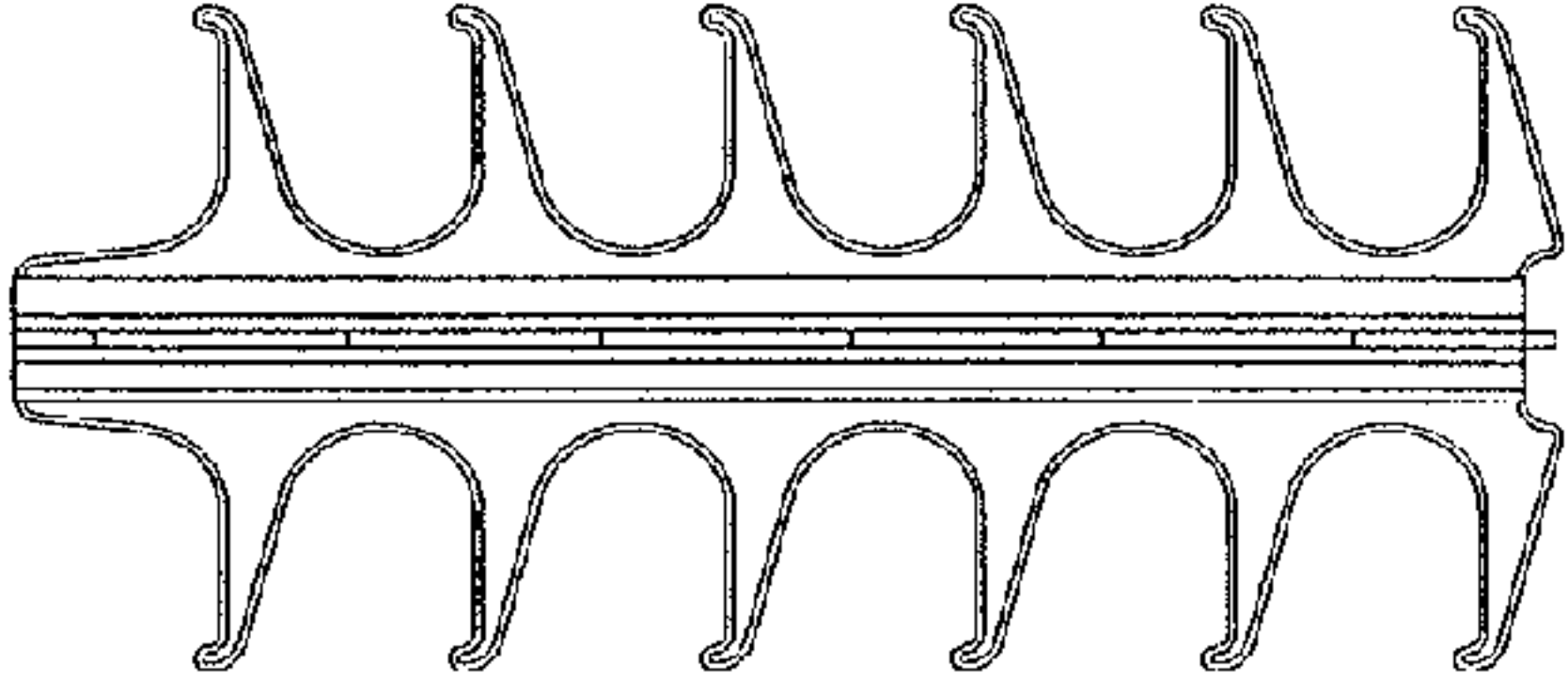

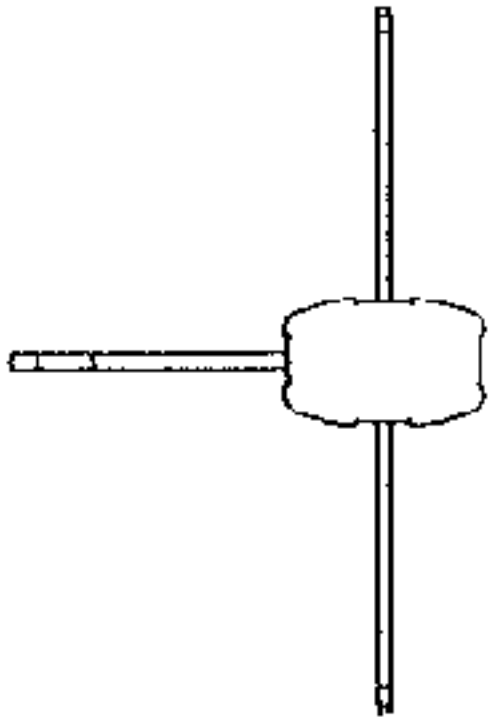

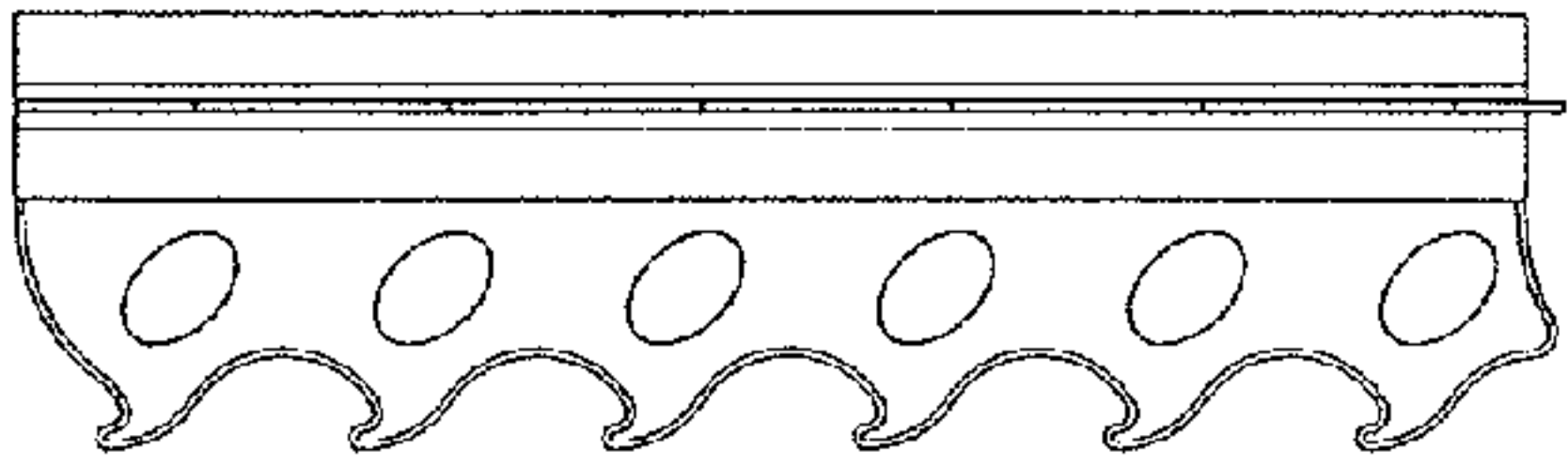

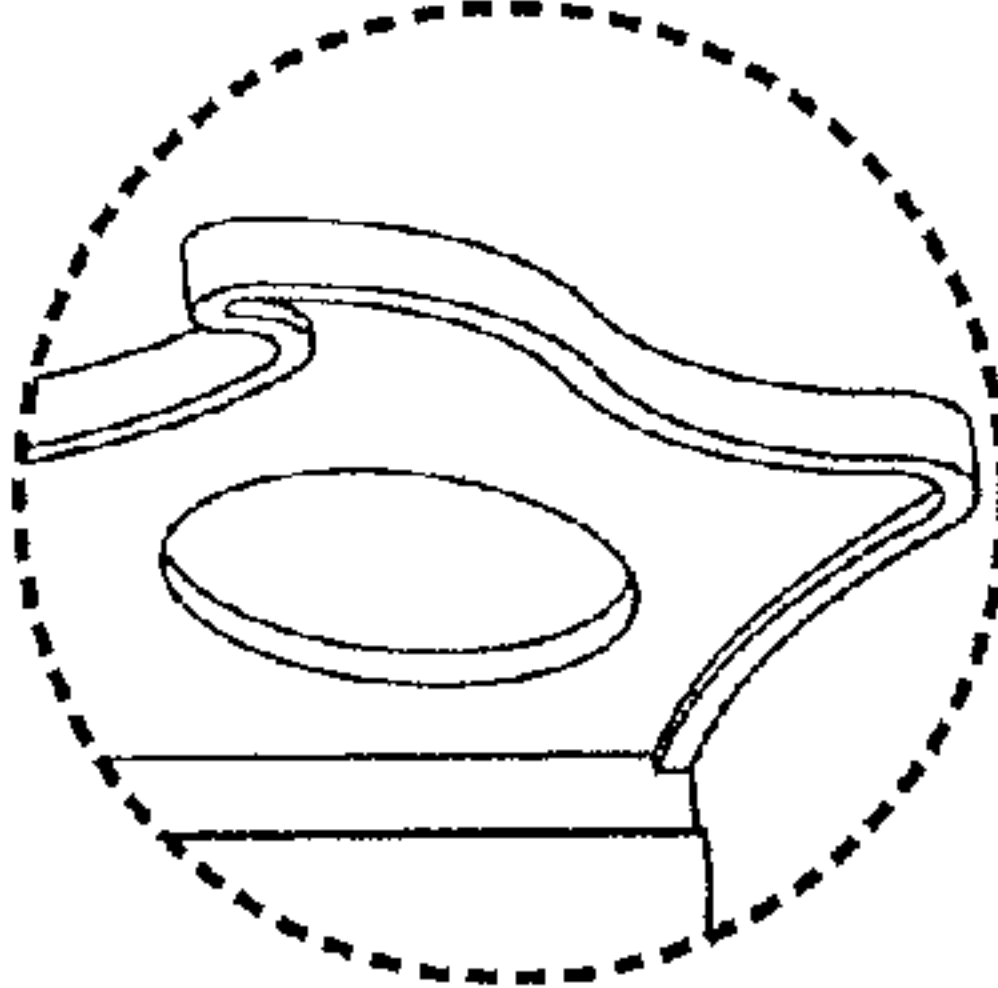

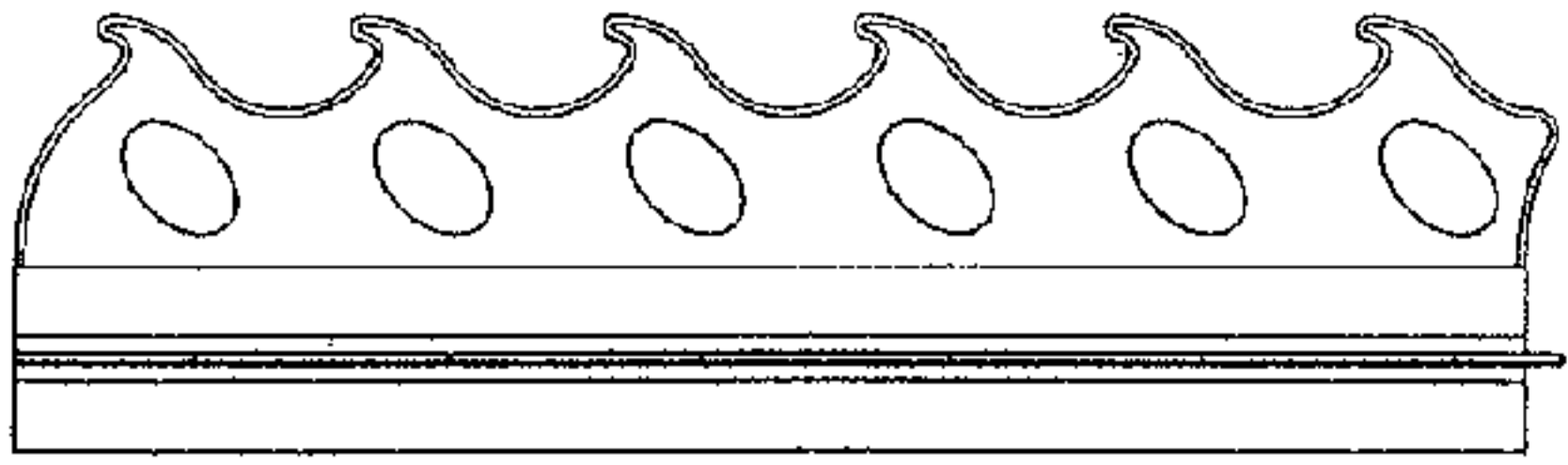

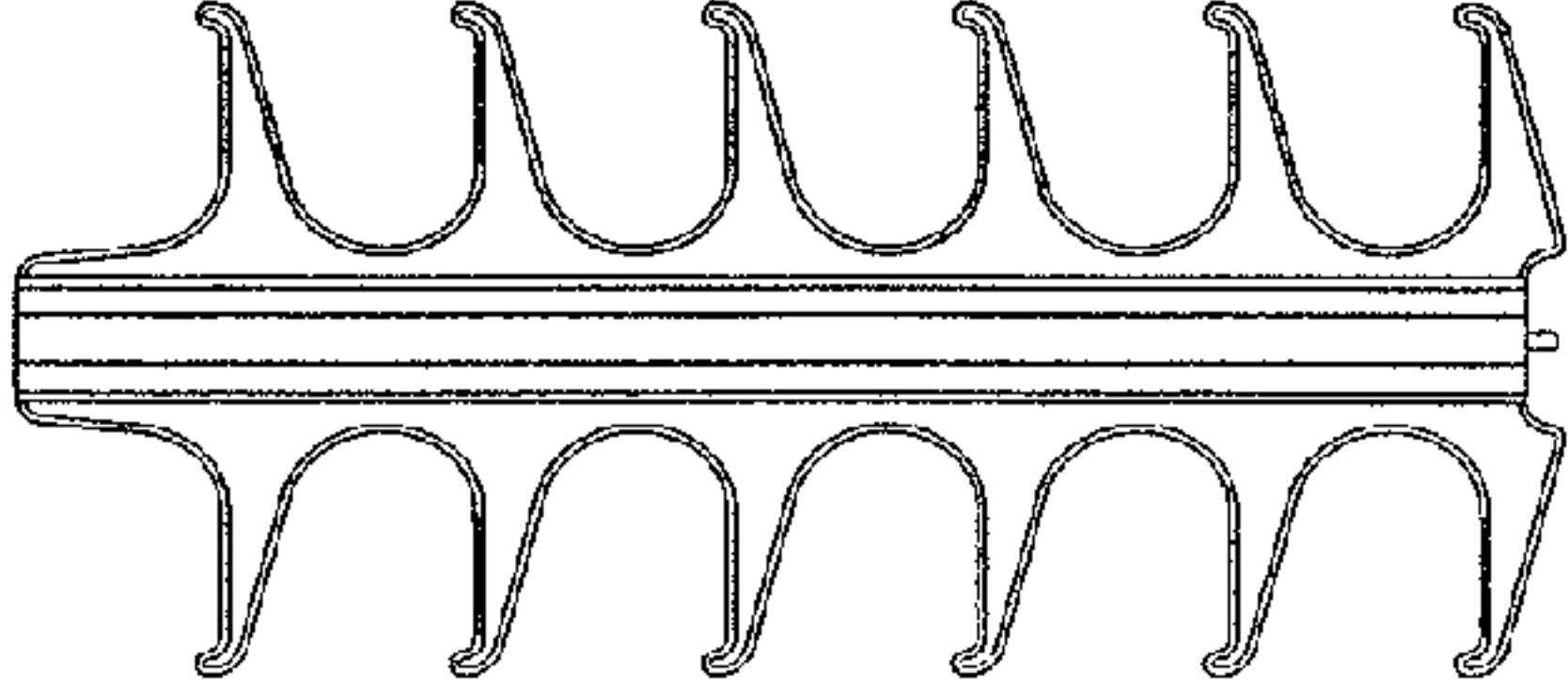

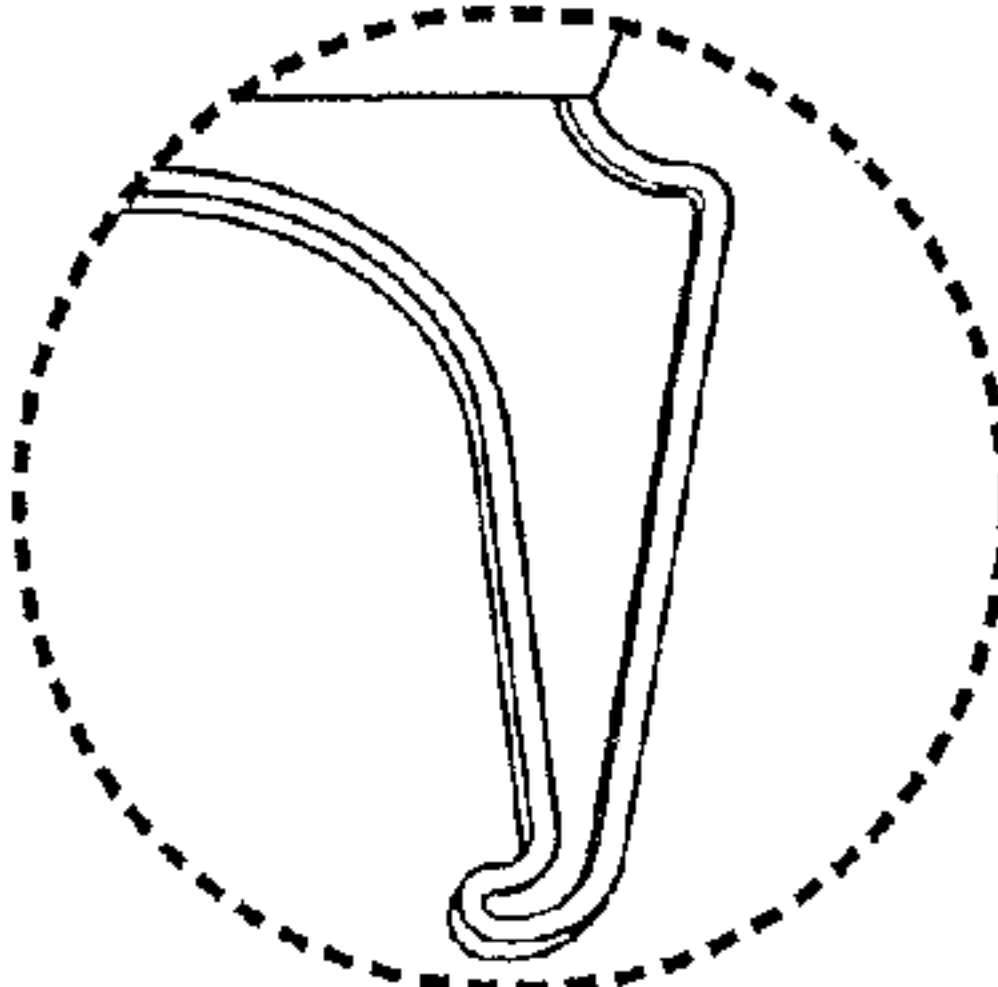
