FIG. 3 is a side elevational view thereof;

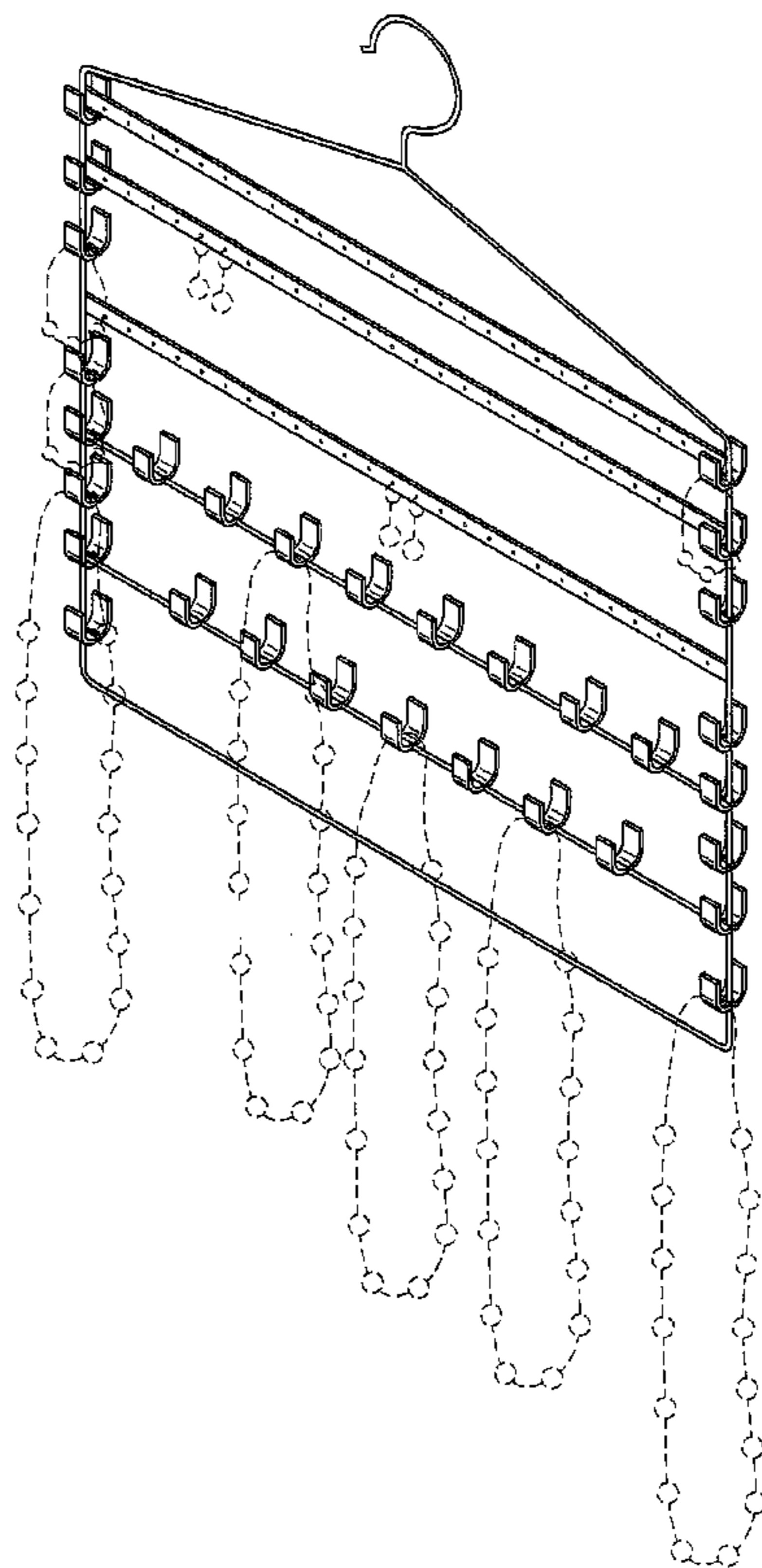
FIG. 4 is an opposite side elevational view thereof;

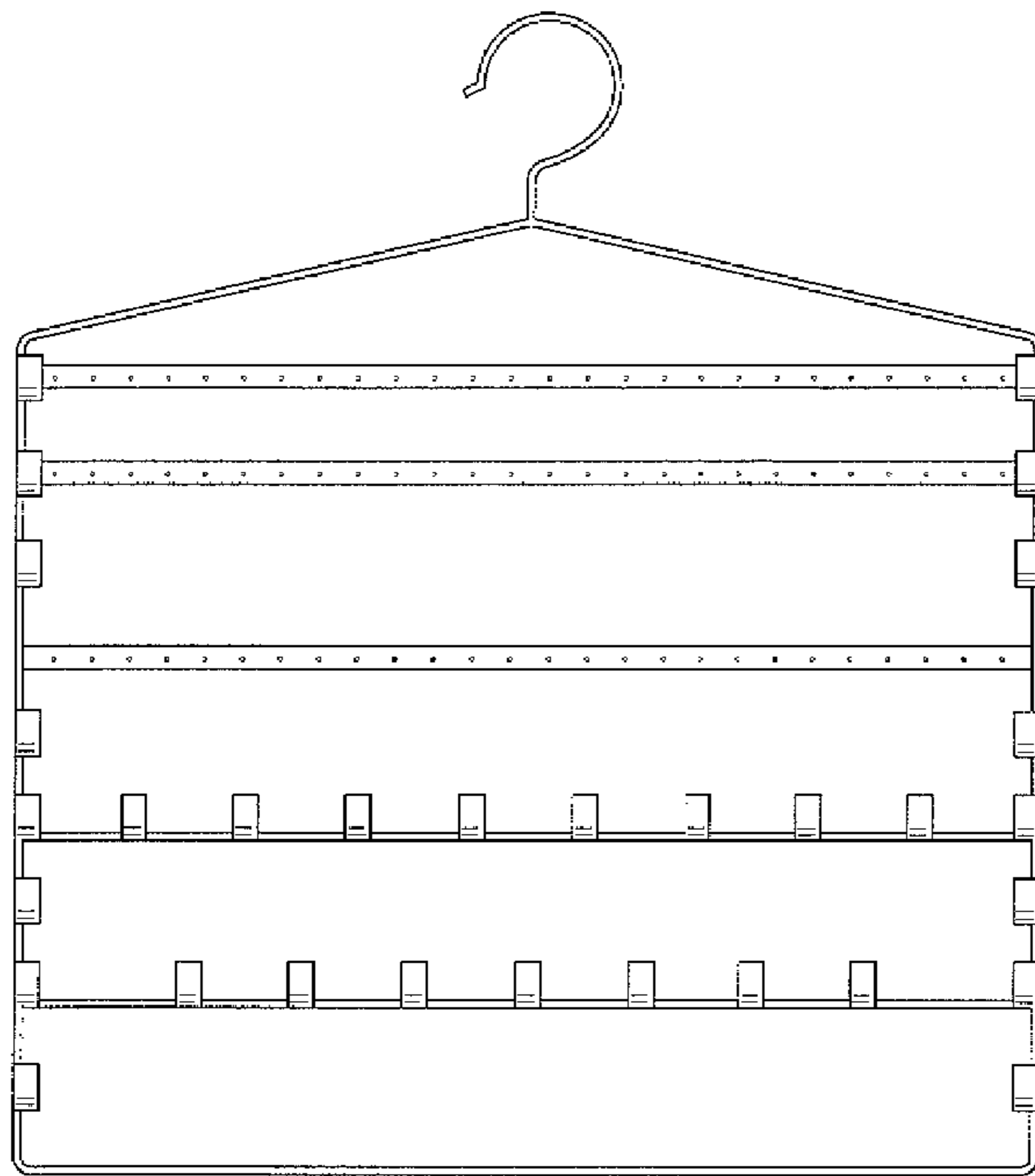

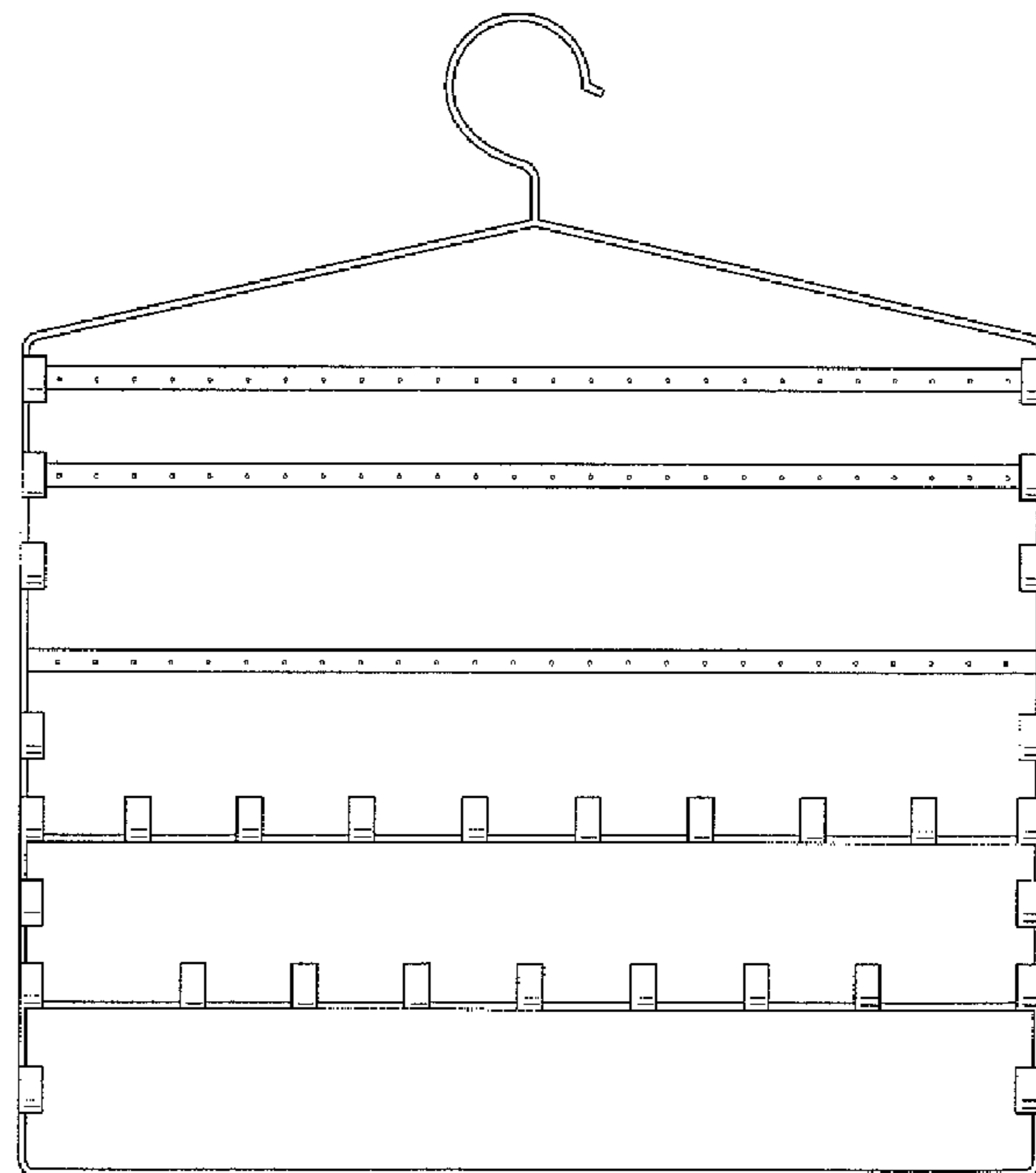

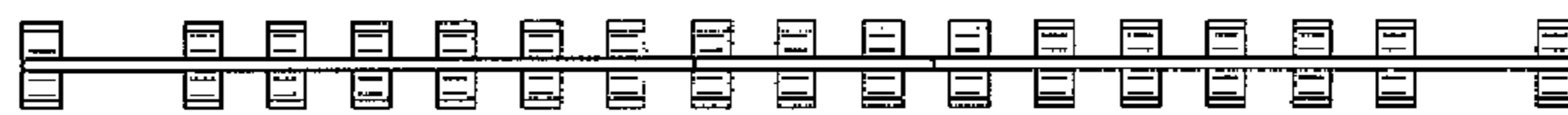

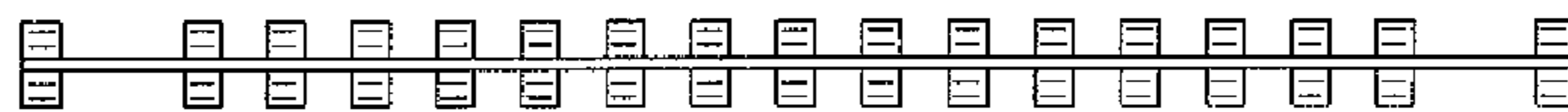

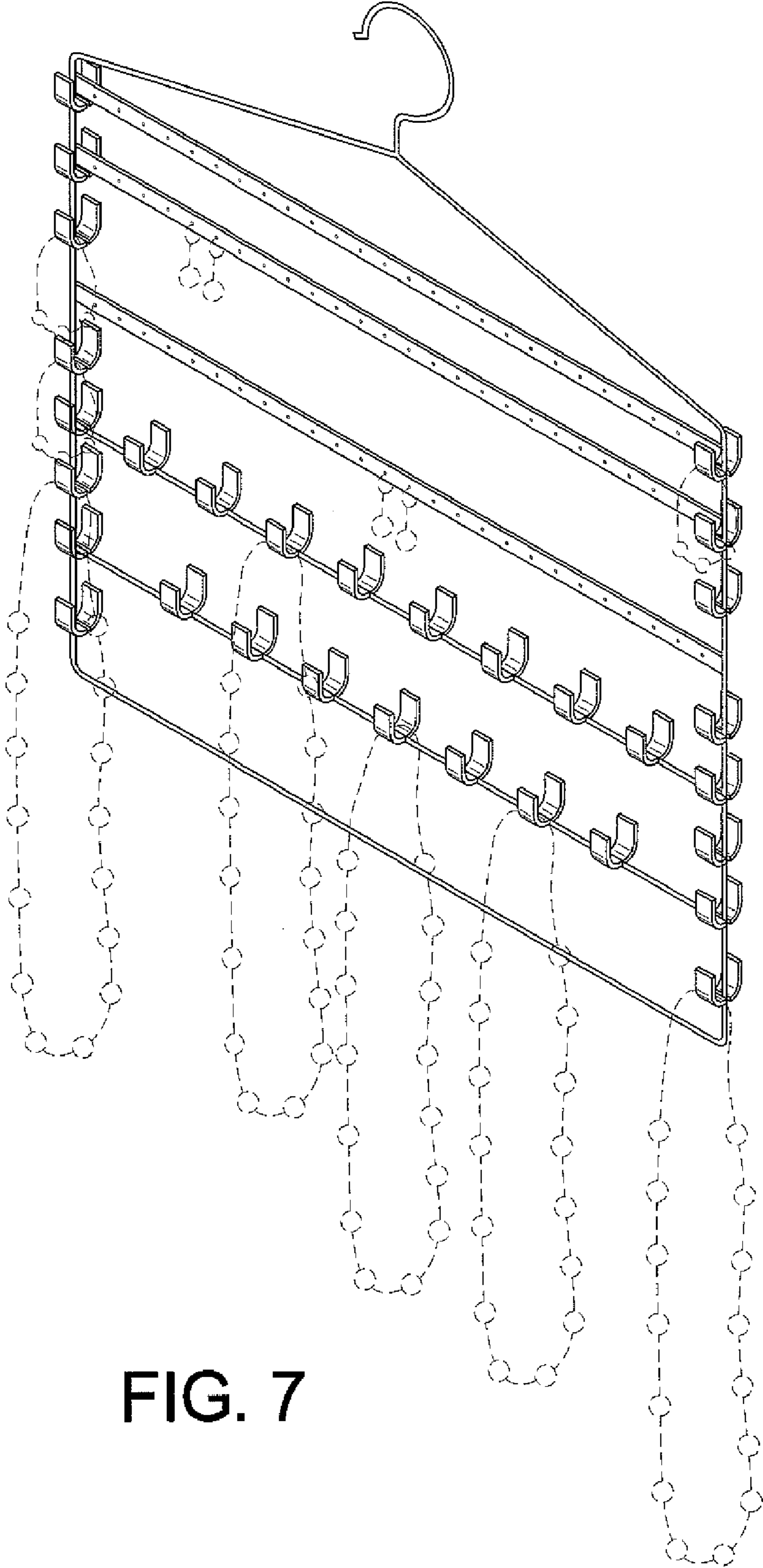
