(57) **CLAIM**

We claim the ornamental design for a gingerbread house mold pan, as shown and described.

DESCRIPTION

FIG. 1 is a top side perspective view of the gingerbread house mold pan;

FIG. 2 is bottom side perspective view of the design embodiment shown in FIG. 1;

FIG. 3 is a bottom side view of the design embodiment shown in FIG. 1;

FIG. 5 is a left side view of the design embodiment shown in FIG. 1;

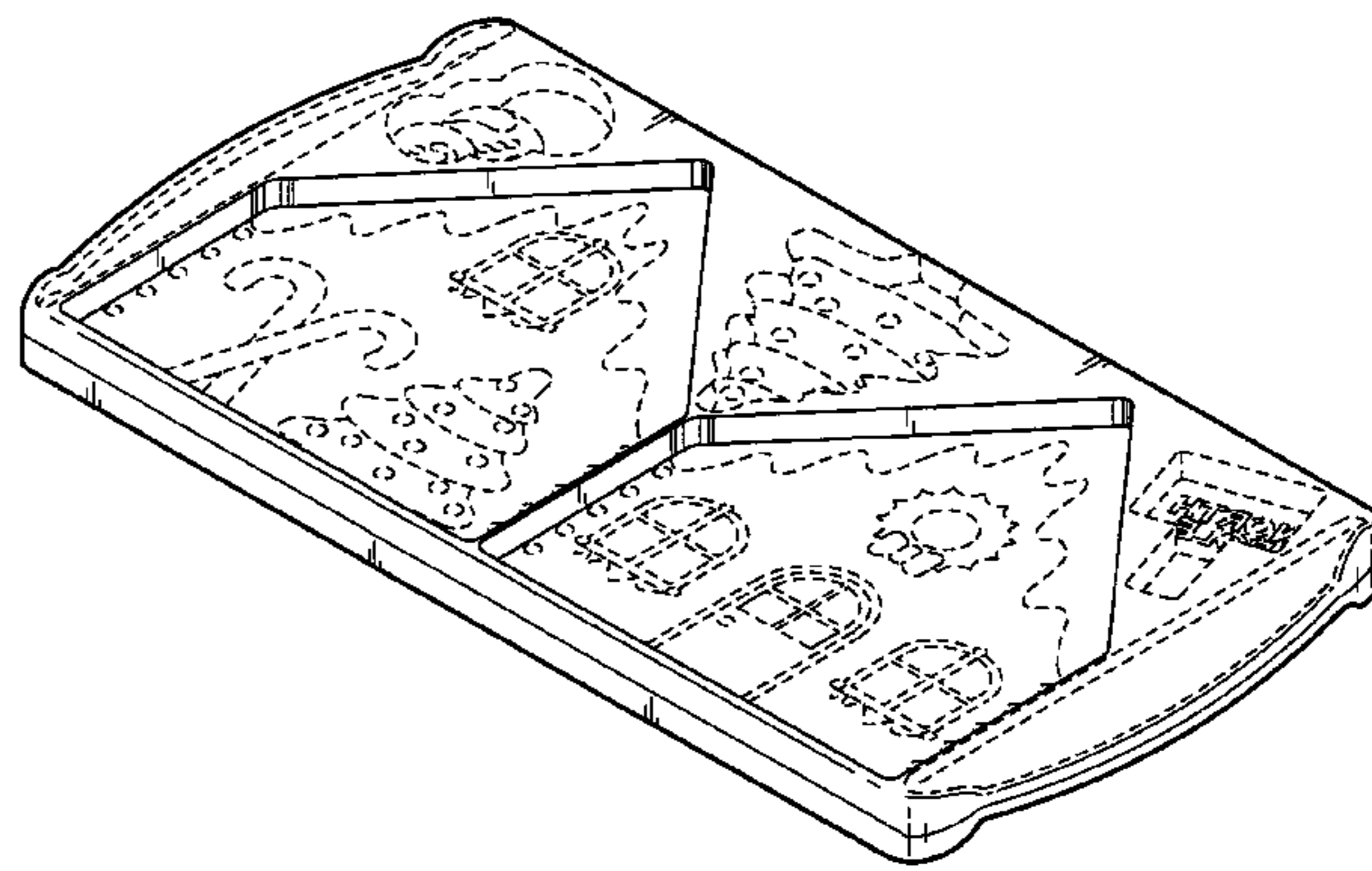
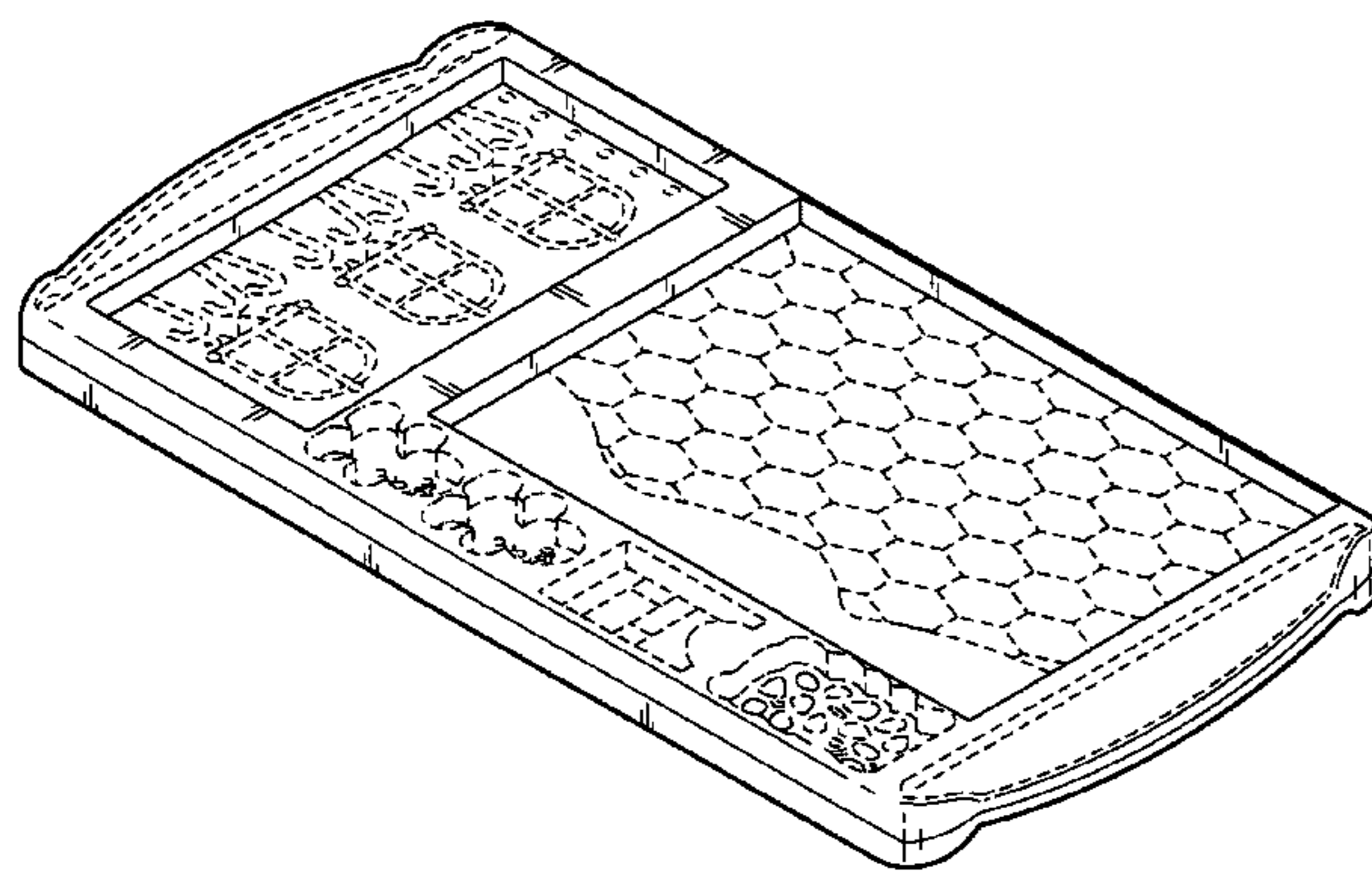
FIG. 6 is a right side view of the design embodiment shown in FIG. 1;

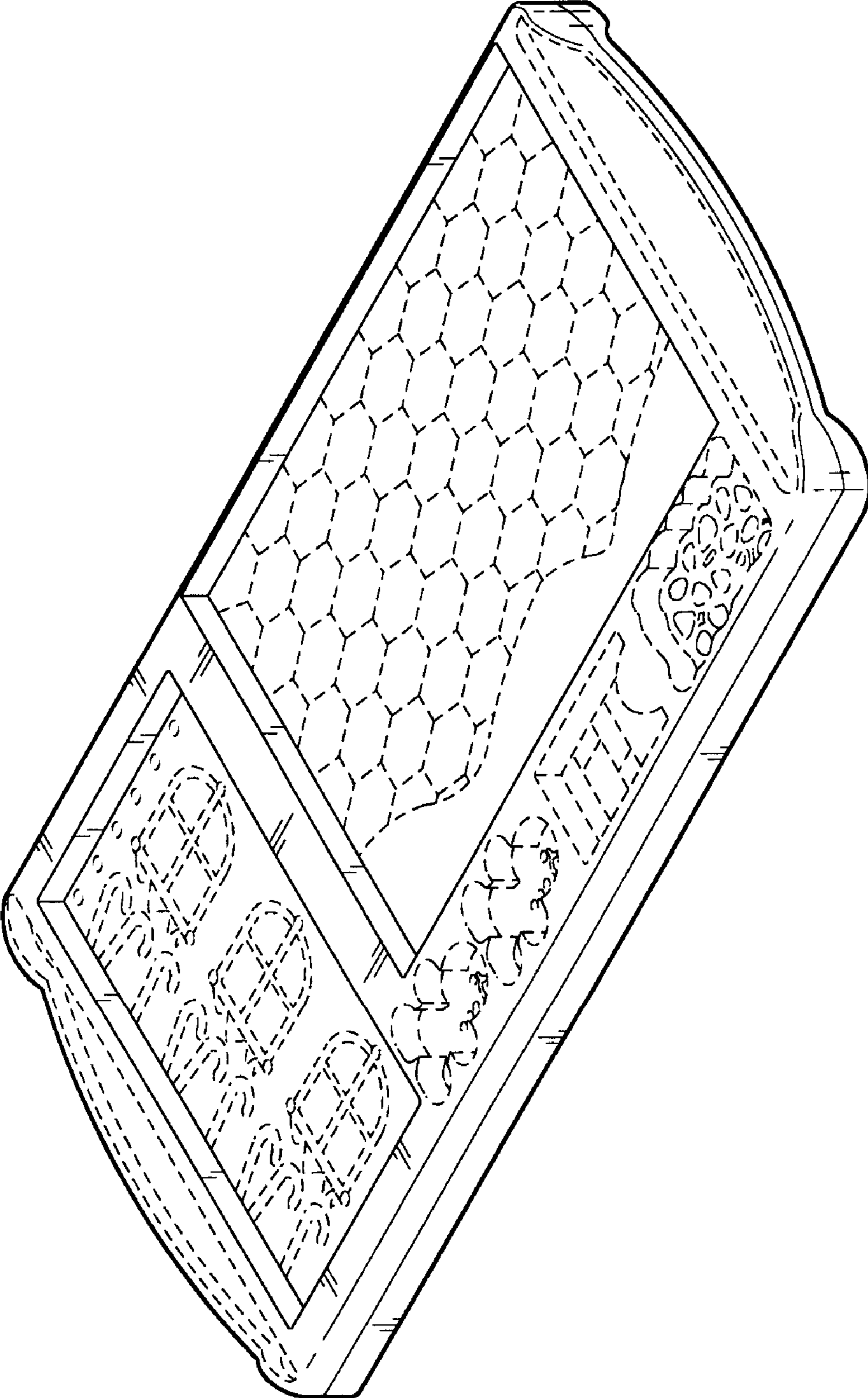

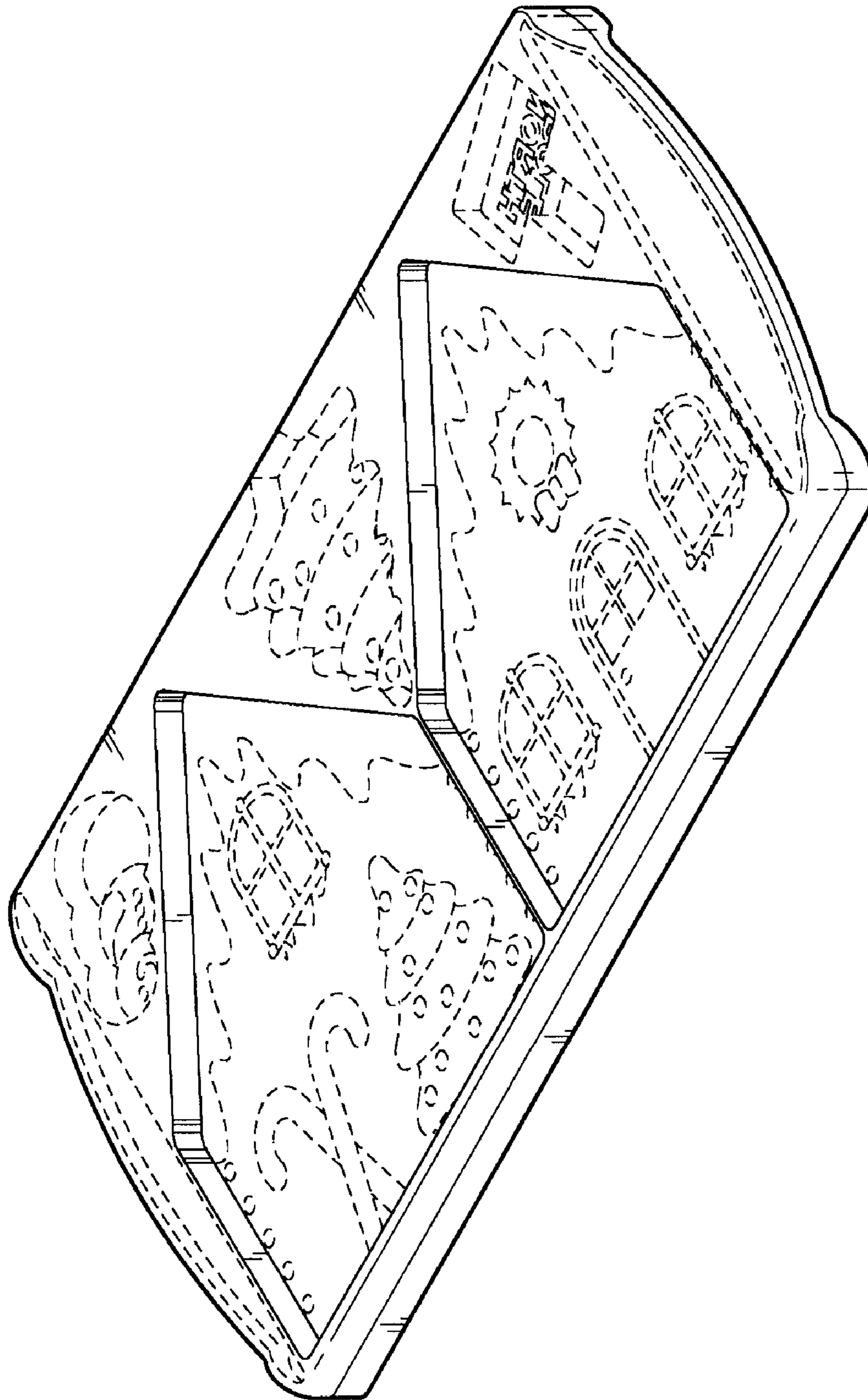

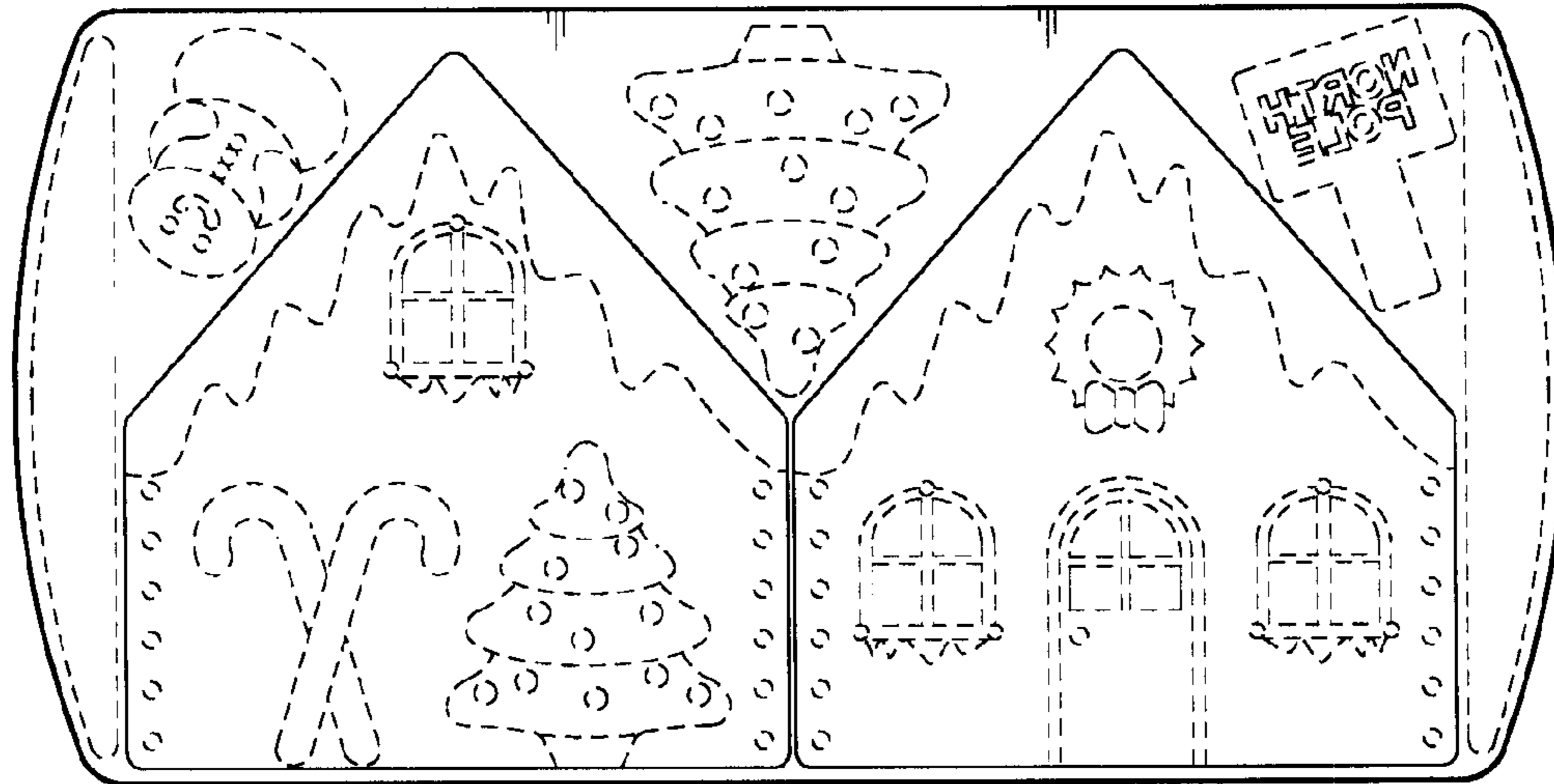

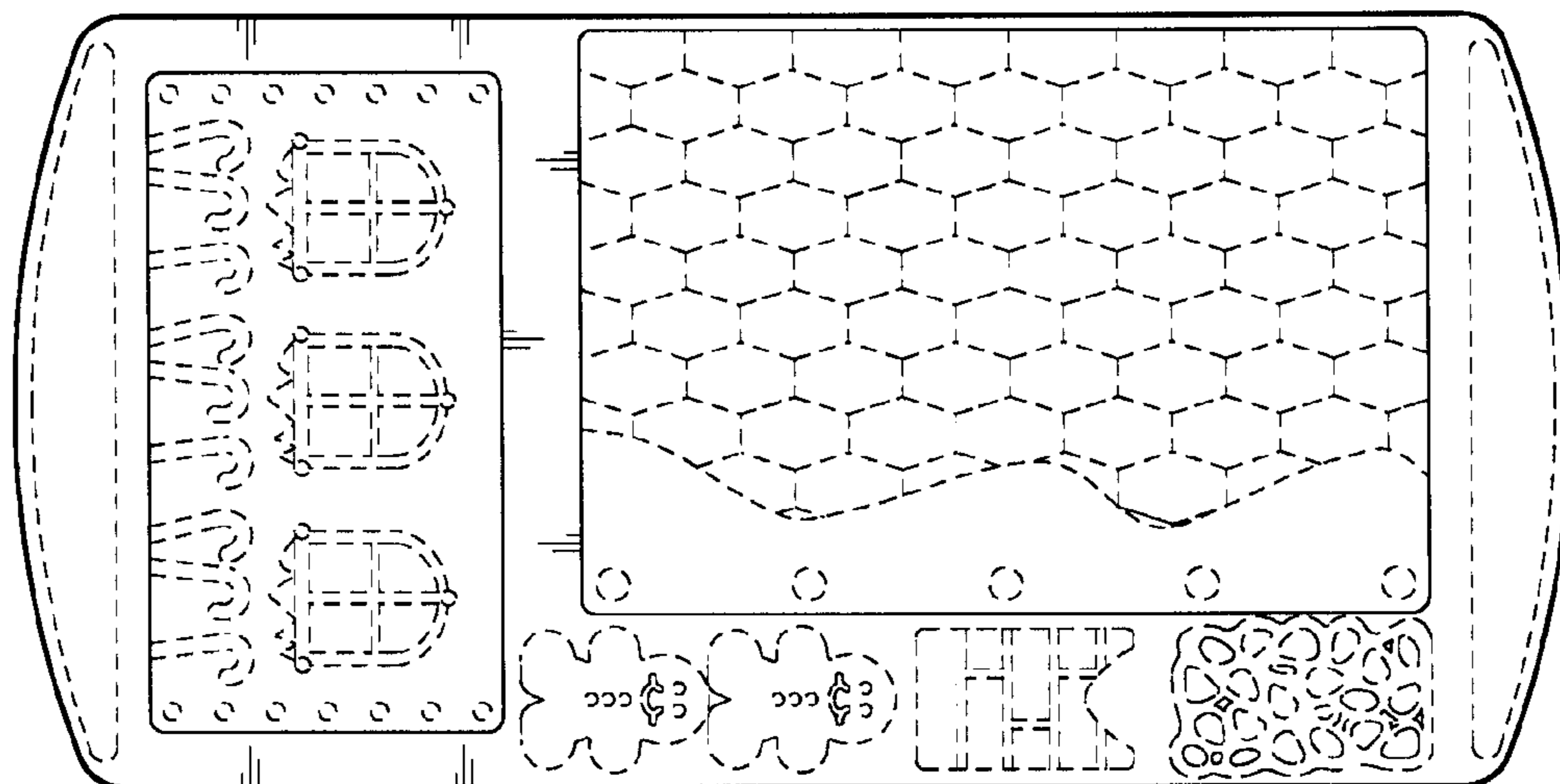

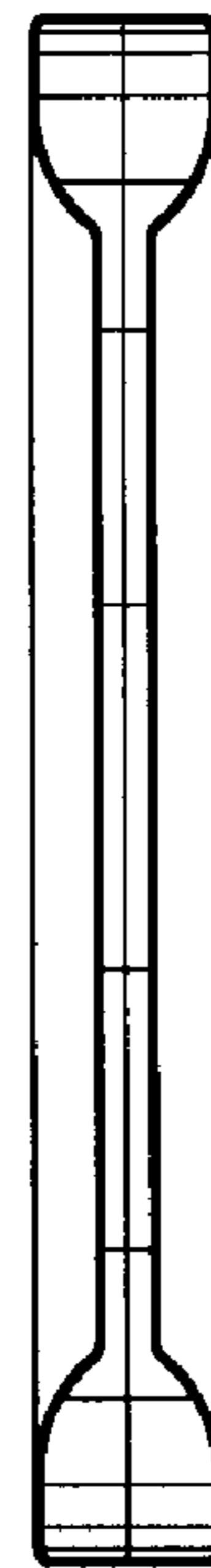

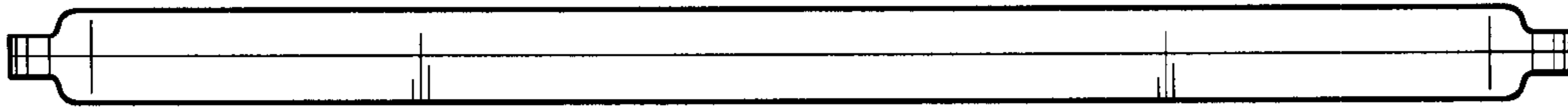

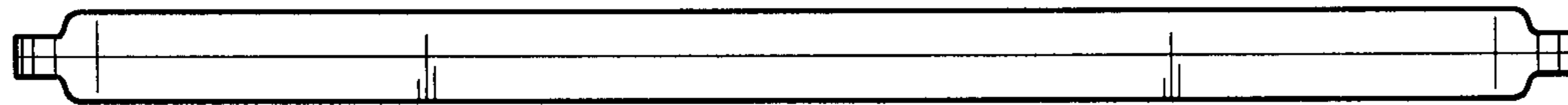
