The ornamental design for a bottle with opposed sealable openings, as shown and described.

**DESCRIPTION**

FIG. 5 is a rear elevational view thereof;

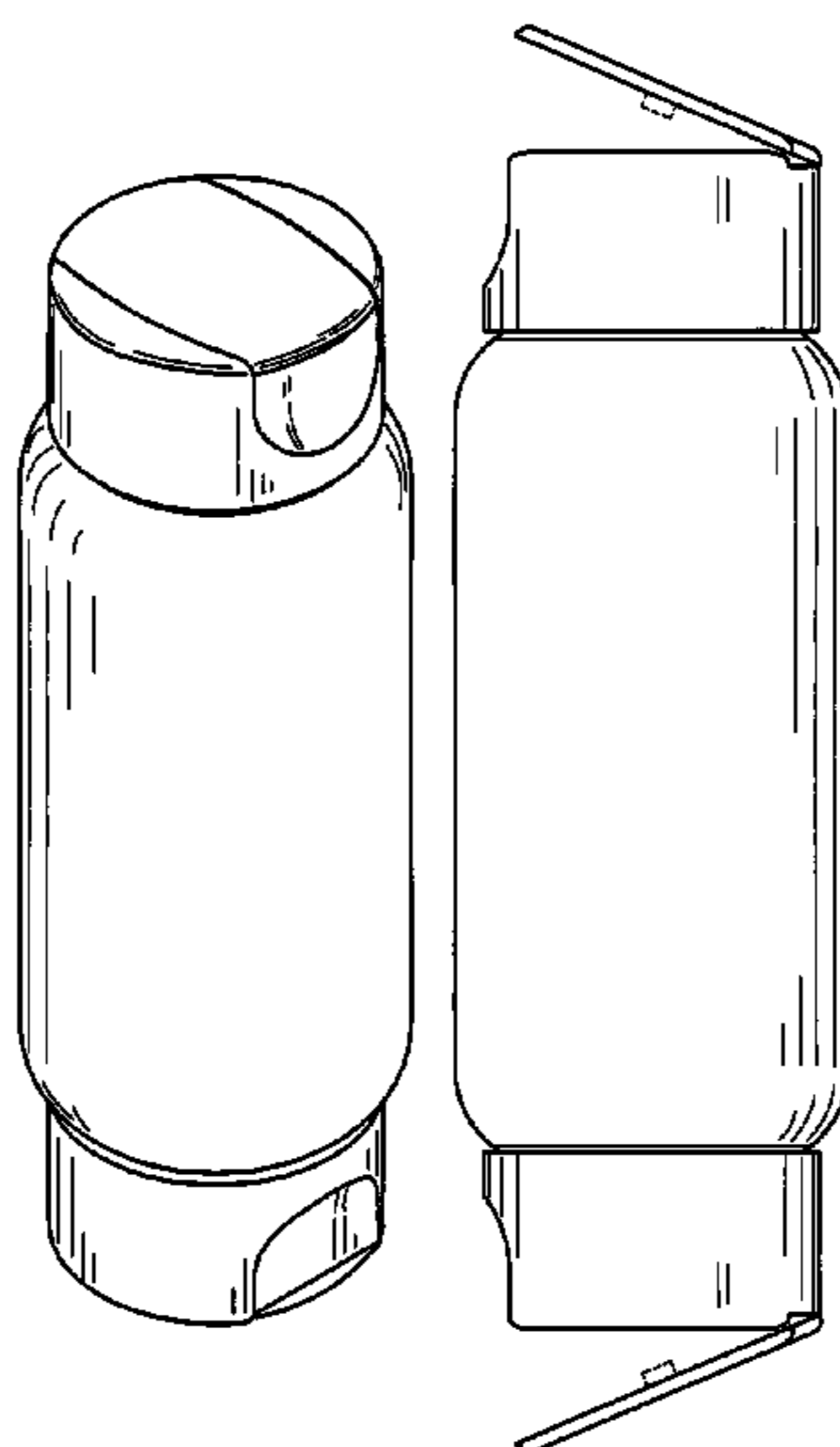
FIG. 6 is a top plan view thereof;

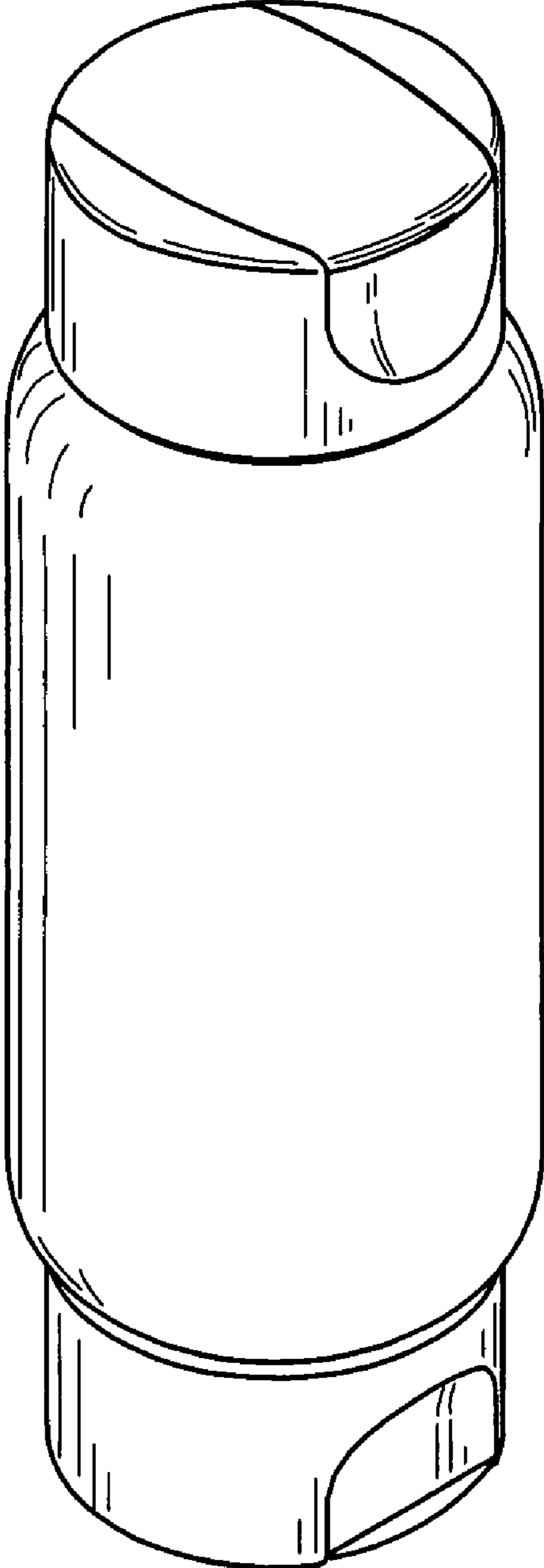
FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a right side elevational view with the hinged portion of the top and bottom caps shown in opened condition.

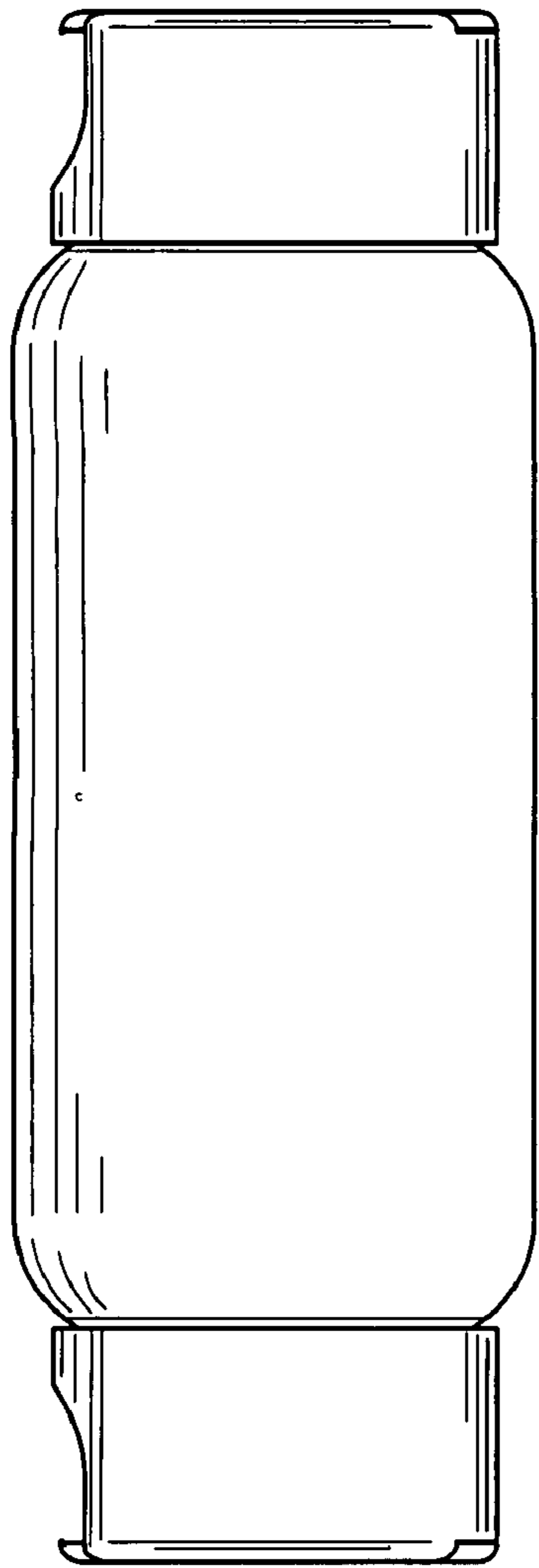
The broken lines shown in the drawings are included for the purpose of showing environmental structure that forms no part of the claimed design.

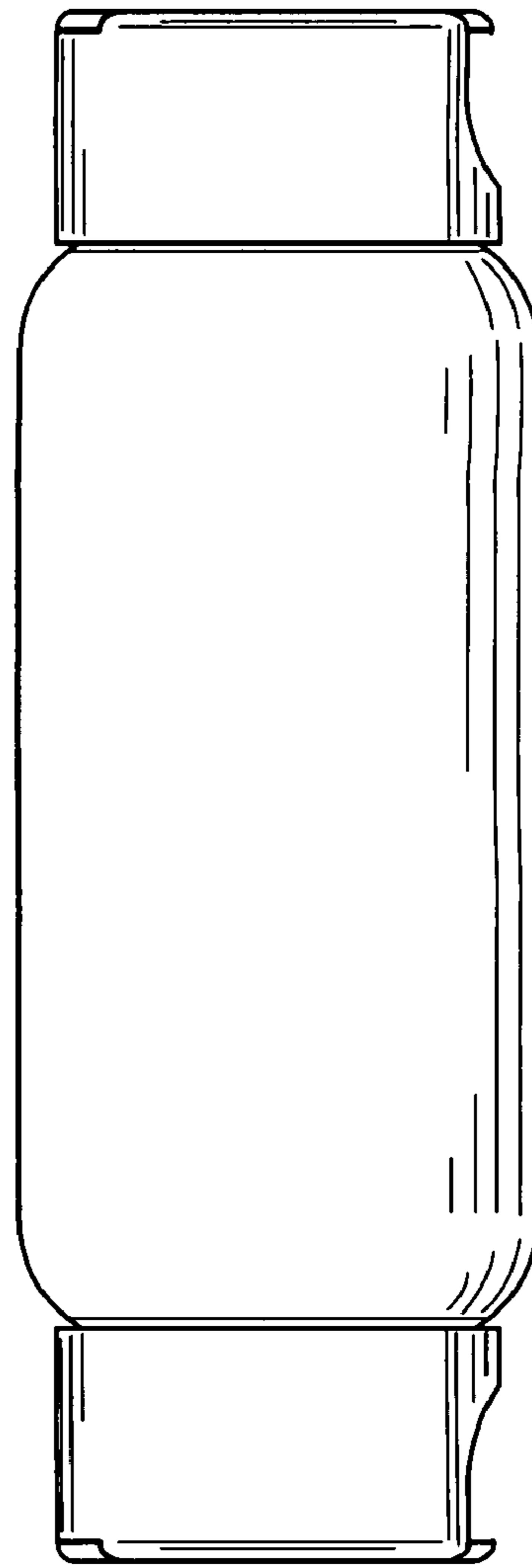




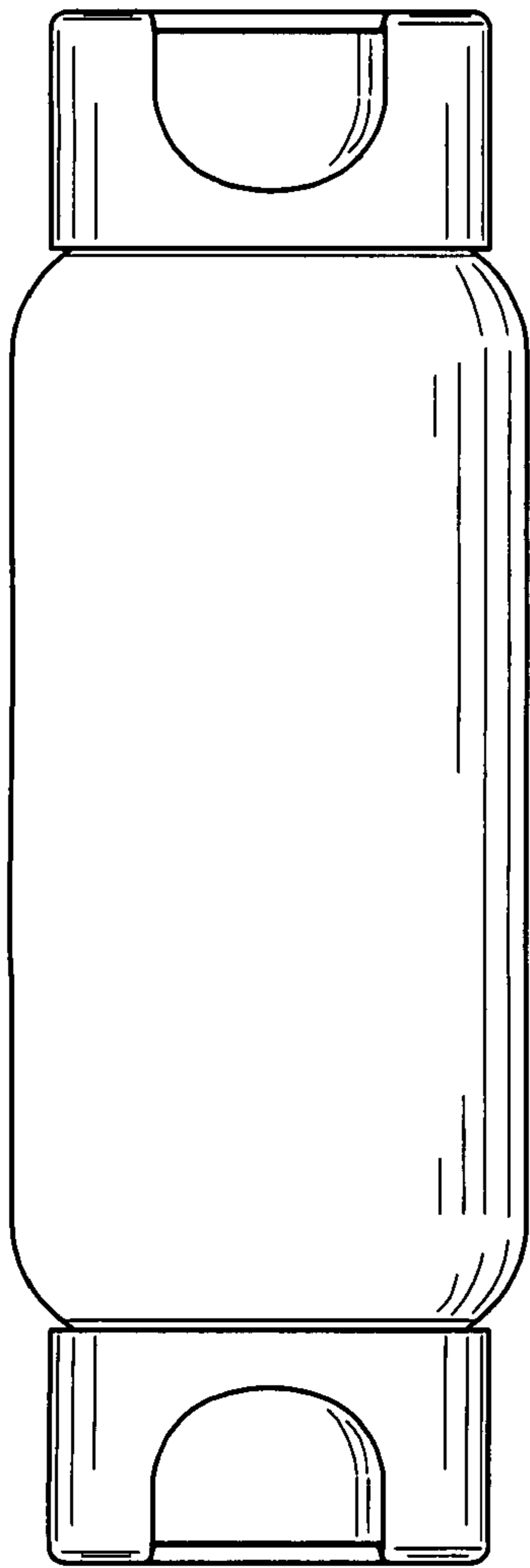

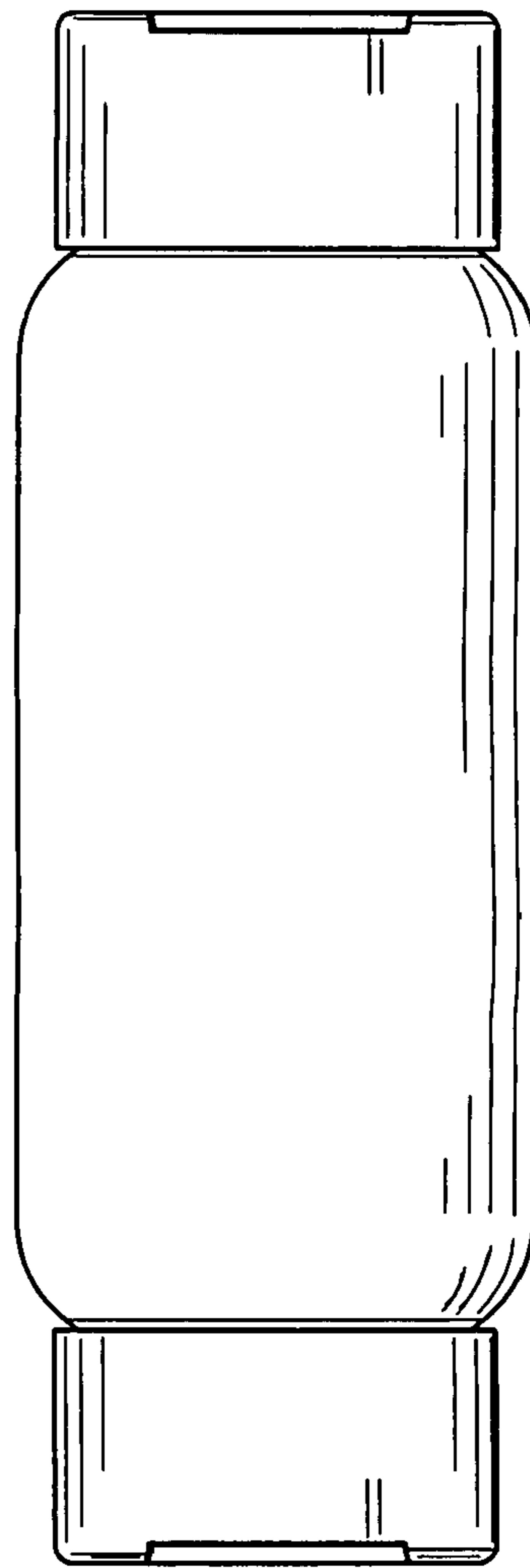

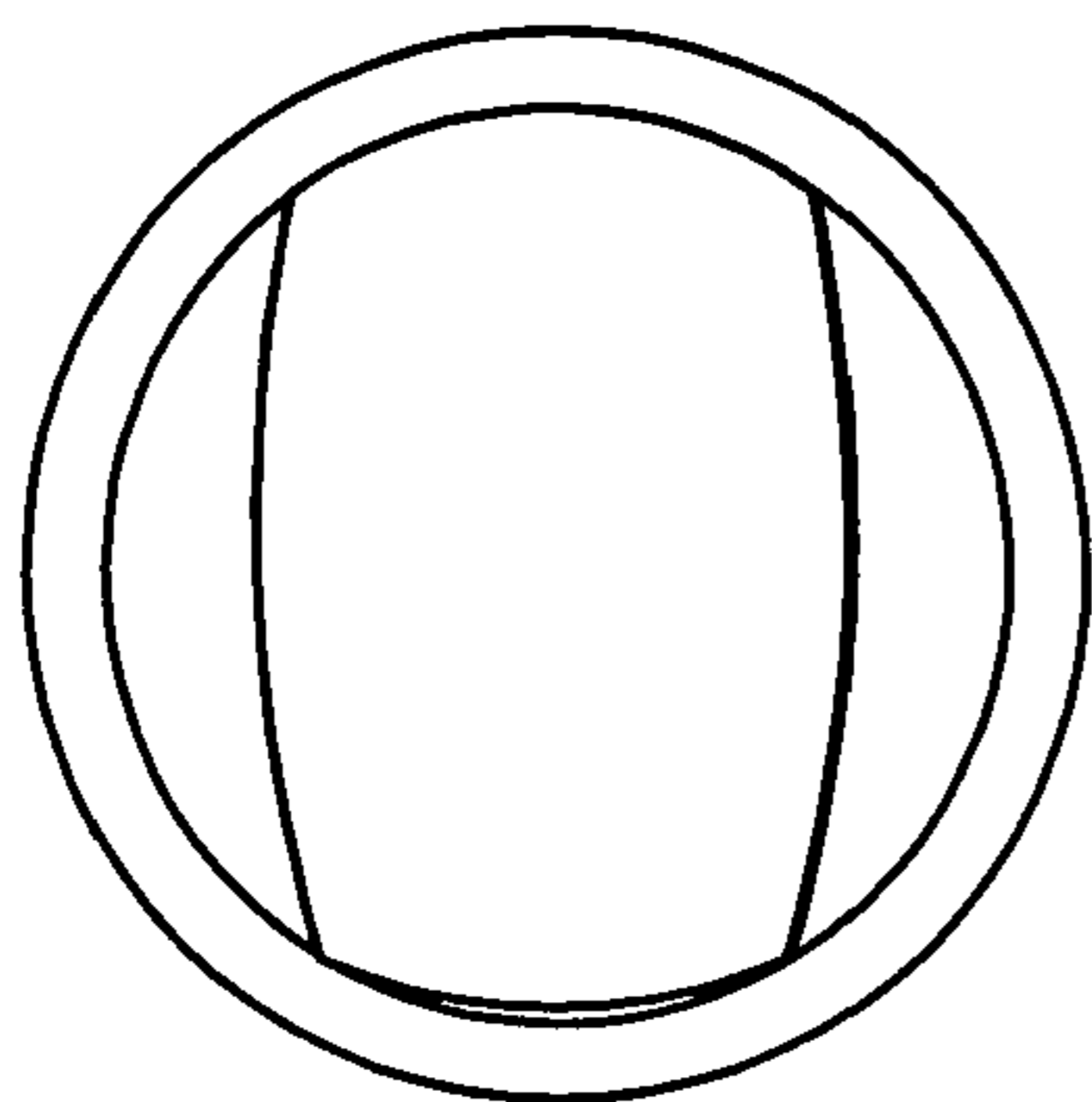

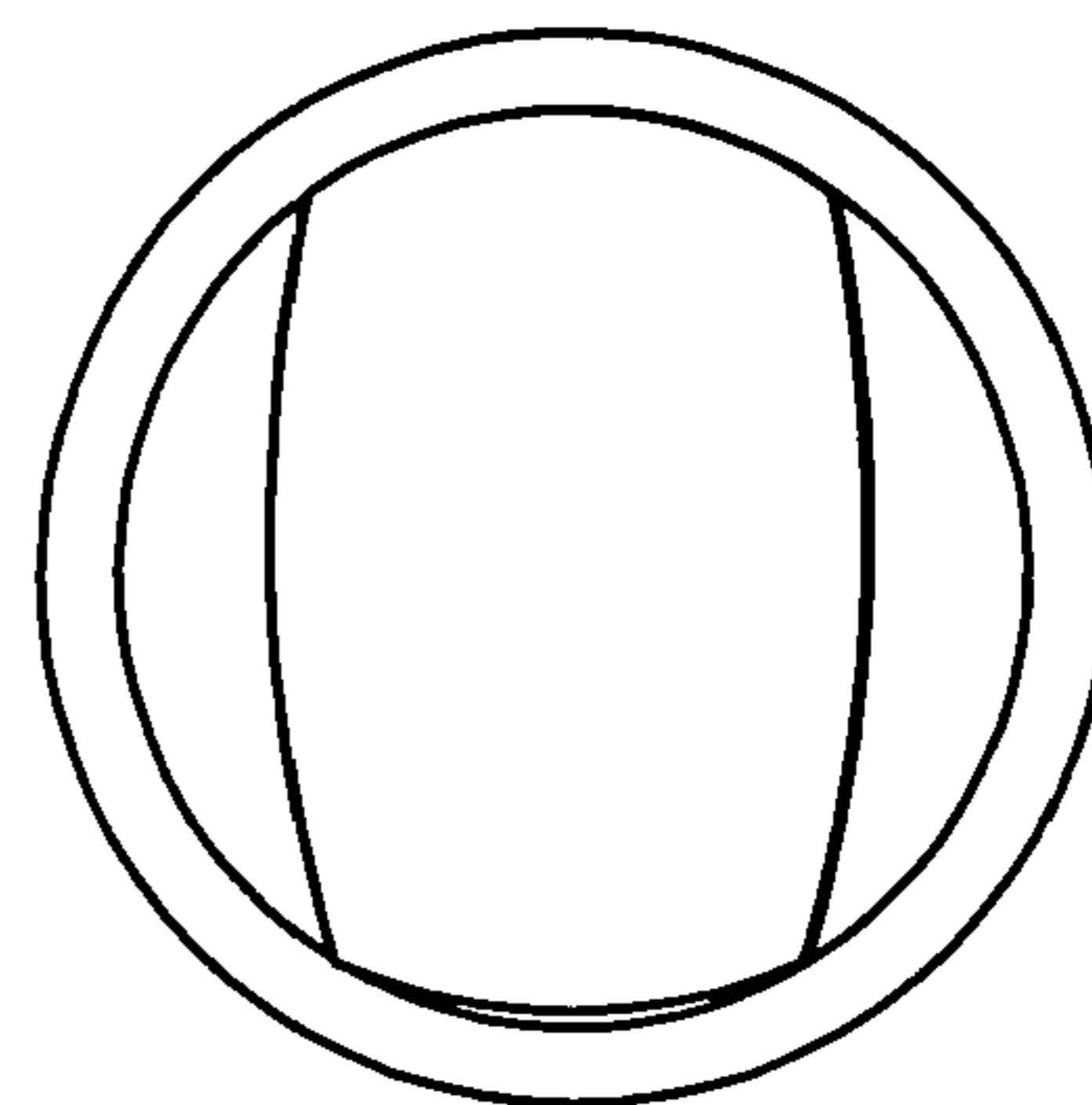

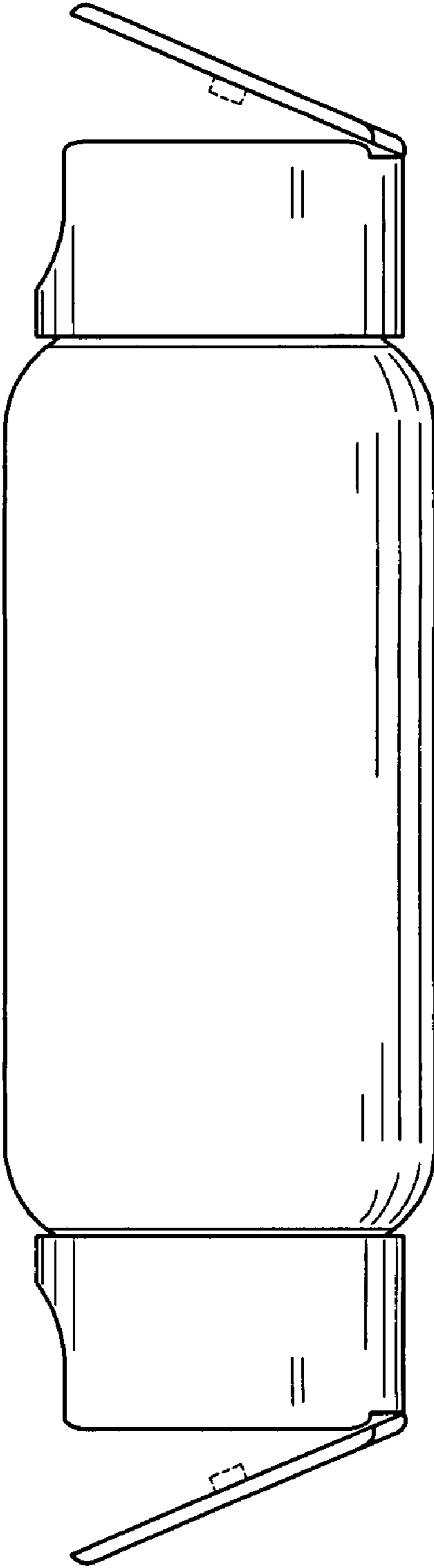
