The ornamental design for a gemstone, as shown.

DESCRIPTION

FIG. 1 is a bottom view of the gemstone according to a first embodiment;

FIG. 2 is a right end view of the gemstone according to the first embodiment;

FIG. 3 is a front view of the gemstone according to the first embodiment;

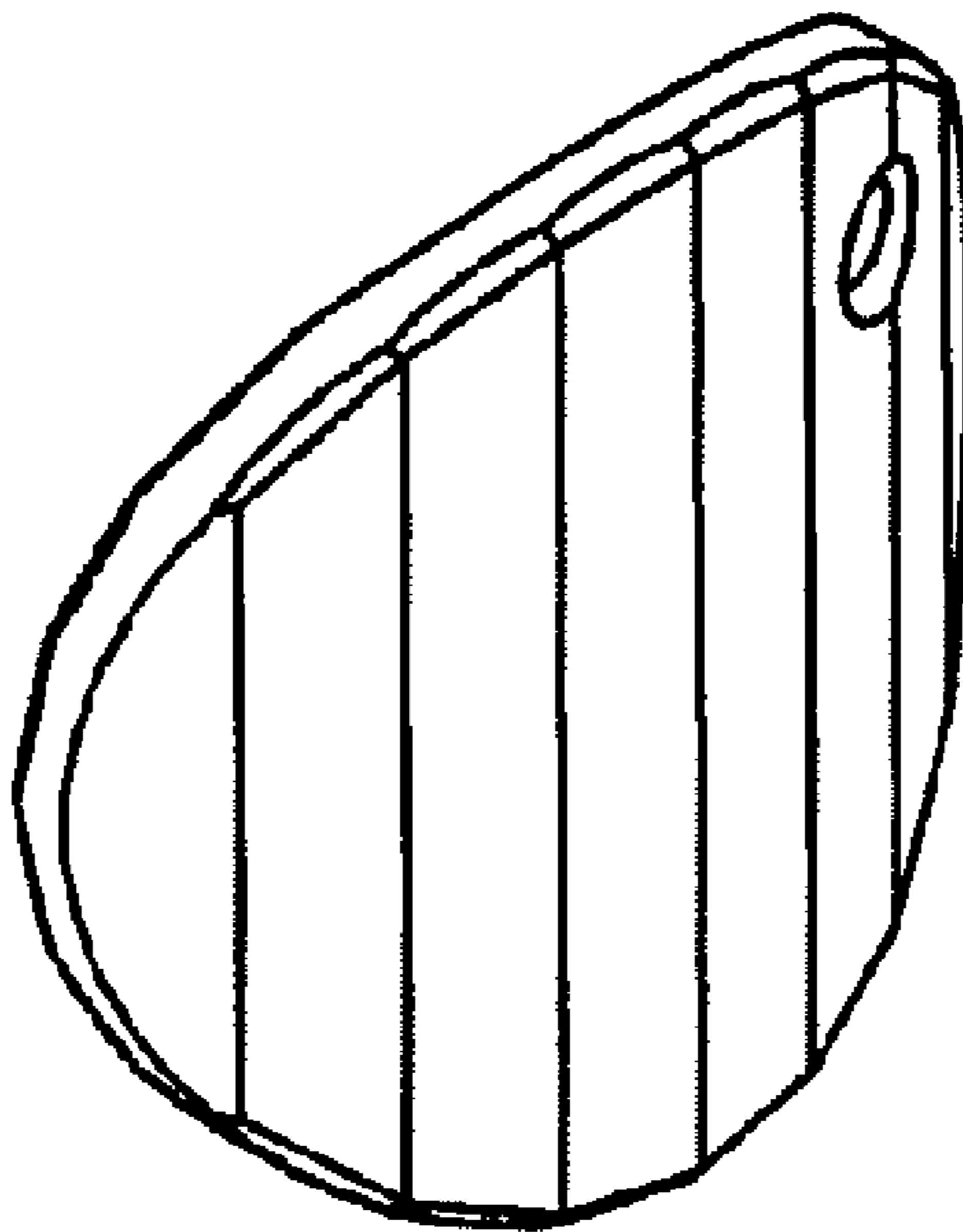

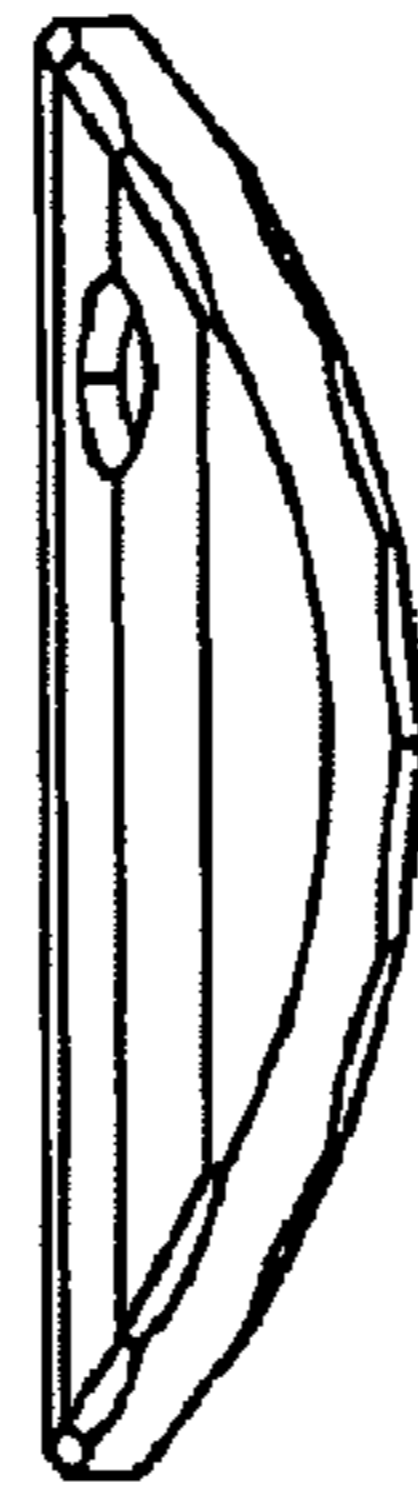

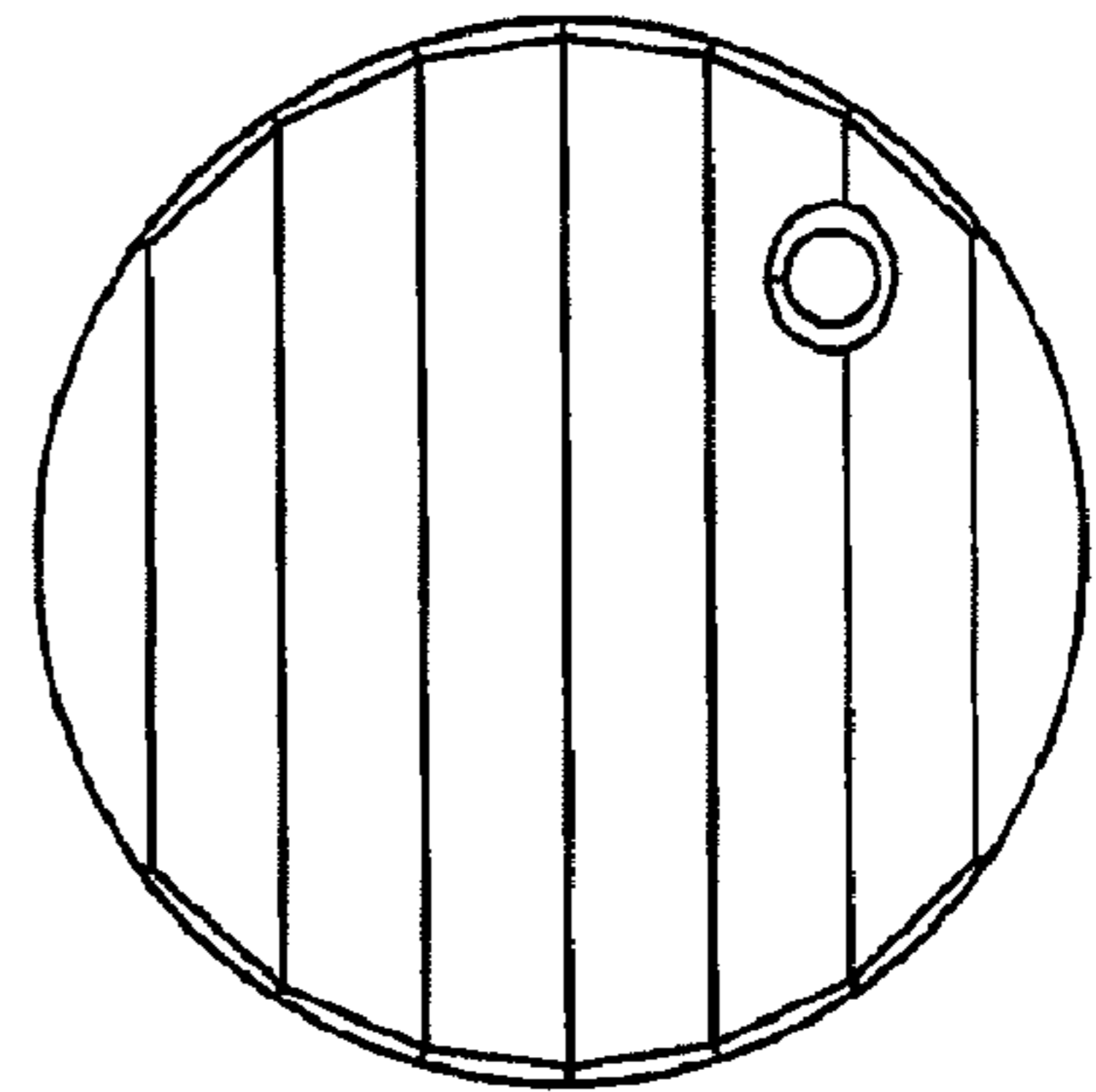

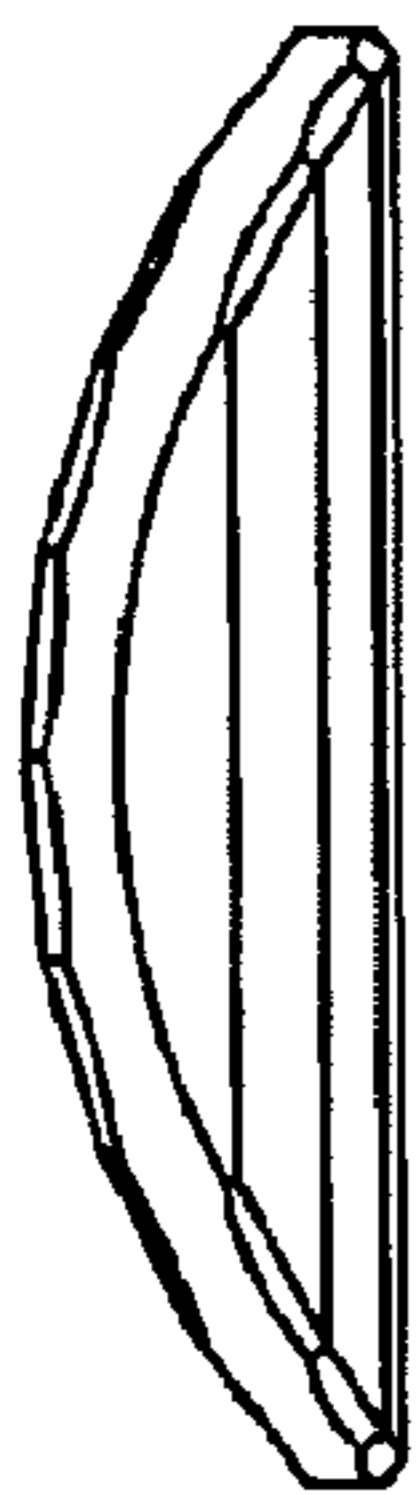

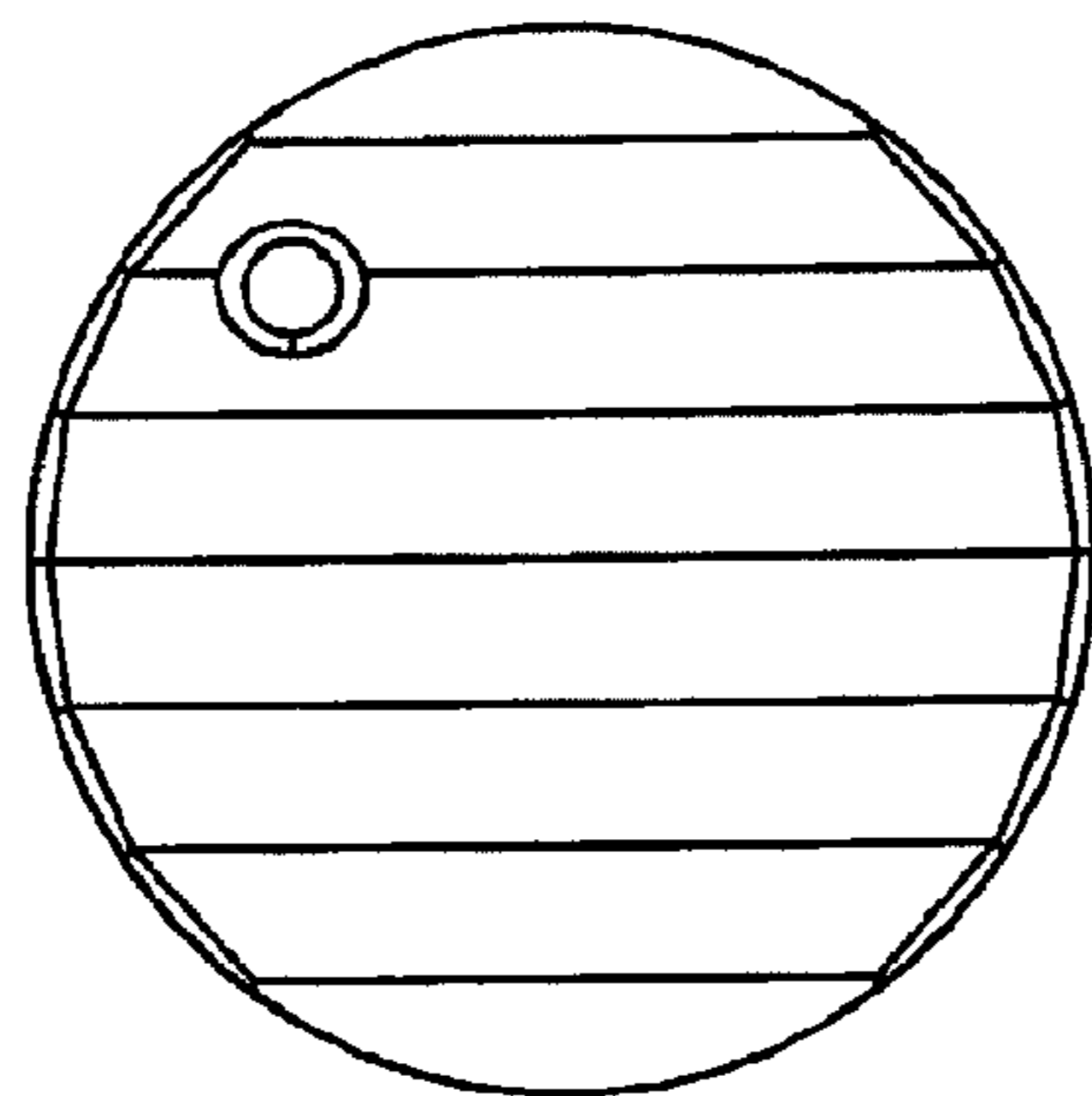

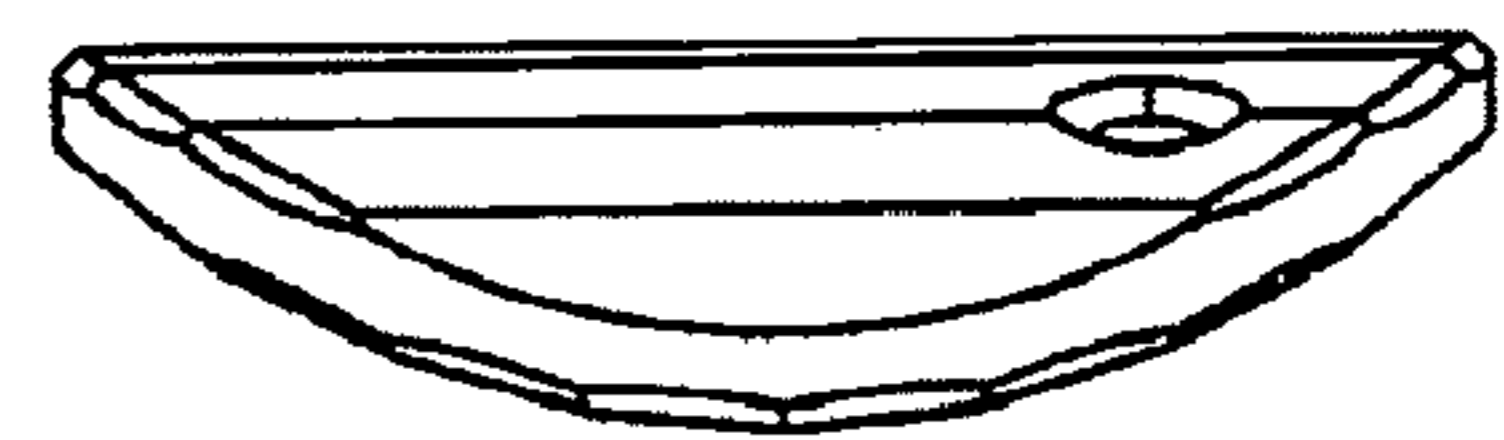

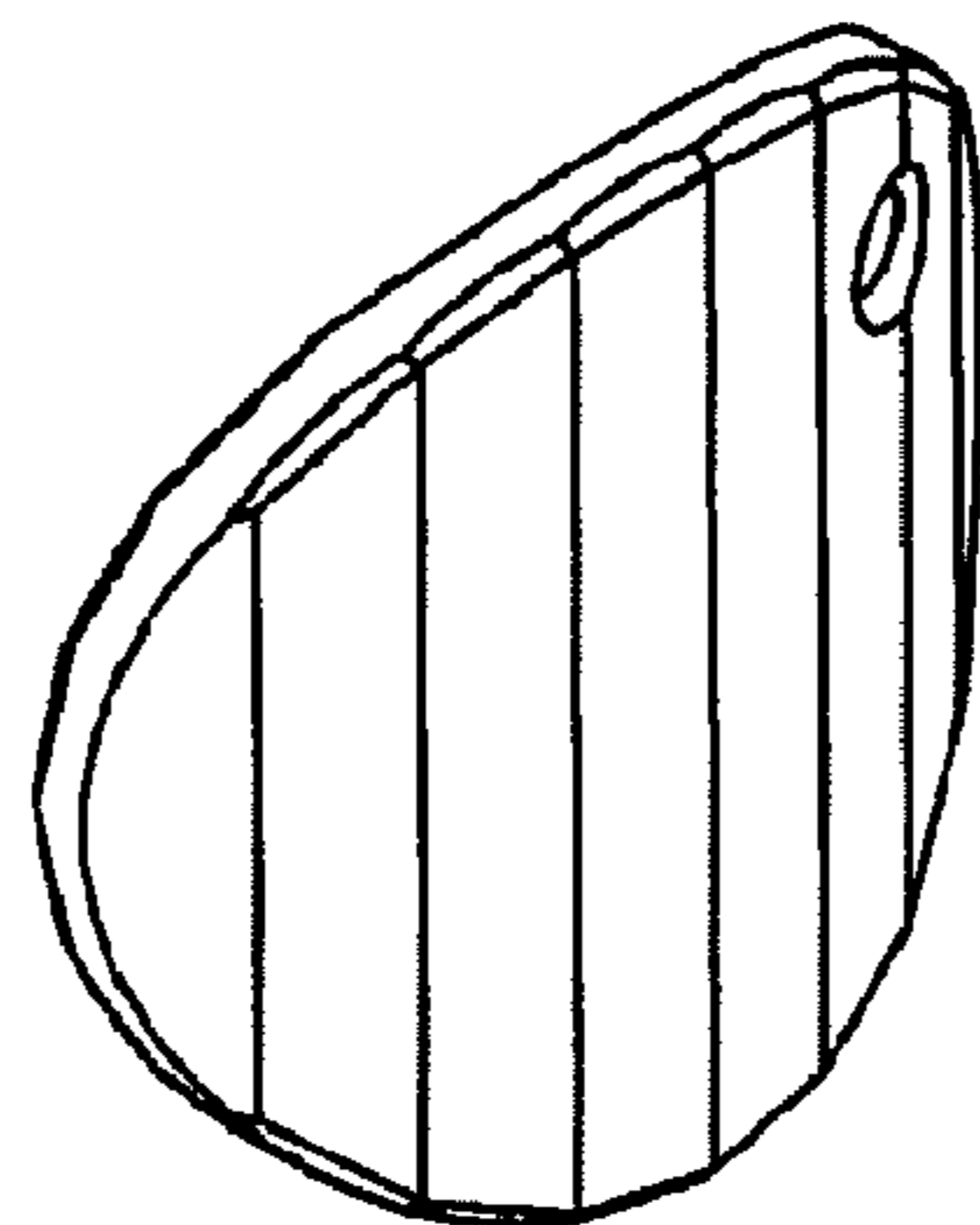

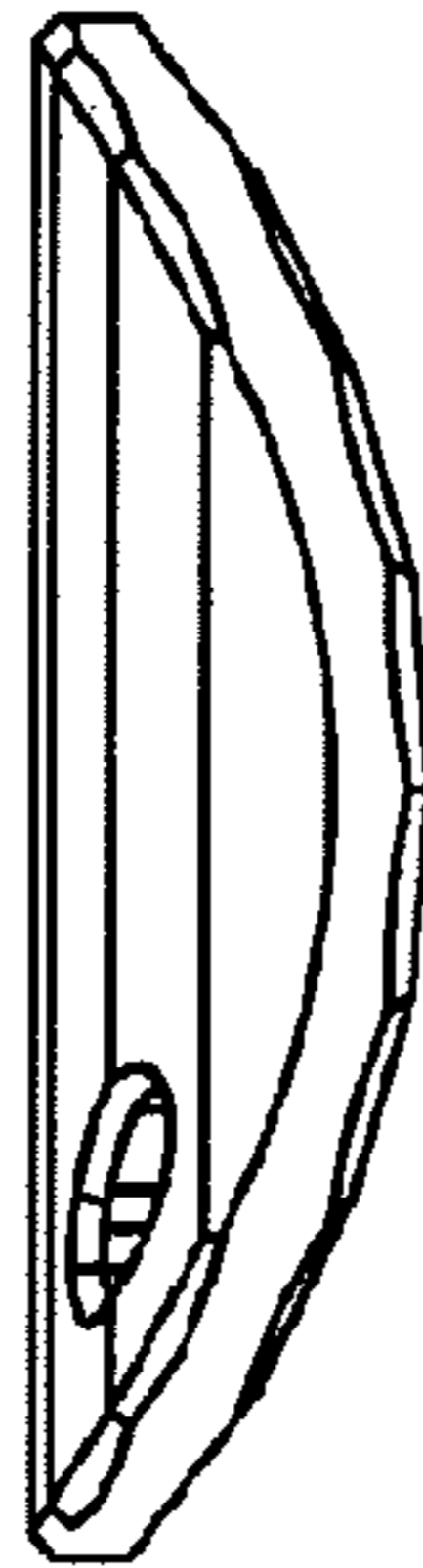

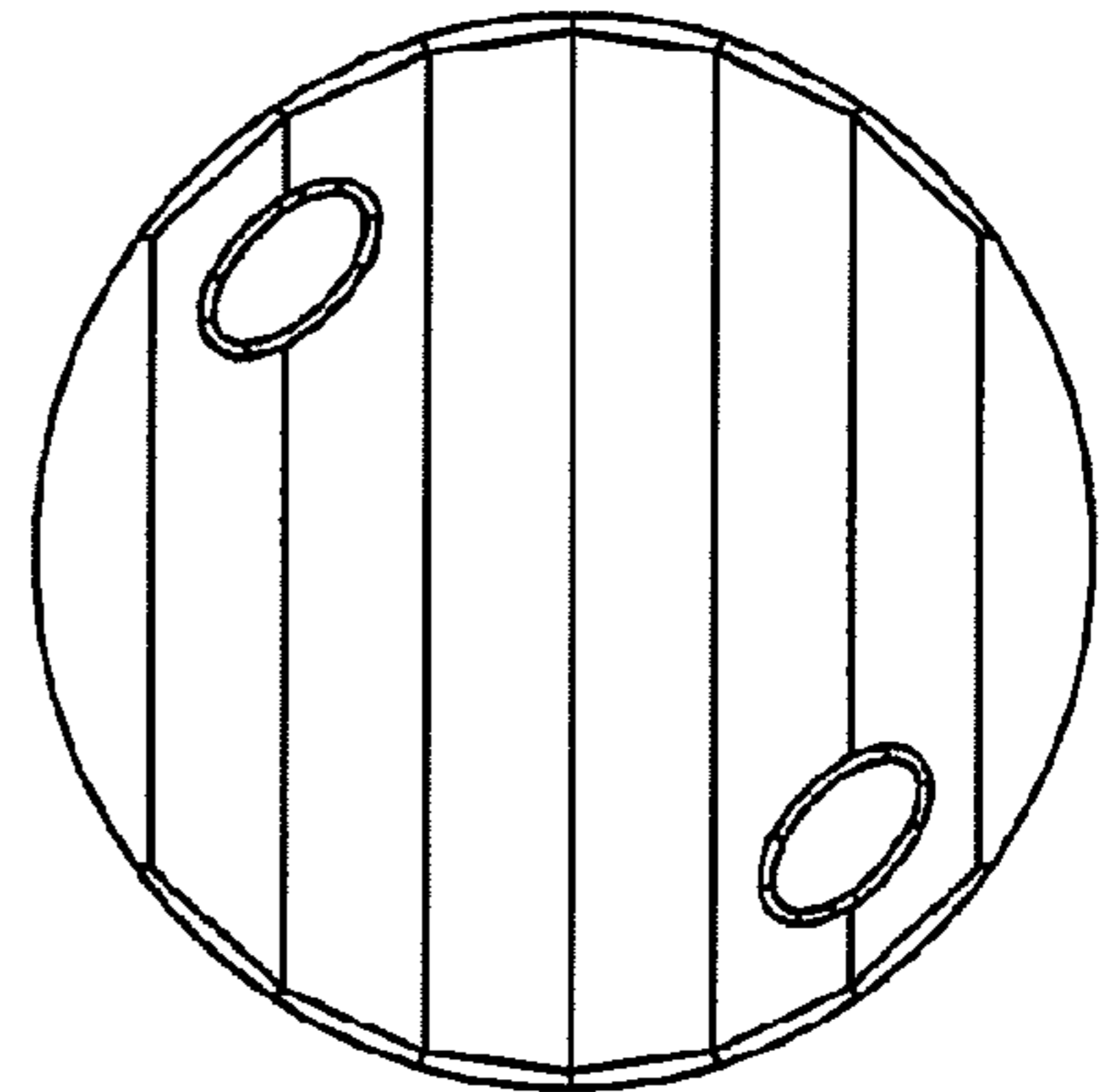

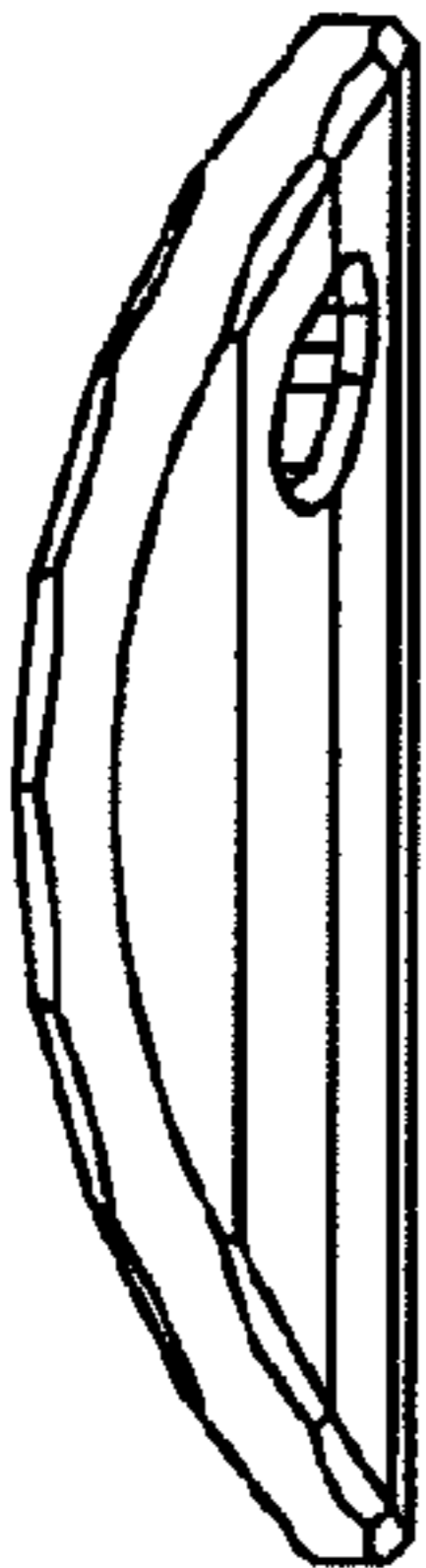

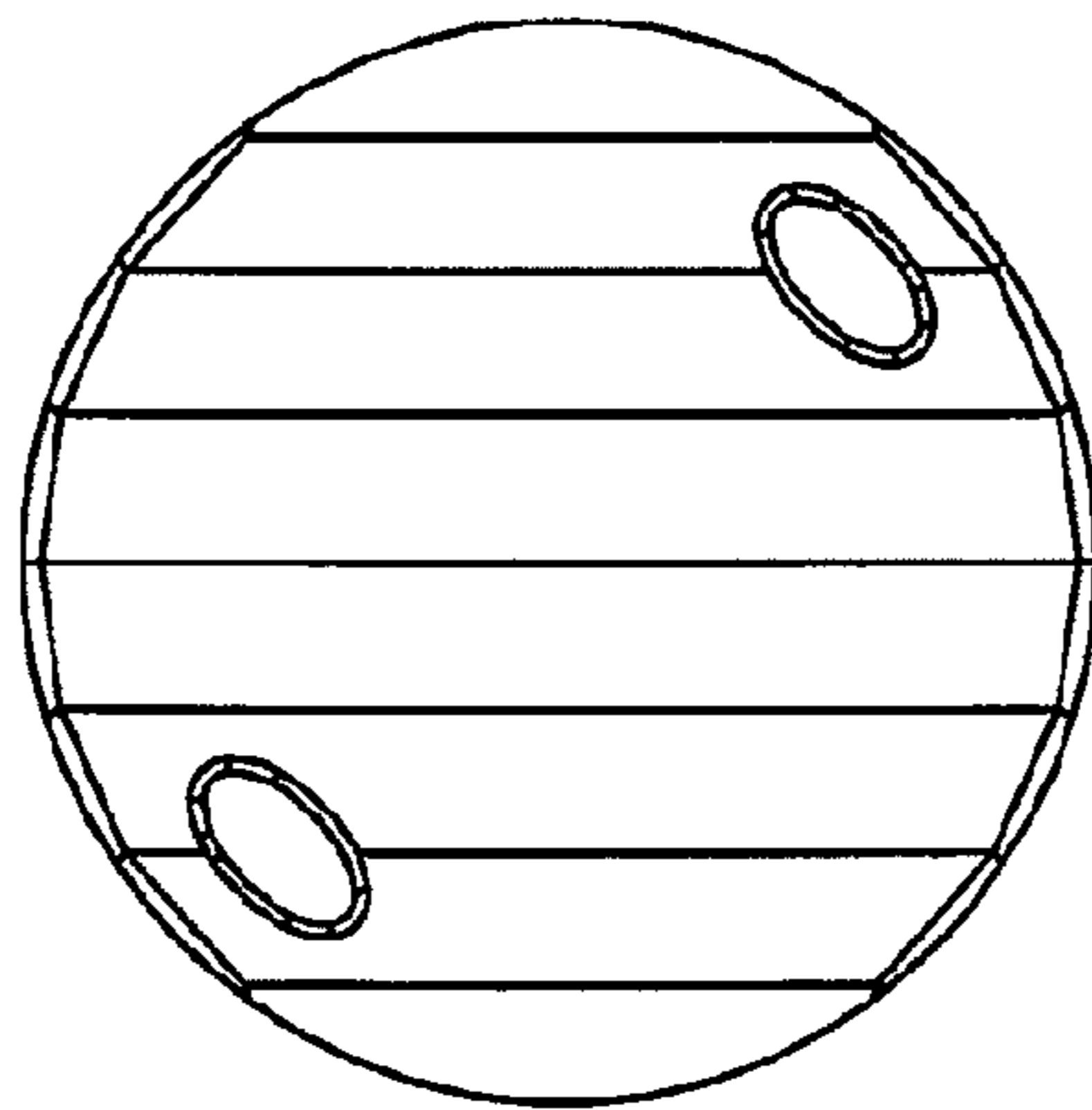

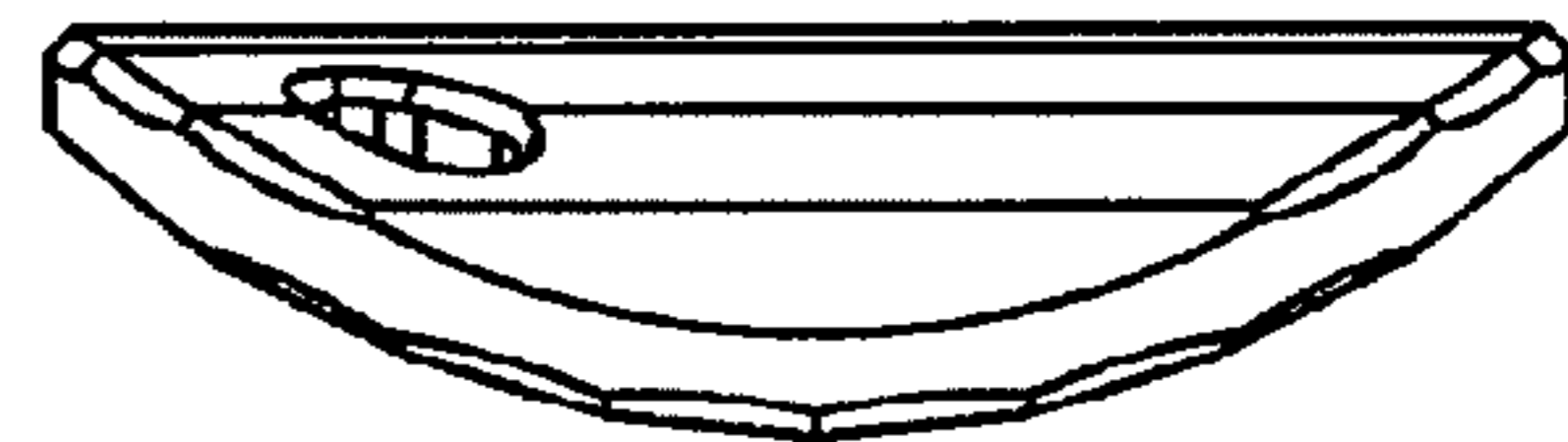

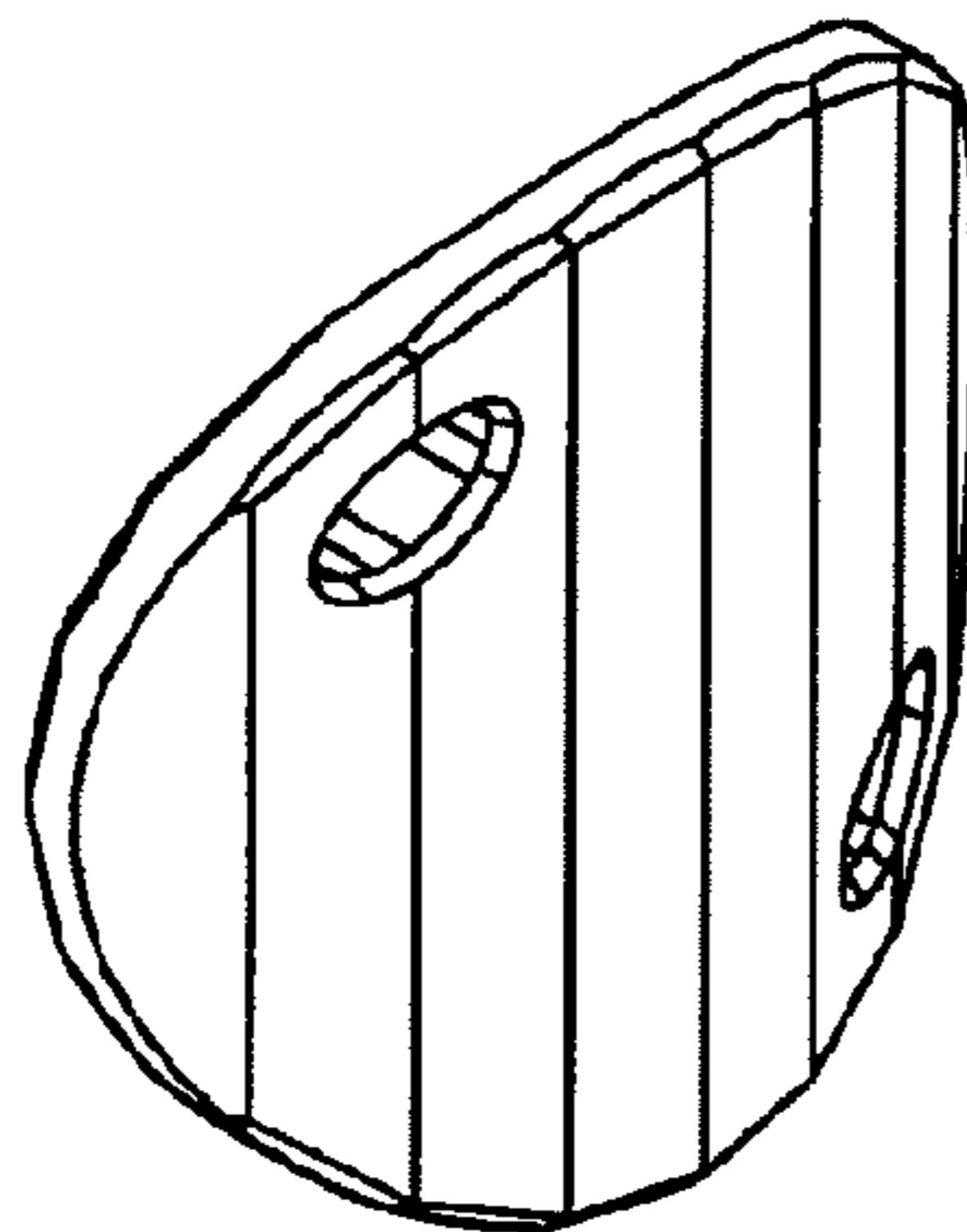
