FIG. 3 is a left-side elevation view thereof;

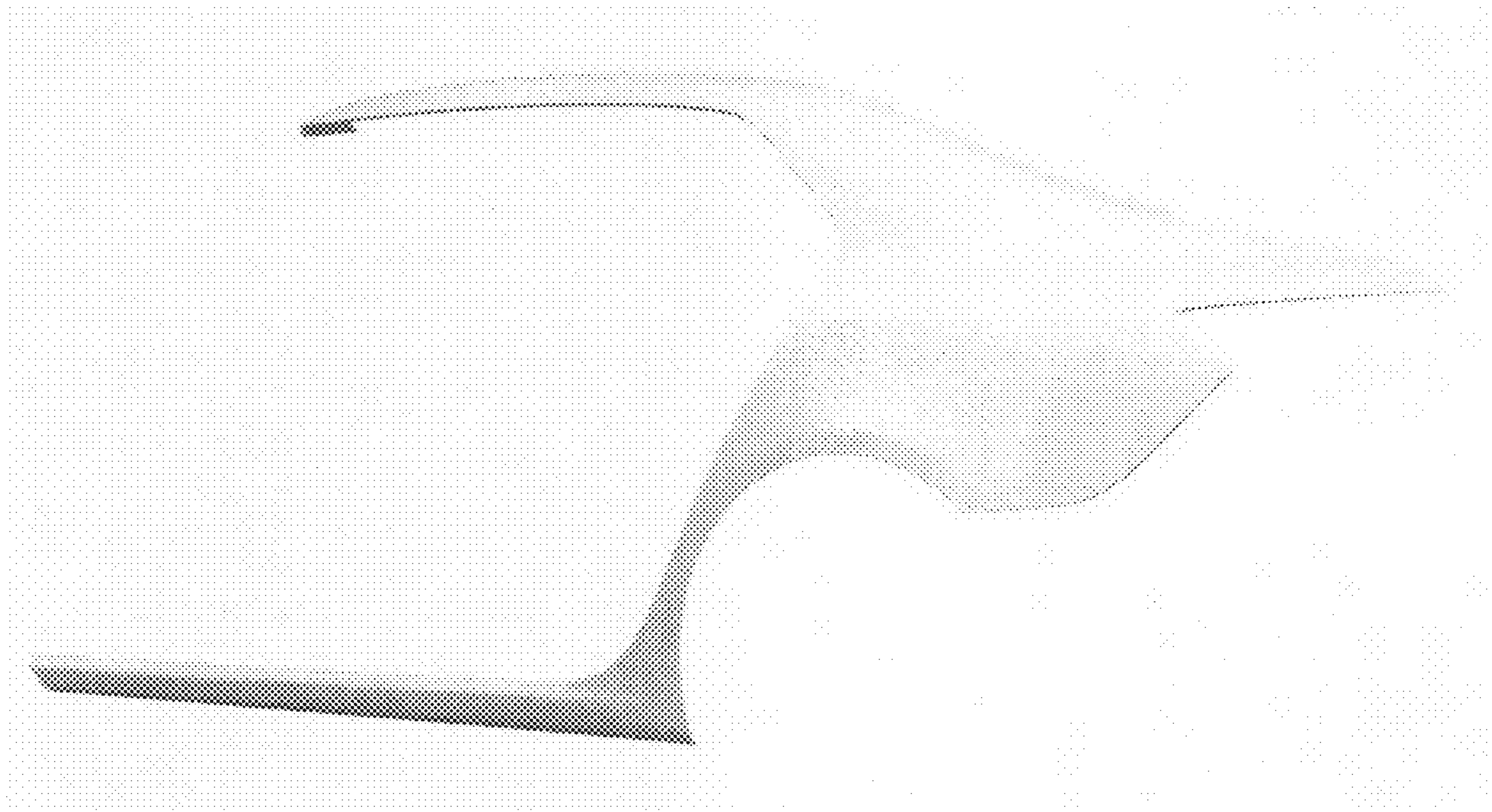
FIG. 4 is a front elevation view thereof;

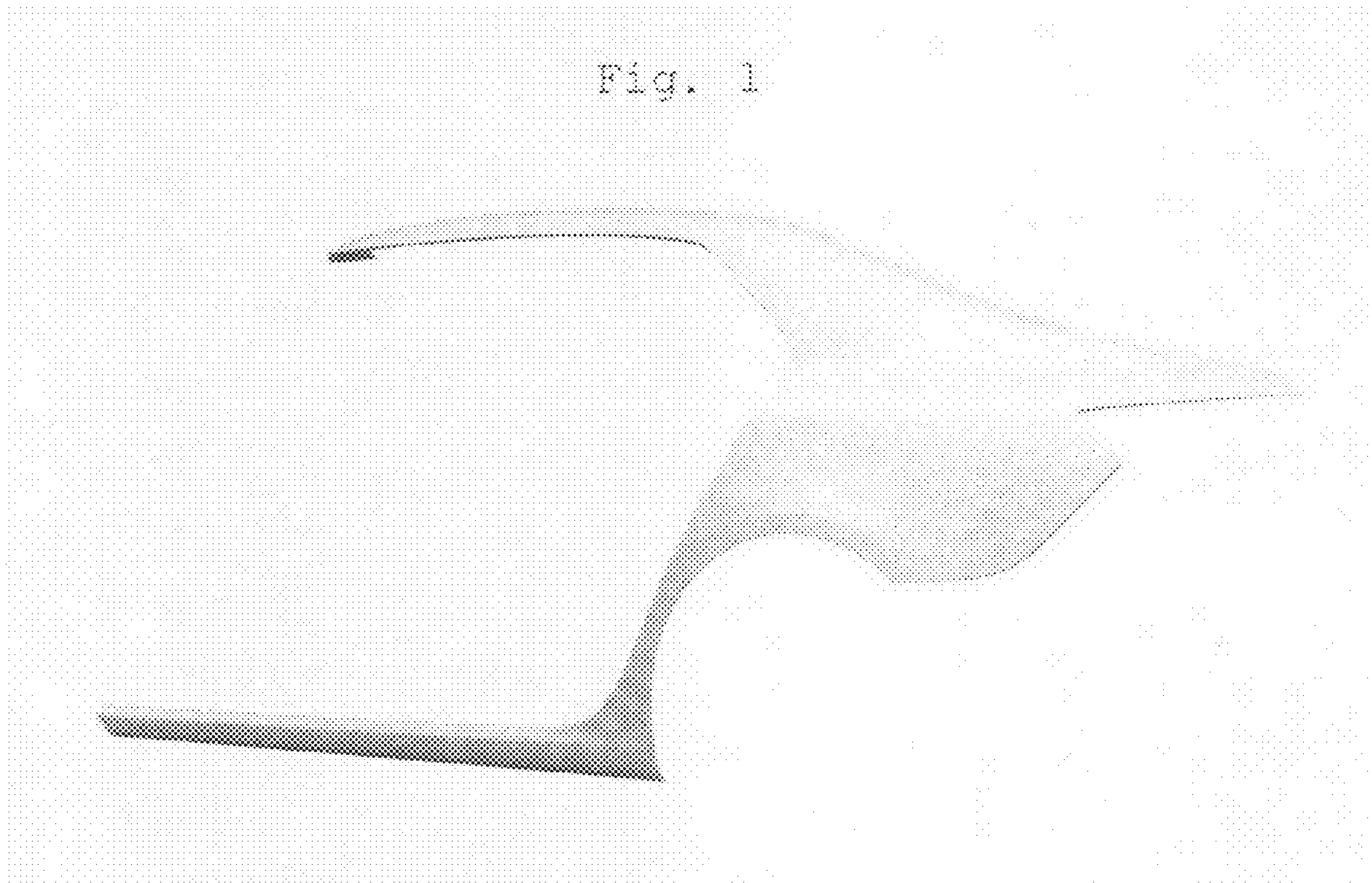

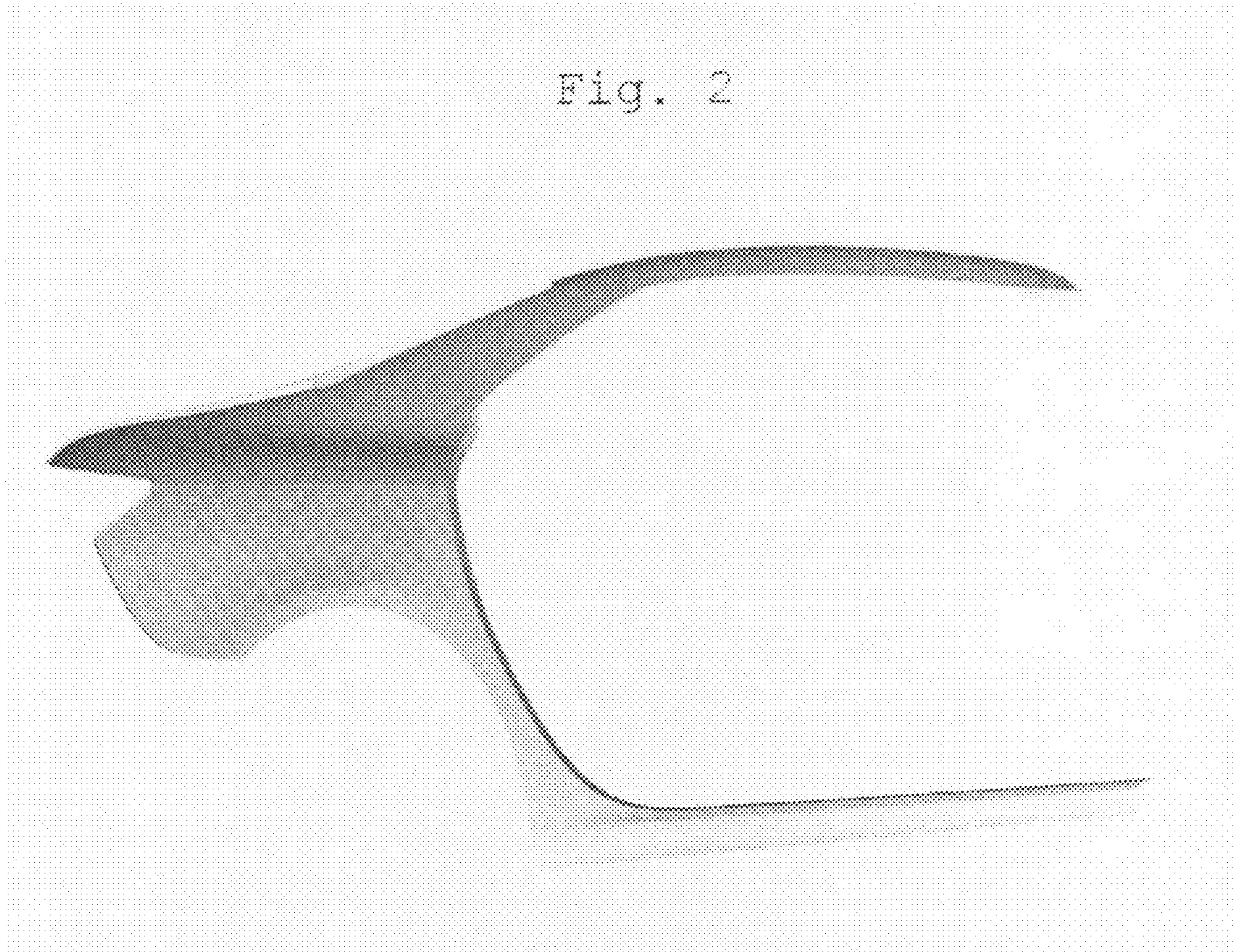

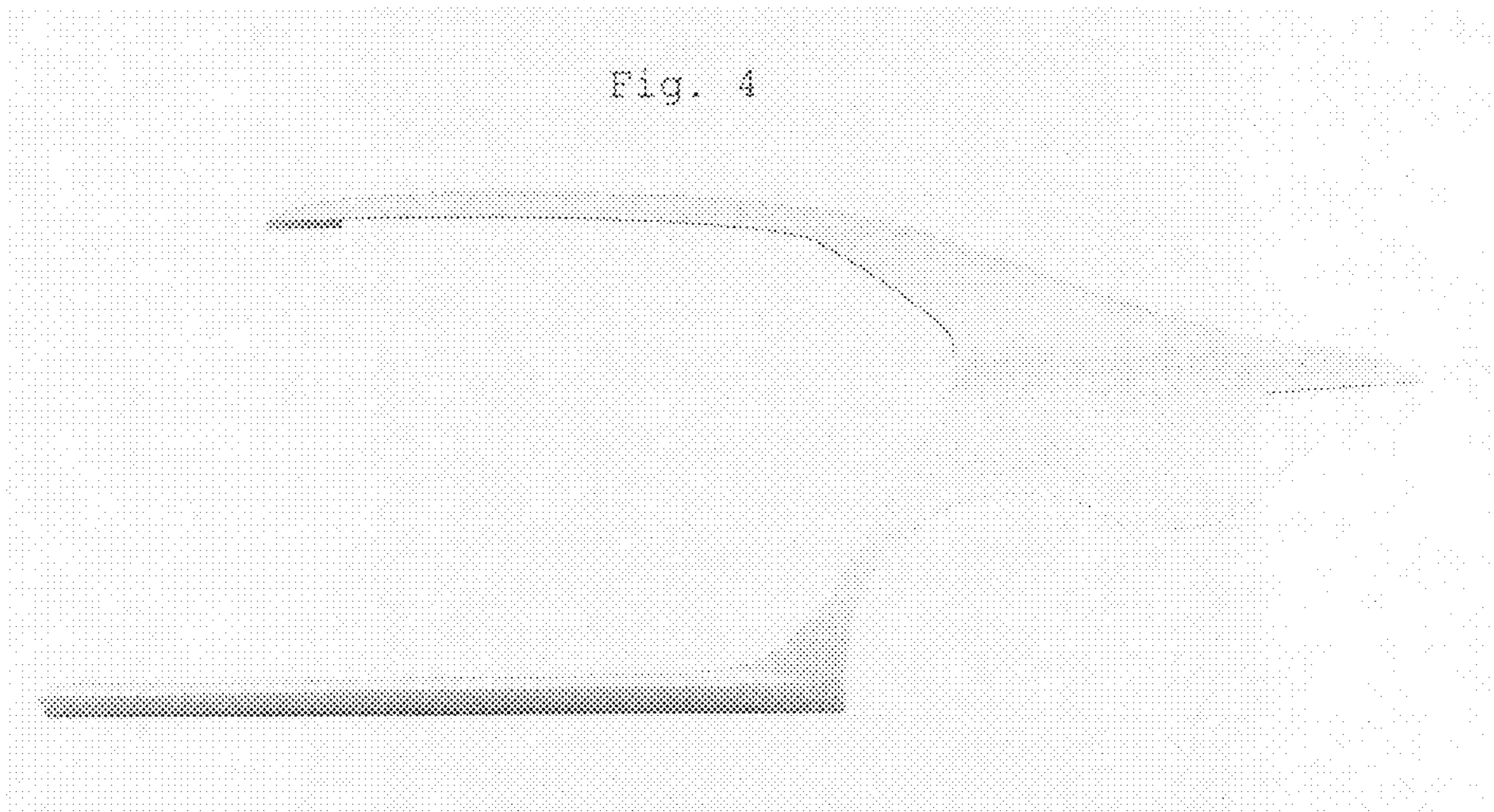
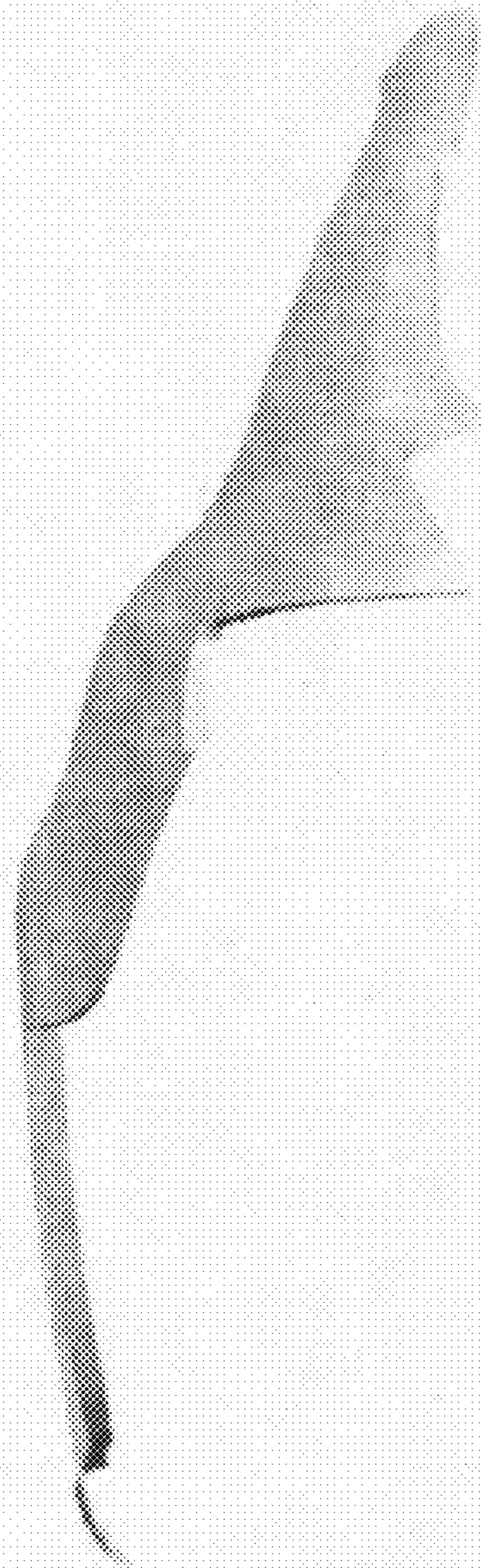
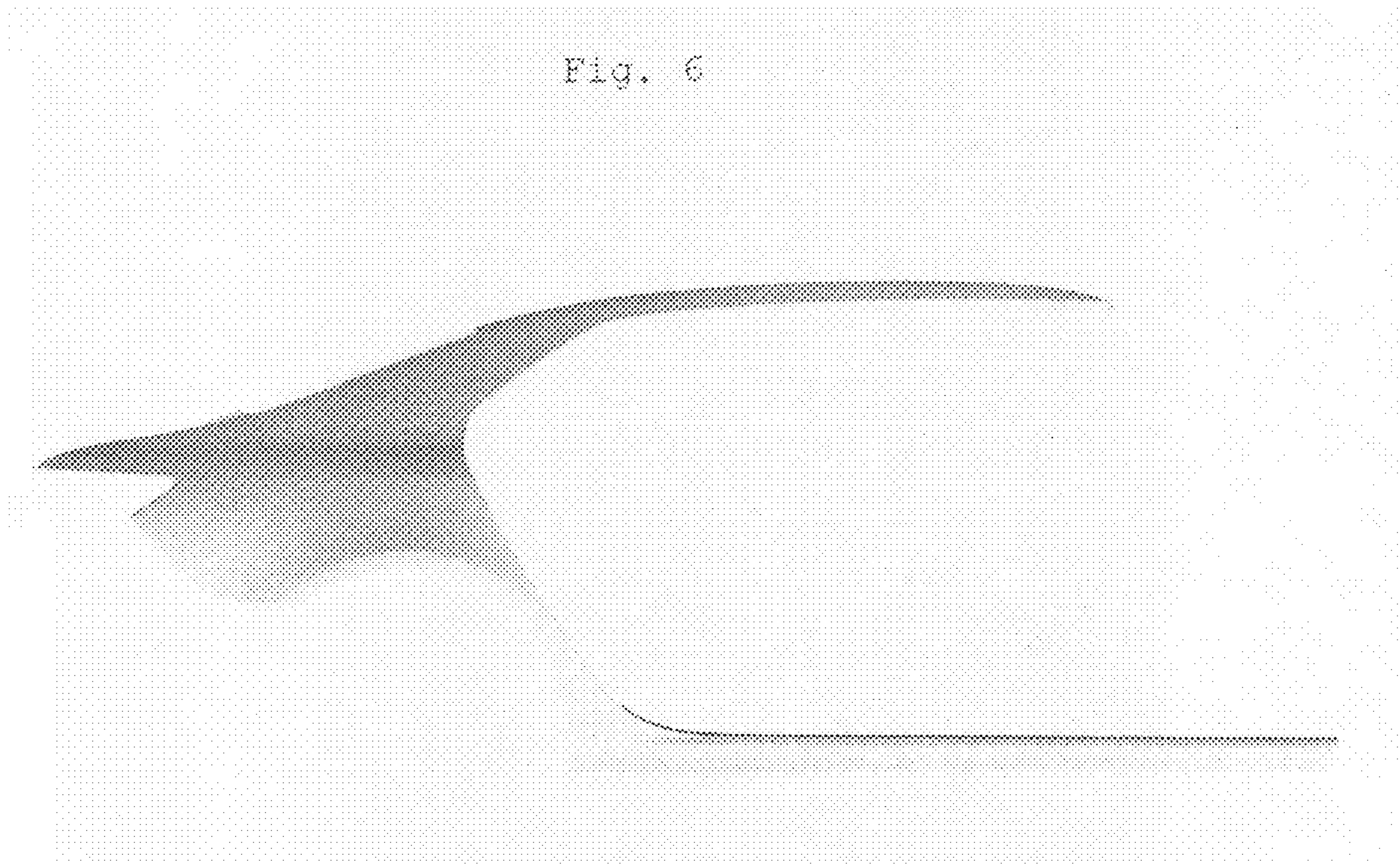
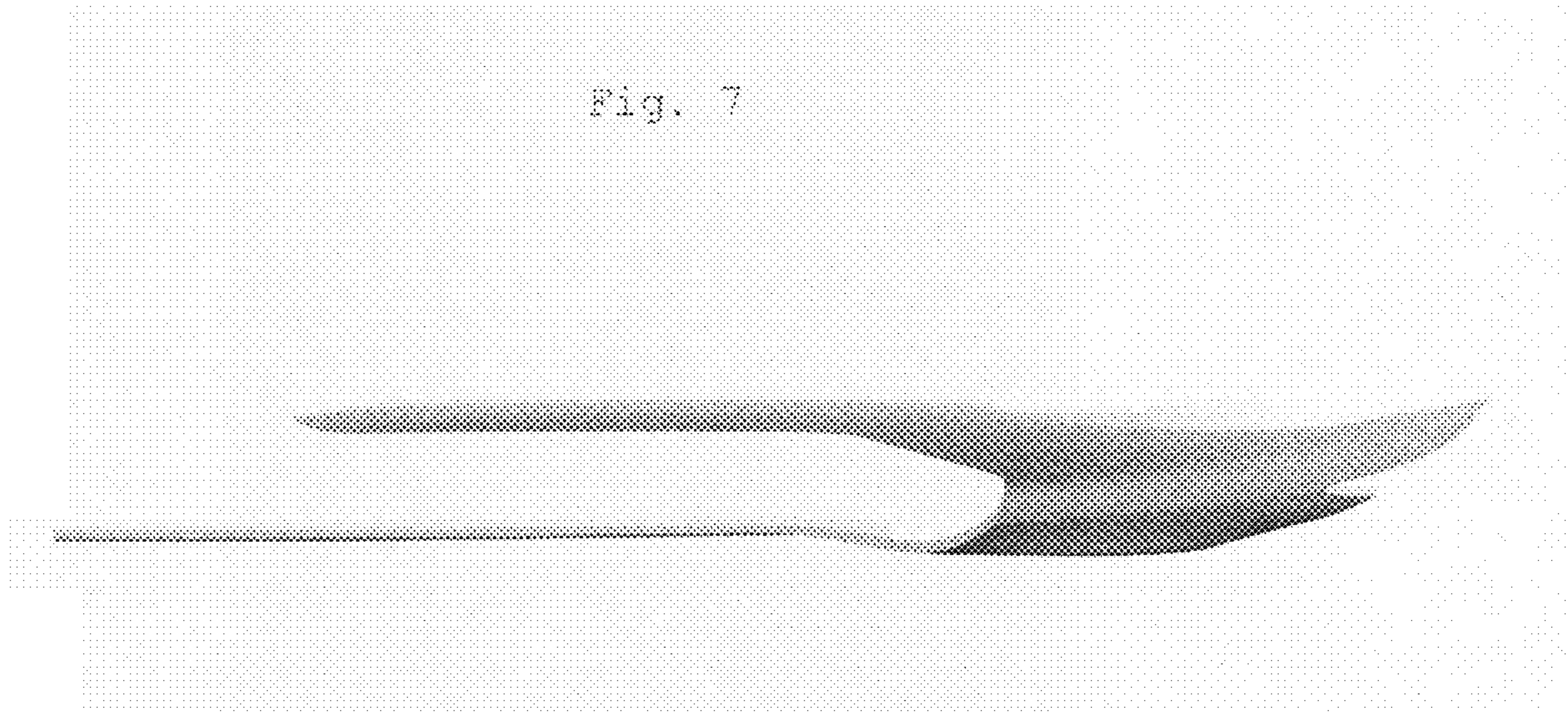

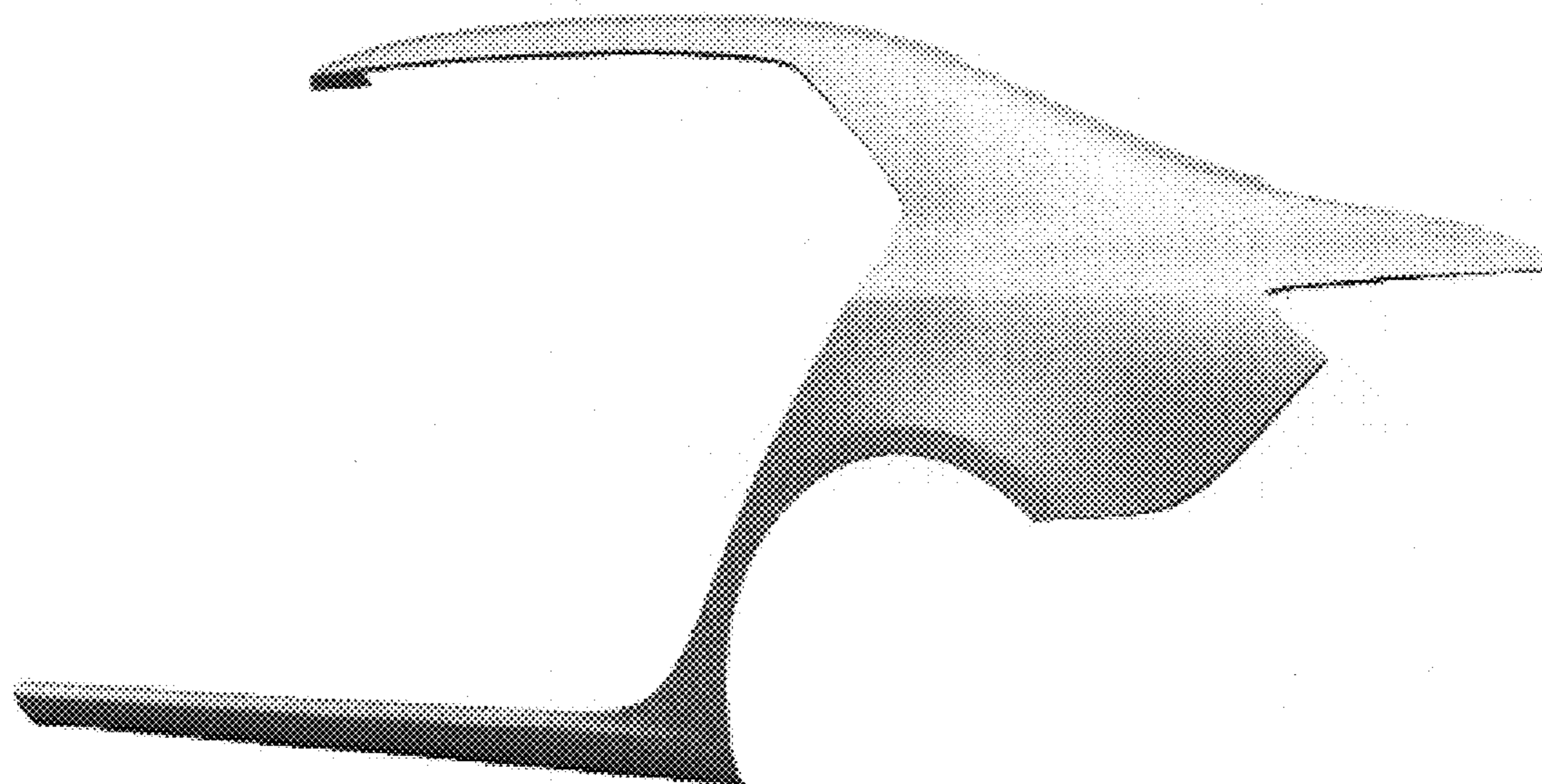

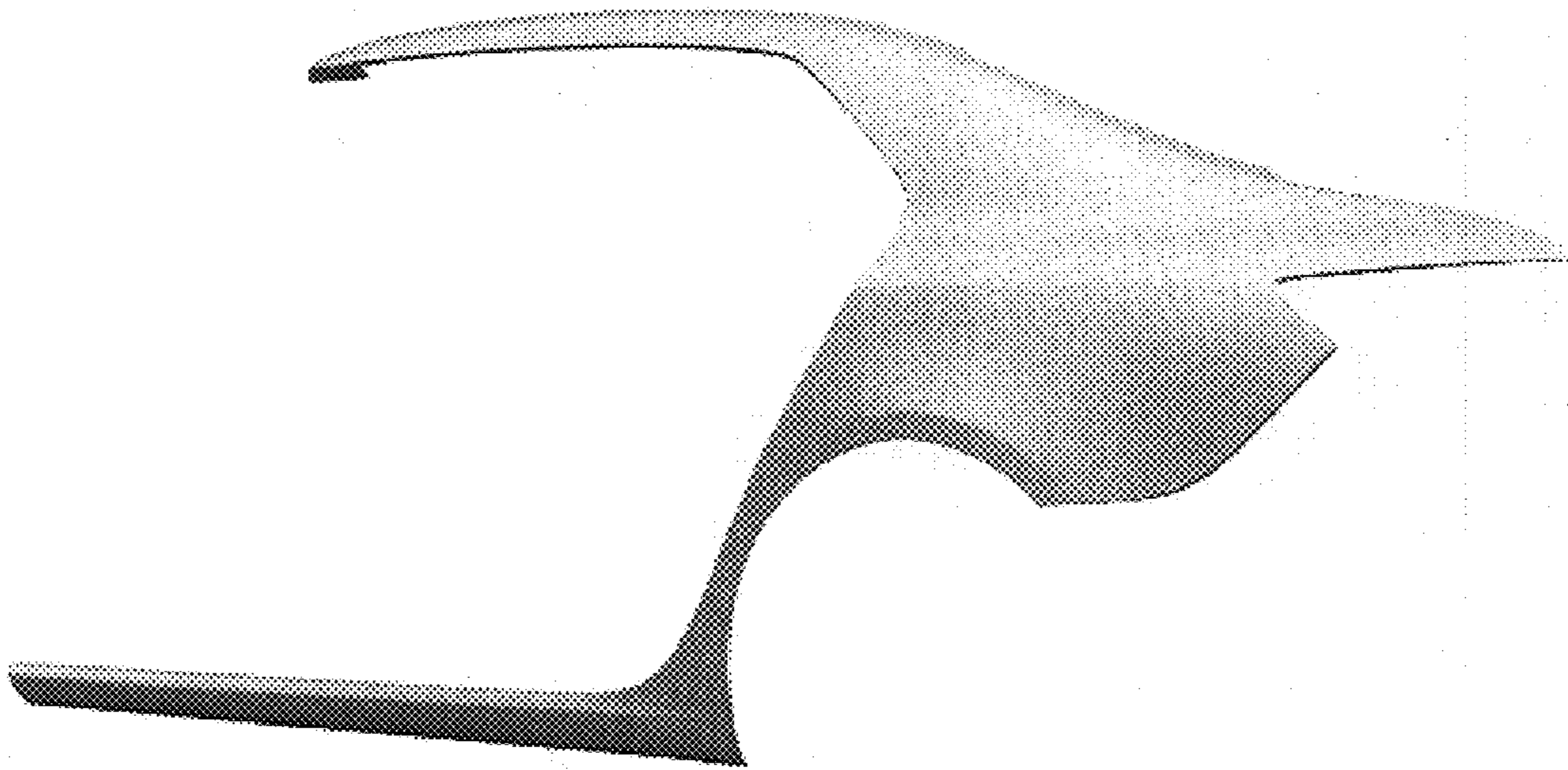

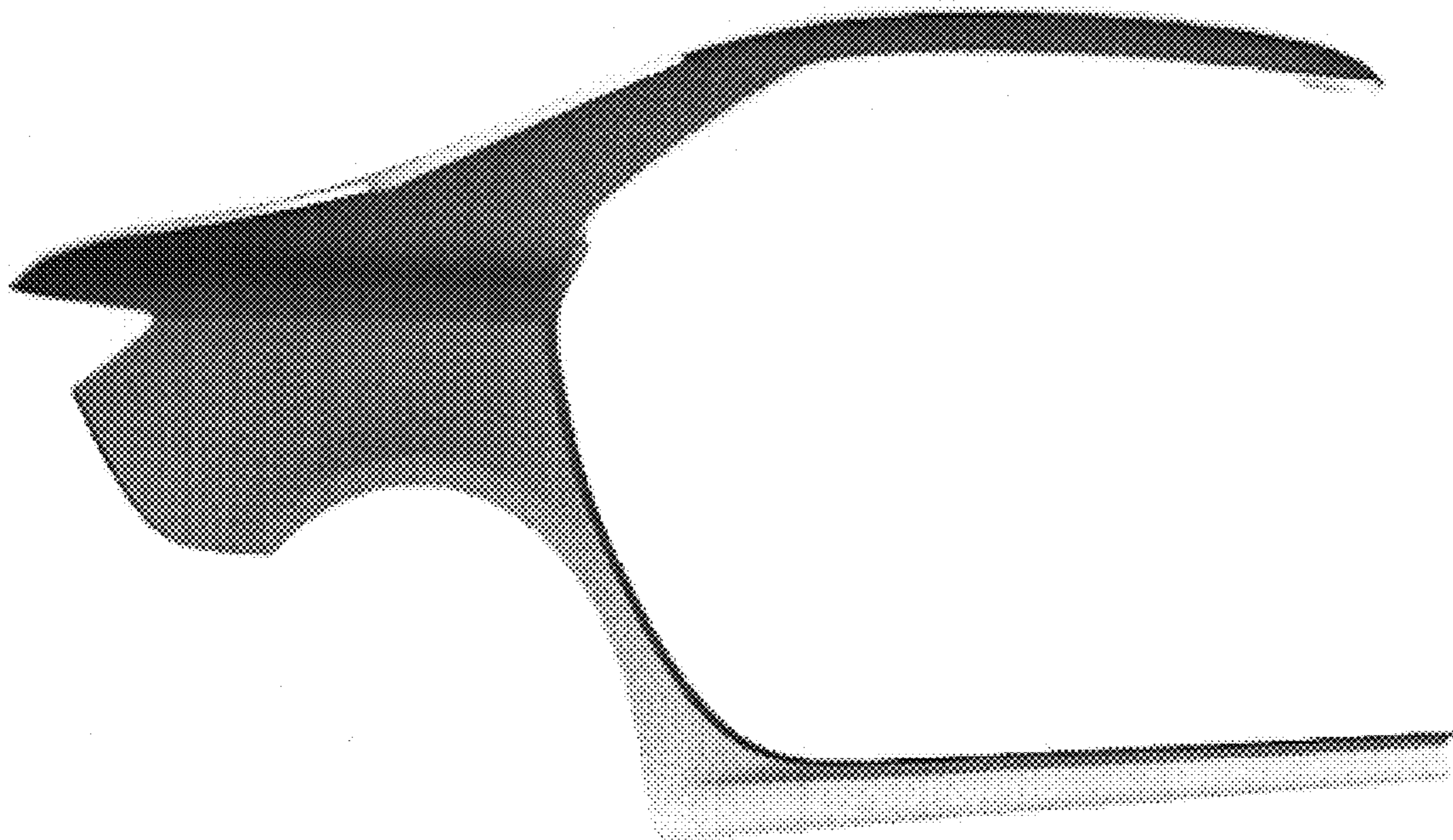

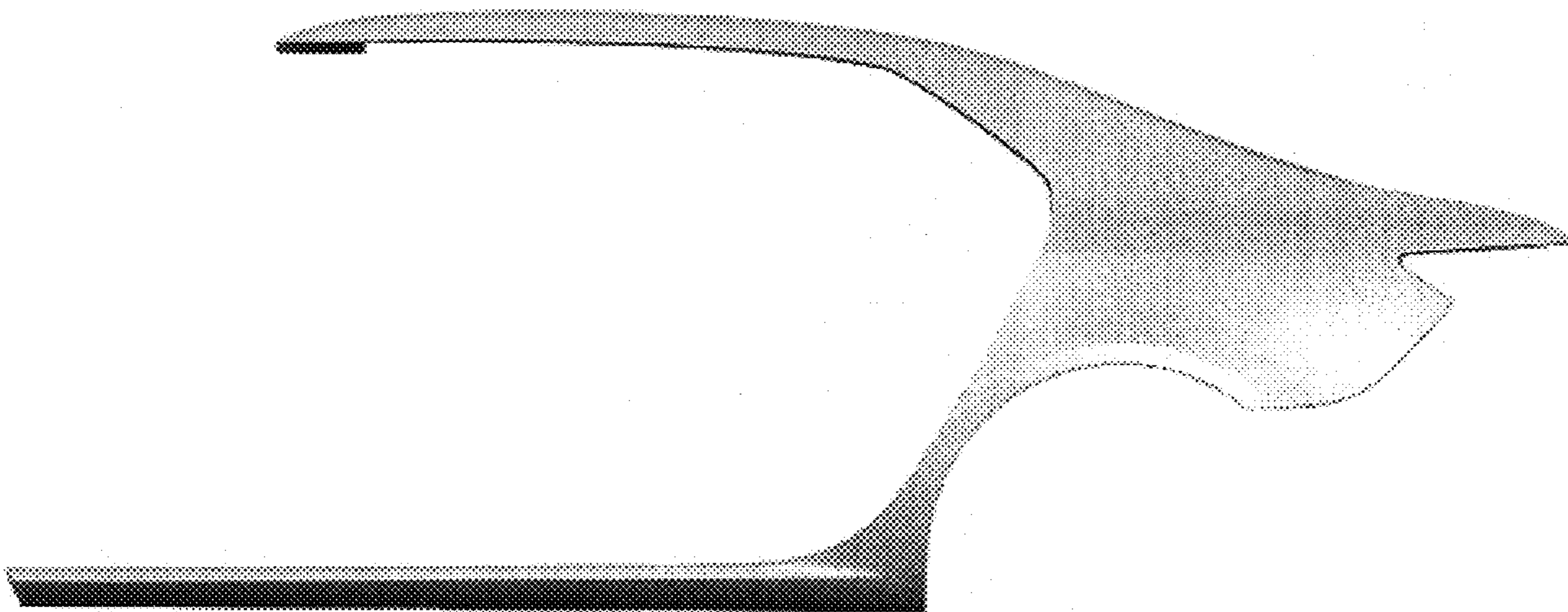

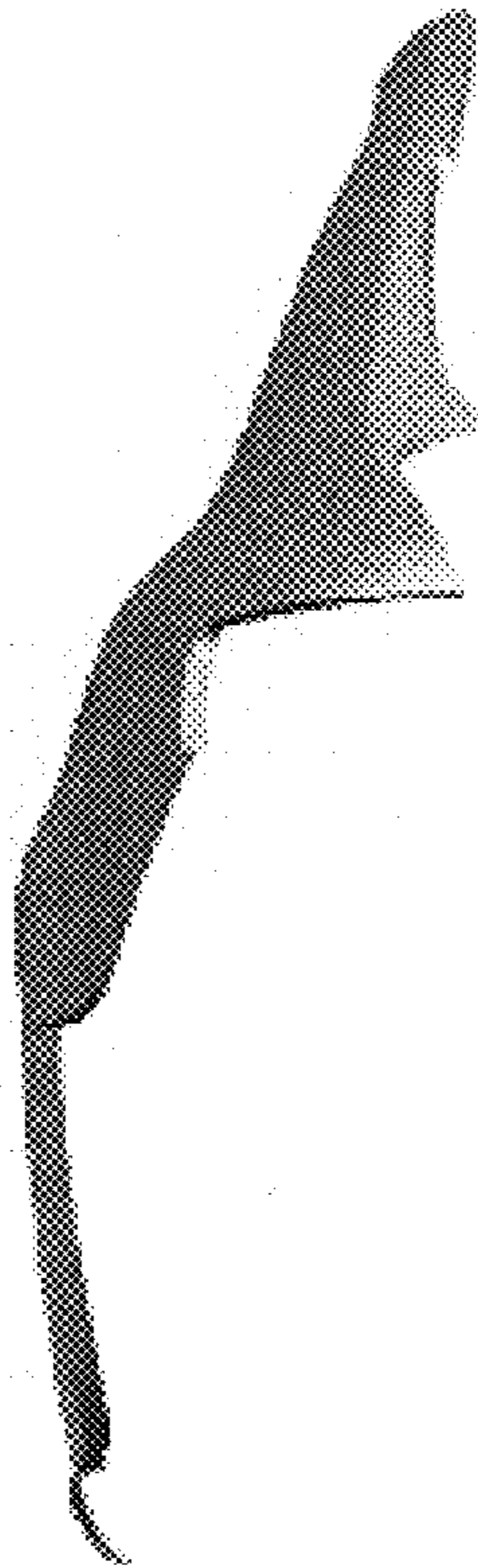
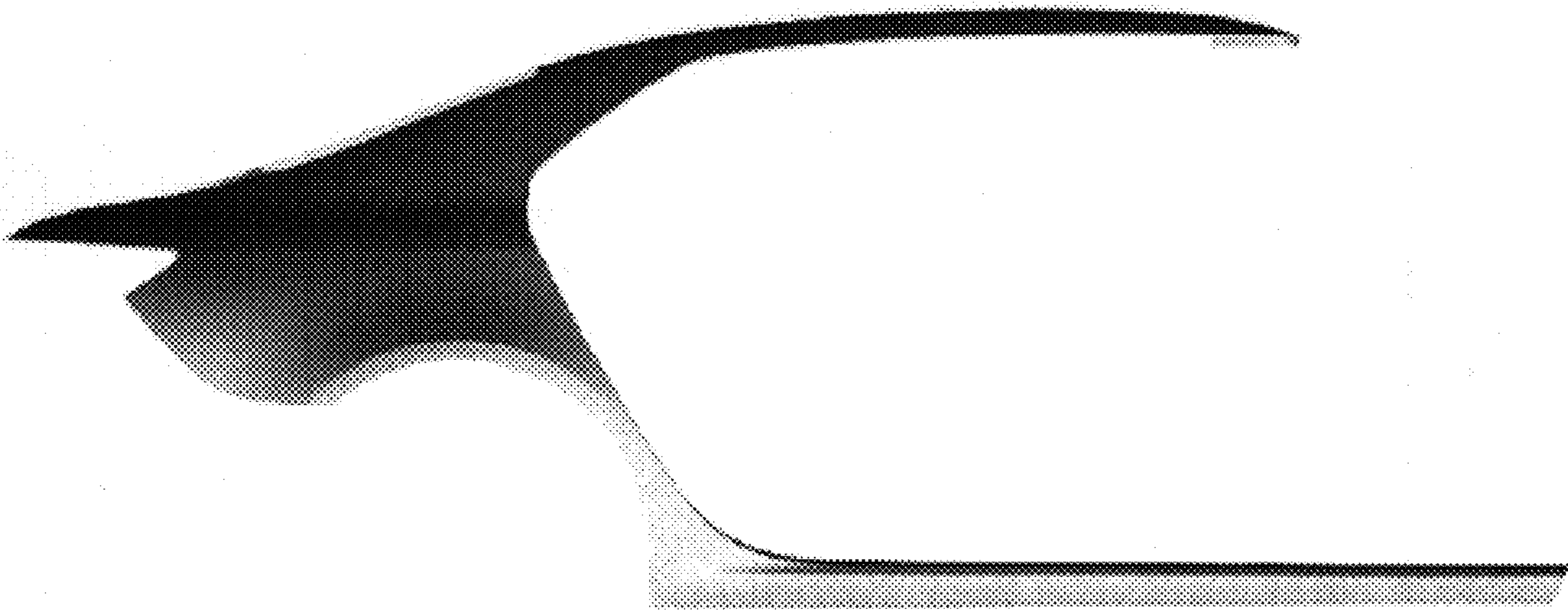
