(57) **CLAIM**

The ornamental design for an illuminated switch, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of an illuminated switch in
accordance with the present design, as viewed from above;
FIG. 2 is a perspective view thereof as viewed from below;
FIG. 3 is a front plan view thereof;
FIG. 4 is a rear plan view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

This illuminated switch may be used in electronic devices
such as digital cameras, mobile phones and audio products
and also used in home electronic appliances and automobiles.

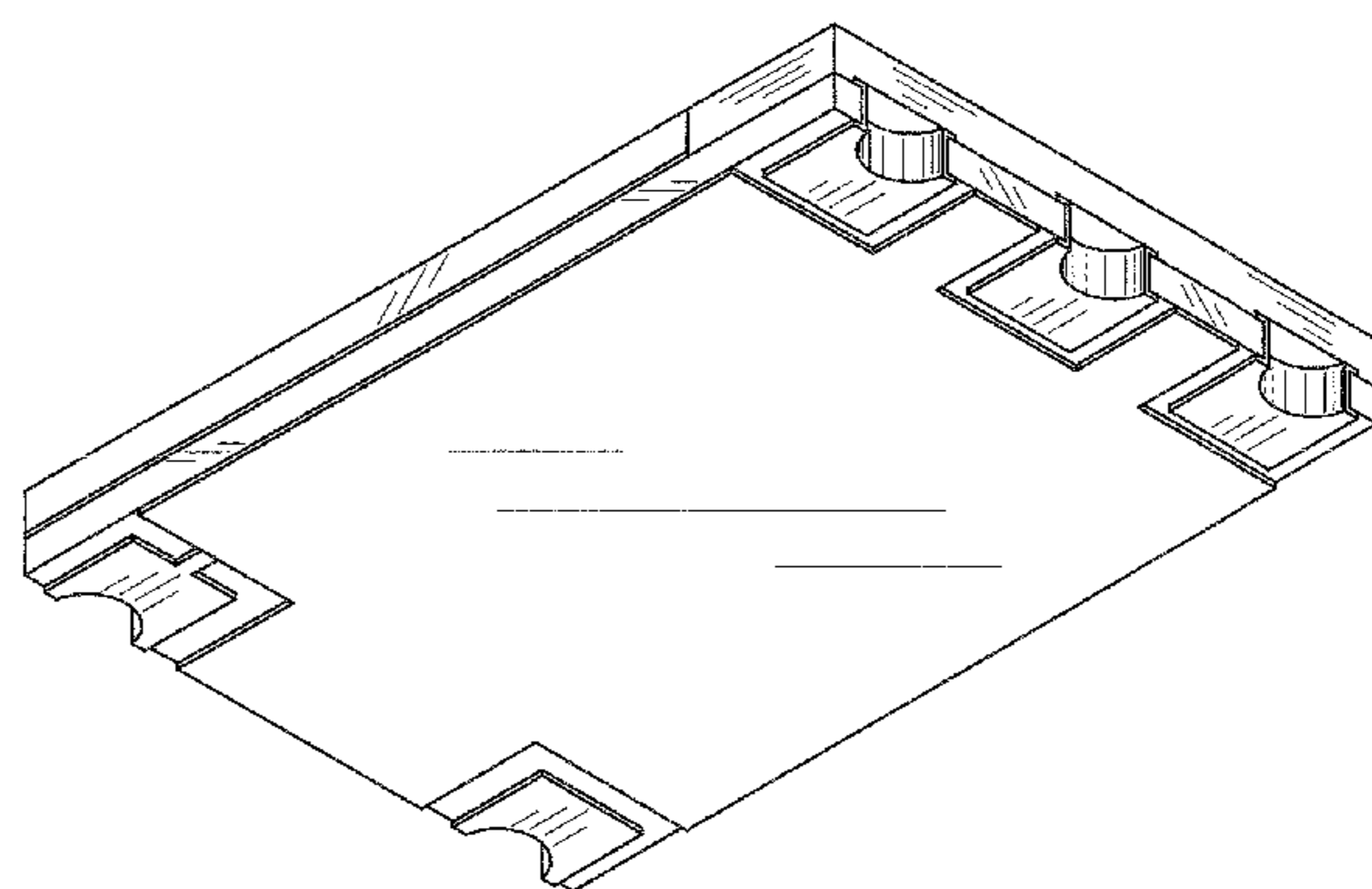
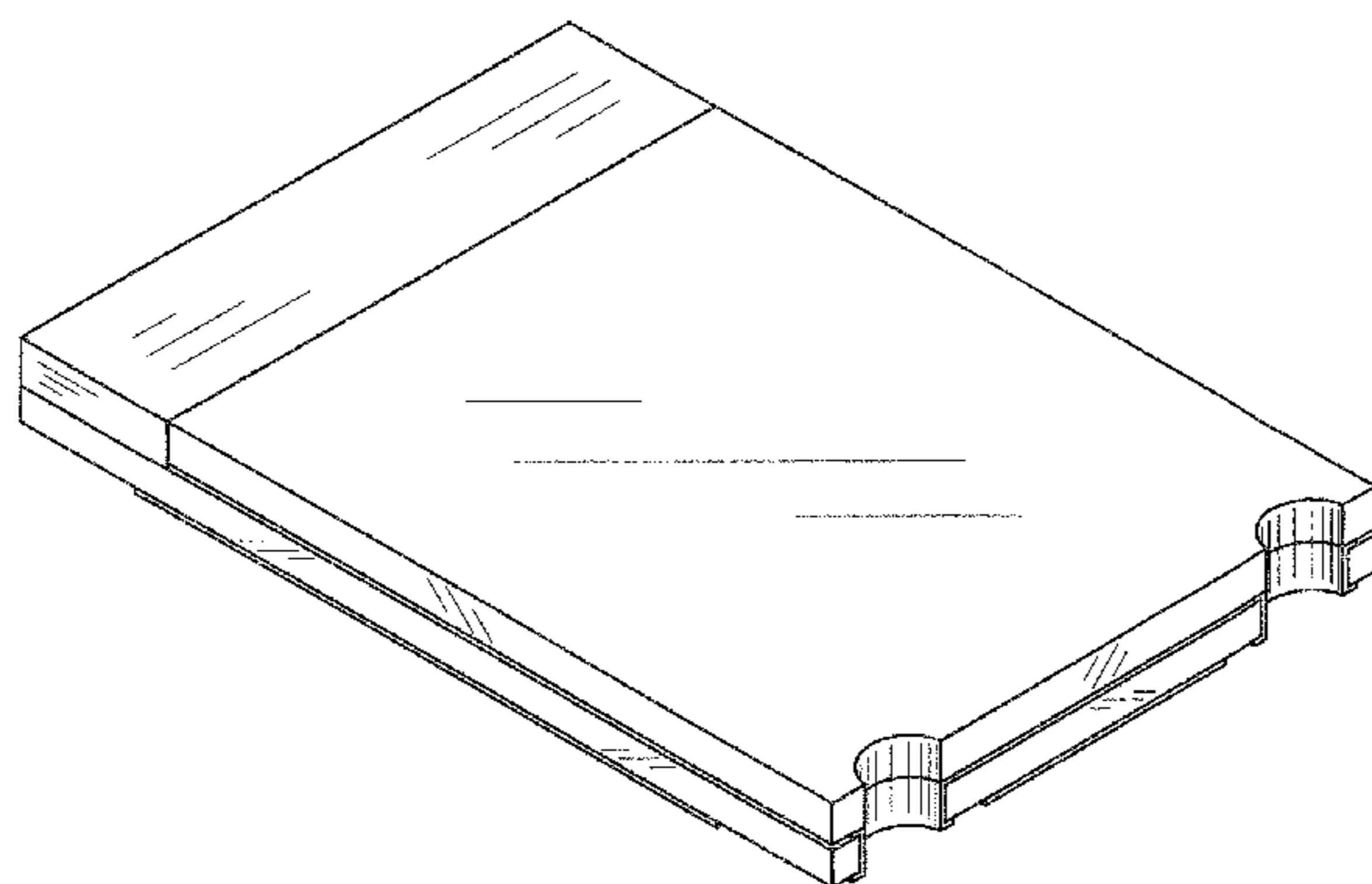

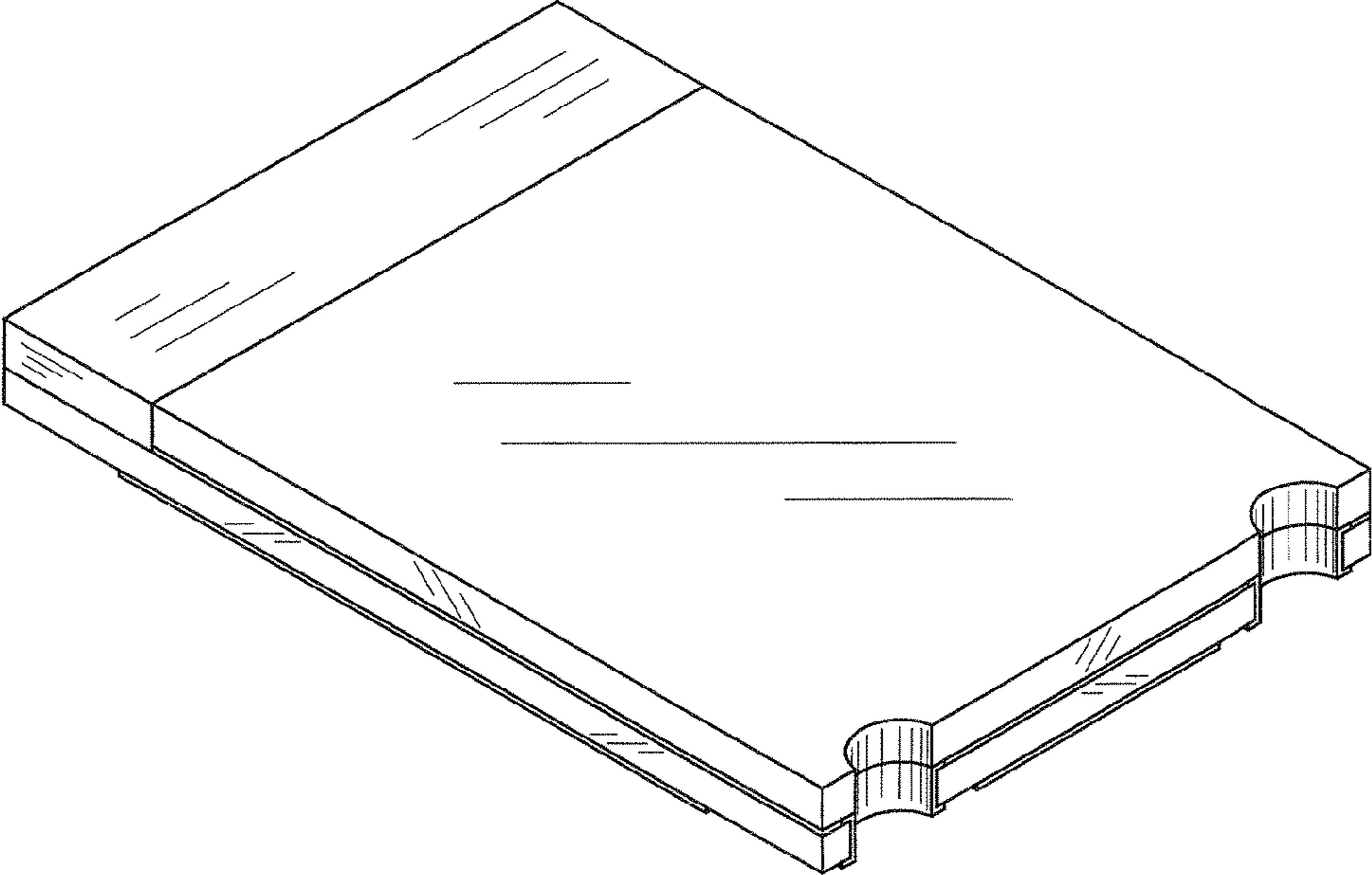

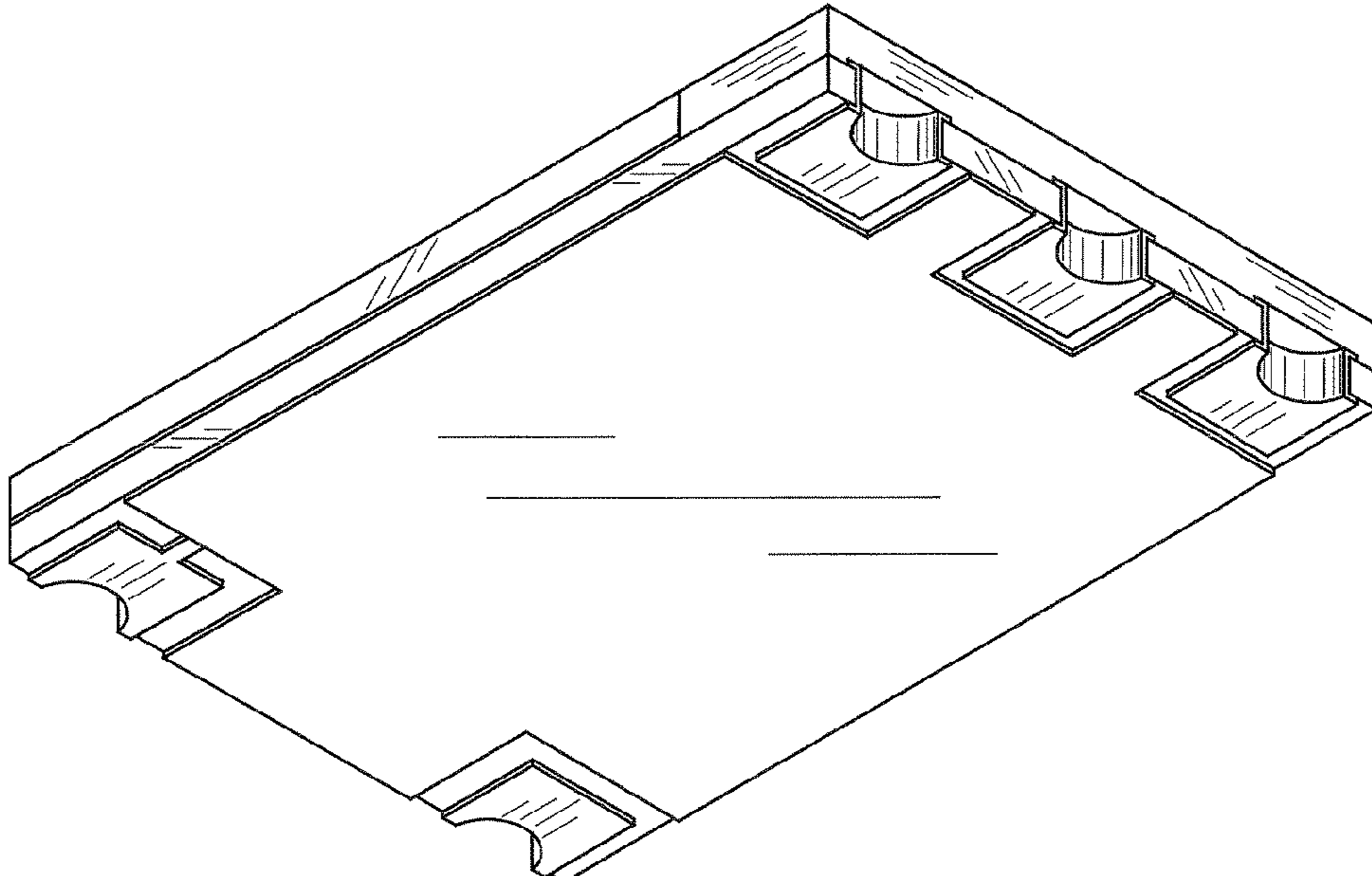

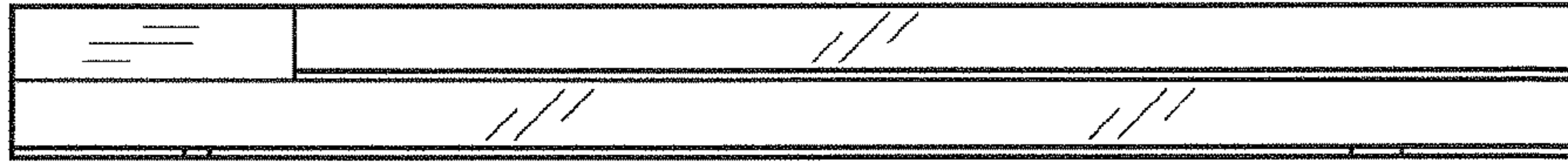

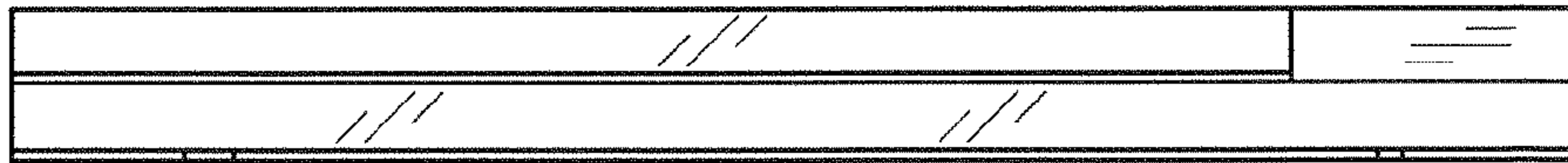

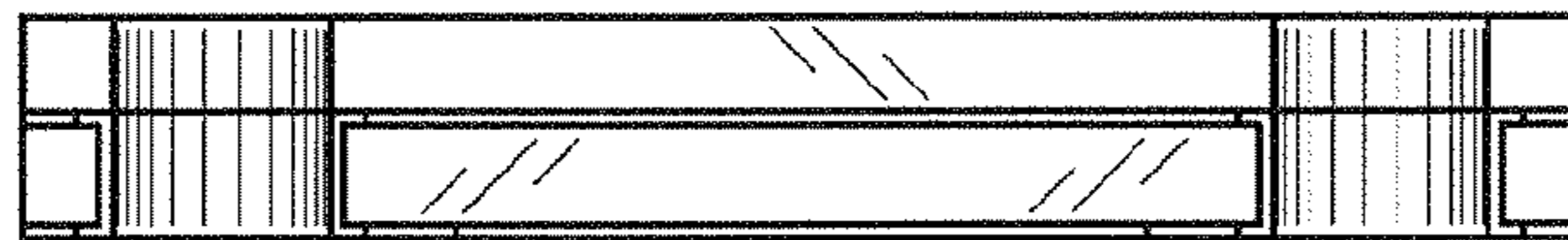

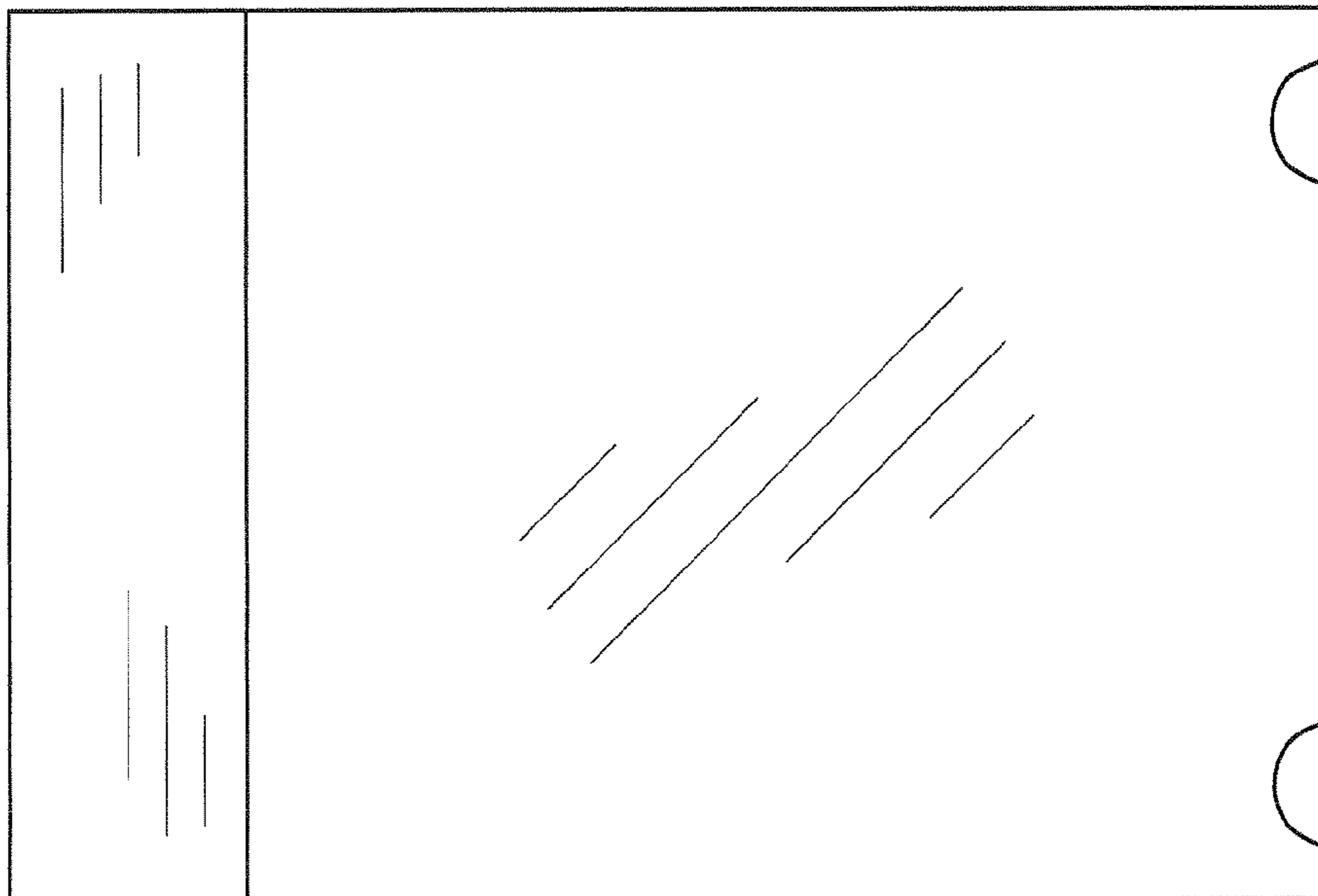
