The ornamental design for a portable communication device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a portable communication device according to our new and ornamental design;

FIG. 4 is a top view thereof;

FIG. 11 is a top view of the embodiment of FIG. 8;

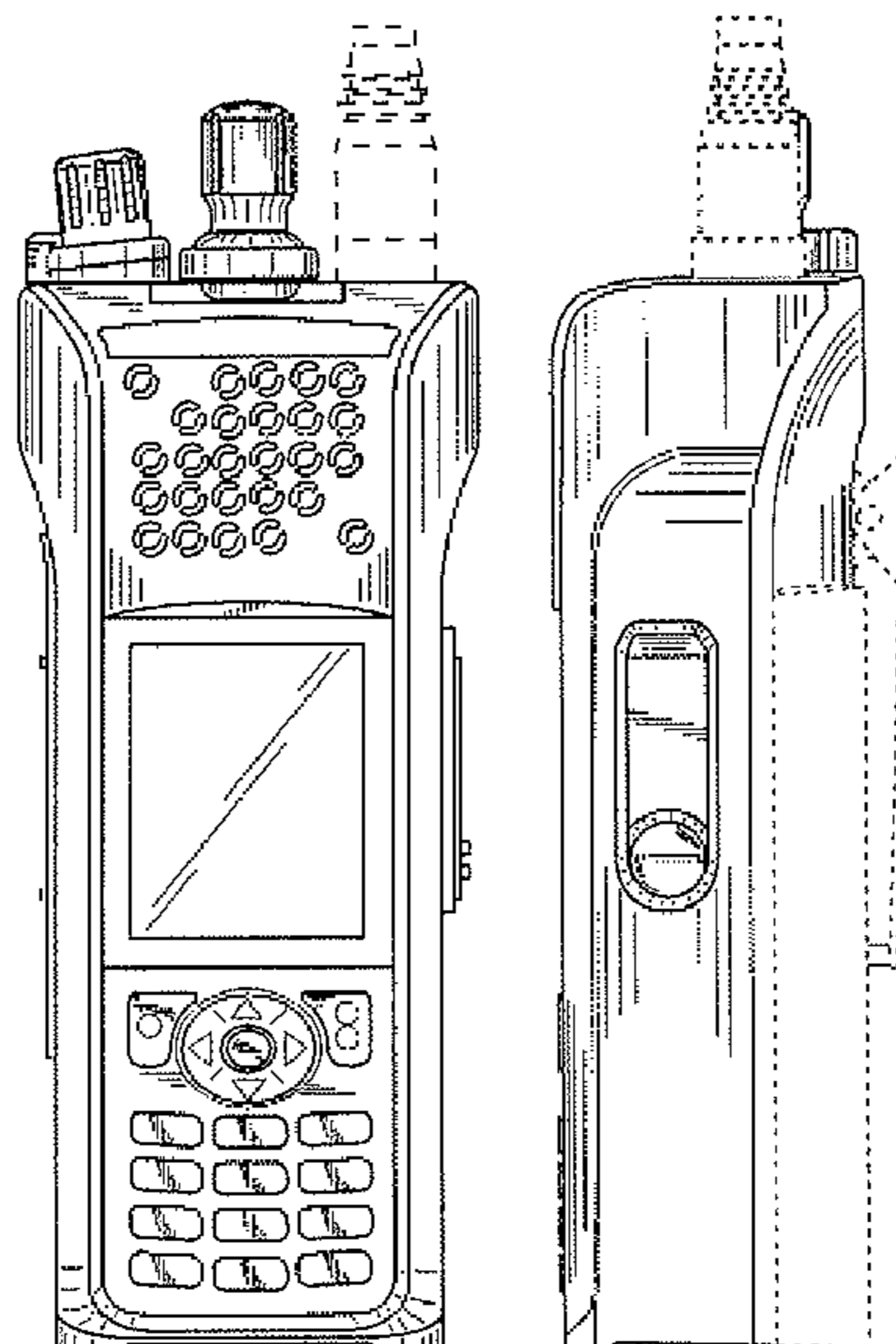
FIG. 12 is a right side view of the embodiment of FIG. 8;

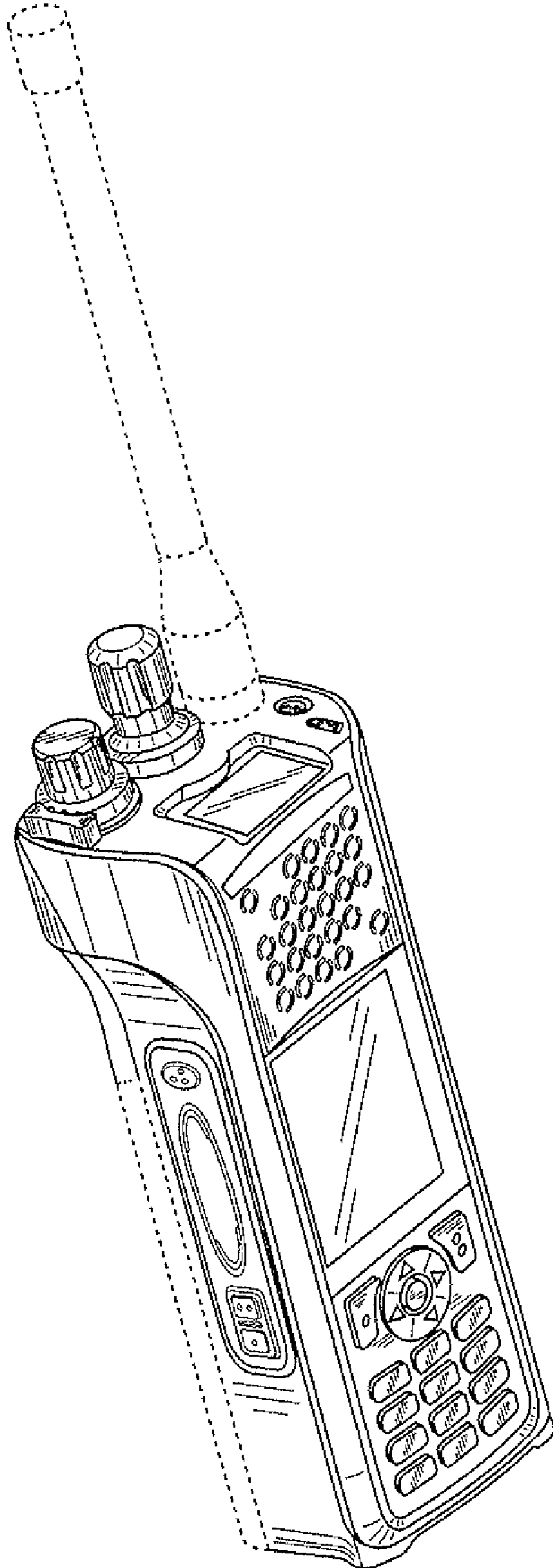

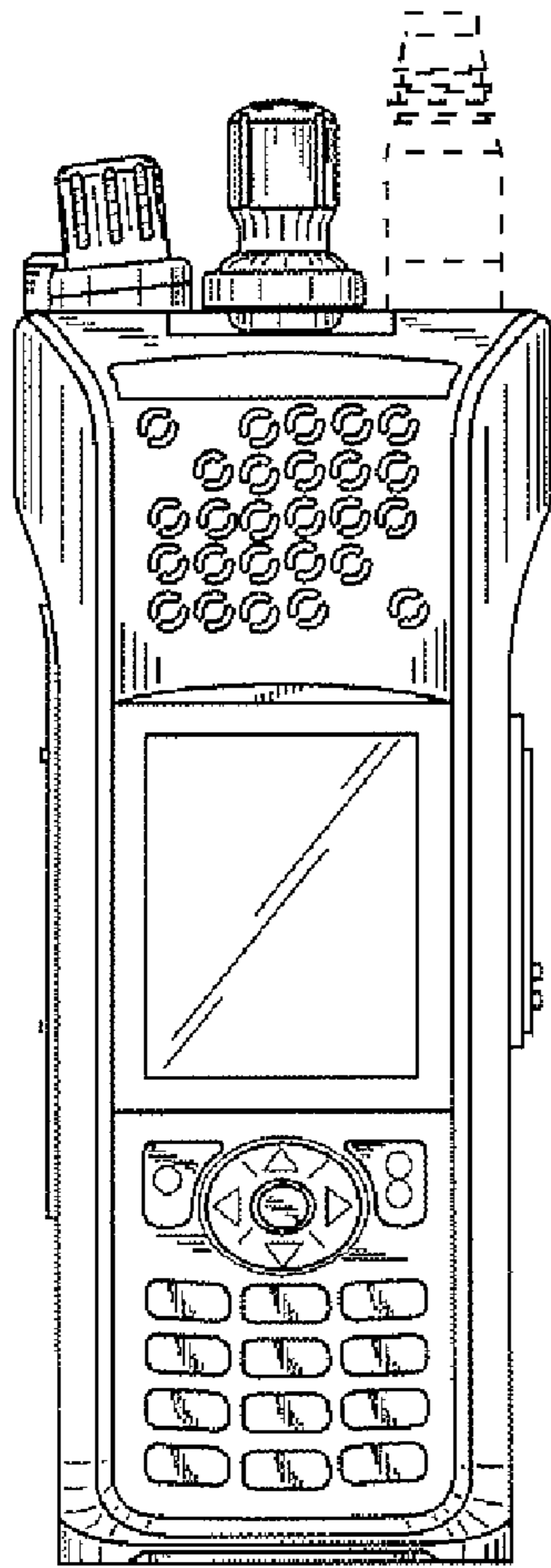

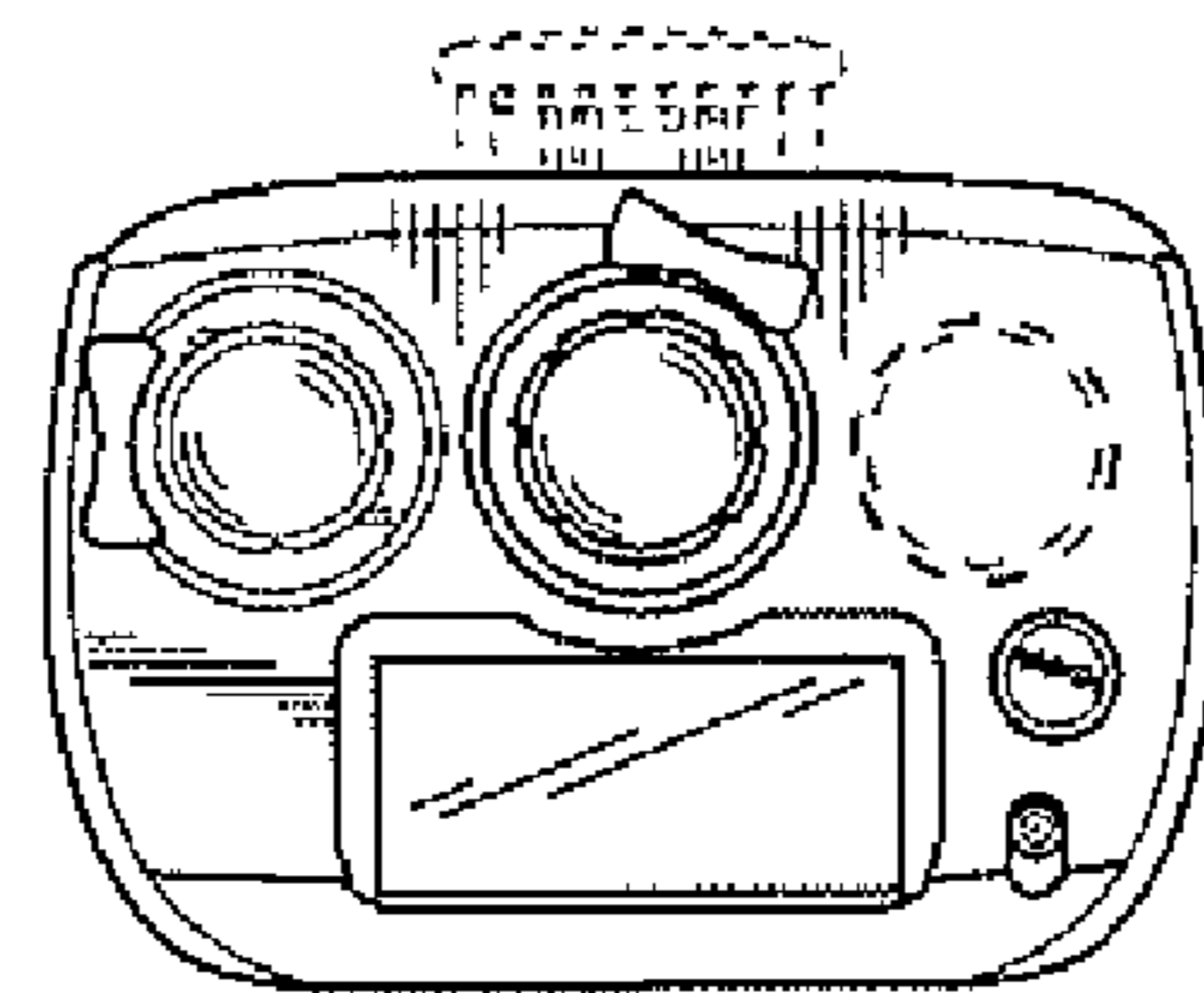
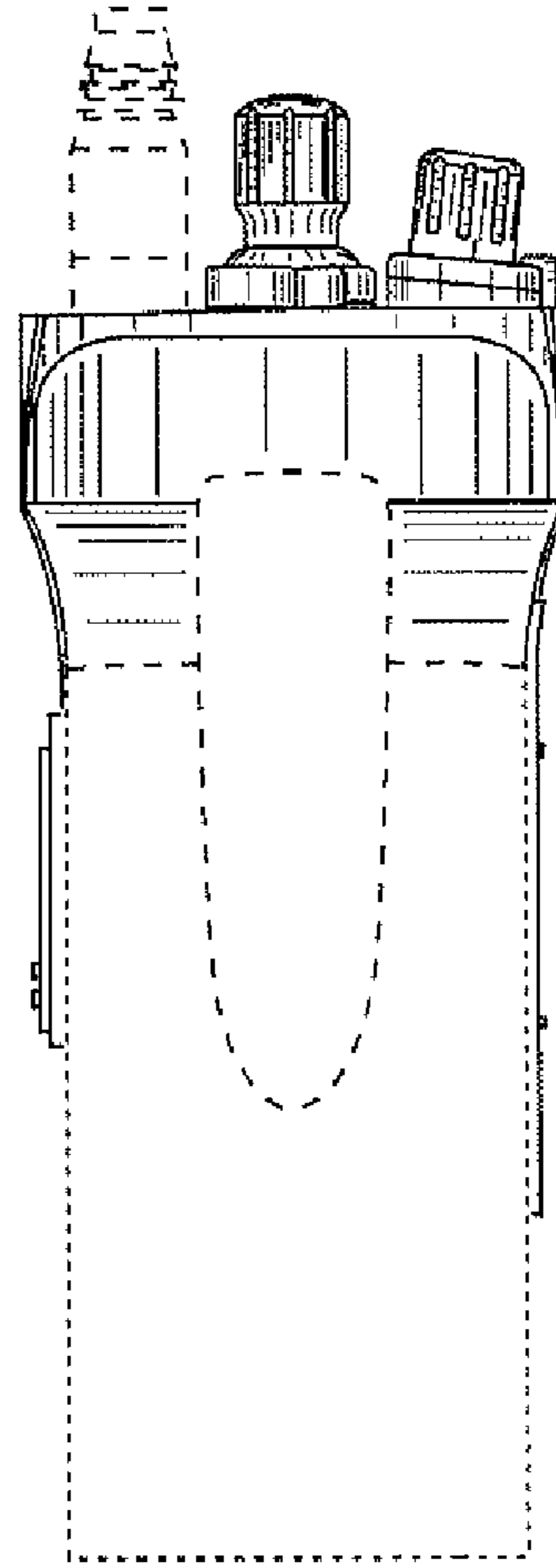

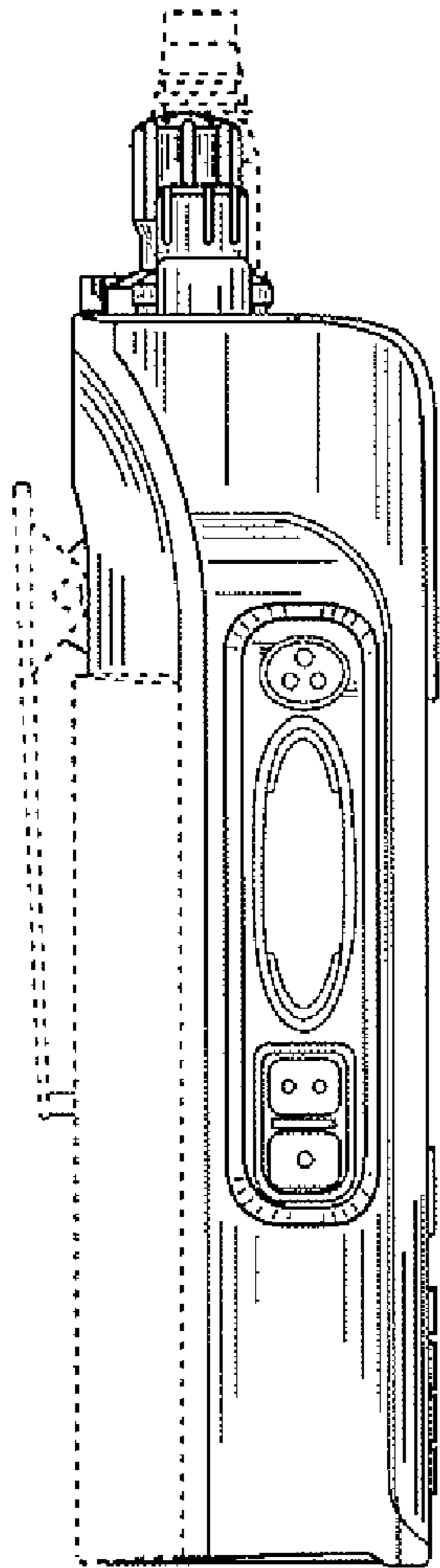

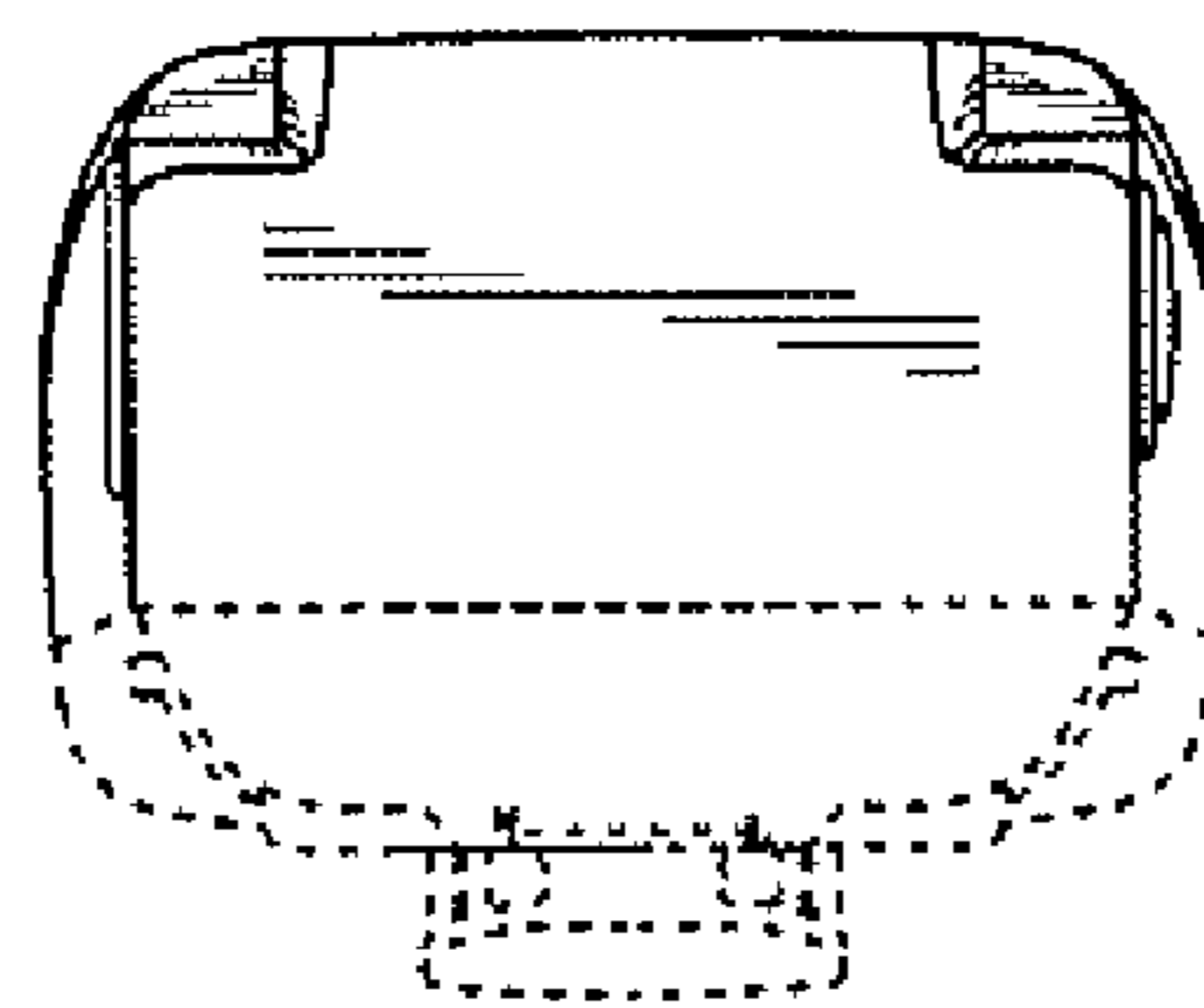
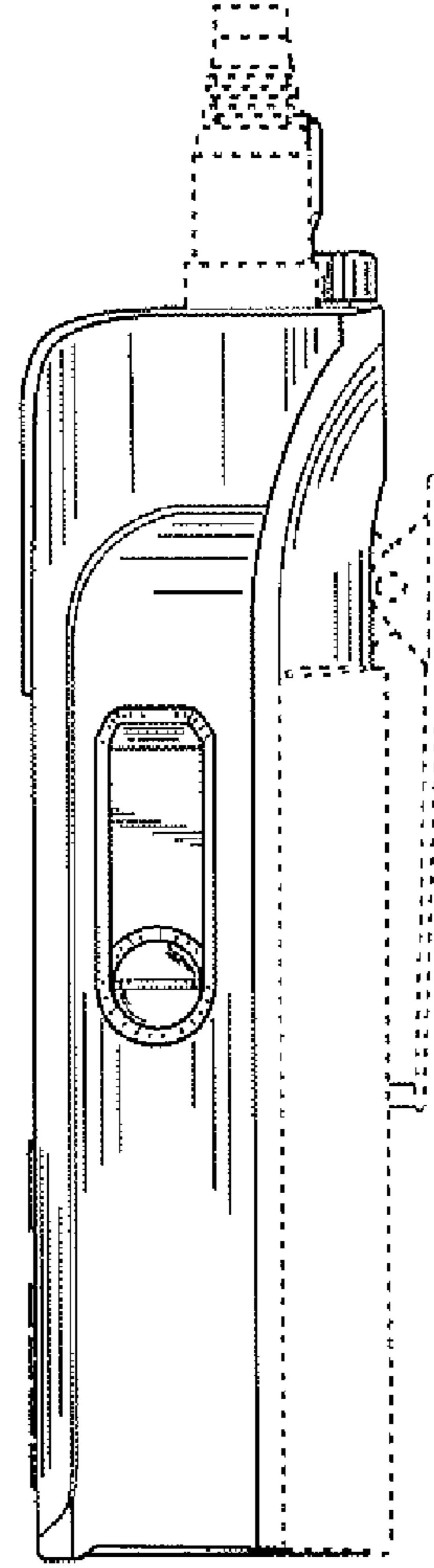

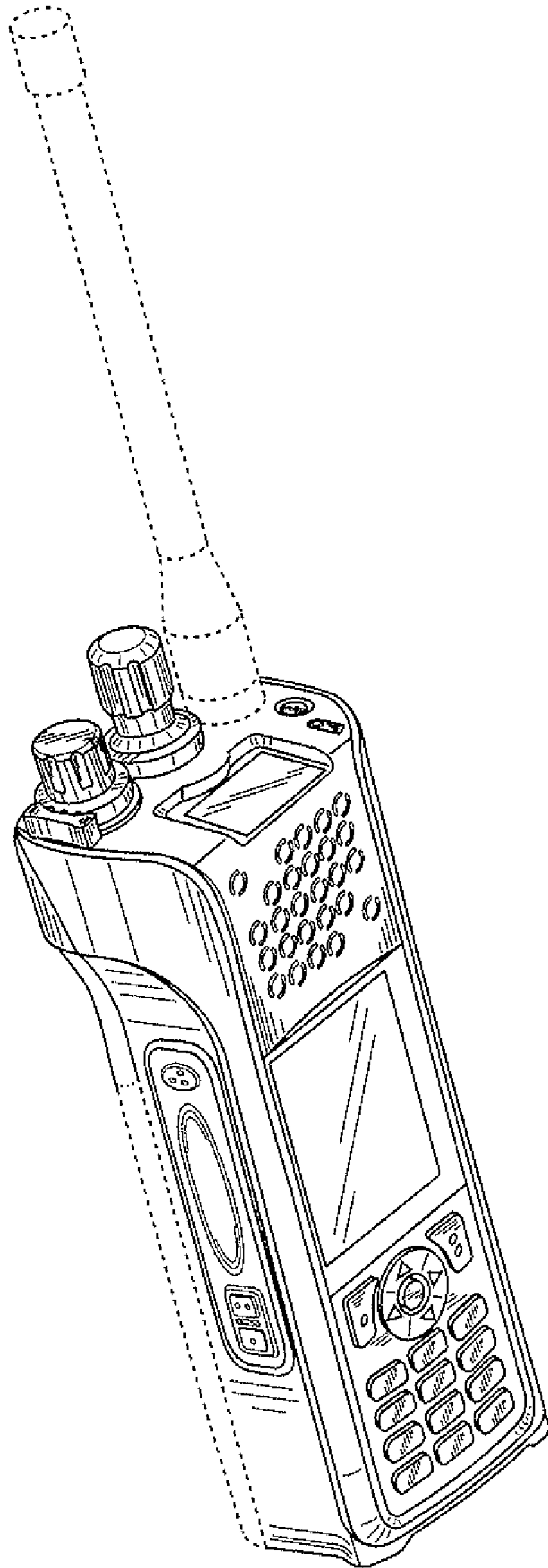

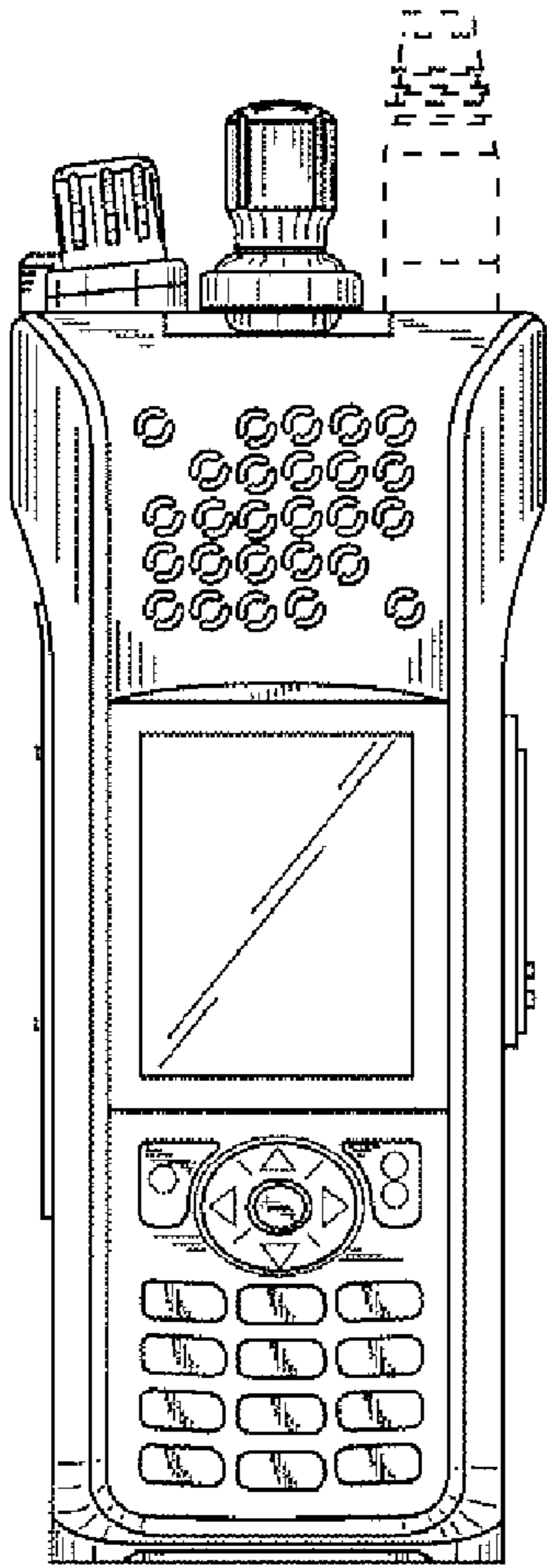

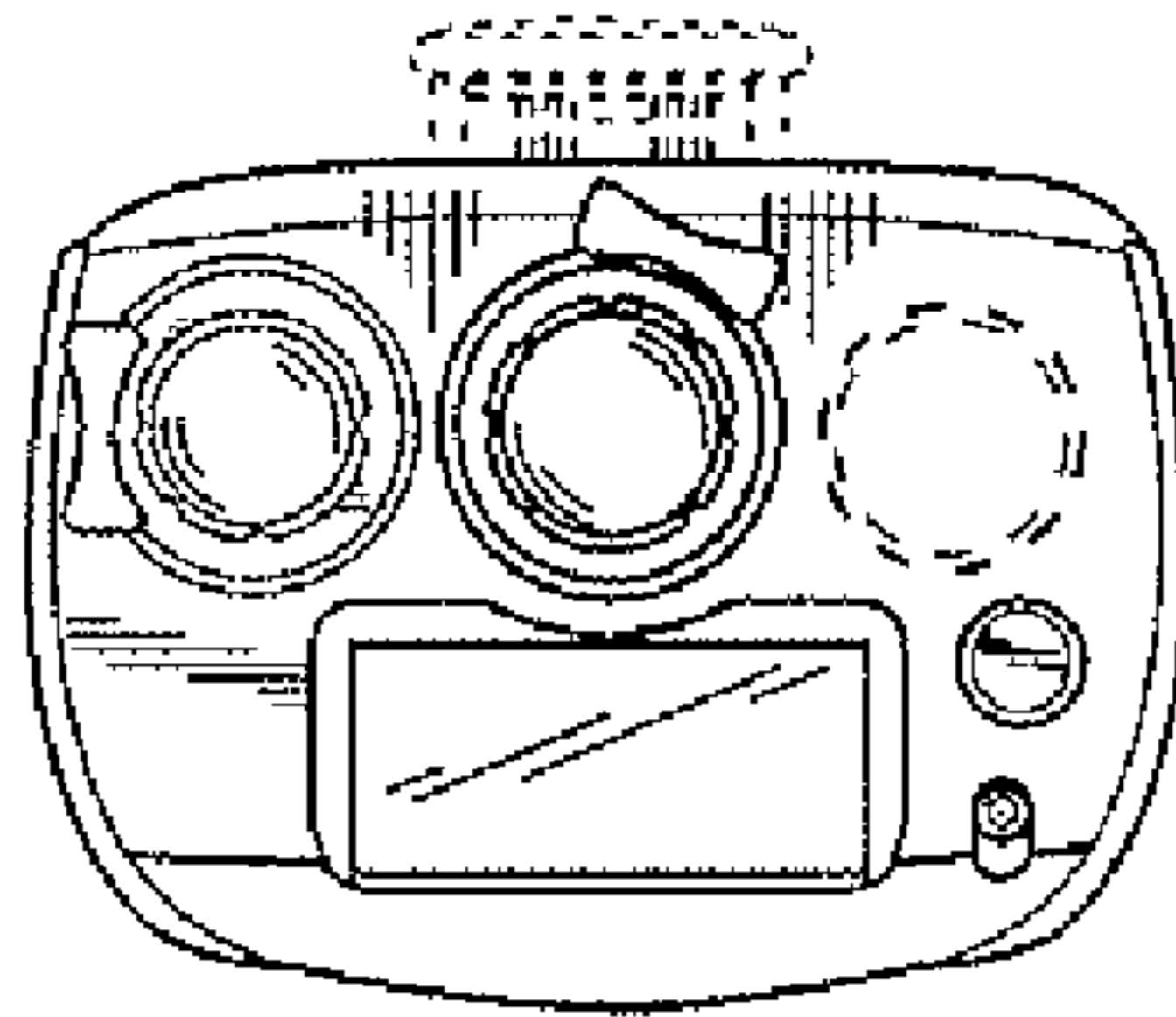
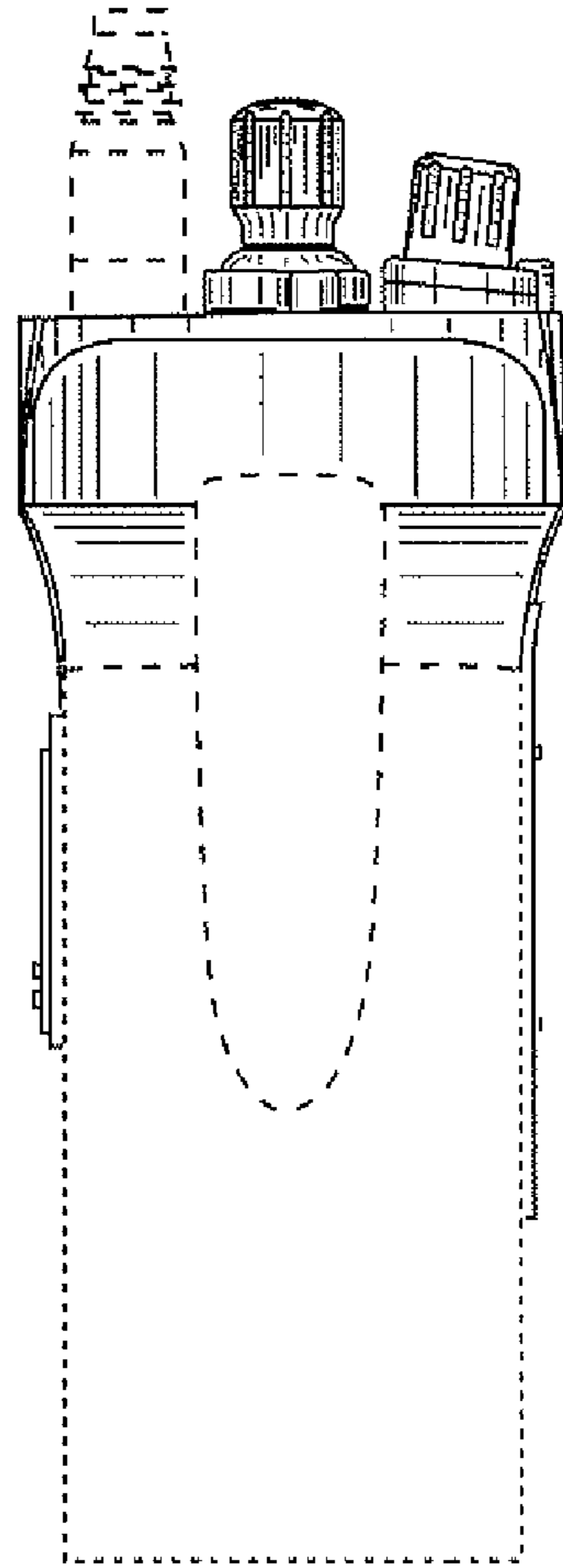

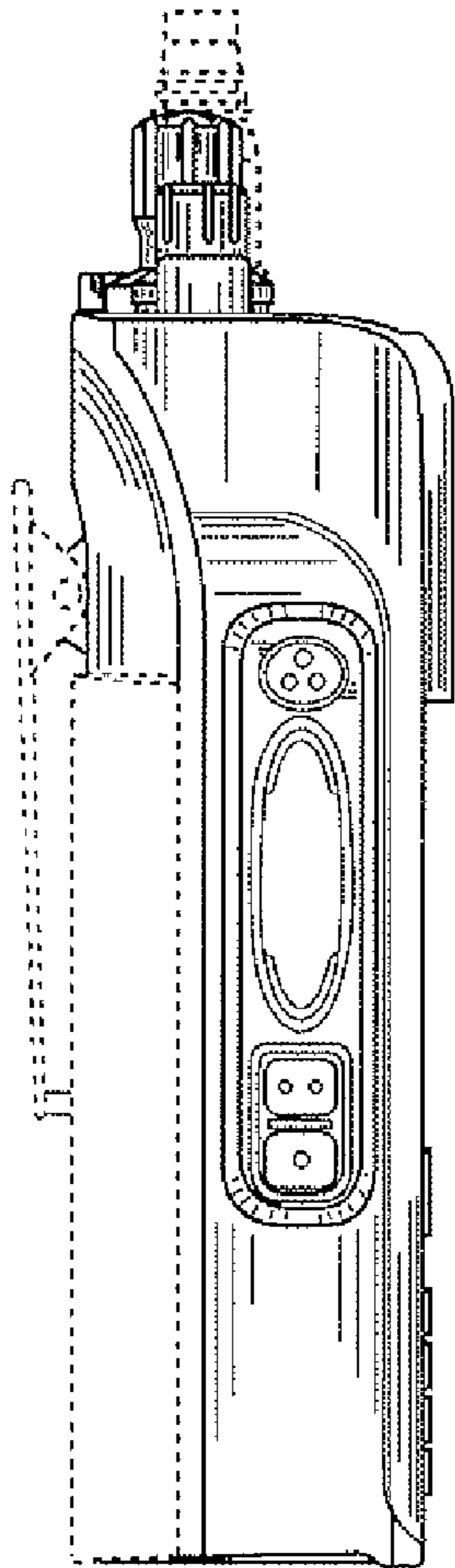

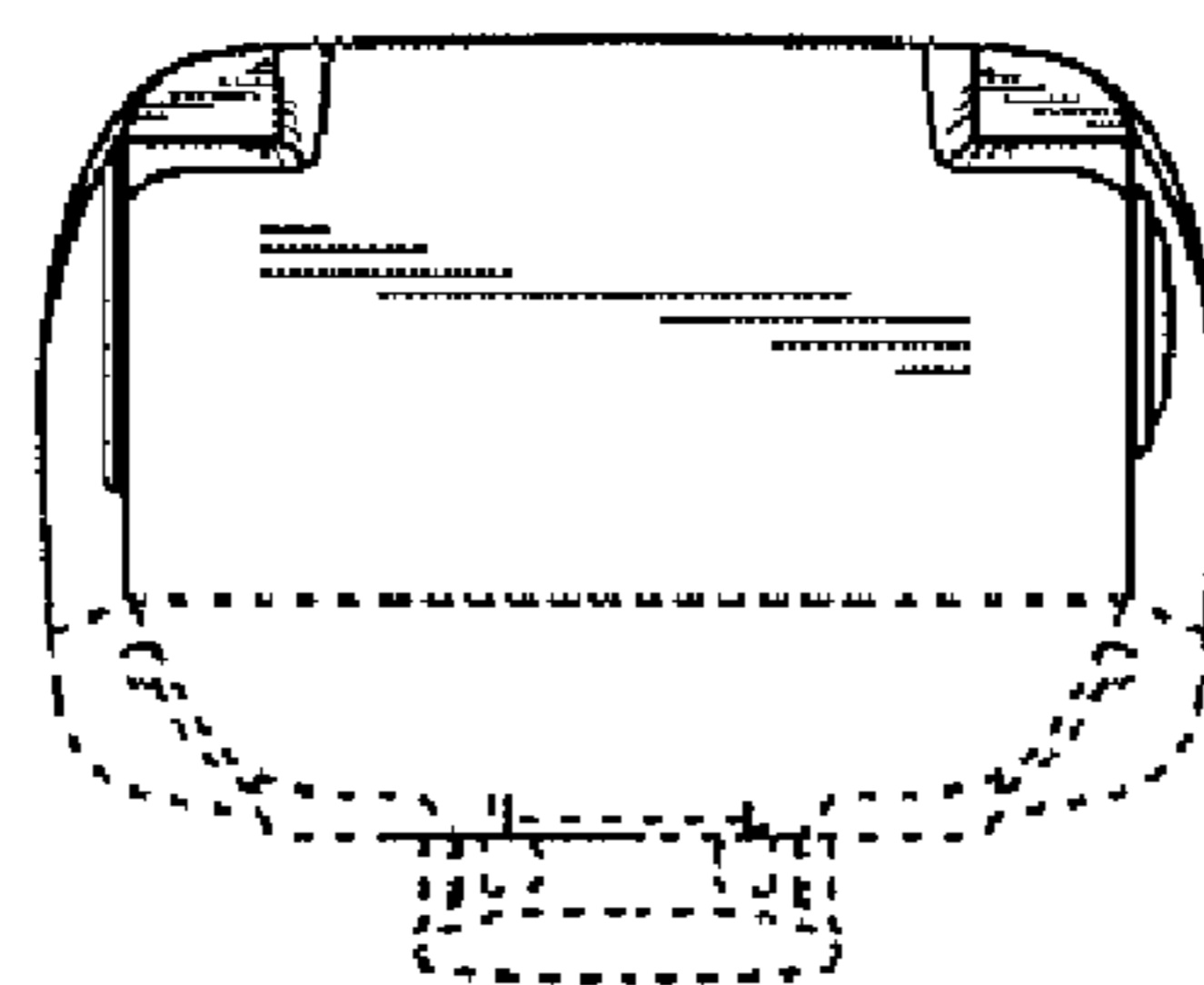
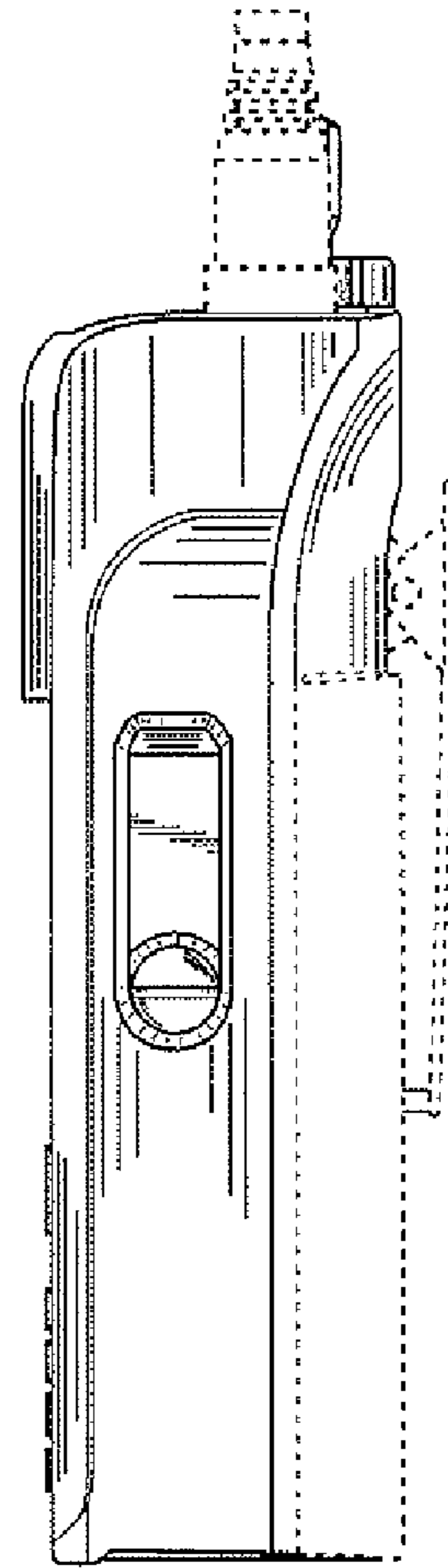
