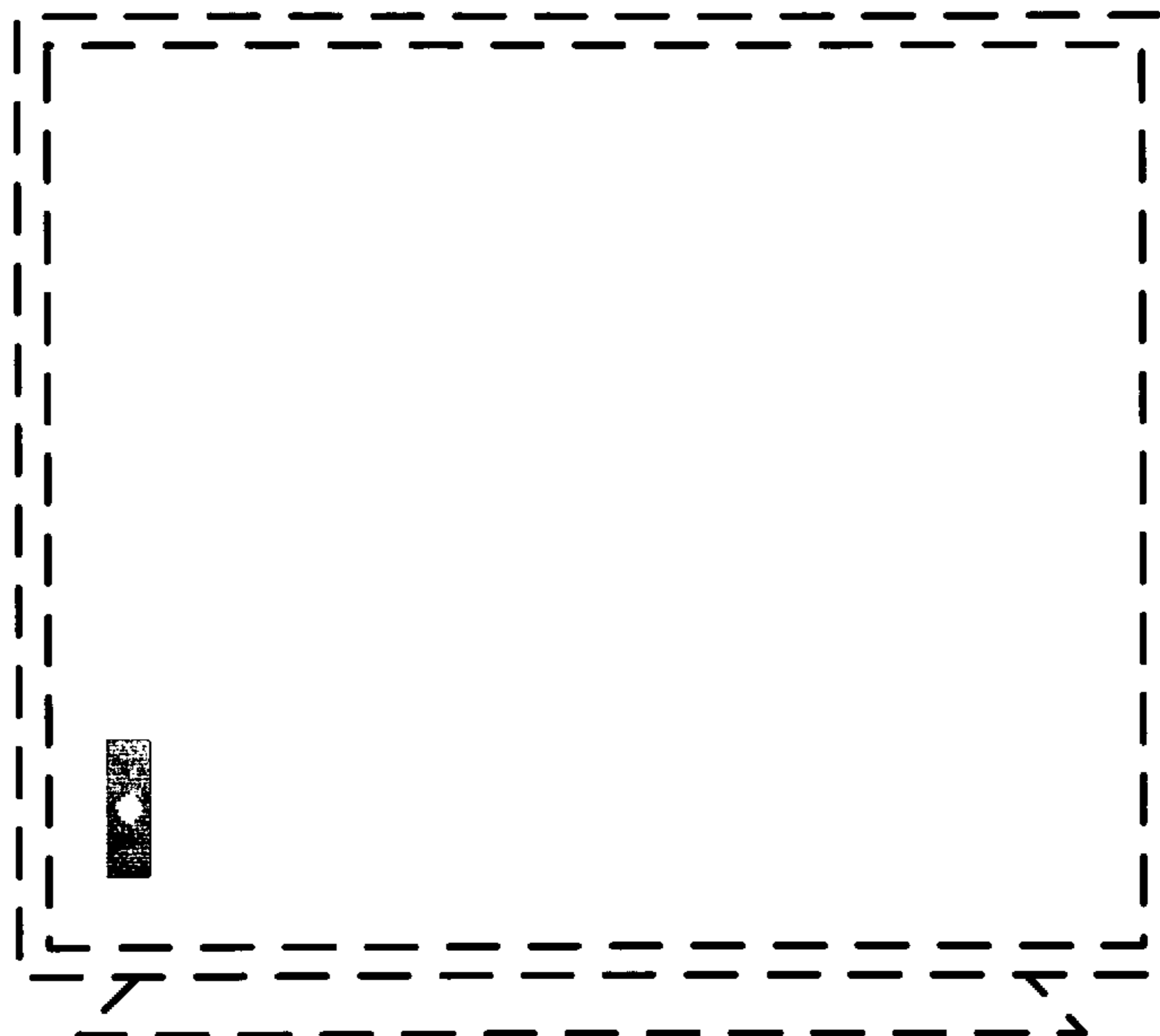
The ornamental design for a graphical user interface for computer screen, as shown and described.

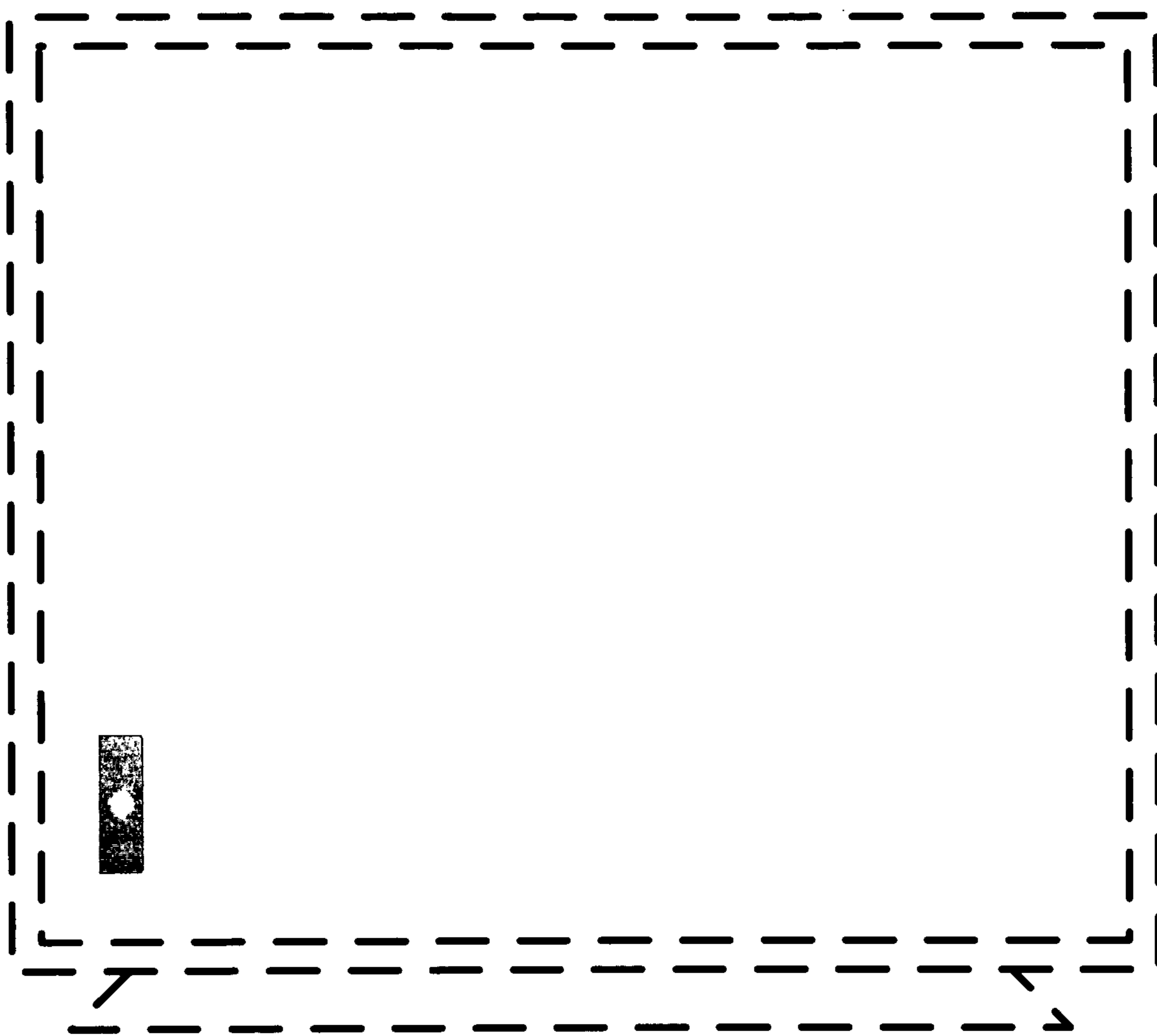
**DESCRIPTION**
