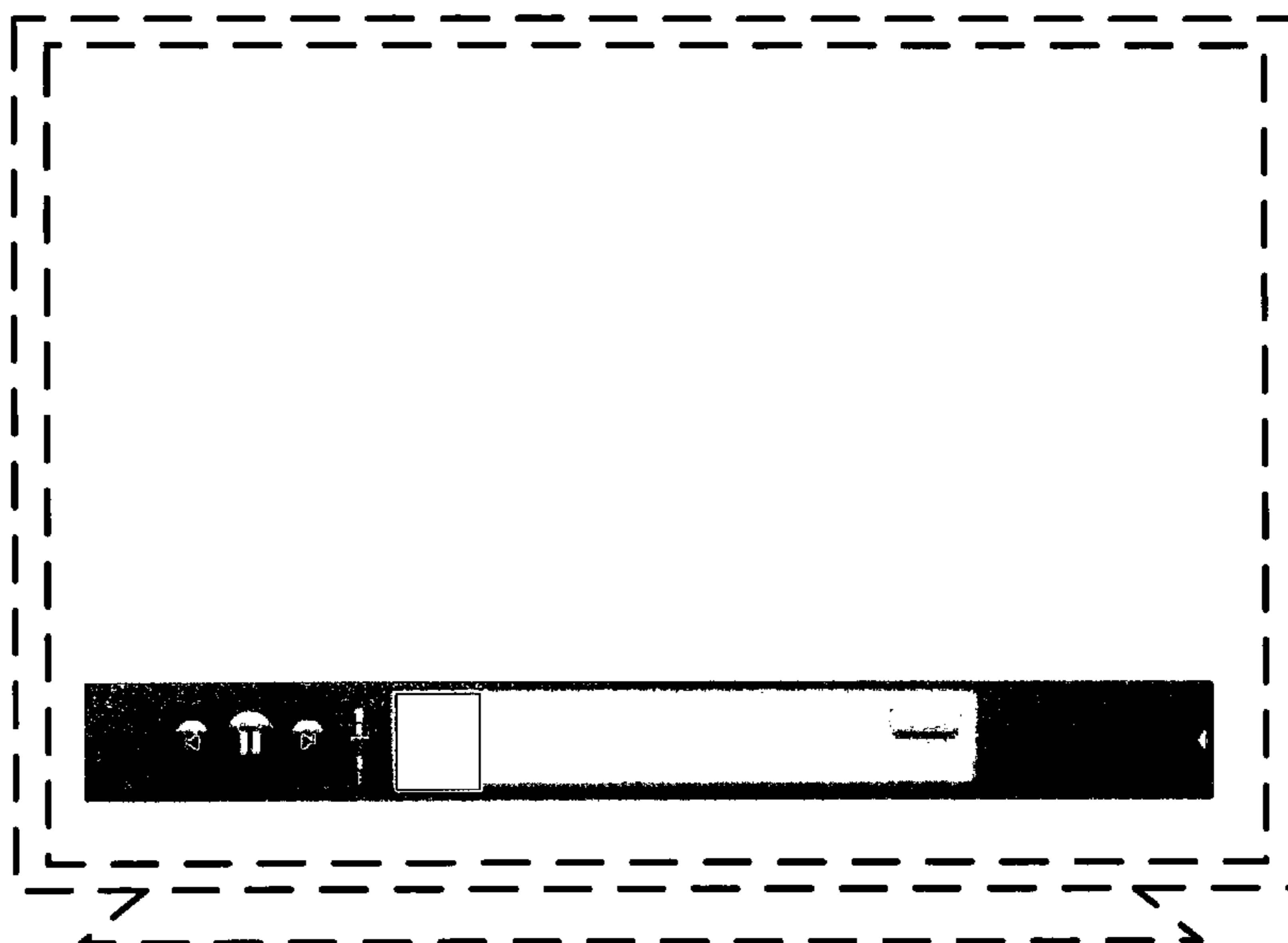
The ornamental design for a graphical user interface for com-
puter screen, as shown and described.

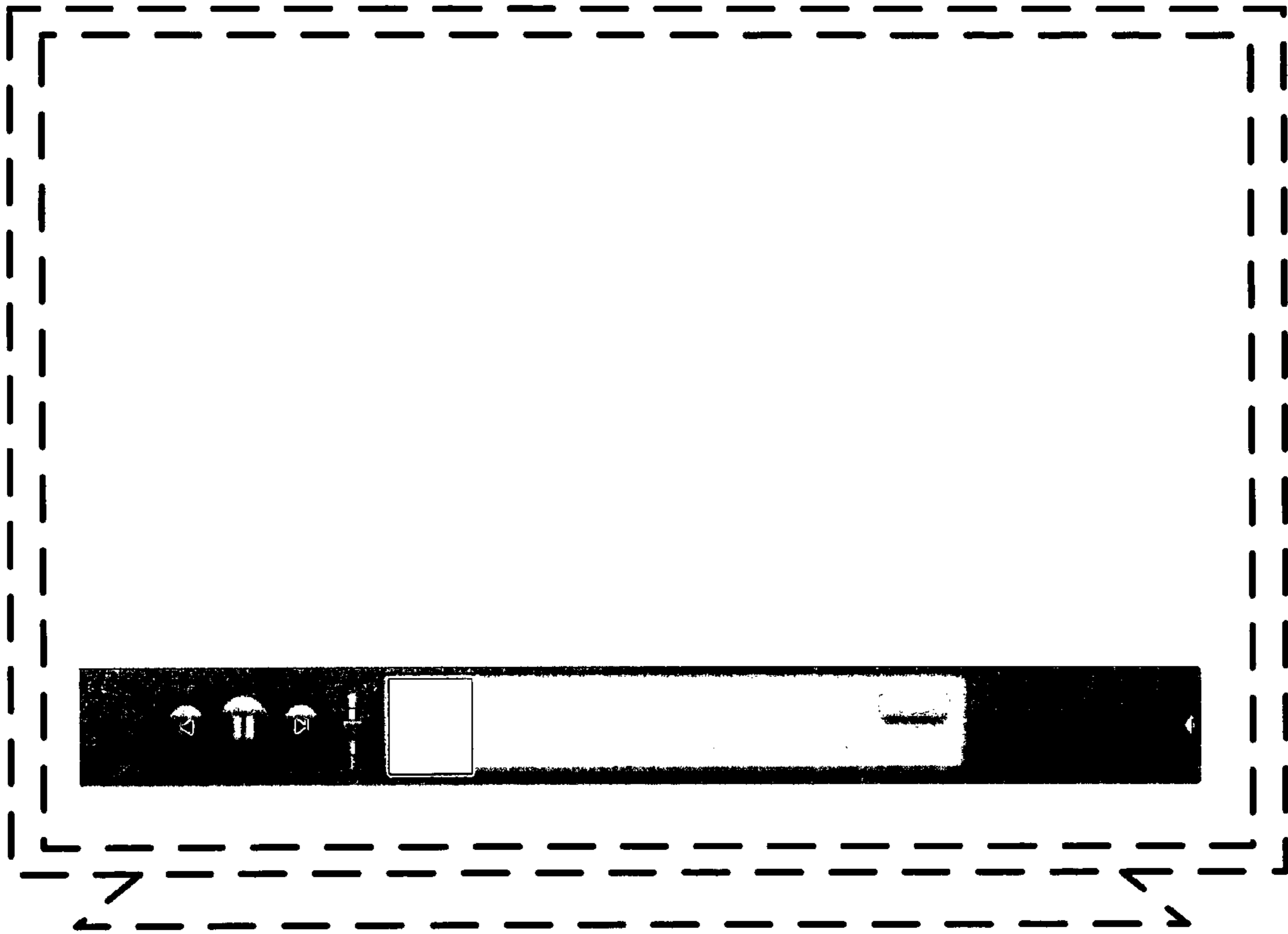
DESCRIPTION
