The ornamental design for a portfolio, as shown and described.

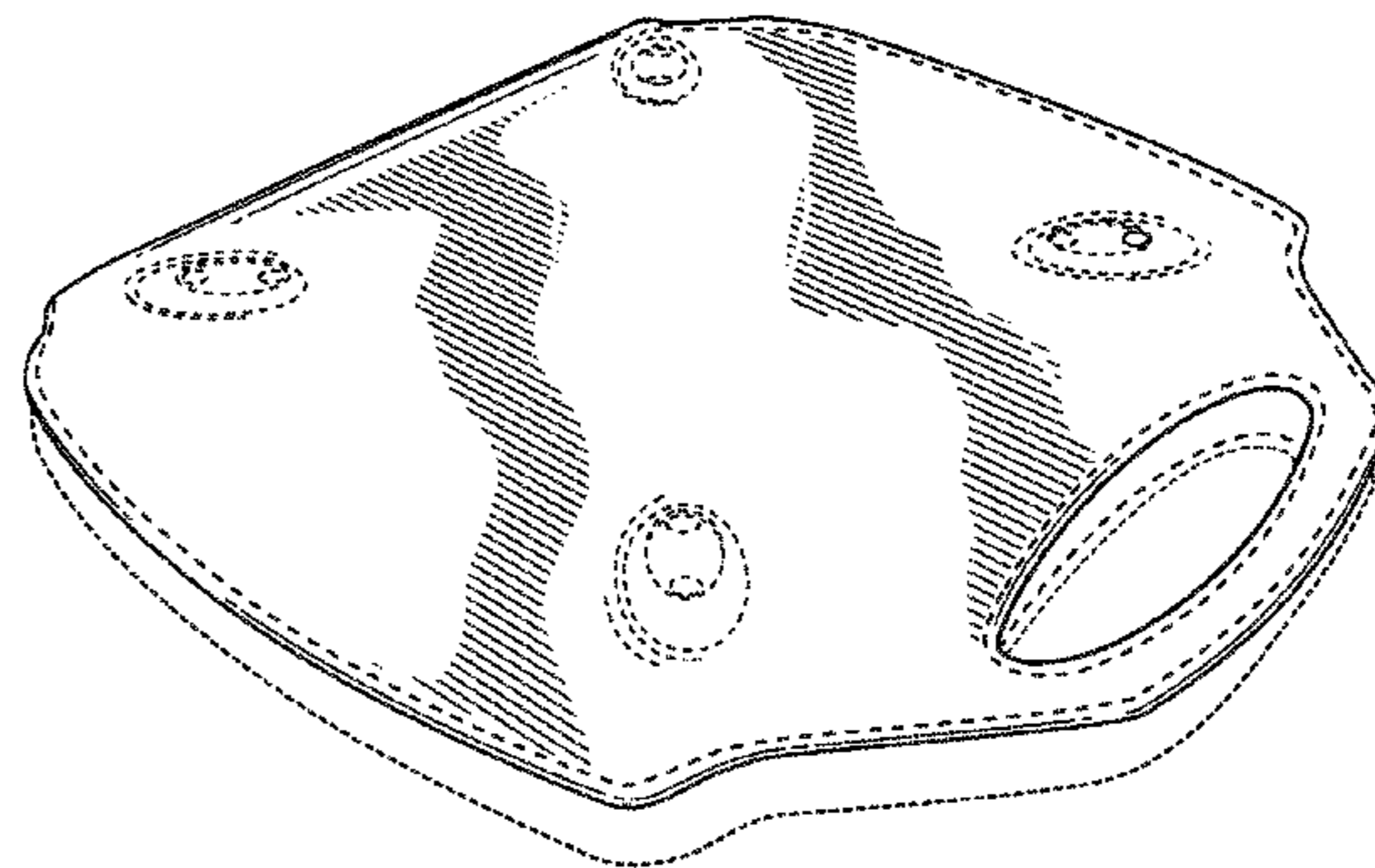
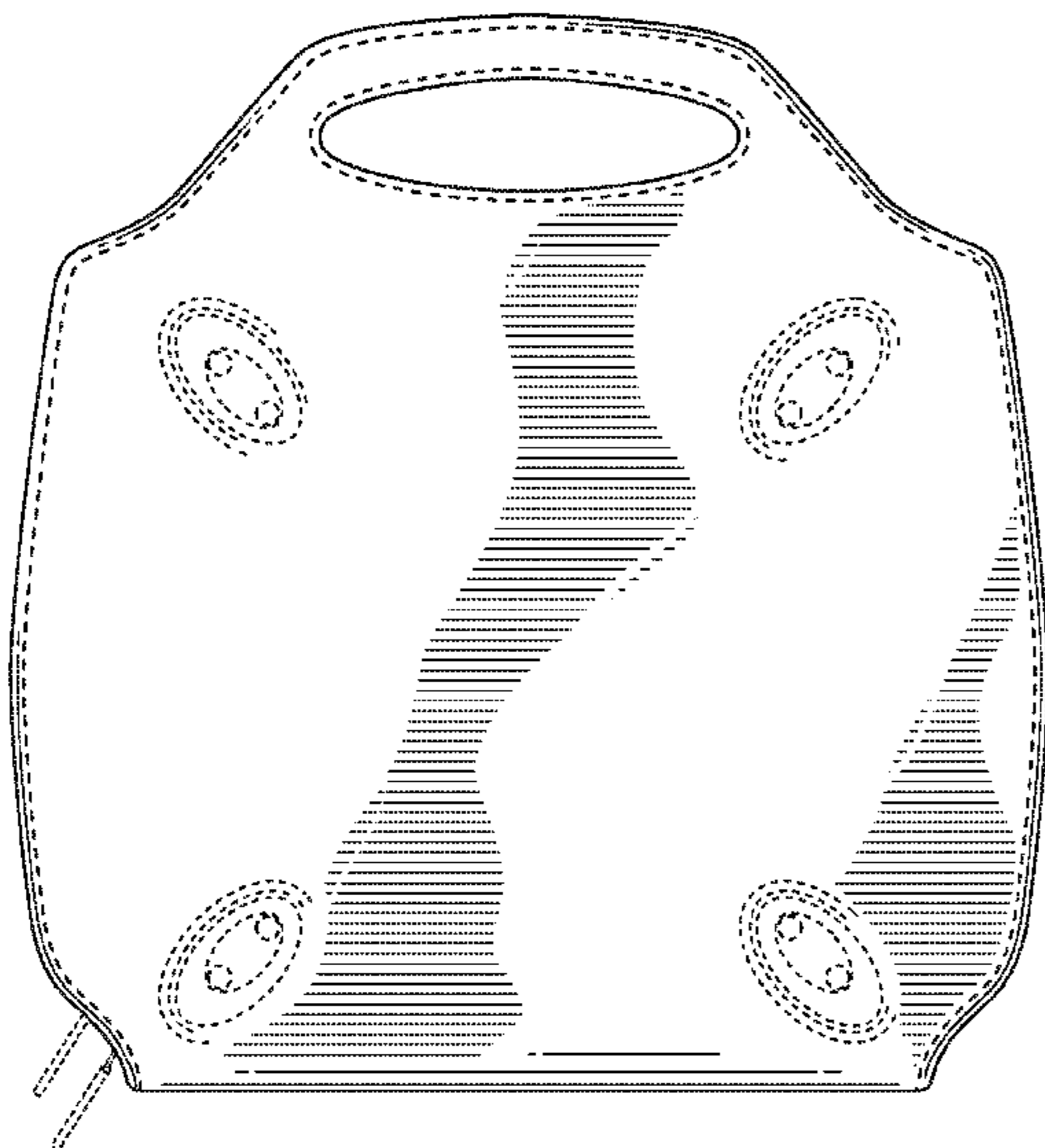
**DESCRIPTION**

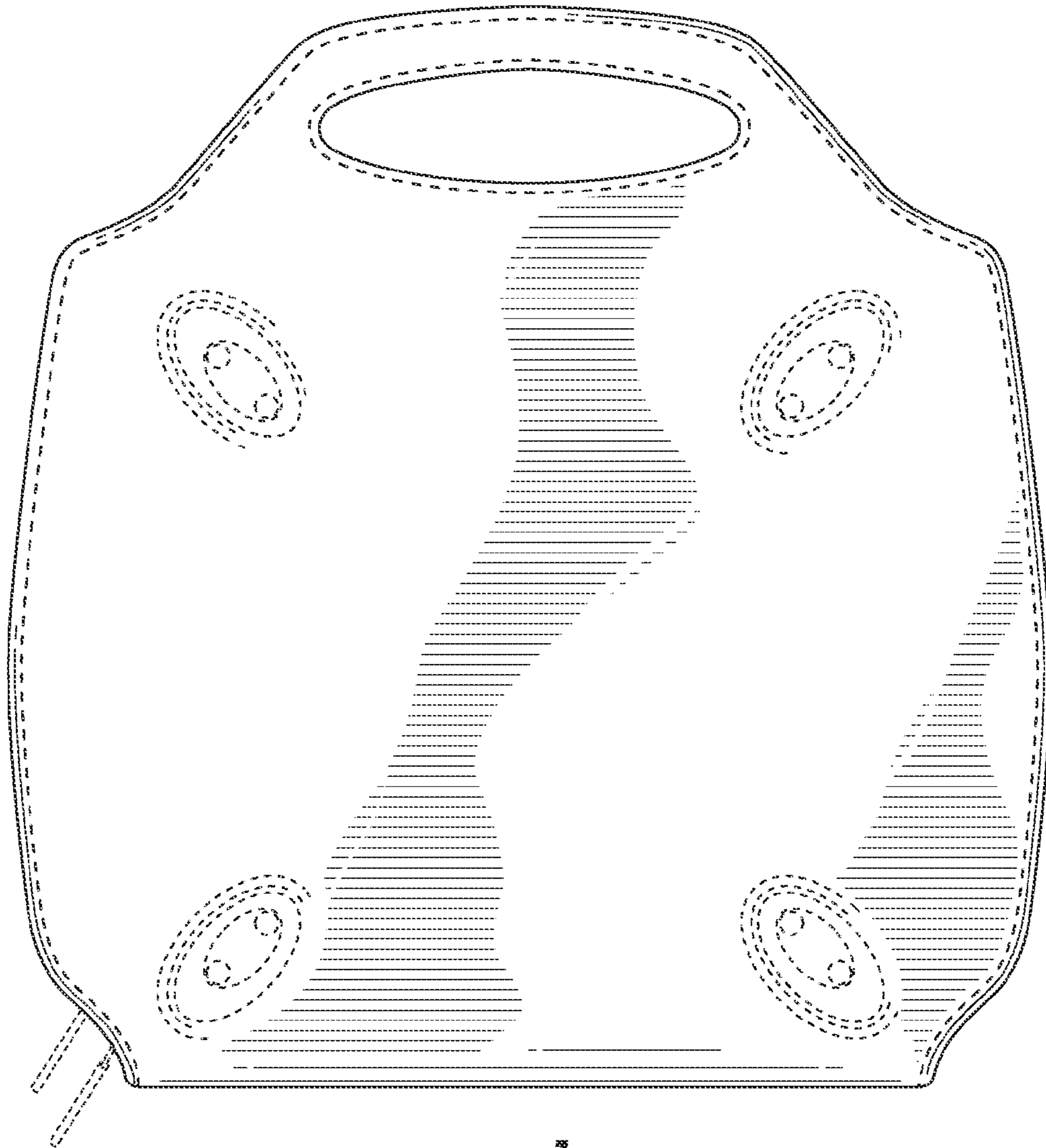

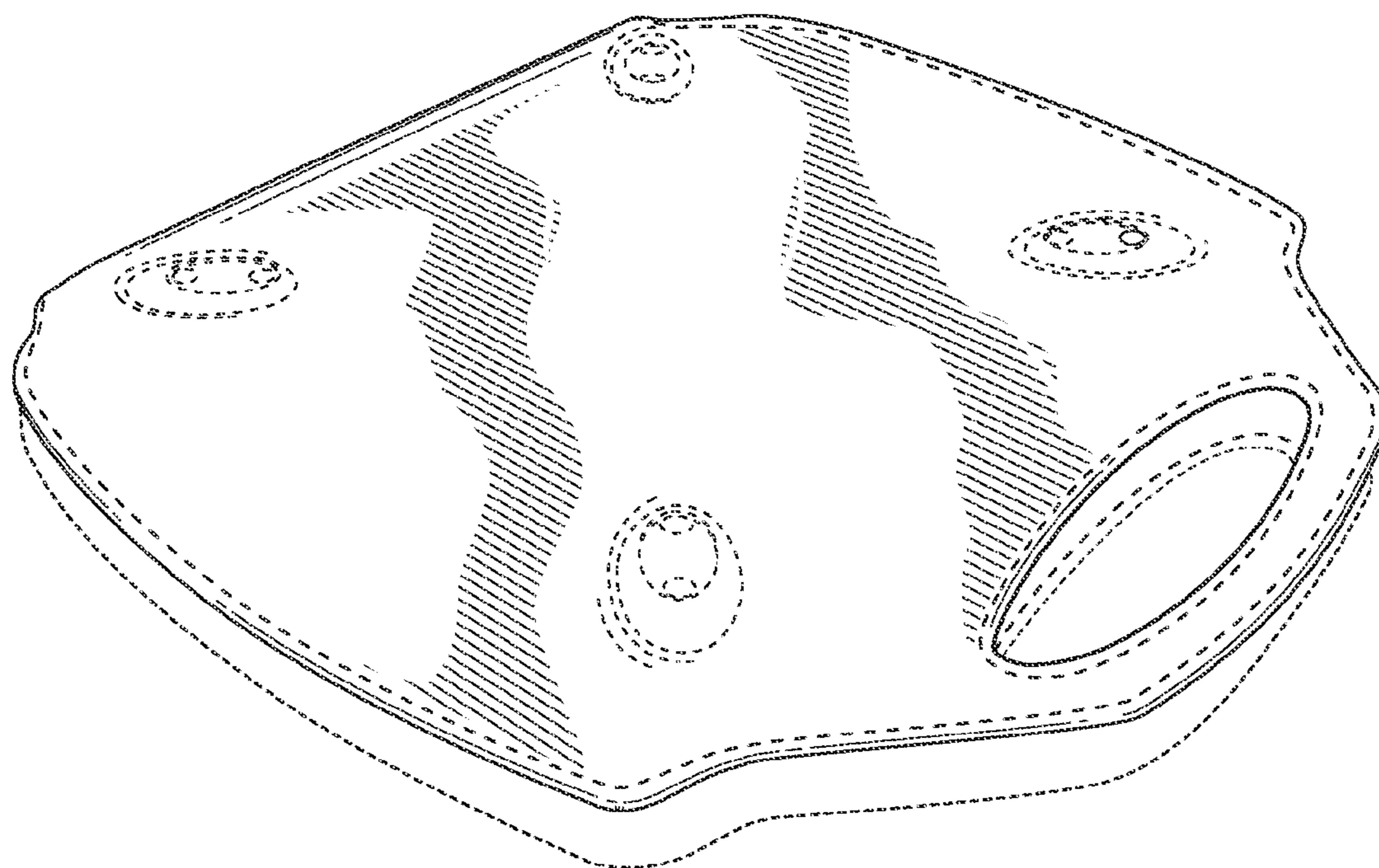
