FIG. 3 is a top plan view thereof;

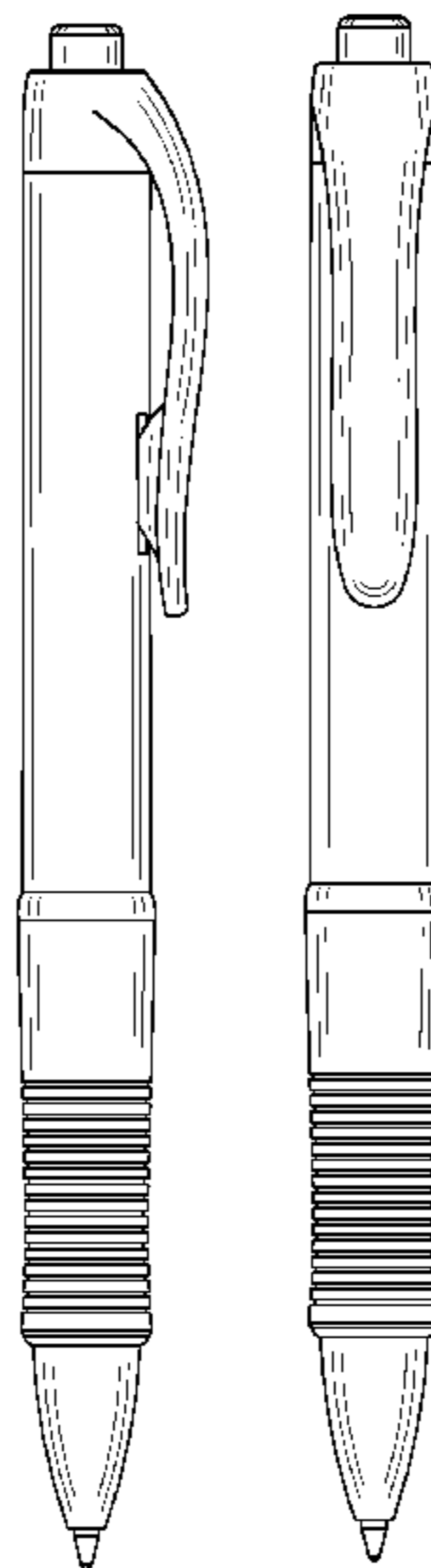
FIG. 4 is a front elevation view thereof;

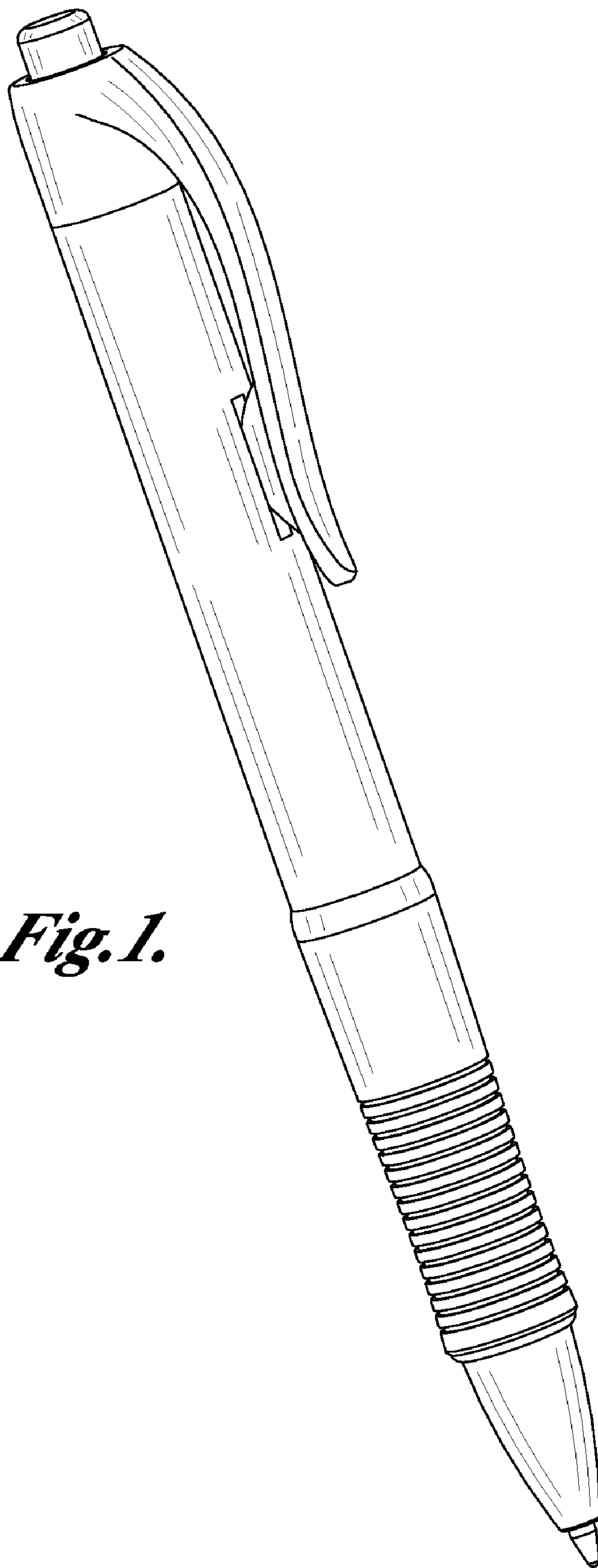
FIG. 5 is a right side elevation view thereof;

FIG. 7 is a rear elevation view thereof.

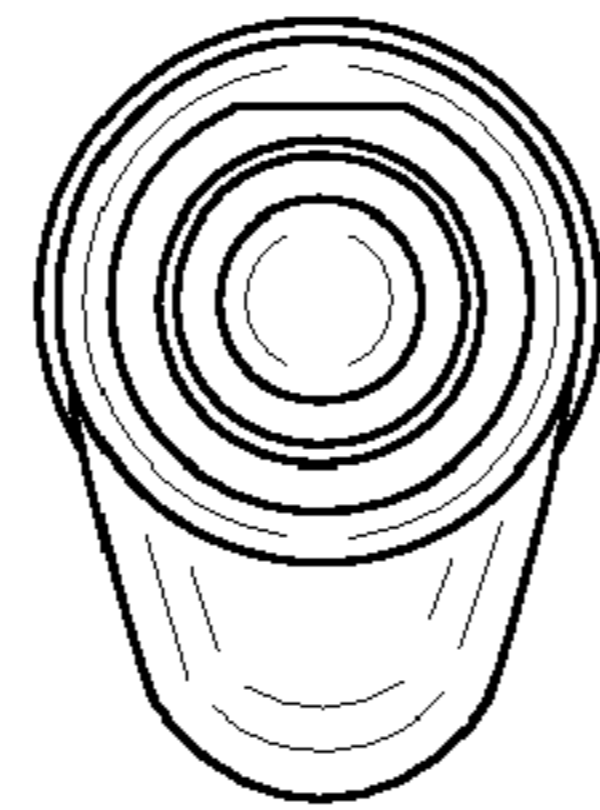
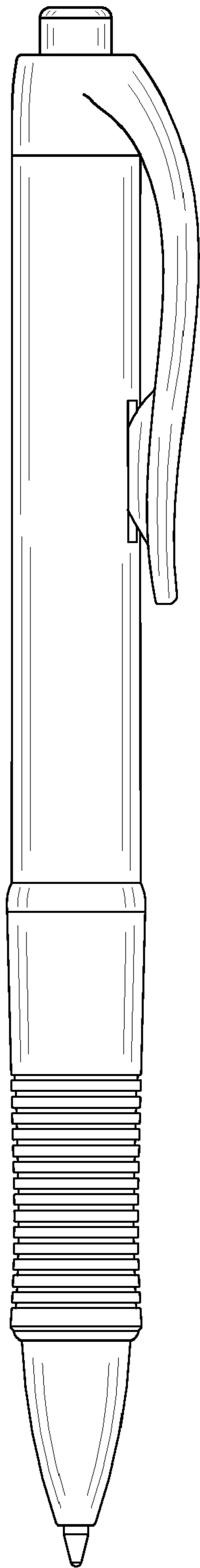

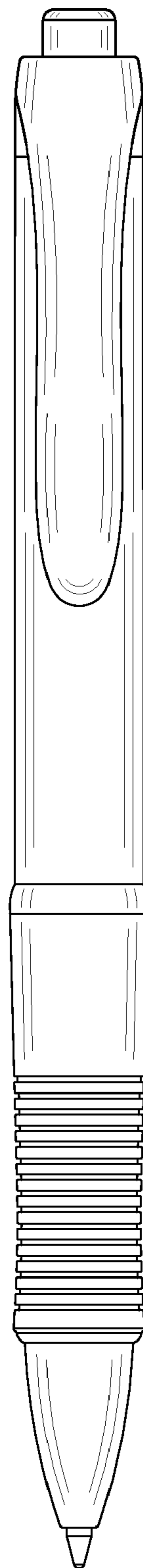

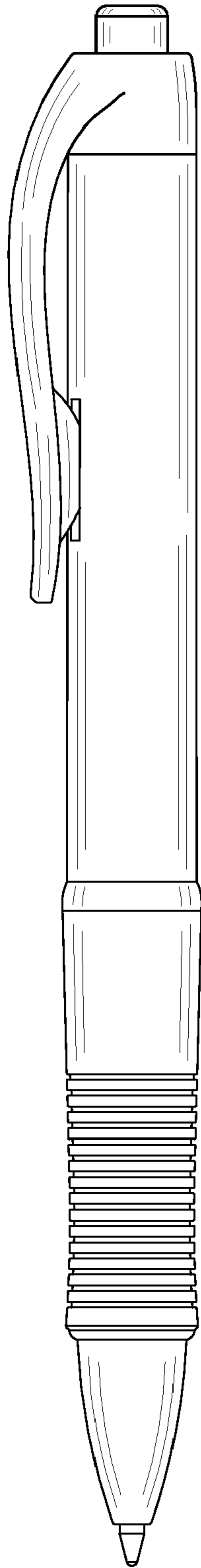

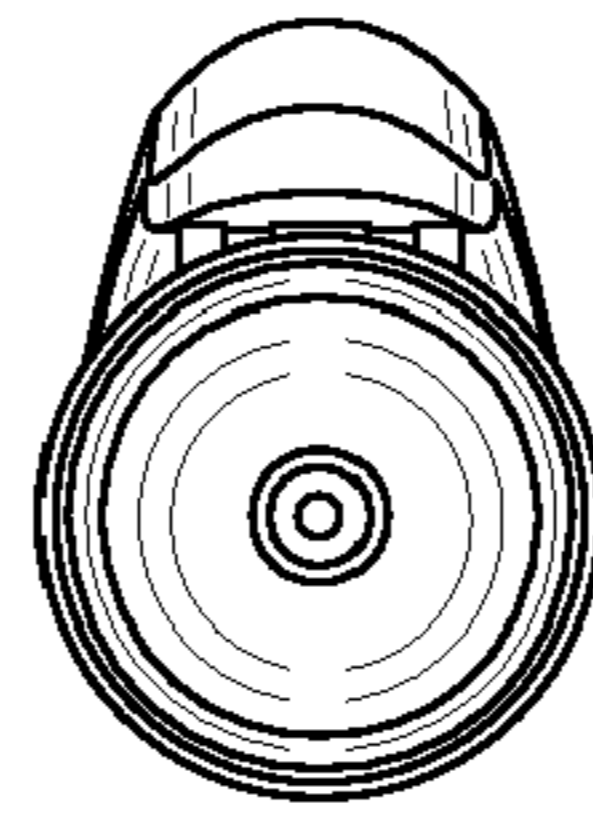

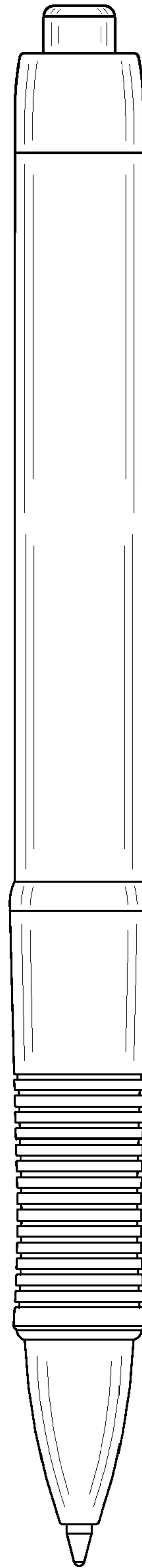
